DR. CARL V. MOORE RESIGNS AS DEAN

Dr. Carl V. Moore has resigned as Dean of the Washington University School of Medicine to accept three other positions in the medical center. The resignation will be effective September 1, although Dr. Moore will continue as acting dean until a successor is chosen.

The new positions that Dr. Moore will fill are: Chairman of the Department of Medicine, Busch Professor of Medicine, and Physician-in-Chief of Barnes Hospital. Dr. Moore said the new posts will enable him to do more intensive teaching and research.

Dr. Moore is a 1932 graduate of Washington University and was named Assistant Professor of Medicine in 1938, and in 1946, became Professor of Medicine. He has been Dean of the school since October, 1953. Dr. Moore, who is an authority on nutrition and hematology, is a fellow of the American College of Physicians and a past president of the American Society of Clinical Instructors.

During the evening Miss Lewis was guest speaker at the annual dinner meeting of the Minnesota District of the American Association of Medical Social Workers. Her topic was, "Implications of Current Trends in Medical Education for Medical Social Workers".

DR. BRADLEY ATTENDS MEETING IN EUROPE

On Wednesday, May 25, Dr. Frank R. Bradley, Director of Barnes Hospital, left for Europe to attend the Congress of the International Hospital Federation which was held May 30 to June 3, at Lucerne, Switzerland. Dr. Bradley who is President of the American Hospital Association headed a delegation from that organization which attended the meeting.

The Congress was devoted to "The Mental Well-Being of Patients In The General Hospital". Dr. Bradley presided over Section II which studied Administrative Procedures. According to the program which was received at Barnes Hospital, Dr. Bradley was the only American that appeared on the agenda.

At the conclusion of the meeting of the International Hospital Congress, Dr. Bradley proceeded to Stuttgart where he inspected the Fifth General Army Hospital at Bad Cannstatt for the Joint Commission on Accreditation of Hospitals. His last official visit was made to Major General Joseph Martin at the 130th U.S. Army Hospital. Following these official duties, Dr. and Mrs. Bradley are touring the hospitals and medical schools in Holland, Belgium, Scotland, and England. They are scheduled to return to St. Louis June 27.

ETHEL SALE TIES BOWLING RECORD

A wise observer of human nature once said: "In all that you do, avoid grumbling and disputing". This was a statement of the first Christian century, written by a great scholar and leader of influence among the people of his day. Paul was the speaker, but the statement could well be one from a leader and thinker of our own day. Many things have changed through the centuries, but people have not advanced beyond the need for such advice. Such bits of wisdom can help shape the conduct of the human family, but only when used by the individual members.

This advice, which we must admit has some application for our generation, starts out with an uncomfortable phrase. We are reminded that these two unwholesome elements are to be avoided in all that we do. That means from the beginning of the day to the close of the evening. That makes it very difficult, for along the way there are many temptations in these directions. Just here we may be reminded of the experiences we had as children when we were told to be very nice when company was expected or when visits to certain homes were planned by the family. It was not too hard on us to be on our good behavior at designated times, but to keep perfectly clean and exactly right at all times was a rather big order. So it is with grumbling and disputing. When a business deal is at stake, it would be very unwise to show such characteristics. When social position is sought we can be on our best behavior. When personal advantage is in clear view, it is not difficult to make use of the attitudes that are in keeping with the situation at hand.

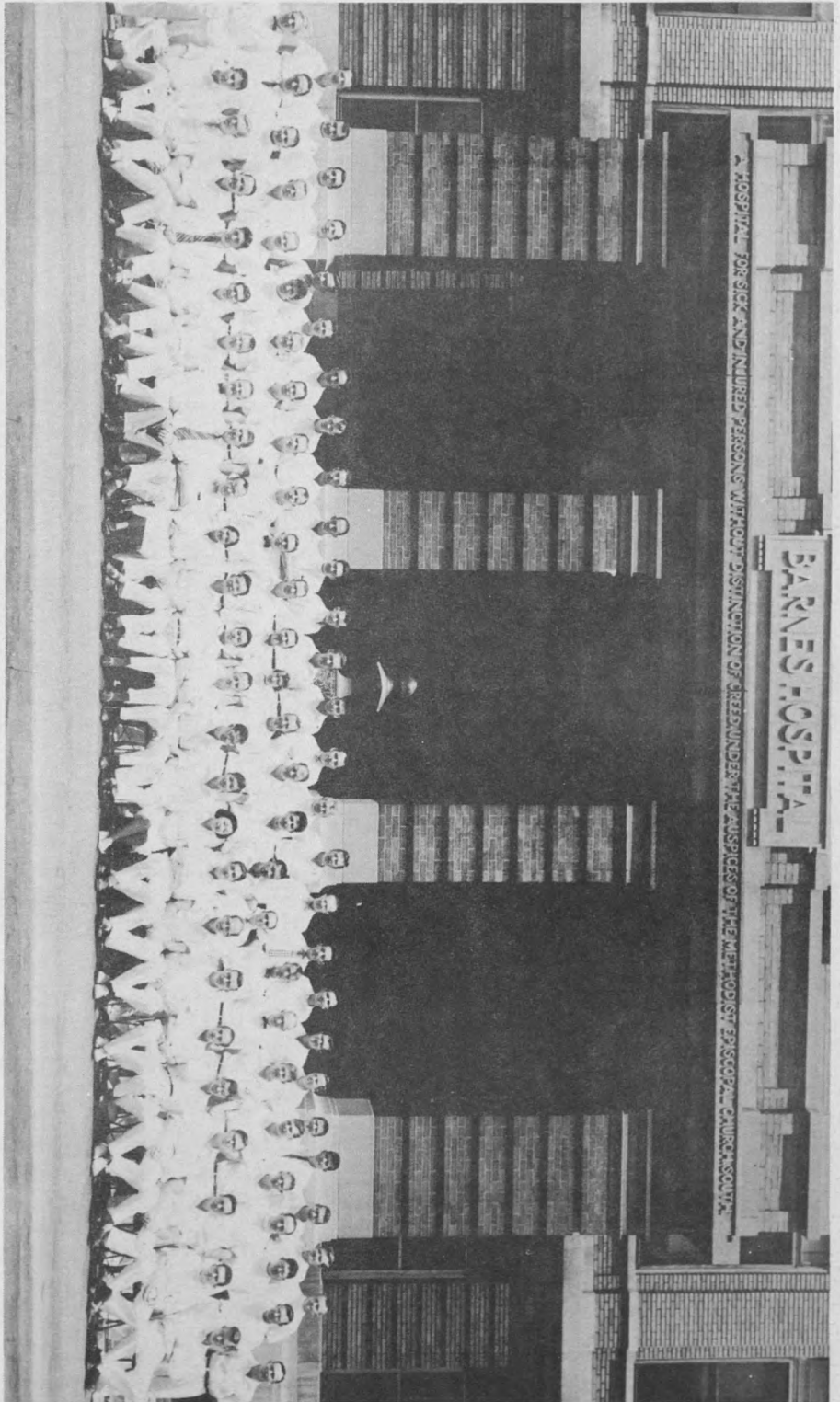
CHAPLAIN'S CORNER (Continued)

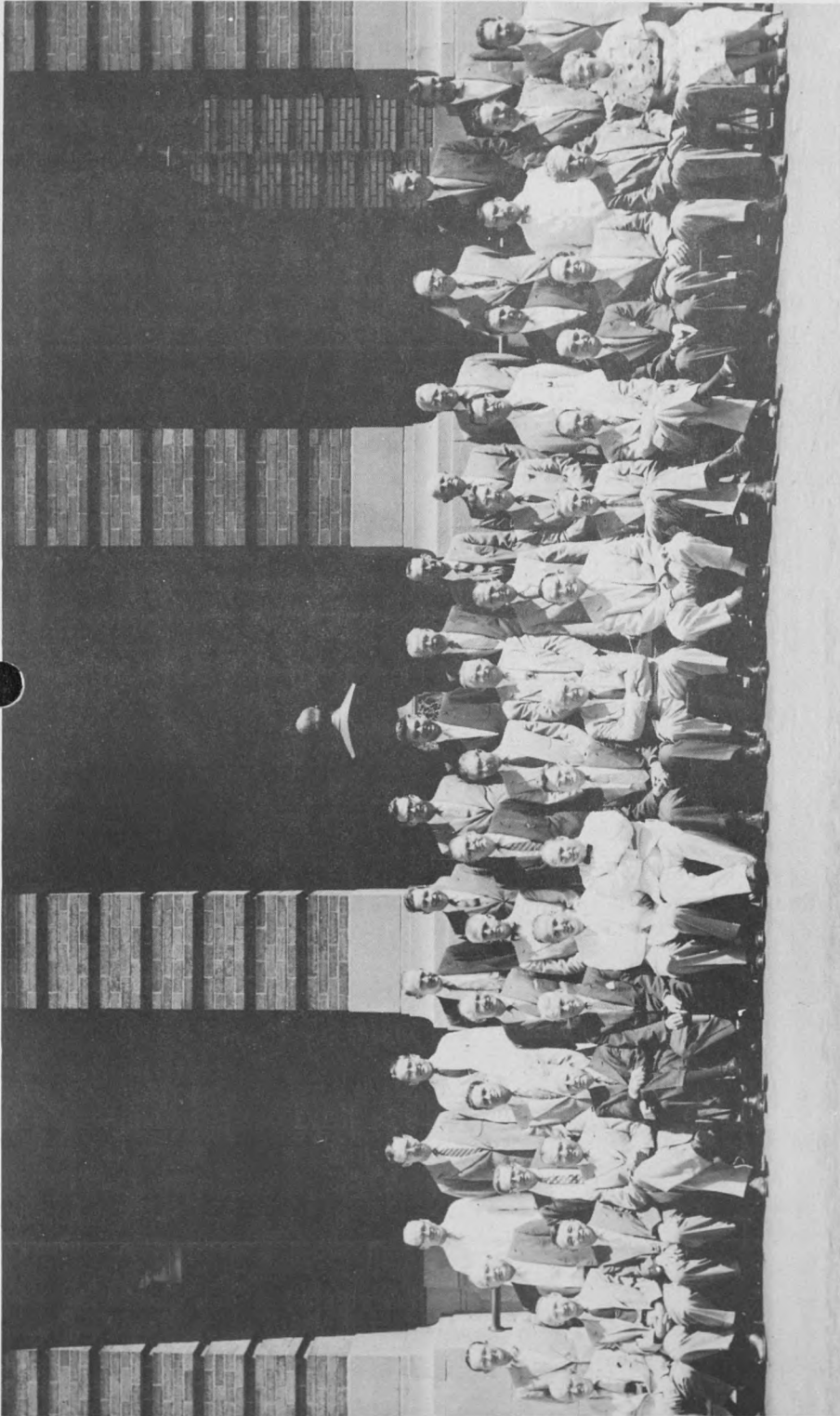
CHAPLAIN BOWLES TEACHES IN PASTOR'S SCHOOL
