## POPULATION AND REPRODUCTIVE HEALTH

### AT A GLANCE

- The Foundation's population and reproductive health grantmaking has two goals: to reduce maternal mortality and morbidity; and to advance young people's sexual and reproductive health and rights. Geographic priorities are India, Mexico, and Nigeria.
- The Foundation supports efforts that seek to accelerate progress on the United Nations Millennium Development Goal #5 aimed at improving maternal health. Grantmaking includes a special focus on two of the primary causes of maternal death: postpartum hemorrhage and eclampsia.
- Priorities for grantmaking on the sexual and reproductive health of young people include efforts to increase the availability of high quality sexuality education and confidential, youth-friendly health services.

### OUR GOALS

Two goals form the core of grantmaking:

- Reducing maternal mortality and morbidity; and
- Advancing the sexual and reproductive health and rights of young people.

MacArthur's work on maternal mortality aims to increase the chances that women will have safer pregnancies and deliveries, a worthy goal in itself, but also an indicator of the availability of services that are needed for women to make informed reproductive choices. The focus on young people is expected to increase the likelihood that they will make wise choices about their sexual activities. Given the effects of population momentum and the large cohort of young people, any delay in childbearing will have an effect on population growth rates.

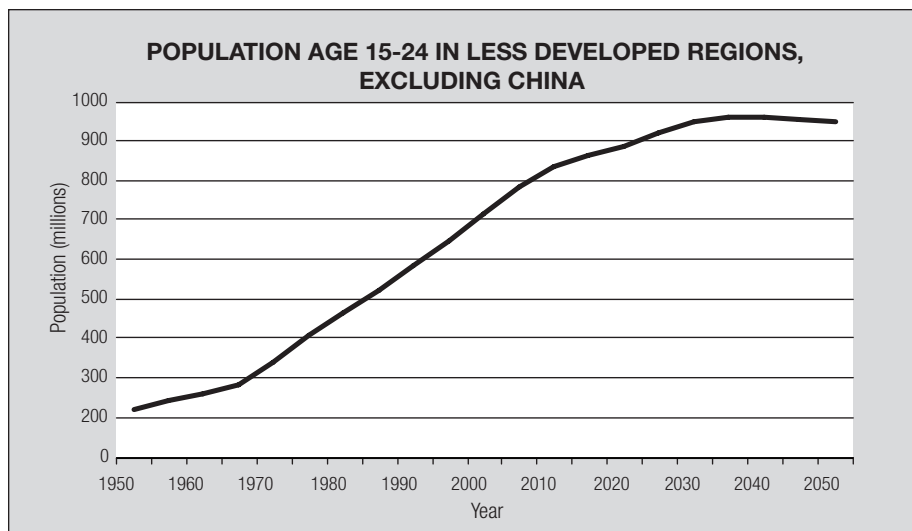
### KEY FACTS

- In the year 2000, the nations of the world reached agreement on the key steps needed to reduce global poverty—the Millennium Development Goals (MDGs). MDG #5 – Improve Maternal Health—is comprised of two targets: 1) reduce the maternal mortality ratio by 75 percent compared to 1990 levels by 2015; and 2) achieve universal access to reproductive health.
- Despite the global target, little progress has been made in reducing maternal mortality during the last two decades. Between 1990 and 2005, the global maternal mortality ratio decreased by only about 5 percent.<sup>1</sup> In sub-Saharan Africa, it decreased by less than 2 percent.
- More than half a million women die every year—about one every minute—due to complications from pregnancy

and childbirth. The vast majority of these deaths occur in the developing world. Approximately a third of maternal deaths occur in two of the Foundation's focus countries combined: India and Nigeria.

- The population of young people in developing countries will continue to increase. The sexual and reproductive decisions made by today's youth will have great impact on their personal lives and on society. From a reproductive health standpoint, adolescents are especially vulnerable. They have high rates of unwanted pregnancy and maternal mortality, are targets of sexual assault, and infection rates of HIV and other sexually-transmitted diseases that are higher than those among adults.

## WHAT WE FUND

### Geographic Priorities

For its work on maternal mortality and young people, MacArthur's population and reproductive health area focuses its work (and has offices) in three countries—India, Mexico, and Nigeria. The countries were chosen because they represent different conditions and are influential within their respective regions. Within each country, the Foundation has also selected priority states where grantmaking is concentrated. Some national level activities that support maternal mortality and morbidity and young people's sexual and reproductive health and rights, such as research and leadership development, are also supported.

### Maternal Mortality and Morbidity

In the three focus countries, the Foundation supports efforts that seek to accelerate progress on MDG #5. Grantmaking concentrates on two of the primary causes of maternal death: postpartum hemorrhage and eclampsia. These efforts include the introduction and scaling up of innovative technologies—such as the AntiShock Garment—and community-based models to reach a greater number of women. MacArthur also supports the enhancement of skills of health professionals to improve the quality and availability of services, as well as

informed advocacy on critical issues related to maternal mortality. Finally, we support policy relevant research that fills crucial gaps in knowledge.

### Young People's Sexual and Reproductive Health and Rights

The Foundation supports initiatives in India, Mexico, and Nigeria that increase the availability of high quality sexuality education and confidential youth-friendly health services. For example, the Foundation supports model sexuality education programs for in- and out-of-school youth and efforts to scale them up, improving young people's access to reproductive health services, and promoting an enabling environment for young people to seek those services. In Mexico, the Foundation has a particular interest in indigenous youth.

The Foundation also supports selected organizations in the population and reproductive health field whose work promotes innovation in policy, programs, and services.
