Dear Friends of The Endowment

California is an extraordinary state, known for its abundance, spectacular physical environment and leading social trends. Foremost among the state's attributes is the tremendous diversity of a population that hails from every part of the country and every corner of the globe.

The hope of The California Endowment is that our state will develop into an example worth emulating in the area of providing quality, affordable health care for all of our communities and residents. We believe California should be a beacon of innovative and effective multicultural approaches to health care; health care that works for everybody. Still, every day we read the headlines: "The numbers of uninsured have increased," "Health care costs escalate while service levels decline" and "Non-English speaking patients fall through the cracks."

To that end, The California Endowment is committed to helping to improve the health of all of the state's residents. On May 21, 2001, we marked our fifth anniversary. As we look back, we are heartened by the achievements of our grantees who, through grit and determination, are finding creative approaches to delivering critical health services and to advocating important health policy for Californians.

This report puts our brief past into perspective. You will see that our commitment is to California's people, in all of their diversity and creativity. You will meet individuals who've benefited from the organizations that have received funding from The Endowment, such as a Bay Area mother who is successfully living with AIDS, a family in Central California whose lives are made easier by access to health insurance, and a San Diego woman who has turned her family's history of diabetes into an asset for teaching others.

In searching for ways to improve the health of underserved populations, over the past year we were able to strengthen our efforts in enhancing the health status of the state's agricultural workers. We commissioned a much-needed examination of the health status of California's overlooked farm laborers. We created a task force of political and community leaders from around the state, resulting in a \$50 million commitment for the health needs of farm workers and their families. And we participated in the establishment of a relationship amongst the state of California, the administration of Mexican President Vicente Fox and our foundation to address and act upon this most pressing health issue.

The Endowment is committed to listening to California's communities - to hearing the needs of residents and learning about the resources and ideas of health practitioners. One example of our response to statewide concerns was that late last year we issued a request for proposals in the area of mental health, resulting in \$24 million in awards to 46 organizations.

Our five years have been characterized by growth – increasing the number and scope of grants made, developing the largest open application grants program within the state and establishing five regional offices. In the fiscal year ending Feb. 28, 2001 alone, we awarded 699 grants totaling \$191,350,500.

The five years have also been characterized by significant learning of the requirements, challenges, innovations and need for partnerships among the many stakeholders – the nonprofit, political and media leaders - working toward improved health. We want to especially pay tribute to those institutions and individuals around California who have helped with that growth and labored in partnership with us to meet the health needs of our neighbors. These grantees and health partners are showing us the way, relying upon diversity as a strength and the many cultures that we celebrate as precious assets in building towards a healthy tomorrow.

PROTEASE INHIBITORS, a powerful new class of anti-viral drugs that attack the protease enzyme used by the AIDS virus to multiply, make their debut and help to create what comes to be known as the "cocktail." In California nearly 100,000 people are living with AIDS.



MAY 21, 1996 — The California Endowment, a new health philanthropy, is created with a \$900 million fund as a result of the conversion of Blue Cross of California from a not-for-profit to a for-profit organization. One of its first grants is to Ventura County Community AIDS Partnership for a prevention program.

Asian & Pacific Islander Wellness Center

THE RAVAGES OF HIV/AIDS cross all boundaries. Health practitioners are well aware that successful treatment, prevention and education depend on a unique combination of comprehensive services and cultural and language expertise.

For many low-income, HIV/AIDS clients, the obstacles to receiving such care are great. Often uninsured, they are faced with confusing and scattered programs which make access difficult. Based in San Francisco's Tenderloin District, Asian & Pacific Islander (A&PI) Wellness Center provides peer-based services by utilizing staff and volunteers with firsthand knowledge about client communities: staff speak 18 languages and include youths, immigrants and refugees, people living with HIV and transgender persons.

The Center's clinic offers an effective continuum of culturally-targeted support services based on an innovative Treatment Case Management Model.



In 1997, A&PI Wellness Center received a grant from The Endowment of \$128,000 to stabilize its merger from two smaller organizations into a more comprehensive agency with greater language and program capacity. A second grant of \$300,000 in 1999 allowed the Center to transform itself from an HIV service provider into a model community wellness center that provides access to a broad range of health promotion services.



HEIDI SHIN'S FACE CRINKLES with laughter as she poses for a photograph with her daughter. They look like any mom and her child, caught in a loving moment and full of vitality. When Shin was first referred to A&PI Wellness Center she was in late-stage HIV disease: "I'd been told I would only live a few months." Now, she manages her illness supported by a team marshaled by her treatment case manager. "She got the best treatment," attests Rachel Matillano, who directs Care Services. "Heidi is a very strong self advocate," smiled Matillano. "She's really a fighter." With assistance from the Center, Heidi accessed resources ranging from psychiatric services and peer support, to medical advocacy and custody planning for her daughter.

The Center offers more than critical health services. "It's not enough to be a service provider," executive director John Manzon-Santos asserts. "The way we provide services also builds a sense of community. It's about breaking down isolation, and bringing the most disenfranchised into the broader community." Manzon-Santos moves constantly, leading a tour of the facilities, as he expresses the Center's unique vision. "We are connected," he argues. "We all live together."

Manzon-Santos describes the Center's outlook. "Clients are more likely to seek primary care if it's accessible." As Daniel D. Yu, MSW, writes in the *Clinician's Guide to Working with Asians & Pacific Islanders Living with HIV*: "Validating and even encouraging patients to use both Western and traditional treatments can help foster trust and collaboration." As one client puts it, "I learned that it is fine to be you, no matter what."

PRESIDENT CLINTON announces *One America in the 21st Century: The President's Initiative on Race* which commits the nation to the ambitious goal of eliminating disparities in health experienced by minorities in six critical areas by the year 2010.



MULTICULTURAL HEALTH: Recognizing that cultural competency and work force development are critical components of the President's call-to-action, The Endowment establishes A Multicultural Approach to Health which invests in programs that support these ideals.

Partnerships Empowering Youth to Serve

HEALTH CARE AND MEDICAL professions continue to be limited by a lack of racial and ethnic diversity. To address this issue, Partnerships Empowering Youth to Serve (P.E.Y.S.), gives high school and college students from disadvantaged African American and Latino neighborhoods leadership development, training and opportunities to volunteer and mentor in community agencies.

P.E.Y.S. has demonstrated that its activities contribute to the academic success of the students, provide support and outreach resources to needy communities and help prepare students for professions in health care and medicine.

Weekend training sessions teach the students about changing demographics of the inner city, conflict mediation, improving wellness and becoming advocates for community health.



To help administer California State University, Northridge Foundation's P.E.Y.S. program, The Endowment provided a planning grant of more than \$53,000 in 1997, followed by a \$15,000 grant in 1998 and in 2000, a three-year award of \$407,681. Since its inception, P.E.Y.S. has exceeded its goal by training and placing 155 students in dozens of community-based agencies, while offering select paid internships and developing curriculum materials so that the program can be replicated elsewhere.



ENGLISH TEACHER Bobby Minton's classroom hums with purposeful activity. It's an oasis in the midst of Watts, one of Los Angeles' toughest neighborhoods. About a dozen students at Riley High School, a continuation campus for pregnant teens, are eagerly engaged in a special summer project sponsored by P.E.Y.S. on personal and community empowerment. Healing artist Janet Bernson quietly moves from table to table as the students share with her the vivid masks they are making for a project on The Peaceful Warrior, studying the life of farm worker leader, Cesar Chavez.

The tables abound with paints on cardboard palettes, as well as bottles of white glue, glitter, yarn, fabric and colorful markers. Each element adds a unique texture to the masks which are like the students themselves: individualized, displaying real beauty. Exercises like these are part of the summer training Riley students receive through the P.E.Y.S. program. They will also tour regional college campuses and some will be awarded paid internships in community organizations. P.E.Y.S. has been working with secondary and elementary students since 1988, pairing its college participants with the public schools, touching as P.E.Y.S. founder Dr. Barbara Rhodes puts it, "two generations." CSUN students, such as Lilliane Hebert, work with Riley teens. About the experience Hebert says, "The opportunity to meet these young women puts my life in perspective."

A graduate of the P.E.Y.S. program, Camille Hill's experience led her to work with the downtown L.A. Skid Row agency, The Weingart Center. Hill credits P.E.Y.S. with helping her prepare for upcoming graduate level psychology studies at the University of Zimbabwe after which she plans to return to the house where she grew up in Bakersfield to "establish a community-based health organization that offers substance abuse treatment, counseling and mentoring." She's going to call it "Gladys' House," in honor of her late mother. P.E.Y.S., she declares, helped her realize that "It's in my genes to serve."

In the words of Dr. Rhodes, "We can't afford to lose people like Camille and the pupils at Riley High School."

DIABETES kills approximately 64,751 Americans, with the highest numbers being among African Americans, Latinos and American Indians and Alaskan Natives. Additionally, 798,000 new cases are diagnosed this year which contribute to the 10.4 million Americans with the disease.

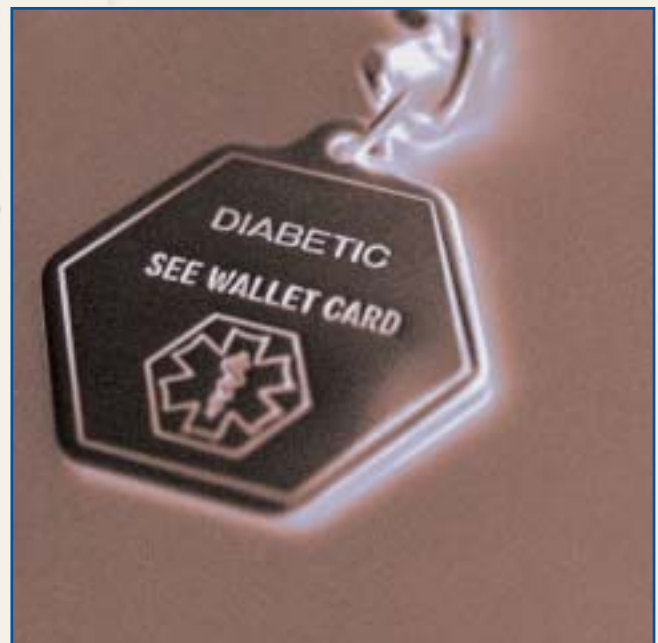


IN OCTOBER 1998, The Endowment debuts CommunitiesFirst, a responsive grant-making program which is rooted in the belief that the role of “community” is central to health, and that inclusion, partnership and community ownership are critical to addressing issues such as diabetes successfully.

Project Dulce

DIABETES IS THE most common health problem among minority populations. The risk of acquiring diabetes can be two to three times higher for Latinos, African Americans, Asian and Pacific Islanders and Native Americans than for Whites.

Project Dulce began as a community-based, pilot program to empower low-income and uninsured Latino patients to manage their own care with education about nutrition, exercise and medication. The program relies on *promotoras* (community outreach educators), mostly diabetics themselves who, after extensive training, are especially effective in culturally sensitive communications with patients.



The Endowment's \$451,000 grant to the Whittier Institute for Diabetes and Endocrinology in San Diego has been used to consolidate and expand Project Dulce throughout community clinics in San Diego County. The approach has reached more than 1,000 patients with diabetes, and administrators and providers are working to expand the promotora model to clinics serving Asian and Pacific Islander, African American and other diabetes patients.



“WE COULDN’T DO what we do in this population without the promotoras,” affirms Patty Dailey, a veteran registered nurse in diabetes care at the Logan Heights Family Health Center. She has treated countless patients in this low-income Latino neighborhood in San Diego and sees Project Dulce as a breakthrough. “It’s provided more of an integrated team approach in our clinic, with physicians, nurses and promotoras more effectively cooperating in comprehensive care for low-income, uninsured patients.”

One of those promotoras is Magdalena Hernandez, soft-spoken and genial. “I have a diabetic family,” she says. “One of my father’s sisters was diabetic. She died. My mom’s brother passed away, too. My older sister had diabetes. When I heard about Project Dulce, I was really interested.” Hernandez underwent rigorous training before beginning outreach efforts through phone contacts and home visits. In talking with patients, Hernandez explains, “We let them know how important education is. It’s the key to feeling good when you have diabetes. Because we’re coming from the community, they feel more confident and secure. We speak their language. We make it very simple, showing them how to use the monitor and test their glucose.” The work has had benefits for Hernandez as well. “I found a lot of friends. And I would like to go back to school to have a diploma. My daughter,” Hernandez adds, eyes shining, “tells me, ‘Oh, Mommy, I feel so proud of you!’”

Pilar Cruz traveled full circle: from an apathetic patient to an advocate for self-management of the disease. “At first,” she admits, “I didn’t really care. I said, ‘I’m going to die anyway.’ When I first began the classes my sugar was in the 300s to 400s, that’s how high it was.” The classes transformed her attitude. “I found out how to control the disease. Honestly, it really changed my life completely. This disease I have, I knew it could take my life. But I can also prevent it from killing me.” Cruz was selected to join the promotora training. “I’m real excited,” she confides. “I would like a career being involved with diabetes.”

California Telehealth and Telemedicine Center

THE U.S. *Surgeon General's Report on Mental Health* indicates that mental illness is the second leading cause of disability and premature mortality. In California, it is estimated that 1.3 million adults have a serious mental illness.



THE ENDOWMENT marks a record year of grant making - more than 50 percent of all grants made by the foundation since its creation are made this year. Of those figures, \$33 million comprising 127 grants are dedicated toward mental health.

California Telehealth and Telemedicine Center

DISTANCE, ISOLATION AND COST can prevent underserved rural and inner city residents from seeking physical and mental health care. Through the California Telehealth and Telemedicine Center (CTTC), the California Health Foundation and Trust is closing the economic and geographic gaps between physicians and mental health providers and their patients throughout the state. Sacramento-based CTTC supports health organizations that utilize new information and communications technologies to reach isolated patients who otherwise wouldn't have access to care.



A three and one-half year \$4.25 million grant in 1999 bolstered the California Health Foundation & Trust's California Telehealth and Telemedicine Center in its ability to meet objectives by supplying grants to about 31 technology projects, programs and networks around the state; providing education and technical assistance to health professionals; and functioning as a key component in implementing the state of California's strategic plan, *Telehealth & Telemedicine: Taking the Distance Out of Caring*.



DR. JOEL MORTON acknowledges that he was no instant convert to telemedicine. The pediatric psychiatrist at the Tri-City Mental Health Center says, "I was afraid the technology would be distant and impersonal." After dozens of consultations in which he sat in a room in Pomona providing psychiatric services through video conferencing technology with a patient hundreds of miles away, Morton found, "It's amazing how quickly you forget you're on TV. You get lost in what you do; focusing on the children, focusing on the parents. It's worked extremely well."

Since October 2000, the Tri-City Mental Health Center has conducted 700 patient visits with physicians seeing 200 individuals. On-site physicians coordinate services with local primary care doctors and therapists in remote areas. Tri-City runs model programs in Claremont, Pomona and LaVerne in eastern Los Angeles County, including wrap-around services for the homeless and incarcerated mentally ill; cooperative efforts with emergency and police personnel dealing with mental health calls; and comprehensive care for troubled youth. Now, the organization is a pioneer in treating psychiatric patients in remote locations through communications technology.

The first public mental health agency and system for telepsychiatry in California, Tri-City exemplifies what CTTC's Bill Halverson argues is most important in telehealth and telemedicine, that "technology, without networks of committed humans, is meaningless."

Executive Director Terry Kramer has expanded the center's reach to underserved residents in rural Kern, Shasta, Mendocino and San Bernardino counties. These counties are often unable to provide even minimal mental health care for residents and because of a shortage of doctors, patients often have to wait months for appointments, then travel extensive distances for doctor's visits. Patients can now access care through telepsychiatry centers established in nearby county facilities and Tri-City expects to add on networks in Humboldt, Trinity, Lassen, Lake and Siskiyou counties.

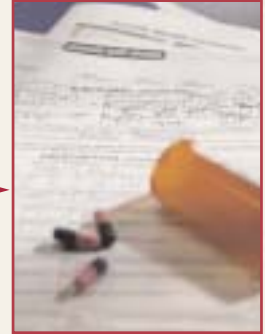
"We're finding," Kramer says, "Not only are patients getting telepsychiatry, but they are receiving the full spectrum of care."

NEARLY 7 MILLION of the country's estimated 42 million Americans without health insurance live in California—a figure of more than one in five non-elderly Californians. The state leads the nation in highest percentage of residents without health insurance.



AGRICULTURAL WORKER health is spotlighted as The Endowment announces results of the first-ever, statewide agricultural worker survey. A task force of political, health, labor and community leaders is formed to provide recommendations to improve the health of this underserved population – of those participating in the survey, 70 percent report being uninsured.

The 100% Campaign

CALIFORNIA HAS the largest number of children without health insurance in the nation. In low-income families, many with working parents, most of these 2 million uninsured children are eligible for public health benefits that can help prevent illness, provide them with regular check-ups and keep them in school.

The 100% Campaign has the goal of providing all of California's children with affordable health coverage. Coordinated by a collaborative between Children Now, The Children's Defense Fund and The Children's Partnership, the Campaign works toward this goal through state advocacy, policy research and working with a network of community and county-based organizations actively enrolling eligible children in Medi-Cal/Healthy Families.

The involvement of community alliances is critical. The majority of the applications received by the state for health coverage are completed with the assistance of the network of community organizations which stretches across California.



The California Endowment is the primary funder for the 100% Campaign, providing more than \$3 million over three years starting in 2001. The policy, advocacy and outreach work of the collaborative is a major boost to the state's Medi-Cal and Healthy Families enrollment. "Express Lane" strategies that could fast track enrollment for an estimated 700,000 eligible but uninsured children, have been developed as part of the effort.



“ONE HUNDRED and ten families were going to lose their benefits,” tells Manuel Romero, project director of Fresno Health Consumer Center of a recent crisis faced by field workers in the Central California area. “The parents would be covered, but the employer could no longer provide health insurance coverage for the children—he couldn’t afford the benefits.” In stepped the Medi-Cal Outreach Partners, of which Fresno Health Consumer Center is a part, which resulted in 80 families being enrolled in state insurance plans with approximately 276 children receiving coverage.

Fresno County has adopted a model, decentralized approach that is working. Community-based organizations such as Fresno Health Consumer Center, the Lao Family Community Center and Sequoia Community Health Foundation actively sign-up families for much needed health benefits.

The Sequoia Community Health Foundation in Fresno serves 65,000 patients a year; 80 percent are Latino farm workers, the remainder are of African American and Southeast Asian descent. “They are hard working, proud, industrious people who would much rather pay a small amount than to be on any kind of subsidy,” states executive director, Laurie Primavera. The program enables families to pay a low cost, based upon their income. The coverage is also crucial for health care providers. When low-income patients have no insurance, they usually wait for a crisis to seek care.

For Sherri Valdez, 9-year-old Richard’s mom, Healthy Families has been a lifesaver. Years ago she was on public assistance. “I didn’t want to stay. I was looking at the light at the end of the tunnel.” She completed training as a medical assistant, and through her job, enrolled Richard in Healthy Families. “It works out great. The payments are low. It’s convenient. Most importantly, if something were to happen to Richard I don’t have to worry about what am I going to do.”

Programs like the 100% Campaign and its success in the Central Valley perhaps best illustrate the impact of The Endowment’s funding—grantees “synergistically” working together from a statewide policy position to the local service provider and advocacy level.

1. ORGANIZATION

The California Endowment ("The Endowment") is a private foundation which began operations in May 1996. The Endowment is exempt from federal income taxes under Section 501(a) of the Internal Revenue Code ("IRC") as an organization described in Section 501(c)(3). The Endowment's mission is to expand access to affordable, quality health care for underserved individuals and communities and to promote fundamental improvements in the health status of all Californians. The Attorney General of the State of California has specific oversight authority related to The Endowment's Articles of Incorporation and certain bylaw provisions.

The Endowment was created as a result of Blue Cross of California (subsequently renamed Wellpoint Health Network, Inc., referred to as "WLP") changing from not-for-profit to for-profit status. Pursuant to agreements between WLP, created as a result of the change, and the State of California Department of Corporations, WLP made an initial cash contribution to The Endowment and issued all of its then outstanding common stock to California HealthCare Foundation ("CHF"). CHF is exempt from federal income taxes under IRC Section 501(a). As CHF sells the WLP stock over time, it must make contributions to The Endowment out of the proceeds from such sales of WLP stock, provided that The Endowment is a nonprofit public benefit corporation in good standing and continues to be an organization described in IRC Section 501(c)(3). CHF must transfer not less than 80% of the net cash proceeds, if any, of any WLP stock sale or disposition on or before the later of December 1 of such year or three months after the receipt of proceeds. See Note 7 for details of contributions received by The Endowment.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF PRESENTATION

The financial statements of The Endowment have been prepared on the accrual basis of accounting.

CASH AND CASH EQUIVALENTS

Cash and cash equivalents are defined as investments with original maturities of three months or less.

INVESTMENTS

Investments, which are all classified as trading securities, are carried at fair value as determined by quoted market prices, or based on quotations of similar securities, or other estimates where market quotes are not available. Investing activities are reported on a trade-date basis. Realized gains and losses are calculated based upon the underlying cost of individual lots. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized gain/loss on investments is based on the fair value of the assets at the

and unrealized gain/loss on investments is based on the fair value of the assets at the beginning of the year or at the time of purchase for assets purchased during the year and the related fair values on the day the investments are sold with respect to realized gains and losses, and on the last day of the year with respect to unrealized gains and losses.

PROGRAM-RELATED INVESTMENT

The Endowment invests in a project that advances its philanthropic purposes. This program-related investment ("PRI") is valued at estimated net realizable value.

PROPERTY AND EQUIPMENT

Property and equipment consists of capitalized leasehold improvements, furnishings, fixtures and equipment for The Endowment's offices, and are carried at cost, less accumulated depreciation and amortization of \$2,765,900 and \$1,576,800 at February 28, 2001 and February 29, 2000, respectively. Depreciation and amortization are computed on the straight-line method based on the estimated useful lives of individual assets ranging from three to five years or the term of the lease.

GRANTS

Unconditional grants are recognized as an expense in the period in which they are approved. Grants, which are conditioned on a future uncertain event, are expensed when these conditions are substantially met. There are no conditional grants at February 28, 2001 or February 29, 2000. USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

In the normal course of business, The Endowment uses various financial instruments, including derivative financial instruments, to maintain desired asset allocations, primarily in fixed income securities. Interest rate futures and options are purchased and sold to manage the interest rate risk on government and corporate obligations. The fair value of interest rate futures is included in investments. Any derivative financial instruments are recorded at their current market value with any changes reflected in income during the period of the change. The Endowment's investment managers are permitted, under the terms of individual investment guidelines, to utilize such financial instruments. As of February 28, 2001, The Endowment had fourteen interest rate futures contracts with delivery dates through March 31, 2002, one S&P futures contract with delivery date through March 31, 2001, and two interest rate put options with delivery dates through March 31, 2001. All of these instruments are supported by government and corporate obligations.

4. PROGRAM-RELATED INVESTMENT ("PRI")

The Endowment has invested a portion of its funds in a project that advances its philanthropic purposes. The PRI is in the form of a non-interest bearing \$20,000,000 loan to a non-profit entity to improve the healthcare conditions of farm workers. The duration of the loan is 30 years due February 2029 with the first payment commencing in fiscal year 2004.

5. COMMITMENTS AND CONTINGENCIES

The Endowment leases its office facilities and telephones under various agreements. Rental expense was approximately \$1,438,000 and \$1,444,300 for the fiscal years ended February 28, 2001 and February 29, 2000, respectively. 6. FEDERAL EXCISE TAXES

The Endowment is subject to federal excise taxes imposed on private foundations at two percent, or at one percent if certain conditions are met. The excise tax is imposed on net investment income, as defined under federal tax law, which includes realized gains on the sale of investments. The Endowment qualified for the one percent reduced excise tax for the years ended February 28, 2001 and February 29, 2000. Deferred taxes payable are recorded at two percent as the qualification for the one percent rate is not determined until the fiscal year in which the gains are realized. The Endowment is required to make estimated tax payments throughout the year. The Endowment made estimated payments that were in excess of the actual payment due which resulted in a prepaid excise tax amount of \$234,000 at February 28, 2001. A current excise tax liability of \$406,600 was recorded at February 29, 2000. Deferred taxes payable at February 28, 2001 and February 29, 2000, of \$1,944,400 and \$11,775,600, respectively, are related to unrealized appreciation, and are reflected as a liability until the related investments are sold or there is a change in the valuation of such investments.

7. CONTRIBUTIONS

As discussed in Note 1, The Endowment continues to receive contributions from CHF as it sells WLP stock.

8. SPECIAL DISTRIBUTIONS

During the five years commencing in the fiscal year ended February 28, 1997, The Endowment was required by the State of California Department of Corporations to make special distributions of at least \$150,000,000, which may include qualifying distributions made by The Endowment under the IRC as a result of the distributable amount for the fiscal year ended February 28, 1997. Such special distributions, not including the credit as a result of the distributable amount for the fiscal year ended February 28, 1997, were to be made as follows:

- At least \$30,000,000 shall have been made before the end of the first year, February 28, 1997.
- At least \$80,000,000 shall have been made before the end of the second year, February 28, 1998, including the distributions made in the first year.
- At least \$100,000,000 shall have been made before the end of the third year, February 28, 1999.
- At least \$120,000,000 shall have been made before the end of the fourth year, February 29, 2000.
- The balance of the \$150,000,000 shall have been made before the end of the fifth year, February 28, 2001.

The Endowment must also make certain distributions from certain designated proceeds transferred to The Endowment due to sales of WLP stock by CHF (See Note 1). During the years ended February 28, 2001 and February 29, 2000, The Endowment was required to make \$37,600,000 and \$65,500,000, respectively, of such distributions. All of these requirements were satisfied.

9. RETIREMENT PLANS

The Endowment maintains a qualified 401(k) Employee Investment Plan (“the plan”), which permits eligible employees to make voluntary contributions on a pretax basis. The plan allows participants to invest in a variety of investments. The plan was enhanced by employer matching for employees contributing to the plan, following six months of employment. The plan provides for uniform employer contributions of 75 cents for every dollar contributed by a participant up to 6 percent of the participant’s salary deferral contribution. The Endowment’s contributions to this plan for the fiscal years ended February 28, 2001 and February 29, 2000 were \$240,400 and \$179,600, respectively.

In addition, The Endowment has a defined benefit cash balance plan covering all employees with one year of service. The plan is entirely funded by The Endowment, with contributions based on a percentage of each employee’s annual compensation. The employees are vested 20% each year, with full vesting at the end of five years. Each employee’s account is credited each year with an interest factor, the lower of 5.25% or the interest rate on 20 year Treasury Bonds. At normal retirement age (65) employees are paid their accumulated amount in the plan, either as an annuity or lump sum, at their election. Upon termination of service employees may withdraw or roll over their vested accumulated cash balance.

At February 29, 2000, the most recent actuarial calculation, the Projected Benefit Obligation under the plan was \$641,000 and the Fair Value of Plan Assets was \$473,000; and Plan assets at market value and the accrued liability on the balance sheet exceeded the Accumulated Benefit Obligation. The Endowment contributed \$156,000 and \$197,900 to the Plan for the fiscal years ended February 28, 2001 and February 29, 2000, respectively. The Endowment incurred \$379,500 and \$234,700 in pension cost for the fiscal years ended February 28, 2001 and February 29, 2000, respectively.
