

## GRANTMAKING IN MEXICO

*The MacArthur Foundation's grantmaking in Mexico supports population and reproductive health and the development of effective human rights protections. In 2010, the Foundation has also begun a new line of grantmaking addressing migration issues in Mexico.*



### AT A GLANCE

- MacArthur's grantmaking began in Mexico in 1986; the Foundation opened an office in Mexico City in 1992. Since then, MacArthur has awarded 733 grants totaling nearly \$116 million to institutions and individuals in Mexico.
- The Foundation currently makes three types of grants in Mexico: for population and reproductive health, for human rights, and on migration issues.
- MacArthur's population and reproductive health grantmaking in Mexico focuses on helping reduce the highest maternal mortality ratios in the country and improving young people's reproductive and sexual health.
- The Foundation's support for human rights in Mexico focuses on efforts to improve justice sector reforms, legal protections through litigation, and public security through policy reform.
- MacArthur's grantmaking on migration in Mexico is aimed at helping diminish the vulnerability and exploitation of migrants and increase their life opportunities and their contributions to countries of origin and destination.

### WHAT IS A PRIVATE FOUNDATION?

In the United States, private foundations are charitable organizations that provide grants to organizations or individuals, helping those in need or working to solve social problems. Foundations can operate locally, nationally, or internationally and enjoy considerable flexibility in choosing where to work and what to support. Private foundations act independently of any private business and of the United States government; they receive no government support. Many private foundations, including MacArthur, have endowments that are the sole source of funds for the grants they make.

Mexico is one of four countries where MacArthur focuses its international grantmaking, including India, Nigeria, and Russia. The Foundation's current areas of emphasis in the country are population and reproductive health, human rights, and migration.

### HUMAN RIGHTS

MacArthur has awarded 92 grants totaling nearly \$17 million in support of human rights in Mexico. The MacArthur Foundation is contributing to human rights reform by strengthening the capacity of leading local rights organizations to promote human rights and engage constructively with government to strengthen laws and institutions.

MacArthur's human rights grantmaking in Mexico supports:

- Improvements in the administration of justice through support for human rights organizations and networks that monitor and deepen the implementation of reforms at the federal and state levels;
- The pursuit of strategic litigation around critical human rights issues through national courts and, when appropriate, the Inter-American Human Rights system; and
- Policy research and advocacy toward effective approaches to public security, including efforts to improve police accountability and respect for human rights through supporting research on systemic change and monitoring abuse.

Integral to these efforts is concern for the well-being of human rights defenders working on these and other important issues.

### POPULATION AND REPRODUCTIVE HEALTH

MacArthur has awarded 320 grants totaling nearly \$48 million in support of population and reproductive health in Mexico. MacArthur's grantmaking in this area reflects a comprehensive approach to reproductive and sexual health that places women's well-being at the center of population policy and emphasizes the rights of individuals to determine and plan family size.

The Foundation's funding focuses on:

- Reducing maternal mortality; and
- Advancing young people's sexual and reproductive health.

The Foundation's grantmaking seeks to reduce the gap in reproductive health inequities by focusing on populations in greatest need for improved access to reproductive health education and services, such as marginalized indigenous women and young people. MacArthur supports organizations that raise awareness about how to prevent maternal death and disability and improve the quality of health care in the rural areas of Oaxaca, Chiapas, and Guerrero, the states with the highest maternal mortality ratios in the country. The Foundation also supports efforts to reduce unsafe abortion-related maternal death. Reducing maternal mortality is an important indicator that women are receiving the reproductive health services they need.

Civil society organizations supported by MacArthur also work to improve the quality and delivery of comprehensive sexuality education and youth-friendly reproductive health services as a means to prevent unwanted pregnancies and increase young people's life options.

### MIGRATION

The Foundation has awarded 20 grants totaling nearly \$6 million in support of migration in Mexico. MacArthur is currently engaged in an exploratory phase of grantmaking on migration issues in Mexico as part of the Foundation's broader Initiative on Global Migration and Human Mobility, which is increasingly oriented toward the Mexico-U.S. migration corridor. The overall goals of the grantmaking are to provide better protections for migrants and help foster improvements in bilateral migration relations between the U.S. and Mexico. Specific work funded to date includes studies of migrant recruitment practices and research on the relationship between migration and economic development.
