
Outlook for Community Foundation Giving

Community foundations account for 1 percent of all U.S. grantmaking foundations but about 9 percent of giving. Since the start of the 1990s, the rate of growth in community foundation giving has surpassed that of U.S. foundations overall in all but two years. The latest year was no exception. Giving by community foundations jumped nearly 14 percent in 2007 to an estimated \$4.1 billion. (Adjusted for inflation, giving rose 10.7 percent.) Contributing to the faster growth in community foundation giving has been strong asset growth, new gifts and bequests from donors, and exceptional disbursements from donor-advised funds.

Looking ahead, close to two-thirds (64 percent) of community foundations responding to the Foundation Center's annual forecasting survey expected to increase their giving in 2008.¹ About half of these funders anticipated giving increases in the 1 to 5 percent and 5 to 10 percent ranges. Yet this positive finding was tempered by the 25 percent of community foundation respondents that expected to reduce their giving in 2008.






Accounting for inflation, community foundations reported the fastest cumulative growth in giving since 1990


Community Foundation Giving Patterns, 2006

The larger community foundations included in the Foundation Center's 2006 grants sample¹ were more likely than independent and corporate foundations to provide funding for the arts and religion. They were less likely to provide funding for international affairs, development, and peace.

By target population group, community foundation giving primarily benefited children and youth and the economically disadvantaged—consistent with independent and corporate foundations. Nonetheless, community foundations gave proportionately more than foundations overall for most population groups.

¹The Foundation Center's 2006 grants sample database includes all of the grants of \$10,000 or more awarded by 1,263 of the largest U.S. foundations, including 86 community foundations. The overall sample accounted for roughly half of grant dollars awarded by the more than 72,000 grantmaking U.S. foundations.

Education and human services were the top priorities of community foundations in 2006



Community foundations provided notably larger shares of their funding for the arts and religion than other foundations in 2006





In addition, grants may benefit multiple population groups, e.g., a grant for homeless children, and would therefore be counted more than once.







Note: Based on total giving by 717 grantmaking community foundations.


Assets: 52 percent of community foundations reported more than \$10 million in assets in 2006


