WHEREAS, on May 25, 1976, in an action pending in the United States District Court for the Eastern District of Tennessee, Northern Division, between Hiram G. Hill, Jr., Zygmunt J. B. Plater, Donald S. Cohen, The Audubon Council of Tennessee, Inc. and the Association of Southeastern Biologists as plaintiffs and Tennessee Valley Authority as defendant, an Order and Memorandum were entered against the said plaintiffs and the said plaintiffs having filed a Notice of Appeal from said Order and Memorandum to the United States Court of Appeals for the Sixth Circuit;
