#### **Editorial Statement**

Along with the assumption of our editorial responsibilities we also initiate a shift in the thematic focus represented by our journal. Thus, the articles contained in this, the seventh, issue of *Research in Language* address topics in applied linguistics which address diverse aspects of the complex processes of second language acquisition and foreign language learning, involving a whole spectrum of native-language backgrounds of L2 learners – the researchers' subjects and informants. The scope of inquiry ranges from studies of information processing, interlanguage theory and language contact phenomena to explorations of individual learner differences such as learning strategies and musical intelligence.
