SENATE LEGISLATION

SB-04F-1828

1 *SB-04F-1828: Title I, IX, X, XI, XII - Statutory Revision Cleanup*

2 Whereas: The Student Government of the University of North Florida was established to
3 represent student concerns in all University wide matters;

4 Whereas: The Student Senate is the legislative body of the University of North Florida's
5 Student Government given the responsibility of carrying out such legislative acts
6 that are necessary and proper for the Student Body of the University of North
7 Florida;

8 Whereas: Legislation dealing with necessary and proper statutory revisions shall be
9 considered by Student Senate;

10 Whereas: Titles I, IX, X, XI, XII are in need of revision;

11 Whereas: The Student Senate's responsibility is to make our statutes proper for the needs
12 of our students;

13 Whereas: Title IX is a repetitive and unnecessary statute and needs to be removed from the
14 system of statutes;

15 Therefore: Let it be enacted, that Title IX be removed from the University of North Florida's
16 Student Government System of Statutes.

17 Further: Let Chapter 100.1 B of Title I read as follows:

18 B. The following shall serve as the table of contents for the Student
