### **Division on Women and Crime Nominations 1998**

### Chair Nominee:

#### **Nicole Hahn Rafter**

Professor of Criminal Justice Northeastern University, College of Criminal Justice

#### Statement of Candidacy:

My work on behalf of the Division on Women and Crime goes back to prehistoric times, as I was one of the group who helped found the Division. Over the years I have served as the Division's Vice-President and as a member of its Executive Board. In addition, I was on the Editorial Board of *Women and Criminal Justice* from 1988-1995 and have published a number of articles in it. My other work for the DWC includes founding and co-chairing the Mentoring Program, Chairing the Awards Committee, membership on the Task Force on Sexual Harassment and the Nominations Committee, and chairing the Fellows Nominations Committee.

Outside the Division I have been active in feminist work both at my home institution where I am a long-term Executive Board member of the women's Studies Program, and in other grassroots and academic organizations concerned with women's issues. My research has often focused on gender issues, with my feminist work including *Judge, Lawyer, Victim, Thief: Women, Gender Roles, and Criminal Justice* (with Betsy Stanko, 1982); *Partial Justice: Women Prisons and Social Control* (1985, 1990); and *International Feminist Perspectives in Criminology: Engendering a Discipline* (with Frances Heidensohn, 1995). My most recent book, *Creating Born Criminals* (1997), applies a gender analysis to the history of biological theories of crime. Currently I am working on an encyclopedia of women and crime.

If elected Chair of the Division, I would encourage work currently underway while at the same time pursuing these projects: (1) making the Division more relevant to young women just entering the field; (2) documenting the history of the Division by establishing its archives; (3) renewing the push, which I initiated about 15 years ago, to educated all ASC members and Department of Justice personnel about the need for nonsexist language and for research samples that included both women and men.

Executive Counselors (three, elected in alternating years) (2 year terms)

Term of office on each incoming officer will begin with the close of the Division's Annual Membership Meeting following their election. Year one election will be held for Chair, Vice-Chair, and one (1) Year one election will be held for Chair, Vice-Chair, and one (1) Executive Counselor. Year Two (or alternating year) elections will be held for Secretary and two (2) Executive Counselors.

The 1997 officers were: Chris Rasche, Chair Evelyn Gilbert, Vice Chair Claire Renzetti, Secretary Phoebe Stambaugh, Executive Counselor Brenda Blackwell, Executive Counselor Carolyn R. Block, Executive Counselor

The current 1998 officers would be: Nicole Hahn Rafter, Chair Evelyn Gilbert, Vice Chair Claire Renzetti, Secretary Carolyn R. Block, Executive Counselor Susan Krumholz, Executive Counselor Brenda Blackwell, Executive Counselor (I am not certain on Brenda, but think her term ends this November. Chris Rasche would know for certain). 2) I believe the offices open for election this year would be: Vice Chair, Executive Secretary and one Executive Counselor).

3) I have faxed you a copy of the amended constitution and also placed one in the mail.

4) As of 3/17/98 there are 210 current division members.

5) The division signed peitions in September-October 1981 to form the Division on Women and Crime. The proposed DWC constitution was presented to the ASC Executive Board for consideration on November 3, 1982 and was approved by the ASC Executive Board in November 1983.

6) Re setting up a DWC web page, I don't think there would be a problem as long as it is hooked up to ASC's website. Our website is handled by the University of Maryland --BSOS.UMD.EDU/ASC. You might want to check with Sally Simpson at Maryland as she is handling any inquiries regarding the ASC website and we have a Maryland student who is updating our website weekly. Sally's telephone number is 301/405-4726 and her email address is ssimpson@bss2.umd.edu.

7) Re archiving the DWC material -- I have some of the early correspondence and information regarding the establishment of the DWC constitution and DWC newsletters. It was previously suggested by the Division that an archive be set up at Northeastern, but I do not think approval was given from the Board as yet on this matter. Re cubic feet, I could not tell you. I presently have the files in one drawer, but other items such as extra newsletters, curriculum guides, etc. are stored in our storeroom.

8) Anything you need duplicated for the Division can be sent to me and I can take care of it for you and charge the Division for the necessary postage, etc.

9) Current officers of the Division on People of Color and Crime are co-chairs: Julius Debro (University of Washington) and Ruth D. Peterson (Ohio State University). They have not yet had an election. 10) My email address is

Dear Dr. Rafter:

I am writing to you by way of introduction from Dr. Donna Hale, Editor of the quarterly journal <u>Women & Criminal Justice</u>. A sample copy of the journal is enclosed in case you have not seen it lately.

Dr. Rafter, Haworth has repeatedly implored the women's division of the American Society of Criminology to consider adopting the journal into the section's dues structure, and thus provide the journal as a membership benefit to attract new members to the special interest group and help retain existing members. The journal had previously had an individual rate of \$36.00; this will be raised to \$45.00 starting with Vol 10, #1.

I understand that your society has about 200 individual members. If the group adopted <u>Women & Criminal Justice</u>, we would provide a bulk rate subscription of \$24.00 per member. In addition, Haworth would include a membership procurement form in both the journal and in its direct mail advertising each year in both our criminal justice (n = 100,000 mailing pieces) and women's studies (n = 80,000 mailing pieces) per year. In addition, I believe Dr. Hale might be open to arranging an editorial liaison between the society and the journal, which might include:

- a separate Boad of Editors further representing your group
- alloting several pages of the journal in each issue for the use of the society;

I must stress that these are my own suggestions and speculations; the final decision must be made by Dr. Hale.

Of all of the benefts of adoption, I could not stress enough the beneft of Haworth's membership marketing. I am not sure if a prospective member must also be a member of your parent organization. If not, the net membership gain would be even Haworth would be reaching out through direct mail greater. to such groups as:

- women's prison administrators, supervisors, job skill training programs;
- women probation & parole officers
- broad, general criminology society mailing lists
- women & crime academics from the disciplines of sociology, psychiatry, psychology & social work
- teachers of women & criminal justice in schools of criminal justice and programs in criminal justice
- foreign/overseas specialists in women & criminal justice
- authors of journal articles specifically dealing with women & criminal justice through a weekly computerized scan from the ISI data base (Institute for Scientiific Information)

And lastly, the journal Women & Criminal Justice is slated to provide an electronic journal format in late 1998 available for a minor 10% - 15% surcharge for those who subscribe to the print version.
