Overview

The University of Windsor implementation of the Ithaka S+R Local Faculty Survey was launched on November 3, 2014, and was closed to new responses on November 30, 2014, with a total of 227 complete responses. The survey covers many scholarly research and teaching-related topics, overlapping with several iterations of the Ithaka S+R U.S. Faculty Survey. The questionnaire covers topics in several key areas, including: how faculty members discover materials for research; faculty members' data preservation and management behaviors and needs; their digital research activities and methodologies; practices and attitudes regarding undergraduate students' research skills; the role of the library in supporting faculty members' needs; faculty members' scholarly communications needs and behaviors; and practices and attitudes regarding research dissemination. Ithaka S+R worked with the University of Windsor and other CARL institutions to develop a version of the survey instrument for the Canadian context. The following report provides a high-level overview of findings from the University of Windsor survey.¹

Details

1,073 uWindsor faculty members received an email invitation to participate in a survey about the impact of electronic technologies on their research and teaching. Three email reminders were sent before the close of the survey. In total, 335 respondents started the survey (about 31%), with 322 of those partially completing the survey (about 30%), and 227 of those respondents completing the survey, for an overall response rate of about 21%. Due to the survey flow and skip patterns, not all uWindsor faculty respondents received every question in the survey.

How to interpret the findings

For each question in the uWindsor faculty survey, this document provides a graph and table of overall responses. Responses are generally grouped together into categories for questions where respondents are asked to respond on a 1 to 10 scale. We report on responses in three categories: 1-3 (strong negative response), 4-7 (moderate or indifferent response), and 8-10 (strong positive response). Questions that use a 1-6 scale, and their responses are similarly grouped into categories: 1-2 (strong negative response), 3-4 (moderate or indifferent response), and 5-6 (strong positive response). Title pages provide information about contingent items, which signifies that a question was only presented to those who satisfied a condition in their response to another question.²

¹ This report covers results from completed surveys and does not include an overview of partially completed responses. Partially completed responses are included in the spreadsheet of data.

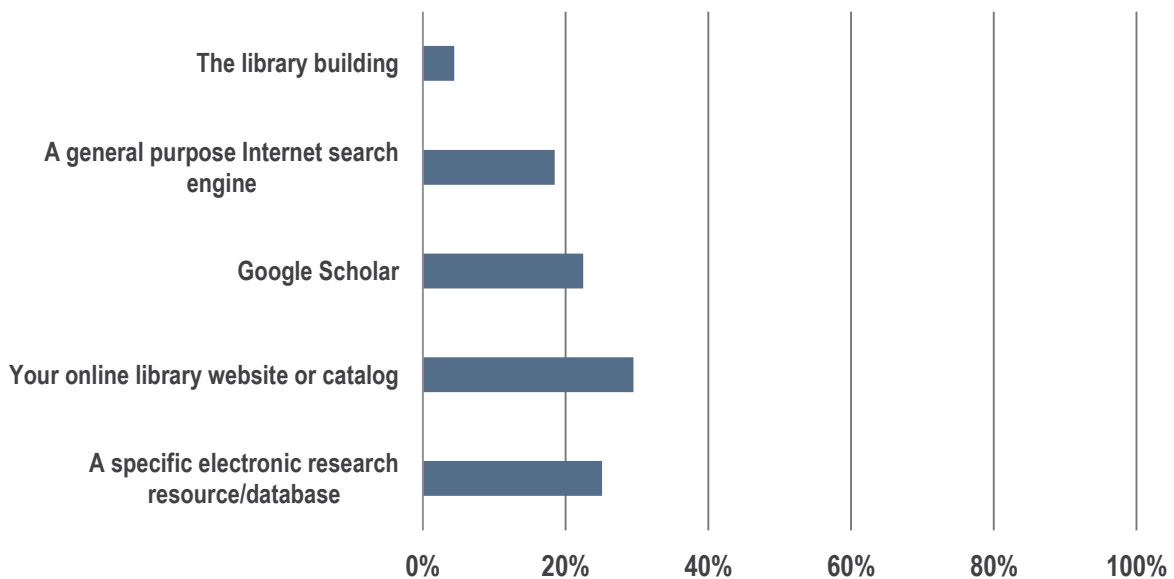

Which of these five starting points do you use to begin locating information for your research?

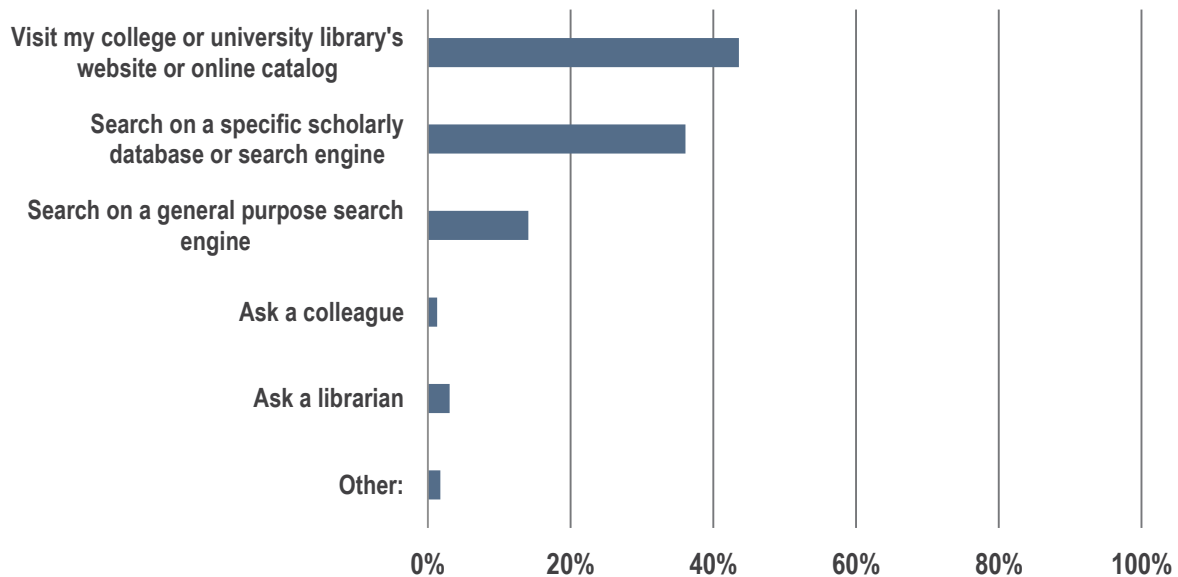

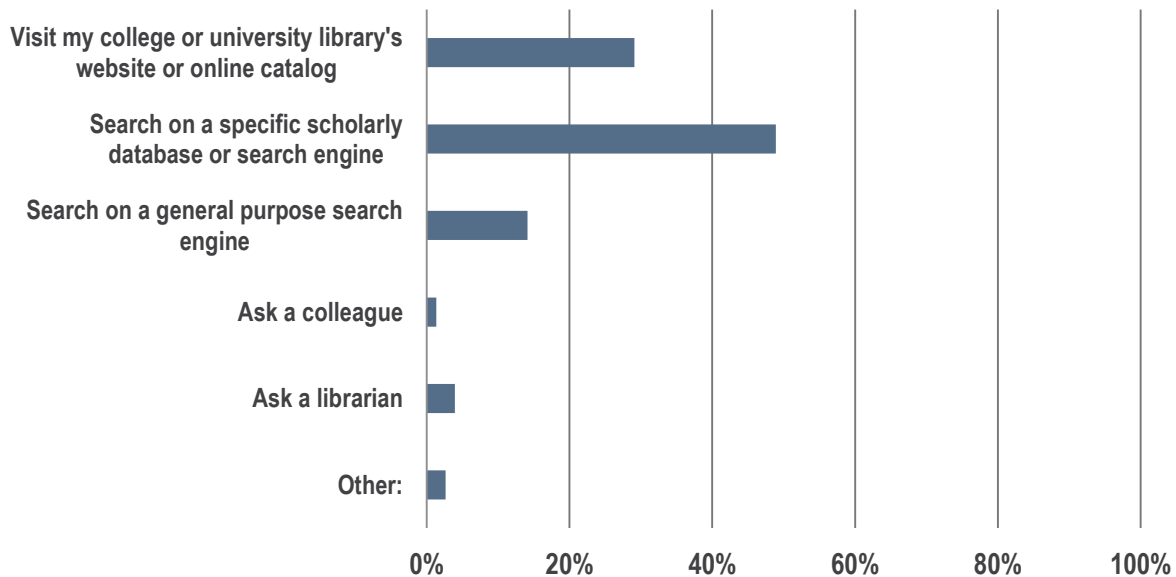

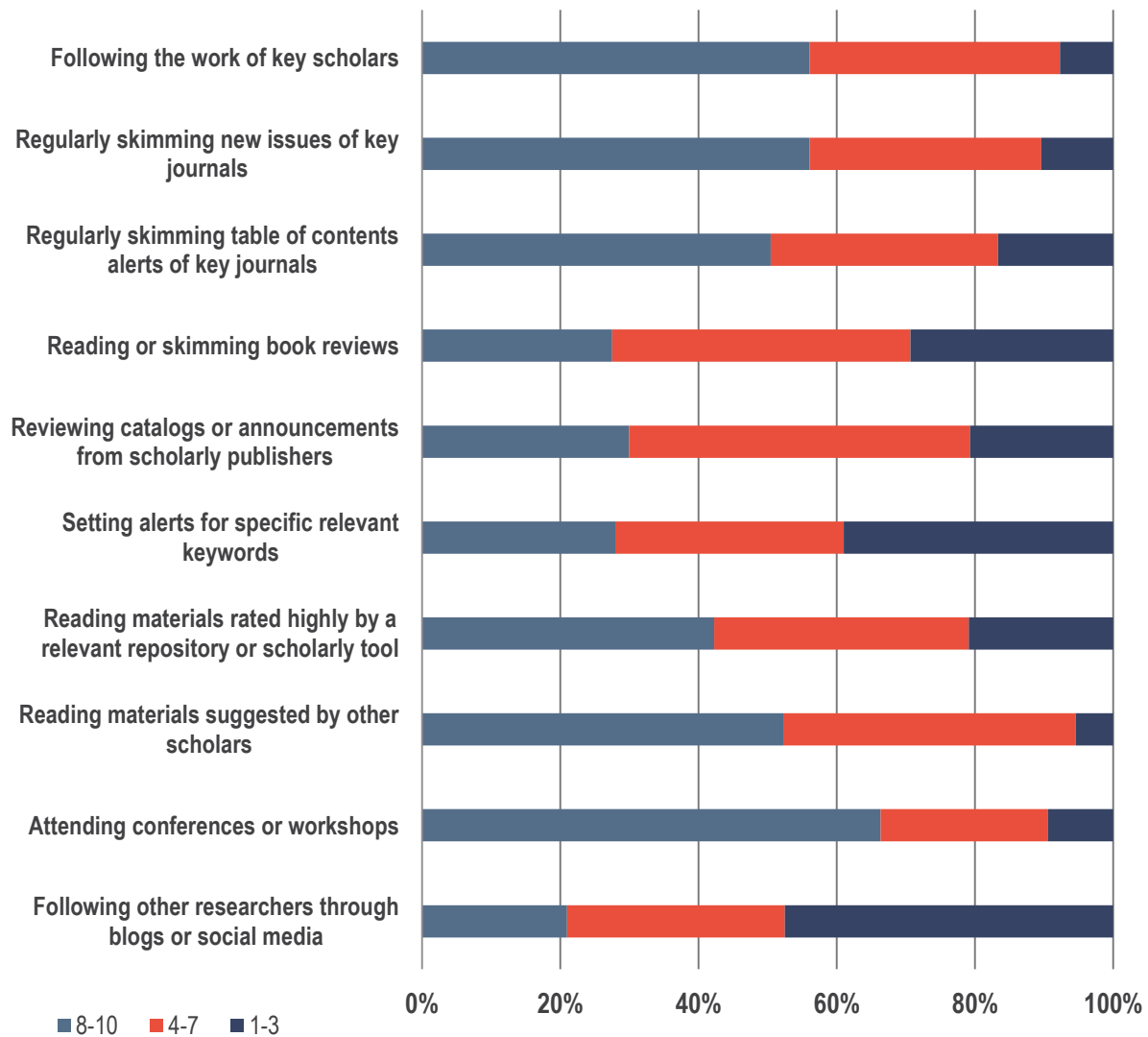

Is performing academic research among your professional responsibilities?

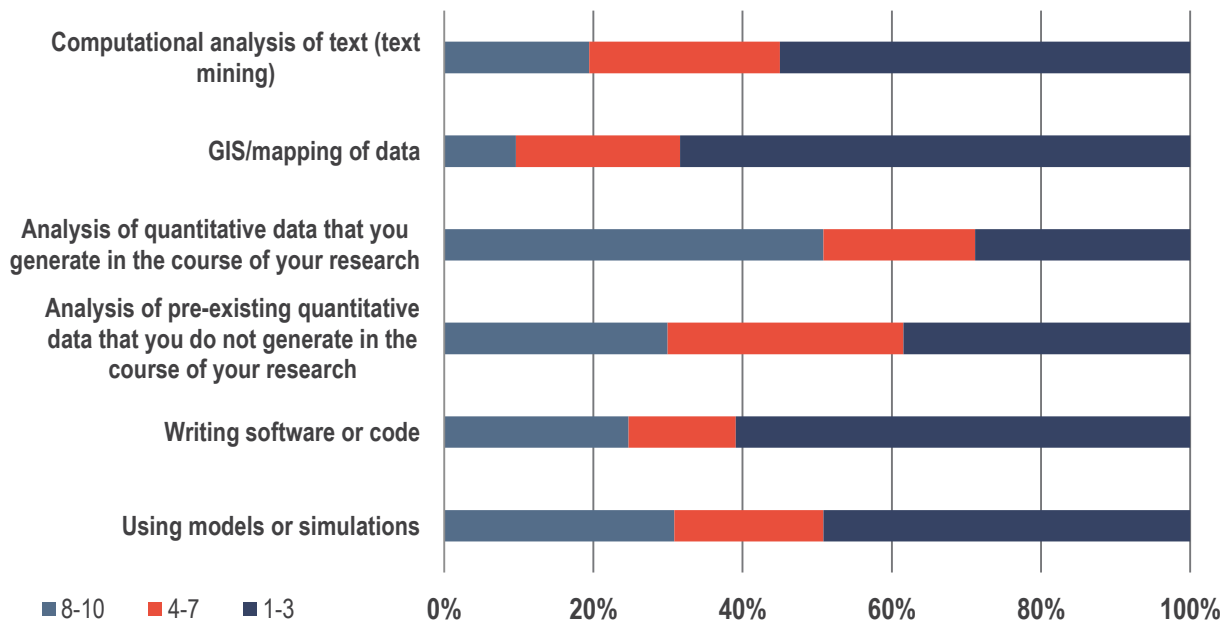

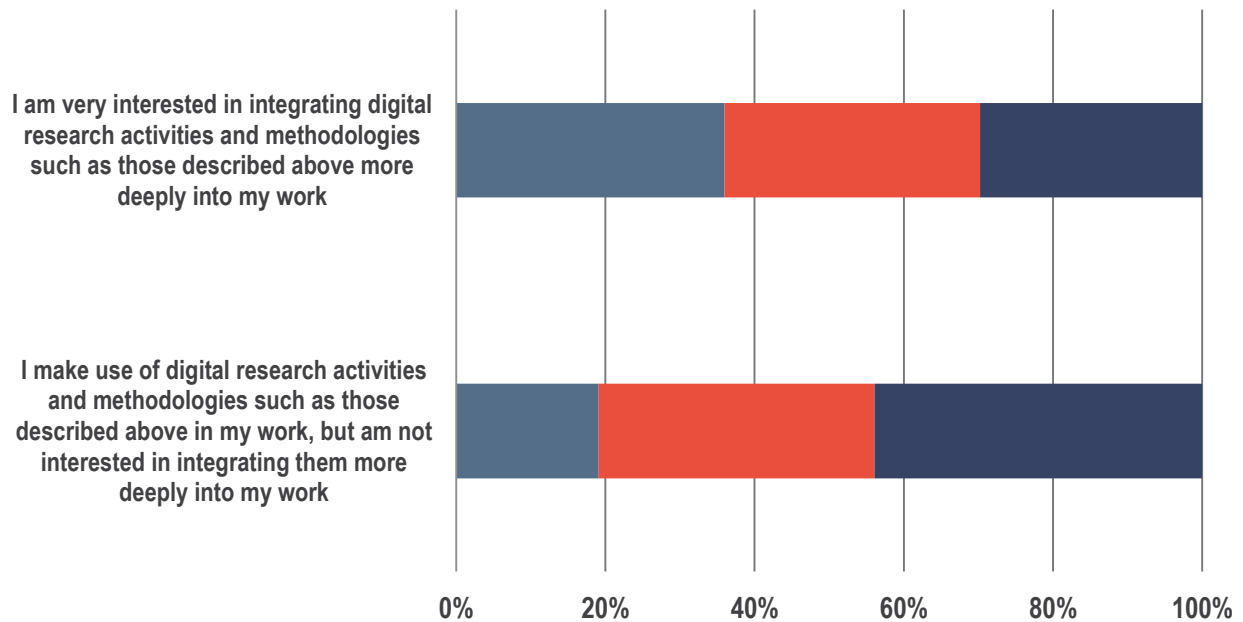

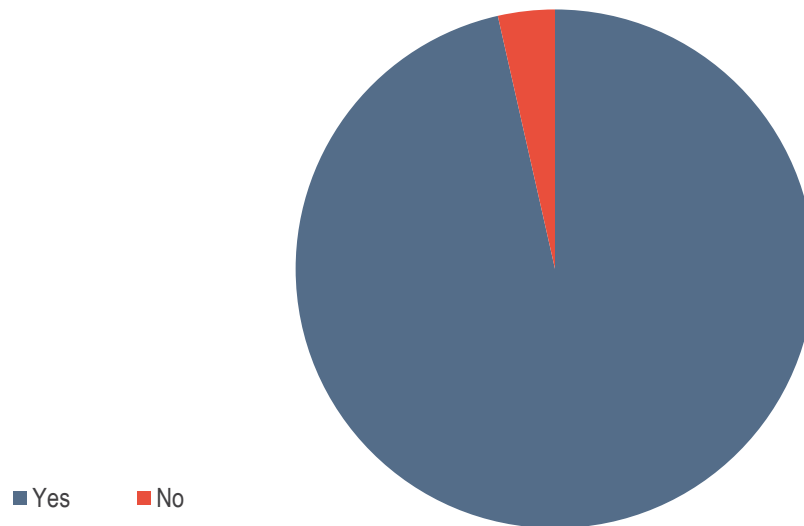

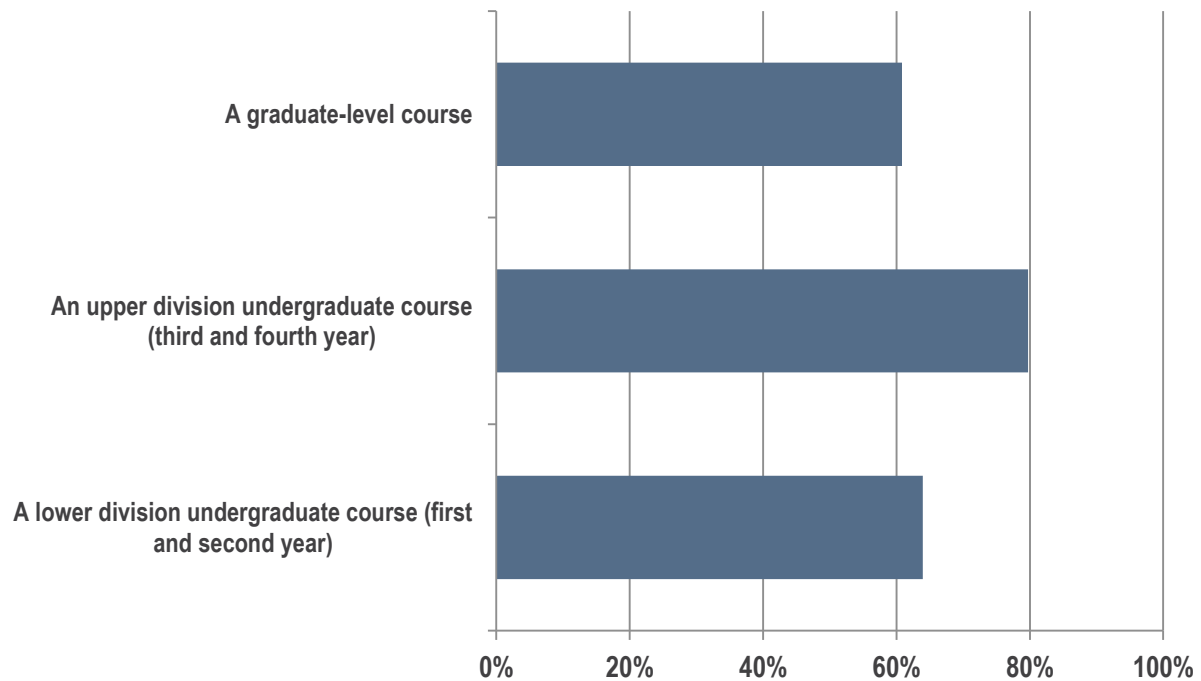

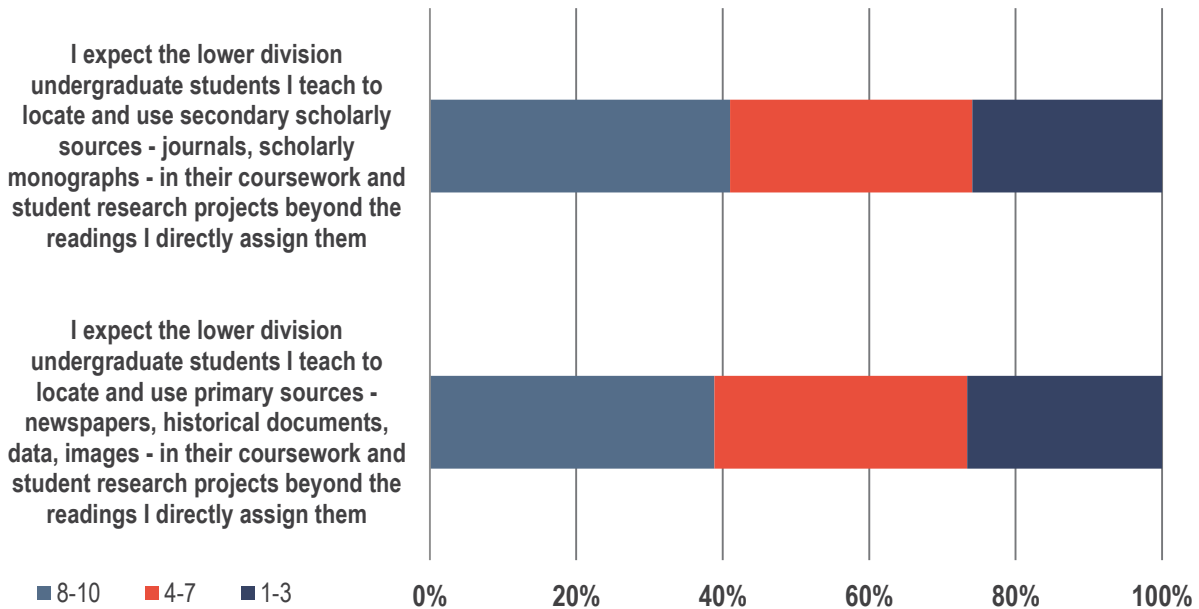

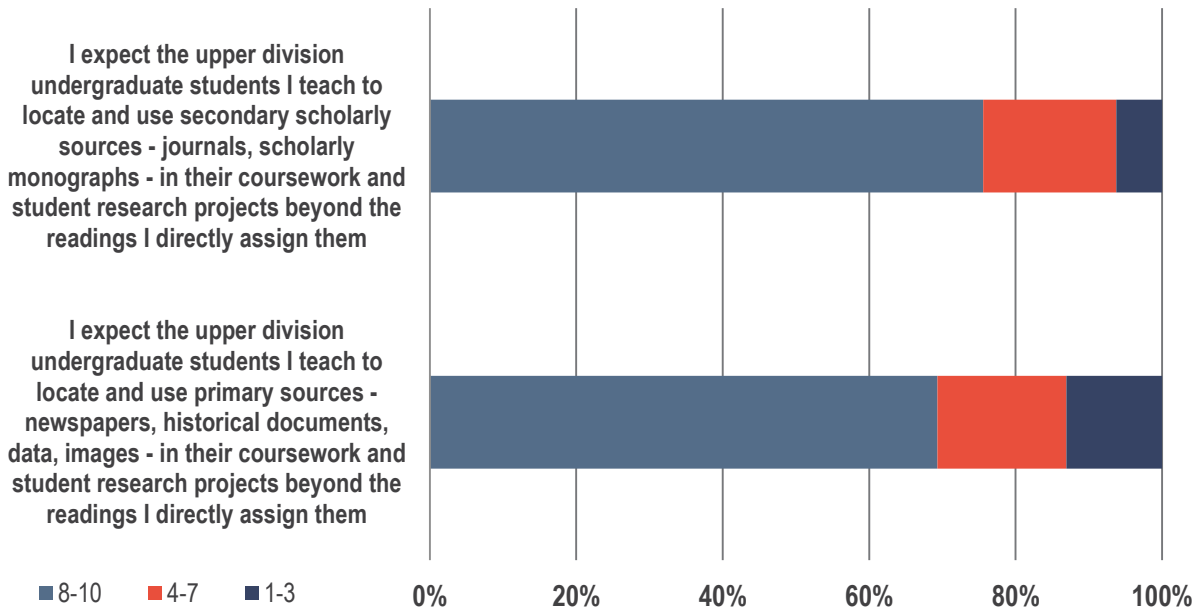

Faculty members' expectations regarding upper division students

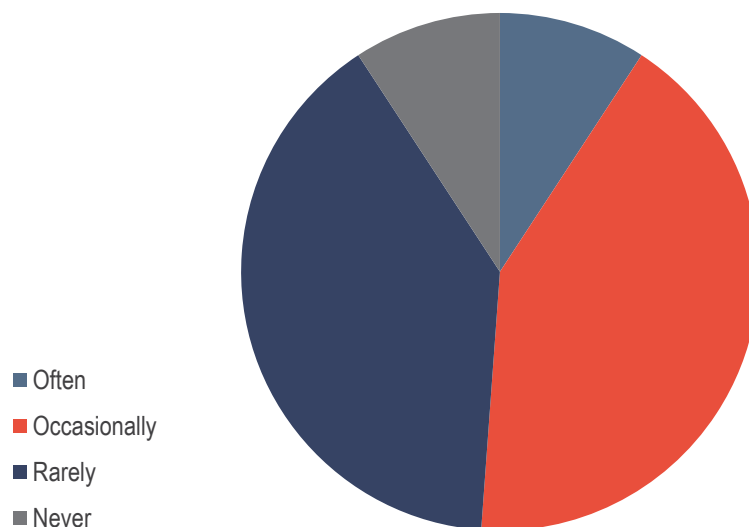

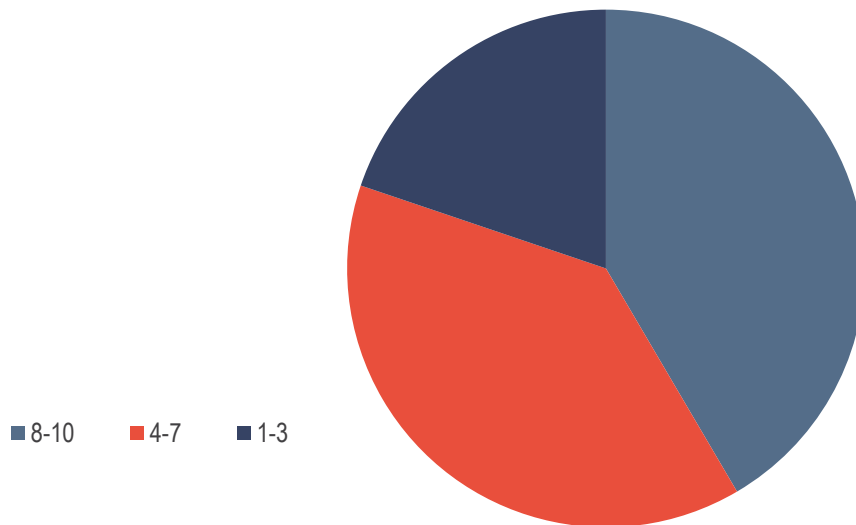

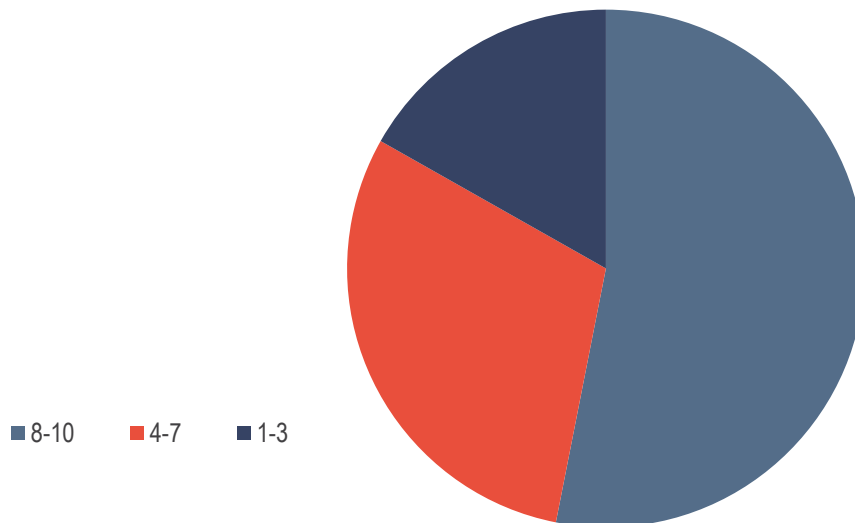

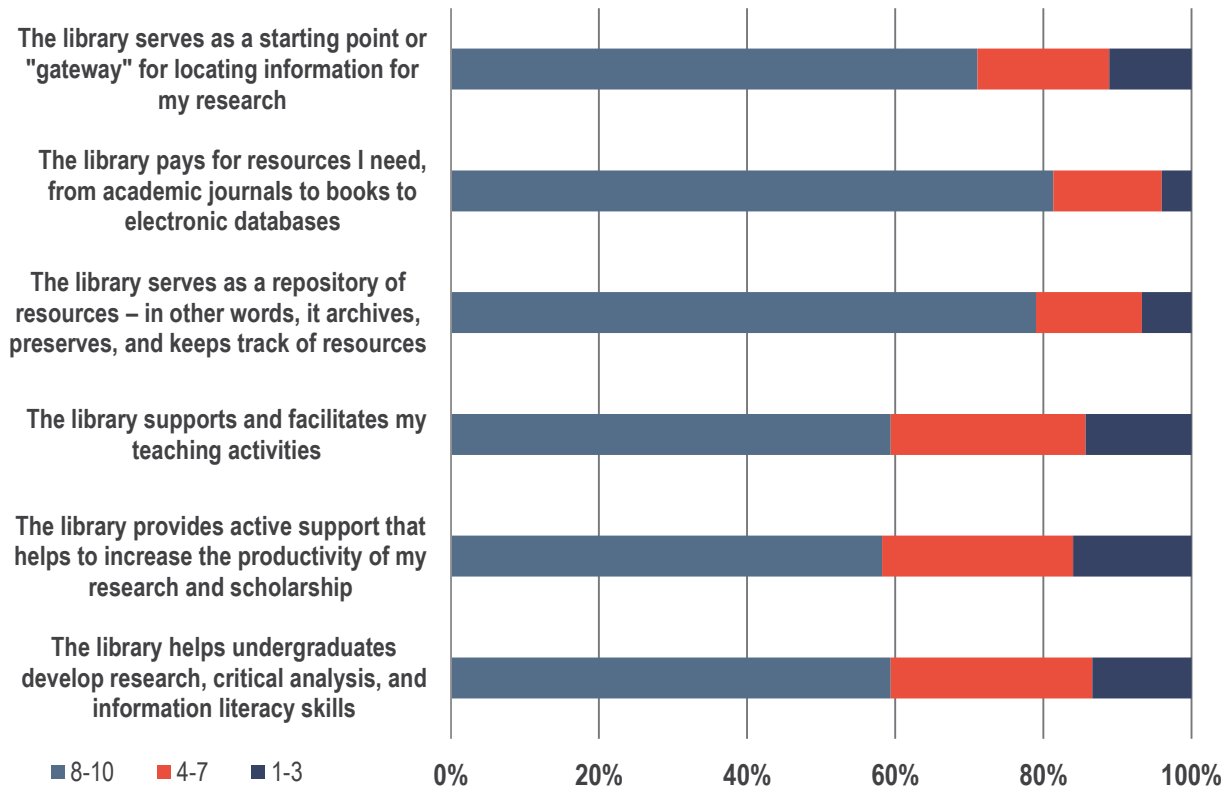

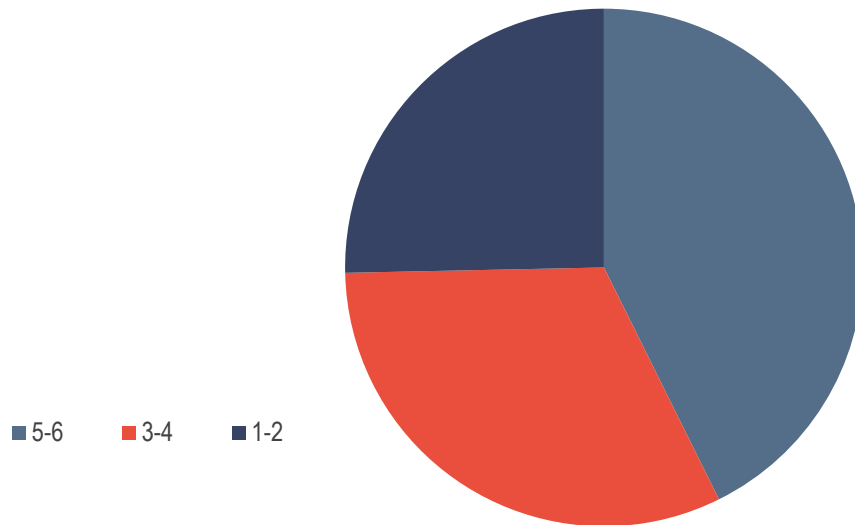

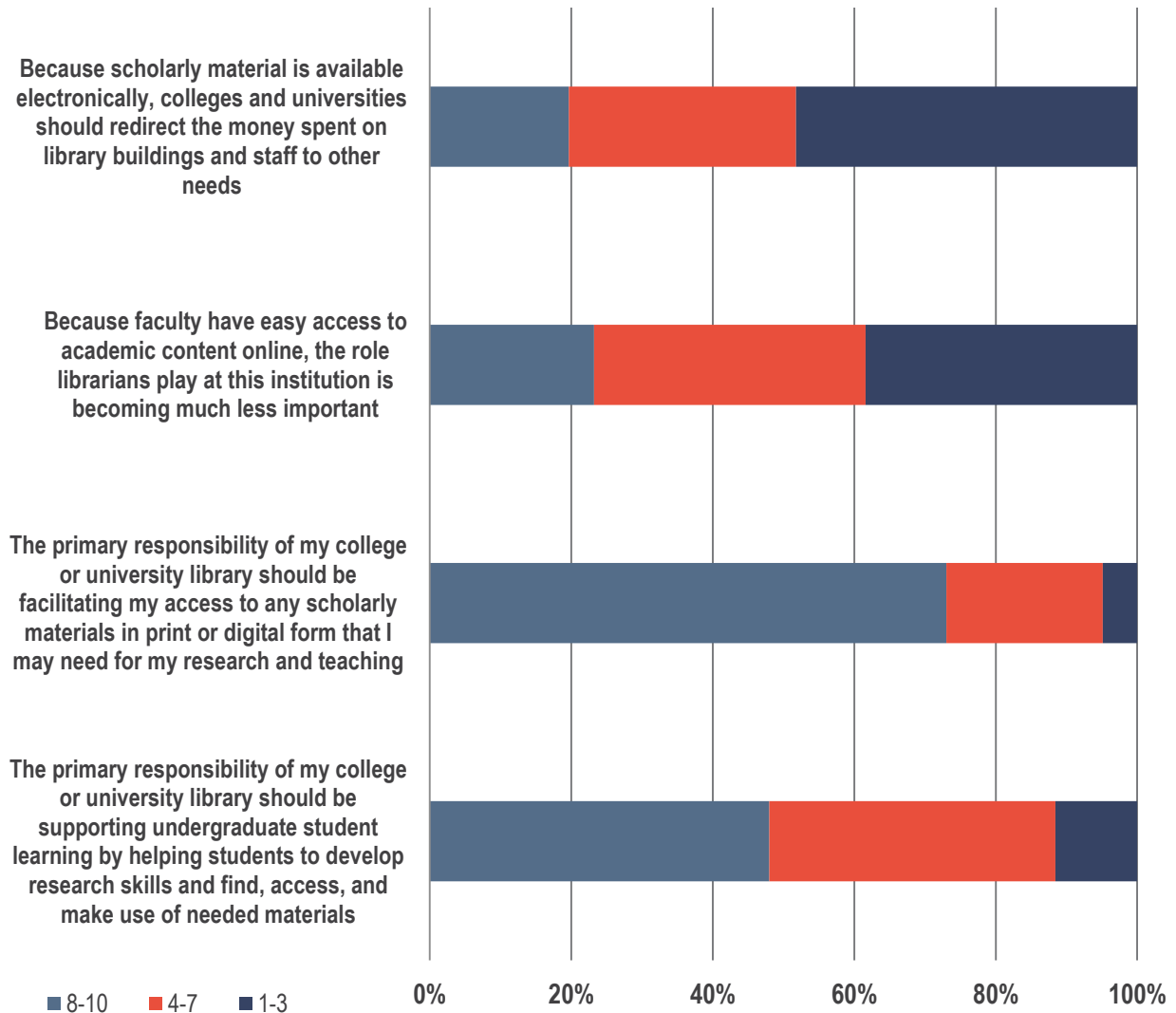

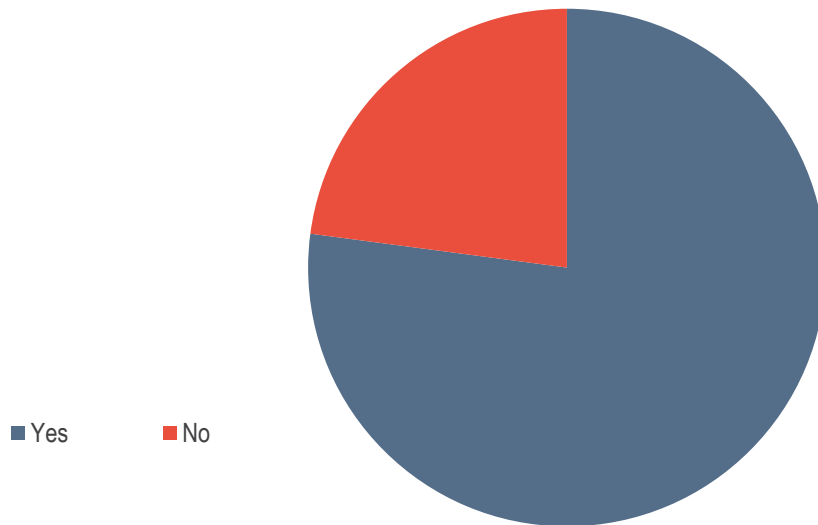

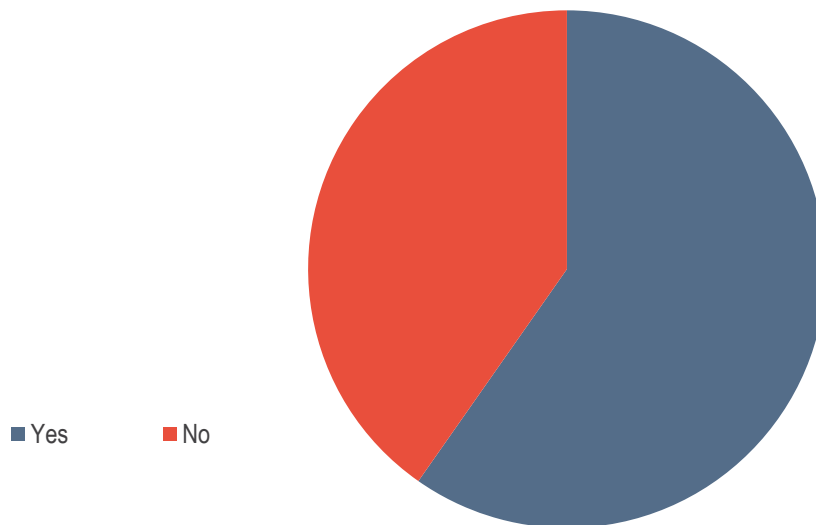

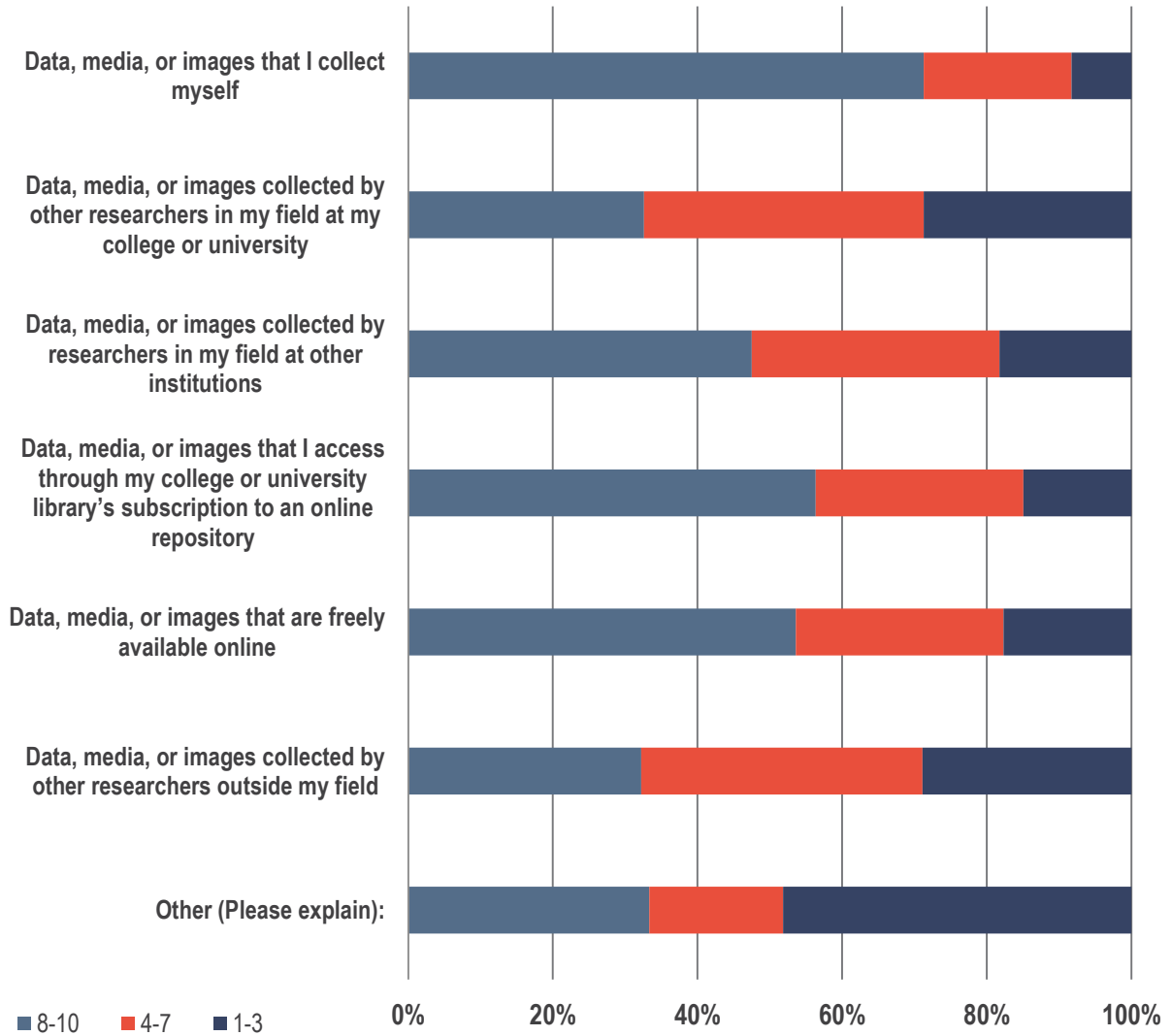

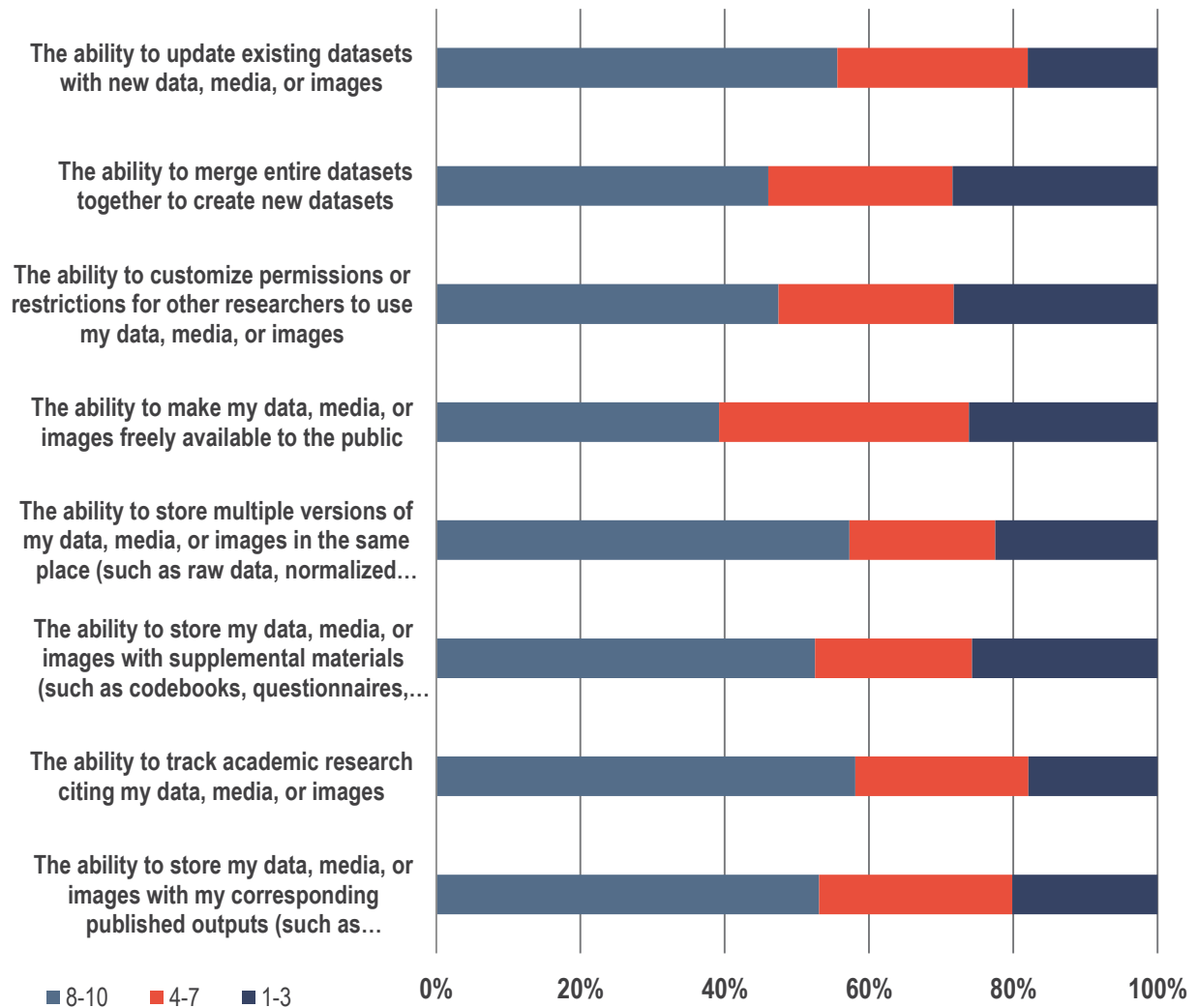

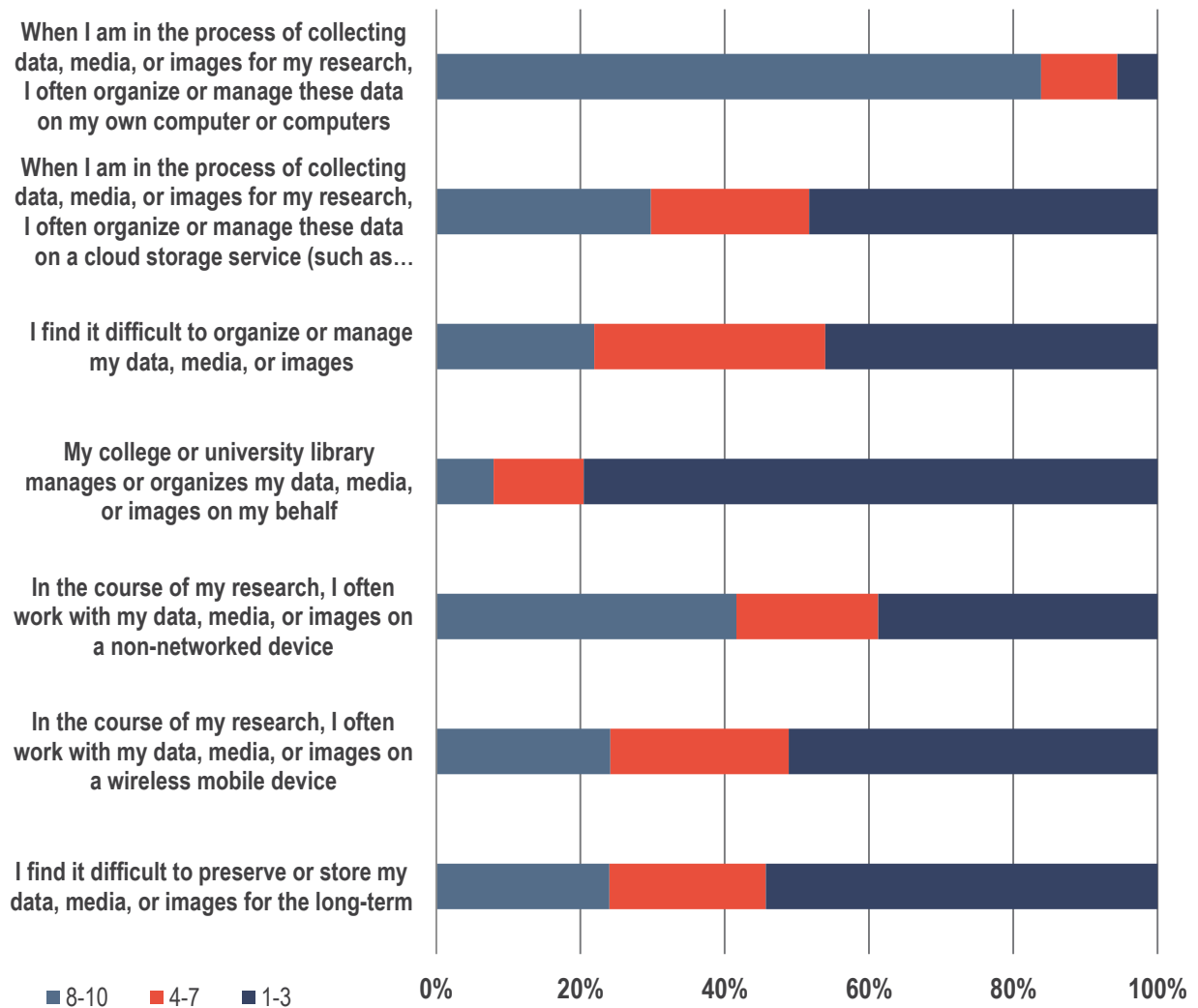

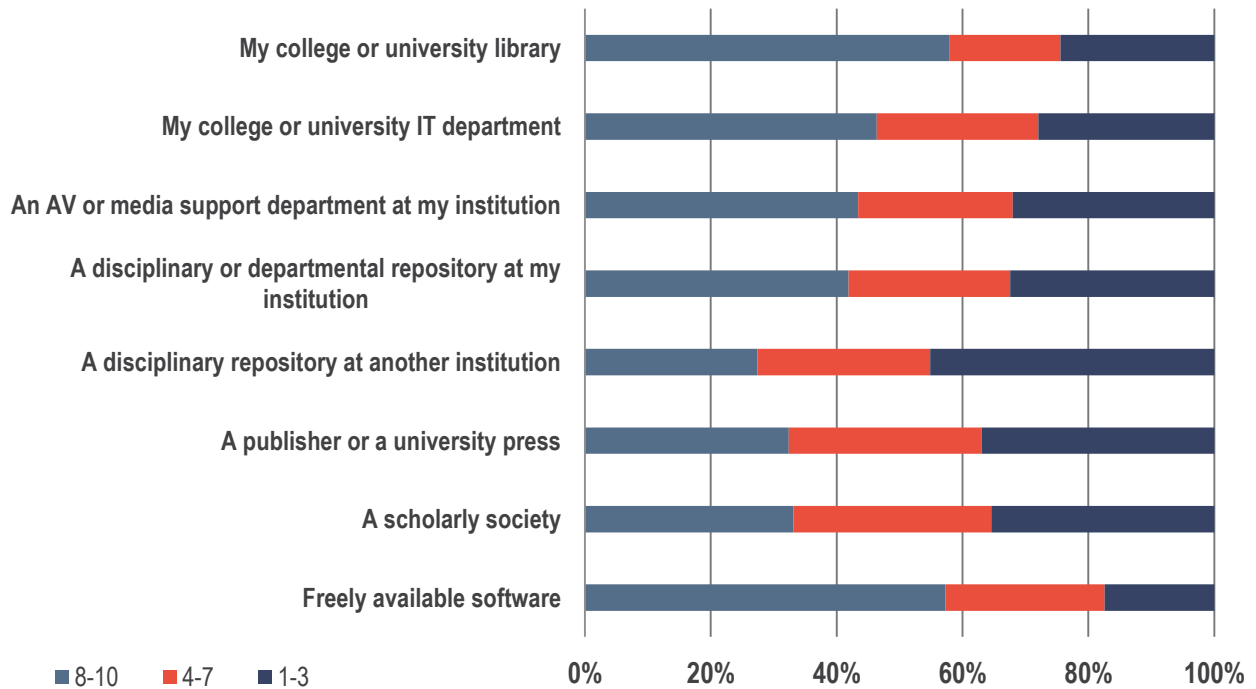

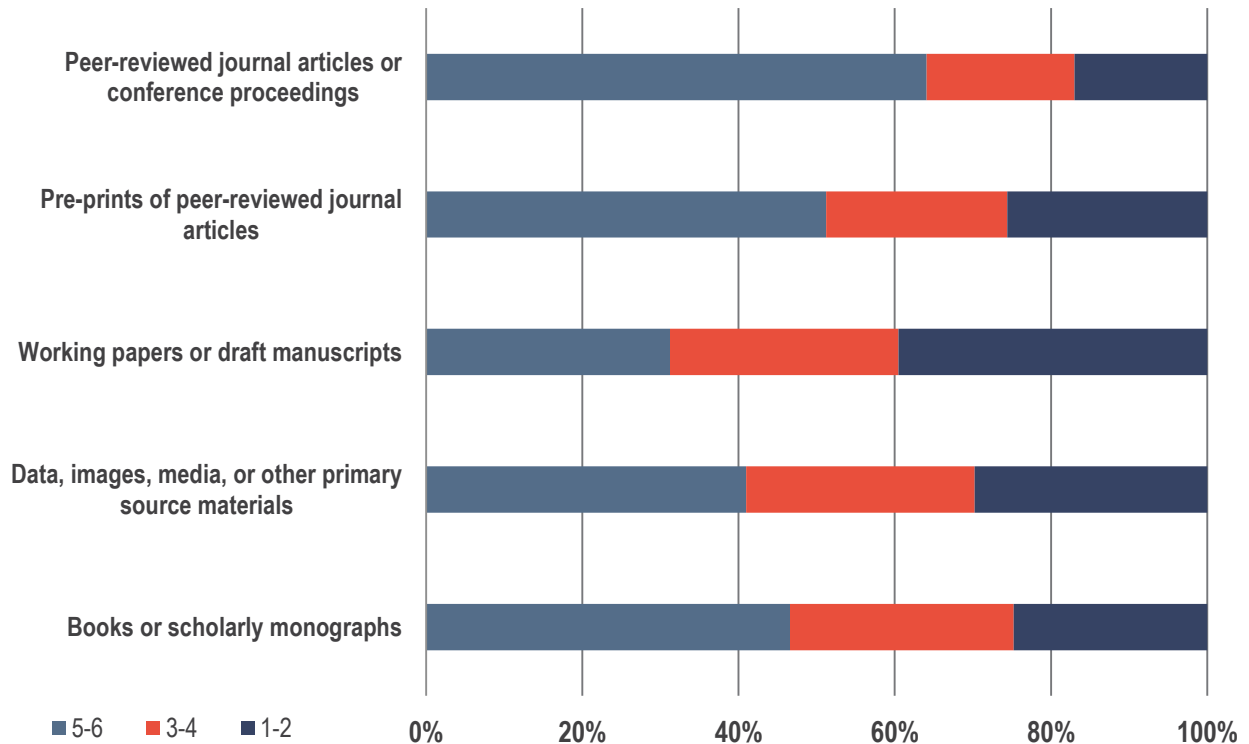

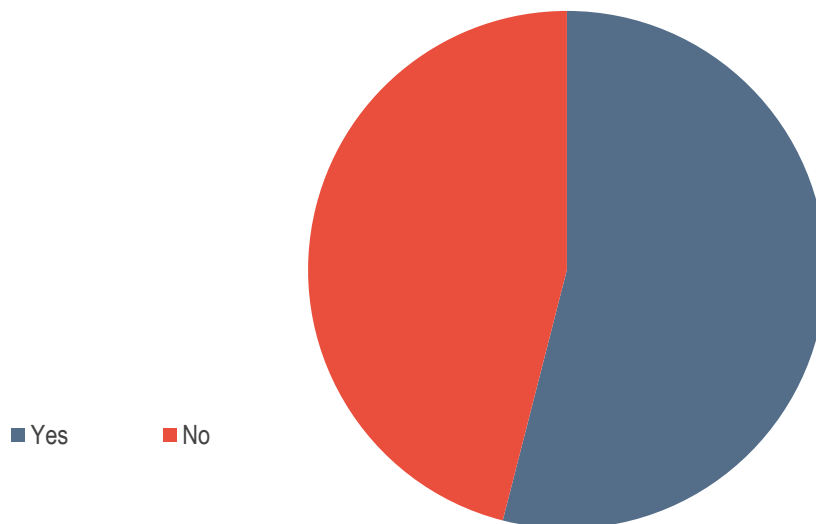

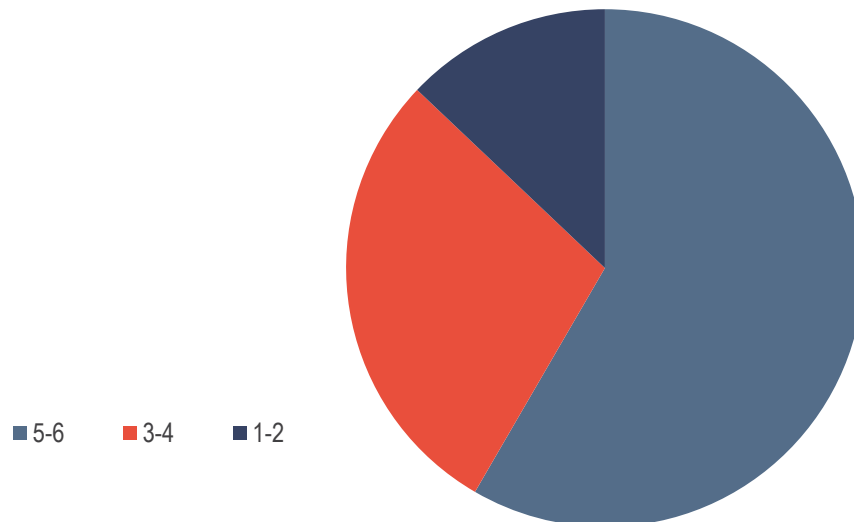

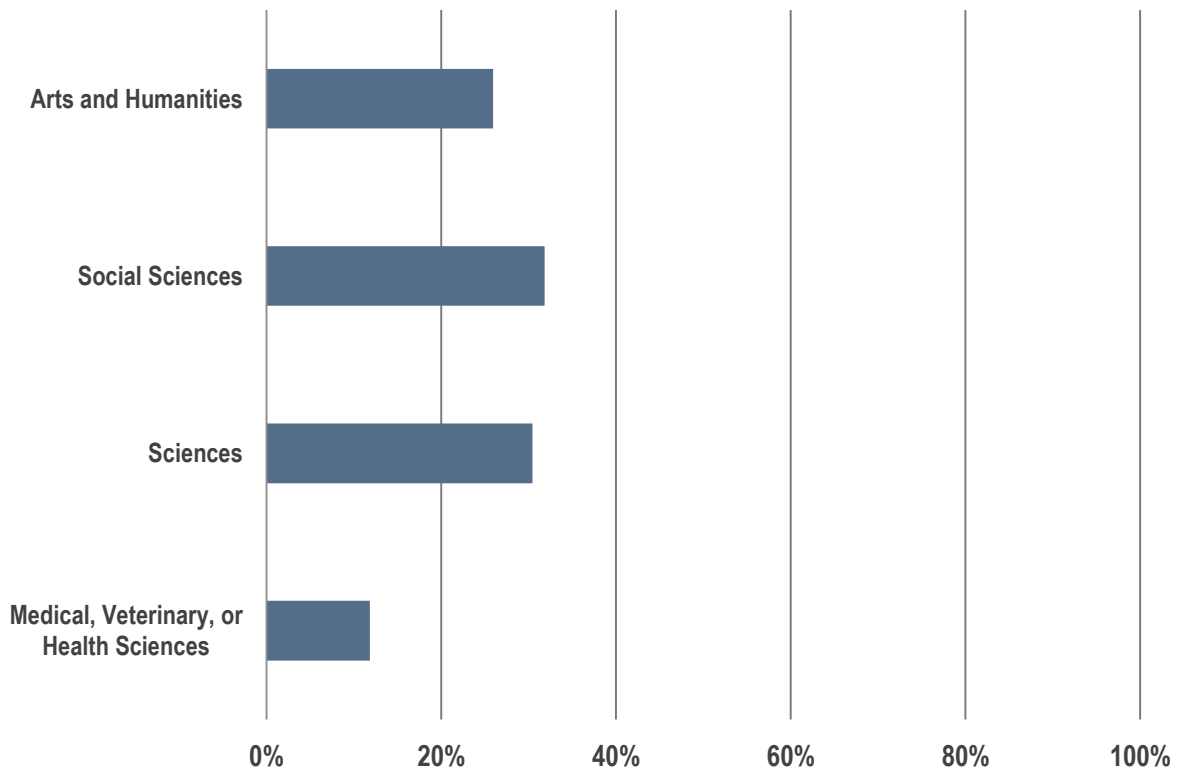

In which academic discipline do you work?

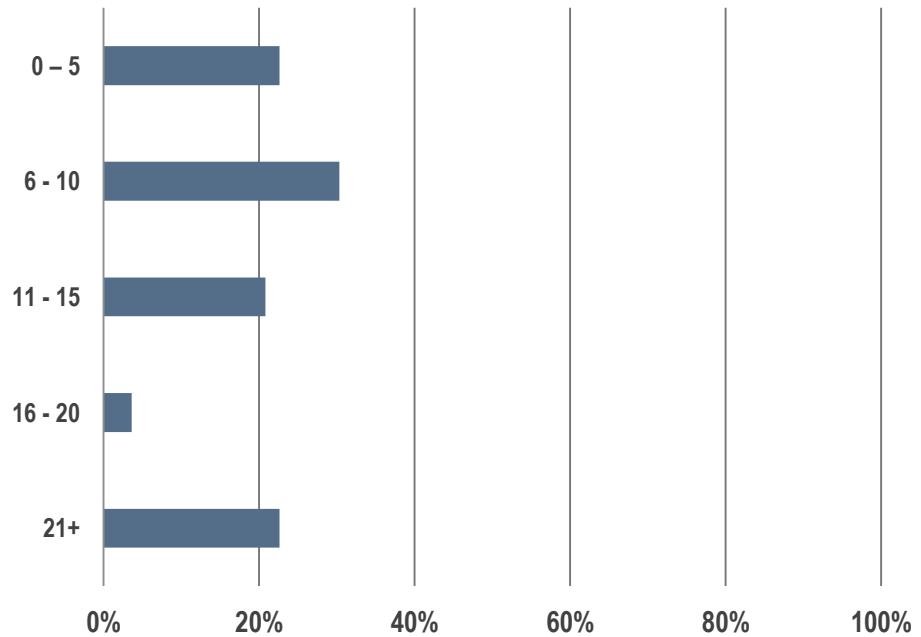

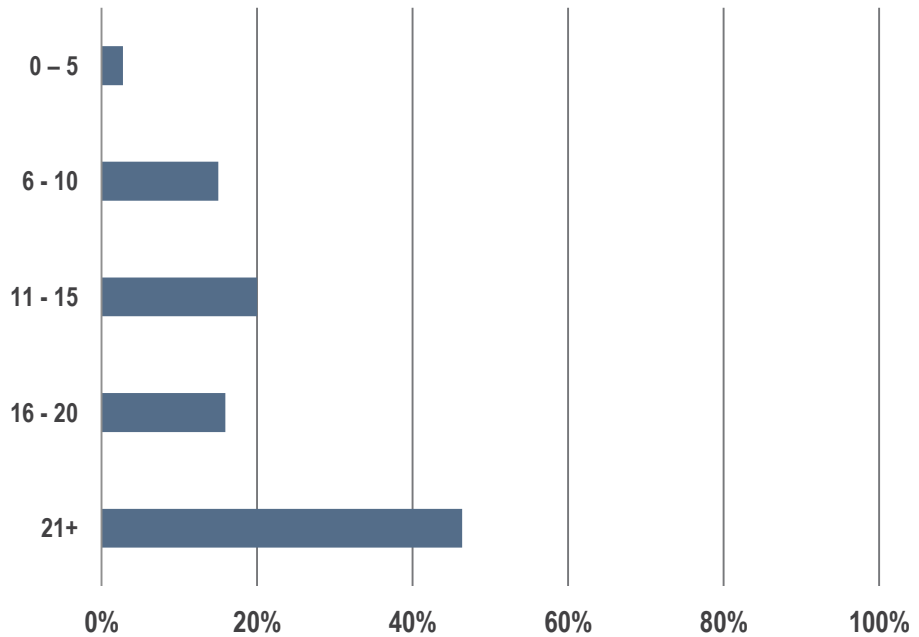

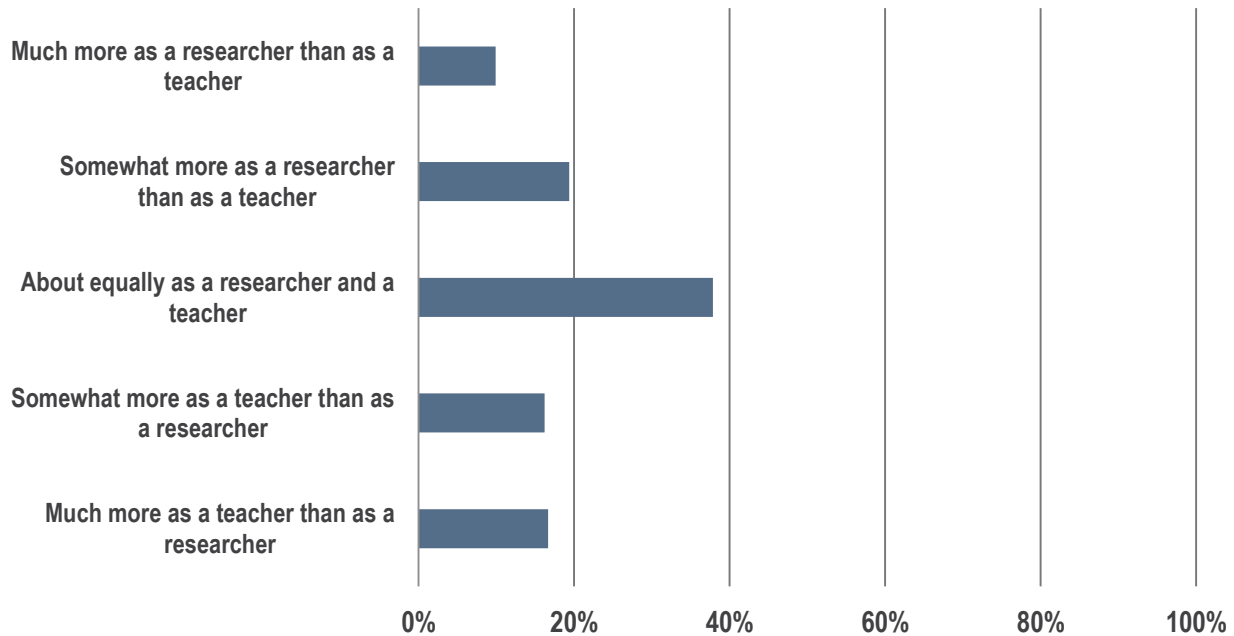
