

## **Extreme Poverty in Illinois Senate District 47**

## Extreme poverty affects thousands of individuals in Illinois Senate District 47



In Illinois Senate District 47, **32,917** people are living in poverty.

**14,130** of these individuals are living in extreme poverty.<sup>1</sup>



Across the state, **502,778** Illinoisans are employed yet still live in poverty.

**11,911** of these workers live in Illinois Senate District 47.<sup>2</sup>



In Illinois Senate District 47, **22,387** adults age 18-64 rely on Medicaid, which no longer provides them with critical dental services.<sup>3</sup>



In Illinois Senate District 47, **5,691** people lack affordable housing, meaning they pay more than 50% of their income toward housing.<sup>4</sup>



In Illinois, approximately **14,144** Illinoisans were homeless at least one night in 2012, including **1,905** families.<sup>5</sup>



In Illinois Senate District 47, **48,426** private sector workers do not have access to an employment based retirement savings program.<sup>6</sup>

According to federal guidelines, families are considered to be living in poverty when their yearly income falls below the Federal Poverty Threshold.

In Illinois, **1.85 million** residents are living in poverty. At least **820,000** are living in extreme poverty.
