By letter of 20 October 1975, the President of the Council of the European Communities requested the European Parliament, pursuant to Article 75 of the EEC Treaty, to deliver an opinion on the proposal from the Commission of the European Communities to the Council for a regulation amending Regulation (EEC) No. 3255/74 of 19 December 1974 extending and amending Regulation (EEC) No. 1174/68 of 30 July 1968, on the introduction of a system of bracket tariffs for the carriage of goods by road between the Member States.

The President of the European Parliament referred this proposal to the Committee on Regional Policy and Transport.

On 21 October 1975, the Committee on Regional Policy and Transport appointed Mr Schwabe rapporteur.

It considered the proposal at its meeting of 29 October 1975 and adopted the motion for a resolution and the explanatory statement unanimously.

EXPLANATORY STATEMENT

In its resolution of 26 June 1974<sup>1</sup> on the Commission's proposal<sup>2</sup> the European Parliament had already suggested an extension of Regulation (EEC) No. 1174/68 of the Council of 30 July 1968<sup>3</sup> until 31 December 1976. There is no reason for any change in the position adopted at that time.
