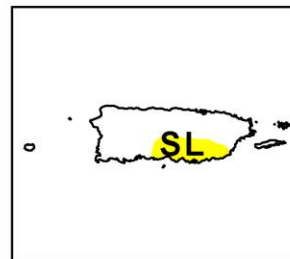
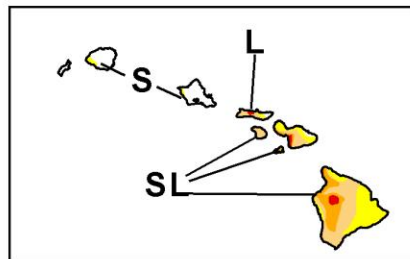
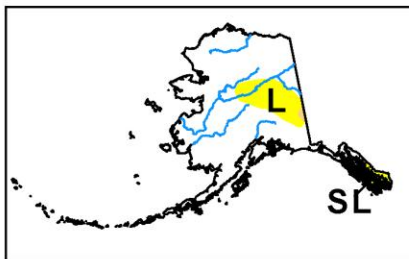
### Drought Impact Types:

- ~ Delineates dominant impacts
- S = Short-Term, typically less than 6 months (e.g. agriculture, grasslands)
- L = Long-Term, typically greater than 6 months (e.g. hydrology, ecology)

### Intensity:

- D0 Abnormally Dry
- D1 Moderate Drought
- D2 Severe Drought
- D3 Extreme Drought
- D4 Exceptional Drought

The Drought Monitor focuses on broad-scale conditions. Local conditions may vary. See accompanying text summary for forecast statements.

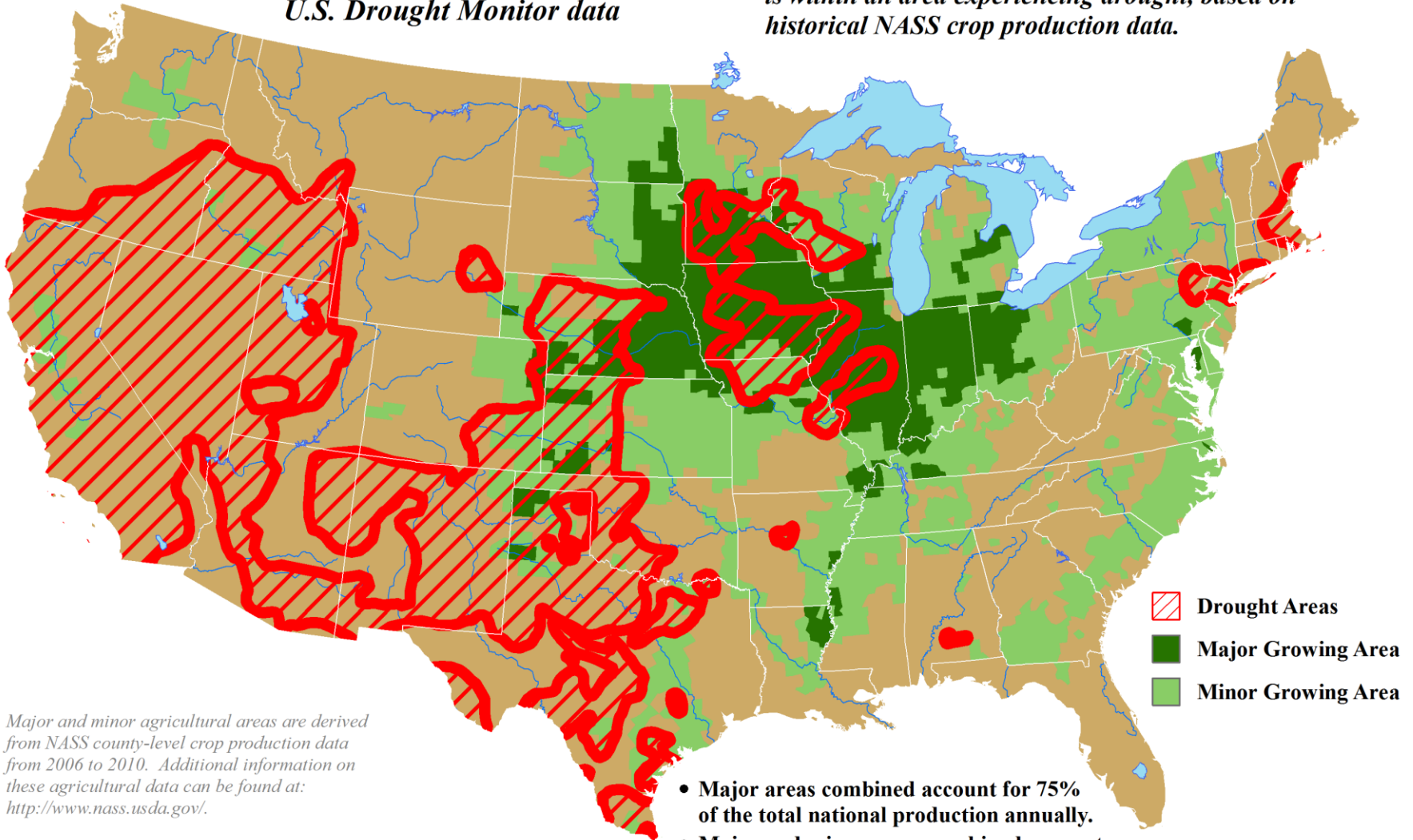

# U.S. Corn Areas Experiencing Drought

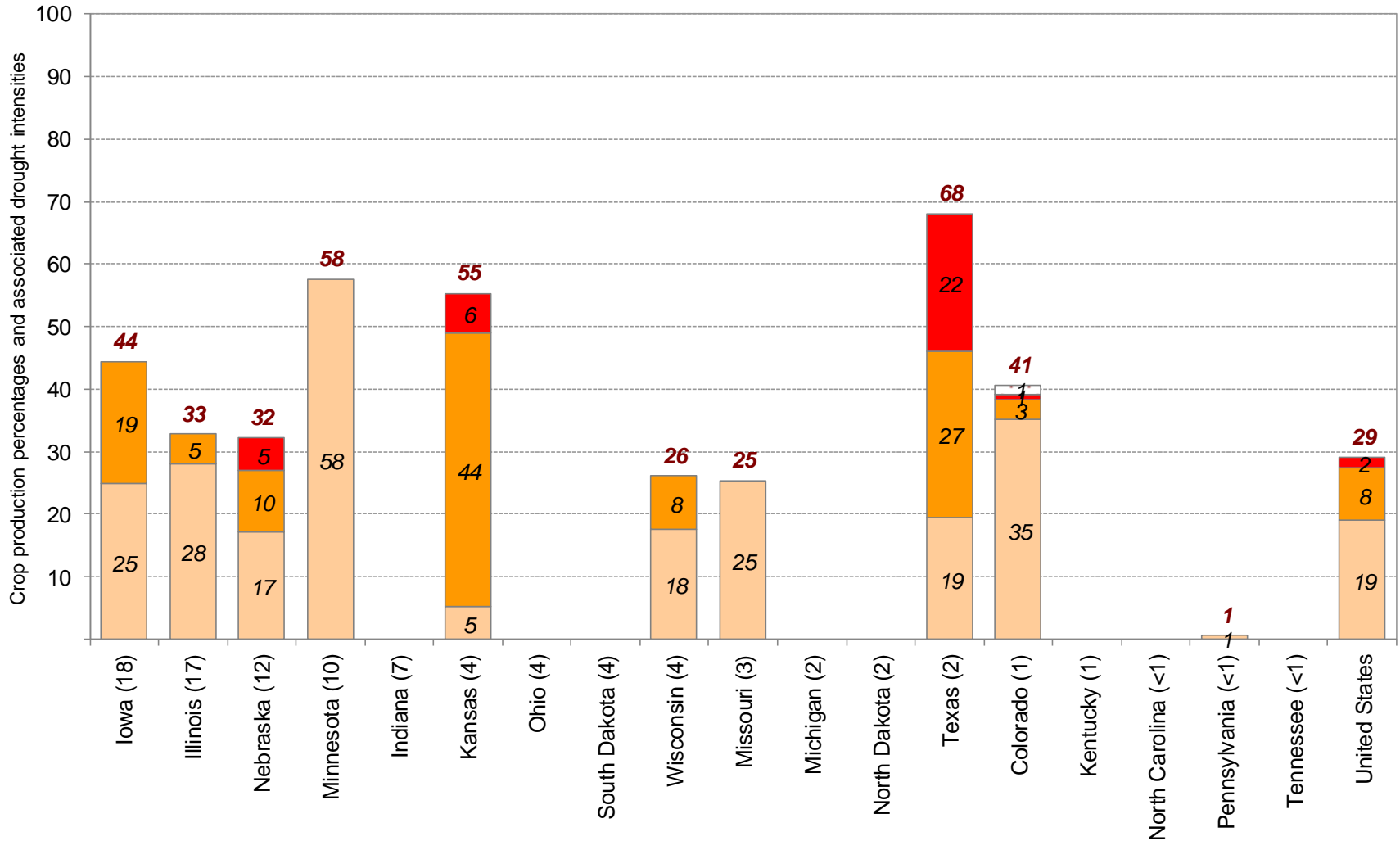
Reflects December 10, 2013

## Approximate Percentage of Corn Located in Drought \* December 10, 2013



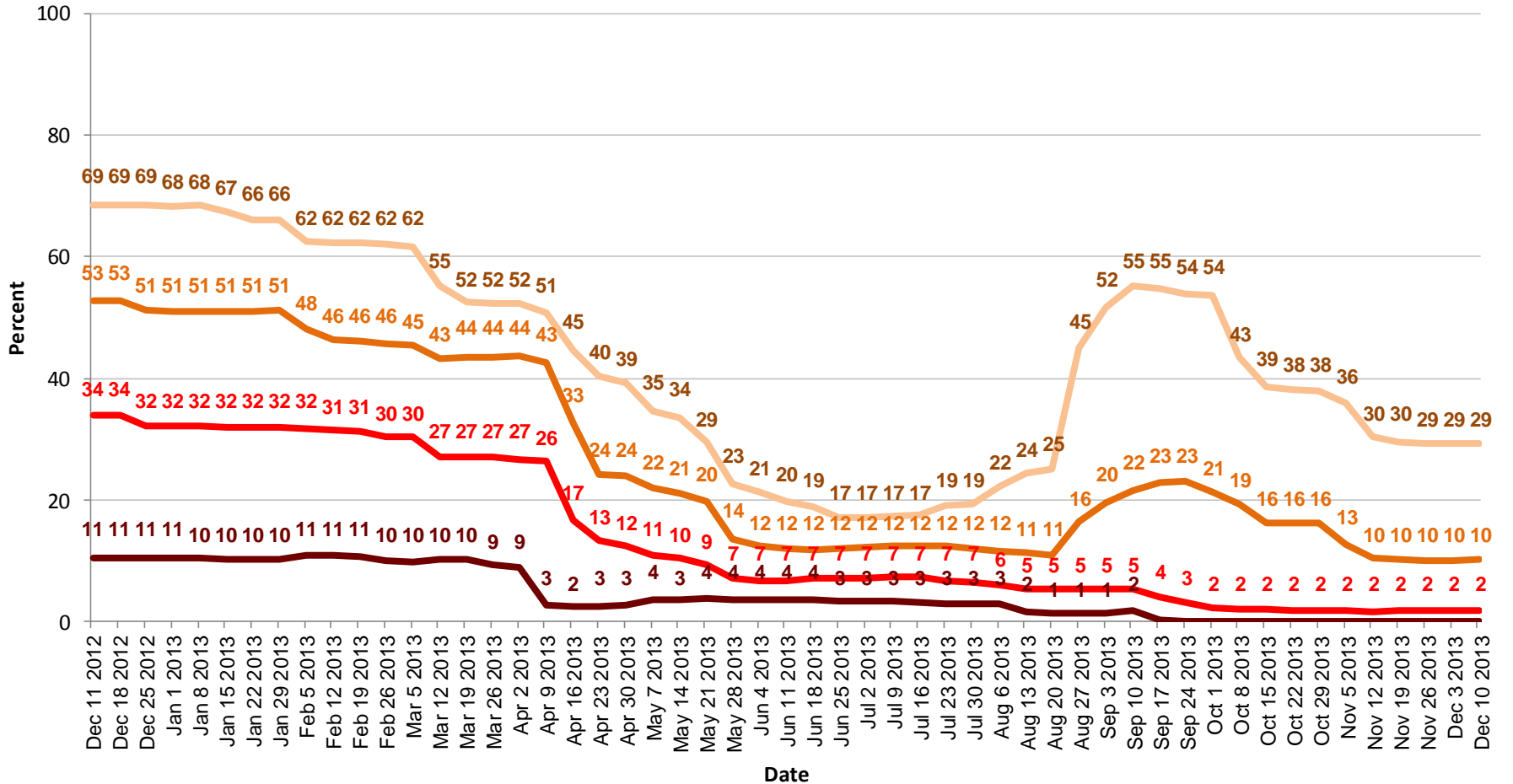

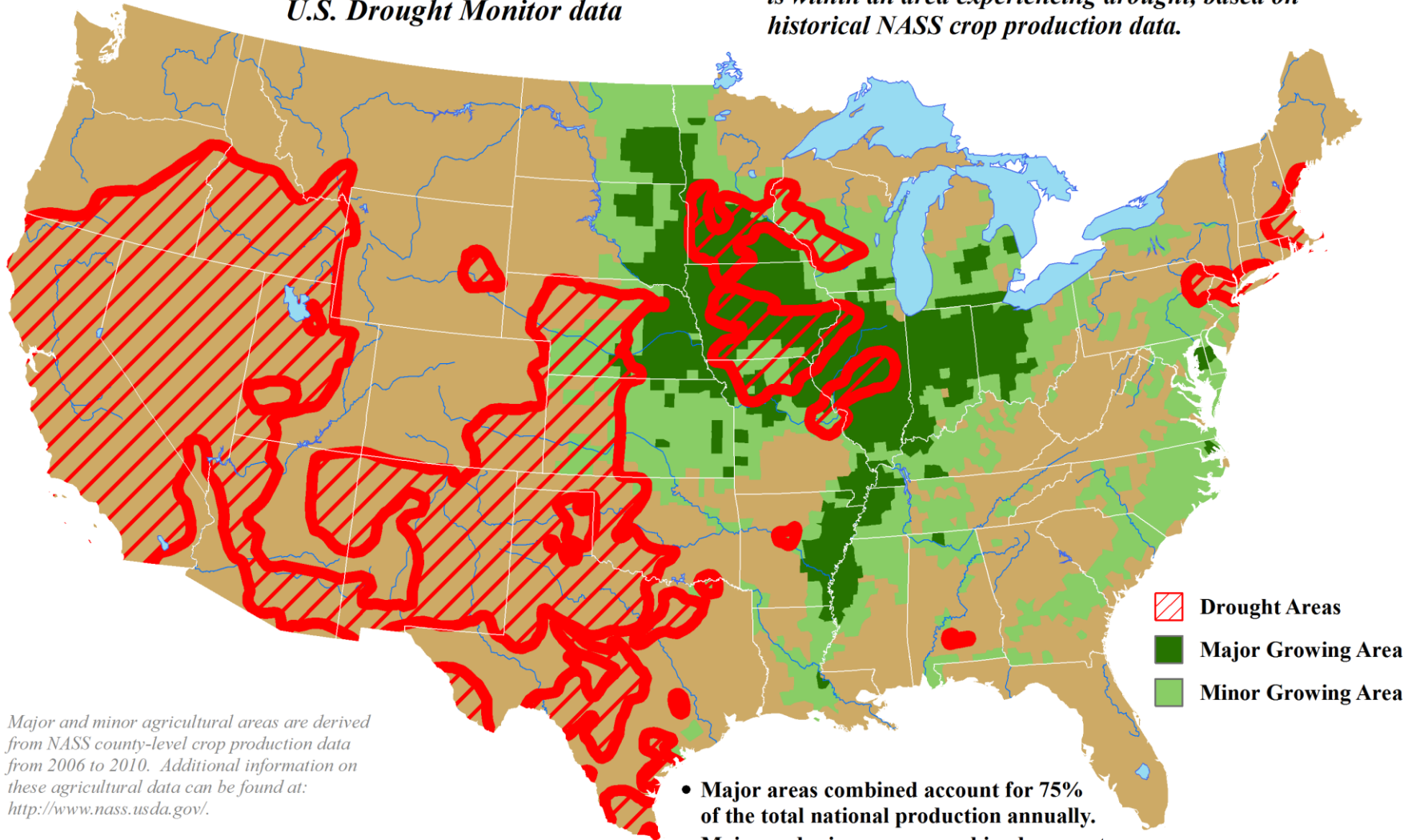

historical NASS crop production data.

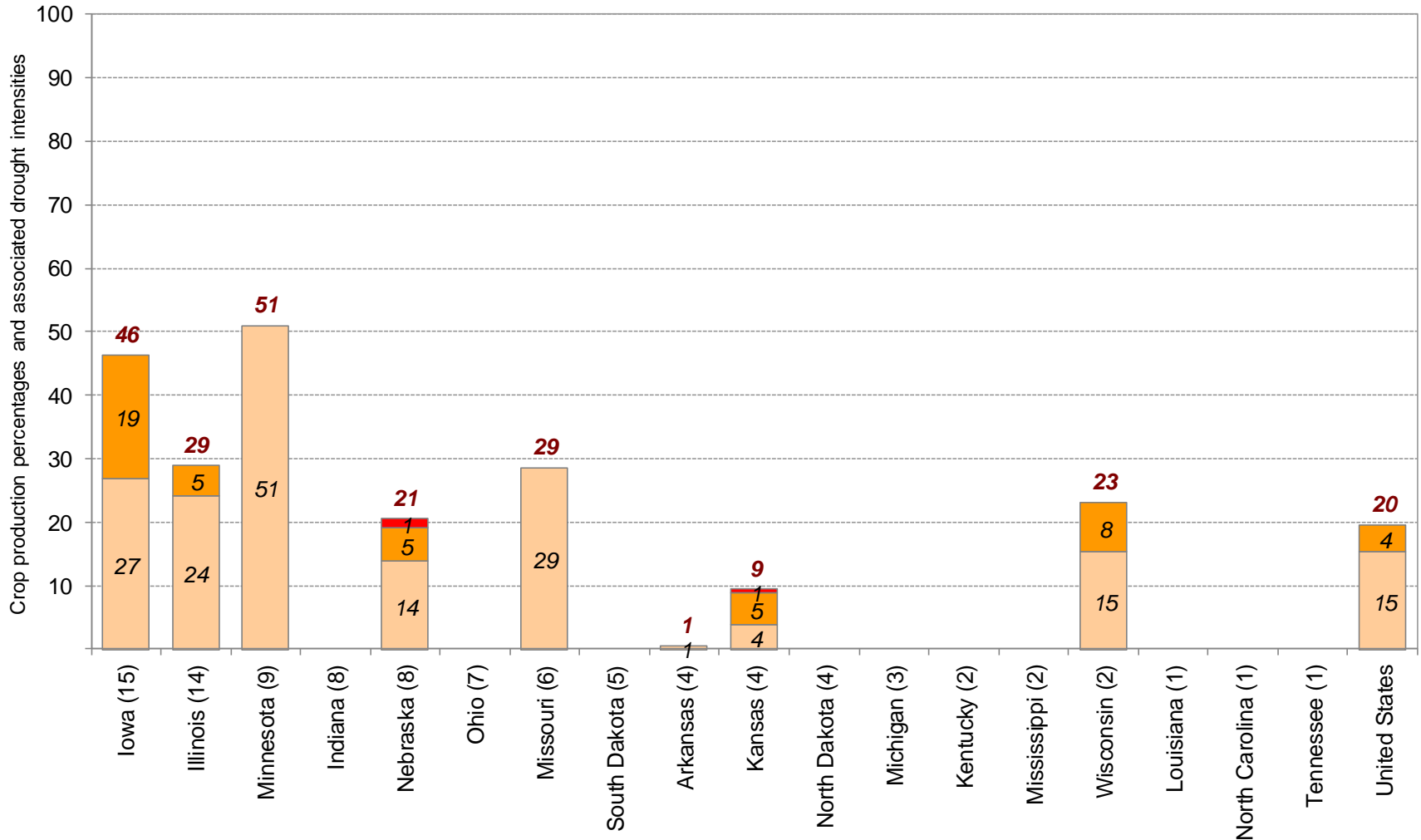

## Approximate Percentage of Soybeans Located in Drought \* December 10, 2013

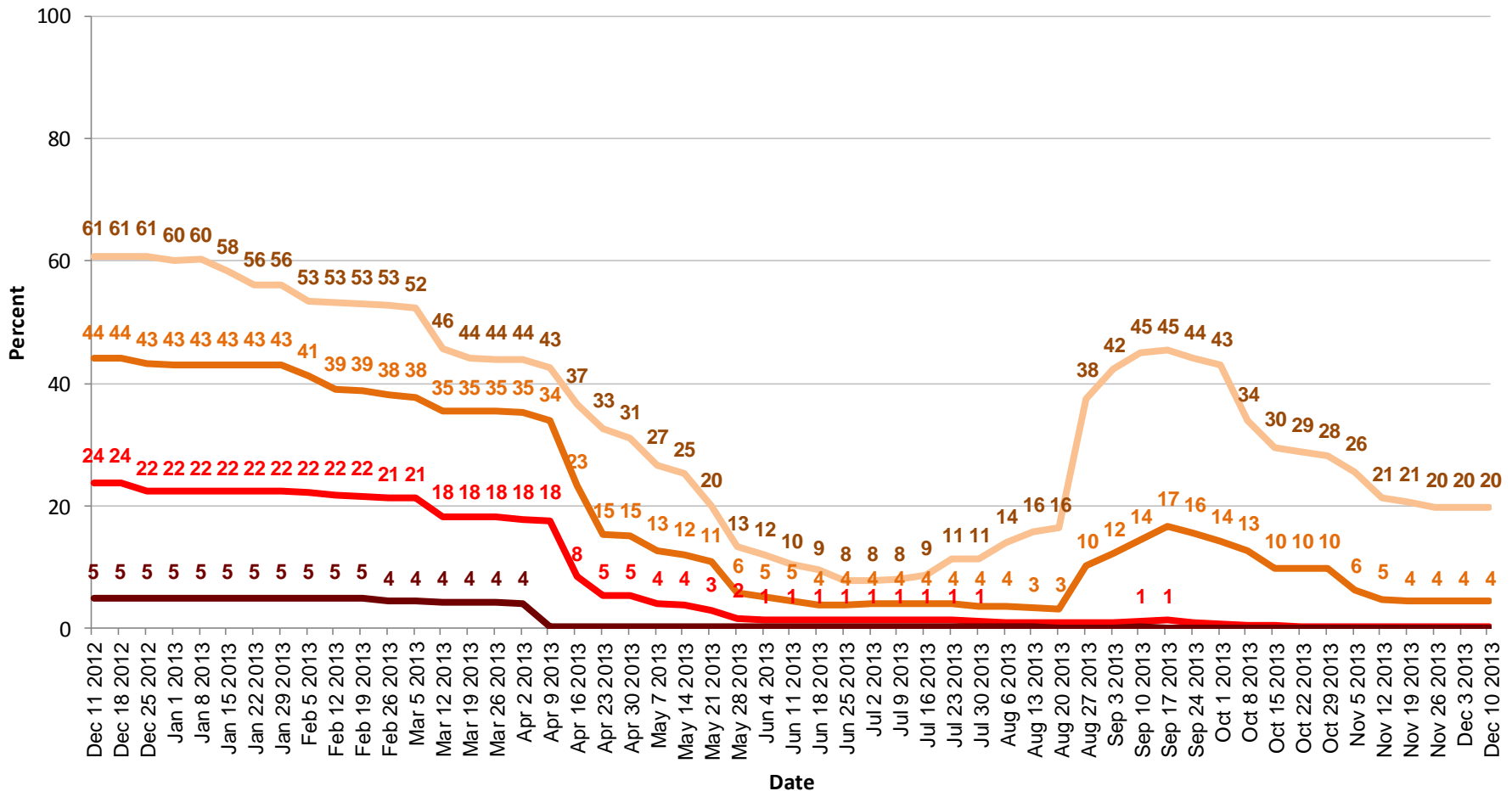

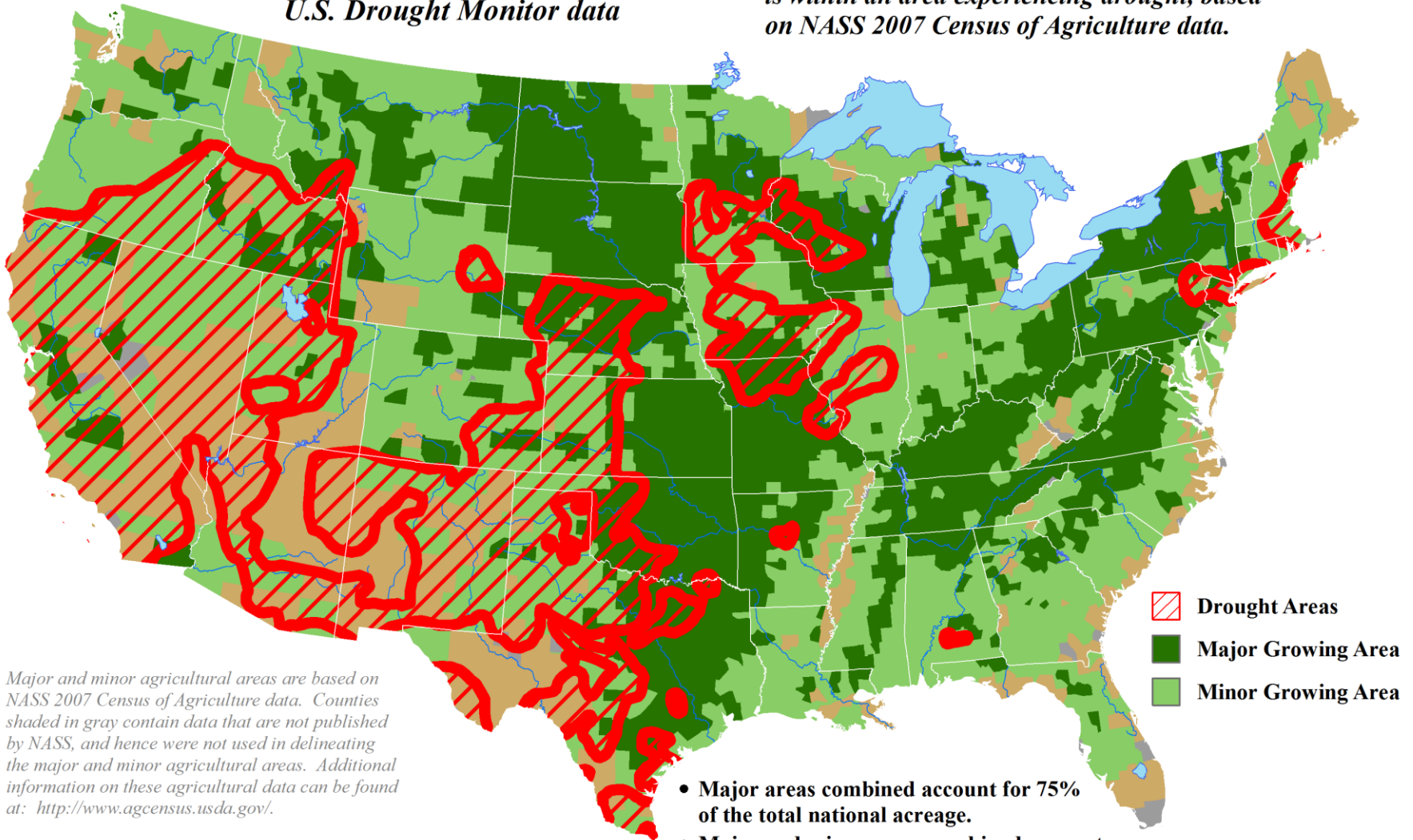

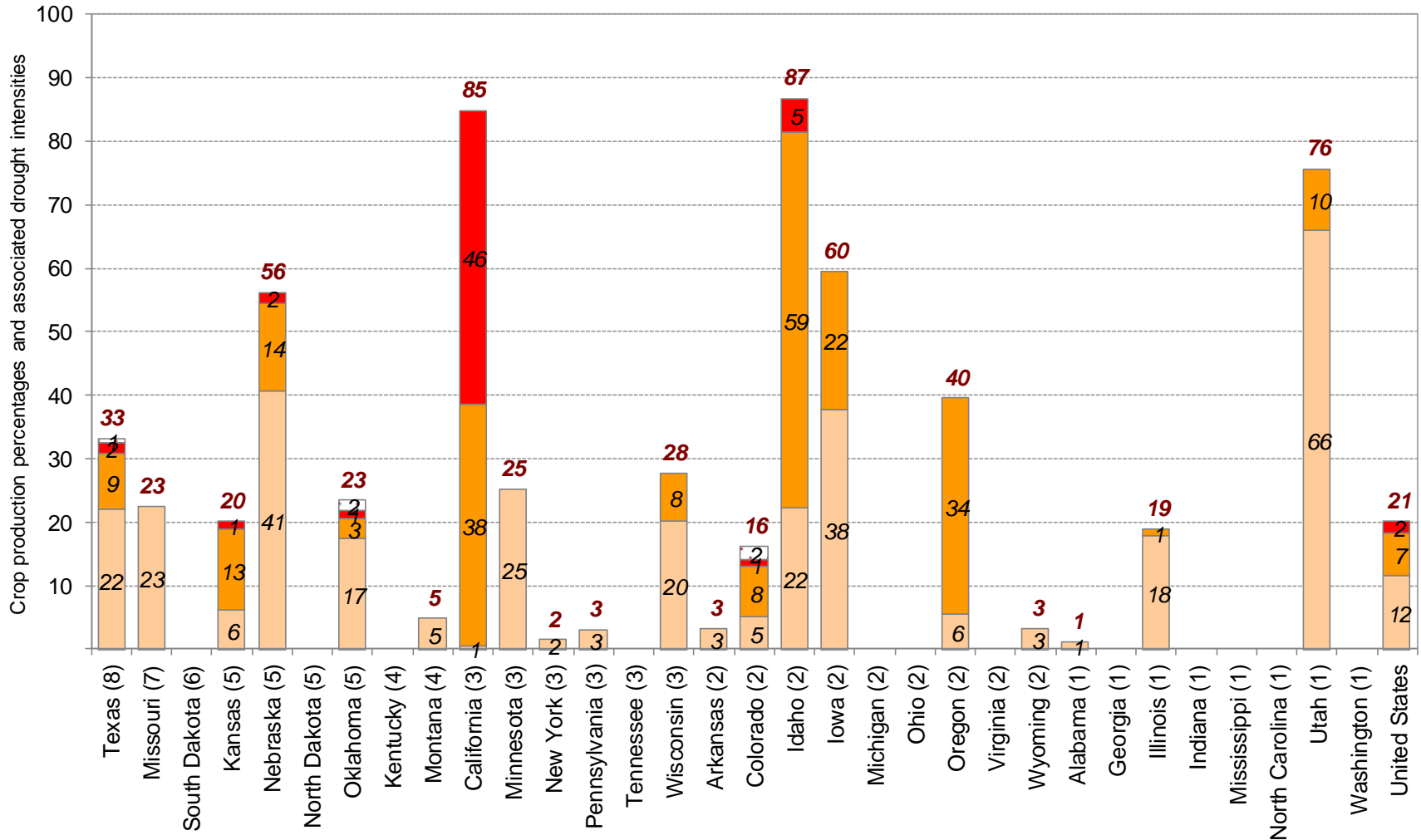

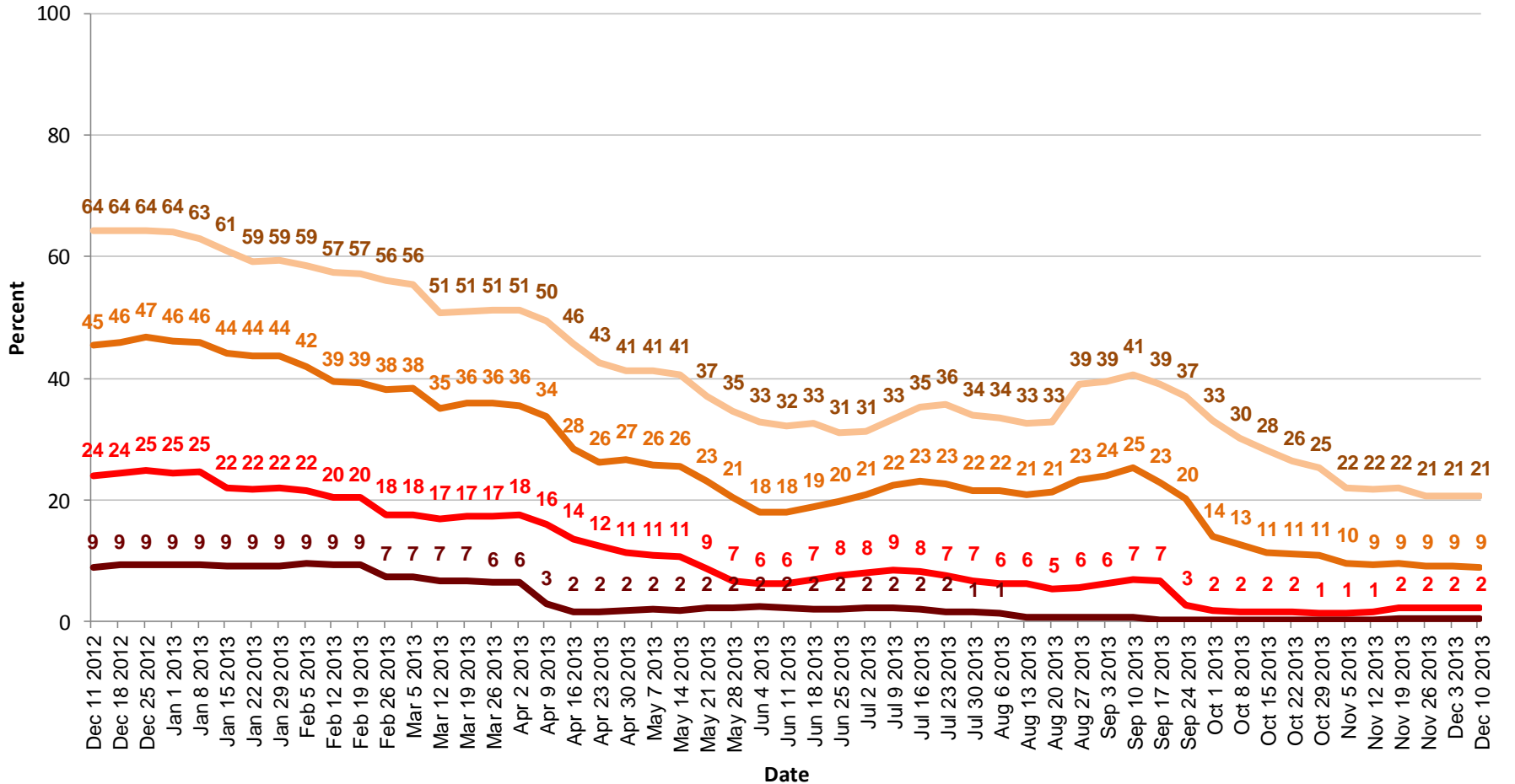

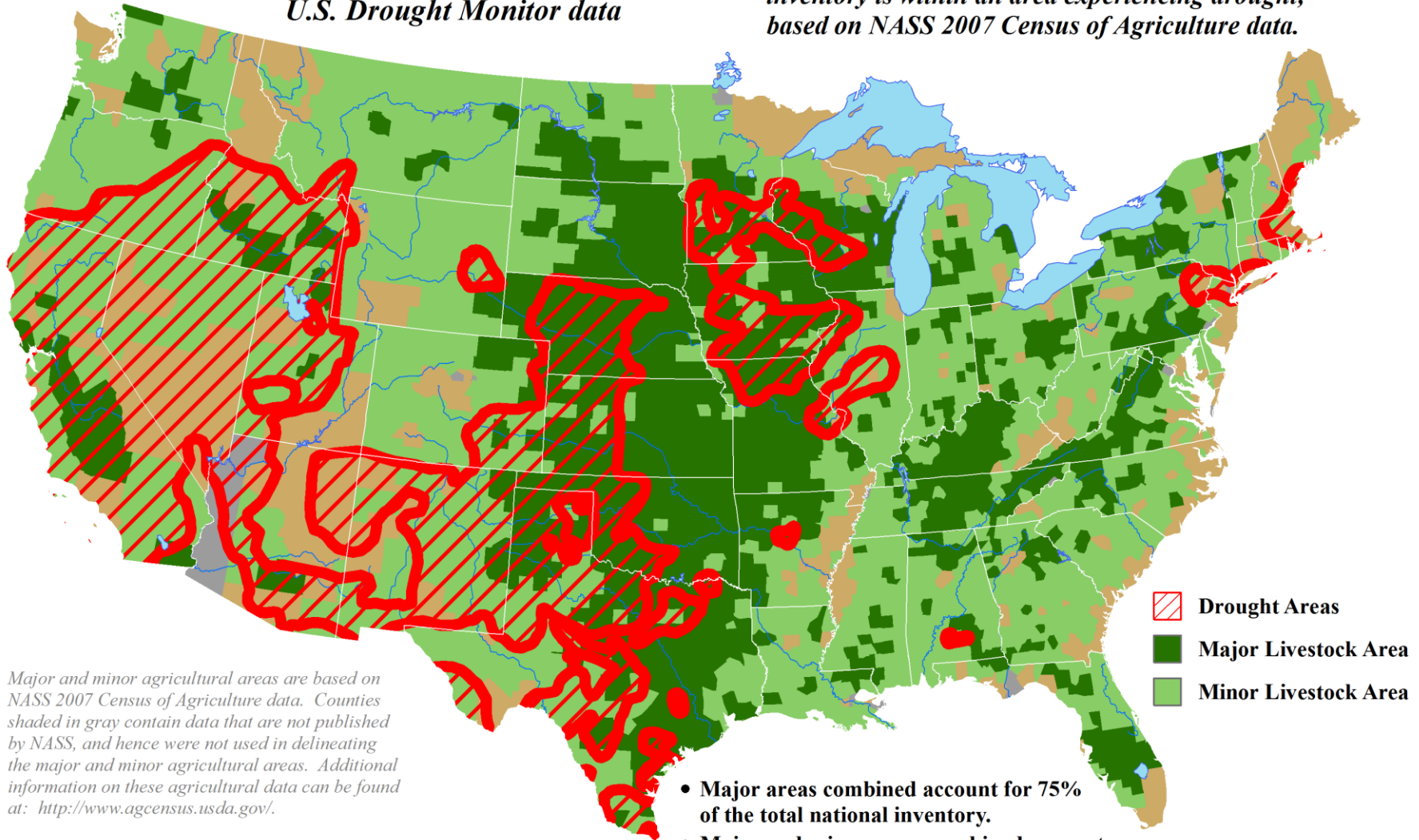

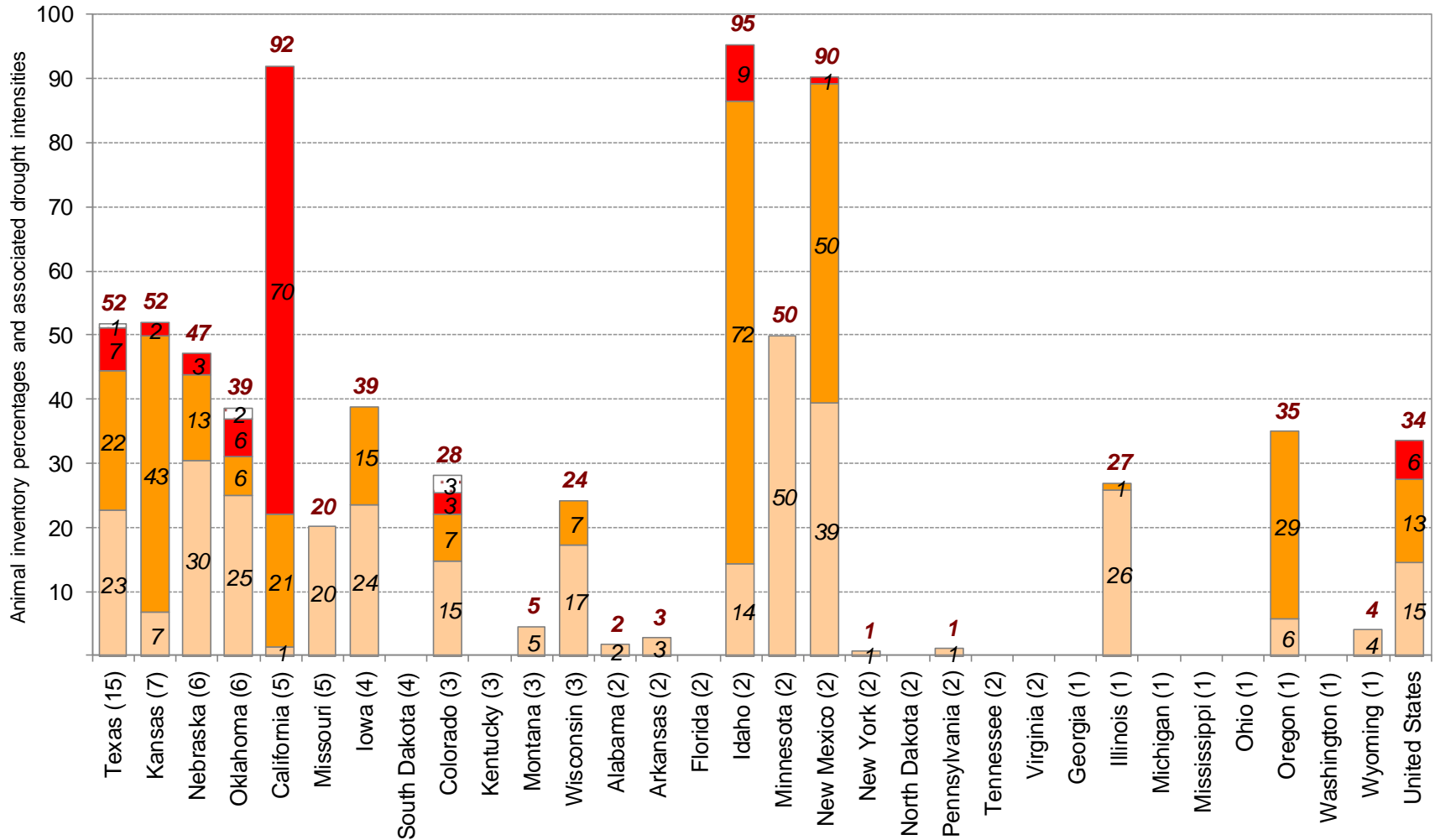

## Approximate Percentage of Cattle Located in Drought \* December 10, 2013



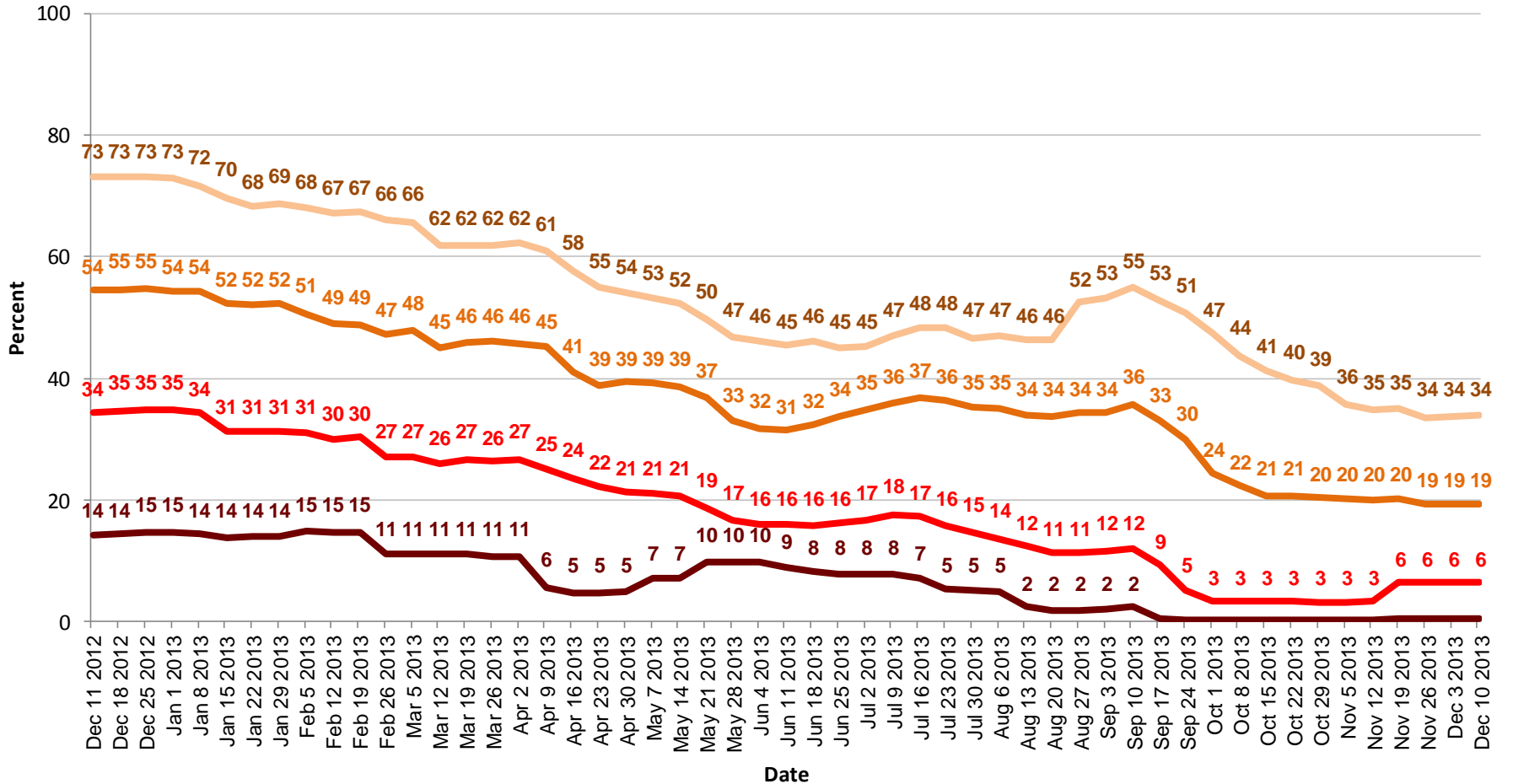

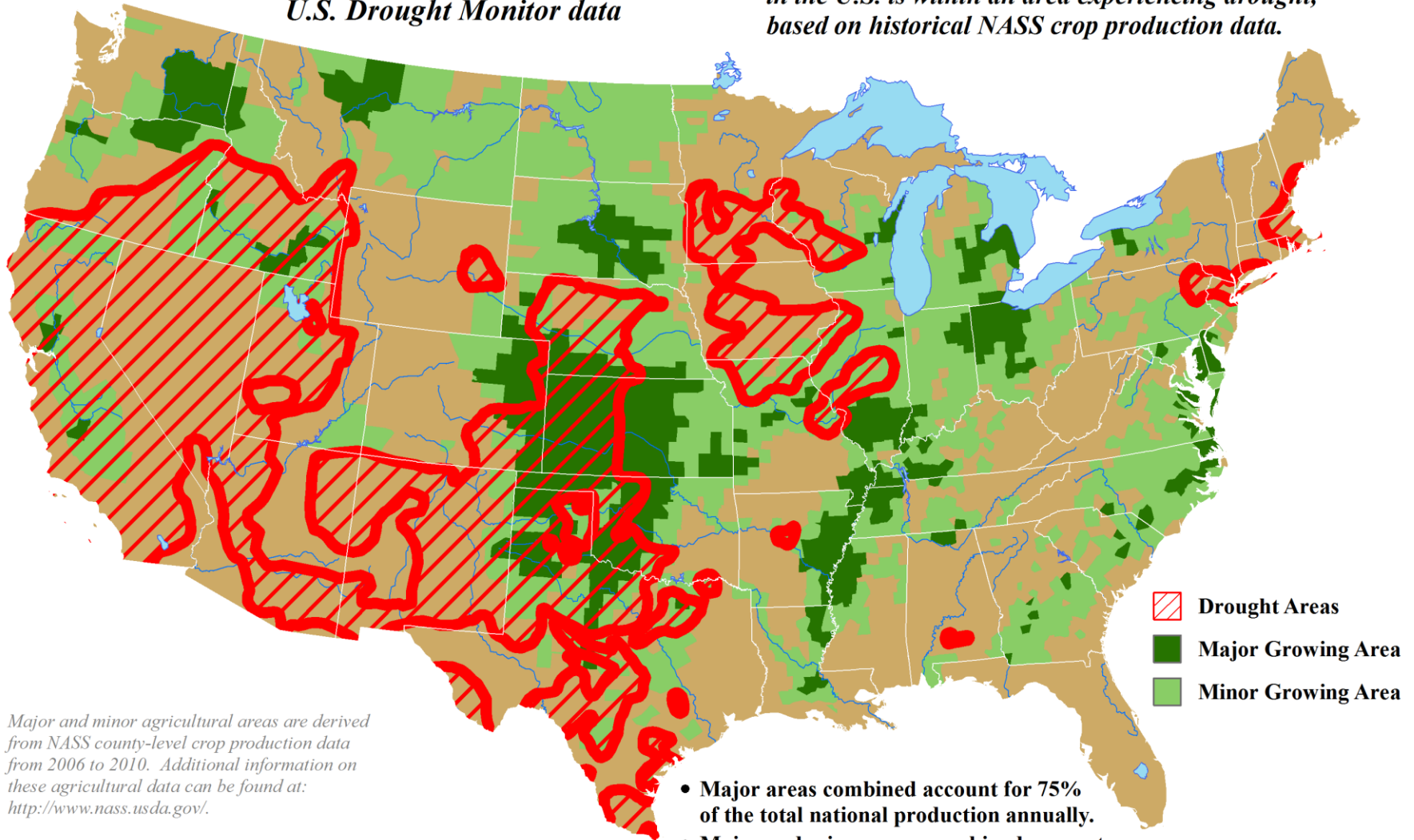

# U.S. Winter Wheat Areas Experiencing Drought

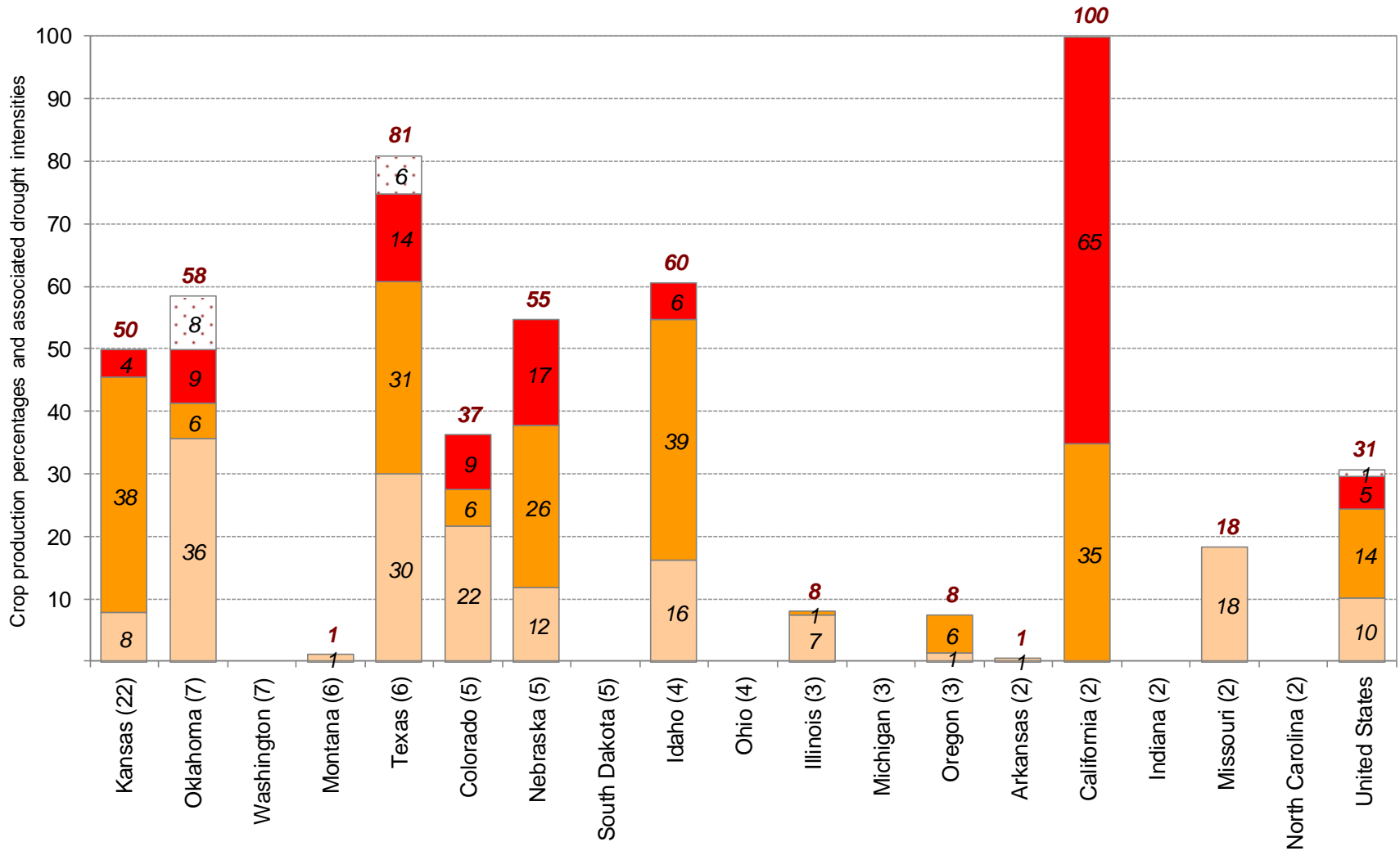
