PART I

1.1 Building a dataset on EU CSDP missions: challenges and opportunities

The emergence of the EU Common Security and Defence (CSDP)—particularly the development from its first mission in 2003 to a current portfolio of over thirty military operations and civilian missions deployed in over twenty countries spanning four continents—has stimulated enormous interest and demand from both policy-makers and academics for information on these important activities.

However, three significant gaps unfortunately remain in the literature today. First, the existing data on these operations and missions, principally which EU member states participate and in what capacity, is severely fragmented among disparate sources. For a complete and holistic view of the CSDP, its past, and its present, researchers must consult individual monographs, edited volumes, peacekeeping databases, and a plethora of other sources. The current state of information lacks a single, centralized source with credible and comprehensive data.

Second, the existing data is incomplete. For example, sources may include information about one mission, but not all cases; they may include all cases, but only the total troop number, without identifying how many troops each member state individually contributes; or they may neglect other qualitative variables, such as the participation of other international organizations in the operation or mission.

Finally, there continue to be wide-ranging discrepancies in the data among the various sources. Due to the sensitive nature of the CSDP, there is a lack of data transparency from the EU and its Member States. In addition, because of the natural and constant shifting of numbers of personnel and troops over the duration of a mission or operation, sources often reflect different total force strength, making it difficult to gauge intensity.

In sum, significant difficulties remain in collecting information in this topic area. Thus, there is an enormous need for centralized, comprehensive, and accurate data on the missions and operations of the CSDP. The opportunity is ripe for a complete dataset, enabling researchers and practitioners to trace and understand the development of the EU as an actor in international affairs.

1.2 Methodology of data collection

The database collects data on operations and missions from 2003 to December 2015. The unit of analysis is represented by the 32 operations and missions conducted by the EU during this period. The core of methodology is data triangulation. For reasons mentioned earlier, data collection in this topic is difficult and rife with discrepancies. In order to ensure quality control of our findings, we rigorously triangulate diverse and multiple sources. For each operation or mission, we first make a broad and deep sweep of existing data from foundational databases, such as the EU ISIS CSDP Mission Map (closed since December 2014), SIPRI, and the IISS Military Balance. We collect as many possible data points for each variable over the duration of the operation or mission to account for any skewed deployments at a given moment in time, and to factor in the natural build-up and withdrawal of forces.

We then conduct a second round of data collection, scanning secondary data sources unique to the specific operation or mission, including official government documents, news reports, or academic publications. In operations or missions where information was unavailable or limited in the number of data points, our team conducted original primary interviews with CSDP officials. As a general best practice, we prioritize data sources that are either from primary documents (for example, government-published reports) or from original primary interviews.

1.3 Overview of sources

Our database draws upon five central groups of sources: foundational databases, original primary interviews, original documents, academic publications, and news sources and other miscellaneous sources.

Data are reported in three different files:

- 1) An Excel table, where nominal variables are indicated as text.
- 2) An Excel table, where all the variables are numerically encoded.
- 3) A STATA file.

The Global Governance Programme at the EUI periodically updates data and related tools, such as graphs, charts, tables, etc.

This dataset offers multiple and diverse potential applications for analysis in new studies beyond this publication—for example, for future studies on the EU and its Member States, enabling comparative analysis on Member State participation in operations and missions, as well as facilitating the tracing of individual Member State engagement over time. As a second possible area for future research, the data could be applied to broader studies in international cooperation, offering new empirical insight into EU cooperation with other international organizations. Third, this data will support new studies in international security and conflict, responding to additional questions on the use of force, civilian peacekeeping, conflict intensity, and more. The future applications will appeal to a broad range of interests and audiences, from academics to practitioners. In sum, the dataset enables rigorous data analysis contributions to studies on international organizations, international relations, and security studies.

The present codebook is organized in four parts. Part I introduces the dataset, with fundamental information about sources and methodology. Part II describes the variables by providing number, name, type, definition and descriptive statistics. Part III presents a summary description of each operation/mission. Finally, Part IV reports the most interesting figures and tables describing EU engagement under four main aspects: trends, intensity of intervention, space (regional) deployment, and single states' involvement.




Figure 4.1 Number of active EU operations and missions per year




Figure 4.2 Types of active operations and missions per year⁵




Figure 4.3 Percentages of types of active operations and missions per year⁶




Figure 4.4 Average percentage of participating states (at launch) per year




Figure 4.5 Goals of the operations and missions by year




Figure 4.6 Average EU Engagement Index per year




Figure 4.7 Average EU Engagement Indexes (1 to 3) per year




Figure 4.9 Total operations and missions by conflict type per year




Figure 4.10 Trend of total operations and missions by conflict intensity per year




Figure 4.11 Average length (months) by percentage of states involved




Figure 4.12 Average EU personnel by percentage of states involved




Figure 4.13 Average personnel peak by percentage of states involved




Figure 4.14 Average percentage of states involved by cooperation with international organizations




Figure 4.15 Average percentage of participating states by conflict intensity




Figure 4.16 Average percentage of participating states by conflict type




Figure 4.17 Average personnel peak by operation and mission goal




Figure 4.18 Average personnel peak by cooperation with international organizations




Figure 4.19 Average personnel (absolute and EU) peak by conflict intensity




Figure 4.20 Average personnel (absolute and EU) peak by conflict type




Figure 4.21 Average length (months) of operations and missions per region




Figure 4.22 Average length (months) of operations and missions per sub-region




Figure 4.23 Average percentage of participating states per region




Figure 4.24 Average percentage of participating states per sub-region




Figure 4.25 Average personnel (absolute and EU) per region




Figure 4.26 Average personnel (absolute and EU) per sub-region




Figure 4.27 Average length (months) of operations and missions by Engagement Index




Figure 4.28 Average percentage of participating states by Engagement Index




Figure 4.29 Average personnel/troops (absolute and EU) by Engagement Index




Figure 4.30 Percentages of engagement level by mission goals




Figure 4.31 Total personnel (peak) employed by each member state




Figure 4.32 Total personnel trend for Austria




Figure 4.33 Total personnel trend for Belgium




Figure 4.34 Total personnel trend for Bulgaria




Figure 4.35 Total personnel trend for Croatia




Figure 4.36 Total personnel trend for Cyprus




Figure 4.38 Total personnel trend for Denmark




Figure 4.39 Total personnel trend for Estonia




Figure 4.40 Total personnel trend for Finland




Figure 4.41 Total personnel trend for France




Figure 4.42 Total personnel trend for Germany




Figure 4.43 Total personnel trend for Greece




Figure 4.44 Total personnel trend for Hungary




Figure 4.45 Total personnel trend for Ireland




Figure 4.46 Total personnel trend for Italy




Figure 4.47 Total personnel trend for Latvia




Figure 4.48 Total personnel trend for Lithuania




Figure 4.49 Total personnel trend for Luxemburg




Figure 4.50 Total personnel trend for Malta




Figure 4.51 Total personnel trend for the Netherlands




Figure 4.52 Total personnel trend for Poland




Figure 4.53 Total personnel trend for Portugal




Figure 4.54 Total personnel trend for Romania




Figure 4.55 Total personnel trend for Slovakia




Figure 4.56 Total personnel trend for Slovenia




Figure 4.57 Total personnel trend for Spain




Figure 4.58 Total personnel trend for Sweden




Figure 4.59 Total personnel trend for the UK




Figure 4.60 Personnel percentages for each member state of EU total personnel: EUMM Georgia




Figure 4.61 Personnel percentages for each member state of EU total personnel: EUFOR ALTHEA BiH




Figure 4.62 Personnel percentages for each member state of EU total personnel: EU-NAVFOR Somalia




Figure 4.64 Personnel percentages for each member state of EU total personnel: EUPM BiH




Figure 4.65 Personnel percentages for each member state of EU total personnel: EUFOR RD Congo




Figure 4.66 Personnel percentages for each member state of EU total personnel: EUPOL Afghanistan




Figure 4.67 Personnel percentages for each member state of EU total personnel: Proxima/FYROM 1 and 2




Figure 4.68 Personnel percentages for each member state of EU total personnel: Aceh AMM




Figure 4.69 Personnel percentages for each member state of EU total personnel: ARTEMIS Congo




Figure 4.70 Personnel percentages for each member state of EU total personnel: EUJUST THEMIS




Figure 4.71 Personnel percentages for each member state of EU total personnel: CONCORDIA/FYROM




Figure 4.72 Personnel percentages for each member state of EU total personnel: EUPOL COPPS/Palestinian Territories




Figure 4.73 Personnel percentages for each member state of EU total personnel: EUBAM Moldova Ukraine




Figure 4.74 Personnel percentages for each member state of EU total personnel: EUTM Somalia




Figure 4.76 Personnel percentages for each member state of EU total personnel: AMIS Darfur




Figure 4.77 Personnel percentages for each member state of EU total personnel: EUFOR TCHAD/RCA




Figure 4.78 Personnel percentages for each member state of EU total personnel: EUCAP Nestor




Figure 4.79 Personnel percentages for each member state of EU total personnel: EUAVSEC South Sudan




Figure 4.80 Personnel percentages for each member state of EU total personnel: EUTM Mali




Figure 4.81 Personnel percentages for each member state of EU total personnel: EUBAM Libya




Figure 4.82 Personnel percentages for each member state of EU total personnel: EUAM Ukraine




Figure 4.83 Personnel percentages for each member state of EU total personnel: EU-SSR Guinea Bissau




Figure 4.84 Personnel percentages for each member state of EU total personnel: EUSEC RD Congo




Figure 4.85 Personnel percentages for each member state of EU total personnel: EUPOL RD Congo




Figure 4.86 Personnel percentages for each member state of EU total personnel: EUPOL Kinshasa Congo




Figure 4.87 Personnel percentages for each member state of EU total personnel: EUJUST LEX-Iraq




Figure 4.88 Personnel percentages for each member state of EU total personnel: EUBAM RAFAH




Figure 4.89 Personnel percentages for each member state of EU total personnel: EUCAP Niger




Figure 4.90 Personnel percentages for each member state of EU total personnel: EUFOR RCA




Figure 4.91 Personnel percentages for each member state of EU total personnel: EUCAP Sahel Mali




Figure 4.92 Average personnel by country for Border Control goal




Figure 4.93 Average personnel by country for Security goal




Figure 4.94 Average personnel by country for Supporting Policy Reforms goal




Figure 4.96 Average personnel by country for Monitoring goal




Figure 4.97 Average personnel by country for 'High' Engagement Index




Figure 4.98 Average personnel by country for 'Medium' Engagement Index




Figure 4.99 Average personnel by country for 'Low' Engagement Index




Figure 4.100 Average personnel by country for operations and missions in Africa




Figure 4.101 Average personnel by country for operations and missions in Asia




Figure 4.102 Average personnel by country for operations and missions in Europe




Figure 4.103 Average personnel by country for operations and missions in Western Africa




Figure 4.104 Average personnel by country for operations and missions in Eastern Africa




Figure 4.105 Average personnel by country for operations and missions in Northern Africa




Figure 4.106 Average personnel by country for operations and missions in Middle Africa




Figure 4.107 Average personnel by country for operations and missions in Southern Asia




Figure 4.108 Average personnel by country for operations and missions in Western Asia




Figure 4.109 Average personnel by country for operations and missions in South-Eastern Asia




Figure 4.110 Average personnel by country for operations and missions in Southern Europe




Figure 4.111 Average personnel by country for operations and missions in Eastern Europe




Figure 4.112 Average personnel by country for 'no conflict'




Figure 4.113 Average personnel by country for 'minor' conflict




Figure 4.114 Average personnel by country for 'war' conflict




Figure 4.115 Average personnel by country for 'internal' conflicts




Figure 4.116 Average personnel by country for 'internationalized' conflicts
