3. Please state the field of expertise of any and all expert witnesses and set forth the professional degree, special professional training and experience special knowledge or skill of said expert witness.

4. Please state the subject matter on which each expert witness is expected to testify.

5. Please state the substance of the facts and opinion to which the expert witness is to testify on.

6. Please state the summary of the grounds for each opinion the expert witness is to testify on.

7. Please state whether any of the above-described expert witnesses have ever testified on behalf of the attorneys representing you and if so, please state the amount of times, the dates and the cases that said testimony was in.

8. Please state the names and addresses of any and all expert witnesses who have been retained or specially employed by you or your attorneys in anticipation of litigation or preparation for trial and who are not expected to be called as witnesses at trial.

9. Please list all documents or demonstrative exhibits you intend to introduce at any administrative proceeding. Please produce or provide for the inspection of originals.
10. Is the subject road a part, a phase, or in any way related to another or larger project. If yes, please give details of the related road including dates, projections, size and purposes.
