LAND EXACTION: A SELECTIVE BIBLIOGRAPHY

MARY ANN NELSON*

This bibliography covers regulations that require a developer to dedicate land, pay fees, provide improvements, or otherwise bear some of the community's costs as a condition to approval of his plat. Although the bibliography primarily concentrates on materials concerning land exactions in the United States, there is selective inclusion of materials from Great Britain and Canada. Coverage starts from 1949, the year the California case, Ayres v. City Council, was decided. The materials in the bibliography are arranged by type into three sections: (1) articles, (2) monographs, and (3) enabling acts for the fifty states.
