ABSTRACT

Schauder estimates were a historical stepping stone for establishing uniqueness and smoothness of solutions for certain classes of partial differential equations. Since that time, they have remained an essential tool in the field. Roughly speaking, the estimates state that the Hölder continuity of the coefficient functions and inhomogeneous term implies the Hölder continuity of the solution and its derivatives. This document establishes pointwise Schauder estimates for second order “parabolic” equations of the form

$$\partial_t u(x, t) - \sum_{i,j=1}^{m_1} a_{ij}(x, t) X_i X_j u(x, t) = f(x, t)$$

where X_1, \dots, X_{m_1} generate the first layer of the Lie algebra stratification for a Carnot group. The Schauder estimates are shown by means of Campanato spaces. These spaces make the pointwise nature of the estimates possible by comparing solutions to their Taylor polynomials. As a prerequisite device, a version of both the mean value theorem and Taylor inequality are established with the parabolic distance incorporated.

0.1 Introduction

Schauder estimates are an essential tool in regularity theory for partial differential equations. Roughly speaking the Schauder estimates state that given a solution to an inhomogeneous equation where the coefficients of the operator as well as the inhomogeneous term are both Hölder continuous, this regularity transmits through the operator to give Hölder continuity of the derivatives of the solution. These estimates were the key to showing uniqueness and smoothness of solutions for certain classes of equations [36].

Juliusz Schauder is credited for the proof in the case of second order linear elliptic equations given in [39] and [40]. Though Caccioppoli also had a similar result around the same time, his work was not as detailed [11]. Hölder continuity in the much simpler case of the Laplacian is due to Hopf [30] a few years prior to Schauder's result. Because of the usefulness of the inequality, a common objective of showing these types of estimates for different types of equations under more general conditions arose. As a result, many methods of proof have emerged. Mentioned here are only a few most relevant to the work of this dissertation. A more complete discussion on Hölder estimates and regularity of solutions can be found in [26, Chapter 6] for elliptic equations or [34, Chapter 4] for parabolic equations.

One method of deriving Schauder estimates depends on having a representation of a fundamental solution, explicitly computing derivatives, and relying on methods of singular integrals to get the results. This is demonstrated in [26, Chapter 6] as well as Chapter 1 of this manuscript. Another method is by means of the Morrey-Campanato classes, which are equivalent to the Hölder spaces and can be seen in [24, Chapter 3] as well as [34, Chapter 4]. A third method is based on a scaling argument and approximation of solutions by Taylor

polynomials. It can be found in [41, Section 1.7]. The proof for the Schauder estimates given in this dissertation has aspects reminiscent of all these methods.

The main result of this paper is a generalization of the classic result in two ways. The “pointwise” result requires only Hölder continuity of the coefficients and inhomogeneous term at a single point in order to get the Hölder continuity of the solution and its derivatives at that same point. This pointwise nature can be useful when the source term or coefficients are not well behaved everywhere. It also allows an application to the study of nodal sets [28]. The other generalization is the change from the Euclidean setting to the Carnot group setting where derivatives are given by vector fields which may not necessarily commute.

Comparing the solution to its Taylor polynomial, a technique first popularized by Caffarelli in 1998 in his work on fully nonlinear equations [12], makes possible the pointwise generalization of the estimate. Caffarelli’s approach was generalized to parabolic equations by Wang in [43], and about a decade later, Han used this same method for proving pointwise Schauder estimates for higher order parabolic and elliptic equations in [28] and [29]. His interest was in the application to nodal sets. These results were extended by Capogna and Han [15] to second order subelliptic linear equations over Carnot groups in 2003. The proof contained in this dissertation follows the same method.

Global and local Schauder estimates have been explored in the group setting as well as the more general case of Hörmander type vector fields. Though this list is not exhaustive, see [5], [7], [9], [10], [27], and [44] for more details. However, the pointwise result contained here seems to be new.

The outline of the paper is as follows. In Chapter 1, the classical Schauder estimates for elliptic equations is discussed. In Chapter 2, we begin with basic definitions related to Carnot

groups before proving the Schauder estimates for the sublaplacian in this setting. Chapter 3 begins the transition to the parabolic setting. Definitions regarding the product space of a group and the real line are made. The main tools such as group polynomials, Campanato classes, and Sobolev spaces are defined, and several lemmas regarding these items are shown. The proof of the main theorem (stated below) is given in Chapter 4.

Before stating the main result, the operator of interest is given by

$$(0.1) \quad H_A = \partial_t - \sum_{i,j=1}^{m_1} a_{i,j}(x,t) X_i X_j$$

where the vector fields X_1, \dots, X_{m_1} generate the first layer of the Lie algebra stratification for a Carnot group, and the matrix $A = (a_{ij})$ is Hölder continuous only at the origin. Additionally there exist constants $1 < \lambda \leq \Lambda < \infty$ such that

$$(0.2) \quad \lambda |\xi|^2 \leq \sum_{i,j=1}^{m_1} a_{ij}(x,t) \xi_i \xi_j \leq \Lambda |\xi|^2 \quad \text{for any } \xi \in \mathbb{R}^{m_1}.$$

The operator is a non-divergence form similar to the heat equation, but it is not truly parabolic as the title suggests since m_1 may be less than the dimension of the space.

Let Q denote the homogeneous dimension of the group \mathbb{G} and $S_p^{2,1}$ denote the Sobolev space containing two spatial derivatives and one time derivative. The exact definitions for the Hölder and Campanato classes can be found in Section 3.3.

THEOREM 0.1. For $Q + 2 < p < \infty$, let $u \in S_p^{2,1}(\mathcal{Q}_1)$ and $H_A u = f$ in \mathcal{Q}_1 with $f \in L^p(\mathcal{Q}_1)$. Assume, for some $\alpha \in (0, 1)$ and some integer $d \geq 2$, $f \in C_{p,d-2}^\alpha(0, 0)$ and $a_{ij} \in C_{p,d-2}^\alpha(0, 0)$. Then $u \in C_{\infty,d}^\alpha(0, 0)$ and

$$\|u\|_{\infty,\alpha,d}(0, 0) \leq C(\|u\|_{L^p(\mathcal{Q}_1)} + \|f\|_{p,\alpha,d-2}(0, 0))$$

where $C = C(\mathbb{G}, p, d, \alpha, A) > 0$.

Section 4.1 gives bounds for the heat kernel associated to the constant coefficient equation as well as a few lemmas regarding polynomial expansions of solutions. These are essential for the constant coefficient a-priori estimates shown in Section 4.2. These estimates give specific information about the bounds of the Sobolev norm of solutions, which is then used to give a basic version of the Schauder estimates for the constant coefficient equation as a quick corollary. The corollary is vastly useful because it allows us to transmit information from the polynomials approximating the inhomogeneous term to the polynomial approximating the solution. The freezing technique is then employed to give a-priori estimates for the non-constant coefficient equation, and a weak version of the Schauder estimates is shown. (It is weak in the sense that we still assume some amount of regularity on solutions and inhomogeneous term.) Finally, by comparing the solution to its first order Taylor polynomial and successively applying the a-priori estimates, the final result is obtained.

CHAPTER 1

The Classical Schauder Estimates

In this chapter, the Schauder estimates for the Laplacian will be shown in detail following the proof given in chapter 4 of [26]. These estimates can be used to get the same result for the more general elliptic case. A description of this method is provided.

The symbols below will be used to notate Hölder continuity on a bounded set Ω where α is always taken to be in $(0, 1)$. By definition $u \in C^\alpha(\Omega)$ is given by

$$[u]_{0,\alpha,\Omega} = \sup_{\substack{x,y \in \Omega \\ x \neq y}} \frac{|u(x) - u(y)|}{|x - y|^\alpha} < \infty,$$

and if $x_o \in \Omega$, we will say u is Hölder continuous at x_o if

$$[u]_{\alpha,x_o} = \sup_{\Omega} \frac{|u(x) - u(x_o)|}{|x - x_o|^\alpha} < \infty.$$

Similarly, $u \in C^{k,\alpha}(\Omega)$ is defined to the space of functions u such that

$$[u]_{k,\alpha,\Omega} = \sup_{|\beta|=k} \sup_{\substack{x,y \in \Omega \\ x \neq y}} \frac{|D^\beta u(x) - D^\beta u(y)|}{|x - y|^\alpha} < \infty.$$

Recall the fundamental solution to Laplace's equation,

$$\Gamma(x - y) = \begin{cases} \frac{1}{n(2-n)\omega_n} |x - y|^{2-n} & n > 2 \\ \frac{1}{2\pi} \log|x - y| & n = 2 \end{cases}.$$

The proof of the Schauder estimates depends very heavily on the following upper bounds of the fundamental solution, which result from direct computation.

$$(1.1) \quad |D^\beta \Gamma(x-y)| \leq C(n, |\beta|) |x-y|^{2-n-|\beta|} \text{ for } |\beta| = 0, 1, 2, \dots$$

We will also make extensive use of Green's representation formula.

$$(1.2) \quad u(y) = \int_{\partial\Omega} \left(u \frac{\partial \Gamma}{\partial \nu}(x-y) - \Gamma(x-y) \frac{\partial u}{\partial \nu} \right) ds + \int_{\Omega} \Gamma(x-y) \Delta u dx, \quad y \in \Omega.$$

Lemmas 1.1 and 1.3 are stated to be true for the Newtonian potential of f , which is by definition $\Gamma * f$. However, the lemmas also apply for solutions of $\Delta u = f$ with compact support since this would result in a vanishing boundary integral in Green's formula.

LEMMA 1.1. *Suppose u is the Newtonian potential of f in Ω , where f is bounded and Hölder continuous in Ω . Then $u \in C^2(\Omega)$ and for every $x \in \Omega$ and $i, j = 1, \dots, n$,*

$$(1.3) \quad D_i u(x) = \int_{\Omega} D_i \Gamma(x-y) f(y) dy$$

and

$$(1.4) \quad D_{ij} u(x) = \int_{\Omega_o} D_{ij} \Gamma(x-y) (f(y) - f(x)) dy - f(x) \int_{\partial\Omega_o} D_i \Gamma(x-y) \nu_j(y) dS_y$$

where Ω_o contains Ω and supports the divergence theorem.

PROOF. While (1.3) seems obvious, it requires some work. The singularity in Γ prevents the use of the dominated convergence theorem, so begin by extending f to vanish outside of Ω and defining $v(x) = \int_{\Omega} D_i \Gamma(x-y) f(y) dy$, which is well defined due to (1.1). Then take a

cutoff function $\eta(t) \in C^1(\mathbb{R})$ with the following properties: $0 \leq \eta \leq 1$, $0 \leq \eta' \leq 2$, $\eta(t) = 0$ for $t \leq 1$, and $\eta(t) = 1$ for $t \geq 2$.

For $\epsilon > 0$ let

$$u_\epsilon(x) = \int_{\Omega} \Gamma(x-y) \eta\left(\frac{|x-y|}{\epsilon}\right) f(y) dy,$$

and notice that $u_\epsilon = 0$ when $|x-y| < \epsilon$ and $u_\epsilon = u$ when $|x-y| > \epsilon$.

To show $D_i u_\epsilon$ converges to v , look at the difference

$$\begin{aligned} |v(x) - D_i u_\epsilon(x)| &= \left| \int_{|x-y| \leq 2\epsilon} D_i \left[\Gamma(x-y) (1 - \eta\left(\frac{|x-y|}{\epsilon}\right)) \right] f(y) dy \right| \\ &= \left| \int_{|x-y| \leq 2\epsilon} \left[D_i \Gamma(x-y) - \Gamma(x-y) D_i \eta\left(\frac{|x-y|}{\epsilon}\right) \right] f(y) dy \right| \\ &\leq \sup |f| \int_{|x-y| \leq 2\epsilon} |D_i \Gamma(x-y)| + \frac{2}{\epsilon} |\Gamma(x-y)| dy. \end{aligned}$$

Finally,

$$|v(x) - D_i u_\epsilon(x)| \leq \sup |f| \begin{cases} \frac{2n\epsilon}{n-2} & n > 2 \\ 4\epsilon(1 + \log(2\epsilon)) & n = 2 \end{cases}.$$

The right hand side converges to 0 as $\epsilon \rightarrow 0$. And since u_ϵ and $D_i u_\epsilon$ converge in Ω to u and v respectively, the implication gives $u \in C^1(\Omega)$ as well as the first conclusion.

The second part of the proof continues in a similar fashion. Continuing with $v = D_i u$, let

$$v_\epsilon(x) = \int_{\Omega} D_i \Gamma(x-y) \eta\left(\frac{|x-y|}{\epsilon}\right) f(y) dy,$$

and differentiate.

$$D_j v_\epsilon(x) = \int_{\Omega} D_j \left[D_i \Gamma(x-y) \eta\left(\frac{|x-y|}{\epsilon}\right) \right] f(y) dy$$

$$\begin{aligned}
&= \int_{\Omega_o} D_j \left[D_i \Gamma(x-y) \eta \left(\frac{|x-y|}{\epsilon} \right) \right] (f(y) - f(x)) dy \\
&\quad + f(x) \int_{\Omega_o} D_j \left[D_i \Gamma(x-y) \eta \left(\frac{|x-y|}{\epsilon} \right) \right] dy \\
&= \int_{\Omega_o} D_j \left[D_i \Gamma(x-y) \eta \left(\frac{|x-y|}{\epsilon} \right) \right] (f(y) - f(x)) dy \\
&\quad - f(x) \int_{\partial\Omega_o} D_i \Gamma(x-y) \eta \left(\frac{|x-y|}{\epsilon} \right) \nu_j(y) dS_y.
\end{aligned}$$

The last equality follows from the divergence theorem.

Set $g(x) = \int_{\Omega_o} D_{ij} \Gamma(x-y) (f(y) - f(x)) dy - f(x) \int_{\partial\Omega_o} D_i \Gamma(x-y) \nu_j(y) dS_y$. Then $g(x)$ is well defined by virtue of the bounds (1.1) and the Hölder continuity of f . Examining the difference below will give the final conclusion.

$$\begin{aligned}
|g(x) - D_j v_\epsilon(x)| &= \left| \int_{\Omega_o} D_j \left\{ D_i \Gamma(x-y) \left[1 - \eta \left(\frac{|x-y|}{\epsilon} \right) \right] \right\} (f(y) - f(x)) dy \right. \\
&\quad \left. - f(x) \int_{\partial\Omega_o} \left[1 - \eta \left(\frac{|x-y|}{\epsilon} \right) \right] D_i \Gamma(x-y) \nu_j(y) dS_y \right| \\
&= \left| \int_{|x-y| < 2\epsilon} D_j \left\{ D_i \Gamma(x-y) \left[1 - \eta \left(\frac{|x-y|}{\epsilon} \right) \right] \right\} (f(y) - f(x)) dy \right| \\
&\leq [f]_{\alpha, x} \int_{|x-y| < 2\epsilon} |D_{ij} \Gamma(x-y) \left[1 - \eta \left(\frac{|x-y|}{\epsilon} \right) \right]| |x-y|^\alpha \\
&\quad + |D_i \Gamma(x-y) D_j \eta \left(\frac{|x-y|}{\epsilon} \right)| |x-y|^\alpha dy \\
&\leq [f]_{\alpha, x} \int_{|x-y| < 2\epsilon} \left(|D_{ij} \Gamma(x-y)| + \frac{2}{\epsilon} |D_i \Gamma(x-y)| \right) |x-y|^\alpha dy \\
&\leq C(n, \alpha) [f]_{\alpha, x} (2\epsilon)^\alpha
\end{aligned}$$

for $\epsilon < \text{dist}(x, \partial\Omega)$. Consequently, the uniform convergence of $D_j v_\epsilon$ to $g(x)$ on compact subsets and the convergence of v_ϵ to $D_i u$ in Ω gives the equality (1.4). \square

REMARK 1.2. From the previous proof, it is easy to show that if $u = \Gamma * f$, then $\Delta u = f$.

To see this set $\Omega_o = B_R$ in (1.4), then for a sufficiently large R , one obtains

$$\Delta u = \frac{1}{n\omega_n R^{n-1}} f(x) \int_{|x-y|=R} \nu_j(y) \nu_i(y) dS_y = f(x).$$

However, this solution is not unique. You can always add a harmonic function to u and have another solution.

LEMMA 1.3. Let $B_1 = B_R(x_o)$ and $B_2 = B_{2R}(x_o)$ be concentric balls in \mathbb{R}^n . Suppose $f \in C^\alpha(\bar{B}_2)$, and suppose u is the Newtonian potential of f in B_2 . Then $u \in C^{2,\alpha}(\bar{B}_1)$ and

$$(1.5) \quad \sup_{B_1} |D^2 u| + R^\alpha [D^2 u]_{\alpha, B_1} \leq C(\sup_{B_2} |f| + R^\alpha [f]_{\alpha, B_2})$$

where $C = C(n, \alpha)$.

PROOF. Take $x \in B_1$, formula (1.4) reads

$$D_{ij}u(x) = \int_{B_2} D_{ij}\Gamma(x-y)(f(y) - f(x))dy - f(x) \int_{\partial B_2} D_i\Gamma(x-y)\nu_j(y)dS_y.$$

Applying the bounds to the fundamental solution and using Hölder continuity of f , gives the estimate

$$(1.6) \quad \begin{aligned} |D_{ij}u(x)| &\leq \frac{[f]_{\alpha, x}}{\omega_n} \int_{B_2} |x-y|^{\alpha-n} dy + \frac{|f(x)|}{n\omega_n} R^{1-n} \int_{\partial B_2} dS_y \\ &\leq 2^{n-1}|f(x)| + \frac{n}{\alpha}(3R)^\alpha [f]_{\alpha, x} \\ &\leq C_1(n, \alpha)(|f(x)| + [f]_{\alpha, x}). \end{aligned}$$

Choose another point $\bar{x} \in B_1$ and use (1.4) again to get

$$D_{ij}u(\bar{x}) = \int_{B_2} D_{ij}\Gamma(\bar{x} - y)(f(y) - f(\bar{x}))dy - f(\bar{x}) \int_{\partial B_2} D_i\Gamma(x - y)\nu_j(y)dS_y.$$

To avoid singularities and examine the continuity of D^2u , we write the difference in a special way letting $\delta = |x - \bar{x}|$ and $\xi = \frac{1}{2}(x + \bar{x})$.

$$D_{ij}u(\bar{x}) - D_{ij}u(x) = f(x)I_1 + (f(x) - f(\bar{x}))I_2 + I_3 + I_4 + (f(x) - f(\bar{x}))I_5 + I_6$$

where the integrals are given by

$$\begin{aligned} I_1 &= \int_{\partial B_2} (D_i\Gamma(x - y) - D_i\Gamma(\bar{x} - y))\nu_j(y)dS_y, \\ I_2 &= \int_{\partial B_2} D_i\Gamma(\bar{x} - y)\nu_j(y)dS_y, \\ I_3 &= \int_{B_\delta(\xi)} D_{ij}\Gamma(x - y)(f(x) - f(y))dy, \\ I_4 &= \int_{B_\delta(\xi)} D_{ij}\Gamma(\bar{x} - y)(f(y) - f(\bar{x}))dy, \\ I_5 &= \int_{B_2/B_\delta(\xi)} D_{ij}\Gamma(x - y)dy, \text{ and} \\ I_6 &= \int_{B_2/B_\delta(\xi)} (D_{ij}\Gamma(x - y) - D_{ij}\Gamma(\bar{x} - y))(f(\bar{x} - f(y))dy. \end{aligned}$$

The estimation of each is fairly straight forward. For I_1 , take \hat{x} between x and \bar{x} . Then

$$\begin{aligned} |I_1| &\leq |x - \bar{x}| \int_{\partial B_2} \frac{|D_i\Gamma(x - y) - D_i\Gamma(\bar{x} - y)|}{|x - \bar{x}|} dS_y \\ &\leq |x - \bar{x}| \int_{\partial B_2} |DD_i\Gamma(\hat{x} - y)| dS_y \\ &\leq |x - \bar{x}| \int_{\partial B_2} |\hat{x} - y|^{-n} dS_y \end{aligned}$$

$$\begin{aligned}
&\leq R^{-n}|x - \bar{x}| \int_{\partial B_2} dS_y \\
&\leq C_1 R^{-1}|x - \bar{x}| \\
&\leq C_1 \left(\frac{\delta}{R}\right) \\
&\leq C_1 \left(\frac{\delta}{R}\right)^\alpha.
\end{aligned}$$

The last inequality follows from $\delta < 2R$.

$$\begin{aligned}
|I_2| &\leq \int_{\partial B_2} |D_i \Gamma(\bar{x} - y)| dS_y \\
&\leq (n\omega_n)^{-1} R^{1-n} \int_{\partial B_2} dS_y \\
&\leq C_2.
\end{aligned}$$

For I_3 , we integrate over a slightly larger set.

$$\begin{aligned}
|I_3| &\leq \int_{B_{3\delta/2}(x)} |D_{ij} \Gamma(x - y)| |f(x) - f(y)| dy \\
&\leq (\omega_n)^{-1} [f]_{\alpha, x} \int_{B_{3\delta/2}(x)} |x - y|^{-n} |x - y|^\alpha dy \\
&\leq C_3 \left(\frac{3\delta}{2}\right)^\alpha [f]_{\alpha, x}.
\end{aligned}$$

I_4 is handled in exactly the same fashion to give

$$|I_4| \leq C_4 \left(\frac{3\delta}{2}\right)^\alpha [f]_{\alpha, x}.$$

Using integration by parts,

$$\begin{aligned}
|I_5| &= \left| \int_{\partial B_2/B_\delta(\xi)} D_i \Gamma(x-y) \nu_j(y) dS_y \right| \\
&\leq \left| \int_{\partial B_2} D_i \Gamma(x-y) \nu_j(y) dS_y \right| + \left| \int_{\partial B_\delta(\xi)} D_i \Gamma(x-y) \nu_j(y) dS_y \right| \\
&\leq 2^{n-1} + (n\omega_n) \left(\frac{\delta}{2} \right)^{1-n} \int_{\partial B_\delta} dS_y \\
&\leq C_5.
\end{aligned}$$

Finally,

$$\begin{aligned}
|I_6| &\leq |x - \bar{x}| \int_{B_2/B_\delta(\xi)} |DD_{ij}\Gamma(\hat{x}-y)| |f(\bar{x}) - f(y)| dy \\
&\leq c\delta \int_{|y-\xi|\geq\delta} \frac{|f(\bar{x}) - f(y)|}{|\hat{x}-y|^{n+1}} dy \\
&\leq c\delta [f]_{\alpha, \bar{x}} \int_{|y-\xi|\geq\delta} \frac{|\bar{x}-y|^\alpha}{|\hat{x}-y|^{n+1}} dy \\
&\leq c' \left(\frac{3}{2} \right)^\alpha 2^{n+1} \delta [f]_{\alpha, \bar{x}} \int_{|y-\xi|\geq\delta} |\xi-y|^{\alpha-n-1} dy \\
&\leq C_6 \delta^\alpha [f]_{\alpha, \bar{x}}
\end{aligned}$$

since $|\bar{x} - y| \leq 3/2|\xi - y| \leq |\hat{x} - y|$.

Thus after collecting terms,

$$|D_{ij}u(\bar{x}) - D_{ij}u(x)| \leq C'(R^{-\alpha}|f(x)| + [f]_{\alpha, x} + [f]_{\alpha, \bar{x}})|x - \bar{x}|^\alpha,$$

where C' is a constant depending only on n and α . Rewriting and taking the supremum over B_2 gives,

$$R^\alpha [D^2u]_{\alpha, B_1} \leq C'(|f(x)| + R^\alpha [f]_{\alpha, B_2}).$$

Combining this with (1.6) gives the conclusion. \square

Now we consider solutions to Poisson's equation $\Delta u = f$. To make the equations more compact, we introduce the following norms:

$$|u|_{k,\alpha,\Omega} := \sum_{j=0}^k \sup_{|m|=j} \sup_{\Omega} |D^m u| + [D^k u]_{\alpha,\Omega}$$

and

$$|u|'_{k,\alpha,B_R} := \sum_{j=0}^k R^j \sup_{|m|=j} \sup_{B_R} |D^m u| + R^k [D^k u]_{\alpha,B_R}.$$

THEOREM 1.4. *Let Ω be a domain in \mathbb{R}^n where $n > 2$ and let $u \in C^2(\Omega)$ and for any two concentric balls (as in Lemma 1.3) B_1 and B_2 completely contained in Ω , we have*

$$(1.7) \quad |u|'_{2,\alpha,B_1} \leq C(\sup_{B_2} |u| + R^2 |f|'_{0,\alpha,B_2})$$

where C depends only on n and α .

PROOF. For $x \in B_2$, decompose u as $u(x) = v(x) + h(x)$ where $v(x)$ is the newtonian potential of f and h is a harmonic function. Gathering information we have on v ;

$$(1.8) \quad \begin{aligned} \sup_{B_1} |v| &\leq C_1 R^2 \sup_{B_1} |f| \quad \text{by Green's formula.} \\ \sup_{B_1} |Dv| &\leq C_2 R \sup_{B_1} |f| \quad \text{by (1.1).} \\ |D^2 v|_{0,\alpha,B_1} &\leq C_3 |f|_{0,\alpha,B_2} \quad \text{by (1.3).} \end{aligned}$$

Together, these give the theorem for the case of v , the Newtonian potential.

Now, we examine h . By interior estimates of derivatives, see [26, Theorem 2.10] we have

$$R \sup_{B_1} |Dh| + R^2 |D^2 h|'_{0,\alpha,B_1} \leq C(n) \sup_{B_2} |h|.$$

And clearly,

$$(1.9) \quad \sup_{B_2} |h| \leq \sup_{B_2} |u| + \sup_{B_2} |v| \leq C(n) (\sup_{B_2} |u| + R^2 \sup_{B_2} |f|).$$

Finally, by (1.8) and (1.9) the conclusion is reached.

$$\begin{aligned} |u|'_{2,\alpha,B_1} &\leq |v|'_{2,\alpha,B_1} + |h|'_{2,\alpha,B_1} \\ &\leq C(\sup_{B_2} |u| + R^2 |f|'_{0,\alpha,B_2}). \end{aligned}$$

□

With certain adaptations of the norms, we give a more general version of Theorem 1.4.

Let d_x be the distance between x and $\partial\Omega$ and $d_{x,y} = \min\{d_x, d_y\}$. Now define

$$|u|_{k,\alpha,\Omega}^* := \sum_{j=0}^k \sup_{\substack{|m|=j \\ x \in \Omega}} d_x^j |D^m u| + \sup_{\substack{|m|=j \\ x,y \in \Omega}} d_{x,y}^{k+\alpha} \frac{|D^k u(x) - D^k u(y)|}{|x-y|^\alpha}$$

and

$$|f|_{0,\alpha,\Omega}^{(2)} := \sup_{x \in \Omega} d_x^2 |f(x)| + \sup_{x,y \in \Omega} d_{x,y}^{2+\alpha} \frac{|f(x) - f(y)|}{|x-y|^\alpha}.$$

THEOREM 1.5. (*Interior Schauder Estimates for the Laplacian*)

Suppose $u \in C^2(\Omega)$ and $f \in C^\alpha(\Omega)$ satisfy $\Delta u = f$ in an open set Ω of \mathbb{R}^n . Then

$$(1.10) \quad |u|_{2,\alpha,\Omega}^* \leq C(\sup_{\Omega} |u| + |f|_{0,\alpha,\Omega}^{(2)})$$

where C depends only on n and α .

PROOF. For $x \in \Omega$, set $R = \frac{1}{3}d_x$, $B_1 = B_R(x)$ and $B_2 = B_{2R}(x)$. Then it follows that

$$\begin{aligned} d_x |Du| + d_x^2 |D^2u| &\leq 3R \sup_{B_1} |Du| + (3R)^2 \sup_{B_1} |D^2u| \\ &\leq C(\sup_{B_2} |u| + R^2 |f'|_{0,\alpha,B_2}) \quad \text{by (1.7)} \\ &\leq C(\sup_{\Omega} |u| + |f|_{0,\alpha,\Omega}^{(2)}). \end{aligned}$$

Now we choose $x, y \in \Omega$ such that $d_x \leq d_y$. Then

$$\begin{aligned} d_{x,y}^{2+\alpha} \frac{|D^2u(x) - D^2u(y)|}{|x - y|^\alpha} &\leq (3R)^{2+\alpha} [D^2u]_{\alpha,B_1} \\ &\quad + 3^\alpha (3R)^2 (|D^2u(x)| + |D^2u(y)|) \\ &\leq C(\sup_{B_2} |u| + R^2 |f'|_{0,\alpha,B_2}) + 6 \sup_{\Omega} d_x^2 |D^2u(x)| \quad \text{by (1.7)} \\ &\leq C(\sup_{\Omega} |u| + |f|_{0,\alpha,\Omega}^{(2)}). \end{aligned}$$

□

We will now allude to the proofs for the case of constant coefficient equations as well as equations with Hölder continuous coefficients.

To get the Schauder estimates for a constant coefficient second order elliptic equation, (for example $L_o u = \sum_{i,j=1}^n a_{ij} \partial_{x_i} \partial_{x_j} u = f$), a simple linear transformation of the matrix with entries a_{ij} is needed. Under this transformation, the operator is mapped to the Laplacian. Keeping careful track of the effect of this transformation on both u and f as well as the effect on the norms in Theorem 1.5, the same conclusion can be reached for the constant coefficient equation. For details, see [26, Lemma 6.1].

Consider now, $L = \sum_{i,j=1}^n a_{ij}(x)\partial_{x_i}\partial_{x_j}$. Dealing with variable coefficients is usually done by the freezing technique. Evaluating the coefficients at a specific point would give an operator of the form L_o . Writing $L_o u = L_o u - Lu + Lu$ and regrouping the terms allows for the use of the constant coefficient result as well as the conditions on the continuity of the coefficient functions. This method also relies on interpolation inequalities of the Hölder norms and can be viewed in [26, Theorem 6.2].

CHAPTER 2

Carnot Groups

2.1 Definitions and Examples

The setting for the sequel is a special type of Lie group with many structures allowing computations to be done in a fashion similar to the Euclidean setting. Most essential to the proof of the Schauder estimates is the extensive use of the homogeneity of Carnot groups. However, care must be taken in the development of ideas such as scaling and distance. This introduction to Carnot groups aims to make these notions clear and precise while pointing out some of the difficulties of working in these groups, the most obvious of which is the fact that the derivatives do not necessarily commute.

Before commencing, let it be known that in this document all vector fields can be written as linear combinators of standard partial derivatives with smooth coefficient functions. That is

$$X = \sum_{k=1}^n b_k(x) \partial_{x_k} \quad \text{where } b_k(x) \in C^\infty(\mathbb{R}^n).$$

DEFINITION 2.1. *A Carnot group \mathbb{G} of step $r \geq 1$ is a connected and simply connected nilpotent Lie group whose Lie algebra \mathfrak{g} admits a vector space decomposition into r layers.*

$$\mathfrak{g} = V^1 \oplus V^2 \oplus \cdots \oplus V^r$$

having the properties that \mathfrak{g} is graded and generated by V^1 . Explicitly, $[V^1, V^j] = V^{j+1}$, $j = 1, \dots, r-1$ and $[V^j, V^r] = 0$, $j = 1, \dots, r$.

Let $m_j = \dim(V^j)$ and let $X_{i,j}$ denote a left-invariant basis of V^j where $1 \leq j \leq r$ and $1 \leq i \leq m_j$. The homogeneous dimension of \mathbb{G} is defined as $Q = \sum_{k=1}^r km_k$. For simplicity, we will set $X_i = X_{i,1}$. We call $\{X_i\}$ the horizontal vector fields and call their span, denoted $H\mathbb{G}$, the horizontal bundle. We call $\{X_{i,j}\}_{2 \leq j \leq r}$ the vertical vector fields and refer to their span, denoted $V\mathbb{G}$, as the vertical bundle. Then $\mathfrak{g} = H\mathbb{G} \oplus V\mathbb{G}$. In fact, the Lie algebra spans the whole tangent space of the group ($T\mathbb{G} = \mathfrak{g}$).

Because of the stratification of the Lie algebra, there is a natural dilation on \mathfrak{g} . If $X = \sum_{k=1}^r X_k$ where $X_k \in V^k$, then the dilation can be defined by $\delta_s(X) = \sum_{k=1}^r s^k X_k$. It is worth noting here that while dilation mappings are defined on the Lie algebra, the mapping $\exp \circ \delta_s \circ \exp^{-1}$ gives the dilation on the group \mathbb{G} . However, the same notation, δ_s , will be used for both maps.

Recall the definition of the exponential of a vector field, X . Fix a point $p \in \mathbb{G}$. Let $\gamma(t)$ be a curve such that $\gamma(0) = p$ and $\frac{d}{dt}\gamma(t) = X_{\gamma(t)}$. (The existence of such a curve is guaranteed by the theorem of existence and uniqueness of systems of ordinary differential equations.) The exponential map is defined as $\exp_p(X) = \gamma(1)$, or more generally, $\exp_p(tX) = \gamma(t)$.

For Lie groups, p is taken as the identity element, and the exponential map provides a means of relating the Lie algebra to the group itself.

$$\exp : \mathfrak{g} \rightarrow \mathbb{G}.$$

And in the special case of Carnot groups, the exponential map is an analytic diffeomorphism, and the Baker-Campbell-Hausdorff formula holds for all X and Y in \mathfrak{g} . For a proof see [17, Theorem 1.2.1].

The Baker-Campbell-Hausdorff formula (BCH) gives a more complete picture of how the exponential map relates the algebra to the group. Take two vector fields in the Lie algebra, X and Y . The BCH is given by explicitly solving for the vector field Z in the equation $\exp(Z) = \exp(X) \cdot \exp(Y)$.

$$\begin{aligned} Z &= \log(\exp(X) \cdot \exp(Y)) \\ (2.1) \quad &= X + Y + \frac{1}{2}[X, Y] + \frac{1}{12}[X, [X, Y]] - \frac{1}{12}[Y, [X, Y]] + \dots \end{aligned}$$

The formula continues with higher order commutators. For nilpotent Lie groups, it is clear the summation will eventually terminate.

DEFINITION 2.2. *Let $\{X_1, \dots, X_n\}$ be a basis for a nilpotent Lie algebra \mathfrak{g} , and consider a map*

$$\Psi : \mathbb{R}^n \rightarrow \mathbb{G}$$

$$\Psi(s_1, \dots, s_n) = \exp(s_1 X_1 + \dots + s_n X_n).$$

The coordinates given by the map Ψ are called exponential coordinates or canonical coordinates of the first kind.

Canonical coordinates of the second kind are defined similarly by taking

$$\Psi(s_1, \dots, s_n) = \exp(s_1 X_1) \cdots \exp(s_n X_n).$$

The foundation has now been laid to give a few examples of Carnot groups.

EXAMPLE 2.3. *The Heisenberg group, \mathbb{H}^n , is a step 2 Carnot group whose underlying manifold is \mathbb{R}^{2n+1} . Taking $x, x' \in \mathbb{R}^{2n}$ and $t, t' \in \mathbb{R}$, the group operation is given by*

$$(x, t) \cdot (x', t') = (x + x', t + t' + 2 \sum_{i=1}^n (x'_i x_{n+i} - x_i x'_{n+i})).$$

The vector fields below form a left-invariant basis for the Lie algebra, $\mathfrak{h} = V^1 \oplus V^2$.

$$X_i = \partial_{x_i} - \frac{1}{2} x_{n+i} \partial_t, \quad X_{i+n} = \partial_{x_{n+i}} + \frac{1}{2} x_i \partial_t \quad \text{for } i = 1, \dots, n$$

$$\text{and } T = \partial_t$$

The horizontal bundle is given by $V^1 = \text{span}\{X_1, \dots, X_{2n}\}$, and the vertical bundle is then $V^2 = \text{span}\{T\}$ leading to a homogeneous dimension of $2n + 2$.

EXAMPLE 2.4. *The Engel group, \mathbb{K}_3 , is an example of a step 3 Carnot group with a homogeneous dimension of 7. See [17] and [18] for more information. This group has an underlying manifold of \mathbb{R}^4 , and the group operation is given by*

$$x \cdot x' = (x_1 + x'_1, x_2 + x'_2, x_3 + x'_3 + A_3, x_4 + x'_4 + A_4)$$

where

$$A_3 = \frac{1}{2}(x_1 x'_2 - x_2 x'_1)$$

and

$$A_4 = \frac{1}{2}(x_1 x'_3 - x_3 x'_1) + \frac{1}{12}(x_1^2 x'_2 - x_1 x'_1 (x_2 + x'_2) + x_2 (x'_1)^2).$$

The Lie algebra can be graded as $\mathfrak{g} = V^1 \oplus V^2 \oplus V^3$ by letting $V^1 = \text{span}\{X_1, X_2\}$, $V^2 = \text{span}\{X_3\}$, and $V^3 = \text{span}\{X_4\}$. Using the Baker-Campbell-Hausdorff formula, expressions

for the vector fields can be found.

$$X_1 = \partial_{x_1} - \frac{x_2}{2}\partial_{x_3} - \left(\frac{x_3}{2} + \frac{x_1x_2}{12}\right)\partial_{x_4}$$

$$X_2 = \partial_{x_2} + \frac{x_1}{2}\partial_{x_3} + \frac{x_1^2}{12}\partial_{x_4}$$

$$X_3 = \partial_{x_3} + \frac{x_1}{2}\partial_{x_4}$$

$$X_4 = \partial_{x_4}$$

Notice that $[X_1, X_2] = X_3$ and $[X_1, X_3] = X_4$ and all other commutators are trivial.

For demonstrative purposes, return to the first Heisenberg group, \mathbb{H}^1 . This group is of great interest and widely studied not only because of its appearance in applications but also because there are only two 3 dimensional simply connected nilpotent Lie groups: \mathbb{H}^1 and \mathbb{R}^3 .

It is simple to check the left-invariance of the vector fields for \mathbb{H}^1 . Let $f(x, y, t)$ be a left translation by (a, b, c) .

$$f(x, y, t) = (x + a, y + b, t + c + 1/2(ay - bx))$$

The differential is

$$(2.2) \quad df = \begin{pmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ -b/2 & a/2 & 1 \end{pmatrix}.$$

Consider first the vector field $X_1 = \partial_x - (y/2)\partial_t = \begin{pmatrix} 1 \\ 0 \\ -y/2 \end{pmatrix}$. If we are to first take the X_1 derivative at a point $p = (x, y, t)$ and then apply the left translation in the tangent space, we get $df \cdot X_1 = \partial_x + (-b/2 - y/2)\partial_t$. On the other hand, if we left translate the point and then find the derivative at the translated point, we get $X_1 \circ f(x, y, t) = \partial_x + (-b/2 - y/2)\partial_t$. Therefore $f_*X_1 = X \circ f$ showing X_1 is left-invariant. The same can be done for the other vector fields. A nice derivation of the vector fields is given in [14].

For \mathbb{H}^1 , the underlying manifold is \mathbb{R}^3 , but X_1 and X_2 do not span all of the tangent space. The commutator, $T = \partial_t$, recovers the missing direction. This group is said to satisfy *Hörmander's condition*. In fact, Carnot groups in general satisfy Hörmander's condition, meaning that the basis of vector fields along with all of their commutators up to some finite step will span the entire tangent space. This property is essential when considering Carnot groups as sub-Riemannian manifolds because it ensures that any two points in the group can be connected by a path that lies entirely in the span of V^1 . This type of path is referred to as a horizontal path. To be more precise, stated below is the fundamental theorem.

THEOREM 2.5. (*Chow's Theorem*) *If a smooth distribution satisfies Hörmander's condition at some point p , then any point q which is sufficiently close to p can be joined to p by a horizontal curve.*

Because the L^2 energy required to travel only along directions in vertical bundle is infinite, the horizontal vector fields give the so called "admissible" directions. Getting from one point to another requires traveling along a horizontal curve, and Chow's theorem alleviates any concern that we might not be able to find an appropriate path. We will always be able to

get there by moving along horizontal curves so long as the vector fields satisfy Hörmander's finite rank condition.

Carnot groups can also be viewed as sub-Riemannian manifolds, and it is always possible to define g a Riemannian metric with respect to which the V^j are mutually orthogonal. A curve $\gamma : [0, 1] \rightarrow \mathbb{G}$ is horizontal if the tangent vector $\gamma'(t)$ lies in V^1 for all t . The Carnot-Carathéodory distance (CC-distance) can now be defined.

DEFINITION 2.6. *Let $p, q \in \mathbb{G}$.*

$$d_{cc}(p, q) = \inf \int_0^1 \left(\sum_{i=1}^{m_1} \langle \gamma'(t), X_i|_{\gamma(t)} \rangle_g^2 dt \right)^{1/2},$$

where the infimum is taken over all horizontal curves γ such that $\gamma(0) = p$, $\gamma(1) = q$ and $\langle \cdot, \cdot \rangle_g$ denotes the left invariant inner product on V^1 determined by the metric g .

Chow's Theorem gives the existence of the horizontal curve, γ . Another consequence of his work is that the CC-distance is finite for connected groups.

The CC-distance is not a true distance in that it lacks the triangle inequality. However it does satisfy the quasi-triangle inequality meaning there exists a positive constant, A , depending on the group \mathbb{G} such that

$$d_{cc}(x, y) \leq A(d_{cc}(x) + d_{cc}(y)).$$

We will also make use of the distance defined by the gauge norm. Let $x_{i,k}$ be the coordinates for a point $x \in \mathbb{G}$, then

$$(2.3) \quad |x|^{2r!} = \sum_{k=1}^r \sum_{i=1}^{m_1} |x_{i,k}|^{2r!/k}.$$

For $x, y \in \mathbb{G}$, we then let $d(x, y) = |xy^{-1}|$ as defined above.

The gauge distance is equivalent to the CC-distance but has the advantage of being a Lipschitz function. We say they are equivalent due to the fact that there exists a constant, $a(\mathbb{G})$, dependent on the group such that

$$a^{-1}d_{cc}(x, y) \leq d(x, y) \leq ad_{cc}(x, y).$$

For a proof, as well as other properties of these metrics see [35].

2.2 Subelliptic Schauder Estimates

This section presents the proof of Schauder estimates by Chao-Jiang Xu [44] for subelliptic operators of the form

$$L = \sum_{j=1}^m X_j^2.$$

We will keep the same notations from the preceding section on Carnot groups. However, here the real smooth vector fields X_1, \dots, X_m satisfy Hörmander's condition but have no requirement related to the structure of commutators as was the case with Carnot groups.

It is by virtue of Rothschild and Stein's theorems of lifting and approximation that equations involving Hörmander vector fields are able to be studied so effectively. Their result roughly states that the manifold can be lifted to a free group and that the difference between the lifted vector fields and the generators of a free nilpotent Lie algebra is almost negligible [37]. This is such an important result that it is worth stating explicitly.

THEOREM 2.7. [37, Theorem 4]

Let X_1, \dots, X_m be vector fields on a manifold M of dimension m such that the commutators of length $\leq r$ span the tangent space at $\xi \in M$. Then in terms of new variables,

$t_{m+1}, t_{m+2}, \dots, t_{\tilde{m}}$, there exist smooth functions $\lambda_{kl}(\omega, t)$ defined in a neighborhood \tilde{U} of $\tilde{\xi} = (\xi, 0) \in M \times \mathbb{R}^{\tilde{m}-m} = \tilde{M}$ such that the vector fields $\{\tilde{X}_k\}$ given by

$$(2.4) \quad \tilde{X}_k = X_k + \sum_{l=m+1}^{\tilde{m}} \lambda_{kl}(\omega, t) \frac{\partial}{\partial t_l}$$

are free up to step r at every point in \tilde{U} .

THEOREM 2.8. [37, Theorem 5]

Let $\tilde{X}_1, \dots, \tilde{X}_n$ be vector fields on a manifold \tilde{M} , $\tilde{\xi}_o \in \tilde{M}$ such that

(i) commutators of length $\leq r$ span the tangent space, and

(ii) $\{\tilde{X}_k\}$ is free up to step r at $\tilde{\xi}_o$.

Choose $\{\tilde{X}_{jk}\}$, commutators of length $\leq r$, determining a system of canonical coordinates (u_{jk}) around $\tilde{\xi}_o$ by $\exp(\sum u_{jk} \tilde{X}_{jk}) \cdot \tilde{\xi}$. Let N be the free Lie group of step r on n generators and \mathfrak{R} its Lie algebra. Then there is a basis $\{Y_{jk}\}$ of \mathfrak{R} and neighborhoods \tilde{V} of $\tilde{\xi}_o \in \tilde{M}$ and U of $0 \in N$ with the following properties. On $\tilde{V} \times \tilde{V}$ consider the mapping to U

$$(2.5) \quad \theta(\tilde{\xi}, \tilde{\omega}) = \exp\left(\sum u_{jk} Y_{jk}\right) \in U,$$

where $\tilde{\omega} = \exp(\sum u_{jk} \tilde{X}_{jk}) \tilde{\xi}$. Then for each fixed $\tilde{\xi}$ the mapping

$$\omega \rightarrow \theta_{\tilde{\xi}}(\tilde{\omega}) = \theta(\tilde{\xi}, \tilde{\omega}) = (u_{jk})$$

is a coordinate chart for V centered at $\tilde{\xi}$.

In this coordinate system,

$$(2.6) \quad \tilde{X}_k = Y_k + R_k, \quad k = 1, \dots, n,$$

where R_k is a differential operator of local degree ≤ 0 .

In the proof of the Schauder estimates, we will let X_{jk} denote a commutator of length j . Using a canonical system of coordinates, we obtain a C^∞ diffeomorphism from a neighborhood about x , $V_x \subset M$ to a neighborhood of 0 in \mathbb{R}^n in the following way. If $y \in V_x$ and $y = \exp(\sum u_{jk} X_{jk})x$, define the mapping by $\theta_x(y) = u = (u_{jk})$.

The distance function used will be given by the gauge norm.

$$d(x, y) = \left(\sum |u_{jk}|^{2r!/j} \right)^{1/2r!},$$

which is locally equivalent to the CC-distance. The base of the tangent space on V_{x_0} will be denoted $\{X_{jk}\}$ ($1 \leq j \leq r$, $k \leq k_j$), then $n = \sum_{j \leq r} k_j$.

The proof is very similar to the Euclidean case, but we do not have an explicit formulation of the fundamental solution resulting in the need for a few technical lemmas. For the sake of brevity, these are given without proof.

LEMMA 2.9. [44, Lemma 1.3]

(i) For every compact set, $K \subset\subset V_{x_0}$, there exists a constant, C such that if $x \in K$ and $\delta < \frac{1}{2}\delta_0$, we have

$$(2.7) \quad |B(x, 2\delta)| \leq C|B(x, \delta)|$$

(ii) For $x \in K \subset\subset V_{x_o}$, $0 < \delta < \delta_o$, we have

$$(2.8) \quad \int_{B(x,\delta)} \frac{d(x,y)^\alpha}{|B(x,d(x,y))|} dy \leq C\delta^\alpha.$$

LEMMA 2.10. [44, Lemma 1.4]

(i) For $x, y \in V_{x_o}$, we have

$$(2.9) \quad |X^I d(x,y)| \leq C d(x,y)^{1-|I|}.$$

(ii) For all $K \subset\subset V_{x_o}$, and $K_{3\epsilon} = \{x \in \mathbb{R}^n; d(x,y) < 3\epsilon, y \in K\} \subset V_{x_o}$, there exists $\Psi \in C_0^\infty(K_{3\epsilon})$, $0 \leq \Psi \leq 1$, $\Psi(x) = 1$ on K such that for all k ,

$$(2.10) \quad |X^I \Psi| \leq C(k)\epsilon^{-|I|}.$$

LEMMA 2.11. [44, Lemma 3.1]

For $n \geq 3$, there exists a Green's kernel $G(x,y)$ for the operator, L , and

$$(2.11) \quad |X^J G(x,y)| \leq C_J \frac{d(x,y)^{2-|J|}}{|B(x,d(x,y))|},$$

where differentiations are taken in x or y . Also,

$$(2.12) \quad -G(x,y) \geq c \frac{d(x,y)^2}{|B(x,d(x,y))|}$$

near the diagonal of $\Omega \times \Omega$.

The existence of the Green's kernel for this operator is due to Bony [4], and the bounds can be found in [38].

The symbols below will be used to notate Hölder continuity on a set $\Omega = V_{x_0}$ where α is always taken to be in $(0, 1)$. By definition

$$C_X^\alpha(\Omega) = \left\{ u \in C^0(\bar{\Omega}); [u]_{\alpha, \Omega}^X = \sup_{\substack{x, y \in \Omega \\ x \neq y}} \frac{|u(x) - u(y)|}{d(x, y)^\alpha} < \infty \right\},$$

and for $k \in \mathbb{N}$,

$$C_X^{k, \alpha}(\Omega) = \{u \in C_X^\alpha(\Omega); X^J u \in C_X^\alpha(\Omega), \text{ for all } |J| \leq |k|\}.$$

Set

$$[u]_{k, 0, \Omega}^X = \sup_{\substack{x \in \Omega \\ |J|=k}} |X^J u(x)|$$

and

$$[u]_{k, \alpha, \Omega}^X = \sup_{|J|=k} [X^J u(x)]_{\alpha, \Omega}^X.$$

As in the Euclidean case, the norms are given analogously by

$$\|u\|_{k, \alpha, \Omega}^X = \sum_{j=0}^k [u]_{j, 0, \Omega}^X + [u]_{k, \alpha, \Omega}^X.$$

LEMMA 2.12. *Suppose $u = \int_{\Omega} G(x, y)f(y)dy$, where f is bounded and integrable in Ω .*

Then $u \in C_X^1(B_1)$ and for every $x \in B_1$ and $i = 1, \dots, m$,

$$(2.13) \quad X_i u(x) = \int_{B_1} X_i^x G(x - y)f(y)dy$$

where the superscript x means X_i is acting on that variable, and

$$(2.14) \quad |X_i u|_{0, B_1} \leq CR |f|_{0, B_1}.$$

PROOF. Let $v = \int_{B_1} X_i^x G(x-y) f(y) dy$, and show it is well defined.

$$\begin{aligned} \int_{B_1} |X_i^x G(x-y) f(y)| dy &\leq |f|_{0, B_1} \int_{B_1} |X_i^x G(x-y)| dy \\ &\leq |f|_{0, B_1} \int_{B(x, 2R)} \frac{d(x, y)}{|B(x, d(x, y))|} dy \quad \text{by (2.11)} \\ &\leq CR |f|_{0, B_1} \quad \text{by (2.8)}. \end{aligned}$$

This inequality also shows (2.14) so long as $X_i u(x) = \int_{B_1} X_i^x G(x-y) f(y) dy$, which will be shown now.

Take a cutoff function $\eta(t) \in C^1(\mathbb{R})$ with the following properties: $0 \leq \eta \leq 1$, $0 \leq \eta' \leq 2$, $\eta(t) = 0$ for $t \leq 1$, and $\eta(t) = 1$ for $t \geq 2$. For $\epsilon > 0$ let

$$u_\epsilon(x) = \int_{B_1} G(x, y) \eta_\epsilon(x, y) f(y) dy,$$

where $\eta_\epsilon(x, y) = \eta\left(\frac{d(x, y)}{\epsilon}\right)$. Notice that $u_\epsilon = 0$ when $d(x, y) < \epsilon$, $u_\epsilon = u$ when $d(x, y) > \epsilon$, and $u_\epsilon \in C^1(B_1)$. To show $X_i u_\epsilon$ converges to v , look at the difference and observe that

$$\int_{B_1} X_i^x G(x-y) f(y) dy - X_i u_\epsilon(x) = \int_{B(x, 2\epsilon)} X_i^x (G(x-y)(1-\eta_\epsilon)) f(y) dy.$$

Using Lemma 2.10, we have that $|X_i \eta_\epsilon| \leq |\eta'_\epsilon \frac{X_i d(x, y)}{\epsilon}| \leq C/\epsilon$.

$$|v(x) - X_i u_\epsilon(x)| = \left| \int_{B(x, 2\epsilon)} [X_i G(x, y) - G(x, y) X_i \eta_\epsilon] f(y) dy \right|$$

$$\begin{aligned}
&\leq |f|_{0,B_1} \int_{B(x,2\epsilon)} |X_i G(x,y)| + \frac{C}{\epsilon} |G(x,y)| dy \\
&\leq C\epsilon |f|_{0,B_1} \text{ by Lemma 2.11.}
\end{aligned}$$

Concluding the proof, let $\epsilon \rightarrow 0$, then u_ϵ and $X_i u_\epsilon$ converge respectively to u and v in B_1 . \square

LEMMA 2.13. *Let $f \in C_X^\alpha(\Omega)$ with $\text{supp } f \subset B_1$, then $u \in C_X^2(B_1)$ and for $x \in B_1$ we have*

$$(2.15) \quad X_i X_j u(x) = \int_{B_1} X_i^x X_j^x G(x,y) (f(y) - f(x)) dy + f(x) \int_{B_2} G_o^{ij}(x,y) dy$$

for $i, j = 1, \dots, m$, where $G_o^{ij}(x,y)$ satisfies the estimate (2.11).

PROOF. By the uniqueness theorem for the operator, L , we have $\text{supp } u = \text{supp } f$. Take $\phi \in C_o^\infty(B_2)$ with $\phi(x) = 1$ on B_1 and $|X^J \phi| \leq C_J/R^{|J|}$. Then set $\tilde{G}(x,y) = \phi(x)G(x,y)\phi(y)$, and denote $w(x)$ by the right hand side of (2.15).

For $x \in B_1$,

$$w(x) = \int_{B_1} X_i^x X_j^x \tilde{G}(x,y) (f(y) - f(x)) dy + f(x) \int_{B_2} G_o^{ij}(x,y) dy,$$

and from Lemma 2.12,

$$\begin{aligned}
X_j u(x) &= \int_{B_2} X_j^x \tilde{G}(x,y) f(y) dy, \text{ and} \\
X_j u_\epsilon(x) &= \int_{B_2} X_j^x \left(\tilde{G}(x,y) \eta_\epsilon(x,y) \right) f(y) dy.
\end{aligned}$$

Clearly $X_j u_\epsilon \in C^1(B_1)$ and $X_j u_\epsilon \rightarrow X_j u$ in B_1 . Taking another derivative in x and using the lifting and approximation theorems (Theorems 2.7 and 2.8), gives

$$\begin{aligned}
X_i X_j u_\epsilon(x) &= \int_{B_2} X_i^x X_j^x \left(\tilde{G}(x, y) \eta_\epsilon(x, y) \right) f(y) dy \\
&= \int_{B_2} X_i^x X_j^x \left(\tilde{G}(x, y) \eta_\epsilon(x, y) \right) (f(y) - f(x)) dy \\
&\quad + f(x) \int_{B_2} X_i^x X_j^x \left(\tilde{G}(x, y) \eta_\epsilon(x, y) \right) dy \\
&= \int_{B_2} X_i^x X_j^x \left(\tilde{G}(x, y) \eta_\epsilon(x, y) \right) (f(y) - f(x)) dy \\
&\quad + f(x) \int_{B_2} R_0^i R_0^j \left(\tilde{G}(x, y) \eta_\epsilon(x, y) \right) dy.
\end{aligned}$$

Define $G_o^{ij} = R_o^i R_o^j \tilde{G}$, and now convergence of $X_i X_j u_\epsilon$ to $w(x)$ will be shown.

$$\begin{aligned}
|w(x) - X_i X_j u_\epsilon(x)| &\leq \int_{B_2} |X_i^x X_j^x \left(\tilde{G}(x, y) (1 - \eta_\epsilon) \right)| |f(y) - f(x)| dy \\
&\quad + |f(x)|_{0, B_1} \int_{B_2} |G_o^{ij}(x, y) dy - R_0^i R_0^j \left(\tilde{G}(x, y) \eta_\epsilon(x, y) \right)| dy \\
&\leq C \int_{B(x, 2\epsilon)} |X_i^x X_j^x \left(\tilde{G}(x, y) (1 - \eta_\epsilon) \right)| d(x, y)^\alpha [f(x)]_{\alpha, B_1}^X dy \\
&\quad + |f(x)|_{0, B_1} \int_{B(x, 2\epsilon)} |R_0^i R_0^j \left(\tilde{G}(x, y) (1 - \eta_\epsilon(x, y)) \right)| dy \\
&\leq C \int_{B(x, 2\epsilon)} \frac{d(x, y)^\alpha [f(x)]_{\alpha, B_1}^X}{|B(x, d(x, y))|} dy \\
&\quad + |f(x)|_{0, B_1} \int_{B(x, 2\epsilon)} \frac{d(x, y)^2}{|B(x, d(x, y))|} dy. \\
&\leq C \epsilon^\alpha \|f\|_{\alpha, B_1}^X,
\end{aligned}$$

proving convergence and the lemma. □

THEOREM 2.14. Let $f \in C_X^\alpha(\Omega)$, with $\text{supp } f \subset B_1$, $\alpha > 0$, and $u = \int_{B_1} G(x, y)f(y)dy$.

Then $u \in C_X^{2,\alpha}(B_1)$ and

$$(2.16) \quad [u]_{2,\alpha,B_1}^X \leq C[f]_{\alpha,B_1}^X,$$

where C is independent of u and R .

PROOF. Using Lemmas 2.13 and 2.11 and taking $x \in B_1$, we have

$$(2.17) \quad \begin{aligned} |X_i X_j u(x)| &\leq C[f]_{\alpha,B_1}^X \int_{B_1} d(x, y)^\alpha |B(x, d(x, y))|^{-1} dy \\ &\leq C[f]_{\alpha,B_1}^X R^\alpha \end{aligned}$$

Choose another point $\bar{x} \in B_1$, and set $\delta = d(x, \bar{x})$. Then take $\xi \in B_1$ such that

$$d(x, \xi), d(\bar{x}, \xi) \leq \frac{\delta}{2}.$$

$$X_i X_j u(x) - X_i X_j u(\bar{x}) = I_1 + I_2 + I_3 + I_4 + (f(x) - f(\bar{x}))I_5 + f(\bar{x})I_6$$

where the integrals are given by

$$\begin{aligned} I_1 &= \int_{B(\xi, \delta)} X_i X_j \tilde{G}(\bar{x}, y)(f(\bar{x}) - f(y))dy, \\ I_2 &= \int_{B(\xi, \delta)} X_i X_j \tilde{G}(x, y)(f(x) - f(y))dy, \\ I_3 &= \int_{B_1/B(\xi, \delta)} X_i X_j \tilde{G}(x, y)(f(\bar{x}) - f(y))dy, \\ I_4 &= \int_{B_1/B(\xi, \delta)} (X_i X_j \tilde{G}(\bar{x}, y) - X_i X_j \tilde{G}(x, y))(f(y) - f(\bar{x}))dy, \\ I_5 &= \int_{B_2} G_o^{ij}(x, y)dy, \text{ and} \end{aligned}$$

$$I_6 = \int_{B_2} (G_o^{ij}(x, y) - G_o^{ij}(\bar{x}, y)) dy.$$

By the same argument used for (2.17), we have

$$|I_1| + |I_2| \leq C\delta^\alpha [f]_{\alpha, B_1}^X.$$

To estimate I_3 , consider first

$$\begin{aligned} I'_3 &= \int_{B_1/B(\xi, \delta)} X_i^x X_j^x \tilde{G}(x, y) dy. \\ &= \int_{B_1/B(\xi, \delta)} X_i^x R_0^j \tilde{G}(x, y) dy \\ &\quad - \int_{\partial B(\xi, \delta)} X_i^x \left(\sum_{k=1}^m X_k(y, \bar{n}) R_k^j \tilde{G}(x, y) \right) dS_y. \end{aligned}$$

$$\begin{aligned} |I'_3| &\leq C_1 R + C_2 \int_{\partial B(\xi, \delta)} \frac{d(x, y)}{|B(x, d(x, y))|} dS_y \\ &\leq C_1 R + C_2 \int_{\partial B(\xi, \delta)} \frac{2d(\xi, y)}{|B(\xi, \frac{1}{2}d(\xi, y))|} dS_y \\ &\leq C_1 R + C'_2 \delta \frac{|\partial B(\xi, \delta)|}{|B(\xi, \frac{1}{2}d(\xi, y))|} \\ &\leq C_3. \end{aligned}$$

Finally, this gives

$$|I_3| \leq |(f(\bar{x}) - f(x))I'_3| \leq C'_3 \delta^\alpha [f]_{\alpha, B_1}^X.$$

To estimate I_4 , let $\hat{x} \in B(\xi, (3/4)\delta)$, then use

$$|X_i X_j \tilde{G}(\bar{x}, y) - X_i X_j \tilde{G}(x, y)| \leq 2d(x, \bar{x}) \sum_{k=1}^m |X_k X_i X_j \tilde{G}(\hat{x}, y)|$$

to see

$$\begin{aligned} |I_4| &\leq 2\delta \int_{B_2/B(\xi, \delta)} \sum_{k=1}^m |X_k X_i X_j \tilde{G}(\hat{x}, y)| |f(y) - f(\bar{x})| dy \\ &\leq 2\delta \int_{B_2/B(\xi, \delta)} \frac{|f(y) - f(\bar{x})|}{d(\hat{x}, y) |B(\hat{x}, d(\hat{x}, y))|} dy \\ &\leq 2\delta [f]_{\alpha, B_1}^X \int_{B_2/B(\xi, \delta)} \frac{d(\hat{x}, y)^\alpha}{d(\hat{x}, y) |B(\hat{x}, d(\hat{x}, y))|} dy. \end{aligned}$$

Now $y \notin B(\xi, \delta)$, hence

$$\begin{aligned} d(\bar{x}, y) &\leq C(d(\bar{x}, \hat{x}) + d(\hat{x}, y)) \\ &\leq C(d(\hat{x}, y) + \delta) \\ &\leq 5Cd(\hat{x}, y). \end{aligned}$$

Using this same type of triangle inequality, one can see that

$$B(\hat{x}, \frac{1}{4}\delta) \subset B(\xi, \delta) \quad \text{and} \quad B(x_o, 2R) \subset B(\hat{x}, 3R).$$

Integrating over this larger set gives

$$\begin{aligned} |I_4| &\leq 2\delta [f]_{\alpha, B_1}^X \int_{B(\hat{x}, 3R)/B(\hat{x}, (1/4)\delta)} \frac{d(\hat{x}, y)^{\alpha-1}}{|B(\hat{x}, d(\hat{x}, y))|} dy \\ &\leq C\delta [f]_{\alpha, B_1}^X \left(\left(\frac{1}{4}\delta \right)^{\alpha-1} - (3R)^{\alpha-1} \right) \end{aligned}$$

$$\leq C\delta^\alpha [f]_{\alpha, B_1}^X.$$

For the estimates of I_5 and I_6 , recall that G_o^{ij} satisfies the same bound (2.11) as the Green's kernel in Lemma 2.11.

$$|f(x) - f(\bar{x})||I_5| \leq C\delta^\alpha [f]_{\alpha, B_1}^X \int_{B_2} |B(x, d(x, y))| dy \leq C\delta^\alpha [f]_{\alpha, B_1}^X$$

and in the same way for I_6 we have

$$|f(\bar{x})||I_6| \leq |f|_{0, B_1} C.'$$

Summing the integrals, gives the conclusion. □

The next theorem is given without proof because it follows in exactly the same way as the proof of the Euclidean case (Theorem 1.4).

THEOREM 2.15. *Let $u(x) \in C^o(\Omega)$ be a solution to $Lu = f$ in Ω where $f \in C_X^\alpha(\Omega)$ and $\text{supp } f \subset B_1$. Then*

$$(2.18) \quad \|u\|'_{2, \alpha, B_1} \leq C(|u|_{0, B_2} + R^2 \|f\|'_{0, \alpha, B_2})$$

where C is independent of f and R .

Note that the version of the theorem stated above is slightly different than in [44, Theorem 3.7]. Both proofs still use the decomposition of solutions into $u = u_1 + u_2$ where $Lu_1 = 0$ and $u_2 = G * f$. The difference is that Xu instead uses the hypoellipticity of the operator (See [31]) to get bounds on u_1 and all its derivatives. Specifically, since $0 \in C^\infty$, $u_1 \in C_X^\infty$,

and

$$\|u_2\|_{k,0,K}^X \leq C(k, X, K) \|u_1\|_{L^\infty(\Omega)} =: D_k$$

for any compact set, $K \in \Omega$. This gives

$$(2.19) \quad \|u\|_{2,\alpha,B_1}^X \leq D_k + C \|f\|_{0,\alpha,B_1}$$

where D_k, C are constants independent of f .

Xu's version has the disadvantage of not making specific the dependence on u and R in the constant, but has the advantage that the right hand side does not need to be on a larger set.

In either case, we wish to now get rid of the compact support condition on f . To that end, stated here without proof is a technical lemma, which is used in the construction of an appropriate cut-off function to give the final result.

LEMMA 2.16. [44, Lemma 3.8]

Let $\phi(t)$ be a non-negative bounded function on $[T_o, T_1]$ with $0 \leq T_o < T_1$. Assume that for any $T_o \leq t < s < T_1$ we have

$$(2.20) \quad \phi(t) \leq \theta \phi(s) + \frac{A}{(s-t)^\beta} + B$$

with $0 < \theta < 1$, and $A, B, \beta \geq 0$. Then we have

$$(2.21) \quad \phi(t) \leq C \left[\frac{A}{(s-t)^\beta} + B \right]$$

for all $T_o \leq t < s \leq T_1$, where $C(\beta, \theta)$.

THEOREM 2.17. Let $B_t = B(x_o, tR)$ and $B_s = B(x_o, sR)$. Let $f \in C_X^\alpha(\Omega)$ and $u \in C^0(\Omega)$ be a solution to $Lu = f$. Then for all $x_o \in \Omega$ there exists $R > 0$ such that

$$(2.22) \quad \|u\|_{2,\alpha,B_t}^X \leq D + C\|f\|_{0,\alpha,B_s}^X + \tilde{C}(\|f\|_{0,B_1} + |u|_{0,B_1})((s-t)R)^{-r\alpha}$$

for all $0 < t < s \leq 1$, where D , C and \tilde{C} are independent of f .

PROOF. Taking for granted, the property of the quasi-distance, $d(x, y)$, which says for any small compact subset $K \subset M$, there exists a constant $c > 0$ such that for any $x, y \in K$,

$$c^{-1}|x - y| \leq d(x, y) \leq c|x - y|^{1/r}$$

where r is the smallest length of the commutators needed to satisfy Hörmander's condition.

This property allows us to see that

$$d_E(\partial B_s, B_t) \geq |Rs - Rt| \geq c^{-1}d(Rs, Rt)^r \geq c^{-2}((s-t)R)^r.$$

By use of Lemma 2.16, there exists a function $\zeta \in C_o^\infty(B_s)$ such that $\zeta(x) = 1$ on B_t and

$$(2.23) \quad \sum_{|J|=k} |X^J \zeta|_{0,B_s} + ((s-t)R)^{r\alpha} [X^k \zeta]_{\alpha,B_s}^X \leq C_k ((s-t)R)^{-rk}.$$

Applying Theorem 2.15 to ζu on B_s , where

$$L(\zeta u) = \zeta(Lu) - \sum_{j=1}^m 2(X_j \zeta)(X_j u) - (L\zeta)u,$$

gives the final conclusion. □

CHAPTER 3

The Parabolic Setting

3.1 Parabolic Distance, Balls, and Cylinders

Throughout this paper, the relevant space is $\mathbb{G} \times \mathbb{R}$, where x is reserved as a space variable in \mathbb{G} and t is thought of as a time variable in \mathbb{R} . This is also a Carnot group where time derivatives appear in the first layer of the stratification. However, homogeneity considerations of the operator would dictate the time derivative should have weight 2, and a different dilation mapping would be needed rather the natural one given previously. An alternative viewpoint is the one given by Rothschild and Stein. In [37], they referred to this situation (where the algebra is generated by a vector field in the second layer, X_o , in addition to the vector fields X_1, \dots, X_{m_1} in the first layer) as a type II stratified group.

This document mostly keeps to the viewpoint of separately dealing with \mathbb{G} and \mathbb{R} to get results on the product space. Therefore we define a new dilation mapping $\delta'_s : \mathbb{G} \times \mathbb{R} \rightarrow \mathbb{G} \times \mathbb{R}$ given by

$$\delta'_s(x, t) = (\delta_s(x), s^2t).$$

With that being said, the parabolic distance is defined.

DEFINITION 3.1. *Let $(x, t), (y, s) \in \mathbb{G} \times \mathbb{R}$. The parabolic distance is*

$$d_p((x, t), (y, s)) = (d(x, y)^2 + |t - s|)^{1/2}.$$

Because \mathbb{G} is stratified, one can always find such a homogeneous norm $d(x, y)$ and a dilation mapping $\delta_s(x)$ such that $d(\delta_s(x), \delta_s(y)) = sd(x, y)$. Both the gauge distance and CC-distance fulfill this requirement.

This is the appropriate distance for the dilation chosen since

$$d_p(\delta'_s(x, t)) = (d(\delta_s x)^2 + |s^2 t|)^{1/2} = sd_p(x, t)$$

as desired. For sake of simplicity, we will use $|(x, t)(y, s)^{-1}|$ to denote the parabolic distance between the points (x, t) and (y, s) , and $|(x, t)|$ to be the parabolic distance between (x, t) and the origin.

Using the quasi-triangle inequality for $d(x, y)$ on the group (with constant A), the analogue can be shown for d_p with the same constant.

PROPOSITION 3.2. *There exists a constant, A depending on the group, \mathbb{G} , such that for all points $(x, t), (y, s), (z, \tau) \in \mathbb{G} \times \mathbb{R}$ the inequality holds.*

$$(3.1) \quad |(x, t)(y, s)^{-1}| \leq A (|(x, t)(z, \tau)^{-1}| + |(z, \tau)(y, s)^{-1}|).$$

PROOF. If we can show that

$$d(x, y)^2 + |t - s| \leq C (d(x, z)^2 + |t - \tau| + d(z, y)^2 + |\tau - s|),$$

then we are done since

$$\begin{aligned} d(x, y)^2 + |t - s| &\leq C (d(x, z)^2 + |t - \tau| + d(z, y)^2 + |\tau - s|) \\ &\leq C(d(x, z)^2 + |t - \tau| + 2\sqrt{d(x, z)^2 + |t - \tau|}\sqrt{d(z, y)^2 + |\tau - s|}) \end{aligned}$$

$$\begin{aligned}
& +d(z, y)^2 + |\tau - s|) \\
= & C \left(\sqrt{d(x, z)^2 + |t - \tau|} + \sqrt{d(z, y)^2 + |\tau - s|} \right)^2.
\end{aligned}$$

Taking the square root of both sides, would give the desired inequality

$$\sqrt{d(x, y)^2 + |t - s|} \leq \sqrt{C} \left(\sqrt{d(x, z)^2 + |t - \tau|} + \sqrt{d(z, y)^2 + |\tau - s|} \right).$$

If $A^2 > 1$ in the quasi-triangle inequality for $d(x, y)$, we get

$$\begin{aligned}
d(x, y)^2 + |t - s| & \leq A^2 d(x, z)^2 + |t - \tau| + A^2 d(z, y)^2 + |\tau - s| \\
& = A^2 (d(x, z)^2 + |t - \tau| + d(z, y)^2 + |\tau - s|) \\
& \quad + (1 - A^2)|t - \tau| + (1 - A^2)|\tau - s| \\
& \leq A^2 (d(x, z)^2 + |t - \tau| + d(z, y)^2 + |\tau - s|).
\end{aligned}$$

If $A^2 < 1$, we actually have a true triangle inequality by adding positive additional terms $(1 - A^2)d(x, z)^2$ and $(1 - A^2)d(z, y)$ to the right hand side. \square

We also use the following form of reverse triangle inequality,

$$(3.2) \quad |(x, t) - A|(y, s)| \leq A|(x, t)(y, s)^{-1}|.$$

DEFINITION 3.3. *Choosing $d(x, z)$ to be the gauge distance defined earlier, the set*

$$\mathcal{Q}_r(x, t) = \{(z, \tau) : |t - \tau| < r^2 \text{ and } d(x, z) < r\}$$

is known as the parabolic cylinder.

Let $B_r(x)$ denote the CC-ball on \mathbb{G} , then it is easy to see that $|\mathcal{Q}_r(x, t)| = r^{Q+2} |B_1(0)|$ where the measures indicated are Lebesgue measures. A simple computation gives $|B_r(x)| = |B_1(0)|r^Q$, and consequently $|\mathcal{Q}_r(x, t)| = r^{Q+2} |B_1(0)|$. The Jacobian determinant of $\delta_r : \mathbb{G} \rightarrow \mathbb{G}$ is simply r^Q , so the calculation follows by a change of variable. See [2] for this calculation and other properties of the CC-balls. Properties of the parabolic balls and parabolic cylinders are nicely explained in [7].

Sometimes it is convenient to use the notation $\mathcal{Q}_r(x, t) = B_r(x) \times \Lambda_r(t)$ where $\Lambda_r(t) = \{\tau \in \mathbb{R} : |t - \tau| < r^2\}$.

We can also define a parabolic ball to be the set

$$B_p((x_o, t_o), r) := \{(y, s) : |(x_o, t_o)(y, s)^{-1}| < r\}.$$

Its size is comparable to the parabolic cylinder, but they are not the same set.

3.2 Group Polynomials

In this section, definitions and terminology regarding group polynomials are given followed by several results regarding Taylor polynomials. For more details see [21].

Let $l \in \mathbb{N}$ and consider a multi-index, $I = [(i_1, k_1), (i_2, k_2), \dots, (i_l, k_l)]$, where $1 \leq k_j \leq r$ and $1 \leq i_j \leq k_{m_j}$. Derivatives of a smooth function, f , defined in \mathbb{G} will be denoted as

$$X^I f = X_{i_1, k_1} X_{i_2, k_2} \dots X_{i_l, k_l} f$$

where the order of the derivative is $|I| = \sum_{j=1}^l k_j$. Throughout this paper, we are only concerned with derivatives appearing in the first layer of the stratification meaning the order will simply be the number of vector fields applied to the function.

DEFINITION 3.4. *A group polynomial on $\mathbb{G} \times \mathbb{R}$ is a function that can be expressed in exponential coordinates as*

$$P(x, t) = \sum_{I, \beta} a_{I, \beta} x^I t^\beta$$

where $I = (i_{j,k})_{j=1 \dots m_k}^{k=1 \dots r}$ and β and $a_{I, \beta}$ are real numbers, and

$$x^I = \prod_{j=1 \dots m_k; k=1 \dots r} x_{j,k}^{i_{j,k}},$$

or equivalently,

$$P(x, t) = \sum_d a_{I, \beta}(x, t)^d$$

where $(x, t)^d = x^I t^\beta$ and $|I| + 2\beta = d$.

The homogeneous degree of the monomial x^I is given by

$$|I| = \sum_{k=1}^r \sum_{j=1}^{m_k} k i_{j,k},$$

and the homogeneous degree of $(x, t)^d$ is (as expected) $d = |I| + 2\beta$. We will notate the set of polynomials of homogeneous degree not exceeding d as \mathcal{P}_d . To avoid tedious language, the homogeneous degree will simply be called the degree of the polynomial.

DEFINITION 3.5. *If $h \in C_0^\infty(\mathbb{G} \times \mathbb{R})$ and k is a positive integer, then the k th order Taylor polynomial P_k of h at the origin is the unique polynomial of homogeneous order at most k*

such that

$$X^I D_t^l P_k(0,0) = X^I D_t^l h(0,0)$$

for all $|I| + 2l \leq k$.

We will need several results regarding Taylor polynomials and their remainders. The upcoming three of which appear in [21, pp.33-35].

THEOREM 3.6. (Stratified Mean Value Theorem) *Let \mathbb{G} be stratified. There exists constants $c > 0$ and $b > 0$ such that for every $f \in C^1$ and for all $x, y \in \mathbb{G}$,*

$$|f(xy) - f(x)| \leq c|y| \sup_{\substack{|z| \leq b|y| \\ 1 \leq j \leq m_1}} |X_j f(xz)|$$

where X_j is in the first layer of the stratification, and $|\cdot|$ is a homogeneous norm on \mathbb{G} .

THEOREM 3.7. (Stratified Taylor Inequality) *Let \mathbb{G} be stratified. For each positive integer k , there exists a constant $c_k > 0$ such that for every $f \in C^k$ and for all $x, y \in \mathbb{G}$,*

$$|f(xy) - P_x(y)| \leq c_k |y|^k \sup_{\substack{|z| \leq b^k |y| \\ |I|=k}} |X^I f(xz) - X^I f(x)|$$

where $P_x(y)$ is the left Taylor Polynomial of f at x of homogeneous degree k and b is as in the Stratified Mean Value Theorem.

COROLLARY 3.8. *If $k \geq 1$, then there exists positive constants C_k and b (independent of k) such that for every $f \in C^{k+1}(\mathbb{G})$ and all $x, y \in \mathbb{G}$ there holds*

$$|f(xy) - P_x(y)| \leq C_k |y|^{k+1} \sup_{\substack{|z| \leq b^k |y| \\ |I|=k+1}} |X^I f(xz)|$$

where $P_x(y)$ is the k th order left Taylor polynomial of f at the point x .

Now results analogous to those above will be provided, incorporating the time derivatives and the parabolic distance. To this end, we will first define some special classes of functions. We will say that $f \in C_*^0(\Omega)$ if f is continuous on the open set $\Omega \in \mathbb{G} \times \mathbb{R}$ with respect to the parabolic distance, and we define

$$C_*^1(\Omega) = \left\{ f \in C_*^0(\Omega) : X_i f \in C_*^0(\Omega) \text{ for } i = 1, \dots, m_1 \text{ and } \frac{|f(x, t) - f(x, \tau)|}{|t - \tau|^{1/2}} < \infty, t \neq \tau \right\}.$$

For any positive integer $k \geq 2$, we define

$$C_*^k(\Omega) = \{ f \in C_*^{k-1}(\Omega) : X_i f \in C_*^{k-1}(\Omega) \text{ for } i = 1, \dots, m_1 \text{ and } D_t f \in C_*^{k-2}(\Omega) \}.$$

Roughly speaking, a function in the set $C_*^k(\Omega)$ will have continuous derivatives up to order k (with respect to the parabolic distance) as well as “half” derivatives in the t variable up to order $k-1$ in keeping with the idea that one time derivative is equivalent to two spatial derivatives.

LEMMA 3.9. *Suppose $g \in C_*^1(\mathbb{G} \times \mathbb{R})$, then for all $(y, s) \in \mathbb{G} \times \mathbb{R}/(0, 0)$ there exists a positive constant C such that*

$$|g(y, s) - g(0, 0)| \leq C|(y, s)| \sup_{\substack{|(z, \tau)| \leq b|(y, s)| \\ i=1, \dots, m_1}} |X_i g(z, \tau)|.$$

PROOF. Notice first that $|g(y, s) - g(0, 0)| \leq |g(y, s) - g(y, 0)| + |g(y, 0) - g(0, 0)|$.

The first term can be estimated using the “half” derivative while the second term requires the Stratified Mean Value Theorem. Together we get the following:

$$|g(y, s) - g(0, 0)| \leq C_1|s|^{1/2} + C|y| \sup_{\substack{|z| \leq b|y| \\ i=1, \dots, m_1}} |X_i g(z, 0)|$$

where $0 < \tau < s$.

Here $|s|$ is referring to the Euclidean distance and $|y|$ is any homogeneous norm on \mathbb{G} .

Clearly, $|s|^{1/2} \leq |(y, s)|$ and $|y| \leq |(y, s)|$ giving

$$|g(y, s) - g(0, 0)| \leq C|(y, s)| \sup_{\substack{|z| \leq b|y| \\ i=1, \dots, m_1}} |X_i g(z, 0)|$$

Taking the appropriate supremum gives the conclusion. \square

Now we give a parabolic version of the Stratified Taylor Inequality.

THEOREM 3.10. *Suppose \mathbb{G} is stratified. For every positive integer k , there exists positive constants C and b depending on k such that for all $f \in C_*^k(\mathbb{G} \times \mathbb{R})$ and all $(x, t), (y, s) \in \mathbb{G} \times \mathbb{R}$,*

$$|f(y, s) - P_k(y, s)| \leq C_k |(y, s)|^k \sup_{\substack{|(z, \tau)| \leq b^k |(y, s)| \\ |I| + 2l = k}} |X^I D_t^l f(z, \tau) - X^I D_t^l f(0, 0)|$$

where $P_k(y, s)$ is the k th order Taylor polynomial about the origin.

PROOF. The method of proof is similar to the proof of the Stratified Taylor Inequality in [21].

Fix a $(y, s) \in \mathbb{G} \times \mathbb{R}$ and let $g(x, t) = f(x, t) - P_k(y, s)$. By definition of the Taylor Polynomial for all $|I| + 2l \leq k$,

$$X^I D_t^l g(0, 0) = X^I D_t^l f(0, 0) - X^I D_t^l P_k(y, s) = 0.$$

By induction on n , we will show for all $0 < n \leq k$

$$(3.3) \quad |X^J D_t^p g(y, s)| \leq C_n |(y, s)|^n \sup_{\substack{|(z, \tau)| \leq b^n |(y, s)| \\ |I| + 2l = k}} |X^I D_t^l f(z, \tau) - X^I D_t^l f(0, 0)|$$

where $|J| + 2p = k - n$. The case $n = k$ will give the conclusion.

To begin, we will see the case $n = 0$ is trivial since $|J| + 2p = k$ and

$$\begin{aligned}
|X^J D_t^p g(y, s)| &= |X^J D_t^p f(y, s) - X^J D_t^p P_k(y, s)| \\
&= |X^J D_t^p f(y, s) - X^J D_t^p f(0, 0)| \\
&\leq \sup_{\substack{|(z, \tau)| \leq |(y, s)| \\ |I| + 2l = k}} |X^I D_t^l f(z, \tau) - X^I D_t^l f(0, 0)|.
\end{aligned}$$

Suppose (3.3) is true for $n = k - 1$, and consider the case $n = k$. Using Lemma 3.9, we have

$$\begin{aligned}
|g(y, s) - g(0, 0)| &= |g(y, s)| \\
&\leq C|(y, s)| \sup_{\substack{|z| \leq b|y| \\ i=1, \dots, m_1}} |X_i g(z, \tau)|.
\end{aligned}$$

Using the $n = k - 1$ case,

$$\begin{aligned}
|g(y, s)| &\leq C|(y, s)|^k \sup_{\substack{|(z, \tau)| \leq b|(y, s)| \\ |I| + 2l = k}} |X^I D_t^l g(z, \tau)| \\
&= C|(y, s)|^k \sup_{\substack{|(z, \tau)| \leq b|(y, s)| \\ |I| + 2l = k}} |X^I D_t^l f(z, \tau) - X^I D_t^l f(0, 0)|.
\end{aligned}$$

□

COROLLARY 3.11. *Suppose \mathbb{G} is stratified. For every positive integer k , there exists positive constants C and b depending on k such that for all $f \in C_*^{k+2}(\mathbb{G} \times \mathbb{R})$ and all $(x, t), (y, s) \in \mathbb{G} \times \mathbb{R}$,*

$$|f(y, s) - P_k(y, s)| \leq C|y, s|^{k+1} \sup_{\substack{|(z, \tau)| \leq b|(y, s)| \\ |I| + 2l = k+1}} |X^I D_t^l f(z, \tau)|$$

where $P_k(y, s)$ is the k th order Taylor Polynomial about the origin.

PROOF. Simply apply Lemma 3.9 to Theorem 3.10. □

3.3 Campanato Spaces and Embeddings

The Pointwise Schauder estimates are proved by means of the Morrey-Campanato norms. In this section we will establish the relationship between the Campanato classes and the Folland-Stein Hölder spaces.

First we will adapt the Folland-Stein Hölder norm to include the parabolic distance as

$$\|f\|_{\Gamma^\alpha(x_o, t_o)} = \sup_{\substack{(x, t) \neq (x_o, t_o) \\ (x, t) \in \Omega}} \frac{|f(x, t) - f(x_o, t_o)|}{|(x, t)(x_o, t_o)^{-1}|^\alpha}$$

where Ω is an open set in $\mathbb{G} \times \mathbb{R}$ and $0 < \alpha < 1$.

$f : \Omega \rightarrow \mathbb{R}$ is in the Hölder Space $\Gamma^\alpha(\Omega)$ if and only if for all $(x, t) \in \Omega$ there exists a constant C such that $\|f\|_{\Gamma^\alpha(x, t)} \leq C(f, \Omega, \alpha) < \infty$, and define

$$\|f\|_{\Gamma^\alpha(\Omega)} = \sup_{\Omega} |f| + \sup_{\substack{(x, t) \neq (y, s) \\ (x, t), (y, s) \in \Omega}} \frac{|f(x, t) - f(y, s)|}{|(x, t)(y, s)^{-1}|^\alpha}$$

where Ω is an open set in $\mathbb{G} \times \mathbb{R}$ and $0 < \alpha < 1$.

$$\|f\|_{\Gamma^{k+\alpha}(\Omega)} = \sum_{j=0}^k \sup_{\substack{|I|+2l=j \\ \Omega}} |X^I D_t^l f| + \sup_{\substack{(x,t) \neq (y,s) \in \Omega \\ |I|+2l=k}} \frac{|X^I D_t^l f(x,t) - X^I D_t^l f(y,s)|}{|(x,t)(y,s)^{-1}|^\alpha}$$

We can also define the local Hölder spaces.

$$\Gamma_{loc}^\alpha(\Omega) = \{f : \Omega \rightarrow \mathbb{R} \mid gf \in \Gamma^\alpha(\Omega) \text{ for some } g \in C_o^\infty(\Omega)\}.$$

We now give the definition of the Campanato Spaces and Morrey-Campanato norm as in [21], and [15]. These classes are equivalent to the Hölder classes. Recall that \mathcal{P}_d refers to the set of group polynomials of homogeneous degree less than or equal to d .

DEFINITION 3.12. *Suppose Ω is open in \mathbb{R}^{n+1} , $\alpha \geq 0$, $d \in \mathbb{N}$, and $1 \leq p \leq \infty$. Then $C_{p,d}^\alpha(x_o, t_o)$ is the set of all functions $u \in L_{loc}^p(\mathcal{Q}_1(x_o, t_o))$ such that*

$$[u]_{p,\alpha,d}(x_o, t_o) = \sup_{0 < r < 1} \inf_{P \in \mathcal{P}_d} r^{-\alpha} \left(\frac{1}{|\mathcal{Q}_r(x_o, t_o) \cap \Omega|} \int_{\mathcal{Q}_r(x_o, t_o) \cap \Omega} |u - P|^p(x,t) dx dt \right)^{1/p} < \infty.$$

If $p = \infty$, the L^∞ norm should be used in place of the L^p norm.

It is worth noting that if the polynomial P exists, then it is unique, and consequently, when $d = 0$ the classical definition of the space of bounded mean oscillation is recovered in that the constant, P , would be the average of u over $\mathcal{Q}_r(x_o, t_o) \cap \Omega$.

While the above is only a semi-norm, we will define and make use of the following true norm.

$$(3.4) \quad \|u\|_{p,\alpha,d}(x_o, t_o) = \sum_{|I|+2l=0}^d |X^I D_t^l u(x_o, t_o)| + [u]_{p,\alpha,d}(x_o, t_o).$$

For the purposes of this paper, we will select $(x_o, t_o) = (0, 0)$, and all results will hold for a general point by left invariance.

THEOREM 3.13. *Suppose $\alpha > 0$, $1 \leq p \leq \infty$, and $d \in \mathbb{N}$. If $f \in C_{p,d}^\alpha(x_o, t_o)$, then for all $k < \alpha$ ($|I| + 2l = k$), $X^I D_t^l f$ is continuous in $\mathcal{Q}_r(x_o, t_o)$ and $X^I D_t^l f \in \Gamma^{\alpha-k}(\mathcal{Q}_r(x_o, t_o))$.*

The proof given in [21, Proposition 5.17] is only for a stratified group, but it works just the same for the parabolic setting because it relies only on the Mean Value Theorem and Taylor inequality, which we have shown in the previous section. The original proof is actually due to Krantz [32] and [33]. The case $d = 0$ will be shown here in a slightly different manner below and depends on a geometric property of the cylinders.

DEFINITION 3.14. *An open set $\Omega \in \mathbb{R}^{n+1}$ is said to have the A -property if there exists a constant $A > 0$ such that $|\mathcal{Q}_r(x, t) \cap \Omega| \geq A|\mathcal{Q}_r(x, t)|$.*

REMARK 3.15. *Parabolic cylinders satisfy the A -property. This is easy to see using the fact that Carnot-Carathéodory balls have the analogous A -property [13], meaning that there exists a positive constant A' such that $|B_r(x) \cap B_R(x_o)| \geq A'|B_r(x_o)|$. This geometric property ensures there are no infinitely sharp cusps on the boundary. We see that*

$$\begin{aligned}
|\mathcal{Q}_r(x, t) \cap \mathcal{Q}_R(x_o, t_o)| &= |(B_r(x) \times \Lambda_r(t)) \cap (B_R(x_o) \times \Lambda_R(t_o))| \\
&= |(B_r(x) \cap B_R(x_o)) \times (\Lambda_r(t) \cap \Lambda_R(t_o))| \\
&= |B_r(x) \cap B_R(x_o)| |\Lambda_r(t) \cap \Lambda_R(t_o)| \\
&\geq A' C |B_r(x)| |\Lambda_r(t)| \\
&= A |B_r(x) \times \Lambda_r(t)| \\
&= A |\mathcal{Q}_r(x, t)|.
\end{aligned}$$

PROPOSITION 3.16. *If an open set $\Omega \in \mathbb{R}^{n+1}$ has the A-property, then $C_{p,0}^\alpha(\Omega) \subset \Gamma^\alpha(\Omega)$.*

PROOF. The proof is similar to the Euclidean case in [25] given the appropriate definition of the A-property as above. Throughout this manuscript, $diam(\Omega)$ will be the diameter of Ω with respect to the parabolic distance, and note that on compact sets, for every α , there is a positive constant R_o such that $0 < \alpha r < R_o$. The average of u over a parabolic cylinder will be

$$u_{(x,t),r} = \mathop{\int}\limits_{\mathcal{Q}_r(x,t)} u(z, \tau) dz d\tau = \frac{1}{|\mathcal{Q}_r(x,t)|} \int_{\mathcal{Q}_r(x,t)} u(z, \tau) dz d\tau.$$

Given this notation, we have $u \in C_{p,0}^\alpha(\Omega)$ if and only if

$$\mathop{\int}\limits_{\mathcal{Q}_r(x,t) \cap \Omega} |u(z, \tau) - u_{(x,t),r}|^p dz d\tau \leq Cr^{\alpha p}$$

for all $(x, t) \in \Omega$ and all $0 < r < \min\{R_o, diam(\Omega)\}$. Now, we will fix r and R so that $0 < r < R < \min\{R_o, diam(\Omega)\}$, and see that

$$\begin{aligned} |u_{(x,t),r} - u_{(x,t),R}|^p &\leq C \left[\mathop{\int}\limits_{\mathcal{Q}_r(x,t) \cap \Omega} |u(z, \tau) - u_{(x,t),r}|^p dz d\tau + \mathop{\int}\limits_{\mathcal{Q}_r(x,t) \cap \Omega} |u(z, \tau) - u_{(x,t),R}|^p dz d\tau \right] \\ &\leq C \left[r^{\alpha p} + \frac{|\mathcal{Q}_R(x,t) \cap \Omega|}{|\mathcal{Q}_r(x,t) \cap \Omega|} \frac{1}{|\mathcal{Q}_R(x,t) \cap \Omega|} \int_{\mathcal{Q}_R(x,t) \cap \Omega} |u(z, \tau) - u_{(x,t),R}|^p dz d\tau \right] \\ &\leq C \left[r^{\alpha p} + \frac{|\mathcal{Q}_R(x,t) \cap \Omega|}{|\mathcal{Q}_r(x,t) \cap \Omega|} R^{\alpha p} \right]. \end{aligned}$$

Using the A-property and $|\mathcal{Q}_R(x,t) \cap \Omega| \leq |\mathcal{Q}_R(x,t)|$, we have

$$\frac{|\mathcal{Q}_R(x,t) \cap \Omega|}{|\mathcal{Q}_r(x,t) \cap \Omega|} \leq \frac{R^{Q+2}}{Ar^{Q+2}},$$

and then

$$|u_{(x,t),r} - u_{(x,t),R}| \leq C \left(\frac{R}{r}\right)^{\frac{Q+2}{p}} R^\alpha.$$

Let $R_i = 2^{-i}R$ and $0 < k < h$. It follows that

$$(3.5) \quad |u_{(x,t),R_h} - u_{(x,t),R_k}| \leq \sum_{l=k}^{h-1} |u_{(x,t),R_{l+1}} - u_{(x,t),R_l}| \leq CR_k^\alpha,$$

and hence, $\{u_{(x,t),R_k}\}_{k \in \mathbb{N}}$ is a Cauchy sequence. As $k \rightarrow \infty$, $u_{(x,t),R_k} \rightarrow u(x,t)$ a.e. in Ω , and

(3.5) gives

$$(3.6) \quad |u(x,t) - u_{(x,t),R_k}| \leq CR_k^\alpha$$

implying that u is continuous.

In order to show that $u \in \Gamma_{loc}^\alpha(\Omega)$, we will now show that $|u(x,t) - u(x_o,t_o)| < CR^\alpha$.

Begin by choosing $(x_o, t_o) \in \Omega$ such that $0 < R = d_p((x,t), (x_o, t_o)) < \frac{1}{2} \min\{R_o, \text{diam}(\Omega)\}$.

We need only use (3.6) and estimate $|u_{(x,t),2R} - u_{(x_o,t_o),2R}|$ to obtain the result since

$$|u(x,t) - u(x_o,t_o)| \leq |u(x,t) - u_{(x,t),2R}| + |u_{(x,t),2R} - u_{(x_o,t_o),2R}| + |u_{(x_o,t_o),2R} - u(x_o,t_o)|.$$

Notice that $|u_{(x,t),2R} - u_{(x_o,t_o),2R}|$

$$\leq C \left[\left(\int_{Q_{2R}(x,t) \cap \Omega} |u(z,\tau) - u_{(x,t),2R}|^p dz d\tau \right)^{1/p} + \left(\int_{Q_{2R}(x_o,t_o) \cap \Omega} |u(z,\tau) - u_{(x_o,t_o),2R}|^p dz d\tau \right)^{1/p} \right].$$

As before, we use the fact that $u \in C_{p,0}^\alpha(\Omega)$ to get that

$$|u_{(x,t),2R} - u_{(x_o,t_o),2R}| \leq CR^\alpha.$$

REMARK 3.17. *There is an important consequence of Theorem 3.13 as it relates to Taylor polynomials. Suppose $f \in C_{p,d}^\alpha(0,0)$ for $\alpha > d$, then f is d times differentiable with Hölder continuous derivatives. (The reverse also holds.) Let the Hölder exponent for the highest order derivative be $\alpha_o = \alpha - d$. This implies that we can take the d th order Taylor expansion of f , and by Theorem 3.10, $|f - P_d| \leq Cr^{d+\alpha_o}$. In other words, if α is large enough (or if we know f is differentiable to some order $d \leq \alpha$), we get that the Taylor expansion satisfies the decay requirements of the Campanato space definition with α replaced with $\alpha_o + d$. This point will be exploited later to give bounds on the derivatives of solutions and inhomogenous terms.*

3.4 Sobolev Spaces and Embeddings

The following notations and estimates will be used extensively throughout this paper. In particular, the L^p estimates are essential for the pointwise result. Whereas in the classical proof as well as the group case proof of the Schauder estimates, the L^p estimates are not necessary. We start by giving the well known results for the constant coefficient case, then prove a version for the non-constant coefficient equations with only pointwise Hölder continuity assumed. Let us first define the relevant operators.

$$(3.7) \quad H_A = \partial_t - \sum_{i,j=1}^{m_1} a_{ij}(x,t) X_i X_j$$

Letting $A = (a_{ij})_{i,j=1\dots m_1}$ denote the positive definite, symmetric $m_1 \times m_1$ real-valued matrix.

Explicitly, there exists a constant, Λ , such that

$$(3.8) \quad \Lambda^{-1}|\xi|^2 \leq \sum_{i=1}^{m_1} a_{ij}(x, t)\xi_i\xi_j \leq \Lambda|\xi|^2 \quad \text{for any } \xi \in \mathbb{S}^{m_1-1} \subset \mathbb{R}^{m_1}.$$

Also assume that $a_{ij} \in \Gamma^\alpha(0, 0)$. The frozen operator is given by

$$(3.9) \quad H_A(0) = \partial_t - \sum_{i,j=1}^{m_1} a_{ij}(0, 0)X_iX_j.$$

Now the appropriate Sobolev spaces are defined.

DEFINITION 3.18. *We say f is in the Sobolev space, $S_p^{k,l}(\Omega)$, if and only if*

$$\|f\|_{S_p^{k,l}(\Omega)} := \sum_{I=0}^k \|X^I f\|_{L^p(\Omega)} + \sum_{j=0}^l \|D_t^j f\|_{L^p(\Omega)} < \infty.$$

The well known Sobolev embedding theorem still holds in the parabolic setting. This result can be found in [20, Theorem 5.15] for groups. We give now a parabolic version.

THEOREM 3.19. *Suppose $H_A u = f$ in \mathcal{Q}_1 and $f \in L^p(\mathcal{Q}_r)$. For $p > \frac{Q+2}{2}$, $S_p^{2,1}(\mathcal{Q}_r(0, 0)) \subset \Gamma^\alpha(\mathcal{Q}_r(0, 0))$ where $\alpha = 2 - \frac{Q+2}{p}$.*

PROOF. The theorem is shown in [23] for solutions to $H_A(0)u = g$. They actually show that for $\alpha = 2 - \frac{Q+2}{p}$,

$$\|u\|_{\Gamma^\alpha(\mathcal{Q}_r)} \leq C\|g\|_{L^p(\mathcal{Q}_r)}.$$

Apply their result to

$$H_A(0)u = H_A u(0) - H_A u + H_A u$$

$$= \sum_{ij=1}^{m_1} (a_{ij}(x, t) - a_{ij}(0, 0)) X_i X_j u + f.$$

Then

$$\|u\|_{\Gamma^\alpha(\mathcal{Q}_r)} \leq C(r^\alpha \|X_i X_j u\|_{L^p(\mathcal{Q}_r)} + \|f\|_{L^p(\mathcal{Q}_r)}),$$

which is finite for fixed r under the conditions of the theorem. \square

Now we are ready to give the interior L^p estimates.

LEMMA 3.20. [37, Theorem 18] *Suppose $f \in L^p_{loc}(\mathbb{G} \times \mathbb{R})$ and $1 < p < \infty$. If $H_A(0)u = f$ on $\mathbb{G} \times \mathbb{R}$, then for any $a, b \in C^\infty(\mathbb{G} \times \mathbb{R})$*

$$(3.10) \quad \|au\|_{S^{2,1}_p(\mathbb{G} \times \mathbb{R})} \leq C(\|bf\|_{L^p(\mathbb{G} \times \mathbb{R})})$$

for some positive constant $C = C(p, \mathbb{G}, a, b)$.

Before moving to the case of variable coefficients where the coefficient functions are Hölder continuous only at a single point, we will localize the above lemma using the technique given in [26]. This proof can also be found in [6, section 5].

LEMMA 3.21. *If $f \in L^p(\mathcal{Q}_{2r}(x, t))$ and $H_A(0)u = f$ on \mathcal{Q}_r , then for any $r > 0$ the following result holds with $k = |I| + 2l$*

$$(3.11) \quad \sum_{k=0}^2 r^k \|X^I D_t^l u\|_{L^p(\mathcal{Q}_r(x, t))} \leq C(\|u\|_{L^p(\mathcal{Q}_{2r}(x, t))} + r^2 \|f\|_{L^p(\mathcal{Q}_{2r}(x, t))})$$

for some positive constant $C = C(p, \mathbb{G}, r, a_{ij}(0, 0))$.

The method of proof relies heavily on the existence of a test function with certain bounds on its derivatives (for the construction see [6, Lemma 5]) as well as an interpolation inequality [6, Theorem 12].

Through the coefficient freezing technique, we obtain the following lemma for the operator with pointwise Hölder continuous coefficients.

LEMMA 3.22. *If $f \in L^p(\mathbb{G} \times \mathbb{R})$ with compact support and $H_A u = f$ on $\mathbb{G} \times \mathbb{R}$, then for any $r > 0$ the following result holds*

$$(3.12) \quad \sum_{k=0}^2 r^k \|X^I D_t^k u\|_{L^p(\mathcal{Q}_r)} \leq C(\|u\|_{L^p(\mathcal{Q}_{2r})} + r^2 \|f\|_{L^p(\mathcal{Q}_{2r})})$$

for some positive constant $C = C(p, \mathbb{G}, r, A)$.

PROOF. Begin by first considering u with compact support

$$\begin{aligned} H_A(0)u &= H_A(0)u - H_A u + H_A u \\ &= \sum_{ij=1}^{m_1} (a_{ij}(0,0) - a_{ij}(x,t)) X_i X_j u(x,t) + f. \end{aligned}$$

Apply Lemma 3.20.

$$(3.13) \quad \|u\|_{S_p^{2,1}(\mathbb{G} \times \mathbb{R})} \leq C \left(\sum_{ij=1}^{m_1} \sup_{\mathcal{Q}_r} |a_{ij}(0,0) - a_{ij}(x,t)| \|X_i X_j u\|_{L^p(\mathbb{G} \times \mathbb{R})} + \|f\|_{L^p(\mathbb{G} \times \mathbb{R})} \right)$$

Choosing r small enough (say $Cr^\alpha < 1/2$), the second derivative term gets absorbed into the left hand side giving

$$(3.14) \quad \|u\|_{S_p^{2,1}(\mathbb{G} \times \mathbb{R})} \leq C \|f\|_{L^p(\mathbb{G} \times \mathbb{R})}$$

For functions without compact support, apply this equation to a product of a cutoff function with a solution, u , and use the same localization argument as in Lemma 3.21. \square

By the Sobolev embedding (Theorem 3.19), we gain as a quick corollary, that $u \in \Gamma^\alpha(\mathcal{Q}_r)$ with $\alpha = 2 - \frac{Q+2}{p}$, and so it is essentially bounded.

COROLLARY 3.23. *If $f \in L^p(\mathcal{Q}_{2r}(x, t))$ and $H_A u = f$ on $\mathcal{Q}_r(x, t)$, and additionally, if $\frac{Q+2}{2} < p < \infty$, then for any $r > 0$*

$$(3.15) \quad \|u\|_{L^\infty(\mathcal{Q}_r(x, t))} \leq C(\|u\|_{L^p(\mathcal{Q}_{2r}(x, t))} + \|f\|_{L^p(\mathcal{Q}_{2r}(x, t))})$$

for some positive constant $C = C(p, \mathbb{G}, r)$.

CHAPTER 4

The Pointwise Schauder Estimates

4.1 Preliminaries

In this chapter, we first explore the heat kernel for the group setting as well as the existence and properties of a fundamental solution. For easy access, the operators of interest as well as the necessary conditions on the coefficients are given here again.

$$(4.1) \quad H = \partial_t - \sum_{i=1}^{m_1} X_i^2,$$

where X_1, \dots, X_{m_1} generate the first layer of the Lie algebra stratification for a Carnot group, and

$$(4.2) \quad H_A = \partial_t - \sum_{i,j=1}^{m_1} a_{ij}(x, t) X_i X_j.$$

Letting $A = (a_{ij})_{i,j=1\dots m_1}$ denote the positive definite, symmetric $m_1 \times m_1$ real-valued matrix, the ellipticity condition states that for all $(x, t) \in \mathbb{G} \times \mathbb{R}$ there exists a constant, Λ such that

$$(4.3) \quad \Lambda^{-1} |\xi|^2 \leq \sum_{i=1}^{m_1} a_{ij} \xi_i \xi_j \leq \Lambda |\xi|^2 \quad \text{for any } \xi \in \mathbb{S}^{m_1-1} \subset \mathbb{R}^{m_1}.$$

We will also make use of the frozen operator,

$$(4.4) \quad H_A(0) = \partial_t - \sum_{i,j=1}^{m_1} a_{ij}(0, 0) X_i X_j.$$

When establishing the a-priori estimates leading up to the Schauder estimates, the proofs are done for the operator H . These proofs will also apply to $H_A(0)$ by making use of a linear transformation. This will be discussed in more detail in Section 4.3.

There is a rich history behind the study of fundamental solutions. Given here are only a few results that are most relevant to the cause of this paper. In reference [3], the authors prove uniform Gaussian estimates on the associated heat kernel of H and H_A . The bounds listed below are given in [3, Theorem 5.3]. Building on this work, the same authors later constructed the fundamental solution, Γ , for the general operator, H_A , under the additional assumption that the entries of A are Hölder continuous [1, Theorem 1.2]. In [8], these same results were extended from the setting of stratified groups to the case of Hörmander vector fields by means of the Rothschild and Stein lifting and approximation theorems (Theorems 2.7 and 2.8).

The subsequent theorem is essentially Theorems 1.1 and 1.2 of [1]. However, we only need the result for the constant coefficient equation, H .

THEOREM 4.1. *Consider the operator H given above. Then there exists a fundamental solution Γ for H with the properties listed below.*

(i) Γ is a continuous function away from the diagonal of $\mathbb{R}^{N+1} \times \mathbb{R}^{N+1}$. Moreover, for every fixed $\zeta \in \mathbb{R}^{N+1}$, $\Gamma(\cdot; \zeta) \in \Gamma_{loc}^{2+\alpha}(\mathbb{R}^{N+1}/\{\zeta\})$, and we have

$$H(\Gamma(\cdot; \zeta)) = 0 \text{ in } \mathbb{R}^{N+1}/\{\zeta\}.$$

(ii) $\Gamma(x, t; y, s) = 0$ for $t \leq s$. Moreover, there exists positive constants b and (for every

$T > 0$) a positive constant C such that for $0 < t - s \leq T$ the following estimates hold:

$$(4.5) \quad |\Gamma(x, t; y, s)| \leq C(t-s)^{-Q/2} \exp\left(-b \left(\frac{d(x, y)^2}{(t-s)}\right)\right)$$

and

$$(4.6) \quad |X^I D_t^l \Gamma(x, t; y, s)| \leq C(t-s)^{-(Q+|I|+2l)/2} \exp\left(-b \left(\frac{d(x, y)^2}{(t-s)}\right)\right)$$

The constants C and b depend on \mathbb{G}, T, A, I , and l

(iii) For every $f \in C_0^\infty(\mathbb{R}^{N+1})$, the function

$$w(z) = \int_{\mathbb{R}^{N+1}} \Gamma(z; \zeta) f(\zeta) d\zeta$$

belongs to the class $\Gamma_{loc}^{2+\alpha}(\mathbb{R}^{N+1})$, and we have

$$Hw = f \quad \text{in } \mathbb{R}^{N+1}.$$

The Gaussian bounds (4.5) for $\Gamma(x, t) = \Gamma(x, t; 0, 0)$ gives the following estimates for (x, t) away from the singularity at the origin, which will be of great use in the next section.

$$\begin{aligned} |\Gamma(x, t)| &\leq C|t|^{-Q/2} \exp\left(-b \left(\frac{d(x, 0)^2}{|t|}\right)\right) \\ &= \frac{C}{|(x, t)|^Q} \left[\frac{|(x, t)|^Q}{|t|^{Q/2}} \exp\left(-b \left(\frac{d(x, 0)^2}{|t|}\right)\right) \right] \end{aligned}$$

Observing the term in brackets is bounded for $(x, t) \neq (0, 0)$, we have

$$(4.7) \quad |\Gamma(x, t)| \leq \frac{C}{|(x, t)|^Q}.$$

Similarly, for derivatives we have the estimate

$$\begin{aligned} |X^I D_t^l \Gamma(x, t)| &\leq C |t|^{-(Q+|I|+2l)/2} \exp\left(-b \left(\frac{d(x, 0)^2}{|t|}\right)\right) \\ &= \frac{C}{|(x, t)|^{Q+|I|+2l}} \left[\frac{|(x, t)|^{Q+|I|+2l}}{|t|^{(Q+|I|+2l)/2}} \exp\left(-b \left(\frac{d(x, 0)^2}{|t|}\right)\right) \right], \end{aligned}$$

which gives

$$(4.8) \quad |X^I D_t^l \Gamma(x, t)| \leq \frac{C}{|(x, t)|^{Q+|I|+2l}}.$$

Consider now the k th order Taylor polynomial (in the x and t variables) of $\Gamma(x, t; y, s)$ with center at the origin given by

$$\Gamma_k(x, t; y, s) = \sum_{|I|+2l=k} c_k X^I D_t^l \Gamma((y, s)^{-1}) x^I t^l.$$

Using the previous estimates, we see that

$$(4.9) \quad |\Gamma_k(x, t; y, s)| \leq \sum_{|I|+2l=k} c_k \frac{|x|^I |t|^l}{|(y, s)|^{Q+|I|+2l}}.$$

Making the first use of the fundamental solution, we prove two lemmas regarding H applied to polynomials. These two results appear in [15] for the sublaplacian as Lemma 3.7 and Lemma 3.8, respectively. Here those proofs are reproduced to ensure they are still valid for the operator H .

LEMMA 4.2. *If Q is a group polynomial of degree $d - 2$, then we can always find a polynomial P of degree d such that $HP(x, t) = Q(x, t)$ in $\mathbb{G} \times \mathbb{R}$.*

PROOF. Let Γ be the fundamental solution as before, and define

$$f(x, t) = \int_{\mathcal{Q}_1(0,0)} \Gamma((x, t)(y, s)^{-1})Q(y, s)dyds$$

so that $Hf(x, t) = Q(x, t)$ in \mathcal{Q}_1 . Consider the d th order Taylor polynomial P_d of f centered at the origin. We can express f as the Taylor polynomial plus some remainder term. $f = P_d + R_d$. We would like to show that $HR_d = 0$ in \mathcal{Q}_1 so that $Hf = HP_d = Q$ in \mathcal{Q}_1 and thus in all of $\mathbb{G} \times \mathbb{R}$.

By definition, for $f \in C_o^\infty(\mathbb{G} \times \mathbb{R})$, we have $X^I D_t^l P_d(0, 0) = X^I D_t^l f(0, 0)$ for all $|I| + 2l \leq d$. This implies $X^I D_t^l R_d(0, 0) = 0$ for all $|I| + 2l \leq d$. Additionally, by degree consideration $X^I D_t^l HR_d(0, 0) = 0$ for all $|I| + 2l \leq d - 2$ giving, $HX^I D_t^l R_d(0, 0) = X^I D_t^l HR_d(0, 0) = 0$ for $|I| + 2l \leq d - 2$.

Now consider the expansion of $\tilde{f}(x, t) = HR_d(x, t)$ as $\tilde{P}_{d-2}(x, t) + \tilde{R}_{d-2}(x, t)$. Again, we have that $X^I D_t^l \tilde{f}(0, 0) = X^I D_t^l \tilde{P}_{d-2}(0, 0)$ for all $|I| + 2l \leq d - 2$. Consequently, $X^I D_t^l \tilde{R}_{d-2}(0, 0) = 0$ for all $|I| + 2l \leq d - 2$, and $X^I D_t^l H\tilde{R}_{d-2} = 0$ for all $|I| + 2l \leq d - 2$.

$$(4.10) \quad X^I D_t^l \tilde{f}(0, 0) = \begin{cases} X^I D_t^l \tilde{P}_{d-2}(0, 0) & \text{for } |I| + 2l \leq d - 2 \\ X^I D_t^l \tilde{R}_{d-2}(0, 0) & \text{for } |I| + 2l > d - 2 \end{cases}$$

However, by the expansion of f , we noted that $X^I D_t^l HR_d(0, 0) = 0$ for all $|I| + 2l \leq d - 2$, so in fact, $X^I D_t^l \tilde{P}_{d-2}(0, 0) = 0$ for all $|I| + 2l \leq d - 2$. Then $\tilde{P}_{d-2}(0, 0)$ has no terms with degree less than or equal to $d - 2$, and \tilde{P}_{d-2} is in fact equal to zero.

By virtue of Corollary 3.11, we see

$$|\tilde{f} - \tilde{P}_{d-2}| \leq c_d |(y, s)|^{d-1} \sup_{\substack{|(z, \tau)| \leq b|(y, s)| \\ |J|+2p=d-1}} |X^J D_t^p \tilde{f}(z, \tau)|.$$

Making substitutions,

$$(4.11) \quad |\tilde{R}_{d-2}| \leq c_d |(y, s)|^{d-1} \sup_{\substack{|(z, \tau)| \leq b|(y, s)| \\ |J|+2p=d-1}} |X^J D_t^p H R_d(z, \tau)|.$$

$X^J D_t^p H$ is an operator of order $d+1$, so P_d is annihilated when the operator is applied giving

$$X^J D_t^p H R_d = X^J D_t^p H (f - P_d) = X^J D_t^p H f = X^J D_t^p Q = 0$$

because Q is of degree $d-2$ and $X^J D_t^p$ is of order $d-1$. Equation (4.11) now reads

$$|\tilde{R}_{d-2}| = |H R_d| \leq 0.$$

□

LEMMA 4.3. *Let $u(x, t) \in C^\infty(\mathcal{Q}_1(0, 0))$ be a solution to $Hu = 0$ in \mathcal{Q}_r with $|u| \leq 1$ on $\partial\mathcal{Q}_1$. If we write $u(x, t) = \sum_{k=1}^d P_k(x, t) + R_d(x, t)$ where the P_k 's are the k th order terms of the Taylor polynomial expansion at the origin and R_d is the remainder term, then for every $0 \leq k \leq d$, $0 < r < 1$, we have:*

(i) $HP_k(x, t) = 0$

(ii) P_k has universally bounded coefficients for all $0 \leq k \leq d$.

PROOF. By the argument given in the proof of Lemma 4.2, we know that $HR_d = 0$. Then $Hu(x, t) = \sum_{k=1}^d HP_k(x, t) = 0$, which implies that for each k , $HP_k(x, t) = 0$. Degree

considerations rule out the possibility of any terms canceling to get zero.

To prove (ii), we need an interior estimate on derivatives and Bony's maximum principle proved in [4]. Derivative estimates (found in [16]) give

$$|X^I D_t^l u(x, t)| \leq Cr^{-k} \sup_{\mathcal{Q}_r(x_o, t_o)} |u(x, t)|$$

for all $0 < r < 1$ and all $|I| + 2l = k$. Let M be the supremum on $\mathcal{Q}_r(x_o, t_o)$, and the maximum principle gives $u(x, t) \leq M$ for all $(x, t) \in \mathbb{G} \times \mathbb{R}$ giving a bound for $|X^I D_t^l u(x, t)|$.

Consequently, the coefficients for P_k are bounded. \square

4.2 A-priori Estimates

LEMMA 4.4. *Suppose $f \in L^p(\mathcal{Q}_1(0, 0))$ and $p > 1 + \frac{Q}{2}$. If for some constants $\gamma > 0$, $\alpha \in (0, 1)$, and some integer $d \geq 2$, f satisfies*

$$(4.12) \quad \|f\|_{L^p(\mathcal{Q}_r)} \leq \gamma r^{d-2+\alpha+\frac{Q+2}{p}} \quad \text{for all } r \leq 1,$$

then there exists a function $u(x, t) \in S_p^{2,1}(\mathcal{Q}_1)$ such that $Hu = f(x, t)$ in \mathcal{Q}_1 , and moreover for $k = |I| + 2l$,

$$(4.13) \quad \sum_{k=0}^2 r^k \|X^I D_t^l u\|_{L^p(\mathcal{Q}_r)} \leq C\gamma r^{d+\alpha+\frac{Q+2}{p}} \quad \text{for all } r \leq 1$$

where C is a positive constant depending on Q, p , and d .

PROOF. The proof is in three steps. First, we will establish the existence of a solution. During step 2, we will establish a particular estimate on this solution, which is vital to step 3 where we obtain (4.13).

Without loss of generality, extend f to equal 0 outside of $|(x, t)| > 1$. With Γ being the fundamental solution to H , we define

$$w(x, t) = \int_{|(y,s)| < 1} \Gamma((x, t)(y, s)^{-1}) f(y, s) dy ds$$

and notice that $Hw = f$ in \mathcal{Q}_1 by Theorem 4.1 . By interior estimates given in Lemma 3.20,

$$\|w\|_{S_p^{2,1}(\mathcal{Q}_1)} \leq C \|f\|_{L^p(\mathcal{Q}_1)} \leq C\gamma.$$

Using the d th order Taylor expansion of Γ at the origin, we similarly define the function

$$v(x, t) = \int_{|(y,s)| < 1} \sum_{k=0}^d \Gamma_k(x, t; y, s) f(y, s) dy ds.$$

By Lemma 4.3, $H\Gamma_k = 0$, and since the Γ_k 's are smooth and bounded, there is no issue with moving the derivatives inside the integral giving $Hv = 0$ provided $v(x, t)$ is well defined. In fact, we can show that $|v(x, t)| \leq C\gamma$ in \mathcal{Q}_1 .

$$\begin{aligned} |v(x, t)| &\leq \int_{|(y,s)| < 1} \sum_{k=0}^d |\Gamma_k(x, t; y, s)| |f(y, s)| dy ds \\ &\leq \sum_{k=0}^d c_k \int_{|(y,s)| < 1} \frac{|x|^{|I|} |t|^l}{|(y, s)|^{Q+k}} |f(y, s)| dy ds \\ &\leq \sum_{k=0}^d c_k \sum_{i=0}^{\infty} \int_{2^{-i} \leq |(y,s)| \leq 2^{-i+1}} \frac{1}{|(y, s)|^{Q+k}} |f(y, s)| dy ds \\ &\leq C \sum_{k=0}^d \sum_{i=0}^{\infty} \int_{2^{-i} \leq |(y,s)| \leq 2^{-i+1}} (2^i)^{Q+k} |f(y, s)| dy ds. \end{aligned}$$

Integrating over the larger set and using Hölder's inequality $\left(\frac{1}{p} + \frac{1}{p'} = 1\right)$ gives the estimation desired.

$$\begin{aligned}
|v(x, t)| &\leq C \sum_{k=0}^d \sum_{i=0}^{\infty} (2^i)^{Q+k} |\mathcal{Q}_{2^{-i+1}}|^{1/p'} \|f(y, s)\|_{L_p(|(y,s)| \leq 2^{-i+1})} \\
&\leq C \sum_{k=0}^d \sum_{i=0}^{\infty} (2^i)^{Q+k} (2^{-i+1})^{(Q+2)/p'} \gamma (2^{-i+1})^{d+\alpha + \frac{Q+2}{p} - 2} \\
&\leq C \gamma \sum_{k=0}^d \sum_{i=0}^{\infty} (2^{-i})^{d+\alpha-k} \\
&\leq C \gamma.
\end{aligned}$$

Let $u = w - v$. Then $Hu = f$. This establishes existence of a solution. To get $u \in S_p^{2,1}$ with the appropriate estimates, we will first show that $|u(x, t)| \leq C\gamma|(x, t)|^{d+\alpha}$ for $|(x, t)| < \frac{1}{D}$ where D is a positive constant to be specified later.

Write u as $u(x, t) = I_1 - I_2 + I_3$ where

$$\begin{aligned}
I_1 &= \int_{|(y,s)| < D|(x,t)|} \Gamma((x, t)(y, s)^{-1}) f(y, s) dy ds, \\
I_2 &= \int_{|(y,s)| < D|(x,t)|} \sum_{k=0}^d \Gamma_k(x, t; y, s) f(y, s) dy ds, \text{ and} \\
I_3 &= \int_{|(y,s)| > D|(x,t)|} \left[\Gamma((x, t)(y, s)^{-1}) - \sum_{k=0}^d \Gamma_k(x, t; y, s) \right] f(y, s) dy ds.
\end{aligned}$$

We will show that each of these integrals is less than $C\gamma|(x, t)|^{d+\alpha}$.

$$\begin{aligned}
|I_1| &\leq \int_{|(y,s)| < D|(x,t)|} |\Gamma((x, t)(y, s)^{-1})| |f(y, s)| dy ds \\
&\leq \int_{|(y,s)| < D|(x,t)|} \frac{C}{|(x, t)(y, s)^{-1}|^Q} |f(y, s)| dy ds.
\end{aligned}$$

Using a change of variables and properties of the quasi-norm,

$$|(z, \tau)| = |(x, t)(y, s)^{-1}| \leq A(|(y, s)| + |(x, t)|) \leq A(D|(x, t)| + |(x, t)|) \leq K|(x, t)|,$$

we get the needed estimate for a positive constant K depending on the group \mathbb{G} by means of a dyadic decomposition and Hölder's inequality.

$$\begin{aligned} |I_1| &\leq \int_{|(z, \tau)| < K|(x, t)|} \frac{C}{|(z, \tau)|^Q} |f(y, s)| dz d\tau \\ &\leq \sum_{i=0}^{\infty} C \left(\int_{K2^{-i}|(x, t)| \leq |(z, \tau)| \leq K2^{-i+1}|(x, t)|} \frac{1}{|(z, \tau)|^{Qp'}} dz d\tau \right)^{1/p'} \|f\|_{L^p(\mathcal{Q}_{K2^{-i+1}|(x, t)|})} \\ &\leq C\gamma \sum_{i=0}^{\infty} \left(\frac{2^i}{K|(x, t)|} \right)^Q \left(\frac{K|(x, t)|}{2^{i-1}} \right)^{\frac{Q+2}{p'}} \left(\frac{K|(x, t)|}{2^{i-1}} \right)^{d+\alpha-2+\frac{Q+2}{p}} \\ &\leq C\gamma \sum_{i=0}^{\infty} (2^{-i})^{d+\alpha} |(x, t)|^{d+\alpha} \\ &\leq C\gamma |(x, t)|^{d+\alpha}. \end{aligned}$$

The final line is obtained by noting the convergence of the geometric series. I_2 is handled similarly.

$$\begin{aligned} |I_2| &\leq \int_{|(y, s)| < D|(x, t)|} \sum_{k=0}^d |\Gamma_k(x, t; y, s)| |f(y, s)| dy ds \\ &\leq \sum_{k=0}^d \int_{|(y, s)| < D|(x, t)|} \frac{C_k |x|^{|l|} |t|^l}{|(y, s)|^{Q+k}} |f(y, s)| dy ds. \end{aligned}$$

Noticing that by binomial expansion $|(x, t)|^k \geq |x|^{|I|}|t|^l$, where $|I| + 2l = k$ gives,

$$\begin{aligned}
|I_2| &\leq C \sum_{k=0}^d \int_{|(y,s)| < D|(x,t)|} \frac{|(x, t)|^k}{|(y, s)|^{Q+k}} |f(y, s)| dy ds \\
&\leq C \sum_{k=0}^d \sum_{i=0}^{\infty} \left(\int_{D2^{-i}|(x,t)| \leq |(y,s)| \leq D2^{-i+1}|(x,t)|} \frac{|(x, t)|^k}{|(y, s)|^{(Q+k)p'}} dy ds \right)^{1/p'} \|f\|_{L^p(\mathcal{Q}_{D2^{-i+1}|(x,t)|})} \\
&\leq C\gamma \sum_{k=0}^d |(x, t)|^k \sum_{i=0}^{\infty} \left(\frac{2^i}{D|(x, t)|} \right)^{Q+k} \left(\frac{D|(x, t)|}{2^{i-1}} \right)^{\frac{Q+2}{p'}} \left(\frac{D|(x, t)|}{2^{i-1}} \right)^{d+\alpha-2+\frac{Q+2}{p}} \\
&\leq C\gamma \sum_{i=0}^{\infty} (2^{-i})^{d+\alpha} |(x, t)|^{d+\alpha} \\
&\leq C\gamma |(x, t)|^{d+\alpha}.
\end{aligned}$$

$$|I_3| \leq \int_{|(y,s)| \geq D|(x,t)|} \left| \Gamma(x, t; y, s) - \sum_{k=0}^d \Gamma_k(x, t; y, s) \right| |f(y, s)| dy ds$$

Using Corollary 3.11,

$$\begin{aligned}
|I_3| &\leq \int_{|(y,s)| \geq D|(x,t)|} C |(x, t)|^{d+1} \sup_{\substack{z \in \mathcal{Q}(0, b|(x,t)|) \\ |I|+2l=d+1}} |X^I D_t^l \Gamma(y, s; z, \tau)| |f(y, s)| dy ds \\
&\leq \int_{|(y,s)| \geq D|(x,t)|} C |(x, t)|^{d+1} \sup_{z \in \mathcal{Q}(0, b|(x,t)|)} |(z, \tau)^{-1}(y, s)|^{-d-1-Q} |f(y, s)| dy ds
\end{aligned}$$

Since $|(z, \tau)| \leq b|(x, t)|$ and $|(y, s)| \geq |(x, t)|$, we have by the reverse quasi-triangle inequality,

$$|(z, \tau)^{-1}(y, s)| \geq (1/A)|(y, s)| - |(z, \tau)| \geq (D/A)|(x, t)| - b|(x, t)| \geq C'|(x, t)|.$$

Now we can see that choosing $D > Ab$ (whose dependence is determined by \mathbb{G} and d), will give a positive constant C' above.

$$\begin{aligned}
|I_3| &\leq C|(x, t)|^{d+1} \int_{|(y, s)| \geq D|(x, t)|} |(x, t)|^{-d-1-Q} |f(y, s)| dy ds \\
&\leq C|(x, t)|^{-Q} \sum_{i=0}^J \left(\int_{2^{-i}D|(x, t)| \leq |(y, s)| \leq 2^{-i+1}D|(x, t)|} 1 dy ds \right)^{1/p'} \|f\|_{L^p(\mathcal{Q}_{2^{-i+1}|(x, t)|})} \\
&\leq C\gamma|(x, t)|^{d+\alpha} \sum_{i=0}^J (2^{-i})^{d+\alpha+Q} \\
&\leq C\gamma|(x, t)|^{d+\alpha}
\end{aligned}$$

In the previous analysis, $J \in \mathbb{N}$ such that $2^{J-1}D|(x, t)| \leq 1 \leq 2^J D|(x, t)|$. Using properties of logs, one can see that $J = \lceil -\log_2(D|(x, t)|) \rceil$.

This completes step 2 of the proof. Before establishing the final conclusion, notice that because we have $|u(x, t)| \leq C\gamma|(x, t)|^{d+\alpha}$ in \mathcal{Q}_1 , we obtain $\|u\|_{L^p(\mathcal{Q}_r(0))} \leq C\gamma|(x, t)|^{d+\alpha+\frac{Q+2}{p}}$ by once again making use of dyadic decomposition.

Let $\tilde{u}(x, t) = u(\delta_r x, r^2 t)$. Applying the operator to $\tilde{u}(x, t)$ gives, $H\tilde{u}(x, t) = r^2 H u(x, t) = r^2 f(x, t)$ on \mathcal{Q}_r . Now apply interior estimates (Lemma 3.21) to $\tilde{u}(x, t)$ to get our final conclusion.

$$\begin{aligned}
\|\tilde{u}(x, t)\|_{S_p^{2,1}(\mathcal{Q}_{\frac{r}{2}}(0))} &\leq C(\|\tilde{u}(x, t)\|_{L^p(\mathcal{Q}_r(0))} + \|H\tilde{u}(x, t)\|_{L^p(\mathcal{Q}_r(0))}) \text{ for all } r \leq \frac{1}{2} \\
&\leq C(\|u(x, t)\|_{L^p(\mathcal{Q}_1(0))} + r^2 \|f(x, t)\|_{L^p(\mathcal{Q}_r(0))}) \text{ for all } r \leq \frac{1}{2} \\
&\leq C\gamma r^{d+\alpha+\frac{Q+2}{p}}.
\end{aligned}$$

The chain rule and a scaling argument completes the proof giving

$$\sum_{k=0}^2 r^k \|X^I D_t^k u(x, t)\|_{L^p(\mathcal{Q}_r)} \leq C\gamma r^{d+\alpha+\frac{Q+2}{p}} \quad \text{for all } r \leq 1.$$

□

COROLLARY 4.5. *Suppose $f \in L^p(\mathcal{Q}_1)$, $p > 1 + \frac{Q}{2}$, satisfies*

$$\|f\|_{L^p(\mathcal{Q}_r)} \leq \gamma r^{d-2+\alpha+\frac{Q+2}{p}} \quad \text{for all } r \leq 1$$

for some positive constants $\gamma > 0$, $\alpha \in (0, 1)$, and some integer $d \geq 2$. For any solution $u(x, t) \in S_p^{2,1}(\mathcal{Q}_1)$ to $Hu = f$, there exists a polynomial P_d of degree no greater than d with $HP_d = 0$ such that

$$|u(x, t) - P_d(x, t)| \leq C(\gamma + \|u\|_{L^p(\mathcal{Q}_1)})|(x, t)|^{d+\alpha} \quad \text{for all } (x, t) \in \mathcal{Q}_{\frac{1}{2}}$$

where $C > 0$ is a constant depending only on $Q, \mathbb{G}, p, d, \lambda$, and α .

PROOF. By Lemma 4.4, there exists $v \in S_p^{2,1}(\mathcal{Q}_1)$ with $Hv = f$ such that

$$|v(x, t)| \leq C\gamma|(x, t)|^{d+\alpha} \quad \text{for all } (x, t) \in \mathcal{Q}_{1/2}$$

and

$$\|v(x, t)\|_{L^p(\mathcal{Q}_1)} \leq C\gamma.$$

Note that $H(u - v) = 0$, by Lemma 4.3 we can write the d th order Taylor expansion of $u - v$ as $u - v = P_d + R_d$. Moreover, using Corollary 3.11, we have a bound on R_d .

$$\begin{aligned}
|R_d| &\leq C|(x, t)|^{d+1} \sup_{\substack{|(x, t)| \leq \frac{1}{2} \\ |I|+2l=d+1}} |X^I D_t^l(u - v)| \\
&\leq C|(x, t)|^{d+1} \sup_{|(x, t)| \leq \frac{3}{4}} |(u - v)| \\
&\leq C|(x, t)|^{d+1} \|u - v\|_{L^p(\mathcal{Q}_{3/4})} \text{ by Corollary 3.23} \\
&\leq C(\gamma + \|u\|_{L^p(\mathcal{Q}_1)})|(x, t)|^{d+1}.
\end{aligned}$$

The conclusion is reached by virtue of the above estimate and the previously mentioned use of Lemma 4.4.

$$|u - P_d| = |v + R_d| \leq |v| + |R_d| \leq C_1 \gamma |(x, t)|^{d+\alpha} + C_2 (\gamma + \|u\|_{L^p(\mathcal{Q}_1)}) |(x, t)|^{d+1}.$$

Since $\alpha < 1$ and $|(x, t)| < 1$, the smaller exponent gives the larger bound, and we reach the conclusion,

$$|u - P_d| \leq C(\gamma + \|u\|_{L^p(\mathcal{Q}_1)}) |(x, t)|^{d+\alpha}.$$

□

4.3 Pointwise Schauder Estimates

We now turn our attention to equations of the following form:

$$(4.14) \quad H_A u(x, t) = \partial_t u(x, t) - \sum_{i,j=1}^{m_1} a_{ij}(x, t) X_i X_j u(x, t) = f(x, t)$$

where the matrix $A = (a_{ij})$ satisfies for some $\alpha \in (0, 1)$ and $1 < \lambda \leq \Lambda < \infty$

$$(4.15) \quad a_{ij} \in \Gamma^\alpha(0, 0)$$

and

$$(4.16) \quad \lambda|\xi|^2 \leq \sum_{i,j=1}^{m_1} a_{ij}(x, t)\xi_i\xi_j \leq \Lambda|\xi|^2 \text{ for any } \xi \in \mathbb{R}^{m_1}.$$

Since $A = (a_{ij}(0, 0))$ is positive definite, we can find a matrix $B \in GL(m_1)$ such that $BB^T = A$. The vector fields $\tilde{X}_i = \sum_{j=1}^{m_1} b_{ij}X_j$ for $i = 1, \dots, m_1$ and all their commutators will still generate the complete Lie algebra, and consequently, Lemma 4.4 and Corollary 4.5 from the previous section will still hold for solutions to the frozen operator,

$$H_A(0)u = \partial_t u(x, t) - \sum_{i=1}^{m_1} \tilde{X}_i^2 u(x, t) = \partial_t u(x, t) - \sum_{i,j=1}^{m_1} a_{ij}(0, 0)X_i X_j u(x, t) = f(x, t).$$

THEOREM 4.6. *Let $u \in S_p^{2,1}(\mathcal{Q}_1)$ be a solution to $H_A u = f$ in \mathcal{Q}_1 , with $f \in L^p(\mathcal{Q}_1)$ and $Q/2 + 1 < p < \infty$. Assume the following:*

1. *There exists a homogeneous polynomial Q of degree $d - 2$ such that*

$$(4.17) \quad \|f - Q\|_{L^p(\mathcal{Q}_r)} \leq \gamma r^{d-2+\alpha+\frac{Q+2}{p}}.$$

2. *There exists a constant $\beta \in (0, 1]$ such that*

$$(4.18) \quad \limsup_{r \rightarrow 0} \frac{\|u\|_{L^p(\mathcal{Q}_r)}}{r^{d-1+\beta+\frac{Q+2}{p}}} < \infty.$$

Then there exists a constant $C = C(G, A)$ such that

$$(4.19) \quad \|u\|_{L^p(\mathcal{Q}_r)} \leq C \left(\|u\|_{L^p(\mathcal{Q}_1)} + \|Q\|_{L^p(\mathcal{Q}_1)} + \gamma \right) r^{d+\frac{Q+2}{p}}$$

for any $0 < r \leq 1$. Moreover, there exists a homogeneous polynomial P of degree d such that $H_A(0)P = Q$,

$$(4.20) \quad |P(x, t)| \leq C \left(\|u\|_{L^p(\mathcal{Q}_1)} + \|Q\|_{L^p(\mathcal{Q}_1)} + \gamma \right) |(x, t)|^d,$$

and

$$(4.21) \quad |u - P|(x, t) \leq C \left(\|u\|_{L^p(\mathcal{Q}_1)} + \|Q\|_{L^p(\mathcal{Q}_1)} + \gamma \right) |(x, t)|^{d+\alpha}$$

for any $r \leq R$. (R is a constant to be fixed during the proof.)

Furthermore, for $j = |I| + 2l$,

$$(4.22) \quad \sum_{j=0}^2 r^j \|X^I D_t^l(u - P)\|_{L^p(\mathcal{Q}_r)} \leq C \left(\|u\|_{L^p(\mathcal{Q}_1)} + \|Q\|_{L^p(\mathcal{Q}_1)} + \gamma \right) r^{d+\alpha+\frac{Q+2}{p}}.$$

PROOF. We will divide this proof into two steps. In the first step, we will show for a fixed $0 < \alpha_1 \leq \alpha$,

$$(4.23) \quad C_k := \sup_{0 < r \leq 1} \frac{\|u\|_{L^p(\mathcal{Q}_r)}}{r^{d-1+\beta+k\alpha_1+\frac{Q+2}{p}}} < \infty,$$

provided $\beta + k\alpha_1 \leq 1$. Assumption 2 establishes the case $k = 0$, which gives

$$\|u\|_{L^p(\mathcal{Q}_r)} \leq C_0 r^{d-1+\beta+\frac{Q+2}{p}}.$$

The proof will proceed by showing the case $k = 1$ follows from this assumption. We also assume $\alpha + \beta < 1$. During the induction argument, the construction of the polynomial P will begin, but additional arguments to complete the estimates on P and $u - P$ will be needed. That will be the second step of the proof.

We begin step one by recalling the L^p estimates for the non-constant coefficient equation in Lemma 3.22. For any $0 < r < 1/2$,

$$\begin{aligned}
(4.24) \quad \sum_{j=0}^2 r^j \|X^I D_t^l u\|_{L^p(\mathcal{Q}_r)} &\leq C(\|u\|_{L^p(\mathcal{Q}_{2r})} + r^2 \|f\|_{L^p(\mathcal{Q}_{2r})}) \\
&\leq C(C_o r^{d-1+\beta+\frac{Q+2}{p}} + r^2(\gamma r^{d-2+\alpha+\frac{Q+2}{p}} + \|Q\|_{L^p(\mathcal{Q}_{2r})})) \\
&\leq C(C_o r^{d-1+\beta+\frac{Q+2}{p}} + \gamma r^{d+\alpha+\frac{Q+2}{p}} + r^{d+\frac{Q+2}{p}} \|Q\|_{L^p(\mathcal{Q}_1)}) \\
&\leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)}) r^{d-1+\beta+\frac{Q+2}{p}}.
\end{aligned}$$

Taking $H_A(0) = \partial_t - \sum_{i,j=1}^{m_1} a_{ij}(0,0)X_i X_j$, we can use Lemma 4.2 to get a polynomial of homogeneous degree d such that $H_A(0)P_1 = Q$. Since Q is assumed to be homogeneous, we can choose P_1 to be homogeneous as well. Observe that if we write $H_A(u - P_1) = \tilde{\phi}$, we get an estimate on $\tilde{\phi}$;

$$\begin{aligned}
\tilde{\phi} &= f - H_A P_1 + H_A(0)P_1 - H_A(0)P_1 \\
&= f - Q + (H_A(0) - H_A)(P_1) \\
&= f - Q + \sum_{i,j=1}^{m_1} (a_{ij} - a_{ij}(0,0))X_i X_j P_1.
\end{aligned}$$

Using the Hölder continuity and the L^p estimates on $H_A(0)P_1 = Q$, we have

$$\begin{aligned}
(4.25) \quad \sum_{i,j=1}^{m_1} \|(a_{ij} - a_{ij}(0,0))X_i X_j P_1\|_{L^p(\mathcal{Q}_r)} &\leq Cr^\alpha \|X_i X_j P_1\|_{L^p(\mathcal{Q}_r)} \\
&\leq Cr^\alpha \left(r^{-2} \|P_1\|_{L^p(\mathcal{Q}_{2r})} + \|Q\|_{L^p(\mathcal{Q}_{2r})} \right) \\
&\leq C \left(\|P_1\|_{L^p(\mathcal{Q}_1)} + \|Q\|_{L^p(\mathcal{Q}_1)} \right) r^{d-2+\alpha+\frac{Q+2}{p}}.
\end{aligned}$$

The factors of r^d, r^{d-2} come from the degrees of homogeneity of P_1 and Q respectively.

Now the estimation of $\tilde{\phi}$ can follow.

$$\begin{aligned}
(4.26) \quad \left\| \tilde{\phi} \right\|_{L^p(\mathcal{Q}_r)} &\leq \|f - Q\|_{L^p(\mathcal{Q}_r)} + \sum_{i,j=1}^{m_1} \|(a_{ij} - a_{ij}(0,0))X_i X_j P_1\|_{L^p(\mathcal{Q}_r)} \\
&\leq \gamma r^{d-2+\alpha+\frac{Q+2}{p}} + C \left(\|P_1\|_{L^p(\mathcal{Q}_1)} + \|Q\|_{L^p(\mathcal{Q}_{2r})} \right) r^{d-2+\alpha+\frac{Q+2}{p}} \\
&\leq C \left(\gamma + \|P_1\|_{L^p(\mathcal{Q}_1)} + \|Q\|_{L^p(\mathcal{Q}_1)} \right) r^{d-2+\alpha+\frac{Q+2}{p}}.
\end{aligned}$$

It is clear that (4.26) also holds for any q replacing p where $1 < q < p$. Now apply L^p estimates to $H_A(u - P_1) = \tilde{\phi}$.

$$\begin{aligned}
(4.27) \quad \sum_{j=0}^2 r^j \|X^I D_t^l(u - P_1)\|_{L^p(\mathcal{Q}_r)} &\leq C \left(\|(u - P_1)\|_{L^p(\mathcal{Q}_{2r})} + r^2 \left\| \tilde{\phi} \right\|_{L^p(\mathcal{Q}_{2r})} \right) \\
&\leq C \|u\|_{L^p(\mathcal{Q}_{2r})} + C' \left(\|P_1\|_{L^p(\mathcal{Q}_1)} + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} \right) r^{d-2+\alpha+\frac{Q+2}{p}} \\
&\leq C_o r^{d-1+\beta+\frac{Q+2}{p}} + C' \left(\|P_1\|_{L^p(\mathcal{Q}_1)} + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} \right) r^{d-2+\alpha+\frac{Q+2}{p}} \\
&\leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)}) r^{d-1+\beta+\frac{Q+2}{p}}.
\end{aligned}$$

Now define $F = H_A(0)(u - P_1)$, so $F = H_A(0)(u - P_1) - H_A(u - P_1) + H_A(u - P_1)$.

Explicitly,

$$F = \sum_{i,j=1}^{m_1} (a_{ij}(x, t) - a_{ij}(0, 0)) X_i X_j (u - P_1) + \tilde{\phi},$$

and we can apply (4.26) and (4.27) to get an estimate on F that satisfies the hypothesis of Corollary 4.5. The first term will be dealt with in such a way that we can see from where

α_1 comes.

For any q with $1 + \frac{Q}{2} < q < p$ we have

$$\begin{aligned} & \sum_{i,j=1}^{m_1} \|(a_{ij}(x, t) - a_{ij}(0, 0)) X_i X_j (u - P_1)\|_{L^q(\mathcal{Q}_r)} \\ & \leq \sum_{i,j=1}^{m_1} \|(a_{ij}(x, t) - a_{ij}(0, 0))\|_{L^{\frac{pq}{p-q}}(\mathcal{Q}_r)} \|X_i X_j (u - P_1)\|_{L^p(\mathcal{Q}_r)} \\ & \leq C \sum_{i,j=1}^{m_1} \|(a_{ij}(x, t) - a_{ij}(0, 0))\|_{L^{\frac{pq}{p-q}}(\mathcal{Q}_r)} \cdot (C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)}) r^{d-3+\beta+\frac{Q+2}{p}}. \end{aligned}$$

Now, we handle two cases. If $p > 2(1 + \frac{Q}{2})$, take $q = p/2 > 1 + \frac{Q}{2}$ so that $\frac{pq}{p-q} = p$.

Therefore,

$$(4.28) \quad \begin{aligned} & \sum_{i,j=1}^{m_1} \|(a_{ij}(x, t) - a_{ij}(0, 0)) X_i X_j (u - P_1)\|_{L^q(\mathcal{Q}_r)} \\ & \leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)}) r^{d-3+\beta+\alpha+\frac{Q+2}{p}}. \end{aligned}$$

If $p \leq 2(1 + \frac{Q}{2})$, take any q where $1 + \frac{Q}{2} < q < p$ so that $\frac{pq}{p-q} > p$. Then,

$$\begin{aligned} \sum_{i,j=1}^{m_1} \|(a_{ij}(x, t) - a_{ij}(0, 0))\|_{L^{\frac{pq}{p-q}}(\mathcal{Q}_r)} & \leq C \sum_{i,j=1}^{m_1} \|(a_{ij}(x, t) - a_{ij}(0, 0))\|_{L^p(\mathcal{Q}_r)}^{\frac{p-q}{q}} \\ & \leq Cr^{\left(\alpha+\frac{Q+2}{p}\right) \cdot \left(\frac{p-q}{q}\right)}. \end{aligned}$$

Hence,

$$\begin{aligned} & \sum_{i,j=1}^{m_1} \|(a_{ij}(x, t) - a_{ij}(0, 0))X_i X_j(u - P_1)\|_{L^q(\mathcal{Q}_r)} \\ & \leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)})r^{d-3+\beta+\frac{\alpha(p-q)}{q}+\frac{Q+2}{p}}. \end{aligned}$$

In either case, we have for any $r \leq 1/2$,

$$(4.29) \quad \begin{aligned} & \sum_{i,j=1}^{m_1} \|(a_{ij}(x, t) - a_{ij}(0, 0))X_i X_j(u - P_1)\|_{L^q(\mathcal{Q}_r)} \\ & \leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)})r^{d-3+\beta+\alpha_1+\frac{Q+2}{q}} \end{aligned}$$

for some $\alpha_1 = \frac{\alpha(p-q)}{q} \leq \alpha$ and some q with $1 + \frac{Q}{2} < q < p$.

And finally,

$$(4.30) \quad \|F\|_{L^p(\mathcal{Q}_r)} \leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)})r^{d-3+\beta+\alpha_1+\frac{Q+2}{p}}.$$

Applying Corollary 4.5 with $\alpha_1 + \beta$ replacing α (which is acceptable since $\alpha_1 + \beta < 1$) and $d - 1$ replacing d , we obtain a polynomial P_o of degree $d - 1$ such that

$$(4.31) \quad |u - P_1 - P_o|(x, t) \leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)})|(x, t)|^{d-1+\alpha_1+\beta}.$$

Now we are in a position to see that P_o is in fact identically 0 through the following argument.

$$\begin{aligned} |u - P_o| &= |u - P_o - P_1 + P_1| \\ &\leq |u - P_o - P_1| + |P_1| \end{aligned}$$

$$\begin{aligned}
&\leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)})|(x, t)|^{d-1+\alpha_1+\beta} + \tilde{C}|(x, t)|^d \\
(4.32) \quad &\leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)})|(x, t)|^{d-1+\alpha_1+\beta}.
\end{aligned}$$

Thus,

$$(4.33) \quad \|u - P_o\|_{L^p(\mathcal{Q}_r)} \leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)})|(x, t)|^{d-1+\alpha_1+\beta+\frac{Q+2}{p}}.$$

And since

$$\|P_o\|_{L^p(\mathcal{Q}_r)} = \|P_o - u + u\|_{L^p(\mathcal{Q}_r)},$$

$$\begin{aligned}
\|P_o\|_{L^p(\mathcal{Q}_r)} &\leq \|u - P_o\|_{L^p(\mathcal{Q}_r)} + \|u\|_{L^p(\mathcal{Q}_r)} \\
&\leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)})r^{d-1+\alpha_1+\beta+\frac{Q+2}{p}} \\
&\quad + C_o r^{d-1+\beta+\frac{Q+2}{p}} \\
&\leq C r^{d-1+\beta+\frac{Q+2}{p}}.
\end{aligned}$$

(4.34)

Thus, $\|P_o\|_{L^p(\mathcal{Q}_1)} \leq C r^\beta$ which implies $P_o \equiv 0$. Looking back to equation (4.33), we see that

$$\|u\|_{L^p(\mathcal{Q}_r)} \leq C(C_o + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)})|(x, t)|^{d-1+\alpha_1+\beta+\frac{Q+2}{p}}$$

Finally, this gives $C_1 < \infty$. Repeating the argument k times we obtain

$$(4.35) \quad \sup_{0 < r \leq 1} \frac{\|u\|_{L^p(\mathcal{Q}_r)}}{r^{d-1+\beta+k\alpha_1+\frac{Q+2}{p}}} < \infty,$$

as long as $\beta + k\alpha < 1$. By induction, the C_k 's are finite for all k , and we can use this fact to complete the construction of a polynomial P with the bounds in the theorem. First notice that in the last step of iteration (from k to $k + 1$) there is a gain on the degree of the polynomial obtained from $d - 1$ to d . To see this this, first notice that for some $0 < \alpha_o < 1$, $1 + \alpha_o < \beta + (k + 1)\alpha$. For this value of k , we revisit (4.30) and see

$$(4.36) \quad \|F\|_{L^p(\mathcal{Q}_r)} \leq C(C_k + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)})r^{d-3+(1+\alpha_o)+\frac{Q+2}{p}}.$$

Applying Corollary 4.5 again gives a polynomial P_2 of degree d such that $H_A(0)P_2 = 0$ and

$$(4.37) \quad |u - P_1 - P_2|(x, t) \leq \left[C(C_k + \gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|P_1\|_{L^p(\mathcal{Q}_1)}) + \|u\|_{L^p(\mathcal{Q}_1)} \right] |(x, t)|^{d+\alpha_o}$$

for all $(x, t) \in \mathcal{Q}_r$. Set $P = P_1 + P_2$, so P is a homogeneous polynomial of degree d and $H_A(0)P = Q$.

REMARK 4.7. *The degree of P is clear, but to see that P is in fact homogeneous, we first write P as the sum of homogeneous polynomials and discover that only the homogeneous part with degree d is nonzero. Let $P = \sum_{j=0}^d \tilde{P}_j$, and recall (4.18) and (4.37), which state*

$$(4.38) \quad |u - P|(x, t) \leq C|(x, t)|^{d+\alpha_o}$$

and

$$(4.39) \quad \|u\|_{L^p(\mathcal{Q}_r)} \leq Cr^{d-1+\beta+\frac{Q+2}{p}}.$$

Then

$$\begin{aligned}
\left\| \sum_{j=0}^d \tilde{P}_j \right\|_{L^p(\mathcal{Q}_r)} &= \|P\|_{L^p(\mathcal{Q}_r)} \leq \|u - P\|_{L^p(\mathcal{Q}_r)} + \|u\|_{L^p(\mathcal{Q}_r)} \\
&\leq \left(\int_{\mathcal{Q}_r} |(x, t)|^{p(d+\alpha_o)} dx dt \right)^{1/p} + Cr^{d-1+\beta+\frac{Q+2}{p}} \\
&\leq Cr^{d+\alpha_o+\frac{Q+2}{p}} + Cr^{d-1+\beta+\frac{Q+2}{p}} \\
&\leq Cr^{d-1+\beta+\frac{Q+2}{p}}.
\end{aligned}$$

This implies $\left\| \tilde{P}_j \right\|_{L^p(\mathcal{Q}_r)} \leq Cr^{d-1+\beta+\frac{Q+2}{p}}$ for every $j = 0, 1, \dots, d$. By homogeneity and a change of variable, we obtain

$$r^{j+\frac{Q+2}{p}} \left\| \tilde{P}_j \right\|_{L^p(\mathcal{Q}_1)} \leq Cr^{d-1+\beta+\frac{Q+2}{p}}$$

and

$$\left\| \tilde{P}_j \right\|_{L^p(\mathcal{Q}_1)} \leq Cr^{d-j+\beta-1}.$$

The last estimate ensures $\tilde{P}_j = 0$ unless $j = d$.

This completes step 1 of the proof. For the second step, we wish to remove the dependence on P_1 and C_k in the constants bounding u and P . To this end, we prove estimates under the additional assumption that $0 < R < 1$ is small enough that

$$\sup_{\mathcal{Q}_R} |a_{ij}(x, t) - a_{ij}(0, 0)| \leq \eta < 1/2$$

for some small $\eta > 0$ to be chosen later in the proof. This assumption can be made without loss of generality. The general case can be recovered by applying the transformation $(x, t) \rightarrow$

(Rx, R^2t) for a suitable $R \in (0, 1)$. Let $\psi = u - P$ and

$$\delta = \sup_{0 < r < R} \frac{\|\psi\|_{L^p(\mathcal{Q}_r)}}{r^{d+\alpha+\frac{Q+2}{p}}}.$$

From step 1 (4.37), we know δ is finite.

$$\begin{aligned} H_A\psi &= H_A(u - P) \\ &= H_Au - H_A(0)P + H_A(0)P - H_AP \\ &= f - Q + \sum_{i,j=1}^{m_1} (a_{ij}(x, t) - a_{ij}(0, 0))X_iX_jP. \end{aligned}$$

We apply L^p estimates again and get for any $r \leq R$,

$$\begin{aligned} \sum_{j=0}^2 r^j \|X^I D_t^l \psi\|_{L^p(\mathcal{Q}_r)} &\leq C(\|\psi\|_{L^p(\mathcal{Q}_{2r})} + r^2 \|f - Q\|_{L^p(\mathcal{Q}_{2r})} + r^2 \|(H_A(0) - H_A)P\|_{L^p(\mathcal{Q}_{2r})}) \\ &\leq C(\delta + \gamma + \|P\|_{L^p(\mathcal{Q}_1)})r^{d+\alpha+\frac{Q+2}{p}} \end{aligned}$$

Consider $H_A(0)\psi = \tilde{F}$ written as $\tilde{F} = H_A(0)\psi - H_A\psi + H_A\psi$ or alternatively,

$$\tilde{F} = \sum_{i,j=1}^{m_1} (a_{ij}(x, t) - a_{ij}(0, 0))X_iX_j\psi + H_A\psi.$$

Then we see that

$$\begin{aligned} \|\tilde{F}\|_{L^p(\mathcal{Q}_r)} &\leq C[\eta(\delta + \gamma + \|P\|_{L^p(\mathcal{Q}_1)})r^{d-2+\alpha+\frac{Q+2}{p}} + (\gamma + \|P\|_{L^p(\mathcal{Q}_1)})r^{d-2+\alpha+\frac{Q+2}{p}}] \\ (4.40) \quad &\leq C[\eta(\delta + \gamma + \|P\|_{L^p(\mathcal{Q}_1)}) + (\gamma + \|P\|_{L^p(\mathcal{Q}_1)})]r^{d-2+\alpha+\frac{Q+2}{p}}. \end{aligned}$$

Using Corollary 4.5, there exists a polynomial P_3 of degree d such that

(4.41)

$$\|\psi - P_3\|_{L^p(\mathcal{Q}_r)} \leq C \left(\eta\delta + \eta(\gamma + \|P\|_{L^p(\mathcal{Q}_1)}) + \gamma + \|P\|_{L^p(\mathcal{Q}_1)} + \|\psi\|_{L^p(\mathcal{Q}_1)} \right) r^{d+\alpha+\frac{Q+2}{p}}.$$

By the same argument given for P_o in step 1, $P_3 \equiv 0$, and

$$\delta \leq C \left(\eta\delta + \eta(\gamma + \|P\|_{L^p(\mathcal{Q}_1)}) + \gamma + \|P\|_{L^p(\mathcal{Q}_1)} + \|\psi\|_{L^p(\mathcal{Q}_1)} \right).$$

Choose $\eta < 1/C$ so that $1 - C\eta$ is positive and

$$(1 - C\eta)\delta \leq C \left((\eta + 1)(\gamma + \|P\|_{L^p(\mathcal{Q}_1)}) + \gamma + \|P\|_{L^p(\mathcal{Q}_1)} + \|\psi\|_{L^p(\mathcal{Q}_1)} \right).$$

By designating a new constant C' whose dependence is the same as the old constant C , we have

$$(4.42) \quad \delta \leq C'(\gamma + \|P\|_{L^p(\mathcal{Q}_1)} + \|\psi\|_{L^p(\mathcal{Q}_1)}).$$

Equivalently from the definition of δ , for $|(x, t)| < R$

$$(4.43) \quad \begin{aligned} \|\psi\|_{L^p(\mathcal{Q}_r)} &\leq C(\gamma + \|P\|_{L^p(\mathcal{Q}_1)} + \|\psi\|_{L^p(\mathcal{Q}_1)})r^{d+\alpha+\frac{Q+2}{p}} \\ &\leq C(\gamma + \|u\|_{L^p(\mathcal{Q}_1)} + \|P\|_{L^p(\mathcal{Q}_1)})r^{d+\alpha+\frac{Q+2}{p}}, \end{aligned}$$

and by (4.40)

$$(4.44) \quad \left\| \tilde{F} \right\|_{L^p(\mathcal{Q}_r)} \leq C(\gamma + \|u\|_{L^p(\mathcal{Q}_1)} + \|P\|_{L^p(\mathcal{Q}_1)})r^{d-2+\alpha+\frac{Q+2}{p}}.$$

This allows us to once again make use of Corollary 4.5 and get \tilde{P} of degree d such that

$$(4.45) \quad |\psi - \tilde{P}| \leq C(\gamma + \|P\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)})|(x, t)|^{d+\alpha} \text{ in } \mathcal{Q}_R.$$

But by the same argument used before, this new polynomial is zero as well, and

$$(4.46) \quad |\psi| \leq C(\gamma + \|P\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)})|(x, t)|^{d+\alpha} \text{ in } \mathcal{Q}_R.$$

We are now in a position to establish the estimates for P and $u - P$. By the definition of ψ and using the fact that $\|P\|_{L^p(\mathcal{Q}_1)} \leq C\|P\|_{L^\infty(\mathcal{Q}_1)}$, we see

$$\begin{aligned} |P(x, t)| &\leq |u(x, t)| + |(u - P)(x, t)| \\ &\leq |u(x, t)| + C(\gamma + \|u\|_{L^p(\mathcal{Q}_1)} + \|P\|_{L^\infty(\mathcal{Q}_1)})|(x, t)|^{d+\alpha}. \end{aligned}$$

And interior estimates (Corollary 3.23) imply that

$$(4.47) \quad |u(x, t)| \leq C(\gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)}) \text{ in } \mathcal{Q}_R.$$

The implication follows as

$$\begin{aligned} |P(x, t)| &\leq C(\gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)}) + C'(\gamma + \|u\|_{L^p(\mathcal{Q}_1)} + \|P\|_{L^\infty(\mathcal{Q}_1)})|(x, t)|^{d+\alpha} \\ &\leq C(\gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)}) + C''\|P\|_{L^\infty(\mathcal{Q}_1)}|(x, t)|^{d+\alpha} \text{ in } \mathcal{Q}_R. \end{aligned}$$

Suppose P restricted in $\{(e_x, e_t) \in \mathbb{G} \times \mathbb{R}; |(e_x, e_t)| = 1\}$ attains its maximum at (z, τ) .

Choose $x = |(x, t)|z$ and $t = |(x, t)|^2\tau$. By the homogeneity of P ,

$$|P(x, t)| = |(x, t)|^d P(z, \tau) = \|P\|_{L^\infty(\mathcal{Q}_1)} |(x, t)|^d,$$

and we see that

$$\|P\|_{L^\infty(\mathcal{Q}_1)} |(x, t)|^d \leq C(\gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)}) + C'' \|P\|_{L^\infty(\mathcal{Q}_1)} |(x, t)|^{d+\alpha} \text{ in } \mathcal{Q}_R.$$

Choosing (x, t) small enough, this implies

$$\|P\|_{L^\infty(\mathcal{Q}_1)} \leq C(\gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)}).$$

Equivalently,

$$|P(x, t)| \leq C(\gamma + \|Q\|_{L^p(\mathcal{Q}_1)} + \|u\|_{L^p(\mathcal{Q}_1)}) |(x, t)|^d$$

establishing estimate (4.20). Using the same argument on (4.46), we get (4.21), and (4.19)

follows from these two results. The estimate (4.22) follows from the interior estimates.

□

THEOREM 4.8. *For $\frac{Q}{2} + 1 < p < \infty$, let $u \in S_p^{2,1}(\mathcal{Q}_1)$ be a solution to $H_A u = f$ in \mathcal{Q}_1 satisfying hypothesis (4.15) and (4.16) and $f \in L^p(\mathcal{Q}_1)$. Assume $d \geq 2$ and that f and u satisfy the following:*

$$(4.48) \quad \limsup_{r \rightarrow 0} \frac{\|u\|_{L^p(\mathcal{Q}_r)}}{r^{d + \frac{Q+2}{p}}} < \infty$$

and

$$(4.49) \quad \limsup_{r \rightarrow 0} \frac{\|f\|_{L^p(\mathcal{Q}_r)}}{r^{d-2+\frac{Q+2}{p}}} < \infty.$$

If for some $l \in \mathbb{N}$ and $\alpha \in (0, 1)$, one has $f \in C_{p,d-2+l}^\alpha(0, 0)$ and $a_{ij} \in C_{p,l}^\alpha(0, 0)$, then $u \in C_{\infty,d+l}^\alpha(0, 0)$. Moreover,

$$(4.50) \quad \sum_{|I|+2h=0}^{d+l} |X^I D_t^h u(0, 0)| + [u]_{\infty,\alpha,d+l} \leq C \left(\|u\|_{L^p(\mathcal{Q}_1)} + \sum_{|J|+2m=d-2}^{d-2+l} |X^J D_t^m f(0, 0)| + [f]_{p,\alpha,d-2+l} \right)$$

where $C = C(G, p, d, l, \alpha, A) > 0$.

PROOF. The proof is given by induction on l . If $l = 0$, the result is given by Theorem 4.6. To see this, first we need to show that we can apply the theorem by showing there exists a homogeneous polynomial Q of degree $d - 2$ such that $\|f - Q\|_{L^p(\mathcal{Q}_r)} \leq \gamma r^{d-2+\alpha+\frac{Q+2}{p}}$. The hypothesis on u is immediate by taking $\beta = 1$ in Theorem 4.6.

The assumption $f \in C_{p,d-2}^\alpha(0, 0)$ means that there exists a polynomial of degree $d - 2$, Q , such that

$$\|f - Q\|_{L^p(\mathcal{Q}_r)} \leq [f]_{p,\alpha,d-2} r^{\alpha+d-2+\frac{Q+2}{p}},$$

and (4.49) gives $\|f\|_{L^p(\mathcal{Q}_r)} \leq Cr^{d-2+\frac{Q+2}{p}}$. This information actually tells us that Q is homogeneous of degree $d - 2$. If $d = 2$, there is nothing to show because Q would be constant, so take $d > 2$. (Additionally, notice that the $d - 2$ order Taylor expansion of f satisfies the decay requirements. We choose Q to be the Taylor polynomial centered at the origin so that we can obtain the derivatives of f at the origin. See Remark 3.17.)

$$\begin{aligned}
\|Q\|_{L^p(\mathcal{Q}_r)} &\leq \|f - Q\|_{L^p(\mathcal{Q}_r)} + \|f\|_{L^p(\mathcal{Q}_r)} \\
&\leq C_1[f]_{p,\alpha,d-2} r^{d-2+\alpha+\frac{Q+2}{p}} + C_2 r^{d-2+\frac{Q+2}{p}} \\
&\leq C[f]_{p,\alpha,d-2} r^{d-2+\frac{Q+2}{p}}.
\end{aligned}$$

Using the familiar trick of writing Q as a sum of homogeneous polynomials of degree j , gives

$$r^{j+\frac{Q+2}{p}} \|Q_j\|_{L^p(\mathcal{Q}_1)} \leq C[f]_{p,\alpha,d-2} r^{d-2+\frac{Q+2}{p}}$$

for each $j = 0, 1, 2, \dots, d-2$. Now in

$$\|Q_j\|_{L^p(\mathcal{Q}_1)} \leq C[f]_{p,\alpha,d-2} r^{d-2-j},$$

the right hand side vanishes unless $j = d-2$ leaving $Q = Q_{d-2}$. Applying Theorem 4.6 with $\gamma = C[f]_{p,\alpha,d-2}$ gives the existence of P_d , a homogeneous polynomial of degree d such that $H_A(0)P_d = Q_{d-2}$ with the following properties:

$$(4.51) \quad \|u\|_{L^p(\mathcal{Q}_r)} \leq C \left(\|u\|_{L^p(\mathcal{Q}_1)} + \|Q_{d-2}\|_{L^p(\mathcal{Q}_1)} + [f]_{p,\alpha,d-2} \right) r^{d+\frac{Q+2}{p}},$$

$$(4.52) \quad |P_d| \leq C \left(\|u\|_{L^p(\mathcal{Q}_1)} + \|Q_{d-2}\|_{L^p(\mathcal{Q}_1)} + [f]_{p,\alpha,d-2} \right) |(x, t)|^d,$$

$$(4.53) \quad |u - P_d| \leq C \left(\|u\|_{L^p(\mathcal{Q}_1)} + \|Q_{d-2}\|_{L^p(\mathcal{Q}_1)} + [f]_{p,\alpha,d-2} \right) |(x, t)|^{d+\alpha}, \text{ and}$$

$$(4.54) \quad \sum_{|I|=0}^2 r^{|I|} \|X^I(u - P_d)\|_{L^p(\mathcal{Q}_r)} \leq C \left(\|u\|_{L^p(\mathcal{Q}_1)} + \|Q_{d-2}\|_{L^p(\mathcal{Q}_1)} + [f]_{p,\alpha,d-2} \right) r^{d+\alpha+\frac{Q+2}{p}}.$$

Equation (4.53) gives $u \in C_{\infty,d}^\alpha(0,0)$ and $[u]_{\infty,\alpha,d} \leq C \left(\|u\|_{L^p(\mathcal{Q}_1)} + \|Q_{d-2}\|_{L^p(\mathcal{Q}_1)} + [f]_{p,\alpha,d-2} \right)$.

Additionally, since we choose Q_{d-2} to be the Taylor polynomial of f , $\|Q_{d-2}\|_{L^p(\mathcal{Q}_1)} \leq C |X^J D_t^m f(0,0)|$ for $|J| + 2m = d - 2$. We have

$$(4.55) \quad \sum_{|I|+2m=1}^2 |X^I D_t^m u(0,0)| + [u]_{\infty,\alpha,d} \leq C \left(\|u\|_{L^p(\mathcal{Q}_1)} + \sum_{|J|+2k=d-2} |X^J D_t^k f(0,0)| + [f]_{p,\alpha,d-2} \right).$$

On the left hand side, we were able to add the derivatives of u at the origin because the assumption on u in fact implies that the the derivatives up to order d are zero.

The case $l = 1$ follows from Theorem 4.6 in much the same way. Begin by noticing that the assumptions on f ensure the existence of homogeneous polynomials Q_{d-2} and Q_{d-1} with respective degrees $d - 2$ and $d - 1$ such that

$$(4.56) \quad \|f - Q_{d-2} - Q_{d-1}\|_{L^p(\mathcal{Q}_r)} \leq C [f]_{p,\alpha,d-1}(0,0) r^{d-1+\alpha+\frac{Q+2}{p}}.$$

To see this, we notice from the $l = 1$ assumptions, that there exists a polynomial Q with degree at most $d - 1$ such that

$$(4.57) \quad \|f - Q\|_{L^p(\mathcal{Q}_r)} \leq [f]_{p,\alpha,d-1} r^{d-1+\alpha+\frac{Q+2}{p}}$$

From the hypothesis, $\|f\|_{L^p(\mathcal{Q}_r)} \leq C r^{d-2+\frac{Q+2}{p}}$.

Write Q as the sum of homogeneous polynomials $Q = \sum_{j=0}^{d-1} Q_j$,

$$\|Q\|_{L^p(\mathcal{Q}_r)} \leq \|f - Q\|_{L^p(\mathcal{Q}_r)} + \|f\|_{L^p(\mathcal{Q}_r)}$$

$$\begin{aligned}
&\leq C_1[f]_{p,\alpha,d-1} r^{d-1+\alpha+\frac{Q+2}{p}} + C_2 r^{d-2+\frac{Q+2}{p}} \\
&\leq C[f]_{p,\alpha,d-1} r^{d-2+\frac{Q+2}{p}}.
\end{aligned}$$

Using the homogeneity and a change of variables,

$$r^{j+\frac{Q+2}{p}} \|Q_j\|_{L^p(Q_1)} \leq C[f]_{p,\alpha,d-1} r^{d-2+\frac{Q+2}{p}}$$

for each $j = 0, 1, 2, \dots, d-2$. Now in the inequality

$$\|Q_j\|_{L^p(Q_1)} \leq C[f]_{p,\alpha,d-1} r^{d-2-j},$$

the right hand side vanishes unless $j = d-2$ or $j = d-1$ leaving $Q = Q_{d-1} + Q_{d-2}$.

Similarly, the hypothesis on a_{ij} gives the existence of a homogeneous polynomial $a_{ij}^{(1)}$ of degree 1 such that

$$(4.58) \quad \left\| a_{ij}(x, t) - a_{ij}(0, 0) - a_{ij}^{(1)} \right\|_{L^p(Q_r)} \leq C[a_{ij}]_{p,\alpha,1}(0, 0) r^{1+\alpha+\frac{Q+2}{p}} \text{ for } i, j = 1 \dots, m_1.$$

From the $l = 0$ case, we have the existence of a homogeneous polynomial P_d of degree d such that (4.20) and (4.21) hold and $H_A(0)P_d = Q_{d-2}$. In particular, we get

$$(4.59) \quad |P_d(x, t)| \leq C \left(\|u\|_{L^p(Q_1)} + \|Q_{d-2}\|_{L^p(Q_1)} + [f]_{p,\alpha,d-2}(0, 0) \right) |(x, t)|^d$$

and

$$(4.60) \quad |u - P_d|(x, t) \leq C \left(\|u\|_{L^p(Q_1)} + \|Q_{d-2}\|_{L^p(Q_1)} + [f]_{p,\alpha,d-2}(0, 0) \right) |(x, t)|^{d+\alpha}.$$

Let $\psi = u - P_d$, and write $H_A\psi = H_Au - H_A(0)P_d + H_A(0)P_d - H_AP_d$. Then $H_A\psi = f - Q_{d-2} + \sum_{i,j=1}^{m_1} (a_{ij}(x,t) - a_{ij}(0,0))X_iX_jP_d$, or alternatively,

$$H_A\psi = f - Q_{d-2} - Q_{d-1} + Q_{d-1} + \sum_{i,j=1}^{m_1} (a_{ij}(x,t) - a_{ij}(0,0))X_iX_jP_d \equiv \tilde{f}.$$

Notice that $\tilde{Q} = Q_{d-1} + \sum_{i,j=1}^{m_1} a_{ij}^{(1)}X_iX_jP_d$ is homogeneous of degree $d-1$, and $\tilde{f} - \tilde{Q} = f - Q_{d-2} - Q_{d-1} + \sum_{i,j=1}^{m_1} (a_{ij}(x,t) - a_{ij}(0,0) - a_{ij}^{(1)})X_iX_jP_d$.

$$(4.61) \quad \left\| \tilde{f} - \tilde{Q} \right\|_{L^p(\mathcal{Q}_r)} \leq ([f]_{p,\alpha,d-1}(0,0) + C \|P_d\|_{L^\infty(\mathcal{Q}_1)}) r^{d-1+\alpha+\frac{Q+2}{p}}.$$

This holds for all $r \leq 1$. By (4.22), we have

$$\limsup_{r \rightarrow 0} \frac{\|\psi\|_{L^p(\mathcal{Q}_r)}}{r^{d+\alpha+\frac{Q+2}{p}}} < \infty.$$

Now we can apply Theorem 4.6 with ψ , $d+1$, \tilde{f} , and \tilde{Q} replacing u , d , f , and Q respectively to get a homogeneous polynomial P_{d+1} of degree $d+1$ such that $H_A(0)P_{d+1} = \tilde{Q}$, and

$$|P_{d+1}(x,t)| \leq C_*(x,t)^{d+1} \quad \text{for all } (x,t) \in \mathcal{Q}_{1/2}$$

$$|\psi(x,t) - P_{d+1}(x,t)| \leq C_*(x,t)^{d+1+\alpha} \quad \text{for all } (x,t) \in \mathcal{Q}_{1/2}$$

where $C_* \leq C([f]_{p,\alpha,d-1} + \|\psi\|_{L^p(\mathcal{Q}_{1/2})} + \|P_d\|_{L^\infty(\mathcal{Q}_1)} + \left\| \tilde{Q} \right\|_{L^p(\mathcal{Q}_1)})$. Using the expressions for ψ and \tilde{Q} , we have

$$C_* \leq C([f]_{p,\alpha,d-1} + \|u - P_d\|_{L^p(\mathcal{Q}_{1/2})} + \|P_d\|_{L^\infty(\mathcal{Q}_1)} + \|Q_{d-1}\|_{L^p(\mathcal{Q}_1)}).$$

We can eliminate P_d by using (4.59) and (4.60) to notice that on \mathcal{Q}_1

$$\|P_d\|_{L^\infty(\mathcal{Q}_1)} \leq C(\|u\|_{L^p(\mathcal{Q}_1)} + \|Q_{d-2}\|_{L^p(\mathcal{Q}_1)} + [f]_{p,\alpha,d-2}).$$

Then

$$C_* \leq C([f]_{p,\alpha,d-1} + [f]_{p,\alpha,d-2}(0,0) + \|u\|_{L^p(\mathcal{Q}_1)} + \|Q_{d-2}\|_{L^p(\mathcal{Q}_1)} + \|Q_{d-1}\|_{L^p(\mathcal{Q}_1)}).$$

Finally,

$$C_* \leq C([f]_{p,\alpha,d-1} + \|u\|_{L^p(\mathcal{Q}_1)} + \sum_{|J|+2k=d-2}^{d-1} |X^J D_t^k f(0,0)|).$$

This completes the proof for $l = 1$. □

THEOREM 4.9. *For $Q + 2 < p < \infty$, let $u \in S_p^{2,1}(\mathcal{Q}_1)$ be a solution of $H_A u = f$ in $\mathcal{Q}_1 \subset \mathbb{G} \times \mathbb{R}$ with $f \in L^p(\mathcal{Q}_1)$. Assume, for some $\alpha \in (0, 1)$ and integer $\tilde{d} \geq 2$, $f \in C_{p,\tilde{d}-2}^\alpha(0,0)$ and $a_{ij} \in C_{p,\tilde{d}-2}^\alpha(0,0)$. Then $u \in C_{\infty,\tilde{d}}^\alpha(0,0)$ and*

$$(4.62) \quad \|u\|_{\infty,\alpha,\tilde{d}} \leq C(\|u\|_{L^p(\mathcal{Q}_1)} + \|f\|_{p,\alpha,\tilde{d}-2})$$

where $C = C(G, p, \tilde{d}, l, \alpha, A) > 0$.

PROOF. Let P_* be the 1st order Taylor polynomial expansion of u at the origin. We can apply Theorem 3.10 and get

$$\begin{aligned} \frac{|u(x,t) - P_*(x,t)|}{|(x,t)|^{1+\alpha}} &\leq C|(x,t)|^{-\alpha} \sup_{\substack{|(z,\tau)| \leq b^k |(x,t)| \\ i=1,\dots,m_1}} |X_i u(z,\tau) - X_i u(0,0)| \\ &= C \|X_i u\|_{\Gamma^\alpha(\mathcal{Q}_{1/2})}. \end{aligned}$$

By Theorem 3.19, $S_p^{2,1}(\mathcal{Q}) \subset \Gamma_{loc}^{\alpha'}(\mathcal{Q})$ for $\alpha' = 2 - \frac{Q+2}{p}$. Here we must account for the derivative and get $\alpha = 1 - \frac{Q+2}{p}$, hence

$$\begin{aligned} \|X_i u\|_{\Gamma^\alpha(\mathcal{Q}_{1/2})} &\leq C \|u\|_{S_p^{2,1}(\mathcal{Q}_{1/2})} \\ &\leq C(\|u\|_{L^p(\mathcal{Q}_1)} + \|f\|_{L^p(\mathcal{Q}_1)}) \end{aligned}$$

for all $|(x, t)| < 1/2$. The previous line is obtained by using the estimates of Lemma 3.22.

Observe by the definition of Taylor polynomial and Lemma 3.22, we also have

$$|P_*(0, 0)| + \sum_{i=1}^{m_1} |X_i P_*(0, 0)| \leq C(\|u\|_{L^p(\mathcal{Q}_1)} + \|f\|_{L^p(\mathcal{Q}_1)}).$$

The goal now is to successively apply Theorems 4.6 and 4.8 with $d = 2$ and $u = u - P_*$.

To see that the hypotheses of Theorem 4.6 are satisfied, first notice that $H_A(u - P_*) = f$

because P_* is of order 1 and is annihilated by H_A . By the above arguments, we know that

$|u - P_*| \leq \tilde{C}r^{1+\alpha} = \tilde{C}r^{2-\frac{Q+2}{p}}$. Using this and a dyadic decomposition, we can get that

$\|u - P_*\|_{L^p(\mathcal{Q}_r)} < Cr^2$ for all $r \in (0, 1)$.

$$\begin{aligned} \|u - P_*\|_{L^p(\mathcal{Q}_r)} &= \left(\int_{\mathcal{Q}_r} |u - P_*|^p dx dt \right)^{1/p} \\ &\leq \left(\int_{\mathcal{Q}_r} (\tilde{C}|(x, t)|^{2-\frac{Q+2}{p}})^p dx dt \right)^{1/p} \\ &\leq \tilde{C} \sum_{j=0}^{\infty} \left(\int_{\mathcal{Q}_{\frac{r}{2^j}} / \mathcal{Q}_{\frac{r}{2^{j+1}}}} |(x, t)|^{2p-Q-2} dx dt \right)^{1/p} \\ &\leq \tilde{C} \sum_{j=0}^{\infty} \left(\frac{r}{2^{j+1}} \right)^{2-\frac{Q+2}{p}} \left(\frac{r}{2^j} \right)^{\frac{Q+2}{p}} \\ &\leq \tilde{C}r^2 \sum_{j=0}^{\infty} \left(\frac{1}{2^j} \right)^2 \end{aligned}$$

$$\leq Cr^2.$$

Since $\frac{Q+2}{p} < 1$,

$$\frac{\|u - P_*\|_{L^p(\mathcal{Q}_r)}}{r^{1+\beta+\frac{Q+2}{p}}} \leq \frac{Cr^2}{r^{1+\beta+\frac{Q+2}{p}}} \leq Cr^{1-\beta-\frac{Q+2}{p}} \rightarrow 0 \text{ as } r \rightarrow 0$$

for some β chosen small enough. Since $f \in C_{p,0}^\alpha(0,0)$, $f \in \Gamma^\alpha(0,0)$ by Proposition 3.16, and so $|f| \leq Cr^\alpha$ on \mathcal{Q}_r . Then

$$\|f\|_{L^p(\mathcal{Q}_r)} \leq Cr^{\alpha+\frac{Q+2}{p}}.$$

This is exactly what is needed to satisfy hypotheses in Theorem 4.6. The conclusion

$$(4.63) \quad \|u - P_*\|_{L^p(\mathcal{Q}_r)} \leq Cr^{2+\frac{Q+2}{p}}$$

gives enough of a decay gain to satisfy hypothesis on $u - P_*$ in Theorem 4.8 where $d = 2$.

We also need to satisfy the hypothesis on f . To do this, we once again use

$$\|f\|_{L^p(\mathcal{Q}_r)} \leq Cr^{\alpha+\frac{Q+2}{p}} \leq Cr^{\frac{Q+2}{p}}.$$

Now Theorem 4.8 reads that if $f \in C_{p,l}^\alpha(0,0)$ and $a_{ij} \in C_{p,l}^\alpha(0,0)$, then $u - P_* \in C_{\infty,2+l}^\alpha(0,0)$.

Moreover,

$$(4.64) \quad \sum_{|I|+2h=1}^{2+l} |X^I D_t^h(u - P_*)(0,0)| + [u - P_*]_{\infty,\alpha,2+l} \leq C(\|u - P_*\|_{L^p(\mathcal{Q}_1)} + \sum_{|J|+2m=0}^l |X^J D_t^m f(0,0)| + [f]_{p,\alpha,l}(0,0))$$

Let $l = \tilde{d} - 2$ to get the final result. □
