### DEWITT ISSUES NEW ORDER TO EXAMINE INCOMING PACKAGES

#### THE BATTLE AGAINST INFLATION

Nations at war discover that they are fighting not only on the battlefields, but also at home. The battle of armies depends upon the battle of production. And the battle of production depends upon waging a successful battle against inflation.

Money by itself, of course, has no value; its value consists only in what it can buy. In wartime money tends to lose in purchasing power because more money is in circulation as a result of vast government spending. If it were possible to increase the supply of civilian goods to keep up with the growing supply of money, inflation could be prevented.

The purchase of war bonds is one method of taking money out of circulation. Increased taxes provide another way. The limiting credit through restrictions on charge accounts and installment buying is another.

Still the cost of living has gone up. From January to May it increased fifteen percent, and it is still rising.

The largest item in most family budgets is for food. So long as farm prices are allowed to rise beyond parity, workers will demand increased wages to meet their rising cost.

Contraband inspection for all packages destined for delivery to all evacuee residents of Poston was announced today by Lieut. Gen. John L. DeWitt of the Fourth Army Command. Inspection will be applicable to all packages, irrespective of the method of delivery, and will be inclusive for all parcel post and express material.

#### WORK PERMIT IS REQUIRED FOR MINORS

That all minors between the ages of 14 to 18 years who are attending schools must immediately secure Work Permits from the Board of Education before being employed, was announced by Vernon R. Kennedy, Chief of Empl. in accordance with the WRA Administrative Instruction No. 27, Supplement 1, in effect from yesterday. The regulation as announced by the Authority, drawn up in cooperation with Children's Bureau of Dept. of Labor, requires that 14 (Continued on Page )

#### ATTENTION: "MRS. SUE"

The young lady mentioned is about 5 ft. tall, and wears glasses who is now working as assistant dietician in the kitchen where food is being planned and cooked for the babies.

The letter is awaiting for "Mrs. Sue" at the Press Bulletin from Mrs. Groothaert.

Specific contraband items include:

- Firearms, weapons or implements of war or component parts thereof including ammunition, short wave radio sets having a frequency of 1750 kil. or greater or of 540 kil. or less, radio transmitting sets, codes, cyphers or cameras.

In making the announcement, the army stressed these points:

1. First Class mail will not be inspected.
2. Magazines, periodicals, newspapers and books printed in the English language and by American publishers and transmitted as second class mail by the original publisher will not be inspected.

In operating the Inspection Office, the following procedure will be observed:

Each package will be opened in the presence of the addressee. All contraband items will be labeled and plainly marked, showing the addressee's name and the name of the sender. A receipt will be issued the addressee for each item of contraband removed, and all such confiscated items will be (Continued on Page )

years is the minimum work age; 16 years-minimum for factory employment; 18 years-minimum for hazardous employment; that minors cannot work between 9 p.m. and 6 a.m. and must have uninterrupted 12 hours free period daily.

Minors will be paid on basis of work performed, that is, basis of part time rate, calculated from the regular rate of 50¢ a day (8 hours) for Group 1, and 80¢ a day for Group 2, and 80¢ a day for Group 3. Combined school hours and work hours shall not exceed 8 hours a day or 40 hours a week.

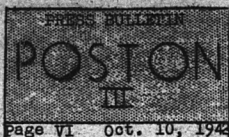
