on the proposal from the Commission of the European Communities to the Council (Doc. 1-44/80) for a regulation laying down for 1982 certain measures for the conservation and management of fishery resources applicable to vessels flying the flag of Spain

By letter of 18 March 1982 the President of the Council of the European Communities requested the European Parliament, pursuant to Article 43 of the EEC Treaty, to deliver an opinion on the proposal from the Commission of the European Communities to the Council for a regulation (EEC) laying down for 1982 certain measures for the conservation and management of fishery resources applicable to vessels flying the flag of Spain, and requested the application of urgent procedure pursuant to Rule 57 of the Rules of Procedure.

The President of the European Parliament referred this proposal to the Committee on Agriculture as the committee responsible.

On 1 April 1982 the Committee on Agriculture appointed Mrs Péry rapporteur.

It considered this proposal at its meeting of 31 March and 1 April 1982.

At the same meeting the committee unanimously adopted the motion for a resolution.

The Committee on Agriculture hereby submits to the European Parliament the following motion for a resolution:

MOTION FOR A RESOLUTION

embodying the opinion of the European Parliament on the proposal from the Commission of the European Communities to the Council for a regulation laying down for 1982 certain measures for the conservation and management of fishery resources applicable to vessels flying the flag of Spain.

The European Parliament,

- having regard to the proposal from the Commission of the European Communities to the Council (COM (82) 86 final),
- having been consulted by the Council pursuant to Article 43 of the EEC Treaty (Doc. 1-44/82),
- having regard to the report of the Committee on Agriculture (Doc. 1-90/82),
- having regard to the agreement on fisheries concluded between the EEC and Spain on 15 April 1980¹,
- whereas the Community and Spain have reached agreement on reciprocal fishing rights for 1982,
- 1. Approves the Commission's proposal;
- 2. Invites the Commission to propose measures to ensure that fishing vessels from third countries, in particular Spanish fishing vessels, do not circumvent the fishing agreements concluded by the Community with their countries by seeking registration in a Community Member State with coastal waters;
- 3. Urges the Commission to ensure that third countries respect the present arrangement in the regrettable absence of a common fisheries policy and of better coordination of the Member States' inspection operations in Community waters;

- 4. Invites the Commission also to report to it on the progress of negotiations on the accession of Spain to the Community with particular reference to the specific question of fisheries, and to comment specifically on
 - (a) the state of fish stocks in which there is common interest, particularly stocks of hake, in the North Atlantic, including the Bay of Biscay,
 - (b) the market outlook for each party in the event of the accession of Spain to the Community,
 - (c) the importance of fisheries for the Spanish economy,
 - (d) measures for the reorganization of the Spanish fishing fleet which could be considered by both parties at the present stage,
 - (e) the desirability of granting 'pre-accession' aid to Spain to enable it to reorganize its fishing fleet;
- 5. Considers that in the interests of both parties the Community must clarify its relations with Spain on the question of fisheries, regardless of whether Spain accedes to the Community.
