

## **$\alpha$ -Sutte Indicator : Suatu Pendekan Baru dalam Peramalan Data**

**$\alpha$ -Sutte Indicator ( $\alpha$ -Sutte)** merupakan pengembangan dari Sutte Indicator. Sutte Indicator dapat digunakan untuk memprediksi pergerakan saham. Sejalan dengan perkembangan ilmu pengetahuan, maka Sutte Indicator kemudian dikembangkan tidak hanya untuk memprediksi pergerakan saham tetapi juga dapat meramalkan data dalam bidang keuangan, asuransi, dan data time series lainnya. Pengembangan dari Sutte Indicator ini kemudian dikenal dengan nama  **$\alpha$ -Sutte Indicator ( $\alpha$ -Sutte)**.

**$\alpha$ -Sutte** dikembangkan menggunakan prinsip metode peramalan yaitu menggunakan data sebelumnya.  **$\alpha$ -Sutte** diadopsi dari metode moving average. Moving Average yang digunakan adalah Simple Moving Average-2 (SMA2). SMA2 ini digunakan untuk melihat trend data. Selain itu,  **$\alpha$ -Sutte** juga menggunakan 4 data sebelumnya ( $X_{t-1}$ ,  $X_{t-2}$ ,  $X_{t-3}$ , dan  $X_{t-4}$ ) dengan asumsi bahwa 4 data sebelumnya berpengaruh terhadap prediksi data berikutnya.

Adapun rumus dari  **$\alpha$ -Sutte** sebagai berikut :

$$a_t = \frac{\alpha \left( \frac{\Delta x}{\alpha + \delta} \right) + \beta \left( \frac{\Delta y}{\beta + \alpha} \right) + \gamma \left( \frac{\Delta z}{\gamma + \beta} \right)}{3}$$

dimana :

$$\delta = a_{t-4}$$

$$\alpha = a_{t-3}$$

$$\beta = a_{t-2}$$

$$\gamma = a_{t-1}$$

$$\Delta x = \alpha - \delta = a_{t-3} - a_{t-4}$$

$$\Delta y = \beta - \alpha = a_{t-2} - a_{t-3}$$

$$\Delta z = \gamma - \beta = a_{t-1} - a_{t-2}$$


$a_t$  = data pada waktu ke-t

$a_{t-k}$  = data pada waktu ke-( $t - k$ )

Berikut hasil uji coba yang dilakukan dengan menggunakan  **$\alpha$ -Sutte**.




