## Washington Campus Program—1982

Five students from F. E. Seidman College of Business and Administration have been selected to participate in the Washington Campus, a month-long summer program offering students an opportunity to study business-government relations in Washington, D.C.

Lewis Carlson, Teresa Ereon, Brian Lundgren, Theresa Orlaske, and Chuck Wattles will attend classes in the nation's capital from May 20 through June 16. Their courses will cover subjects includ-

ing domestic and international economic policy, government regulation, policy development in the elective branch, and Congress, lobbying and interest groups.

Grand Valley is one of 13 colleges in the Washington Campus consortium, which was founded in 1978 as a non-profit educational organization offering intensive study in business-government relations. A total of 75 students from the 13 colleges will participate in two four-week sessions offered in Washington this summer.
