lowa is bordered by two "coasts," the Mississippi and Missouri rivers. These two coasts are an economic and environmental resource of enormous proportion. The nearly 500 miles of the Mississippi and Missouri rivers along lowa's borders are open for commercial navigation and provide safe, efficient and effective transportation for over 9 million tons of lowa products, primarily the state's agriculture production. These rivers, and the terminals along them, are a gateway for lowa to the extensive 12,000-mile inland waterway system that has access to ports throughout the country, and ultimately the world. Over 60 percent of the U.S. corn and soybean exports move on the river system through the Gulf to foreign markets.
