DOING BIBLIOMETRIC REVIEWS FOR THE IBEROAMERICAN JOURNAL OF STRATEGIC MANAGEMENT

The editorial comments published in the Iberoamerican Journal of Strategic Management are intended to help researchers and students to improve their articles. These editorial comments include content and suggestions about writing, publishing and reviewing articles, as well as methodological issues. In this new editorial comment, we will present our views on bibliometric studies. BIBLIOMETRIC STUDIES - COCITATION AND BIBLIOGRAPHIC COUPLING

Scholars seek to understand and make logical sense of knowledge produced through the evolution of disciplines and research themes (Ferreira, Pinto & Serra, 2014). There are many ways to prepare reviews (Paré et al., 2011). In

addition to other possibilities, extant research works can be measured using objective methods, such as bibliometric methods (Ferreira, Pinto & Serra, 2014). Bibliometrics can be used as an indicator of scientific research performance (e.g., Phelan, Ferreira & Salvador, 2002). It can also be used, in less descriptive works, to trace the intellectual structure and mainstream of current research trends (Vogel, & Güttel, 2013). In the latter case, bibliometrics can be used to conduct a more structured literature review, including information and identifying patterns in a field, theme or phenomenon (Zupic, & Čater, 2015).

Bibliometric analyses are used to investigate several fields of research, including strategic management (Table 1). Ramos-Rodriguez and Ruiz-Navarro (2004) and Nerur, Rasheed and Natarajan (2008) investigated the intellectual structure of strategic management research. Shafique (2013) investigated the intellectual structure of innovation in a strategic perspective.

As shown in Table 1, most studies published in renowned journals predominantly use the cocitation method supported by multivariate quantitative methods. Bibliographic coupling works are also growing in number.

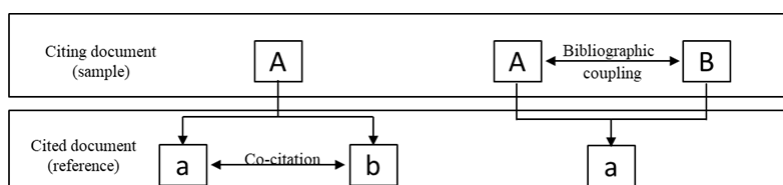


Figure 1 - Cocitation and bibliographic coupling

Figure 1 illustrates the difference between cocitation and bibliographic coupling (Vogel, & Güttel, 2013). Cocitation allows a measurement of how frequently a pair of articles are cited together (McCain, 1990). Cocitation analysis is a measurement that changes over time as a field evolves. It is useful for detecting paradigmatic changes and schools of thought (Zupic, & Čater, 2015). Cocitation analysis is a method that reflects the past influence of the research field. It is related to the impact of publications. Cocitation represents the knowledge basis of the field (Gregoire et al., 2016), and citation analysis is usually used together with cocitation analysis, as both use the references of a work. It identifies the most influential works on the assumption that the more contributions a work makes to a theme, the more it will be cited (McCain, 1990).

Bibliometric coupling is also a measure of similarity, but is based on the frequency that two documents from the sample share at least one common reference, i.e., the documents of a sample are grouped in accordance with the overlapping of its bibliographies (Vogel, & Güttel, 2013; Zupic, & Čater, 2015). The higher the number of references shared by two documents in a sample, the greater the similarity between them (White, & McCain, 1998; Vogel, & Güttel, 2013). Bibliographic

coupling results change slightly over time and reflect the evolution of research, rather than its impact (Vogel, & Güttel, 2013). Bibliographic coupling is useful for detecting tendencies and possible paths to a field, and is related to publication. Bibliographic coupling indicates the research front in a field (Zupic, & Čater, 2015). Zupic, & Čater (2015) and suggests some research questions to guide bibliometric studies (Table 2).

The aforementioned methods produce different results using empirical evidence, but are complementary (Janervig, 2005). Vogel and Güttel (2013) suggest that researchers dedicated to a research field should not focus only to the mainstream of their field, but also to the “newstream”. These works can be identified using bibliographic coupling. The “newstream” may reveal “tomorrow’s classics”. In spite of the traditional use of cocitation techniques in bibliometric studies (Zupic, & Čater, 2015), bibliographic coupling is interesting when it comes to understanding growing fields of publication (Vogel & Güttel, 2013).

The use of cocitation and bibliographic techniques supported by multivariate methods does not replace the need for extensive reading of works (Zupic & Čater, 2015). The bibliometric method used as a review may be considered a mixed method (see Creswell, 2014).

Bibliometric methods will often reveal the structure of a field differently from

the classification of traditional literature reviews, so these differences need to be reconciled. Science maps provide a starting point for analytical examination but are not an end in itself. Interpretation strategies in bibliometric analysis are dependent on the focus of the paper authors are writing.

METHODOLOGICAL SEQUENCE SUGGESTED

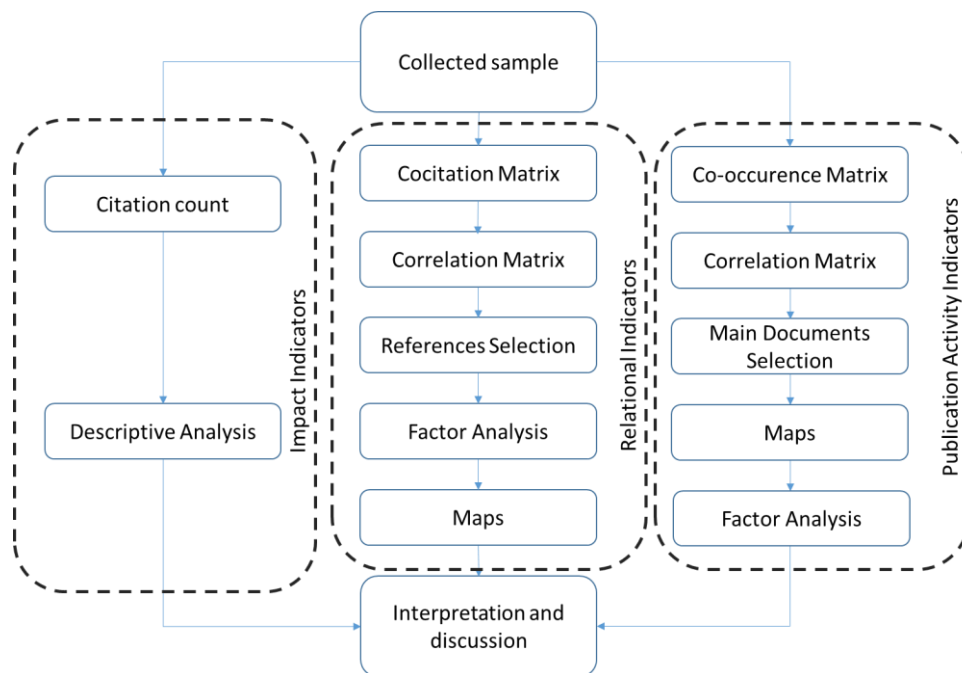


Figure 2 - Citation, cocitation and bibliographic coupling methods.

Figure 2 summarizes the methodological sequence suggested for bibliometric studies of cocitation and bibliographic coupling. It is an adaptation of the method used by Ramos-Rodriguez and Ruiz-Navarro (2004), with the inclusion of the bibliographic coupling proposed by Vogel and Güttel (2013).

Data collection and sample

Two databases are normally used to collect information for bibliometric studies: Web of Science and Scopus. Both are important because of their wide coverage of social science publications, as they index the main international periodicals in the field. Despite the existence of works that examine a field through specialized journals, e.g. the article of Ramos-Rodriguez and Ruiz-Navarro (2004), which examined the articles published in the Strategic Management Journal using cocitation, we usually conduct a search using words or terms related to the subject we wish to investigate. This is a sensitive step, as the words must cover the topic but avoid being too broad in scope, making it difficult to filter the articles for the final sample. We also suggest using “*” after incomplete words to search for variations of the word. For example, Vogel and Güttel, 2012 (p. 5) used the term “dynamic capabilit*” to search the titles, abstracts and keywords of the Social Science Citation Index of Web Science in their work.

Even with carefully selected terms for searching and refining by field in the database (e.g., Business and Management), there is the possibility that articles not related to the research topic will be automatically selected. To reduce the sample bias, and guarantee the validity and reliability of the selected studies, the authors must define the criteria for the inclusion of articles in their sample (Zupic,

& Čater, 2015), as the filtering of the sample is not automatic. We suggest that this filtering should be done by at least two of the authors independently through the reading of the title, abstract and introduction of the works. Whenever the authors do not agree, we suggest that they should read the article together.

Analysis procedures

In our procedure, we suggest the use of the Bibexcel software for information extraction and organization (Persson, Danell, & Schneider, 2009). The software extracts and organizes information from the databases to enable different possibilities of bibliometric study objects (authors, keywords, references, year of publication, journal, etc.) in excel sheets. This primary information must also be reviewed by the researchers, as the references may not be uniform. We use the year of publication to evaluate the growth of the theme (see Figure 3 for an example) and the frequency of publication to research citation. The software also generates the co-specific occurrence matrix to investigate cocitation and bibliographic coupling. These matrices have the same references in both rows and columns, with frequency of co-occurrence in the cells, which can be considered a measure of similarity (e.g., Bernard & Ryan, 2010). The matrices can be used as input for exploratory multivariate analysis (Bazeley, 2010), in this case,

either for the EFA or the network analysis. Through statistical analyses, large quantities of bibliographic data can be gathered, which are more complex in uniquely qualitative reviews (Vogel, & Güttel, 2013; Zupic, & Čater, 2015).

The citation analysis is the first procedure we suggest should be conducted. With this procedure, the authors can identify the most cited, i.e., the most representative, works in the field. The citation analysis shown reflects how frequently works are referenced in other works (Vogel, & Güttel, 2013). The sample cut regarding the quantity of references is done regarding Lotka's law of bibliometrics, that very few articles (around 5%) would be representative of the field (Nath, & Jackson, 1991). It should be highlighted that Bibexcel software is used to extract the references (Pilkington, 2006). Usually, in established fields no more than 50 cited references would represent between 5 and 10% of the total citations.

The cocitation co-occurrence matrix using the selected references is extracted using Bibexcel software (Persson, et al., 2009). To continue with the analysis, we suggest the use of EFA, since it is the most common clustering method in bibliometrics (McCain, 1990; Zupic, & Čater, 2015), as shown, for example, in Table 1. The matrix should be converted into a Pearson correlation matrix used as factor analysis input. The factor analysis can be run with statistical packages such as SPSS or R. We also suggest considering the diagonal of the matrix as null, a simplification that will not change the results (White, & Griffith, 1981; Charvet et al., 2008). We propose that the extraction of factors using the principal components method, with Varimax rotation (Lin, & Cheng, 2010) and Kaiser normalization, retaining factor loading greater than or equal to 0.40, be maintained. We attribute the documents with cross-loadings¹ to the factor in which their loading was greater (Vogel, & Güttel, 2013). As we used an exploratory factor analysis, we suggest the use of an alternative method to increase the robustness of the results (Zupic, & Čater, 2015), in this case the network analysis obtained using Ucinet (Borgatti et al., 2013).

Bibliographic coupling uses a similar co-occurrence matrix, in this case with the articles that shared references. The procedure is equivalent to that presented for cocitation, but in this case, to cut the sample we restrict the articles using the number of ties with the help of Ucinet network software. As a hypothetical example, suppose you have a sample of 160 documents. Examining them using the

network software, you maintain the documents with at least seven couplings (ties ≥ 7). If this results in a matrix of 70 documents, it would represent a high percentage of the total sample, and would be well represented graphically, enabling reading and content analysis together with the EFA.

For both co-citation and bibliographic coupling, we must name and present the factors through a detailed analysis of the works' content. The argument for each factor must present the central idea that the group of references is representing. We suggest following the recommendations of Denyer and Tranfield (2009) for systematic literature reviews.

SCRIPT FOR COCITATION AND BIBLIOGRAPHIC COUPLING BIBLIOMETRIC STUDIES²

Through this script, we now present the suggested procedures for preparing cocitation and bibliographic bibliometric studies. This script is reproduced in Portuguese in Appendix 1 of this editorial comment.

To begin, it is necessary to download the Bibexcel software from the following link:

Bibexcel is an extractor software. It extracts from your sample the desired information using SSCI abbreviation (check Table 3 in Step 3). The software only runs in MS Windows. It will only extract the first author of the works.

Step 1 – WEB OF SCIENCE (WoS) or Scopus

Access, considering Brazil, through the CAPES portal or other option available in your school's digital library.

- Select data base / WoS or Scopus
- Search
 - Select the field you are going to search:
 - Options: topic, author; group of authors, editor, name of the publication, DOI, year of publication, address.
 - “topic”: search for the keyword in the title, abstract and KW.
 - Insert words for search.

¹ It is important to note that the cross-loadings of the EFA are important to the interpretation of the results regarding the influence of one factor on another.

- Booleans (And, Or, Not).
- “*” in the keyword: enables a search for all variations of the word using the asterisk.
- Select the limits of the search.
 - Time frame;
 - Data bases;
 - Field of study;
 - Type of document.

Step 2 – Options for refining results

Options: research areas, types of documents, authors, editors, source title, conference title, year of publication, idioms, countries/regions, impact factor (WoS - JCR).

Step 3 – Save the search

Identifying the selected articles. Click on “Add to the marked list”, then follow one of the options:

- a. Mark individually (frame in front of each article) or
- b. “All pages” (frame in the top, the left of the page), or
- c. Specify the register to be sent.

Observe the field “marked list” to the quantity of the register selected.

- d. Registers with already in the list.
- e. There are no duplications of loading for specific load of “marked list”.

Click on “marked list”:

- f. Select “Main collection of WoS”;
- g. Verify if the fields are marked:
 - i. Abstract;
 - ii. References cited;
 - iii. Keywords;
 - iv. Allow the remaining marked.

Export the registers:

- h. Select “send by e-mail”;
- i. Inform the address in the field “Up to”.
- j. Describe the search in “notes”.
- k. It is only possible to send 500 articles at a time.

4. Procedure – Bibexcel

- Copy the generated file from the e-mail, selecting from PT J up to EF and paste into the software notepad;
 - i. Always begin with PT J and finish with ER. The selection ends with EF.
 - ii. There is no space at the end between ER and EF (remove the blank line).
- Save with name up to 15 letters (.txt);
- Pattern ANSI;
- Create a file .xlsx for future enquiry;
- In searches with more than 500 articles, the resulting files must be integrated as follows, example for a search with 1,500 articles:
 - i. Archive 1 (from article 1 to 500) the letter EF to the end of the file must be erased;
 - ii. Archive 2 (from 501 to 1000) the content must be pasted at the end of Archive 1. Erase the letters EF at the end;
 - iii. Archive 3 (1001 to 1500) paste the content at the end of Archive 1;

5. Bibexcel (to Scopus see Note 3)

- All the files generated by Bibexcel are compatible with Excel.
- Open Bibexcel;
- In the box “Select file here” click on the .txt file (step 4) and then on “View file”;
- Visualize the content in the box “The list”;
- Go to “Misc” on the upper side command bar:
 - i. “Convert to dialog...”;
 - ii. Click on “Convert from Web of Science”;
 - iii. Click on “Plain text”, OK, YES;
 - iv. A .doc file is generated, as shown in the box “The box”;
- Select the generated .doc file and click on “View file”;
- Insert in “Old tag” the legend referring to the field to be selected (for the searches in citation and cocitation, CD (usual) or CR, depending of the field in .doc);
- Any other tag may be inserted at “Old tag”, depending on what we wish to extract from the sample. So: AU to

- authors, SO to journals and PY year of publication, etc.
- In “Select field to be analyzed...”, opt for “Any; separate field”, then click on “Prep”, then on OK and Yes.
 - i. The .out file will be generated (list of references by article for all the sample)
 - ii. .out to .1st – edit out files > keep only authors first initial
 - iii. .1st to .low – edit out files > convert upper lower case > good for cited references strings
 - At the field “Frequency distribution” mark “Sort descending”.
 - i. At the white bar select the option “Whole string”;
 - ii. Click on “Start” and OK;
 - iii. The .cit file will be generated;
 - iv. The .cit file must be used for citation analysis.
 - Select the .cit file and click on “View file”.
 - i. In “The list” will appear the content of the archive with the frequency of occurrence of the information required in descending order;
 - ii. .cit correction – see Note 1. This correction must be made.
 - iii. Cocitation and bibliographic coupling?
 - a. Cocitation: go to 6.1;
 - b. Bibliographic coupling: go to 6.2
 - iii. A dialog box will appear, click on NO and on OK.
 - iv. A .coc file will be created;
 - “View file” of .coc file
 - i. In “Analyze” on the upper side bar, click on “List units in pairs”;
 - ii. In the dialog box, select OK;
 - iii. A .ccc will be created;
 - “View file” of .ccc file;
 - Select the .coc file, but **do not click** on “View file”;
 - i. In “Analyze” on the upper side bar, click on “Make a matrix for MDS etc”;
 - ii. In the dialog boxes, click sequentially on:
 1. OK
 2. NO
 3. YES
 4. YES
 5. NO
 6. Finally, on OK
 - iii. The .ma2 is generated. This is the cocitation matrix that will be used in Excel. Sums of lines and columns: individual frequency of cocitation.
 - iv. The crossing of line and column represents the counting of co-occurrences.
 - v. This file is a symmetric matrix with a null diagonal.
 - vi. The value represents the frequency of co-citation between the woks in a determined line and column.
 - vii. The .ma2 file, in .xlsx format (item 7) is the *input* for SPSS and Ucinet/Pajek.

6. Cocitation and bibliographic coupling analysis.

6.1 Generation of the cocitation matrix

- In the box “The list”, select the .cit file (already corrected), the sample that will be used in the matrix – the amount of lines and columns of the square matrix.
 - i. Go to “Analyze” on the upper side bar;
 - ii. Then in “Co-ocurrence”, click on “Select units via listbox”;
- Select the .low file, but **do not** click on “View file”.
 - i. Go to “Analyze” on the upper side bar;
 - ii. Then in “Co-ocurrence”, click on “Make pairs via listbox”;

6.2 Bibliographic coupling analysis

- Select the .low file, but **do not** click on “View file”.
 - i. Go to “Analyze” on the upper side bar;
 - ii. In “Shared units/coupling”, click on “Shared units”;
 - iii. A dialog box will appear, click on NO and then on OK.
 - iv. A .cou file will be created;
- “View file” of the .cou file
 - i. In “Analyze”, on the upper side bar, click on “List units in pairs”;
 - ii. In the dialog box, select OK;
 - iii. A .ccc file will be generated;
- “View file” of the .ccc file;

- Select the .cou file, but **do not click** on “View file”;
 - i. In “Analyze”, on the upper side bar, click on “Make a matrix for MDS etc”;
 - ii. In the dialog boxes, click sequentially on:
 1. OK
 2. NO
 3. YES
 4. YES
 5. NO
 6. Finally, on OK
 - iii. The .ma2 file is generated, the bibliographic coupling matrix, and will be used in the Excel. Sum of lines or columns: individual frequency of bibliographic coupling.
 - iv. This file is a symmetric matrix with a null diagonal.
 - v. The values represent the frequency of bibliographic coupling between the works of a determined line and column.
 - vi. The .ma2 file, in .xlsx format (item 7) is the *input* for SPSS and Ucinet/Pajek.

7. Preparation of the bibliographic coupling matrix:

- Open the .ma2 file in Excel;
- Insert the column before column “A”;
- It is necessary to edit the labels of line “1”, inserting the authors of the work once in the collection, the WoS only informs the first author. Only authors and year must be kept as the label for the bibliographic coupling matrix, erasing the remaining information;
- Select and copy line “1”;
- Paste special in columns “A”, from line “1”, mark option “Transpose”;
- The bibliographic coupling matrix indicates the reference sharing between articles;
- Attention: the labels of the columns must be equal to the labels of the lines.
- The spreadsheet generated here will be used for the procedures of multivariate statistics and to prepare the networks.

Notes

1 – Correcting the .cit file (necessary)

We suggest the following process for the correction:

- Open the .cit file and .out in Excel;
- In the .cit file: select the lines (number of citation and authors) that will be used in the research;
- Change the color of the cells of the selected references (.cit file).
- Insert a line before Line 1 and put Excel filter;
- Classify the .cit file in alphabetical order by author (by inserting the filter or by “Data/classify/A-Z”).
- Analyze whether there are occurrences not colored that should be included.
- Correct the .out (or .low) file, previously ordered in alphabetical order, the same way as for the .cit file. The correction of both files must be identical. It must begin with .cit to direct the corrections to the more important references. The main motives for these occurrences are the different abbreviations for the same observations (author/article/journal).
- Return the .out and .cit to their original format – without filter and ordered by author.
- Return to procedure 5 (Bibexcel).
- Proceed to the generation of the new .cit, which will be created with a corrected grouping of citations/authors.

2 – General sequence

Search WoS → .txt → .doc → .out → .lst → .low → .cit → .coc / cou → .ccc → .ma2 → .xlsx → SPSS → Ucinet/Pajek. Pesquisa WOS → . Txt → ...

3 – For **Scopus** files, use in MISC: Convert from Scopus RIS format. Sometimes a “carriage return” is requested. It is only necessary to follow the steps indicated by Bibexcel.

4 – When the research is conducted in **WoS** and **Scopus**, the bases may be unified in the .out file. Care should be taken with the duplication of articles and using the first column, number of order of the article to eliminate this duplicity.

5 – To use in other database, the articles should be inserted manually.

6 - Bibliometric coupling is executed without sample cutting criteria, regarding cocitation. It is necessary to pre-establish a criterion to cut the articles. This may be done using the co-occurrence matrix. We suggest the use of nodes from the

network, as was the case in Vogel and Güttel, 2013.

FINAL COMMENTS

In this editorial comment, we set out to share our accumulated experience in bibliometric studies. We are suggesting and presenting a script to help researchers with their bibliometric studies of

cocitation and bibliographic coupling supported by multivariate analysis, using EFA and network analysis (MDS is also included in the script).

We presented fundamental information regarding the method. Despite the possibility of preparing the data for bibliometric analysis, it is important to reinforce the need to read and interpret the content. Review articles using bibliometric analysis, like any other, should be supported by strong arguments and make a contribution to the field.

- Mudar cor das células que foram as referências selecionadas (no arquivo .cit).
- Inserir linha antes da linha 1 e colocar filtro do excel;

- Classificar o arquivo .cit em ordem alfabética por autor (por meio da inserção de filtro ou por "Dados/classificar/A-Z").
- Analisar se há ocorrências não coloridas que deveriam estar contidas nas observações coloridas.
- Corrigir o arquivo .out (ou .low), já previamente ordenado em ordem alfabética, da mesma forma que feito no .cit. As correções em ambos os arquivos devem ser idênticas. Inicia-se com o .cit para direcionar as correções para as referências mais importantes. 5 – Desconheço a viabilidade para outras bases de dados.

6 - O pareamento é executado sem o critério de corte nas citações como na cocitação. Portanto, é necessário estabelecer um critério para corte das referências (artigos). Pode ser feito usando a matriz de coocorrência. Sugerimos a utilização uso número de laços e de nós, como Vogel e Güttel, 2013.
