Gardner-Webb College has been named a Bicentennial Campus by the American Revolution Bicentennial Administration. The designation was made following approval of the college's proposed bicentennial program by the ARBA. The far-reaching program was created during the summer by a 12 member steering committee of students and faculty headed by Mr. Lansford Jolley, Chairman of the Department of Social Sciences. The proposed activities are arranged under one of three general themes developed to emphasize the growth of the nation. Heritage '76 focuses on America's past; Festive U.S.A. highlights the country's pageantry and spirit of hospitality; Horizons '76 looks to the future. "By covering the complete spectrum from the past to the future we hope to give citizens an opportunity to rediscover the ideals that made our nation great," explained Jolley.

Student enrollment for the Fall semester is 1419. This represents a drop of 11% in enrollment from the record setting student body of last fall. After close examination it has become apparent that the drop is in freshmen from the areas of North Carolina whose economy is based on the textile and furniture industries. With the projected improvement in the economy in these areas, it is hoped that this problem will soon be eliminated.

Those were the days . . . This feature of the WEB which was introduced in the last issue drew correct responses from approximately 20 Alumni. The picture was, of course, the 1964-65 Cheerleaders. The winner of the two reserved football tickets for Homecoming was Mrs. Teresa Hamrick Huggins of the Class of 1953 who submitted the first correct entry.

Mr. Hanson D. Powers who taught science and coached men's sports at Boiling Springs High School from 1930-32 has given a personal gift to initiate the J.D. Huggins Memorial Loan Fund. The loans from this program are designated for "worthy and needy students who are capable of making a meaningful contribution to society upon the completion of their work at Gardner-Webb College". Mr. Powers is requesting that others join him in showing their love and respect for Professor Huggins by sending a gift to the Alumni Office designated for the J.D. Huggins Memorial Loan Fund.

During the recent Founders' Day celebration, a Scroll of Honor was unveiled honoring the Shareholders in GWC Development campaigns since 1969. The beautiful scroll will hang in the John R. Dover, Sr. Library as a permanent tribute to these dedicated Friends of the College.

# New Campaign Begins

*NEW CONSTRUCTION NEEDS \$4,000,000*

Gardner-Webb has recently launched a campaign to improve living and learning facilities for students. The administrator of the campaign, Mr. Bill Briggs, Coordinator of Development, and the workers in the campaign hope to raise \$10 million needed to accomplish their goals, by 1980.

The \$10 million is divided into three main financial goals. They are, endowment needs, new construction needs, and resource and equipment needs.

Endowment needs take up \$5 million of the proposed \$10 million. These needs include \$2 million for operations. Operations involve the upkeep and continuance of the physical plant, and maintenance.

A second use of endowment needs is for student financial aid which takes up another \$2 million. Financial aid includes \$1 million for endowed scholarships and \$1 million for a revolving loan fund.

The last \$1 million of endowment needs is to be used for the salaries of faculty members. Salaries are some-

what below the national average. Not only do salaries need to meet the average and stay with or above it, but senior faculty needs to be rewarded for many years of service.

The second aim of the campaign is entitled "new construction needs". The four buildings proposed total approximately \$4,000,000.

The special events building, costing \$2.5 million, is to be used for various activities of the college, such as large religious, cultural, and athletic events. It is to be large enough to hold a gathering of both the Gardner-Webb student body, faculty, staff, and the public.

The residence hall complex (\$500,000) is being planned of modular construction to provide easy expansion in response to demand. The apartments will be convertible to family living units also.

The School of Business building is being planned due to the fact that the present Business Department is outgrowing its facilities. With more industry moving into this area, the

Two basic objectives will be met once the foregoing needs are realized. First, the College will be able to provide an educational opportunity of uniformly high quality through improved academic facilities and enlarged instructional resources. Second, the College will be able to assure those students who want to enroll the chance to do so regardless of circumstances.

Hopefully, a substantially enlarged endowment fund points the way to complete independence for Gardner-Webb. One day soon deserving students will find College resources entirely adequate to assist them, rather than having to rely on government tuition grants.

An aim such as this sets Gardner-Webb apart from others. It reflects a true commitment to a proud and free heritage.

Business Department is expected to grow even more. It will cost \$600,000 and be annexed to Lindsay building.

The Science Building addition, costing \$400,000, will be added to the present Withrow Science Building. The present building was designed to serve a student body of 800 and since that figure has doubled, more space is needed.

The third financial goal, resource and equipment needs, totals \$1 million.

Building and equipment improvements will require \$500,000. Some classroom buildings need to be air-conditioned. Also, new equipment needs to be purchased and installed, especially in the new proposed classroom buildings.

Dover Library acquisitions will take up \$250,000. Basic research works, up-to-date periodical holdings,

and a wider selection of recording and audio-visual materials need to be purchased in order for Gardner-Webb to keep up to senior college standards.

The remaining \$250,000 is to be used for landscaping, roads, and tennis courts.

## College Friends Regroup

(The following note was recently received by the Alumni Office. It describes a *memorable* relationship which was developed at Gardner-Webb and which has endured the years. We are happy to share it with you.)

Recently at Myrtle Beach, South Carolina, a group of former Gardner-Webb classmates and their wives and husbands had occasion to find out what a decade and a half does to college friendships. The group members tempered their enjoyment of the weekend of sand and surf with a healthy amount of reminiscing. To their pleasant surprise, "the gang" found that the years had drawn them closer together, especially their appreciation for the experience of Gardner-Webb College. The conversation returned again and again to those influences which the college stamped indelibly upon their lives. Each member agreed that the deep religious commitment sustained over the years was a particularly strong bond that had seen them through many personal crises.

Here were a dozen lives—unusually diverse in all other respects—but bonded together by one powerful formative experience: Gardner-Webb College. All felt the influence of that steadfast institution at a time when their identity was being hammered out in the midst of the painful turbulence of their adolescence. There was no lamenting that they had been denied the liberties of such modern collegiate innovations as: coed dormitories, unrestricted visitation privileges and relaxed curfews. Where else but at Gardner-Webb College would a group of students join in a funeral procession through downtown Boiling Springs, mournfully following a motorcycle bearing a satin-lined casket enclosing the remains of a frog lovingly dissected in Professor Stacy's biology lab? Where else would male students flee to the top of trees and quonset huts on Sodie Hawkin's Day? Where else would students build a life-sized igloo in the middle of the campus after heavy snows? The group could now recall with a considerable amount of humor the rigorous manner in which the college officials enforced the rules during the late fifties and early sixties. When compared to the cynicism of many contemporary campuses, the

seemingly over-bearing restrictions of Gardner-Webb became something to be prized.

All of "the gang" have done surprisingly well to have been students at a tiny college of scarcely more than five hundred. If one word could describe the considerable contributions which that group has made to society, it would be "steadiness." No divorces marred the record of those who had met on the campus and later married, or did the virtues of middle America seem to grate upon any of their sensitivities. There seemed to be one unspoken, but universally recognized consensus among them all: they were extremely fortunate in having been exposed to the experience that was Gardner-Webb College. When they lolled on the patio of the cottage, lyrics of old hymns and choruses which graced the college vesper services, spontaneously welled up in their hearts and came out in song. One emotion threatened the tranquility: without Gardner-Webb College the eternal friendship of this gang would not exist. The very

thought of such a denial was overwhelming. That old school had engulfed their lives and changed them for all time. For that they could not have been happier. There was also the realization that even with the death of a beloved member the group would not break as a chain which loses its power to bind with the severing of a single link, but would hold them the more firmly together.

# New Orleans Seminary To Accept GWC Credits

Gardner-Webb College and the New Orleans Baptist Theological Seminary have reached an advanced standing credit agreement. Under this agreement a graduate of Gardner-Webb choosing New Orleans for seminary studies can receive up to 16 hours of credit for specific courses completed on the college level which develop the same competencies as those at the seminary.

A first among Southern Baptist institutions, the agreement is the culmination of discussions stretching back over two decades, according to Dr. Bob Lamb, professor of religious education and religion at Gardner-Webb. The framework for the agreement was established last year at a meeting in Nashville sponsored by Dr. Allen Comish, director of the church services and materials division of the Southern Baptist Convention Sunday School Board, and Dr. Ben Fisher, director of the education commission.

"Resulting from that meeting was the decision that a college wishing to enter into such a program with a seminary should meet certain basic criteria," said Dr. Lamb. "As listed by Dr. Jack Watson of New Orleans, the college first must have a Department of Religion in which a major or integrated program in religious education is offered, and an academically qualified faculty is assigned to teach. Gardner-Webb has one of the strongest religious education programs of any of the Southern Baptist colleges in the United States."

Among other conditions cited by Dr. Watson, the college library must have resources available for the training of religious education students; students committed to religious education must be identified as religious education ministers in training; a minimum of one year or the equivalent must be offered in religious field education; and descriptions of current courses must be made available to New Orleans Baptist Theological Seminary.

Dean J. Hardee Kennedy of New Orleans and Executive Vice President and Dean Thomas J. McGraw of Gardner-Webb called the agreement "a positive step forward in en-

abling students to correlate better their total preparation for ministry."

Dr. Lamb attributed the strength of the college's program to the personal influence of the Gardner-Webb staff. "Our President, Dr. Eugene Poston, has maintained an excellent relationship with the churches in the state. The Rev. Buddy Freeman, our campus minister, relates well to young people and encourages them

to seek God's will for their lives," he explained.

"Dr. Vann Murrell has built a strong Department of Religious Studies and Philosophy and gives warm support to his faculty members, and the most recent addition to the department, Dr. Cullinan, brings a woman's point of view to the subject. She has quickly become known for her distinctive new approaches."

## GWC Receives \$100,000 Grant

Gardner-Webb College has received a grant of \$100,000 from the Z. Smith Reynolds Foundation of Winston-Salem. Announcement of the grant was made by Mrs. Katharine B. Mountcastle, president of the foundation.

The grant will be included in the college's present \$10 million capital funds campaign and will be applied to the construction of a much needed special events building, according to Gardner-Webb President Dr. E. Eugene Poston.

"We are delighted that the trustees of the Z. Smith Reynolds Foundation have chosen to be a part of our program," said Dr. Poston. "This grant may be the catalyst we need in beginning construction of the special events center in the immediate future. It certainly moves us closer to that day."

The special events facility will be designed to accommodate the college's health and physical education department and will have adequate seating capacity for large religious, cultural and athletic events. Preliminary plans include permanent seats for 7,500 people. Projected construction cost is \$2.5 million.

"This building is one that the Southern Association of Colleges and Schools say we must have as a requirement for accreditation," Dr. Poston stated. "Our current allocations of space are not adequate for teaching purposes. Also, the multi-purpose design will allow us to stage a variety of events for our students and the community."

The special events center is one of four new buildings included in the \$10 million campaign. Others are a school of business, an addition to the existing science building, and a residence hall complex. Additional funds will be used to establish a student financial aid program, acquire additional educational resources, maintain the physical plant and increase faculty salaries.

## Cage Team Has Many New Faces

Gardner-Webb opened its basketball campaign against Claffin with a 129-80 victory and the Bulldogs appear to have all the ingredients necessary to develop into another outstanding team.

The Bulldogs possess good speed and quickness overall and are perhaps the best group of shooters Coach Eddie Holbrook has ever assembled. They have the size and strength to match up with most of their opponents.

The only thing lacking from last year's 23-3 squad is experience. Six seasoned veterans are missing from the unit that finished third nationally, and how quickly their replacements can mature will determine how far the Bulldogs will go this season.

"We'll be young and inexperienced at the start," admits Holbrook, "but if we mature quickly and play well before Christmas, we could develop into a good team by the end of the season."

Sophomore John Pait, who was the starting point man at the end of last year, returns and should provide good leadership. He is the lone starter returning.

Other returnees are 6-5 soph Norman Mukka, 6-6 senior John Brame and 6-11 junior Lester Stinson. Stinson, a 265-pounder, missed a good portion of last year with a broken ankle and underwent minor surgery this fall for the removal of a bone chip. He is not expected to play before January.

A good recruiting year has resulted in a lot of new faces in the Bulldogs' lineup.

Red-shirt Dave Borman, 6-7, and freshman Lew Young, 6-6, are a pair of excellent shooters from the wing position. John Borders, a versatile 6-2 freshman, will see duty at both the wing and post slots.

The inside attack will be bolstered by 6-10 freshman Will Franklin, a quick, explosive player who could develop into an intimidator.

Carl Martin, an all-region performer at Wingate last year, is being groomed as the high-post man in Holbrook's double post offense.
