## 1. ADMINISTRATION

The meeting minutes from the 11/22/2013 meeting of the SRSTF were reviewed and approved.

#### 2. <u>RFP UPDATE</u>

Mr. Schweizer provided an update on the results of RTO-Wide RFP for Black Start resources: <u>RTO</u> <u>Wide RFP Update</u>.

#### 3. COST IMPACTS

Mr. Hauske reviewed a cost impact analysis of the Minimum Incentive and Proxy for Formula Replacement packages: <u>Black Start Compensation Proposal Annual Revenue Comparison</u>.

#### 4. MRC PRESENTATION

Ms. Hendrzak reviewed a draft of the presentation to be shared with the MRC in January as part of the first read: <u>Draft Compensation Presentation for MRC</u>.

#### 5. FINAL PROPOSAL REVIEW

Mr. Boyle reviewed a draft version of the final proposal as well as proposed manual changes based on the proposals that will move forward to the MRC: <u>Draft Final Proposal Report</u>, <u>M27 Changes - Minimum</u> Incentive Compensation Proposal, <u>M27 Changes - Proxy Cost Compensation Proposal</u>.

#### 6. ACTION ITEMS

- Summarize NYISO backstop process (Status In Progress)
- Review of the requirements of Hydro units to get compensation for fuel storage. (Was developed during former Black Start Task Force) (STATUS In Progress)
- Review BS selection criteria (STATUS In progress)
- BS cost forecast (STATUS Complete)



- Market participation of BS unit in NYISO & ISO NE (STATUS NYISO Complete; NEISO Complete)
  - 1. What markets must and can a BS unit participate in?
  - 2. What are the revenue rules for BS units that participate in multiple markets? (i.e. are there offsets in the Tariff or netting rules?)
- Compensation for BS units not in the rest of NYISO (ConEd covered in previous TF meeting) (STATUS – Complete)
- In ISONE, is there a requirement that normal natural gas-fired units have dual-fuel capability and is there compensation for that? (STATUS Complete)
- Continue discussion with OPSI regarding status of SRSTF activities. (STATUS Ongoing)
- Provide periodic updates on status of EPRI Black Start study. (STATUS Ongoing)
- Summary of why Generation Owners have filed for FERC approved rates versus the options available under PJM's Tariff. If there are trends, this may inform some changes we might consider as a TF. (Status – Open)
- Develop FAQs for this phase of the TF. Include how BS resources are related to the Capacity Market. (Status In Progress)
