1. Introduction

Switched systems consist of subsystems (modes) and a switching signal that organizes which subsystem drives the overall system. Piecewise Linear Systems (PLS) are a subclass of switched systems where subsystems are linear, time invariant and the switching is autonomous (state dependent). Since PLS are driven by both continuous and discrete dynamics (switching), they exhibit a rich dynamic behavior. The reader may refer to the books by Filippov [\[1\]](#page-8-0), di Bernardo et al. [\[2\]](#page-8-1) and tutorial papers by Cortes et al. [\[3\]](#page-8-2), and Goebel et al. [\[4\]](#page-8-3), which contain many examples demonstrating the dynamic behavior of PLS. A general treatment of switched systems is given by Liberzon [\[5\]](#page-8-4).

Bimodal Piecewise Linear Systems (BPLS) and Bimodal Piecewise Affine Systems (BPAS) are special subclasses of PLS where there are only two subsystems. Subsystems in BPLS are homogeneous $(\dot{\mathbf{x}} = \mathbf{A}_i \mathbf{x}, i = 1, 2)$, whereas in BPAS a constant vector is added to the vector field ($\dot{\mathbf{x}} = \mathbf{A}_i \mathbf{x} + \mathbf{b}_i$, $i = 1, 2$).

BPLS and BPAS attracted considerable attention in the literature lately. This is basically due to the fact that these systems can be

A B S T R A C T

This paper considers well-posedness (the existence and uniqueness of the solutions) of Bimodal Piecewise Affine Systems in \mathbb{R}^n . It is assumed that both modes are observable, but only one of the modes is in observable canonical form. This allows the vector field to be discontinuous when the trajectories change mode. Necessary and sufficient conditions for well-posedness are given as a set of algebraic conditions and sign inequalities. It is shown that these conditions induce a joint structure for the system matrices of the two modes. This structure can be used for the classification of well-posed bimodal piecewise affine systems. Furthermore, it is also shown that, under certain conditions, well-posed Bimodal Piecewise Affine Systems in \mathbb{R}^n may have one or two equilibrium points or no equilibrium points.

used for modeling a rich variety of mechanical, electrical, biological and engineering systems. As a consequence, BPLS and BPAS are investigated by many authors in the context of stability, stabilizability and control in the literature (see, for instance, $[6-10]$). In addition to this, BPAS turns out to be an appropriate tool to understand nonlinear phenomena. For instance, BPAS version of the well known traveling wave equation model of Michelson System [\[11\]](#page-8-6), the Wien-bridge oscillator of $[12]$, a biological network model by Imura et al. [\[13\]](#page-8-8), are examples of nonlinear systems modeled as BPAS.

Well-posedness simply means existence and uniqueness of solutions. If the vector field is assumed to be continuous, then for each initial condition in \mathbb{R}^n , there is a unique and continuously differentiable solution of PLS which resolves the issue of wellposedness. The literature contains many papers which investigate stability $[14,6]$ $[14,6]$, controllability and observability $[15,7,9]$ $[15,7,9]$ $[15,7,9]$ under this assumption. If the vector field is discontinuous, then dynamic behavior of PLS cannot be represented by continuously differentiable solutions and well-posedness become a central issue in PLS. There are various solution structures for many classes of systems with discontinuous vector fields and the details and examples can be found in the survey papers by Georgescu et al. [\[16\]](#page-8-13) and Cortes [\[3\]](#page-8-2) and in the book [\[17\]](#page-9-0). An interesting dynamic behavior encountered in PLS is the existence of trajectories which change mode infinite number of times in a finite time interval. This paradoxical behavior is called Zeno behavior and investigated in a series of papers [\[15](#page-8-10)[,18,](#page-9-1)[19\]](#page-9-2). Moreover, well-posedness is also an essential issue in problems such as stability, stabilizability and feedback

control. Along this line, the reader may refer to Example 13 in [\[20\]](#page-9-3), where well-posedness conditions guarantee global asymptotic stability of a BPLS in $\mathbb{R}^2.$

Well-posedness of BPLS in \mathbb{R}^n is first solved by Imura and van der Schaft [\[21\]](#page-9-4) in the context of Carathéodory solutions. Imura [\[22\]](#page-9-5) investigated well-posedness of BPAS with control inputs in \mathbb{R}^n and presented a classification of well-posed feedback systems in \mathbb{R}^n . The papers by Çamlıbel et al. [\[15\]](#page-8-10), by Çamlıbel [\[18\]](#page-9-1), and by Thuan and Çamlıbel [\[19\]](#page-9-2) have also provided important contributions on the Zeno behavior of well-posed PLS.

In this paper, we consider well-posedness problem of BPAS in \mathbb{R}^n where both modes are observable. We assume, without loss of any generality, that only the system matrix of one of the modes is in observable canonical form. This allows for discontinuities of the vector field. It is shown that necessary and sufficient conditions of well-posedness given in this paper induce a special structure on the matrix of the subsystem which is not in observable canonical form. This leads to a joint structure for the two modes, which holds for both BPLS and BPAS. This structure can be checked easily and be used for classification of well-posed BPAS and BPLS. Finally, at the end of the paper, we exploit the relation between the conditions of well-posedness and the equilibrium points of BPAS and provide the conditions under which BPAS have one or two or no equilibrium points. Comparison of the results presented here with the results [g](#page-3-0)iven in the literature (such as [\[21–23\]](#page-9-4)) are given in [Remarks 3.3–](#page-3-0) [3.5](#page-3-0) in the paper.

2. Preliminaries

In this section we investigate well-posedness conditions of the following BPAS

$$
\Sigma_0: \begin{cases} \dot{\mathbf{x}} = \mathbf{A}_1 \mathbf{x} + \mathbf{b}_1, & \text{if } \mathbf{c}^T \mathbf{x} \ge \mathbf{0} \\ \dot{\mathbf{x}} = \mathbf{A}_2 \mathbf{x} + \mathbf{b}_2, & \text{if } \mathbf{c}^T \mathbf{x} \le \mathbf{0} \end{cases} \tag{1}
$$

where $A_i \in \mathbb{R}^{n \times n}$, b_i , $c \in \mathbb{R}^n$. The following definition is crucial in our approach.

Definition 2.1. The observability index of a linear time invariant system is the smallest integer *k* such that $rank(\mathcal{O}_k^i) = rank(\mathcal{O}_{k+1}^i)$ where $\mathcal{O}_k^i := \begin{bmatrix} \mathbf{c} & \mathbf{A}_i^T \mathbf{c} & \cdots & \cdots & \left(\mathbf{A}_i^{k-1} \right)^T \mathbf{c} \end{bmatrix}^T$ for $i = 1, 2$. If $k = n$, then the pair $(\textbf{c}^{T}, \textbf{A}_i)$ is said to be observable.

In view of this definition, we assume that: "The pairs $(\textbf{c}^{\mathsf{T}}, \textbf{A}_1)$ and $(\textbf{c}^{\mathsf{T}}, \textbf{A}_2)$ are observable and the pair $(\textbf{c}^{\mathsf{T}}, \textbf{A}_2)$ is in observable canonical form''.

Note that assuming $(\mathbf{c}^T,\mathbf{A}_2)$ to be in observable canonical form does not cause any loss of generality since A_1 is completely free. In view of this assumption, the components of Σ_0 are given as follows.

$$
\mathbf{A}_{1} = \begin{bmatrix} a_{11} & \cdots & a_{1n} \\ \vdots & \ddots & \vdots \\ a_{n1} & \cdots & a_{nn} \end{bmatrix}, \qquad \mathbf{A}_{2} = \begin{bmatrix} k_{1} & k_{2} & \cdots & \cdots & k_{n} \\ 1 & 0 & \cdots & \cdots & 0 \\ 0 & 1 & 0 & \cdots & \vdots \\ \vdots & \ddots & \ddots & \ddots & \vdots \\ 0 & \cdots & 0 & 1 & 0 \end{bmatrix}, \qquad (2)
$$

$$
\mathbf{b}_{i} = \begin{bmatrix} b_{i1} \\ \vdots \\ b_{in} \end{bmatrix}, \quad i = 1, 2 \text{ and } \mathbf{c}^{T} = \begin{bmatrix} 0 & \cdots & 0 & 1 \end{bmatrix}.
$$

For well-posedness of Σ_0 , we only consider the solutions in the sense of Carathéodory as defined below. This definition is taken from [\[18\]](#page-9-1).

Definition 2.2. An absolutely continuous function $\mathbf{x} : \mathbb{R} \to \mathbb{R}^n$ is said to be a solution of Σ_0 for the initial condition \mathbf{x}_0 in the sense of

- 1. Carathéodory if $\mathbf{x}(0) = \mathbf{x}_0$ and $\mathbf{x}(t)$ satisfies [\(1\)](#page-1-0) for almost all $t \in \mathbb{R}$.
- 2. Forward Carathéodory for the initial state \mathbf{x}_0 , if it is a solution in the sense of Carathéodory, and for each $t_0 \geq 0$, there exists $\epsilon^+ > 0$ such that either $\dot{\mathbf{x}} = \mathbf{A}_1 \mathbf{x} + \mathbf{b}_1$ and $\mathbf{c}^T \mathbf{x} \ge 0$, or $\dot{\mathbf{x}} = \mathbf{A}_2 \mathbf{x} + \mathbf{b}_2$ and $\mathbf{c}^T \mathbf{x} \leq 0$, hold for all $t \in [t_0, t_0 + \epsilon^+]$.

Definition 2.3. The system Σ_0 is said to be well-posed if for every initial state $\mathbf{x}(0) = \mathbf{x}_0 \in \mathbb{R}^n$, there exists a unique forward Carathéodory solution **x**(*t*) of Σ_0 .

Definition 2.4. Let δ_i , $i = 1, 2$ denote the set of initial conditions \mathbf{x}_0 ∈ \mathbb{R}^n defined as follows: For each \mathbf{x}_0 ∈ δ_i there exists $\epsilon_i > 0$ and a forward Carathéodory solution with $\mathbf{x}(0) = \mathbf{x}_0$ and $\dot{\mathbf{x}} = \mathbf{A}_i \mathbf{x} + \mathbf{b}_i$ such that $\mathbf{x}(t) \in \mathcal{S}_i$ for all $t \in [0, \epsilon_i]$. Then, we say that the solution with $\mathbf{x}(0) = \mathbf{x}_0 \in \mathcal{S}_i$ smoothly continues in mode *i*.

This definition is consistent with Definition 2.3 in [\[21\]](#page-9-4). In order to show that δ_i 's ($i = 1, 2$) are nonempty, let $\mathcal H$ denote the switching hyperplane defined as follows.

$$
\mathcal{H} := \{ \mathbf{x} \in \mathbb{R}^n \mid \mathbf{c}^T \mathbf{x} = 0 \}.
$$

Note that *H* is a subspace of dimension *n* − 1 which divides \mathbb{R}^n into two open half spaces defined as

$$
\mathcal{H}^+ := \left\{ \mathbf{x} \in \mathbb{R}^n \, \middle| \, \mathbf{c}^T \mathbf{x} > 0 \right\} \quad \text{and} \quad \mathcal{H}^- := \left\{ \mathbf{x} \in \mathbb{R}^n \, \middle| \, \mathbf{c}^T \mathbf{x} < 0 \right\}.
$$

In view of the theory of differential equations, for any initial condition $\mathbf{x}_0 \in \mathcal{H}^+$ ($\mathbf{x}_0 \in \mathcal{H}^-$), there exists $\varepsilon^+ > 0$ ($\varepsilon^- > 0$) and a forward Carathéodory solution $\mathbf{x}(t)$ such that $\mathbf{x}(0)$ = \mathbf{x}_0 , $\mathbf{c}^T \mathbf{x}(t) > 0$ and $\dot{\mathbf{x}} = \mathbf{A}_1 \mathbf{x} + \mathbf{b}_1$ ($\mathbf{c}^T \mathbf{x}(t) < 0$ and $\dot{\mathbf{x}} = \mathbf{A}_2 \mathbf{x} + \mathbf{b}_2$) for all $t \in [0, \varepsilon^+]$ $(t \in [0, \varepsilon^-])$. Since only one of the modes is active, the solution is unique. This implies that \mathcal{S}_1 and \mathcal{S}_2 are nonempty. More precisely, $\mathcal{H}^+ \subset \mathcal{S}_1$ and $\mathcal{H}^- \subset \mathcal{S}_2$. If $\mathbf{x}_0 \in \mathcal{H}$, then we cannot claim uniqueness of solutions since both modes are allowed to be active on H . Therefore, the problem of well-posedness reduces to the characterization of the sets $\delta_i \cap \mathcal{H}$, for $i = 1, 2$. In order to resolve this problem, we present below two Lemmas from [\[21](#page-9-4)[,22\]](#page-9-5). These Lemmas give necessary and sufficient conditions for wellposedness of BPLS and BPAS, respectively.

Lemma 2.5 ([\[21,](#page-9-4) Lemma 2.1]). Let $\mathbf{b}_1 = \mathbf{b}_2 = \mathbf{0}$. Then the following *are equivalent.*

- 1. Σ_0 is well-posed
- 2. From every initial state $\mathbf{x}_0 \in \mathbb{R}^n$, smooth continuation is possible in *only one of the two modes, except for the case when the solutions for both modes are the same in some time interval.*

Lemma 2.6 ($[22$, Lemma 2.2-(i)]). Σ_0 is well-posed if and only if S_1 ∪ S_2 = \mathbb{R}^n and for every $\mathbf{x}_0 \in S_1 \cap S_2$ the solutions according *to both modes are the same in some time interval.*

We should remark here that in [\[22,](#page-9-5) Lemma 2.2-(i)], C-wellposedness is used instead of well-posedness. Since C-wellposedness is the same as well-posedness given in [Definition 2.3,](#page-1-1) we simply use well-posedness here.

Remark 2.7. Note that the conditions given in [\[22,](#page-9-5) Lemma 2.2-(i)] are also valid for BPLS. This follows from the fact that $\delta_1 \cap \delta_2$ is a single point in \mathbb{R}^n and this point is the origin, i.e., the equilibrium point of well-posed BPLS. Hence, the solutions in both modes are the same. It will be shown in the sequel that $\mathcal{S}_1 \cap \mathcal{S}_2$ is also a single point for a well-posed BPAS. This point may also be the equilibrium point of BPAS (see item 5 of [Corollary 3.2\)](#page-4-0).

In view of [Definition 2.3](#page-1-1) and Lemma's given above, wellposedness is equivalent to the fact that the derivatives with respect to *t* of the solutions, i.e. $\frac{d(c^T x)}{dt_c}$, for both modes must have the same sign at any $\mathbf{x}_0 \in \mathcal{H}$. We can formalize this observation by using the classification given in [\[24,](#page-9-6) pp. 58] as follows.

Let $\mathbf{x}_0 \in \mathcal{H}$. Then, the following hold for a well-posed BPLS or BPAS,

- Either \mathbf{c}^T ($\mathbf{A}_i \mathbf{x}_0 + \mathbf{b}_i$) > 0 for $i = 1, 2$ or \mathbf{c}^T ($\mathbf{A}_i \mathbf{x}_0 + \mathbf{b}_i$) < 0 for $i = 1, 2.$
- The case $\mathbf{c}^T (A_1 \mathbf{x}_0 + \mathbf{b}_1) > 0$ and $\mathbf{c}^T (A_2 \mathbf{x}_0 + \mathbf{b}_2) < 0$ is not allowed because it implies that there are two solutions smoothly continuing in two modes and this contradicts uniqueness.
- The case ${\bf c}^T (A_1{\bf x}_0 + {\bf b}_1)$ < 0 and ${\bf c}^T (A_2{\bf x}_0 + {\bf b}_2)$ > 0 is not allowed because it implies that there are no solutions in the sense of Carathéodory.

Nonlinear version of the framework given above is previously used for the investigation of well-posedness of bimodal systems with nonlinear subsystems in [\[25\]](#page-9-7).

3. Main results

We now present the main result of the paper.

Theorem 3.1. Consider the piecewise affine system Σ_0 defined by *Eqs.* [\(1\)](#page-1-0) and [\(2\)](#page-1-2)*. The system is well-posed if and only if the following hold.*

- (1) *The structure of* A_1 *is such that* $a_{ij} = 0$ *if* $i = 3, 4, ..., n$ *and j* = 1, 2, ..., *i* − 2, *or equivalently the following hold* $\bigcap_{r=0}^{s}$ ker $(\mathbf{c}^T \mathbf{A}_1^r) = \bigcap_{r=0}^{s}$ ker $(\mathbf{c}^T \mathbf{A}_2^r)$ *for s* = 1, 2, ..., *n* − 1. $\sum_{r=0}^{s}$ ker $(c^T A_1^r) = \bigcap_{r=0}^{s}$ ker $(c^T A_2^r)$ for $s = 1, 2, ..., n-1$.
- (2) *The entries of* **A**¹ *which are below the diagonal are positive i.e.,* $a_{i+1,i} > 0$ *for* $i = 1, 2, ..., n - 1$.
- (3) *The relation between* \mathbf{b}_1 *and* \mathbf{b}_2 *is as follows.*

(4) *The following equation hold for the entries of* \mathbf{b}_1 *and* \mathbf{b}_2 *.*

$$
a_{n,n-1}a_{n-1,n-2}\dots a_{21}\left(b_{11}-\sum_{j=1}^{n-1}a_{1j}b_{2,j+1}\right)
$$

= $b_{21}-\sum_{j=1}^{n-1}k_jb_{2,j+1}$.

Note that items 3 and 4 of [Theorem 3.1](#page-2-0) give the algebraic relations between the affine terms of modes, while items 1 and 2 impose a special structure on A_1 as shown below.

$$
\mathbf{A}_1 = \begin{bmatrix} a_{11} & a_{12} & \cdots & a_{1,n-1} & a_{1n} \\ a_{21} & a_{22} & \cdots & a_{2,n-1} & a_{2n} \\ 0 & a_{32} & \ddots & \vdots & \vdots \\ \vdots & \ddots & \ddots & \vdots & \vdots \\ 0 & \cdots & 0 & a_{n,n-1} & a_{nn} \end{bmatrix}
$$
 (3)

If we partition both system matrices, their joint structure (induced by well-posedness conditions) can be displayed as follows.

$$
\mathbf{A}_1 = \begin{bmatrix} \mathbf{y}_1^T & a_{1n} \\ \mathbf{A}_{11} & \mathbf{z}_1 \end{bmatrix}, \quad \text{and} \quad \mathbf{A}_2 = \begin{bmatrix} \mathbf{y}_2^T & k_n \\ \mathbf{I} & \mathbf{0} \end{bmatrix}, \tag{4}
$$

where **y**₁, **y**₂, and **z**₁ are in \mathbb{R}^{n-1} and $\mathbf{A}_{11} \in \mathbb{R}^{(n-1)\times(n-1)}$ as defined below.

$$
\mathbf{A}_{11} := \begin{bmatrix} a_{21} & a_{22} & \cdots & a_{2,n-1} \\ 0 & a_{32} & \cdots & \vdots \\ \vdots & \ddots & \ddots & \vdots \\ 0 & \cdots & 0 & a_{n,n-1} \end{bmatrix}, \quad \mathbf{y}_{1} := \begin{bmatrix} a_{11} \\ a_{12} \\ \vdots \\ a_{1,n-1} \end{bmatrix},
$$

$$
\mathbf{z}_{1} := \begin{bmatrix} a_{2n} \\ \vdots \\ a_{nn} \end{bmatrix}, \quad \mathbf{y}_{2} := \begin{bmatrix} k_{1} \\ k_{2} \\ \vdots \\ k_{n-1} \end{bmatrix}.
$$

The proof of [Theorem 3.1](#page-2-0) is technical and it is given in the [Appendix.](#page-5-0) In the sequel, we first give an example to motivate the proof of [Theorem 3.1.](#page-2-0)

Example 3.2. Consider the following BPAS.

$$
\mathbf{A}_{i} = \begin{bmatrix} a_{i} & b_{i} & c_{i} \\ 1 & 0 & 0 \\ 0 & 1 & 0 \end{bmatrix}, \quad i = 1, 2,
$$

$$
\mathbf{b}_{1} = \begin{bmatrix} 2 \\ 1 \\ -3 \end{bmatrix}, \qquad \mathbf{b}_{2} = \begin{bmatrix} 1 \\ -2 \\ 2 \end{bmatrix}, \qquad \mathbf{c} = \begin{bmatrix} 0 \\ 0 \\ 1 \end{bmatrix}
$$

where a*i*, b*ⁱ* and c*ⁱ* are arbitrary real numbers. Let us define the lines L_1 and L_2 in $\mathcal{H} := \ker \mathbf{c}^T$ as follows.

$$
L_1 = \left\{ \mathbf{x}_0 \in \mathcal{H} \mid \mathbf{x}_0 = \begin{bmatrix} \gamma_1 & 3 & 0 \end{bmatrix}^T, \ \gamma_1 \in \mathbb{R} \right\},
$$

$$
L_2 = \left\{ \mathbf{x}_0 \in \mathcal{H} \mid \mathbf{x}_0 = \begin{bmatrix} \gamma_1 & -2 & 0 \end{bmatrix}^T, \ \gamma_1 \in \mathbb{R} \right\},
$$

where y_1 is an arbitrary real number (these lines are depicted in [Fig. 1\)](#page-2-1). Note that if $\mathbf{x}_0 \in L_1$ ($\mathbf{x}_0 \in L_2$) then \mathbf{c}^T ($\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1$) = 0 $(c^T (A_2 x_0 + b_2) = 0)$. Let $x_0 = [\gamma_1 \quad \gamma_2 \quad 0]^T$ be an arbitrary initial condition in H. Note that if $\gamma_2 > 3$, then it follows that the first derivatives with respect to *t* of the solutions for both modes are ${\bf c}^T$ (${\bf A}_1{\bf x}_0 + {\bf b}_1$) = $\gamma_2 - 3 > 0$ and ${\bf c}^T$ (${\bf A}_2{\bf x}_0 + {\bf b}_2$) = $\gamma_2 + 2 >$ 0. Similarly, if γ_2 < -2, then it follows that $\mathbf{c}^T (\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1)$ < 0 and \mathbf{c}^T $(\mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2) < 0$. Consequently, for each initial condition **x**₀ ∈ H where γ_2 > 3 (γ_2 < −2), there exists a unique forward Carathéodory solution which smoothly continues in first mode (second mode). However, if $-2 < \gamma_2 < 3$, then $\mathbf{c}^T (\mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2) > 0$ and \mathbf{c}^T ($\mathbf{A}_1\mathbf{x}_0 + \mathbf{b}_1$) < 0. This implies that there are no solutions in the sense of Carathéodory. Hence, the lines L_1 and L_2 should be the same in order to guarantee the existence of a unique forward Carathéodory solution for each $\mathbf{x}_0 \in \mathcal{H}$ and $\mathbf{x}_0 \notin L_1$ (=*L*₂).

Let us change **b**₂ as **b**₂ = $\begin{bmatrix} 1 & -2 & -3 \end{bmatrix}^T$ so that $L_1 = L_2$ and define \mathcal{H}_1 as follows.

\mathcal{H}_1 := \left\{ \mathbf{x}_0 \in \mathcal{H} \mid \mathbf{c}^T \left(\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1 \right) = \mathbf{c}^T \left(\mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2 \right) = 0 \right\},
$$

=
$$
\left\{ \mathbf{x}_0 \in \mathcal{H} \mid \mathbf{x}_0 = \begin{bmatrix} \gamma_1 & 3 & 0 \end{bmatrix}^T \right\}.
$$

Fig. 2. Plane geometry for well-posed system.

Note that H_1 divides H into two affine spaces (each with dimension two) which can be described as follows.

 $\mathcal{H}_1^+ := \{ \mathbf{x}_0 \in \mathcal{H} \mid \mathbf{c}^T (\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1) > 0 \text{ and } \mathbf{c}^T (\mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2) > 0 \},\$ $\mathcal{H}_1^- := \{ \mathbf{x}_0 \in \mathcal{H} \mid \mathbf{c}^T (\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1) < 0 \text{ and } \mathbf{c}^T (\mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2) < 0 \}$.

Let us now consider the following lines, $M_1 \in \mathcal{H}$ and $M_2 \in$ \mathcal{H} , where $\mathbf{c}^T (\mathbf{A}_1^2 \mathbf{x}_0 + \mathbf{A}_1 \mathbf{b}_1) = 0$ and $\mathbf{c}^T (\mathbf{A}_2^2 \mathbf{x}_0 + \mathbf{A}_2 \mathbf{b}_2) = 0$, respectively. These lines can be described as follows (depicted in [Fig. 1\)](#page-2-1).

$$
M_1 = \left\{ \mathbf{x}_0 \in \mathcal{H} \mid \mathbf{x}_0 = \begin{bmatrix} -1 & \gamma_2 & 0 \end{bmatrix}^T, \ \gamma_2 \in \mathbb{R} \right\},
$$
\n
$$
M_2 = \left\{ \mathbf{x}_0 \in \mathcal{H} \mid \mathbf{x}_0 = \begin{bmatrix} 2 & \gamma_2 & 0 \end{bmatrix}^T \right\}, \quad \gamma_2 \in \mathbb{R}
$$

where γ_2 is an arbitrary real number. Note that M_1 and M_2 intersect \mathcal{H}_1 at $\gamma_2 = 3$. Then, consider an initial condition $\mathbf{x}_0 \in \mathcal{H}$ defined as $\mathbf{x}_0 := \begin{bmatrix} \gamma_1 & 3 & 0 \end{bmatrix}^T$. Note that if $\gamma_1 > 2$, then it follows that the second derivatives of the trajectory are $\mathbf{c}^T \left(\mathbf{A}_1^2 \mathbf{x}_0 + \mathbf{A}_1 \mathbf{b}_1 \right)$ = $\gamma_1 + 1 > 0$ and ${\bf c}^T \left({\bf A}_2^2 {\bf x}_0 + {\bf A}_2 {\bf b}_2 \right) = \gamma_1 - 2 > 0$. If $\gamma_1 < -1$, then we get ${\bf c}^T \left({\bf A}_1^2 {\bf x}_0 + {\bf A}_1 {\bf b}_1 \right)$ ≤ 0 and ${\bf c}^T \left({\bf A}_2^2 {\bf x}_0 + {\bf A}_2 {\bf b}_2 \right)$ ≤ 0 . Consequently, for each initial condition $\mathbf{x}_0 \in \mathcal{H}_1$ where γ_1 > 2 ($\gamma_1 < -1$), there exists a unique forward Carathéodory solution which smoothly continues in first mode (second mode). However, if $-1 < \gamma_1 < 2$ (corresponds to the points in between M_1 and *M*₂), then ${\bf c}^T \left({\bf A}_2^2 {\bf x}_0 + {\bf A}_2 {\bf b}_2 \right) \ < \ 0$ and ${\bf c}^T \left({\bf A}_1^2 {\bf x}_0 + {\bf A}_1 {\bf b}_1 \right) \ > \ 0$. This implies that there are two solutions in the sense of Carathéodory. One smoothly continues in s_1 and the other smoothly continues in \mathcal{S}_2 . Therefore, the lines M_1 and M_2 should be the same in order to guarantee the existence of unique forward Carathéodory solution for each $\mathbf{x}_0 \in \mathcal{H}_1$ and $\mathbf{x}_0 \notin M_1$ (=*M*₂).

Let us change \mathbf{b}_2 as $\mathbf{b}_2 = \begin{bmatrix} 1 & 1 & -3 \end{bmatrix}^T$ so that $M_1 = M_2$ and define H_2 as follows.

\mathcal{H}_2 := \left\{ \mathbf{x}_0 \in \mathcal{H}_1 \, | \mathbf{c}^T \left(\mathbf{A}_1^2 \mathbf{x}_0 + \mathbf{A}_1 \mathbf{b}_1 \right) = \mathbf{c}^T \left(\mathbf{A}_2^2 \mathbf{x}_0 + \mathbf{A}_2 \mathbf{b}_2 \right) = 0 \right\},
$$
\n
$$
= \left\{ \mathbf{x}_0 \in \mathcal{H}_1 \mid \mathbf{x}_0 = \begin{bmatrix} -1 & 3 & 0 \end{bmatrix}^T \right\}.
$$

Along the same lines, \mathcal{H}_2 divides \mathcal{H}_1 into two half lines (each with dimension one) which can be described as follows.

$$
\mathcal{H}_2^+ := \left\{ \mathbf{x}_0 \in \mathcal{H}_1 \mid \mathbf{c}^T \left(\mathbf{A}_1^2 \mathbf{x}_0 + \mathbf{A}_1 \mathbf{b}_1 \right) > 0 \text{ and } \mathbf{c}^T \left(\mathbf{A}_2^2 \mathbf{x}_0 + \mathbf{A}_2 \mathbf{b}_2 \right) > 0 \right\},\
$$

$$
\mathcal{H}_2^- := \left\{ \mathbf{x}_0 \in \mathcal{H}_1 \mid \mathbf{c}^T \left(\mathbf{A}_1^2 \mathbf{x}_0 + \mathbf{A}_1 \mathbf{b}_1 \right) < 0 \text{ and } \mathbf{c}^T \left(\mathbf{A}_2^2 \mathbf{x}_0 + \mathbf{A}_2 \mathbf{b}_2 \right) < 0 \right\}.
$$

Note that H_2 is a single point (depicted in [Fig. 2\)](#page-3-1) and with new **b**₂ = $\begin{bmatrix} 1 & 1 & -3 \end{bmatrix}^T$, the existence and uniqueness of solutions for each $\mathbf{x}_0 \in \mathbb{R}^3$ is guaranteed, except for $\mathbf{x}_0^* = \begin{bmatrix} -1 & 3 & 0 \end{bmatrix}^T = \mathcal{H}_2$.

Note that the third derivative of $\mathbf{c}^T \mathbf{x}$ (*t*) at $t = 0$ where \mathbf{x} (0) = \mathbf{x}_0^* , is easily calculated as follows.

$$
\frac{d^3}{dt^3} \left(\mathbf{c}^T \mathbf{x} \right) |_{t=0} = \begin{cases} \mathbf{c}^T \mathbf{A}_1^2 \mathbf{x}_0^* + \mathbf{c}^T \mathbf{A}_1^2 \mathbf{b}_1 \\ \mathbf{c}^T \mathbf{A}_2^2 \mathbf{x}_0^* + \mathbf{c}^T \mathbf{A}_2^2 \mathbf{b}_2 \end{cases} = \begin{cases} 2 - \mathfrak{a}_1 + 3 \mathfrak{b}_1 \\ 1 - \mathfrak{a}_2 + 3 \mathfrak{b}_2 \end{cases}.
$$

The equality $2 - \alpha_1 + 3\beta_1 = 1 - \alpha_2 + 3\beta_2$ implies and implied by $\mathbf{A}_1 \mathbf{x}_0^* + \mathbf{b}_1 = \mathbf{A}_2 \mathbf{x}_0^* + \mathbf{b}_2$. Consequently, these conditions are necessary and sufficient for the existence of a unique forward Carathéodory solution starting from **x** ∗ 0 .

Remark 3.3. Smooth continuation sets (δ_1, δ_2) are characterized by lexicographic inequalities in [\[21,](#page-9-4)[22\]](#page-9-5). These inequalities also imply that the vector field of both modes have a certain structure on H , but this structure is displayed implicitly for BPLS by Theorems 4.1 and 4.2 in $[21]$. Theorem 4.2 of $[21]$ gives the necessary and sufficient conditions for well-posedness of BPLS. For the case where (c^T, A_1) and (c^T, A_2) are observable, these conditions reduce to the existence of a lower left triangular matrix **M** with positive diagonal entries such that $\mathcal{O}_n^1 = \mathbf{M}\mathcal{O}_n^2$ (\mathcal{O}_k^i is the observability matrix given in [Definition 2.1\)](#page-1-3). It can be easily shown (by setting $b_1 = b_2 = 0$ in the proof of [Theorem 3.1\)](#page-2-0) that this condition is equivalent to first and second items of [Theorem 3.1.](#page-2-0) Thus, in our approach **M** arises naturally within the structure of **A**1. Moreover, starting with only one of the modes in observable canonical form, we arrive at a joint structure for a well-posed BPLS given by Eqs. $(5)-(7)$. This structure can be checked by simple inspection and used for an explicit classification of well-posed BPLS. We should point out here that this result was first proven for BPLS in \mathbb{R}^3 in [\[8\]](#page-8-14) and it was noted that these results can be extended to bimodal systems in \mathbb{R}^n .

Our main result, extends this result to well-posed BPAS and yields a joint structure for the triples $\left(\mathbf{c}^{\mathsf{T}}, \mathbf{A}_1, \mathbf{b}_1\right)$ and $\left(\mathbf{c}^{\mathsf{T}}, \mathbf{A}_2, \mathbf{b}_2\right)$ which can also be checked by simple inspection and used for classification of well-posed BPAS. Finally, we should also remark here that our main result can be easily extended to the case of unobservable subsystems, if the observability indices of both modes are equal. In this case, the joint structure of (c^T, A_1, b_1) and (c^T, A_2, b_2) given in our main result holds for the observable parts of the subsystems. For the unobservable part, $A_1x = A_2x$ for any **x** ∈ ker \mathcal{O}_n^1 , as given in the Theorem 4.2 of [\[21\]](#page-9-4).

Remark 3.4. Feedback well-posedness of BPAS is considered in $[22]$. The conditions given in $[22]$ should reduce to the conditions given in our main result if the feedback terms are removed. However, since the setup in [\[22\]](#page-9-5) is based on feedback terms (which involves controllability indices), such an equivalence is not readily obvious.

Remark 3.5. Theorem 3.1 of Thuan and Çamlıbel [\[23\]](#page-9-8) provides sufficient conditions for a Filippov solution to be right unique and for each Filippov solution to be both forward and backward Carathéodory solution. (The definitions of Filippov solutions, backward Carathéodory solutions and Zeno Behavior are given in [\[18,](#page-9-1)[23\]](#page-9-8).) For the case where both the pairs (c^T, A_1) and (c^T, A_2) are observable the Statement 5 of Theorem 3.1 in [\[23\]](#page-9-8) can be written as follows

$$
\left[\mathcal{O}_{n+1}^1\right] = \mathbf{M}\left[\mathcal{O}_{n+1}^2\right], \qquad \left[\begin{matrix} f \\ \mathcal{O}_n^1 \mathbf{b}_1 \end{matrix}\right] = \mathbf{M}\left[\begin{matrix} f \\ \mathcal{O}_n^2 \mathbf{b}_2 \end{matrix}\right],
$$

where **M** is a lower left triangular matrix with positive diagonal entries, \mathcal{O}_k^i 's are as defined by [Definition 2.1,](#page-1-3) and *f* is a real scalar such that for $\mathbf{c}^T \mathbf{x} + f \geq 0$ the first mode is active and for $\mathbf{c}^T \mathbf{x} + f \leq 0$ the second mode is active. Similarly, Statement 6 of Theorem 3.1 in [\[23\]](#page-9-8) can be written as follows.

$$
\left[\mathcal{O}_{n+1}^1\right]\mathbf{x}_0+\begin{bmatrix}f\\ \mathcal{O}_n^1\mathbf{b}_1\end{bmatrix}=\mathbf{0}\Longrightarrow \mathbf{A}_1\mathbf{x}_0+\mathbf{b}_1=\mathbf{A}_2\mathbf{x}_0+\mathbf{b}_2.
$$

Since $f = 0$ in our setup, it can be easily shown that first equation in Statement 5 of Theorem 3.1 in $[23]$ and positivity of the diagonal entries of **M** are equivalent to the first two items of our main result. Moreover, the second equation in Statement 5 of Theorem 3.1 in [\[23\]](#page-9-8) is equivalent to Item 3 of our main result. Finally, Statement 6 of Theorem 3.1 in [\[23\]](#page-9-8) is equivalent to Item 4 of our main result.

On the other hand, Implications C and D of Theorem 3.1 in [\[23\]](#page-9-8) states that the conditions given above are sufficient conditions for every Filippov solution to be both forward and backward Carathéodory solution and every Filippov solution to be right unique, respectively. Consequently, in view of the results given in [\[23\]](#page-9-8), our main result [\(Theorem 3.1\)](#page-2-0) implies that Filippov solutions are right unique and they are both forward and backward Carathéodory solutions.

Remark 3.6. If Σ_0 is well-posed, then it is clear, by Example 3.2 and the proof of [Theorem 3.1,](#page-2-0) that there exist affine spaces \mathcal{H}_k , $k =$ 1, 2, . . . , *n* − 1, each with dimension *n* − *k* − 1, such that \mathcal{H}_{n-1} ⊂ $\mathcal{H}_{n-2} \subset \cdots \subset \mathcal{H}_1 \subset \mathcal{H}$ and

$$
\mathcal{H}_k := \left\{ \mathbf{x}_0 \in \mathcal{H}_{k-1} | \mathbf{c}^T \mathbf{A}_1^{k-1} \left(\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1 \right) \right\}
$$

$$
= \mathbf{c}^T \mathbf{A}_2^{k-1} \left(\mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2 \right) = 0 \right\}.
$$

Furthermore, H*^k* divides H*k*−¹ into two affine spaces H + *k* and \mathcal{H}_k^- defined as follows.

$$
\mathcal{H}_k^+ := \left\{ \mathbf{x}_0 \in \mathcal{H}_{k-1} \mid \mathbf{c}^T \mathbf{A}_1^{k-1} \left(\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1 \right) > 0 \text{ and } \mathbf{c}^T \mathbf{A}_2^{k-1} \left(\mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2 \right) > 0 \right\},
$$

$$
\mathcal{H}_k^- := \left\{ \mathbf{x}_0 \in \mathcal{H}_{k-1} \mid \mathbf{c}^T \mathbf{A}_1^{k-1} \left(\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1 \right) < 0 \text{ and } \mathbf{c}^T \mathbf{A}_2^{k-1} \left(\mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2 \right) < 0 \right\}.
$$

Note that if $\mathbf{x}_0 \in \mathcal{H}_1^+$ $\big(\mathcal{H}_1^-\big)$, then the solutions of $\mathit{\Sigma}_0$ can only arrive at \mathbf{x}_0 from $\mathcal{H}^-\left(\mathcal{H}^+\right)$ and continue in $\mathcal{H}^+\left(\mathcal{H}^-\right)$. These solutions are both forward and backward Carathéodory solutions and x_0 is a switching point (any trajectory that arrives at x_0 changes mode). However, if $\mathbf{x}_0\in\mathcal{H}^{\pm}_2\left(\mathcal{H}^-_2\right)$ this is not necessarily true. In order to show the difference, suppose that $\mathbf{x}_0 \in \mathcal{H}_2^-$ and $\mathbf{x}(t)$ is a solution which starts from \mathcal{H}^+ and continues in \mathcal{H}^+ until $t = t_1$ and $\mathbf{x}(t_1) = \mathbf{x}_0$. Then, since the first derivative of $\mathbf{c}^T \mathbf{x}(t)$ is zero and the second derivative is negative at $t = t_1$, it follows that $\mathbf{c}^T \mathbf{x}(t)$ has a local maximum at $t = t_1$ and $\mathbf{c}^T \mathbf{x}(t) = 0$. But, any small neighborhood of $\mathbf{c}^T \mathbf{x}(t_1)$ contains $\mathbf{c}^T \mathbf{x}(t) > 0$ for $t < t_1$. This contradicts the fact that $\mathbf{c}^T\mathbf{x}\left(t_1\right)$ is a local maximum. Hence, the solutions of Σ_0 cannot arrive at $\mathbf{x}_0 \in \mathcal{H}^-_2$ from \mathcal{H}^+ . Using similar reasoning with local minimums, it can be easily shown that the solutions of Σ_0 cannot arrive at $\mathbf{x}_0 \in \mathcal{H}_2^+$ from \mathcal{H}^- . On the other hand, there exist solutions **x** (*t*) of Σ_0 which starts from the second mode and continues in \mathcal{H}^- until $t = t_1$ and $\mathbf{x}(t_1) = \mathbf{x}_0$. Again $\mathbf{c}^T\mathbf{x}\left(t\right)$ has a local maximum at $t=t_1.$ But, since the first derivative of $\mathbf{c}^T\mathbf{x}(t)$ is zero and the second derivative of $\mathbf{c}^T\mathbf{x}(t)$ is negative, **x** (*t*) will go back to H^- and will not change mode.

We can summarize the observation given above as follows. If $\mathbf{x}_0 \in \mathcal{H}^-_2\left(\mathcal{H}^+_2\right)$, then the solutions of \mathcal{L}_0 can only arrive at \mathbf{x}_0 from $\mathcal{H}^-\left(\mathcal{H}^+\right)$ and do not switch mode at $\mathbf{x}_0.$ In each case, the solutions are both forward and backward Carathéodory solutions. Since forward (backward) Carathéodory solutions rule out left (right) Zeno behavior as noted in [\[18\]](#page-9-1), it follows that well-posed BPAS considered in this work do not exhibit Zeno behavior.

It is clear from the development given above that the conditions of well-posedness require sign equalities for the derivatives of solutions for both modes on the hyperplane H . On the other hand, the points on H where the derivatives of solutions for both modes are equal to the zero vector are equilibrium points of BPAS. At this stage, it is natural to look for the connections between the conditions of well-posedness and the equilibrium points of BPAS. Towards this end, suppose that A_1 and A_2 are nonsingular. Let $\hat{\mathbf{b}}_i^T := \begin{bmatrix} b_{i2} & b_{i3} & \cdots & b_{in} \end{bmatrix}$ for $i = 1, 2$. Then, the last item of [Theorem 3.1](#page-2-0) can be written as follows.

$$
\det (\mathbf{A}_{11}) \left(b_{11} - \mathbf{y}_1^T \mathbf{A}_{11}^{-1} \hat{\mathbf{b}}_1 \right) = b_{21} - \mathbf{y}_2^T \hat{\mathbf{b}}_2, \tag{6}
$$

where y_2 is as defined in Eq. [\(5\).](#page-2-2) As demonstrated in Example 3.2 this equality implies the existence of a point $\mathbf{x}_0^* \ := \ \begin{bmatrix} \hat{\mathbf{b}}_i^T \mathbf{0} \end{bmatrix}^T$ in $\mathcal{H} \cap \mathcal{S}_1 \cap \mathcal{S}_2$. The existence of such a point(which may be the equilibrium point of BPAS) was pointed out in [Remark 2.7.](#page-1-4) In what follows, we give the conditions under which \mathbf{x}_0^* is the equilibrium point of BPAS (item 5 of [Corollary 3.2\)](#page-4-0) and also state the relations between the equilibrium points of the individual subsystems and equilibrium points of BPAS (items 1–4 of [Corollary 3.2\)](#page-4-0). Note that using the partitions of system matrices given in Eqs. [\(4\)](#page-2-3) and [\(5\)](#page-2-2) and the fact that $A_{11}^{-1}\hat{b}_1 = \hat{b}_2$ by item 3 of [Theorem 3.1,](#page-2-0) it is easy to show that

$$
- \mathbf{A}_1^{-1} \mathbf{b}_1 = \begin{bmatrix} \frac{1}{\gamma} \mathbf{A}_{11}^{-1} \mathbf{z}_1 b_{11} - \mathbf{A}_{11}^{-1} \hat{\mathbf{b}}_1 - \frac{1}{\gamma} \mathbf{A}_{11}^{-1} \mathbf{z}_1 \mathbf{y}_1^T \mathbf{A}_{11}^{-1} \hat{\mathbf{b}}_1 \\ \frac{-1}{\gamma} \left(b_{11} - \mathbf{y}_1^T \mathbf{A}_{11}^{-1} \hat{\mathbf{b}}_1 \right) \\ \end{bmatrix}
$$

$$
= \begin{bmatrix} \frac{1}{\gamma} \mathbf{A}_{11}^{-1} \mathbf{z}_1 \left(b_{11} - \mathbf{y}_1^T \hat{\mathbf{b}}_2 \right) - \hat{\mathbf{b}}_2 \\ \frac{-1}{\gamma} \left(b_{11} - \mathbf{y}_1^T \hat{\mathbf{b}}_2 \right) \end{bmatrix}, \tag{7}
$$

where $\gamma = a_{1n} - \mathbf{y}_1^T \mathbf{A}_{11}^{-1} \mathbf{z}_1 \in \mathbb{R}$. Similarly, we also have

$$
-\mathbf{A}_2^{-1}\mathbf{b}_2 = \begin{bmatrix} -\hat{\mathbf{b}}_2\\ \frac{-1}{k_n} \left(b_{21} - \mathbf{y}_2^T \hat{\mathbf{b}}_2\right) \end{bmatrix}.
$$
 (8)

In view of the above development, we now state and prove the following result.

Corollary 3.2. *Suppose that* **A**¹ *and* **A**² *are nonsingular for a wellposed BPAS as defined by Eqs.* [\(2\)–\(5\)](#page-1-2)*. Then, the following hold.*

- 1. *If* $\gamma k_n > 0$ and $\frac{-1}{\gamma} (b_{11} \mathbf{y}_1^T \hat{\mathbf{b}}_2) > 0$, then $\mathbf{x}_0 = -\mathbf{A}_1^{-1} \mathbf{b}_1$ is the *unique equilibrium point of* Σ_0 *.*
- 2. If $\gamma k_n > 0$ and $\frac{-1}{\gamma} \left(b_{11} \mathbf{y}_1^{\text{T}} \hat{\mathbf{b}}_2 \right) < 0$, then $\mathbf{x}_0 = \mathbf{A}_2^{-1} \mathbf{b}_2$ is the *unique equilibrium point of* Σ_0 *.*
- 3. If γk_n < 0 and $\frac{-1}{\gamma} \left(b_{11} \mathbf{y}_1^{\mathrm{T}} \hat{\mathbf{b}}_2 \right)$ > 0, then there are two ϵ *equilibrium points* $\left(-\mathbf{A}_1^{-1}\mathbf{b}_1 \text{ and } -\mathbf{A}_2^{-1}\mathbf{b}_2\right)$ of \varSigma_0 ; one in \mathcal{H}^+ and *one in* H^- .
- 4. If $\gamma k_n < 0$ and $\frac{-1}{\gamma}\left(b_{11}-\mathbf{y}_1^{\text{T}}\hat{\mathbf{b}}_2\right) < 0$, then there are no equilib*rium points of* Σ_0 *.*
- 5. If $b_{21} \mathbf{y}_2^T \hat{\mathbf{b}}_2 = b_{11} \mathbf{y}_1^T \hat{\mathbf{b}}_2 = 0$, then $\begin{bmatrix} -\hat{\mathbf{b}}_2^T & 0 \end{bmatrix}^T$ is the unique *equilibrium point of* Σ_0 .

Proof. Recall that det (\mathbf{A}_{11}) > 0. Since γk_n > 0, then γ and k_n have the same sign and are different from zero. If $\frac{-1}{\gamma}\left(b_{11}-\mathbf{y}_1^T\hat{\mathbf{b}}_2\right)>0$, then by Eqs. [\(6\)](#page-4-1) and [\(8\)](#page-4-2) it follows that $\frac{-1}{k_n} \left(b_{21} - \mathbf{y}_2^T \hat{\mathbf{b}}_2 \right) > 0$. This implies that at $\mathbf{x}_0 = -\mathbf{A}_1^{-1}\mathbf{b}_1$, we get $\mathbf{A}_1\mathbf{x}_0 + \mathbf{b}_1 = \mathbf{0}$ and $\mathbf{c}^T \mathbf{x}_0 > 0$ (only the first mode is active). Thus, $-\mathbf{A}_1^{-1} \mathbf{b}_1$ is the unique equilibrium point of Σ_0 .

 $\text{Similarly, if } \frac{-1}{\gamma}\left(b_{11}-\mathbf{y}_1^T\hat{\mathbf{b}}_2\right) < 0 \text{, then } \frac{-1}{k_n}\left(b_{21}-\mathbf{y}_2^T\hat{\mathbf{b}}_2\right) < 0.$ Then at $\mathbf{x}_0 = -\mathbf{A}_2^{-1}\mathbf{b}_2$, we get $\mathbf{A}_2\mathbf{x}_0 + \mathbf{b}_2 = \mathbf{0}$ and $\mathbf{c}^T\mathbf{x}_0 <$ 0 (only the second mode is active). Thus, $-A_2^{-1}$ **b**₂ is the unique equilibrium point of Σ_0 .

If γk_n < 0, then γ and k_n have the different signs and are different from zero. In this case, if $\frac{-1}{\gamma}\left(b_{11}-\mathbf{y}_1^{\mathrm{T}}\hat{\mathbf{b}}_2\right)>0$, it follows $\frac{1}{k_n}\left(b_{21}-\mathbf{y}_2^T\hat{\mathbf{b}}_2\right)< 0.$ Then, at $\mathbf{x}_0=-\mathbf{A}_1^{-1}\mathbf{b}_1$, we get $\mathbf{A}_1\mathbf{x}_0+\mathbf{A}_2\mathbf{x}_1$ $\mathbf{b}_1 = \mathbf{0}$ and $\mathbf{c}^T \mathbf{x}_0 > 0$. Similarly, at $\mathbf{x}_0 = -\mathbf{A}_2^{-1} \mathbf{b}_2$, we get $\mathbf{A}_2 \mathbf{x}_0 + \mathbf{A}_3 \mathbf{x}_1$ $\mathbf{b}_2 = \mathbf{0}$ and $\mathbf{c}^T \mathbf{x}_0 < 0$. Consequently, there are two equilibrium points $\left(-\mathbf{A}_1^{-1}\mathbf{b}_1\right)$ and $\left(-\mathbf{A}_2^{-1}\mathbf{b}_2\right)$ of Σ_0 ; one in \mathcal{H}^+ and one in \mathcal{H}^- . On the other hand, if $\frac{-1}{\gamma} \left(b_{11} - \mathbf{y}_1^{\text{T}} \hat{\mathbf{b}}_2 \right)$ < 0, then $\frac{-1}{k_n} \left(b_{21} - \mathbf{y}_2^{\text{T}} \hat{\mathbf{b}}_2 \right)$

 $\mathbf{y}_2^T \hat{\mathbf{b}}_2 \Big) \ > \ 0.$ Then, at $\mathbf{x}_0 \ = \ -\mathbf{A}_1^{-1} \mathbf{b}_1$, we get $\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1 \ = \ \mathbf{0}$ and $\mathbf{c}^T\mathbf{x}_0 \ < \ 0$ where the first mode is not allowed to be active. Similarly, at $\mathbf{x}_0 = -\mathbf{A}_2^{-1}\mathbf{b}_2$, we get $\mathbf{A}_2\mathbf{x}_0 + \mathbf{b}_2 = \mathbf{0}$ and $\mathbf{c}^T\mathbf{x}_0 > 0$ where the second mode is not allowed to be active. Consequently, there are no equilibrium points of Σ_0 .

Finally, if $(b_{21} - \mathbf{y}_2^T \hat{\mathbf{b}}_2) = det(\mathbf{A}_{11}) (b_{11} - \mathbf{y}_1^T \mathbf{A}_{11}^{-1} \hat{\mathbf{b}}_1) = 0,$ then Eqs. [\(5\)](#page-2-2) and [\(6\)](#page-4-1) imply that $-{\bf A}_2^{-1}{\bf b}_2 = -{\bf A}_1^{-1}{\bf b}_1 = \begin{bmatrix} -\hat{{\bf b}}_2^T & 0 \end{bmatrix}^T$. Let $\mathbf{x}_0 = \begin{bmatrix} -\hat{\mathbf{b}}_2^T & 0 \end{bmatrix}^T$. Then, it follows that $\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1 = \mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2 =$ **0.** Consequently, $\begin{bmatrix} -\hat{\mathbf{b}}_2^T & 0 \end{bmatrix}^T$ isthe unique equilibrium point of Σ_0 . \square

4. Conclusions and future work

In this paper, well-posedness conditions (in the sense of forward Carathéodory solutions) of BPAS in R *n* , where the vector field is not necessarily continuous on the switching hyperplane H . are investigated. It is shown that these conditions reduce to a set of algebraic equations and inequalities involving the subsystem matrices and affine terms. This yields a joint structure for wellposed BPAS triples $(\textbf{c}^{T}, \textbf{A}_1, \textbf{b}_1)$ and $(\textbf{c}^{T}, \textbf{A}_2, \textbf{b}_2)$ which can be checked by simple inspection. Furthermore, it is also demonstrated that well-posedness conditions for BPAS reduce to well-posedness conditions for BPLS, if $\mathbf{b}_1 = \mathbf{b}_2 = \mathbf{0}$. Thus, the results given in this work can be used for characterization of well-posed BPLS and BPAS with discontinuous vector fields. Finally, the conditions under which well-posed BPAS have one, or two or no equilibrium points are given.

The next step along this direction could be to investigate wellposedness conditions for multi-modal systems. Towards this end, conewise linear systems, which are investigated in [\[15\]](#page-8-10) under the assumption that the vector field is continuous, can be considered. When the vector field is continuous, well-posedness is resolved. If we relax this assumption and allow the vector field to be discontinuous, the assessment of the conditions of well-posedness of conewise linear systems could be an interesting problem.

Appendix

Proof of Theorem 3.1. Since only one of the modes is active for the initial conditions in $\mathcal{H}^-\left(\mathcal{H}^+\right)$, there exist unique forward Carathéodory solutions which smoothly continue in $\mathcal{H}^-\left(\mathcal{H}^+\right)$. Therefore, in the proof, we only consider initial conditions in \mathcal{H} . Let

$$

= \begin{cases} a_{n1} \gamma_1 + a_{n2} \gamma_2 + \dots + a_{n,n-2} \gamma_{n-2} + a_{n,n-1} \gamma_{n-1} + b_{1n} \\ \gamma_{n-1} + b_{2n} \end{cases}.
$$

Let us fix γ_{n-1} so that $\gamma_{n-1} + b_{2n} = 0$. Note that the sign of $a_{n1}\gamma_1 + b_{n2}$ $a_{n2}\gamma_2+\cdots+a_{n,n-2}\gamma_{n-2}+a_{n,n-1}\gamma_{n-1}+b_{1n}$ can be changed arbitrarily by appropriate choice of the real numbers $\gamma_1, \gamma_2, \ldots, \gamma_{n-2}$. This contradicts well-posedness. Thus, it is necessary that a_{n1} = a_{n2} = ··· = $a_{n,n-2}$ = 0 or equivalently ker **c**^{*T*} ∩ ker **c**^{*T*}**A**₁ ⊂ ker **ker** $**c**^{*T*} **A**₂$ **. Since both modes are observable, it follows that** $\dim (\ker \mathbf{c}^T \cap \ker \mathbf{c}^T \mathbf{A}_1) = \dim (\ker \mathbf{c}^T \cap \ker \mathbf{c}^T \mathbf{A}_2)$ which implies that ker $\mathbf{c}^T \cap \ker \mathbf{c}^T \mathbf{A}_1 = \ker \mathbf{c}^T \cap \ker \mathbf{c}^T \mathbf{A}_2$. Then, the derivatives of ${\bf c}^T {\bf x}(t)$ at $t=0$ for both modes are given as follows.

Note that $a_{n,n-1} \neq 0$, because this contradicts observability. On the other hand, if $a_{n,n-1}$ < 0, then we can choose γ_{n-1} > \max_{L} $rac{b_{1n}}{a_{n,n-1}}$ $\left| , |b_{2n} \right|$ so that $a_{n,n-1}\gamma_{n-1} + b_{1n} < 0$ and γ_{n-1} + $b_{2n} > 0$ which implies that there are no solutions in the sense of Carathéodory. Thus, it is necessary that $a_{n,n-1} > 0$. In this case $a_{n,n-1}\gamma_{n-1} + b_{1n}$ and $\gamma_{n-1} + b_{2n}$ must have the same sign for all real numbers γ_{n-1} in order to guarantee well-posedness. Consider the following sets in H .

where $\gamma_1, \gamma_2, \ldots, \gamma_{n-1}$ are arbitrary real numbers. If $\gamma_{n-1} = 0$, then \mathcal{H}_{11} and \mathcal{H}_{21} are affine spaces (of dimension $n-2$) which describe the set of initial conditions where $\frac{d}{dt}$ ($\mathbf{c}^T \mathbf{x}$) $|_{t=0} = 0$ for both modes. If these affine spaces are not equal, then we have three alternatives.

- 1. If γ_{n-1} is chosen so that $\gamma_{n-1} > \max \left\{-b_{2n}, -\frac{b_{1n}}{a_{n,n-1}}\right\}$, then $\frac{d}{dt}$ (**c**^T**x**) $|_{t=0}$ > 0 for both modes and there is a unique forward Carathéodory solution which smoothly continues in the first mode.
- 2. If γ_{n-1} is chosen so that γ_{n-1} < min $\left\{-b_{2n}, -\frac{b_{1n}}{a_{n,n-1}}\right\}$, then $\frac{d}{dt}$ (**c**^T**x**) $|_{t=0}$ < 0 for both modes and there is a unique forward Carathéodory solution which smoothly continues in the second mode.
- 3. If γ_{n-1} is chosen so that $\min \left\{ -b_{2n}, -\frac{b_{1n}}{a_{n,n-1}} \right\}$ < γ_{n-1} < $\max\left\{-b_{2n}, -\frac{b_{1n}}{a_{n,n-1}}\right\}$, then the sign of $\frac{d}{dt}$ (**c**^T**x**) $|_{t=0}$ is different for each mode. If $a_{n,n-1}\gamma_{n-1} + b_{1n} > 0$ and $\gamma_{n-1} + b_{2n} < 0$, then there are two solutions which smoothly continue in separate modes. If $a_{n,n-1}\gamma_{n-1} + b_{1n} < 0$ and $\gamma_{n-1} + b_{2n} > 0$, then there are no solutions in the sense of Carathéodory.

Consequently, it is necessary that $a_{n,n-1}b_{2n} = b_{1n}$ or equivalently $\mathcal{H}_{11} = \mathcal{H}_{21}$. Let \mathcal{H}_1 be an affine space (of dimension $n - 2$) defined as $\mathcal{H}_1 := \mathcal{H}_{11} = \mathcal{H}_{21}$. Then, we have

are necessary for the existence of a unique forward Carathéodory solution for each $\mathbf{x}_0 \in \mathcal{H}$, except for $\mathbf{x}_0 \in \mathcal{H}_1$.

Conversely, suppose that the conditions given in [\(9\)](#page-6-0) hold. Then, $\mathcal{H}_1(=\mathcal{H}_{11}=\mathcal{H}_{21})$ divides \mathcal{H} into two affine spaces \mathcal{H}_1^+ and $\mathcal{H}_1^$ defined as follows.

Thus, for each initial condition $\mathbf{x}_0 \in \mathcal{H}^+_1$ (\mathcal{H}^-_1) there exists a unique forward Carathéodory solution which smoothly continues in the first (second) mode. Consequently, the conditions given in [\(9\)](#page-6-0) are both necessary and sufficient conditions for the existence of a unique forward Carathéodory solution for each $x_0 \in \mathcal{H}$, except for $\mathbf{x}_0 \in \mathcal{H}_1$. Note further that $\mathcal{H}_1^+ \subset \mathcal{S}_1$ and $\mathcal{H}_1^- \subset \mathcal{S}_2$.

It is clear that for any initial condition in \mathcal{H}_1 we have to check the sign of the second derivative. Towards this end, let \mathbf{x}_0 = $\begin{bmatrix} \gamma_1 & \gamma_2 & \cdots & \cdots & \gamma_{n-2} & -b_{2n} & 0 \end{bmatrix}^T \in \mathcal{H}_1$. In this case, we have

Then, there will be cases where there are no solutions in the sense of Carathéodory. Hence, it is necessary that $a_{n-1,1} = a_{n-1,2} = \cdots = a_{n-1,n-3} = 0$ or equivalently

Note that if $\gamma_{n-2} = 0$, then \mathcal{H}_{12} and \mathcal{H}_{22} are affine spaces in \mathcal{H}_1 which describe the set of initial conditions where $\frac{d}{dt}$ (**c**^T**x**) $|_{t=0} = \frac{d^2}{dt^2}$ $\frac{d^2}{dt^2}$ $(c^T x)$ $|_{t=0}$ = 0, for both modes. If these affine spaces are not equal, then since $a_{n,n-1} > 0$, we have three alternatives.

d 2 $\frac{d^2}{dt^2}$ (**c**^T**x**) $|_{t=0}$ is different for each mode. Then, either there are two solutions, (one for each mode) or there are no solutions in the sense of Carathéodory. Consequently, it is necessary that $b_{2,n-1} = \frac{b_{1,n-1}-a_{n-1,n-1}b_{2n}}{a_{n-1,n-2}}$ $\frac{1-a_{n-1,n-1}b_{2n}}{a_{n-1,n-2}}$ or equivalently $\mathcal{H}_{12} = \mathcal{H}_{22}$. Let \mathcal{H}_{2} be an affine space (of dimension *n*−3) defined as $\mathcal{H}_2 := \mathcal{H}_{12}$ H_{22} . Then, we get

$$
\mathcal{H}_2 = \left\{ \mathbf{x}_0 \in \mathcal{H}_1 \mid \mathbf{c}^T \mathbf{A}_1 (\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1) = \mathbf{c}^T \mathbf{A}_2 (\mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2) = 0 \right\},
$$

= \left\{ \mathbf{x}_0 \in \mathcal{H}_1 \mid \mathbf{x}_0
$$

= \left[\gamma_1 \quad \gamma_2 \quad \cdots \quad \gamma_{n-3} \quad -b_{2,n-1} \quad -b_{2n} \quad 0 \right]^T \right\},
$$

then the conditions

$$
a_{n-1,1} = a_{n-1,2} = \dots = a_{n-1,n-3} = 0, a_{n-1,n-2} > 0,
$$

and

b_{2,n-1} = \frac{b_{1,n-1} - a_{n-1,n-1}b_{2n}}{a_{n-1,n-2}}

 (10)

are necessary for the existence of a unique forward Carathéodory solution for each $\mathbf{x}_0 \in \mathcal{H}_1$, except for $\mathbf{x}_0 \in \mathcal{H}_2$.

Conversely, if the conditions given in [\(10\)](#page-6-1) hold, then \mathcal{H}_2 divides \mathcal{H}_1 into two affine spaces \mathcal{H}_2^+ and \mathcal{H}_2^- defined as follows.

\mathcal{H}_2^+ := \left\{ \mathbf{x}_0 \in \mathcal{H}_1 | \mathbf{c}^T \mathbf{A}_1 (\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1) > 0 \right\}

and

\mathbf{c}^T \mathbf{A}_2 (\mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2) > 0 \right\},
$$

$$
\mathcal{H}_2^- := \left\{ \mathbf{x}_0 \in \mathcal{H}_1 | \mathbf{c}^T \mathbf{A}_1 (\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1) < 0 \right\}
$$

and
$$
\mathbf{c}^T \mathbf{A}_2 (\mathbf{A}_2 \mathbf{x}_0 + \mathbf{b}_2) < 0 \right\}.
$$

Therefore, for each initial condition $\mathbf{x}_0 \in \mathcal{H}^+_2(\mathcal{H}^-_2)$ there exists unique forward Carathé odory solution which smoothly continues in the first (second) mode. Consequently, the conditions given above in expression [\(10\)](#page-6-1) are both necessary and sufficient conditions for the existence of a unique forward Carathéodory solution for each $\mathbf{x}_0 \in \mathcal{H}_1$, except for $\mathbf{x}_0 \in \mathcal{H}_2$. Note further that $\mathcal{H}_2^+ \subset \mathcal{S}_1$ and $H_2^- \subset \mathcal{S}_2$.

Also note that the relation between b_{2n} , b_{2n-1} and b_{1n} , $b_{1,n-1}$ can be written compactly as follows.

$$
\begin{bmatrix} a_{n-1,n-2} & a_{n-1,n-1} \ 0 & a_{n,n-1} \end{bmatrix} \begin{bmatrix} b_{2,n-1} \ b_{2n} \end{bmatrix} = \begin{bmatrix} b_{1,n-1} \ b_{1n} \end{bmatrix}.
$$

Furthermore, we have

where \times denotes entries which are not calculated explicitly.

For the rest of the proof, we use mathematical induction, which essentially follows similar lines as above. Towards this end, suppose that $\bigcap_{r=0}^s$ ker $\mathbf{c}^T \mathbf{A}_1^r = \bigcap_{r=0}^s$ ker $\mathbf{c}^T \mathbf{A}_2^r$ for $s = 1, 2, \ldots, k < 1$ *n* − 2, or equivalently $a_{n-i+1,j}$ = 0 for *i* = 1, 2, ..., *k* and *j* = 1, 2, ..., *n* − *i* − 1, hold. Also suppose that $a_{n-i+1,n-i}$ > 0 for $i = 1, 2, ..., k$ and

Also let

\mathbf{c}^T \mathbf{A}_1^k = \begin{bmatrix} 0 & \cdots & 0 & a_{n,n-1}a_{n-1,n-2} \dots a_{n-k+1,n-k} & \times & \cdots & \times \end{bmatrix}.
$$

Note that the preceding statements hold for $k = 1, 2$. Let $\mathbf{x}_0 \in \mathcal{H}_k$ be an initial condition given as follows.

$$
\mathbf{x}_0 = \begin{bmatrix} \gamma_1 & \gamma_2 & \cdots & \gamma_{n-k-1} & -b_{2,n-k+1} & \cdots & -b_{2n} & 0 \end{bmatrix}^T, \quad (12)
$$

where \mathcal{H}_k is an affine space of dimension $n - k - 1$. Then, for each $\mathbf{x}_0 \in \mathcal{H}_k$, the derivatives of the trajectories are zero up to order *k* for both modes and $\mathcal{H}_k \subset \mathcal{H}_{k-1} \subset \cdots \subset \mathcal{H}_2 \subset \mathcal{H}_1$. Let us consider $(k + 1)$ th derivative.

$$
\frac{d^{k+1}}{dt^{k+1}}\left(\mathbf{c}^T\mathbf{x}\right)|_{t=0} = \begin{cases} \mathbf{c}^T\mathbf{A}_1^k\left(\mathbf{A}_1\mathbf{x}_0 + \mathbf{b}_1\right) \\ \mathbf{c}^T\mathbf{A}_2^k\left(\mathbf{A}_2\mathbf{x}_0 + \mathbf{b}_2\right) \end{cases} = \begin{cases} \mathbf{c}^T\mathbf{A}_1^k\left(\mathbf{A}_1\mathbf{x}_0 + \mathbf{b}_1\right) \\ \gamma_{n-k-1} + \mathbf{b}_{2,n-k} \end{cases}.
$$

Then, using Eqs. [\(11\)](#page-7-0) and [\(12\),](#page-7-1) $A_1x_0 + b_1$ can be written as in [Box I.](#page-8-15) This implies that

$$
\mathbf{c}^{T} \mathbf{A}_{1}^{k} (\mathbf{A}_{1} \mathbf{x}_{0} + \mathbf{b}_{1}) = a_{n,n-1} a_{n-1,n-2} \dots a_{n-k+1,n-k} [a_{n-k,1} \gamma_{1} + \dots + a_{n-k,n-k-1} \gamma_{n-k-1} + b_{1,n-k} - a_{n-k,n-k} b_{2,n-k+1} - \dots - a_{n-k,n-1} b_{2n}].
$$

Let us fix γ_{n-k-1} such that $\gamma_{n-k-1} + b_{2,n-k} = 0$. Then, as in the previous cases, the sign of $b_{2,n-k}$ is fixed and the sign of $\mathbf{c}^T \mathbf{A}^k_1 (\mathbf{A}_1 \mathbf{x}_0 + \mathbf{b}_1)$ can be changed arbitrarily by an appropriate choice of $\gamma_1, \gamma_2, \ldots, \gamma_{n-k-2}$. Hence, it is necessary that $a_{n-k,1} =$ $a_{n-k,2} = \cdots = a_{n-k,n-k-2} = 0$ or equivalently $\bigcap_{r=0}^{k+1}$ ker $\mathbf{c}^T \mathbf{A}_1^r = 0$ $\bigcap_{r=0}^{k+1}$ ker $\mathbf{c}^T \mathbf{A}_2^r$. Then, $(k+1)$ th derivative can be calculated as in [Box II.](#page-8-16)

Note that $a_{n-k,n-k-1} \neq 0$, because this contradicts observability. Furthermore, if $a_{n-k,n-k-1} < 0$, then we can choose $\gamma_{n-k-1} >$ $max{||}$ *^b*1,*n*−*k*−*an*−*k*,*n*−*kb*2,*n*−*k*+1−···−*an*−*k*,*n*−1*b*2*ⁿ* $\vert b_{2,n-k} \vert$ so that

$$

$$

and $\gamma_{n-k-1} + b_{2,n-k} > 0$, which implies that there are no solutions in the sense of Carathéodory. Thus, it is necessary that *an*−*k*,*n*−*k*−¹ > 0, which implies that $a_{n,n-1}a_{n-1,n-2} \ldots a_{n-k,n-k-1} > 0$. Note that

$$
\begin{bmatrix} a_{n-k,n-k-1}\gamma_{n-k-1} + b_{1,n-k} - a_{n-k,n-k}b_{1,n-k+1} \\ - \cdots - a_{n-k,n-1}b_{1n} \end{bmatrix}
$$

and γ_{n-k-1} + $b_{2,n-1}$ must have same sign for the existence of a unique forward Carathéodory solution starting from **x**0. Let us now consider the following sets of equations in [Box III,](#page-8-17) where $\gamma_1, \gamma_2, \ldots, \gamma_{n-k-1}$ are arbitrary real numbers. Note that if $\gamma_{n-k-1} = 0$, then $\mathcal{H}_{1,k+1}$ and $\mathcal{H}_{2,k+1}$ are affine spaces in \mathcal{H}_k which describe the set of initial conditions where $\frac{d}{dt}$ ($\mathbf{c}^T \mathbf{x}$) $|_{t=0}$ = *d* 2 $\frac{d^2}{dt^2}$ (**c**^T**x**) $|_{t=0} = \cdots = \frac{d^{k+1}}{dt^{k+1}}$ $\frac{d^{k+1}}{dt^{k+1}}\left(\mathbf{c}^T\mathbf{x}\right)|_{t=0} = 0$, for first and second modes, respectively. If these affine spaces are not equal, then we have three alternatives.

1. If γ_{n-k-1} is chosen so that

\gamma_{n-k-1} > \max\left\{-b_{2,n-k}, -\frac{b_{1,n-k}-a_{n-k,n-k}b_{2,n-k+1}-\cdots-a_{n-k,n-1}b_{2n}}{a_{n-k,n-k-1}}\right\},\

2. If γ*n*−*k*−¹ is chosen so that

\gamma_{n-k-1} < \min\left\{-b_{2,n-k}, -\frac{b_{1,n-k}-a_{n-k,n-k}b_{2,n-k+1}-\cdots-a_{n-k,n-1}b_{2,n}}{a_{n-k,n-k-1}}\right\}

then $\frac{d^{k+1}}{dt^{k+1}}$ d*t* forward Carathéodory solution which smoothly continues in $\frac{d^{k+1}}{d^{k+1}}$ $\left(\mathbf{c}^T\mathbf{x}\right)|_{t=0} < 0$ for both modes and there is a unique the second mode.

3. If γ_{n-k-1} is chosen so that

then the sign of $\frac{d^{k+1}}{dt^{k+1}}$ $\frac{d^{k+1}}{dt^{k+1}}$ (c^T**x**) $|_{t=0}$ is different for each mode. Then, either there are two solutions, (one in each mode) or there are no solutions in the sense of Carathéodory. Consequently, it is $\text{necessary that } b_{2,n-k} = \frac{b_{1,n-k} - a_{n-k,n-k}b_{2,n-k+1} - \cdots - a_{n-k,n-1}b_{2,n}}{a_{n-k,n-k+1}}$ $a_{n-k,n-k-1}$ $a_{n-k,n-k-1}$ or equivalently $\mathcal{H}_{1,k+1} = \mathcal{H}_{2,k+1}$. Let \mathcal{H}_{k+1} be an affine space (of dimension *n* − *k* − 2) defined as \mathcal{H}_{k+1} := $\mathcal{H}_{1,k+1} = \mathcal{H}_{2,k+1}$. Then, we have given equations in [Box IV.](#page-8-18)

Furthermore, the equation above also implies that $b_{1,n-k}$ = $a_{n-k,n-k-1}b_{2,n-k} + a_{n-k,n-k}b_{2,n-k+1} + \cdots + a_{n-k,n-1}b_{2n}$. Therefore, the conditions

Conversely, if the conditions given in expression (13) hold, then \mathcal{H}_{k+1} divides \mathcal{H}_k into two affine spaces \mathcal{H}_{k+1}^+ and \mathcal{H}_{k+1}^- given as fol-

This implies that there exists a unique forward Carathéodory solution for each $\mathbf{x}_0 \in \mathcal{H}_k$, except $\mathbf{x}_0 \in \mathcal{H}_{k+1}$. Thus, the conditions given in expression [\(13\)](#page-7-2) are both necessary and sufficient for the existence of a unique forward Carathéodory solution for each $\mathbf{x}_0 \in \mathcal{H}_k$, except $\mathbf{x}_0 \in \mathcal{H}_{k+1}$. Then, by induction it follows that items 1, 2 and 3 of [Theorem 3.1](#page-2-0) are necessary and sufficient for the existence of a unique forward Carathéodory solution for each $\mathbf{x}_0 \in \mathbb{R}^n$, except for \mathcal{H}_{n-1} . Note further that \mathcal{H}_i^+ \subset \mathcal{S}_1 and $\mathcal{H}_i^ \subset$ \mathcal{S}_2 for *i* = 1, 2, . . . , *n*−1. Moreover, H_{n-1} has zero dimension or consists of a single point $\mathbf{x}_0^* = \begin{bmatrix} -b_{22} & -b_{23} & \cdots & -b_{2,n-1} & -b_{2n} & 0 \end{bmatrix}^T$. Recall that for this initial condition, all the derivatives up to order *n* − 1 are zero for both modes. Calculating the *n*th derivative of $(c^T x)$ for both modes at $t = 0$, we get

$$
\frac{d^n}{dt^n} (\mathbf{c}^T \mathbf{x})\big|_{t=0} = \begin{cases} \mathbf{c}^T \mathbf{A}_1^{n-1} (\mathbf{A}_1 \mathbf{x}_0^* + \mathbf{b}_1) \\ \mathbf{c}^T \mathbf{A}_2^{n-1} (\mathbf{A}_2 \mathbf{x}_0^* + \mathbf{b}_2) \end{cases}
$$

=
$$
\begin{cases} a_{n,n-1}a_{n-1,n-2} \dots a_{21} \left[b_{11} - a_{11}b_{22} - \dots - a_{1,n-1}b_{2n} \right] \\ b_{21} - \sum_{j=1}^{n-1} k_j b_{2,j+1} \end{cases}

Note that ${\bf c}^T {\bf A}_i^{k-1} \left({\bf A}_i {\bf x}_0^* + {\bf b}_i \right) = 0$ for $i = 1, 2$ and $k = 1, 2, \ldots, n-1$ 1. Therefore, if

$$
a_{n,n-1}a_{n-1,n-2}\dots a_{21} [b_{11}-a_{11}b_{22}-\dots-a_{1,n-1}b_{2n}]
$$

= $b_{21}-\sum_{j=1}^{n-1}kj b_{2,j+1}$ (14)

then, since both modes are observable, it follows that $(A_1x_0^* + b_1)$ $=$ $(A_2x_0^* + b_2)$. This means that the solutions for both modes are the same. Conversely, if the solutions for both modes are the same, then $(A_1x_0^* + b_1) = (A_2x_0^* + b_2)$ which implies that Eq. [\(14\)](#page-8-19) holds. Consequently, for any $\mathbf{x}_0^* \in \mathcal{S}_1 \cap \mathcal{S}_2$ solutions in both modes are the same and this concludes the proof. \square
