Constants for Besov Spaces $b_{p,q}^{s}$, 0

ABSTRACT

Sharp estimates are obtained for the rates of blow up of the norms of embeddings of Besov spaces $b_{p,q}^s$ in Lorentz spaces as the parameters approach critical values. In [8] the case $1 \leq p < \infty$ was investigated. The case 0 of the present paper requires different methods as the pointwise estimates established are different and the interpolation argument used in [8] is no longer available.

Key words: Besov spaces, Lorentz spaces, embedding norms, rates of blow-up. 2000 Mathematics Subject Classification: 46E30, 46E35.

Introduction

In [8] we obtained sharp estimates for the rates of blow up of the norms of embeddings of Besov spaces in Lorentz spaces as the various parameters approached critical values. We describe this work briefly so as to provide some background and motivation for the present paper.

Let $p \in (0,\infty)$, $q \in (0,\infty]$, denote by $\|\cdot\|_p$ the standard (quasi-)norm on $L_p = L_p(\mathbf{R}^n)$ and let $L_{p,q}$ be the usual Lorentz space, defined by the quasinorm

$$||f||_{p,q} \coloneqq \begin{cases} \left(\int_0^\infty \{t^{1/p} f^*(t)\}^q \frac{dt}{t} \right)^{1/q}, & 0 < q < \infty \\\\ \sup_{0 < t < \infty} \{t^{1/p} f^*(t)\}, & q = \infty. \end{cases}$$

Here f^* is the non-increasing rearrangement of f, given by

$$f^*(t) = \inf\{\lambda \ge 0 : \mu_f(\lambda) \le t\}, \quad t \ge 0,$$

where μ_f is the distribution function of f, defined by

$$\mu_f(\lambda) = |\{x \in \mathbf{R}^n : |f(x)| \ge \lambda\}|_n$$

 $|\cdot|_n$ denoting Lebesgue *n*-measure. We remark that all the spaces considered in this paper will consist of real- or complex-valued functions. Given any $s \in (0, \infty)$, the (homogeneous) Besov space $b_{p,q}^s$ is defined to be the set of all $f \in L_p(\mathbf{R}^n)$ with finite quasinorm

$$\|f \mid b_{p,q}^s\| \coloneqq \left(\int_0^\infty \{t^{-s}\omega_p^k(t,f)\}^q \frac{dt}{t}\right)^{1/q},$$

(suitably interpreted when $q = \infty$), where $\omega_p^k(t, f) \coloneqq \sup_{|h| \le t} \|\Delta_h^k f\|_p$ is the k^{th} -order L_p -modulus of continuity of f, Δ_h^k being the k^{th} -order difference operator with step length h defined recursively by

$$\Delta_h f(x) = \Delta_h^1 f(x) \coloneqq f(x+h) - f(x), \quad \Delta_h^k \coloneqq \Delta_h^1 \Delta_h^{k-1}, \quad (k \ge 2).$$

Here k is any natural number greater than s; different choices of k give equivalent quasinorms. We shall also write $b_{p,q}^s(k)$ rather than $b_{p,q}^s$ if it is desirable to stress the dependence on k. Moreover, we shall write $\omega_p(t, f)$ instead of $\omega_p^1(t, f)$.

It is well known (see [19]) that, if $p \in [1, \infty)$,

$$b_{p,q}^s \hookrightarrow L_{r,q}$$
, where $1/r = 1/p - s/n$ and $0 < s < n/p$, (1)

where by $X \hookrightarrow Y$ we mean that X is continuously embedded in Y. In [8] sharp estimates were obtained of the rates of blow up of the embedding constant as $s \to (n/p)$ in terms of

$$b_1 \coloneqq \sup_{f \neq 0} \|f\|_{r,q} / \|f \mid b_{p,q}^s\|, b_2 \coloneqq \sup_{f \neq 0} \|f\|_r / \|f \mid b_{p,q}^s\|.$$
(2)

Since $s \to n/p$ and 0 < s < k, we must have $n/p \leq k$. It was shown that as $s \to n/p < k$, with $1 and <math>0 < q \leq \infty$,

$$b_1 \approx r^c$$
, $b_2 \approx r^{(1-1/q)_+}$, where $a_+ = \max(a, 0)$ and $c = \max(1, 1/q)$. (3)

Here we use the notation $c \leq d$ or $d \geq c$ to mean that c is bounded above by a multiple of d, the multiple being independent of variables in c and d; also, $c \approx d$ means that $c \leq d$ and $d \leq c$. If k = n/p the results were different since $||f| |b_{p,q}^s||$ may tend to infinity as $s \to n/p = k$. With $s = \sigma k$, $0 < \sigma < 1$, we showed that if 1 , <math>k = n/p, and $0 < q \leq \infty$, then

$$b_{p,q}^{k\sigma} \hookrightarrow (1-\sigma)^{-a+c} L_{r,q},$$

where

$$1/r = (1 - \sigma)/p, \quad a = \min(1/p, 1/q), \quad c = \max(1, 1/q)$$

In this, by $X \hookrightarrow \lambda Y$, where X and Y are quasi-Banach spaces and $\lambda > 0$, we mean that there is a constant C > 0, independent of λ , such that for all $f \in X$, $\lambda ||f| |Y|| \le C ||f| |X||$. Special cases of these results were proved by Bourgain, Brezis, and Mironescu ([5,6]), Maz'ya and Shaposhnikova ([15,16]), Kolyada and Lerner ([11]). For the embedding constants b_1 and b_2 of (2) we proved that if 1 , <math>k = n/p, $q \in [1,\infty]$, and $1/r = (1 - \sigma)k/n$, then as $r \to \infty$,

$$b_1 \approx r^{1-1/p}, b_2 \approx r^{1-2/p}.$$
 (4)

In this paper we extend the embedding (1) to cover the case in which 0and make corresponding extensions of (3) concerning the rates of blow up of theembedding constants. We show that

$$b_{p,q}^{n/p-(1-\sigma)n} \hookrightarrow r^{-c}L_{r,q},$$

where

$$1/r = 1 - \sigma$$
, $0 < \sigma < 1$, $c = \max(1, 1/q)$, $0 ,$

and that as $\sigma \to 1$, with 0 , <math>n/p < k, and $0 < q \le \infty$,

$$b_1 \approx r^c, \quad b_2 \approx r^{(1-1/q)_+}, \quad \text{where} \quad a_+ = \max(a, 0).$$
 (5)

The estimates (5) are also proved when n/p = k, but only in the case n = 1; comparison with (4) shows that the cases p < 1 and p > 1 give entirely different results. The proofs make substantial use of the (nonlinear) spaces $L^{(\gamma)}(r,q)$ defined to be the set of all functions $f \in L_{\gamma} + L_{\infty}$ ($0 < \gamma \leq 1$) such that $f^*(\infty) = 0$ and

$$\|f \mid L^{(\gamma)}(r,q)\| \coloneqq \begin{cases} \left\{ \int_0^\infty t^{q/r} \left((|f|^\gamma)^{**}(t) - (|f|^\gamma)^*(t) \right)^{q/\gamma} \frac{dt}{t} \right\}^{1/q}, & 0 < q < \infty, \\ \sup_{t>0} t^{1/r} \left((|f|^\gamma)^{**}(t) - (|f|^\gamma)^*(t) \right)^{1/\gamma}, & q = \infty, \end{cases}$$

is finite (see [2, 12, 17]). Here $g^{**}(t) = t^{-1} \int_0^t g^*(s) \, ds$.

The paper concludes with a brief discussion of the supercritical case of embeddings of Besov spaces, by which we mean that the target space is L_{∞} , and the proof of sharp embeddings of Besov spaces in the critical case s = n/p (see also [13, 14] and for Sobolev spaces see [1,9,12,17]).

1. Preliminaries

1.1. The spaces $L^{(\gamma)}(r,q)$

These spaces will play an important technical rôle in our arguments. For $0 < q \le \infty$ and $-\infty < 1/r < 1/\gamma$, $0 < \gamma \le 1$, the (nonlinear) space $L^{(\gamma)}(r,q)$ is defined (following [2,12] and [1,17]) to be the family of all $f \in L_{\gamma} + L_{\infty}$ such that $f^*(\infty) = 0$ and

$$\|f \mid L^{(\gamma)}(r,q)\| \coloneqq \left\{ \int_0^\infty t^{q/r} (\delta_\gamma f^*(t))^q \frac{dt}{t} \right\}^{1/q} < \infty$$

(with the natural interpretation when $q = \infty$). Here

$$\delta_{\gamma} f^{*}(t) = \left((|f|^{\gamma})^{**}(t) - (|f|^{\gamma})^{*}(t) \right)^{1/\gamma}$$

and $f^{**}(t) = t^{-1} \int_0^t f^*(s) ds$. We recall that (see [3, Proposition 2.1.7]) $(|f|^p)^* = (f^*)^p$. Since $\frac{d}{dt}(|f|^{\gamma})^{**}(t) = t^{-1}\{(|f|^{\gamma})^*(t) - (|f|^{\gamma})^{**}(t)\}$, it follows that

$$(|f|^{\gamma})^{**}(t) = \int_{t}^{\infty} \left((|f|^{\gamma})^{**}(s) - (|f|^{\gamma})^{*}(s) \right) \frac{ds}{s} \quad \text{if} \quad f^{*}(\infty) = 0.$$
(6)

Note that an application of l'Hôpital's rule to $f^{**}(t) = t^{-1} \int_0^t f^*(s) ds$ shows that the condition $f^*(\infty) = 0$ is equivalent to $f^{**}(\infty) = 0$. Moreover,

$$L^{(\gamma)}(\infty,\gamma) = L_{\infty}.$$

The case $\gamma = 1$ corresponds to the spaces L(r,q) used in [8]. Routine inequalities show that

$$L(r,q) \hookrightarrow L^{(\gamma)}(r,q) \quad \text{if} \quad -\infty < 1/r < \gamma < 1, \quad \gamma > 0,$$

and

$$L^{(\gamma_1)}(r,q) \hookrightarrow L^{(\gamma)}(r,q) \quad \text{if} \quad -\infty < 1/r < \gamma < \gamma_1, \quad \gamma > 0,$$

with an obvious extension of the use of the symbol \hookrightarrow .

Many properties of the spaces $L^{(\gamma)}(r,q)$ follow from those known for L(r,q) together with the facts that $f \in L^{(\gamma)}(r,q)$ if and only if $|f|^{\gamma} \in L(r/\gamma, q/\gamma)$, and

$$||f| L^{(\gamma)}(r,q)|| = |||f|^{\gamma} | L(r/\gamma, q/\gamma)||^{1/\gamma}.$$

In particular, we have the following embedding result immediately from [8, Lemma 1.1].

Lemma 1.1. Let $0 < \gamma < r < \infty, \gamma \leq 1, 0 < q \leq \infty$ and put $c = \max(1/\gamma, 1/q)$. Then

$$L^{(\gamma)}(r,q) \hookrightarrow r^{-c}L_{r,q}.$$

We note in passing that we can easily extend some of the results of [7] to the case when the functions involved are not necessarily integrable. First, we generalise the spaces $L^{(\gamma)}(r,q)$, replacing the weight $t^{q/r-1}$ by a general weight w. Thus we define the (nonlinear) space $L^{(\gamma)}(w,q)$ to be the set of all $f \in L_{\gamma} + L_{\infty}$ such that $f^*(\infty) = 0$ and

$$||f| L^{(\gamma)}(w,q)|| \coloneqq \left\{ \int_0^\infty (\delta_\gamma f^*(t))^q w(t) \, dt \right\}^{1/q} < \infty$$

(with the usual understanding when $q = \infty$). The case $\gamma = 1$ corresponds to the spaces considered in [7] and there denoted by $S_q(w)$. We remark that $f \in L^{(\gamma)}(w,q)$ if and only if $|f|^{\gamma} \in L(w, q/\gamma)$, and

$$||f| L^{(\gamma)}(w,q)|| = |||f|^{\gamma} | L(w,q/\gamma)||^{1/\gamma}$$

Now consider the corresponding generalised Lorentz spaces $\Lambda^{(\gamma)}(w,q)$ with quasi-norm

$$||f| \Lambda^{(\gamma)}(w,q)|| \coloneqq \left\{ \int_0^\infty ((|f|^{\gamma})^{**})^{q/\gamma} w(t) \, dt \right\}^{1/q}$$

(interpreted appropriately when $q = \infty$). As a consequence of the above remark and [7, Theorem 3.3] concerning the spaces L(w, q) we see that

$$L^{(\gamma)}(w,q) = \Lambda^{(\gamma)}(w,q)$$
 for $q > \gamma$ if and only if $w \in RB_{q/\gamma}$.

Here the class of weights RB_p is defined in [7]: for $0 , <math>w \in RB_p$ if there is a constant c > 0 such that, for all r > 0,

$$\int_0^r w(s) \, ds \le cr^p \int_r^\infty w(s) s^{-p} \, ds.$$

Analogously, $L^{(\gamma)}(w,q)$ is a quasi-normed space for $q > \gamma$ if and only if $w \in RB_{q/\gamma}$.

1.2. Pointwise estimates for the rearrangement

Lemma 1.2. Let $k \in \mathbf{N}$ and suppose that $0 . Then for all <math>f \in L_p(\mathbf{R}^n)$,

$$\{(|f|^p)^{**}(t) - (|f|^p)^{**}(2t)\}^{1/p} \lesssim t^{-1/p} \omega_p(t^{1/n}, f), \quad 0 < t < \infty,$$
(7)

where $\omega_p = \omega_p^1$, and

$$(|f|^{p})^{**}(t) - (|f|^{p})^{**}(2t) \lesssim \int_{t}^{\infty} \int_{s_{k-1}}^{\infty} \cdots \int_{s_{2}}^{\infty} s_{1}^{-1} \{\omega_{p}^{k}(s_{1}^{1/n}, f)\}^{p} \frac{ds_{1}}{s_{1}} \cdots \frac{ds_{k-1}}{s_{k-1}},$$
$$0 < t < \infty, \quad k \ge 2. \quad (8)$$

Proof. First, note that

$$(|f|^{p})^{**}(t) - (|f|^{p})^{*}(t) \le 2\{(|f|^{p})^{**}(t) - (|f|^{p})^{**}(2t)\}.$$
(9)

This follows from a more general inequality: see [20, Lemma 3.2]. Here we present another simple proof. From (6) it follows that

$$(|f|^p)^{**}(t) - (|f|^p)^{**}(2t) = \int_t^{2t} \{(|f|^p)^{**}(s) - (|f|^p)^{*}(s)\} \frac{ds}{s}$$

and we now simply use the fact that $t \mapsto t\{(|f|^p)^{**}(t) - (|f|^p)^*(t)\}$ is non-decreasing since its derivative is $-t\frac{d}{dt}(|f|^p)^*(t)$. Let t > 0 and let B_t be the ball in \mathbf{R}^n with centre 0 and volume 2t. Let $u \in B_t$.

Since

$$|f(x)| \le |\Delta_u f(x)| + |f(x+u)|,$$

and hence

$$|f(x)|^p \le |\Delta_u f(x)|^p + |f(x+u)|^p$$
,

we have, integrating with respect to u over B_t ,

$$2t|f(x)|^{p} \leq \int_{B_{t}} |\Delta_{u}f(x)|^{p} du + \int_{0}^{2t} (|f|^{p})^{*}(s) \, ds.$$

Now integrate with respect to x over a subset E of \mathbb{R}^n with Lebesgue n-measure t and take the supremum over all such sets E. This gives (see [3, p. 53, Proposition 2.3.3])

$$2t\{(|f|^{p})^{**}(t) - (|f|^{p})^{**}(2t)\} \leq \int_{B_{t}} (|\Delta_{u}f|^{p})^{**}(t) \, du$$

$$= \frac{1}{t} \int_{B_{t}} \int_{0}^{t} (|\Delta_{u}f|^{p})^{*}(s) \, ds \, du \lesssim \frac{1}{t} \int_{B_{t}} \|\Delta_{u}f\|_{p}^{p} \, du$$

$$\leq \sup_{|u| \leq (2t/\varpi_{n})^{1/n}} \|\Delta_{u}f\|_{p}^{p}$$

$$= \{2\omega_{p}^{1}((2t/\varpi_{n})^{1/n}, f)\}^{p}, \qquad (10)$$

where ϖ_n is the measure of the unit ball in \mathbb{R}^n . In view of [4, (5.4.5), p. 332], and the fact that ω_p^1 is an increasing function, we see that (7) follows. Further, applying (6) to $\Delta_u f$ and using (9) and (10), we obtain

$$(|f|^{p})^{**}(t) - (|f|^{p})^{**}(2t) \lesssim t^{-1} \int_{B_{t}} \int_{t}^{\infty} \{(|\Delta_{u}f|^{p})^{**}(s) - (|\Delta_{u}f|^{p})^{**}(2s)\} \frac{ds}{s} \, du. \quad (11)$$

Now (7) gives

$$(|f|^p)^{**}(t) - (|f|^p)^{**}(2t) \lesssim t^{-1} \int_{B_t} \int_t^\infty s_1^{-1} \{\omega_p(s_1^{1/n}, \Delta_u f)\}^p \frac{ds_1}{s_1} \, du.$$

From [3, Lemma 5.4.11] and this we see that

$$(|f|^p)^{**}(t) - (|f|^p)^{**}(2t) \lesssim \int_t^\infty s_1^{-1} \{\omega_p^2(s_1^{1/n}, f)\}^p \frac{ds_1}{s_1},$$

which is the required estimate (8) for k = 2. We proceed by induction. If (8) is valid for some $k \ge 2$, then from (11) we have

$$(|f|^{p})^{**}(t) - (|f|^{p})^{**}(2t) \\ \lesssim t^{-1} \int_{B_{t}} \int_{t}^{\infty} \int_{s}^{\infty} \int_{s_{k-1}}^{\infty} \int_{s_{2}}^{\infty} s_{1}^{-1} \{\omega_{p}^{k}(s_{1}^{1/n}, \Delta_{u}f)\}^{p} \frac{ds_{1}}{s_{1}} \cdots \frac{ds_{k-1}}{s_{k-1}} \frac{ds}{s} du.$$

The induction is established from [3, Lemma 5.4.11].

We also need the following variant of the estimate (8).

Lemma 1.3. Let $k \in \mathbf{N}$, $k \geq 2$ and suppose that $0 . Then for all <math>f \in L_p(\mathbf{R}^n)$,

$$(|f|^{p})^{**}(t) - (|f|^{p})^{**}(2t) \lesssim \int_{t}^{1} \int_{s_{k-1}}^{1} \cdots \int_{s_{2}}^{1} s_{1}^{-1} \{\omega_{p}^{k}(s_{1}^{1/n}, f)\}^{p} \frac{ds_{1}}{s_{1}} \cdots \frac{ds_{k-1}}{s_{k-1}} + (1 + |\log t|^{k-2}) ||f| |L_{p} + L_{\infty}||, \quad 0 < t < 1.$$
(12)

Proof. From (6) we have

$$(|f|^p)^{**}(t) = \int_t^1 (\delta_p f^*)^p(u) \, du/u + (|f|^p)^{**}(1).$$

Since the K-functional for the pair L_p, L_∞ satisfies

$$K(t, f; L_p, L_\infty) \approx \left(\int_0^{t^p} (f^*(s))^p ds\right)^{1/p}$$

(see [4, Theorem 5.2.1]), we have

$$||f| L_p + L_{\infty}||^p = K(1, f; L_p, L_{\infty})^p \approx \int_0^1 (f^*(s))^p ds = (|f|^p)^{**}(1).$$

Thus

$$(|f|^{p})^{**}(t) \approx \int_{t}^{1} (\delta_{p} f^{*})^{p}(u) \, du/u + ||f| \, L_{p} + L_{\infty}||^{p}.$$
(13)

Applying this to $\Delta_u f$ and using (9), (10), and (7) we obtain

$$(\delta_p f^*)^p(t) \lesssim t^{-1} \int_{B_t} \int_t^1 s_1^{-1} \{ \omega_p(s_1^{1/n}, \Delta_u f) \}^p \frac{ds_1}{s_1} du + \|f\| L_p + L_\infty \|^p.$$

From [3, Lemma 5.4.11] and this we see that

$$(\delta_p f^*)^p(t) \lesssim \int_t^1 s_1^{-1} \{\omega_p^2(s_1^{1/n}, f)\}^p \, \frac{ds_1}{s_1} + \|f\| L_p + L_\infty\|^p.$$
(14)

Repeating this procedure, we have from (13) and (14),

$$(|\Delta_u f|^p)^{**}(t) \lesssim \int_t^1 \left(\int_{s_2}^1 s_1^{-1} \{ \omega_p^2(s_1^{1/n}, \Delta_u f) \}^p \frac{ds_1}{s_1} + \|f\| L_p + L_\infty \|^p \right) \frac{ds_2}{s_2} + \|f\| L_p + L_\infty \|^p.$$

Hence

$$(\delta_p f^*)^p(t) \lesssim \int_t^1 \int_{s_2}^1 s_1^{-1} \{\omega_p^3(s_1^{1/n}, f)\}^p \frac{ds_1}{s_1} \frac{ds_2}{s_2} + (1 + |\log t|) ||f| |L_p + L_\infty ||^p.$$

In this way by induction we prove (12) for all $k \ge 2$.

1.3. Embedding of Besov spaces in L(r,q)

The main idea now is to reduce everything to the case p = 1.

Theorem 1.4. Let $0 , <math>0 < q \le \infty$ and $0 < s < k \in \mathbb{N}$. Then

$$b_{p,q}^{s}(k) \hookrightarrow \beta^{c}(m-\beta)^{c}b_{1,q}^{\beta}(m),$$
(15)

where $\beta = s - n/p + n$, $0 < \beta < m < k$, and $c = \max(1, 1/q)$.

Proof. First we prove that

$$b_{p,1}^{n/p-n}(k) \hookrightarrow L_1, \quad n/p-n < k.$$
 (16)

If k = 1 this follows from (7), (9), and Lemma 1.1. If $k \ge 2$, then on substituting $s_1/s_2, s_2/s_3, \ldots, s_{k-2}/s_{k-1}, s_{k-1}/t$ for $s_1, s_2, \ldots, s_{k-2}, s_{k-1}$ in (8) we get

$$(\delta_p f^{**}(t))^p \lesssim \int_1^\infty \cdots \int_1^\infty g^p (s_1 s_2 \cdots s_{k-1} t) \frac{ds_1}{s_1} \cdots \frac{ds_{k-1}}{s_{k-1}}, \quad g(u) = u^{-1/p} \omega_p^k(u^{1/n}, f).$$

Applying Minkowski's inequality, we find that

$$\int_{0}^{\infty} \delta_{p} f^{**}(t) dt \lesssim \left(\int_{1}^{\infty} \cdots \int_{1}^{\infty} \left(\int_{0}^{\infty} g(s_{1}s_{2}\cdots s_{k-1}t) dt \right)^{p} \frac{ds_{1}}{s_{1}} \cdots \frac{ds_{k-1}}{s_{k-1}} \right)^{1/p},$$

and after a change of variables we have

$$\int_0^\infty \delta_p f^{**}(t) \, dt \lesssim \left(\int_1^\infty \cdots \int_1^\infty s_1^{-p} \cdots s_{k-1}^{-p} \frac{ds_1}{s_1} \cdots \frac{ds_{k-1}}{s_{k-1}} \right)^{1/p} \int_0^\infty t^{-1/p} \omega_p^k(t^{1/n}, f) \, dt,$$

which is exactly (16) in view of Lemma 1.1.

Application of the embedding (16) to the function $\Delta_h^k f$ for $|h| \le t$ gives

$$\|\Delta_{h}^{k}f\|_{1} \lesssim \int_{0}^{t} s^{n-n/p} \omega_{p}^{k}(s,f) \, ds/s + \int_{t}^{\infty} s^{n-n/p} \|\Delta_{h}^{k}f\|_{p} \, ds/s$$

Hence

$$\omega_1^k(t,f) \lesssim \int_0^t s^{n-n/p} \omega_p^k(s,f) \, ds/s + t^{n-n/p} \omega_p^k(t,f) (n-n/p)^{-1}.$$

Using also the estimate

$$\int_0^t s^{n-n/p} \omega_p^k(s,f) \, ds/s \gtrsim t^{n-n/p} \omega_p^k(t,f),$$

which follows easily from the monotonicity of $\omega_p^k(t,f)$ and the equivalence $\omega_p^k(t/2,f)\approx$ $\omega_p^k(t, f)$, we obtain

$$\omega_1^k(t,f) \lesssim \int_0^t s^{n-n/p} \omega_p^k(s,f) \, ds/s.$$

This estimate shows that

$$I \coloneqq \int_0^\infty \{t^{-\beta} \omega_1^k(t,f)\}^q dt/t \lesssim \int_0^\infty t^{-\beta q} \left(\int_0^t g(u) du/u\right)^q dt/t,$$

where $g(u) = u^{n-n/p} \omega_p^k(u, f)$. If $q \ge 1$, then by a change of variables and Minkowski's inequality,

$$\begin{split} I &\lesssim \left(\int_0^1 \left(\int_0^\infty t^{-\beta q} g(ut)^q dt/t \right)^{1/q} du/u \right)^q \\ &\lesssim \left(\int_0^1 u^\beta du/u \right)^q \int_0^\infty t^{-q(\beta+n/p-n)} (\omega_p^k(t,f))^q dt/t \end{split}$$

In other words,

$$\|f \| b_{1,q}^{\beta}(k)\| \lesssim \beta^{-c} \|f \| b_{p,q}^{s}(k)\|, \quad s = \beta + n/p - n, \quad c = \max(1, 1/q).$$
(17)

If 0 < q < 1, we put $h(t) = \int_0^t u^{n-n/p} \omega_p^k(u, f) \, du/u$ and use integration by parts to obtain, assuming that the integrated terms play no part in the inequality,

$$\begin{split} I \lesssim \int_0^\infty t^{-\beta q} h^q(t) dt/t \lesssim \beta^{-1} \int_0^\infty h^q(t) dt^{-\beta q} \\ \lesssim \beta^{-1} \int_0^\infty t^{-\beta q} h^{q-1}(t) h'(t) dt. \end{split}$$

Since

$$h'(t) = t^{n-n/p-1} \omega_p^k(t, f) \quad \text{and} \quad h(t) \gtrsim t^{n-n/p} \omega_p^k(t, f),$$

we have (17) for this case also. It remains to justify the neglect of the integrated terms. As $\omega_p^k(u, f)$ is monotonic in u,

$$\int_{t}^{2t} (u^{-s} \omega_{p}^{k}(u, f))^{q} du/u \geq ((2t)^{-s} \omega_{p}^{k}(t, f))^{q} \int_{t}^{2t} du/u,$$

and so

$$(t^{-s}\omega_p^k(t,f))^q \lesssim \int_t^{2t} (u^{-s}\omega_p^k(u,f))^q du/u \to 0 \quad \text{as } t \to 0$$

since $f \in b_{p,q}^s$. Hence by l'Hôpital's rule,

$$\lim_{t \to 0} \frac{\int_0^t u^{n-n/p} \omega_p^k(u, f) du/u}{t^{s-n/p+n}} = \lim_{t \to 0} \frac{t^{n-n/p-1} \omega_p^k(t, f)}{(s-n/p+n)t^{s-n/p+n-1}} = 0$$

Further, we show that (17) implies (15). We have to prove that

$$b_{1,q}^{\beta}(k) \hookrightarrow (m-\beta)^c b_{1,q}^{\beta}(m), \quad k > m.$$
 (18)

To this end we use the Marchaud inequality (see [3, p. 332])

$$\omega_1^m(t,f) \lesssim t^m \int_t^\infty \omega_1^k(u,f) u^{-1-m} du, \quad m < k.$$

Arguing as above (applying Minkowski's inequality if $q \ge 1$ and integrating by parts if 0 < q < 1) we obtain (18).

Using also the estimate (see [8, (13)])

$$f^{**}(t) - f^{**}(2t) \lesssim t^{-1} \omega_1^m(t^{1/n}, f), \quad m < n+2,$$

we obtain the following Corollary.

Corollary 1.5. Let $0 , <math>0 < q \le \infty$, let $m, k \in \mathbf{N}$ and $s \in \mathbf{R}$ be such that m < k, 0 < s < k, n/p - n < s < n/p - n + m, and let 1/r = 1/p - s/n, $\beta = s - n/p + n$, $\beta < m < n + 2$, $c = \max(1, 1/q)$. Then

$$b_{p,q}^s(k) \hookrightarrow \beta^c (m-\beta)^c L(r,q).$$

2. Sharp embedding constants for Besov spaces

2.1. Subcritical case

Here we establish the embedding (see [19])

$$b_{p,q}^s \hookrightarrow L_{r,q}, \qquad 1/r = 1/p - s/n, \quad 0 < s < n/p, \quad 0 < p < 1,$$

and aim to find sharp rates of blow up for the embedding constants as $s \to n/p$. As explained in the introduction, this means that $n/p \leq k$. We remind the reader that the embedding constants are given by

$$b_1 \coloneqq \sup_{f \neq 0} ||f||_{r,q} / ||f|| b_{p,q}^s ||$$
 and $b_2 \coloneqq \sup_{f \neq 0} ||f||_r / ||f|| b_{p,q}^s ||.$

From Theorem 1.4 with $\beta = \sigma n$ and [10, Theorem 6] we obtain

Theorem 2.1. Let $0 , <math>0 < q \le \infty$, $n/p \le k$, $0 < \sigma < 1$, $1/r = 1 - \sigma$ and put $c = \max(1, 1/q)$. Then as $\sigma \to 1$,

$$b_{p,q}^{n/p-(1-\sigma)n} \hookrightarrow (1-\sigma)^c L_{r,q}.$$
(19)

The estimates

$$b_1 \approx r^c \quad and \quad b_2 \approx r^{(1-1/q)_+} \tag{20}$$

hold if, in addition, either n/p < k or n = 1 and p = 1/k. The upper estimates for b_1 and b_2 implicit in (20) hold without these additional restrictions.

Proof. We only need to prove the relations (20). The embedding (19) gives the required estimate from above, and when n/p < k the estimates from below can be proved in the same way as in [8]. The case k = n/p is more difficult to settle, and at the moment we can deal only with the situation when n = 1.

First suppose that $0 < q \le 1, n = 1$ and $p = 1/k, k \in \mathbb{N}$. Define a function f on \mathbb{R} by

$$f(x) = \begin{cases} x, & 0 \le x \le 1/2, \\ 1 - x, & 1/2 < x \le 1, \\ 0, & \text{otherwise.} \end{cases}$$

We estimate $\Delta_h^k f(x)$ for small positive h and observe that it is zero everywhere except in the intervals (-kh, 0), (1/2-kh, 1/2), and (1-kh, 1), in which we have the pointwise estimate

$$\left|\Delta_h^k f(x)\right| \lesssim h.$$

It follows that

$$\int_{\mathbf{R}} |\Delta_h^k f(x)|^p dx \lesssim h^{1+p},$$

so that

Hence

$$\begin{split} \omega_p^k(t,f) \lesssim t^{k+1}. \\ \|f \mid b_{p,q}^{1/p-1+\sigma}\| \lesssim 1. \end{split}$$

On the other hand,

$$||f| | L(r,q)|| \approx r^{1/q}$$

and thus

$$b_1 \gtrsim r^{1/q}$$

Since $||f||_r = (r+1)^{-1/r}/2 \approx 1$, the desired lower estimate for b_2 also follows.

Next suppose that $1 < q \leq \infty, n = 1$ and $p = 1/k, k \in \mathbb{N}$. Again we obtain lower bounds for b_1 and b_2 by constructing a test function, but this time the argument is more delicate. Let $f : \mathbb{R} \to \mathbb{R}$ be even, zero outside the interval (-1, 1) and given by

$$f(x) = j + 2 - 2^{j+1}x, \quad x \in (2^{-j-1}, 2^{-j}], \ j \in \mathbf{N}_0 \coloneqq \mathbf{N} \cup \{0\}.$$

We aim to estimate $\Delta_h^2 f(x)$, and first take $h = -2^{-m}$ for a fixed large $m \in \mathbf{N}$. Since f is even, we need only consider intervals in the positive half-line. For each $a \ge 0$ let δ_a be the interval $(2^{-a-1}, 2^{-a})$. Let $x \in \delta_j$ for some $j \in \mathbf{N}_0$. We estimate $\int_{\delta_j} |\Delta_h^2 f(x)|^{1/2} dx$ for $j > m - m_0$, where m_0 will be specified below. For any fixed $x \in \delta_j$ we can find s_0, s_1 such that $s_0 > s_1 > j$ and $|x + 2h| \in \delta_{s_0}$ while $|x + h| \in \delta_{s_1}$. In this way the interval δ_j may be covered by a union of corresponding intervals, where

$$|f(x+2h) - f(x+h)| \le s_0 - s_1 + 2$$
 if $x \in \delta_j \cap \delta_{s_0} \cap \delta_{s_1}$

and

$$|f(x+h) - f(x)| \le s_1 - j + 2 \quad \text{if } x \in \delta_j \cap \delta_{s_1}$$

Then we have

$$\begin{split} \int_{\delta_j} \left| \Delta_h^2 f(x) \right|^{1/2} dx &\leq \sum_{s_j > j} \sum_{s_0 > s_1} (s_0 - s_1 + 2)^{1/2} 2^{-s_0 - 1} \\ &+ \sum_{s_j > j} (s_1 - j + 2)^{1/2} 2^{-s_1 - 1} \\ &\leq \sum_{s_j > j} 2^{-s_1} \sum_{s_0 > s_1} (s_0 - s_1 + 2)^{1/2} 2^{-(s_0 - s_1) - 1} \\ &+ \sum_{s_j > j} (s_1 - j + 2)^{1/2} 2^{-(s_1 - j) - 1} 2^{-j} \\ &< 2^{-j} \end{split}$$

Hence

$$\sum_{j>m-m_0} \int_{\delta_j} |\Delta_h^2 f(x)|^{1/2} dx \lesssim |h|.$$

To handle the case $j \leq m - m_0$, let $x \in \delta_j$ and suppose that $x + 2h \in \delta_{j+1}$. Then $j \leq m-4$, and so we define $m_0 = 4$. For $j \leq m-4$, if $x \in (2^{-j-1}+2|h|, 2^{-j})$, then all points x, x + h, x + 2h lie in the same interval δ_j , so that the second difference is zero. Thus we need to consider only the interval $(2^{-j-1}, 2^{-j-1}+2|h|)$. Then (if, say, $x + h \in \delta_j$)

$$\begin{split} f(x+2h) - 2f(x+h) + f(x) &= j+3 - 2^{j+2}(x+2h) \\ &\quad -2\{j+2 - 2^{j+1}(x+h)\} + j+2 - 2^{j+1}x \\ &= 1 - 2^{j+1}x - 2^{j+2}h, \end{split}$$

and since $1 < 2^{j+1}x < 1 + 2^{j+2} |h|$, we obtain

$$|\Delta_h^2 f(x)| \lesssim 2^{j-m}.$$

Hence

$$\sum_{j \le m-4} \int_{2^{-j-1}}^{2^{-j-1+2|h|}} |\Delta_h^2 f(x)|^{1/2} dx \lesssim |h|.$$

Now we suppose that $h = 2^{-m}$ for a fixed large positive integer m. Let $2^{-j-1} < x < 2^{-j}$, $j \in \mathbf{N}_0$. First we estimate $\int_{2^{-j-1}}^{2^{-j}} |\Delta_h^2 f(x)|^{1/2} dx$ for j > m-2. We can reduce the problem to that of estimating the first-order differences f(x+2h) - f(x+h) and f(x+h) - f(x). Since f is even, given any fixed $x \in (2^{-j-1}, 2^{-j})$, there exist s_0, s_1 , with $j > s_0 \ge s_1 \ge -1$, such that $2^{-s_0-1} < |x+h| < 2^{-s_0}$ and $2^{-s_1-1} < |x+2h| < 2^{-s_1}$; that is, $x + h \in \delta_{s_0}$ and $x + 2h \in \delta_{s_1}$. Then

$$|f(x+2h) - f(x+h)| \le s_0 - s_1 + 4$$
 if $x \in \delta_j \cap \delta_{s_0} \cap \delta_{s_1}, s_1 \ge -1$

and

$$|f(x+h) - f(x)| \le j - s_0 + 4 \quad \text{if } x \in \delta_j \cap \delta_{s_0}.$$

We claim that $s_0, s_1 > m-4$. To justify this, first let $j \ge s_1+2$. Then the inequalities $2^{-s_1-1} < x+2h < 2^{-s_1}$ and $2^{-j-1} < x+h < 2^{-j}$ imply that $2^{-s_1-2} \le h = 2^{-m}$, so that $s_1 \ge m-2$. If $j < s_1+2$, then $s_1+2 > m-2$, and so $s_1 > m-4$. The proof

that $s_0 > m - 4$ is analogous. Hence

$$\sum_{j>m-2} \int_{\delta_j} |\Delta_h^2 f(x)|^{1/2} dx \le \sum_{s_1>m-4} 2^{-s_1} \sum_{s_0>s_1} (s_0 - s_1 + 4)^{1/2} 2^{-(s_0 - s_1)} \\ \times \sum_{j>s_0} 2^{-(j-s_0)} \\ + \sum_{s_0>m-4} 2^{-s_0} \sum_{j>s_0} (j - s_0 + 4)^{1/2} 2^{-(j-s_0)} \\ \lesssim 2^{-m}.$$

Now consider the case $j \leq m-2$. If $2^{-j-1} < x < 2^{-j} - 2h$, then $\Delta_h^2 f(x) = 0$, and so we have only to consider the interval $2^{-j} - 2h < x < 2^{-j}$, of length 2h. Let, for example, $x + h \in \delta_j$. Then

$$\Delta_h^2 f(x) = j + 1 - 2^j (x + 2h) - 2\{j + 2 - 2^{j+1}(x + h)\} + j + 2 - 2^{j+1}x,$$

and so

$$|\Delta_h^2 f(x)| \le |-1 + 2^j x + 2^{j+1} h| \lesssim 2^j h = 2^{j-m}.$$

Hence

$$\sum_{j \le m-2} \int_{\delta_j} |\Delta_h^2 f(x)|^{1/2} dx \lesssim h \sum_{j \le m-2} 2^{-(m-j)/2} \lesssim h.$$

In this way we obtain the estimate

$$\omega_p^k(t; f) \lesssim t^k \quad \text{if} \quad 0 < t < 1, \quad k = 1/p,$$

which gives $||f| | b_{p,q}^{k-1/r} || \lesssim r^{1/q}$. It remains to check that $||f||_r \approx r$. In fact,

$$||f||_r^r = \sum_{j\ge 0} \int_{\delta_j} (j+2-2^{j+1}x)^r dx = \sum_{j\ge 0} 2^{-j-1} \int_1^2 (j+2-s)^r ds \lesssim \sum_{j\ge 0} 2^{-j} j^r \lesssim r!.$$

On the other hand, for $j \approx r$,

$$||f||_r^r \ge \int_{\delta_j} (j+2-2^{j+1}x)^r dx = 2^{-j-1} \int_1^2 (j+2-s)^r ds \gtrsim 2^{-r} r^r,$$

so that $b_1 \gtrsim r$. The estimates for b_2 follow as before.

2.2. Supercritical case

When s > n/p we know (see [21]) that

$$B^s_{p,q} \hookrightarrow L_\infty,$$

where $B_{p,q}^s$ is the inhomogeneous Besov space, defined by means of Fourier decompositions. The problem of finding sharp rates of blow up for the corresponding embedding constants as $s \to (n/p)$ + was considered recently by Triebel [22], who dealt not only with Besov but also with Lizorkin-Triebel spaces, both types of spaces being considered on bounded Lipschitz domains. Here we consider the same problem for the slightly larger Besov spaces $\tilde{b}_{p,q}^s$, $0 (the case <math>1 \le p < \infty$ was considered in [8]), defined by means of the quasi-norm

$$\|f \mid \tilde{b}_{p,q}^s\| \coloneqq \left(\int_0^\infty \{t^{-s}\omega_p^{k+1}(t,f)\}^q \frac{dt}{t}\right)^{1/q} + \|f \mid L_p + L_\infty\|, \quad n/p < s < k.$$

Using monotonicity, we can replace the above integral by a sum and conclude that the scale $\tilde{b}_{p,q}^s$ is increasing with respect to q. It turns out that the results concerning the embedding constants are the same as in [22]. Let

$$b_3 \coloneqq \sup_{f \neq 0} ||f||_{\infty} / ||f|| \, \tilde{b}_{p,q}^s ||.$$

Theorem 2.2. Let $0 , <math>0 < q \le \infty$, and $\sigma > 0$. Then as $\sigma \to 0$,

$$\tilde{b}_{p,q}^{n/p+\sigma} \hookrightarrow \sigma^{(1-1/q)_+} L_{\infty}$$

Proof. First we prove that in the definition of the space $\tilde{b}_{p,q}^s$ we can replace the weaker quasi-norm of $L_p + L_{\infty}$ by the stronger norm of $L_1 + L_{\infty}$. To this end we establish the embedding

$$\tilde{b}_{p,q}^{n/p} \hookrightarrow L_1 + L_\infty. \tag{21}$$

In fact,

$$\begin{split} \|f \| L_{1} + L_{\infty} \| &= \int_{0}^{1} f^{*}(s) \, ds \leq \int_{0}^{1} \left(t^{-1} \int_{0}^{t} (f^{*}(u))^{p} du \right)^{1/p} dt \\ &= \int_{0}^{1} ((|f|^{p})^{**})^{1/p} dt \\ &\leq \int_{0}^{1} \left(\int_{t}^{1} (\delta_{p} f^{*}(s))^{p} ds/s + \|f\| L_{p} + L_{\infty} \|^{p} \right)^{1/p} dt \\ &\lesssim \int_{0}^{1} \left(\int_{t}^{1} (\delta_{p} f^{*}(s))^{p} ds/s \right)^{1/p} dt + \|f\| L_{p} + L_{\infty} \| \\ &\lesssim \int_{0}^{1} \left(\int_{1}^{1/t} (\delta_{p} f^{*}(st))^{p} ds/s \right)^{1/p} dt + \|f\| L_{p} + L_{\infty} \| \\ &\lesssim \left(\int_{1}^{\infty} \left(\int_{1}^{1/s} (\delta_{p} f^{*}(st))^{p} dt \right)^{p} ds/s \right)^{1/p} + \|f\| L_{p} + L_{\infty} \| \\ &\lesssim \left(\int_{1}^{\infty} s^{-p} ds/s \right)^{1/p} \int_{0}^{1} \delta_{p} f^{*}(t) dt + \|f\| L_{p} + L_{\infty} \|. \end{split}$$

Thus

$$||f| | L_1 + L_{\infty}|| \lesssim \int_0^1 \delta_p f^*(t) dt + ||f| | L_p + L_{\infty}||.$$

Now we use the estimates (9) and (12). Applying also Minkowski's inequality as above, we obtain the estimate

$$\begin{split} \|f\|L_1 + L_\infty\| &\lesssim \int_0^1 \left(\int_t^1 \int_{s_{k-1}}^1 \dots \int_{s_2}^1 s_1^{-1} (\omega_p^k(s_1^{1/n}, f))^p \frac{ds_1}{s_1} \dots \frac{ds_{k-1}}{s_{k-1}} \right)^{1/p} dt \\ &+ \|f\|L_p + L_\infty\| \int_0^1 \left(1 + |\log t|^{(k-2)/p}\right) dt \\ &\lesssim \left(\int_1^\infty \dots \int_1^\infty s_1^{-p} \dots s_{k-1}^{-p} \frac{ds_1}{s_1} \dots \frac{ds_{k-1}}{s_{k-1}} \right)^{1/p} \int_0^1 u^{-1/p} \omega_p^k(u^{1/n}, f) \, du \\ &+ \|f\|L_p + L_\infty\|. \end{split}$$

Hence (21) is established for $q = \infty$, and so also for any q by monotonicity. The same proof gives

$$\tilde{b}_{p,q}^{n/p+\sigma} \hookrightarrow L_1 + L_{\infty},$$

uniformly for $\sigma \geq 0$. In other words, we have

$$\tilde{b}_{p,q}^{n/p+\sigma} = b_{p,q}^{n/p+\sigma} \cap (L_1 + L_\infty), \tag{22}$$

uniformly for $\sigma \geq 0$.

Moreover, from Theorem 1.4 with $s = n/p + \sigma, \beta = \sigma + n, m = n + 1$ and small $\sigma > 0$, together with (22), we have

$$\tilde{b}_{p,q}^{n/p+\sigma} \hookrightarrow \tilde{b}_{1,q}^{n+\sigma}(n+1), \quad 0$$

uniformly with respect to σ . Finally, [8, Theorem 4.1] gives

$$\tilde{b}_{1,q}^{n+\sigma} \hookrightarrow \sigma^{(1-1/q)_+} L_{\infty}.$$

As a consequence we have

Corollary 2.3. Under the conditions of the last theorem,

$$b_3 \approx \sigma^{-(1-1/q)_+}.$$

Part of this follows from [22], since $B_{p,q}^s \hookrightarrow \tilde{b}_{p,q}^s$, uniformly with respect to $s \to (n/p)+$ (see [21, p. 110]).

2.3. Critical case

Here we derive sharp embeddings in the critical case s = n/p, 0 . First, from Corollary 1.5, with <math>s = n/p, $\beta = n$ and m = n + 1 if $0 , and from [8, Lemma 2.2] if <math>p \ge 1$, it follows that

$$b_{p,q}^{n/p} \hookrightarrow L(\infty, q), \quad 0 (23)$$

If $0 < q \leq 1$, then $L(\infty, q) \hookrightarrow L_{\infty}$, and so (23) is a sharpening of the well-known embeddings [21]. When q > 1 we can replace $L(\infty, q)$ by a linear and larger space. Let $L^{\infty,q}(\log L)_{-1}$ be the space with norm

$$||f| L^{\infty,q} (\log L)_{-1}|| = \left(\int_0^\infty \{(1+|\log t|)^{-1} f^{**}(t)\}^q dt/t\right)^{1/q}.$$

Then

$$L(\infty, q) \cap (L_1 + L_\infty) \hookrightarrow L^{\infty, q} (\log L)_{-1}, \quad q > 1.$$

$$(24)$$

To prove this, we start with (6) for $\gamma = 1$:

$$f^{**}(t) = \int_{t}^{1} (f^{**}(s) - f^{*}(s)) \, ds/s + f^{**}(1).$$

Then by the Muckenhoupt inequality [18] for q > 1,

$$\left(\int_0^1 \{(1+|\log t|)^{-1}f^{**}(t)\}^q dt/t\right)^{1/q} \lesssim \left(\int_0^1 (f^{**}(s) - f^*(s))^q ds/s\right)^{1/q} + f^{**}(1),$$

and obviously

$$\left(\int_{1}^{\infty} \{(1+|\log t|)^{-1}f^{**}(t)\}^{q} dt/t\right)^{1/q} \lesssim f^{**}(1).$$

Thus (24) is proved.

As a consequence, we obtain the embedding

$$\tilde{b}_{p,q}^{n/p} \hookrightarrow L^{\infty,q} (\log L)_{-1}, \quad 0$$

In fact, we have proved a little more, namely

$$\tilde{b}_{p,q}^{n/p} \hookrightarrow \cap_{w \in W} \Lambda^q(w), \quad 0$$

where the norm in $\Lambda^q(w)$ is given by

$$||f| \Lambda^{q}(w)|| = \left(\int_{0}^{\infty} \{w(t)f^{**}(t)\}^{q} dt/t\right)^{1/q}$$

and W is the family of all positive Muckenhoupt weights, that is, weights w satisfying

$$\left(\int_0^t w^q(s)ds/s\right)^{1/q} \lesssim (1+|\log t|)^{1/q-1}, \quad 0 < t < 1, \quad q > 1.$$
