CAPACITARY TYPE ESTIMATES IN STRONGLY NONLINEAR POTENTIAL THEORY AND APPLICATIONS

Abstract

In this article a general result on smooth truncation of Riesz and Bessel potentials in Orlicz-Sobolev spaces is given and a capacitary type estimate is presented. We construct also a space of quasicontinuous functions and an alternative characterization of this space and a description of its dual are established. For the Riesz kernel \mathcal{R}_m , we prove that operators of strong type (A, A), are also of capacitaries strong and weak types (m, A).

1 Introduction

In this paper, we continue the development of the Potential Theory in Orlicz spaces, called Strongly Nonlinear Potential Theory, studied in [6, 7, 8, 9, 10, 11].

We begin by establishing, in Theorem 3.5, a general result on smooth truncation of Riesz and Bessel potentials in Orlicz-Sobolev spaces $W^m L_A(\mathbb{R}^N)$ such that A and A^* satisfy the Δ_2 condition. This result has been proven, in the framework of Lebesgue spaces, first by V. G. Maz'ya for the first order type inequality using truncation in the class $W^{1,p}$. For the Sobolev space $W^{2,p}$, Maz'ya used smooth truncation to get the result. Later, D. R. Adams proved the same result for any integer. After several intermediate stages, the result was proved in the generality by K. Hansson.

As a consequence, by showing the equivalence of some capacities, we obtain, in Theorem 3.7, the capacitary strong type estimates with the aid of the norms defined on Orlicz spaces.

On the other hand, for the Bessel capacity $B'_{m,A}$ in the Orlicz space \mathbf{L}_A , the natural question: "does the quantity $\int_0^\infty B'_{m,A} (\{x : |\psi| \ge t\}) dt$ define a norm on a linear space of functions ψ on \mathbb{R}^N ?", leads us to construct the space $\mathbf{L}_A(B'_{m,A})$ of quasicontinuous functions "integrable with respect to capacity", with the aid of the Orlicz space \mathbf{L}_A and the capacity $B'_{m,A}$. We prove, for reflexive Orlicz spaces \mathbf{L}_A , that $\mathbf{L}_A(B'_{m,A})$ contains the potential space $\mathbf{L}_{m,A}$. We give in Theorem 4.6, for reflexive Orlicz spaces \mathbf{L}_A , a characterization of $\mathbf{L}_A(B'_{m,A})$ as the space of quasicontinuous functions ψ which satisfy the following boundedness condition: $\int_0^\infty B'_{m,A} (\{x : |\psi(x)| \ge t\}) dt < \infty$. As a consequence, if the potential space $\mathbf{L}_{m,A}$ is imbedded in a Banach space \mathbf{B} which is partially ordered in the sense that $u, v \in \mathbf{B}$ and $|u(x)| \le |v(x)|$ everywhere implies that $||u||_{\mathbf{B}} \le ||v||_{\mathbf{B}}$ for a norm of \mathbf{B} , then \mathbf{B} contains $\mathbf{L}_A(B'_{m,A})$.

We characterize also, in Theorem 4.8, the dual $\mathbf{L}_A(B'_{m,A})^*$ of $\mathbf{L}_A(B'_{m,A})$, when A verifies the Δ_2 condition, as the space of measures whose total variation belongs to the dual of the potential space $\mathbf{L}_{m,A}$.

Finally, in the case of the Riesz kernel \mathcal{R}_m , we prove in Proposition 5.1, that operators of strong type (A, A), are also of capacitary strong type (m, A) if A and A^* satisfy the Δ_2 condition, and of capacitary weak type (m, A) for any N-function A.

2 Preliminaries

2.1 Orlicz spaces

An *N*-function is a continuous convex and even function A defined on R, verifying A(t) > 0 for t > 0, $\lim_{t \to 0} \frac{A(t)}{t} = 0$ and $\lim_{t \to +\infty} \frac{A(t)}{t} = +\infty$. We have the representation $A(t) = \int_{0}^{|t|} a(x)dx$, where $a : R^+ \to R^+$ is non-decreasing, right continuous, with a(0) = 0, a(t) > 0 for t > 0, $\lim_{t \to +\infty} a(t) = +\infty$.

The N-function A^* conjugate to A is defined by $A^*(t) = \int_{0}^{|t|} a^*(x) dx$, where a^* is given by $a^*(s) = \sup\{t : a(t) \le s\}$.

Let A be an N-function and Ω an open set in \mathbb{R}^N . We note $\mathcal{L}_A(\Omega)$ the set, called an *Orlicz class*, of measurable functions f, on Ω , such

that

$$\rho(f, A, \Omega) = \int_{\Omega} A(f(x)) dx < \infty.$$

Let A and A^{*} be two conjugate N-functions and let f be a measurable function defined almost everywhere in Ω . The Orlicz norm of f, $||f||_{A,\Omega}$ or $||f||_A$ if there is no confusion, is defined by

$$||f||_A = \sup\left\{\int_{\Omega} |f(x)g(x)| \, dx : g \in \mathcal{L}_{A^*}(\Omega) \text{ and } \rho(g, A^*, \Omega) \le 1\right\}.$$

The set $\mathbf{L}_A(\Omega)$ of measurable functions f, such that $||f||_A < \infty$ is called an *Orlicz space*. When $\Omega = \mathbb{R}^N$, we set \mathbf{L}_A in place of $\mathbf{L}_A(\mathbb{R}^N)$.

The Luxemburg norm $|||f|||_{A,\Omega}$ or $|||f|||_A$ if there is no confusion, is defined in $\mathbf{L}_A(\Omega)$ by

$$|||f|||_A = \inf\left\{r > 0 : \int_{\Omega} A\left(\frac{f(x)}{r}\right) dx \le 1\right\}.$$

Orlicz and Luxemburg norms are equivalent. More precisely, if $f \in \mathbf{L}_A(\Omega)$, then

$$|||f|||_A \le ||f||_A \le 2|||f|||_A$$

Let A be an N-function. We say that A verifies the Δ_2 condition if there is a constant C > 0 such that $A(2t) \leq CA(t)$ for all $t \geq 0$.

Recall that A verifies the Δ_2 condition if and only if $\mathcal{L}_A = \mathbf{L}_A$. Moreover \mathbf{L}_A is reflexive if and only if A and A^* verify the Δ_2 condition.

Note that if A verifies the Δ_2 condition, $\int A(f_i(x))dx \to 0$ as $i \to \infty$ if and only if $|||f_i||_A \to 0$ as $i \to \infty$.

Let $m \in N$. The Orlicz-Sobolev space $W^m L_A(\Omega)$ is the space of real functions f, such that f and its distributional derivatives up to the order m, are in $L_A(\Omega)$.

 $W^m L_A(\Omega)$ is a Banach space equipped with the norm

$$|||f|||_{m,A} = \sum_{|i| \le m} |||D^i f|||_A, f \in W^m L_A(\Omega).$$

Let $W^{-m}L_{A^*}(\Omega)$ denote the space of distributions on Ω , which can be written as sums of derivatives up to the order m of functions in $L_{A^*}(\Omega)$. It is a Banach space under the usual quotient norm.

If A and A^{*} satisfy the Δ_2 condition, the dual of $W^m L_A(\mathbb{R}^N)$ coincides with $W^{-m} L_{A^*}(\mathbb{R}^N)$.

We recall the following results. Let A be an N-function and a its derivative. Then, from [19], the following statements are equivalent

i) A verifies the Δ_2 condition. ii) $\forall r > 1, \exists k = k(r) : (\forall t \ge 0, A(rt) \le kA(t))$ iii) $\exists \alpha > 1 : (\forall t \ge 0, ta(t) \le \alpha A(t))$ iv) $\exists \beta > 1 : (\forall t \ge 0, ta^*(t) \ge \beta A^*(t))$ v) $\exists d > 0 : \left(\forall t \ge 0, \left(\frac{A^*(t)}{t}\right)' \ge d\frac{a^*(t)}{t}\right)$.

Moreover α in *iii*) and β in *iv*) can be chosen such that $\alpha^{-1} + \beta^{-1} = 1$. We note $\alpha(A)$ the smallest α such that *iii*) holds.

For more details on the theory of Orlicz spaces, see [5, 19, 20, 21, 23].

2.2 Capacity, Bessel potentials and Quasicontinuity

We define a *capacity* as an increasing positive set function C given on a σ -additive class of sets Γ , which contains compact sets and such that $C(\emptyset) = 0$ and $C(\bigcup_{i\geq 1} X_i) \leq \sum_{i\geq 1} C(X_i)$ for $X_i \in \Gamma$, i = 1, 2,

Let k be a positive and measurable function on \mathbb{R}^N and let A be an N-function. For $X \subset \mathbb{R}^N$, we define

$$C'_{k,A}(X) = \inf\{|||f|||_A : f \in \mathbf{L}_A^+ \text{ and } k * f \ge 1 \text{ on } X\},\$$

and

$$C_{k,A}(X) = A\left(C'_{k,A}(X)\right),$$

where k * f is the usual convolution and \mathbf{L}_A^+ is the set of positive elements in \mathbf{L}_A .

From [10] $C'_{k,A}$ is a capacity.

If a statement holds except on a set X where $C_{k,A}(X) = 0$, then we say that the statement holds $C_{k,A}$ -quasieverywhere (abbreviated $C_{k,A} - q.e.$ or (k, A) - q.e. if there is no confusion).

For m > 0, the Bessel kernel \mathcal{G}_m is defined through its Fourier transform $\mathfrak{F}(\mathcal{G}_m)$ as $[\mathfrak{F}(\mathcal{G}_m)](x) = (2\pi)^{-\frac{N}{2}} \left(1 + |x|^2\right)^{-\frac{m}{2}}$ where $[\mathfrak{F}(f)](x) = (2\pi)^{-\frac{N}{2}} \int f(y) e^{-ixy} dy$ for $f \in \mathbf{L}^1$.

The Bessel kernel \mathcal{G}_m is a positive and Lebesgue integrable function. Moreover, for any r and s, $\mathcal{G}_{r+s} = \mathcal{G}_r * \mathcal{G}_s$.

For more details on Bessel kernels, see [12, 13, 24].

We note $\mathcal{R}_m(x) = |x|^{m-N}$ the Riesz kernel.

We put $B_{m,A} = C_{\mathcal{G}_m,A}, B'_{m,A} = C'_{\mathcal{G}_m,A}, R_{m,A} = C_{\mathcal{R}_m,A}$ and $R'_{m,A} = C'_{\mathcal{R}_m,A}$.

Let A be an N-function and $m \in R$. We define the space of Bessel potentials $\mathbf{L}_{m,A}$ by

$$\mathbf{L}_{m,A} = \{ \psi = \mathcal{G}_m * f : f \in \mathbf{L}_A \},\$$

and a norm on $\mathbf{L}_{m,A}$ by

$$|||\psi|||_{m,A} = |||f|||_A$$
 if $\psi = \mathcal{G}_m * f$.

From [14] we know that if $m \in N$, then $\mathbf{L}_{m,A} = W^m L_A(\mathbb{R}^N)$ with equivalent norms.

Recall the following fact (see [19]) : If A verifies the Δ_2 condition and if F is a continuous linear functional over \mathbf{L}_A , then there is a unique $v \in \mathbf{L}_{A^*}$ such that

$$F(u) = \langle u, v \rangle = \int u(x)v(x)dx, \forall u \in \mathbf{L}_A.$$

This implies, for A verifying the Δ_2 condition, that $(\mathbf{L}_{m,A})^* = \mathbf{L}_{-m,A^*}$. The proof is exactly the same as the one in [15] relative to Lebesgue classes.

We recall the general definition of quasicontinuity.

Definition 2.1. Let C be a capacity on \mathbb{R}^N and let f be a function defined C-q.e. on \mathbb{R}^N or on some open subset of \mathbb{R}^N . Then f is said to be C-quasicontinuous if for every $\varepsilon > 0$, there is an open set O such that $C(O) < \varepsilon$ and $f \mid_{O^c} \in C(O^c)$.

In other words, the restriction of f to the complement of O is continuous in the induced topology.

For Bessel capacity $B'_{m,A}$, we write (m, A)-quasicontinuous in place of $B'_{m,A}$ -quasicontinuous.

Recall the following result. See [9]

Theorem 2.1. Let A be any N-function. Let f and g be two (m, A)-quasicontinuous functions, m > 0. Suppose that f(x) = g(x) almost everywhere. Then f(x) = g(x) (m, A)-quasieverywhere.

Note $\mathfrak{M} = \mathfrak{M}(\mathbb{R}^N)$ the vector space of Radon measures on \mathbb{R}^N . Then any (m, A)-quasicontinuous function f is measurable with respect to any $\mu \in \mathfrak{M}$ that is absolutely continuous with respect to (m, A)-capacity in the sense that $|\mu|(E) = 0$ for every Borel set E with $B_{m,A}(E) = 0$. In fact, from Definition 2.1 and the Tietze extension theorem, it follows that a quasicontinuous function is the pointwise limit of continuous functions outside some G_{δ} set of (m, A)-capacity zero.

Thus $\int_{\mathbb{R}^N} f d\mu$ is well defined as soon as $\int_{\mathbb{R}^N} |f| d |\mu| < \infty$. It follows from Theorem 2.1 that $\int_{\mathbb{R}^N} f d\mu = \int_{\mathbb{R}^N} g d\mu$ even if we only know that f = g a.e., in addition to being quasicontinuous.

On the other hand, for any positive measure μ and any Borel set E, we have for all $f \in \mathbf{L}_A^+$ such that $k * f \ge 1$ on E,

$$\mu(E) \leq \int (\mathcal{G}_m * f) d\mu \leq \int (\mathcal{G}_m * \mu) \cdot f dx \leq |||f|||_A \cdot ||\mathcal{G}_m * \mu||_{A^*}.$$

Thus

$$\mu(E) \le B_{m,A}(E) \cdot ||\mathcal{G}_m * \mu||_{A^*}.$$

Hence all (m, A)-quasicontinuous functions f are measurable with respect to all μ such that $|\mu| \in (\mathbf{L}_{m,A})^*$, (respectively $|\mu| \in \mathbf{L}_{-m,A^*}$ if Averifies the Δ_2 condition) and equality (m, A)-quasieverywhere implies equality μ -a.e.

We know also from [9] that if A verifies the Δ_2 condition, then every element in $\mathbf{L}_{m,A}$ has an (m, A)-quasicontinuous representative. Thus if $\psi \in \mathbf{L}_{m,A}$, there is $f \in \mathbf{L}_A$ such that $\mathcal{G}_m * f$ is (m, A)-quasicontinuous and $\psi = \mathcal{G}_m * f$.

Hence, for any $\mu \in \mathfrak{M}(\mathbb{R}^N)$ such that $|\mu| \in \mathbf{L}_{-m,A^*}$, we get

$$\int_{\mathbb{R}^N} |\psi| \, d|\mu| \le \int_{\mathbb{R}^N} \mathcal{G}_m * |f| \, d|\mu|$$

By Fubini's Theorem

$$\int_{\mathbb{R}^N} \mathcal{G}_m * |f| \, d|\mu| = \int_{\mathbb{R}^N} |f| \, .(\mathcal{G}_m * |\mu|) dx$$

Hölder inequality in Orlicz spaces gives

$$\int_{\mathbb{R}^N} |f| . (\mathcal{G}_m * |\mu|) dx \le |||f|||_A . ||\mathcal{G}_m * |\mu|||_{A^*} < \infty.$$

Hence $\int_{R^N} \, |\psi| \, d |\mu| < \infty.$

We deduce for such measure, that ψ belongs to $\mathbf{L}^1(|\mu|)$, and that $\mathbf{L}_{m,A}$ is continuously imbedded in $\mathbf{L}^1(|\mu|)$. Moreover, in this case the duality between \mathbf{L}_{-m,A^*} and $\mathbf{L}_{m,A}$ is given by

$$\langle \mu, \psi \rangle = \int_{\mathbb{R}^N} \psi \, d\mu = \int_{\mathbb{R}^N} (\mathcal{G}_m * \mu) . f dx.$$

This result is extended in Theorem 4.8 below.

Notice also that if $\mu \in \mathfrak{M}^+(\mathbb{R}^N) \cap \mathbf{L}_{-m,A^*}$, then $\mu(E) = 0$ for every μ -measurable set E such that $B_{m,A}(E) = 0$.

In [7] we have extended this result to signed measures.

In this paper, the letter C will denote various constants which may differ from one formula to the next one even within a single string of estimates. We make no attempt to obtain the best values for these constants.

3 A capacitary type estimate

In this section we begin with some lemmas

Lemma 3.1. Let A be an N-function, $f \in \mathbf{L}_A$ and Ω a measurable set in \mathbb{R}^N . Then

$$||f||_{A,\Omega} = ||f.\mathbf{1}_{\Omega}||_A \text{ and } |||f|||_{A,\Omega} = |||f.\mathbf{1}_{\Omega}|||_A.$$

Proof. We omit the proof.

Lemma 3.2 Let A be an N-function, $f \in \mathbf{L}_A$ and $(\Omega_j)_j$ a sequence of measurable sets such that $\Omega_j \cap \Omega_l = \emptyset$ if $j \neq l$. Then

$$\sum_{j} ||f||_{A,\Omega_j} \le ||f||_A, \text{ and } \sum_{j} |||f|||_{A,\Omega_j} \le 4|||f|||_A.$$

Proof. For $\varepsilon > 0$ and $j \in N$, there is φ_j such that

$$\int_{\Omega_i} A^* \left(\varphi_j(x) \right) dx \le 1 \text{ and } ||f||_{A,\Omega_j} \le \int_{\Omega_i} f \varphi_j(x) dx + \frac{\varepsilon}{2^j}.$$

Define $\psi_j = \varphi_j \cdot \mathbf{1}_j$. Then $\int A^*(\psi_j(x)) dx \leq 1$ and $||f||_{A,\Omega_j} \leq \int f \cdot \psi_j(x) dx + \frac{\varepsilon}{2^j}$.

Let $\psi = \sup \psi_j$. Since A^* is non decreasing, the Beppo-Levi Theorem gives

$$\int (A^* \circ \psi)(x) dx = \overline{\lim} \int (A^* \circ \psi_j)(x) dx \le 1.$$

Moreover $\sum_{j} ||f||_{A,\Omega_j} \leq \sum_{j} \int_{\Omega_j} f \cdot \varphi_j(x) dx + \varepsilon \leq \int f \cdot \psi(x) dx + \varepsilon.$ Hence $\sum_{j} ||f||_{A,\Omega_j} \leq ||f||_A.$

The second inequality is a consequence of the equivalence between Orlicz and Luxemburg norms.

Let \mathcal{M} be the Hardy-Littlewood maximal operator. Recall the following Lemma..

Lemma 3.3. [9] Let A be any N-function. For all multiindices ξ such that $|\xi| < m < N$, there is a constant C such that for all $f \in \mathbf{L}_A$ and for almost every x,

$$\left| D^{\xi}(\mathcal{G}_m * f)(x) \right| \leq C \mathcal{M}f(x)^{\frac{|\xi|}{m}} \left(\mathcal{G}_m * |f|(x) \right)^{1 - \frac{|\xi|}{m}}.$$

For Riesz kernel, we have the correspondent result which is very simple to verify.

Lemma 3.4. Let A be any N-function. For all multi-indices ξ such that $|\xi| < m < N$, there is a constant C such that for all $f \in \mathbf{L}_A$ and for almost every x,

$$\left| D^{\xi}(\mathcal{R}_m * f)(x) \right| \le C \mathcal{M}f(x)^{\frac{|\xi|}{m}} \left(\mathcal{R}_m * |f|(x) \right)^{1 - \frac{|\xi|}{m}}.$$

Remark 3.1. From [8] we know that if A verifies the Δ_2 condition and if $\alpha = \alpha(A)$ is such that $m < N/\alpha$, then all non empty balls are of strictly positive $R_{m,A}$ capacity. Hence, the restriction $m < N/\alpha$ is essential when working with Riesz capacity $R'_{m,A}$. Note that this is the same restriction as in the case of \mathbf{L}^p .

Theorem 3.5. Let A be an N-function such that A and A^* verify the Δ_2 condition, $\alpha = \alpha(A)$ and m is a positive integer. Let $T_{i \in \mathbf{Z}}$ be a

doubly infinite sequence of $C^m(R)$ functions identically zero for t < 0with T'_i having disjoints supports in $(0, \infty)$ and such that

$$\sup_{t>0} \left| t^{k-1} T_j^{(k)}(t) \right| \le L < \infty, k = 0, 1, ..., m.$$
(1)

Then for all $f \in \mathbf{L}_A^+$, there is a constant C depending only on N, m, L and A such that

$$\sum_{j} |||D^{\beta}T_{j}(\mathcal{S}_{m} * f)|||_{A} \leq C|||f|||_{A},$$

where β is a multi-index such that $|\beta| = m$, and S_m is either \mathcal{G}_m if m is a positive integer, or \mathcal{R}_m if m is a positive integer such that $m < N/\alpha$.

Proof. Let $g = S_m * f$, and $|\beta| = m$. Then

$$D^{\beta}(T_{j} \circ g) = \sum_{k=1}^{m} T_{j}^{(k)} \circ g \sum c_{\beta} D^{\beta_{1}} g \dots D^{\beta_{k}} g,$$

where the last sum is for the multi-indices $\{\beta_1, ..., \beta_k\}$ such that $\beta_1 + ... + \beta_k = \beta$. The value of the coefficients c_β is of no importance.

Let Ω_j be the support of $T'_j \circ g$. Then $\Omega_j \cap \Omega_l = \emptyset$ if $j \neq l$.

By hypothesis $\left|D^{\beta}\left(T_{j}\circ g\right)\right| \leq CL \sum_{k=1}^{m} g^{1-k} \sum \left|D^{\beta_{1}}g...D^{\beta_{k}}g\right|.\mathbf{1}_{\Omega_{j}}$

For k > 1, we estimate these derivatives with the aid of the two previous Lemmas. We get

$$\left| D^{\beta_{k}} g \right| \mathbf{1}_{\Omega_{j}} \leq C \mathcal{M} f(x)^{\frac{|\beta_{k}|}{m}} \left(\mathcal{S}_{m} * |f|(x) \right)^{1 - \frac{|\beta_{k}|}{m}} \cdot \mathbf{1}_{\Omega_{j}}$$

Since $\sum_{l=1}^{k} \left(1 - \frac{\beta_l}{m}\right) = k - \frac{|\beta|}{m} = k - 1$, we obtain

$$\sum_{k=2}^{m} g^{1-k} \sum \left| D^{\beta_1} g \dots D^{\beta_k} g \right| \mathbf{1}_{\Omega_j} \le C \sum_{k=2}^{m} g^{1-k} (\mathcal{M}f) \cdot g^{k-1} = C(\mathcal{M}f) \cdot \mathbf{1}_{\Omega_j}$$

By adding the term for k = 1, we get

$$\left|D^{\beta}\left(T_{j}\circ g\right)\right|\leq CL\left(\mathcal{M}f\right)\mathbf{1}_{\Omega_{j}}+\left|D^{\beta}g\right|.\mathbf{1}_{\Omega_{j}}.$$

By Lemma 3.1

$$|||(\mathcal{M}f)\mathbf{1}_{\Omega_j}|||_A = |||\mathcal{M}f|||_{A,\Omega_j} \text{ and } |||(D^{\beta}g).\mathbf{1}_{\Omega_j}|||_A = |||D^{\beta}g|||_{A,\Omega_j}.$$

And by Lemma 3.2

$$\sum_{j} |||\mathcal{M}f|||_{A,\Omega_j} \le 4|||\mathcal{M}f|||_A \text{ and } \sum_{j} |||D^\beta g|||_{A,\Omega_j} \le 4|||D^\beta g|||_A.$$

By [16], $|||\mathcal{M}f|||_A \leq C|||f|||_A$, and from [14] we have $|||D^{\beta}g|||_A \leq C|||f|||_A$.

This completes the proof.

Let m be a positive integer. We define for a compact set K in \mathbb{R}^N ,

$$\Gamma_{m,A}(K) = \left\{ \sum_{|\beta|=m} |||D^{\beta}g|||_{A} : g \in D(\mathbb{R}^{N}), g \equiv 1 \text{ in a neighborhood of } K \right\}.$$

We extend the definition of $\Gamma_{m,A}$ to all the class of all subsets of \mathbb{R}^N as an inner capacity. Hence for any $X \subset \mathbb{R}^N$, $\Gamma_{m,A}(X)$ is defined as

 $\Gamma_{m,A}(X) = \sup \left\{ \Gamma_{m,A}(K) : K \text{ compact and } K \subset X \right\}.$

Since $\Gamma_{m,A}$ is monotone, this definition agrees with our first one when X is compact.

The \mathbf{L}^p version of the following Lemma can be found in [1] and in [4].

Lemma 3.6. Let A be an N-function such that A and A^* verify the Δ_2 condition, m a positive integer such that $m < N/\alpha$. Then there is a positive constant C such that

$$C^{-1}R'_{m,A}(K) \le \Gamma_{m,A}(K) \le CR'_{m,A}(K),$$

for all compact K, C independent of K.

Proof. We adapt Adams proof in [1] relative to \mathbf{L}^p Lebesgue spaces to our case.

We begin by proving the first inequality. Let $g \in D(\mathbb{R}^N)$, $g \equiv 1$ in a neighborhood of K. From [24] we have the representation for $g \in D(\mathbb{R}^N)$

$$g(x) = \sum_{|\beta|=m} c_{\beta} K_{\beta} * D^{\beta} g(x),$$

where K_{β} is the convolution operator $K_{\beta^1} * ... * K_{\beta^N}$, $\beta = (\beta^1, ..., \beta^N)$, K_{β^j} is the convolution operator whose kernel is $\omega_{N-1}^{-1} .x_j |x|^{-N}$ convoled β^j -times.

We get
$$|g(x)| \leq C\mathcal{R}_m * \left(\sum_{|\beta|=m} |D^{\beta}g|\right)(x).$$

Set $f = C\left(\sum_{|\beta|=m} |D^{\beta}g|\right)$. We have $\mathcal{R}_m * f \geq 1$ on K and $R'_{m,A}(K) \leq |||f|||_A \leq C\sum_{|\beta|=m} |||D^{\beta}g|||_A.$

This implies the first inequality.

For the second inequality, we apply Theorem 3.5 for one *J*-function defined by $J(t) \equiv 0$, for $t \leq 1/2$, and $J(t) \equiv 1$, for $t \geq 1$, and $J \in C^{\infty}(R)$ otherwise.

Let $\varphi \in D(\mathbb{R}^N)^+$ be such that $\operatorname{supp}\varphi \subset B(0,1)$ and $\int \varphi(x)dx = 1$. Set $\varphi_h(x) = h^{-N}\varphi(x/h)$, h > 0. Choose an open bounded set $G \supset K$ and any $f \in \mathbf{L}_A^+$ such that $\mathcal{R}_m * f \ge 1$ on G.

Then for sufficiently small h, $\varphi_h * (\mathcal{R}_m * f) \ge 1$ on G_1 , where $K \subset G_1 \subset G$, G_1 an open with $\overline{G_1} \subset G$.

Set $g(x) = J \circ (\mathcal{R}_m * (\varphi_h * f))(x)$. Clearly $g \in D(\mathbb{R}^N)$ and $g \equiv 1$ on G_1 .

By Theorem 3.5

$$\Gamma_{m,A}(K) \le \sum_{|\beta|=m} |||D^{\beta}g|||_A \le C|||\varphi_h * f|||_A.$$

By [14 or 22], we know that $|||\varphi_h * f|||_A \leq ||\varphi_h||_1 \cdot |||f|||_A = |||f|||_A$. Thus $\Gamma_{m,A}(K) \leq CR'_{m,A}(G)$, for all $G \supset K$. From [10] R' is an outer capacity and the result follows

From [10], $R'_{m,A}$ is an outer capacity, and the result follows.

For $f \geq 0$, $\mathcal{R}_m * f$ is lower semi-continuous. Hence the set $X_t = \{x : \mathcal{R}_m * f \geq t\}$ is a G_{δ} -set and by [6] it is capacitable since A and A^* verify the Δ_2 condition. Consequently, there is a positive constant, independent of X_t , such that

$$C^{-1}R'_{m,A}(X_t) \le \Gamma_{m,A}(X_t) \le CR'_{m,A}(X_t).$$

Remark 3.2. Let $f \in D(\mathbb{R}^N)$. Since $Y_t = \{x : \mathcal{G}_m * f \ge t\}$ is a compact set, we know from [8] that there is a positive constant C, independent of Y_t , such that

$$C^{-1}R'_{m,A}(Y_t) \le B'_{m,A}(Y_t) \le CR'_{m,A}(Y_t).$$

Hence, there is a positive constant C, independent of Y_t , such that

$$C_{m,A}^{-1}\Gamma\left(Y_{t}\right) \leq B_{m,A}'\left(Y_{t}\right) \leq C\Gamma_{m,A}\left(Y_{t}\right).$$

Let \mathcal{S}_m as above and set

$$\mathcal{S}'_{m,A}(X) = \inf\left\{|||f|||_A : f \in \mathbf{L}^+_A \text{ and } \mathcal{S}_m * f \ge 1 \text{ on } X\right\}.$$

Theorem 3.7. Let A be an N-function such that A and A^* verify the Δ_2 condition and m a positive integer. Then there is a constant C depending only on N, m and A such that for all $f \in \mathbf{L}_A^+$

$$\int_0^\infty \mathcal{S}'_{m,A}\left(\{x: \mathcal{S}_m * f(x) \ge t\}\right) dt \le C|||f|||_A.$$

Proof. Since A verifies the Δ_2 condition, there is a sequence $(f_i)_i \subset D(\mathbb{R}^N)$ such that $|||f - f_i|||_A \to 0$ as $i \to \infty$. Hence

$$\{x: \mathcal{S}_m * f(x) \ge 2t\} \subset \{x: \mathcal{S}_m * |f - f_i| (x) \ge t\} \cup \{x: \mathcal{S}_m * f_i(x) \ge t\}.$$

Thus

$$\mathcal{S}'_{m,A}\left(\{x: \mathcal{S}_m * f(x) \ge 2t\}\right) \le |||\frac{f-f_i}{t}|||_A + \mathcal{S}'_{m,A}\left(\{x: \mathcal{S}_m * f_i(x) \ge t\}\right).$$

 So

$$\lim_{i \to \infty} \mathcal{S}'_{m,A}\left(\{x : \mathcal{S}_m * f_i(x) \ge t\}\right) \ge \mathcal{S}'_{m,A}\left(\{x : \mathcal{S}_m * f(x) \ge 2t\}\right).$$

This implies that it suffices to prove the theorem for $f \in D(\mathbb{R}^N)$.

But from Lemma 3.6 and Remark 3.2, it suffices to consider only $\Gamma_{m,A}$ in place of $\mathcal{S}'_{m,A}$.

Let $g = \mathcal{S}_m * f$. Then

$$\int_{0}^{\infty} \Gamma_{m,A} \left(\{ x : g(x) \ge t \} \right) dt = \sum_{k=-\infty}^{+\infty} \int_{2^{k}}^{2^{k+1}} \Gamma_{m,A} \left(\{ x : g(x) \ge t \} \right) dt$$
$$\leq \sum_{k=-\infty}^{+\infty} \Gamma_{m,A} \left(\{ x : g(x) \ge 2^{k} \} \right) 2^{k}.$$

Remark that $\{x: g(x) > 2^{k-1}\}$ is a neighborhood of the compact $\{x: g(x) \ge 2^k\}$.

As in [1] define $T(x) \equiv 0$, for $x \leq 0$, $T(x) \equiv 1$, for $x \geq 1$, and $T \in C^{\infty}(R)$ otherwise.

Let $T_k(x) = 2^k T (2^{2-k}x - 1)$. Then

$$T_k \circ g \in D(\mathbb{R}^N)$$
 and $2^{-k}T_k \circ g \equiv 1$ on $\{x : g(x) > 2^{k-1}\}$.

Hence

$$\sum_{k=-\infty}^{+\infty} \Gamma_{m,A} \left(\left\{ x : g(x) \ge 2^k \right\} \right) 2^k \le \sum_{k=-\infty}^{+\infty} \sum_{|\beta|=m} |||D^{\beta} \left(T_k \circ g \right) |||_A \le C |||f|||_A$$

by Theorem 3.5, since the sequence $(T_k)_{k \in \mathbb{Z}}$ verifies (1).

4 A space of quasicontinuous functions

This part is devoted to generalize some results in [2] and in [17] relative to the \mathbf{L}^p Lebesgue classes.

From Theorem 3.7, it is natural to seek when the quantity

$$\int_0^\infty B'_{m,A}\left(\{x: |\psi| \ge t\}\right) dt \tag{2}$$

defines a norm on a linear space of functions ψ on \mathbb{R}^N . Although the answer is not known in general, we shall show that (2) is equivalent to a certain norm of ψ .

Definition 4.1. for ψ a function on \mathbb{R}^N , define for m > 0, \mathbf{K}_{ψ} and $\Lambda_{m,A}(\psi)$ as

$$\mathbf{K}_{\psi} = \left\{ f \in \mathbf{L}_{A}^{+} : \mathcal{G}_{m} * f(x) \ge |\psi(x)|, \forall x \in \mathbb{R}^{N} \right\}$$

$$\Lambda_{m,A}(\psi) = \inf \left\{ |||f|||_{A} : f \in \mathbf{K}_{\psi} \right\}.$$

Proposition 4.1. $\Lambda_{m,A}$ has the following properties

$$\begin{aligned}
\Lambda_{m,A}(\psi_1) &\leq \Lambda_{m,A}(\psi_2), \text{ if } |\psi_1| \leq |\psi_2|; \quad (3) \\
\Lambda_{m,A}(\chi_E) &= B'_{m,A}(E), \text{ for all } E; \\
\Lambda_{m,A}\left(\psi \cdot \chi_{(\cup_j K_j)}\right) &\leq \sum_j \Lambda_{m,A}(\psi \cdot \chi_{K_j}).
\end{aligned}$$

Proof. The first two properties are immediate. For the last one we proceed as in proof of subadditivity of $B'_{m,A}$. See [10].

If $\sum_{j} \Lambda_{m,A}(\psi,\chi_{K_{j}}) = +\infty$, there is nothing to prove. Let $\sum_{j} \Lambda_{m,A}(\psi,\chi_{K_{j}}) < \infty$. Then $\Lambda_{m,A}(\psi,\chi_{K_{j}}) < \infty$, for all j. Hence $\forall \varepsilon > 0, \exists f_{j} \in \mathbf{L}_{A}^{+}$: $\mathcal{G}_{m} * f_{j} \geq |\psi,\chi_{K_{j}}(x)|$ on \mathbb{R}^{N} and $|||f_{j}|||_{A} \leq \Lambda_{m,A}(\psi,\chi_{K_{j}}) + \frac{\varepsilon}{2^{j}}$. We pose $f = \sup_{i} f_{i}$. Then from [10], $|||f|||_{A} \leq \sum_{j} |||f_{j}|||_{A}$. Hence $|||f|||_{A} \leq \sum_{j} \Lambda_{m,A}(\psi,\chi_{K_{j}}) + \varepsilon$. This implies $f \in \mathbf{L}_{A}^{+}$. But $\mathcal{G}_{m} * f \geq |\psi,\chi_{(\cup_{j}K_{j})}|$ on \mathbb{R}^{N} . Thus $\Lambda_{m,A}(\psi,\chi_{(\cup_{j}K_{j})}) \leq \sum_{j} \Lambda_{m,A}(\psi,\chi_{K_{j}})$.

The proof is finished.

Proposition 4.2. 1. Let A be any N-function and $m \in R^+$. The function $\Lambda_{m,A}$ defines a norm on $C_0 = C_0(R^N)$, and

$$\frac{1}{4}\Lambda_{m,A}(\psi) \le \int_0^\infty B'_{m,A}\left(\{x : |\psi(x)| \ge t\}\right) dt$$

for all continuous functions ψ .

2. Let A be an N-function such that A and A^* verify the Δ_2 condition and m a positive integer. Then there is a constant C such that

$$\frac{1}{4}\Lambda_{m,A}(\psi) \le \int_0^\infty B'_{m,A}\left(\{x: |\psi(x)| \ge t\}\right) dt \le C\Lambda_{m,A}(\psi)$$

for all continuous functions ψ .

Proof. 1. If $\psi_i \in C_0$ and $f_i \in \mathbf{K}_{\psi_i}$, for i = 1, 2, then $f_1 + f_2 \in \mathbf{K}_{\psi_1 + \psi_2}$, and thus

$$\Lambda_{m,A}(\psi_1 + \psi_2) \le |||f_1 + f_2|||_A \le |||f_1|||_A + |||f_2|||_A$$

Hence

$$\Lambda_{m,A}(\psi_1 + \psi_2) \le \Lambda_{m,A}(\psi_1) + \Lambda_{m,A}(\psi_2).$$

It is obvious that $\Lambda_{m,A}(0) = 0$, and $\Lambda_{m,A}(d\psi) = |d| \Lambda_{m,A}(\psi)$. Let $\psi \in C_0$ be such that $\Lambda_{m,A}(\psi) = 0$. Then

$$\forall \varepsilon > 0, \exists f \in \mathbf{L}_A^+ : \mathcal{G}_m * f \ge |\psi(x)|, \forall x \in \mathbb{R}^N \text{ and } |||f|||_A \le \varepsilon.$$

Recall that $|||\mathcal{G}_m * f|||_A \leq ||\mathcal{G}_m||_1 \cdot |||f|||_A$. See [14 or 22]. Since $C_0 \subset \mathbf{L}_A$, we get $|||\psi|||_A \leq |||\mathcal{G}_m * f|||_A \leq ||\mathcal{G}_m||_1 \cdot |||f|||_A = |||f|||_A \leq \varepsilon$, and $\psi \equiv 0$.

This shows that $\Lambda_{m,A}$ is a norm on C_0 .

Let $j \in \mathbb{Z}$ and $\gamma > 1$. Set $K_j = \{x : \gamma^j \leq |\psi(x)| \leq \gamma^{j+1}\}$, and $E_j = \{x : \gamma^j \leq |\psi(x)|\}$.

From Proposition 4.1, it follows that

$$\Lambda_{m,A}(\psi) \le \sum_{j \in \mathbf{Z}} \Lambda_{m,A}(\psi.\chi_{K_j}) \le \sum_{j \in \mathbf{Z}} \gamma^{j+1} B'_{m,A}(E_j).$$

On the other hand

$$\int_0^\infty B'_{m,A}\left(\{x: |\psi(x)| \ge t\}\right) dt \ge \sum_{j \in \mathbf{Z}} \gamma^j (1 - \gamma^{-1}) B'_{m,A}(E_j).$$

Hence

$$\Lambda_{m,A}(\psi) \le \frac{\gamma^2}{\gamma - 1} \int_0^\infty B'_{m,A}\left(\{x : |\psi(x)| \ge t\}\right) dt.$$

The function $h(\gamma) = \frac{\gamma^2}{\gamma - 1}$ attains the minimum at $\gamma = 2$, and h(2) = 4.

2. Let $f \in \mathbf{K}_{\psi}$. Then by Theorem 3.7, there is a constant C such that

$$\int_0^\infty B'_{m,A}\left(\{x: |\psi(x)| \ge t\}\right) dt \le C|||f|||_A.$$

This completes the proof.

We define a new Banach space, $\mathbf{L}_A(B'_{m,A})$, as the completion of $D(\mathbb{R}^N)$ in the norm $\Lambda_{m,A}$.

Lemma 4.3. Let A be an N-function such that A and A^* verify the Δ_2 condition and m a positive integer. Then $\mathbf{L}_{m,A} \subset \mathbf{L}_A(B'_{m,A})$.

Proof. Let $f \in \mathbf{L}_A$ and choose a sequence $(f_i)_i \subset D(\mathbb{R}^N)$ such that $|||f_i - f|||_A \to 0$ as $i \to \infty$. Then by Proposition 4.2 and Theorem 3.7

$$\Lambda_{m,A}(\mathcal{G}_m * f_i - \mathcal{G}_m * f) \le 4 \int_0^\infty B'_{m,A}(\{x : \mathcal{G}_m * |f_i(x) - f(x)| \ge t\}) dt \le C|||f_i - f|||_A.$$

Hence $\mathcal{G}_m * f_i - \mathcal{G}_m * f \to 0$ in $\mathbf{L}_A(B'_{m,A})$. Define $\mathcal{G}_{m,R}(x) = \mathcal{G}_m(x)$ for $|x| \leq R$ and $\mathcal{G}_{m,R}(x) = 0$ for |x| > R. Then $\mathcal{G}_{m,R} * f_i \in D(\mathbb{R}^N)$ and

$$(\mathcal{G}_m - \mathcal{G}_{m,R}) * |f_i|(x) \le ||f_i||_{\infty} \int_{|y|>R} \mathcal{G}_m(y) dy \searrow 0$$
, as $R \to \infty$.

This implies that $\mathcal{G}_m * f_i$, and thus $\mathcal{G}_m * f$ belongs to $\mathbf{L}_A(B'_{m,A})$.

Lemma 4.4. Let A be an N-function such that A and A^* verify the Δ_2 condition and m a positive integer. Any continuous compactly supported function belongs on $\mathbf{L}_A(B'_{m,A})$.

Proof. Let f be such function. Then there is a sequence $(f_i)_i \subset D(\mathbb{R}^N)$ supported in a fixed ball such that $(f_i)_i$ converges uniformly to f. Hence by Lebegue's Theorem, $\int A(|f - f_i|(x))dx \to 0$. Since A verifies the Δ_2 condition, $|||f_i - f|||_A \to 0$. But there is $\varphi \in \mathbf{L}^+_A$ such that $f_i - f = \mathcal{G}_m * \varphi$. Hence

$$\Lambda_{m,A}(f_i - f) \le |||\psi|||_A = |||f_i - f|||_A.$$

The proof is complete.

Lemma 4.5. Let A be an N-function such that A and A^* verify the Δ_2 condition and m a positive integer. If $\psi \in C$ is such that

$$\int_0^\infty B'_{m,A}\left(\{x: |\psi(x)| \ge t\}\right) dt < \infty,$$

then $\psi \in \mathbf{L}_A(B'_{m,A}).$

Proof. Let $\psi \in C$ be such that $\int_0^\infty B'_{m,A}(\{x : |\psi(x)| \ge t\}) dt < \infty$.

By Proposition 4.2 we have $\Lambda_{m,A}(\psi) < \infty$. So there is an $f \in \mathbf{L}_A^+$ such that $\mathcal{G}_m * f \geq |\psi(x)|$ on \mathbb{R}^N .

Let $h \in C_0$ be arbitrary, and let $\eta \in C_0$ be a cut off function such that $\eta(x) = 1$ on supph, and $0 \le \eta \le 1$. Thus $\eta \psi \in C_0$, and $(1-\eta)h = 0$. Hence $|\psi(x) - \eta(x)\psi(x)| \le (1 - \eta(x)) |\mathcal{G}_m * f(x) - h(x)|$. Then from Proposition 4.1, $\Lambda_{m,A}(\psi - \eta\psi) \le \Lambda_{m,A}(\mathcal{G}_m * f - h)$. From Lemma 4.4, $\eta \psi \in \mathbf{L}_A(B'_{m,A})$. So, for $\varepsilon > 0$, there is $v \in D(\mathbb{R}^N)$ such that $\Lambda_{m,A}(v - \eta\psi) \le \frac{\varepsilon}{2}$. And from Lemma 4.3, $\mathcal{G}_m * f \in \mathbf{L}_A(B'_{m,A})$. So, there is $h \in D(\mathbb{R}^N)$ such that $\Lambda_{m,A}(\mathcal{G}_m * f - h) \le \frac{\varepsilon}{2}$. Now $\Lambda_{m,A}(\psi - v) \le \Lambda_{m,A}(\psi - v\psi) + \Lambda_{m,A}(v - \eta\psi) \le \varepsilon$.

Theorem 4.6. Let A be an N-function such that A and A^* verify the Δ_2 condition and m a positive integer. Then a function ψ on \mathbb{R}^N belongs to $\mathbf{L}_A(B'_{m,A})$ if and only if it is (m, A)-quasicontinuous, and

$$\int_{0}^{\infty} B'_{m,A}\left(\{x : |\psi(x)| \ge t\}\right) dt < \infty.$$
(4)

Proof. Let $\psi \in \mathbf{L}_A(B'_{m,A})$. Then there is a sequence $(\psi_i)_i$ of continuous, compactly supported functions such that

$$\int_0^\infty B'_{m,A}\left(\{x: |\psi(x) - \psi_i(x)| \ge t\}\right) dt \le 4^{-i}.$$

This implies

$$B'_{m,A}\left(\left\{x: |\psi(x) - \psi_i(x)| \ge 2^{-i}\right\}\right) . 2^{-i} \le 4^{-i}.$$

Hence

$$B'_{m,A}\left(\left\{x: |\psi(x) - \psi_i(x)| \ge 2^{-i}\right\}\right) \le 2^{-i}$$

Since $B'_{m,A}$ is an outer capacity (see[10]), there is an open set such that

$$O_i \supset \{x : |\psi(x) - \psi_i(x)| \ge 2^{-i}\}$$
 and $B'_{m,A}(O_i) \le 2^{-i+1}$.

Pose
$$O = \bigcup_{i=k}^{\infty} O_i$$
. Then $B'_{m,A}(O) \le \sum_{i=k}^{\infty} B'_{m,A}(O_i) \le 2^{-k+2}$.

Moreover $\psi_i(x) \to \psi(x)$ uniformly on O^c , and k is arbitrary. Thus ψ is (m, A)-quasicontinuous on \mathbb{R}^N .

Let ψ be an (m, A)-quasicontinuous function that satisfies (4). We can assume that ψ is real valued. Define, for R > 0, ψ_R by $\psi_R(x) = \psi(x)$ when $|\psi(x)| \leq R$, $\psi_R(x) = R$ when $\psi(x) > R$, and $\psi_R(x) = -R$ when $\psi(x) < -R$. Then ψ_R is also quasicontinuous, and

$$\int_{0}^{\infty} B'_{m,A} \left(\{ x : |\psi(x) - \psi_{R}(x)| \ge t \} \right) dt = \\ \int_{0}^{\infty} B'_{m,A} \left(\{ x : |\psi(x)| \ge R + t \} \right) dt \\ \le \int_{R}^{\infty} B'_{m,A} \left(\{ x : |\psi(x)| \ge t \} \right) dt,$$

which is arbitrarily small.

Since ψ_R is quasicontinuous, for $\varepsilon > 0$, we can find an open set Owith $B'_{m,A}(O) < \varepsilon$ such that ψ_R restricted to O^c is continuous. By the Tietze extension theorem there is a continuous function φ such that $\varphi|_{O^c} = \psi_R|_{O^c}$ and $\|\varphi\|_{\infty} \leq R$. Then

$$\int_0^\infty B'_{m,A}\left(\{x: |\varphi(x) - \psi_R(x)| \ge t\}\right) dt \le 2RB'_{m,A}(O) < 2R\varepsilon,$$

and the proof is finished.

Corollary 4.7 Let A and m be as in the previous theorem. If $\psi \in \mathbf{L}_A(B'_{m,A})$, and if φ is an (m, A)-quasicontinuous function such that $|\varphi| \leq |\psi|$ a.e., then

 $\varphi \in \mathbf{L}_A(B'_{m,A}), and \|\varphi\|_{\mathbf{L}_A(B'_{m,A})} \le \|\psi\|_{\mathbf{L}_A(B'_{m,A})}.$

Moreover, if $\mathbf{L}_{m,A}$ is imbedded in a Banach space \mathbf{B} such that $\|.\|_{\mathbf{B}}$ is monotone in the sense that $\|u\|_{\mathbf{B}} \leq \|v\|_{\mathbf{B}}$ for all u and v such that $|u(x)| \leq |v(x)|$ everywhere, then \mathbf{B} contains $\mathbf{L}_{A}(B'_{m,A})$.

Proof. By [9] the assumptions imply that $|\varphi| \leq |\psi|$ (m, A)-q.e. It follows that φ verifies (4), and thus $\varphi \in \mathbf{L}_A(B'_{m,A})$. An easy extension of (3) gives the norm inequality.

For the second part, suppose that $||u||_{\mathbf{B}} \leq C||u||_{m,A}$ for all $v \in \mathbf{L}_{m,A}$. Let $v \in D(\mathbb{R}^N)$. Then $||v||_{\mathbf{B}} \leq ||\mathcal{G}_m * f||_{\mathbf{B}} \leq C||\mathcal{G}_m * f||_{\mathbf{B}} = C|||f|||_A$ for all $f \in \mathbf{K}_v$. Hence $||v||_{\mathbf{B}} \leq C\Lambda_{m,A}(v)$.

Since $\mathbf{L}_A(B'_{m,A})$ is the closure of $D(\mathbb{R}^N)$, the conclusion follows.

We describe now the dual space to $\mathbf{L}_A(B'_{m,A})$.

Theorem 4.8. Let A be an N-function such that A verifies the Δ_2 condition and m > 0. Then the dual space $\mathbf{L}_A(B'_{m,A})^*$ can be identified with the space of all $\mu \in \mathfrak{M}(\mathbb{R}^N)$ such that $\mathcal{G}_m * |\mu| \in \mathbf{L}_{A^*}$. If $\psi \in$ $\mathbf{L}_A(B'_{m,A})$ and $\mu \in \mathbf{L}_A(B'_{m,A})^*$, then $\psi \in \mathbf{L}^1(|\mu|)$, and the duality is given by

$$\langle \mu,\psi\rangle = \int_{R^N} \psi d\mu$$

Moreover, the norm of μ in $\mathbf{L}_A(B'_{m,A})^*$ is $||\mathcal{G}_m * |\mu|||_{A^*}$.

Proof. Let $\mu \in \mathfrak{M}(\mathbb{R}^N)$ be such that $||\mathcal{G}_m * |\mu|||_{A^*} < \infty$, and $\psi \in C_0$. Let $f \in \mathbf{K}_{\psi}$. Then

$$\int_{\mathbb{R}^{N}} |\psi| \, d \, |\mu| \leq \int_{\mathbb{R}^{N}} (\mathcal{G}_{m} * f) \, d \, |\mu| = \int_{\mathbb{R}^{N}} f(\mathcal{G}_{m} * |\mu|) \, d \, x \leq \\ |||f|||_{A} \cdot ||\mathcal{G}_{m} * |\mu| \, ||_{A^{*}}.$$

Hence

$$\int_{\mathbb{R}^N} |\psi| \, d \, |\mu| \le \Lambda_{m,A}(\psi) . \left| \left| \mathcal{G}_m * |\mu| \right| \right|_{A^*}.$$

This implies that any Cauchy sequence in $\mathbf{L}_A(B'_{m,A})$ is Cauchy in $\mathbf{L}^1(|\mu|)$ and thus $\mathbf{L}_A(B'_{m,A}) \subset \mathbf{L}^1(|\mu|)$ since $\mathbf{L}_A(B'_{m,A})$ is the completion of C_0 . Moreover

$$\int_{R^N} \psi d\mu \le |||f|||_{A} \cdot ||\mathcal{G}_m * |\mu| ||_{A^*},$$

so μ defines a linear functional on $\mathbf{L}_A(B'_{m,A})$ with norm $\|\mu\| \leq \|\mathcal{G}_m * |\mu|\|_{A^*}$.

Conversely, consider $\mu : \psi \mapsto \langle \mu, \psi \rangle$ a bounded linear functional on $\mathbf{L}_A(B'_{m,A})$ with norm $\|\mu\|$. Let K be a compact set, and let $\chi \in C_0$ such that $0 \leq \chi \leq 1$, and $\chi|_K = 1$. Then for any $\psi \in C_0(K)$ we have $|\psi| \leq \|\psi\|_{\infty} \cdot \chi$, and thus

$$|\langle \mu, \psi \rangle| \le \|\mu\| \cdot \Lambda_{m,A}(\psi) \le \|\mu\| \cdot \|\psi\|_{\infty} \cdot \Lambda_{m,A}(\chi).$$

This implies that μ is a bounded linear functional on $C_0(K)$ for each compact K. By the Riesz representation theorem, μ can be identified with a Radon measure so that $\langle \mu, \psi \rangle = \int_{\mathbb{R}^N} \psi d\mu$ for all $\psi \in C_0$. It only remains to prove that $||\mathcal{G}_m * |\mu|||_{A^*} \leq ||\mu||$ since C_0 is dense in $\mathbf{L}_A(B'_{m,A})$. We have

$$\int_{\mathbb{R}^N} \psi d \, |\mu| = \sup \left\{ \int_{\mathbb{R}^N} \varphi d\mu : \varphi \in C_0, \ |\varphi| \le \psi \right\}.$$

By assumption $\left|\int_{R^N} \varphi d\mu\right| \leq \|\mu\| . \Lambda_{m,A}(\varphi)$, and thus $\int_{R^N} \psi d|\mu| \leq \|\mu\| . \Lambda_{m,A}(\psi)$ for all positive ψ in C_0 .

By approximation from below, here C_0 is dense in \mathbf{L}_A because A verifies the Δ_2 condition, it follows that for all $f \in \mathbf{L}_A^+$

$$\int_{\mathbb{R}^{N}} f(\mathcal{G}_{m} * |\mu|) \, dx = \int_{\mathbb{R}^{N}} f(\mathcal{G}_{m} * |\mu|) \, dx \le \|\mu\| . \Lambda_{m,A}(\mathcal{G}_{m} * f)) \le \|\mu\| . \|\|f\||_{A}.$$

But we know that

$$||\mathcal{G}_m * |\mu|||_{A^*} = \sup\left\{\int_{\mathbb{R}^N} f(\mathcal{G}_m * |\mu|) \, dx : |||f|||_A \le 1\right\},$$

 \mathbf{SO}

$$||\mathcal{G}_m * |\mu|||_{A^*} \le ||\mu||.$$

This completes the proof.

5 Maximal operators and capacity

Let $(\theta_j)_j$ be a sequence of convolution operators. Define the maximal operator J by $J(f) = \sup_j |\theta_j * f|$, where f is initially taken to be in the Schwarz class of rapidly decreasing C^{∞} functions on \mathbb{R}^N denoted by $S = S(\mathbb{R}^N)$.

An operator $H : \mathbf{L}_A \to \mathbf{L}_A$ is of strong type (A, A) if

$$|||H(f)|||_A \le C|||f|||_A, \,\forall f \in \mathbf{L}_A,$$

where C is a constant dependent only on A.

For more details, see [25].

Definition 5.1. An operator $H : \mathbf{L}_A \to \mathbf{L}_A$ is of capacitary weak type (A, A) if

$$\forall f \in \mathbf{L}_A, \forall t > 0, \ R'_{m,A}\left(\{x : H(\mathcal{R}_m * f)(x) \ge t\}\right) \le C_A \frac{|||f|||_A}{t},$$

where C_A is a constant dependent only on N, m and A.

H is of capacitary strong type (m, A) if

$$\forall f \in \mathbf{L}_A, \ \int_0^\infty R'_{m,A} \left(\{ x : H(\mathcal{R}_m * f)(x) \ge t \} \right) dt \le C |||f|||_A,$$

where C is a constant dependent only on N, m and A.

Proposition 5.1. 1. Let A be an N-function such that A and A^* verify the Δ_2 condition, $\alpha = \alpha$ (A) and m is a positive integer such that $m < N/\alpha$. If J is of strong type (A, A), then it is also of capacitary strong type (m, A).

2. Let A be any N-function. If J is of strong type (A, A) and 0 < m < N, then it is also of capacitary weak type (m, A).

Proof. Let $f \in S$. Then $\theta_j * (\mathcal{R}_m * f) = \mathcal{R}_m * (\theta_j * f)$. This implies $J(\mathcal{R}_m * f) \leq \mathcal{R}_m * (J(f))$. By Theorem 3.7,

$$\int_0^\infty R'_{m,A}(\{x: J(\mathcal{R}_m * f)(x) \ge t\})dt \le C|||J(f)|||_A \le C|||f|||_A.$$

For the second statement, we have the obvious inequality

$$R'_{m,A}(\{x : \mathcal{R}_m * f(x) \ge t\}) \le \frac{|||f|||_A}{t}.$$

Hence

$$R'_{m,A}(\{x: J(\mathcal{R}_m * f)(x) \ge t\}) \le C \frac{|||f|||_A}{t}$$

The proof is finished.

6 Some open questions

- 1. The first natural question is: whether or not Theorem 3.7 is valid for $m \in \mathbb{R}^+$.
- 2. We recall the definition of radially decreasing convolution kernel.

Definition 6.1. A function g defined on $\mathbb{R}^N \times \mathbb{R}^N$ is a radially decreasing convolution kernel if $g(x, y) = g_0(|x - y|)$, where g_0 is a positive lower semicontinuous, non-increasing function on \mathbb{R}^+ and such that $\int_0^1 g_0(t)t^{N-1}dt < \infty$.

As in Lebesgue case, can Theorem 3.7 be extended to radially decreasing convolution kernels?

3. For \mathbf{L}^p Lebesgue case, we have the obvious capacitary weak inequality

$$\mathcal{S}_{m,p}\left(\{x:\mathcal{S}_m*f(x)\geq t\}\right)\leq \left(\frac{||f||_p}{t}\right)^p=\frac{||f||_p^p}{t^p}.$$

Here $\mathcal{S}_{m,p}(X) = \inf \left\{ ||f||_p^p : f \in \mathbf{L}_p^+ \text{ and } \mathcal{S}_m * f \ge 1 \text{ on } X \right\}$ Hence

$$\mathcal{S}_{m,p}\left(\left\{x:\mathcal{S}_m*f(x)\geq t\right\}\right).t^p\leq ||f||_p^p.$$

And we know the following stronger version of Theorem 3.7

$$\int_0^\infty \mathcal{S}_{m,p}\left(\{x: \mathcal{S}_m * f(x) \ge t\}\right) dt^p \le C ||f||_p^p.$$

For Orlicz case, we have the obvious capacitary weak inequality

$$\mathcal{S}_{m,A}\left(\{x:\mathcal{S}_m*f(x)\geq t\}\right)\leq A\left(\frac{|||f|||_A}{t}\right)$$

Then the question is: whether or not the following stronger version of Theorem 3.7 holds

$$\int_0^\infty \mathcal{S}_{m,A}\left(\{x: \mathcal{S}_m * f(x) \ge t\}\right) dA(t) \le CA(|||f|||_A).$$

Here dA(t) = a(t)dt, and $\mathcal{S}_{m,A}(X) = A(\mathcal{S}'_{m,A}(X)).$
