Introducció

Aquest recull bibliogràfic té per objectiu de proporcionar un potencial i ampli fons documental sobre el fet social en el marc urbà de la nostra contemporaneïtat des de, sobretot, la perspectiva de l'antropologia urbana. Cal recordar, a més, que el conjunt de l'antropologia com a disciplina ha estat desenvolupada des de societats que havien elaborat sistemes de vida urbans i que pensaven des d'estructures i objectius d'aquestes mateixes societats.

La primera evidència a la qual aquesta tasca ens ha enfrontat és que en aquest camp específic la interdisciplinarietat és inexcusable. Hem inclòs aquí aportacions fetes tant des de l'antropologia com des de la geografia, la sociologia o l'urbanisme. Una aproximació a la ciutat com a *modus vivendi* d'una gran part de la humanitat no podia, malgrat que partís des del *background teòric* de l'antropologia urbana, obviar les aportacions que des de tots aquests diversos àmbits s'han fet.

Tot i voler recollir treballs recents per tal de poder documentar l'antropologia urbana més vigent, més contemporània, hem creut necessari també (les dates de publicació així ho testimonien) de submarcir-nos en una mínima part de la producció històrica de la disciplina per tal de poder-hi situar els antecedents i els contextos de formació i elaboració de l'actual producció.

Ja per finalitzar només volem constatar el fet que som conscients de les limitacions que té un recull així. No hem pretès abraçar-ho tot, hauria es-

tat impossible, tan sols donar forma a una eina de treball útil per a tots aquells que s'interessin pel camp de l'antropologia urbana. Sabem que no hi és tot el que hi hauria de ser, però creiem que el modest objectiu principal sí que ha estat assolit.
