Robust satisfiability for CSPs: hardness and algorithmic results

An algorithm for a constraint satisfaction problem is called robust if it outputs an assignment satisfying at least a $(1 - f(\epsilon))$ -fraction of constraints for each $(1 - \epsilon)$ -satisfiable instance (i.e. such that at most a ϵ -fraction of constraints needs to be removed to make the instance satisfiable), where $f(\epsilon) \rightarrow 0$ as $\epsilon \rightarrow 0$. We establish an algebraic framework for analyzing constraint satisfaction problems admitting an efficient robust algorithm with functions f of a given growth rate. We use this framework to derive hardness results. We also describe three classes of problems admitting an efficient robust algorithm such that f is $O(1/\log(1/\epsilon))$, $O(\epsilon^{1/k})$ for some $k > 1$, and $O(\epsilon)$, respectively. Finally, we give a complete classification of robust satisfiability with a given f for the Boolean case.

1. INTRODUCTION

The constraint satisfaction problem (CSP) provides a framework in which it is possible to express, in a natural way, many combinatorial problems encountered in computer science and AI [Cohen and Jeavons 2006; Creignou et al. 2001; Feder and Vardi 1998]. An instance of the CSP consists of a set of variables, a domain of values, and a set of constraints on combinations of values that can be taken by certain subsets of variables. The aim is then to find an assignment of values to the variables that satisfies the constraints (decision version) or that satisfies the maximum number of constraints (optimization version).

Since the CSP is NP-hard in full generality, a major line of research in CSP tries to identify the tractable cases of such problems (see [Creignou et al. 2001; Creignou et al. 2008]), the primary motivation being the general picture rather than specific applications. The two main ingredients of a constraint are (a) variables to which it is applied and (b) relations specifying the allowed combinations of values or the costs for all combinations. Therefore, the main types of restrictions on CSP are (a) *structural*

where the hypergraph formed by sets of variables appearing in individual constraints is restricted [Gottlob et al. 2009; Marx 2010], and (b) *language-based* where the constraint language Γ , i.e. the set of relations that can appear in constraints, is fixed (see, e.g. [Bulatov et al. 2005; Cohen and Jeavons 2006; Creignou et al. 2001; Feder and Vardi 1998]); the corresponding problem is denoted by $\text{CSP}(\Gamma)$. The language-based direction is considerably more active than the structural one, and there are many partial language-based complexity classification results, e.g. [Barto and Kozik 2009; 2012; Bulatov 2006; 2011; Creignou et al. 2001; Deineko et al. 2008; Jonsson et al. 2006; Jonsson et al. 2011], but many central questions are still open.

The use of approximation algorithms is one of the most fruitful approaches to coping with NP-hard optimization problems. The CSP has always played an important role in the study of approximability. For example, the famous PCP theorem has an equivalent reformulation in terms of inapproximability of a certain $\text{CSP}(\Gamma)$, see [Arora and Barak 2009]; moreover, the recent combinatorial proof of this theorem [Dinur 2007] deals entirely with CSPs. The first optimal inapproximability results [Håstad 2001] by Håstad were about problems $\text{CSP}(\Gamma)$, and they led to the study of a new hardness notion called approximation resistance [Håstad 2008], which, intuitively, means that a problem cannot be approximated better than by just picking a random assignment, even on almost satisfiable instances. Arguably, the most exciting development in approximability in the past five to six years is the work around the Unique Games Conjecture (UGC) of Khot, see survey [Khot 2010]. The UGC states that it is NP-hard to tell almost satisfiable instances of $\text{CSP}(\Gamma)$ from those where only a small fraction of constraints can be satisfied, where Γ is the constraint language consisting of all graphs of permutations over a large enough domain. This conjecture (if true) is known to imply optimal inapproximability results for many classical optimization problems [Khot 2010]. Moreover, if the UGC is true then a simple algorithm based on semidefinite programming (SDP) provides the best possible approximation for all optimization problems $\text{CSP}(\Gamma)$ [Raghavendra 2008], though the exact quality of this approximation is unknown. There is, however, no unanimity as to which way the UGC will be resolved [Arora et al. 2010]. A common theme in these results is the focus on *almost satisfiable* instances, i.e. those where a tiny fraction of constraints can be removed to make the remaining instance satisfiable. The approximability of CSPs restricted to such instances has been actively studied, see references in [Khot 2010], also [Charikar et al. 2009; Guruswami et al. 2011; Guruswami and Zhou 2012; Zwick 1998]; this additional restriction may change the approximability of a problem. Most, but not all, algorithms used in this line of research are based on LP (linear programming) or SDP, and analytic methods are used to study them.

A polynomial-time algorithm for $\text{CSP}(\Gamma)$ would, in general, treat all unsatisfiable instances the same. When can such an algorithm be made to also deal with near-misses, i.e. find almost satisfying assignments for almost satisfiable instances? There is a line of research aimed at identifying tractable optimization problems $\text{CSP}(\Gamma)$, i.e. those where an optimal assignment can always be found in polynomial time [Cohen et al. 2005], and this property is known to be quite restrictive [Deineko et al. 2008; Jonsson et al. 2006; Jonsson et al. 2011]. The following natural notion of tractability, which is stronger than classical tractability of $\text{CSP}(\Gamma)$, but much less restrictive than tractability of optimization version of $\text{CSP}(\Gamma)$, was suggested in [Zwick 1998]. Call $\text{CSP}(\Gamma)$ *robustly solvable* if there is a polynomial-time algorithm which, for every $\epsilon > 0$ and every $(1 - \epsilon)$ -satisfiable instance of $\text{CSP}(\Gamma)$ (i.e. at most an ϵ -fraction of constraints can be removed to make the instance satisfiable), outputs a $(1 - f(\epsilon))$ -satisfying assignment (i.e. that fails to satisfy at most a $f(\epsilon)$ -fraction of constraints) where f is a function such that $f(\epsilon) \rightarrow 0$ as $\epsilon \rightarrow 0$ and $f(0) = 0$. Note that the running time of the algorithm

should not depend on ϵ (which is unknown when the algorithm is run). Thus, robust solvability combines, in a natural way, tractability and approximation for CSPs.

The main goal of this paper is to study robust algorithms for problems $\text{CSP}(\Gamma)$. Two very recent papers [Barto and Kozik 2012; Kun et al. 2012] study the same topic. In fact, some of our results, (hardness) Theorem 3.8 and (positive) Theorem 5.2, were announced simultaneously with [Kun et al. 2012] where Theorem 5.2 is proved independently in a different way. Our Theorem 3.8(1) describes problems $\text{CSP}(\Gamma)$ that cannot have an efficient robust algorithm unless $P = NP$. Predicting this theorem, Guruswami and Zhou conjectured [Guruswami and Zhou 2012] that all other problems do admit an efficient robust algorithm, Theorem 5.2 was a partial confirmation of the conjecture. Soon after our Theorem 3.8 and Theorem 5.2 were announced, Barto and Kozik fully confirmed the conjecture in [Barto and Kozik 2012]. The function $f(\epsilon)$ in [Barto and Kozik 2012] is $O(\log \log (1/\epsilon) / \log (1/\epsilon))$ for the randomized algorithm and $O(\log \log (1/\epsilon) / \sqrt{\log (1/\epsilon)})$ for its derandomization, thus one can naturally ask which problems $\text{CSP}(\Gamma)$ have efficient robust algorithms with better functions f . Our results in this direction, Theorems 5.2, 5.3 and 5.8 contribute towards answering this question within a well known class of CSPs, CSPs of width 1. The last two theorems are obtained after, and influenced by, results from [Barto and Kozik 2012; Kun et al. 2012].

Recent breakthroughs in the study of the complexity of CSP have been made possible by the introduction of the universal-algebraic approach (see [Bulatov et al. 2005; Cohen and Jeavons 2006]), which extracts algebraic structure from a given constraint language Γ (via operations called *polymorphisms* of Γ) and uses it to analyze problem instances. More precisely, Γ is associated a finite universal algebra \mathbb{A} , whose operations are the polymorphisms of Γ , such that the complexity of $\text{CSP}(\Gamma)$ (and some other important features) is determined solely by the properties of \mathbb{A} . This approach is usually used with the following pattern: a property is identified, often in terms of operations with specific identities, such that either \mathbb{A} fails this property and then $\text{CSP}(\Gamma)$ can simulate some simple problem(s) with undesirable attributes (e.g. intractable or not robustly solvable), or else \mathbb{A} has the property, that often comes in several equivalent forms, which is then used to analyze problem instances and design required algorithms. Note that every single step in the above description usually requires non-trivial work. We adapt the universal-algebraic framework to study robust algorithms in Section 3. We hope that the algebraic approach will become just as fruitful for the study of robust satisfiability as it has been for the study of decision CSPs.

Establishing local consistency is one of the most natural algorithms for dealing with (decision) CSPs. The basic idea is to inspect a given instance locally, deriving new constraints according to the currently observed part of the instance and then moving to another part, until no new constraints can be derived. Then either a contradiction is derived or else local consistency is established (which in general does not imply the existence of a solution). Under additional assumptions on Γ , the latter does imply the existence of a solution. These additional assumptions can often be expressed in terms of polymorphisms [Bulatov et al. 2008; Carvalho et al. 2010; Dalmau 2005; Feder and Vardi 1998]. There are many sorts of local consistency that have been studied in the literature, which use various rules for deriving new constraints. One nice way to formalize the fact that some form of local consistency correctly solves a $\text{CSP}(\Gamma)$ is via homomorphism dualities, and we use this approach in the present paper (see Section 4). We use algebraic characterizations of some dualities to design robust approximation algorithms for $\text{CSP}(\Gamma)$ in Section 5. For a given almost satisfiable instance, the algorithms seek to remove a small fraction of constraints to achieve some form of local consistency, thus obtaining an assignment satisfying the remaining constraints.

Finally, in Section 6, we use our results together with some earlier results to complete the picture of robust satisfiability in the Boolean (i.e. two-valued) case: for each Γ we describe the best possible function f , modulo complexity-theoretic assumptions.

2. PRELIMINARIES

Let A be a finite set. A k -ary tuple $\mathbf{a} = (a_1, \dots, a_k)$ is any element of A^k . For $1 \leq i \leq k$, we shall use \mathbf{a}_i to denote the i th element a_i of \mathbf{a} . A k -ary relation on A is a collection of k -ary tuples or, alternatively, a subset of A^k . We shall use $\rho(R)$ to denote the arity of relation R . For any $1 \leq i \leq k$, the *projection* of R to the i th coordinate $\text{pr}_i(R) \subseteq A$ is defined as $\text{pr}_i(R) = \{\mathbf{a}_i \mid \mathbf{a} \in R\}$.

An *instance* of the CSP is a triple $I = (V, A, \mathcal{C})$ with V a finite set of *variables*, A a finite set called *domain*, and \mathcal{C} a finite list of *constraints*, where each constraint is a pair $C = (\mathbf{v}, R)$ where $\mathbf{v} = (v_1, \dots, v_k)$ is a tuple of variables of length k , called the *scope* of C , and R an k -ary relation on D , called the *constraint relation* of C . The *arity* of a constraint C , $\rho(C)$, is defined to be arity of its constraint relation.

Note that we allow repetition of constraints in \mathcal{C} . Very often we will say that a constraint C belongs to instance I when, strictly speaking, we should be saying that appears in the constraint list \mathcal{C} of I . Also, we might sometimes write (v_1, \dots, v_k, R) instead of $((v_1, \dots, v_k), R)$. A finite set of relations Γ on a finite set A is called a *constraint language*. The problem $\text{CSP}(\Gamma)$ consists of all instances of the CSP where all the constraint relations are from Γ . An assignment for I is a mapping $s : V \rightarrow A$. We say that s *satisfies* a constraint (\mathbf{v}, R) if $s(\mathbf{v}) \in R$ (where s is applied component-wise). For $0 \leq \alpha \leq 1$, we say that assignment s α -*satisfies* I if it satisfies at least α -fraction of the constraints in I . In this case, we say that I is α -satisfiable.

The *decision problem* for $\text{CSP}(\Gamma)$ asks whether an input instance I of $\text{CSP}(\Gamma)$ has a solution, i.e., an assignment satisfying all constraints. The *optimization problem* for $\text{CSP}(\Gamma)$ asks to find an assignment that satisfies the maximum number of constraints. The maximization problem is computationally intractable for the vast majority of constraint languages Γ motivating the study of *approximation* algorithms.

Let Γ be a constraint language and let ALG be an algorithm that receives as input an instance of $\text{CSP}(\Gamma)$ and returns an assignment for its input. For real numbers $0 \leq \alpha, \beta \leq 1$ we say that ALG (α, β) -*approximates* $\text{CSP}(\Gamma)$ if it outputs an assignment satisfying at least α -fraction of constraints for any β -satisfiable instance I (i.e. where an optimal assignment satisfies β -fraction of the constraints).

Let $f : [0, 1] \rightarrow [0, \infty)$ be an *error function* with $f(\epsilon) \rightarrow 0$ as $\epsilon \rightarrow 0$ and $f(0) = 0$. If ALG $(1 - f(\epsilon), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma)$ for every $\epsilon \geq 0$ then we say that ALG *robustly solves* $\text{CSP}(\Gamma)$. Furthermore, if $f(\epsilon) = O(\epsilon^{1/k})$ for some $k \geq 1$ then we say that ALG *robustly solves* $\text{CSP}(\Gamma)$ *with polynomial loss*.

If \mathcal{G} is a finite Abelian group we denote by $3\text{EQ-LIN}(\mathcal{G})$ the constraint language over the base set of \mathcal{G} that contains all linear equations over \mathcal{G} with at most 3 variables. As a consequence of the following theorem by Håstad, $3\text{EQ-LIN}(\mathcal{G})$ is not robustly solvable if \mathcal{G} has more than one element.

THEOREM 2.1. [Håstad 2001] *If \mathcal{G} is an Abelian group with $d > 1$ elements then for every $\epsilon > 0$ there is no polynomial-time algorithm that $(1/d + \epsilon, 1 - \epsilon)$ -approximates $\text{CSP}(3\text{EQ-LIN}(\mathcal{G}))$ unless $\text{P} = \text{NP}$.*

Local consistency is a powerful family of algorithms used in the decision problem for $\text{CSP}(\Gamma)$. For fixed integers $0 \leq j \leq k$, the (j, k) -*consistency* algorithm derives constraints on j variables which can be deduced by looking at k variables at a time. The algorithm finishes after a polynomial number of steps. During this process, the algorithm might generate a contradiction, that is, a constraint with empty constraint

relation meaning that the instance has no solution. Since CSP is NP-complete one cannot expect that the converse always holds. We say that $\text{CSP}(\Gamma)$ has *width* (j, k) if an instance has a solution if and only if the (j, k) -consistency algorithm does not derive a contradiction. Finally, we say that $\text{CSP}(\Gamma)$ has *width* j if it has width (j, k) for some $j \leq k$ and that $\text{CSP}(\Gamma)$ has *bounded width* if it has width j for some $j \geq 0$. We shall give a precise, alternative characterization of bounded width CSPs in Section 2.1. The power of (j, k) -consistency is, by now, very well understood due to the results of Barto and Kozik [Barto and Kozik 2009], building upon [Maróti and McKenzie 2008] (see Theorem 2.7 below) and Bulatov [Bulatov 2009].

Guruswami and Zhou conjectured the following connection between bounded width and approximation:

CONJECTURE 2.2. ([Guruswami and Zhou 2012]) *For every constraint language Γ , $\text{CSP}(\Gamma)$ has bounded width if and only if it is robustly solvable.*

The 'only if' direction of the conjecture follows with just a little bit of work from known results. We prove it in Section 3. The 'if' part is much more difficult. In Section 5 we give a proof for the case of width 1 CSPs. This result has been obtained independently by Kun et al [Kun et al. 2012]. Later, Barto and Kozik presented a proof for all bounded width CSPs, settling the Guruswami-Zhou conjecture.

THEOREM 2.3. [Barto and Kozik 2012] *For every constraint language Γ , if $\text{CSP}(\Gamma)$ has bounded width then it is robustly solvable.*

In this paper, we are interested in a more fine-grained analysis of robust approximation that takes into consideration the quantitative dependence of f on ϵ (linear loss $O(\epsilon)$, quadratic loss $O(\epsilon^{1/2})$, etc.). To investigate it, we introduce the notation $\text{CSP}(\Gamma) \leq_{\text{RA}} \text{CSP}(\Gamma')$ as a shorthand for: *for any error function f with $\lim_{\epsilon \rightarrow 0} f(\epsilon) = 0$, if some algorithm $(1 - f(\epsilon), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma')$ for every $\epsilon \geq 0$ then there is a polynomial-time algorithm that $(1 - O(f(\epsilon)), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma)$ for every $\epsilon \geq 0$. Note that the relation \leq_{RA} is transitive.*

We need a few concepts from propositional logic. A clause is Horn (respectively, dual Horn) if it contains at most one positive (respectively, one negative) literal. Let k -HORN (resp. k -DualHORN) be the constraint language over the Boolean domain that contains all Horn (dual Horn) clauses with at most k variables, and let 2-SAT be the constraint language over the Boolean domain containing all clauses with at most 2 literals. Let \neq_2 be the boolean relation $\{(0, 1), (1, 0)\}$.

The next theorem uses Khot's Unique Games (UG) conjecture [Khot 2002]. This conjecture states that, for any $\epsilon \geq 0$, there is a large enough number $k = k(\epsilon)$ such that it is NP-hard to tell ϵ -satisfiable from $(1 - \epsilon)$ -satisfiable instances of $\text{CSP}(\Gamma_k)$, where Γ_k consists of all graphs of bijections on a k -element set.

THEOREM 2.4. [Zwick 1998; Guruswami and Zhou 2012; Charikar et al. 2009; Khot et al. 2007] *Let $k \geq 1$. The following conditions hold:*

- (1) *There is a polynomial time algorithm that $(1 - O(1/\log(1/\epsilon)), 1 - \epsilon)$ -approximates $\text{CSP}(k\text{-HORN})$ for all $\epsilon \geq 0$.*
- (2) *If $k \geq 3$, there is no polynomial time algorithm that $(1 - o(1/\log(1/\epsilon)), 1 - \epsilon)$ -approximates $\text{CSP}(k\text{-HORN})$ for all $\epsilon \geq 0$ unless the UG conjecture is false.*
- (3) *There is a polynomial time algorithm that $(1 - O(\sqrt{\epsilon}), 1 - \epsilon)$ -approximates $\text{CSP}(2\text{-SAT})$ for all $\epsilon \geq 0$.*
- (4) *There is no polynomial time algorithm that $(1 - o(\sqrt{\epsilon}), 1 - \epsilon)$ -approximates $\text{CSP}(\{\neq_2\})$ for all $\epsilon \geq 0$ unless the UG conjecture is false.*

Conditions (1) and (2) obviously hold if we replace k -HORN by k -DualHORN.

For any instance $I = (V, A, \mathcal{C})$ of $\text{CSP}(\Gamma)$, there is an equivalent canonical 0-1 integer program. It has variables $p_v(a)$ for every $v \in V$, $a \in A$, as well as variables $p_C(\mathbf{a})$ for every constraint $C = (\mathbf{v}, R)$ and every tuple $\mathbf{a} \in A^{\rho(R)}$. The interpretation of $p_v(a) = 1$ is that variable v is assigned value a ; the interpretation of $p_C(\mathbf{a}) = 1$ is that \mathbf{v} is assigned (component-wise) tuple \mathbf{a} . More formally, the program is the following:

$$\text{maximize: } \frac{1}{|\mathcal{C}|} \sum_{C=(\mathbf{v}, R) \in \mathcal{C}} p_C(R)$$

subject to:

$$p_v(A) = 1 \quad v \in V \quad (1)$$

$$p_C(A^{j-1} \times \{a\} \times A^{\rho(C)-j}) = p_{\mathbf{v}_j}(a) \quad C = (\mathbf{v}, R) \in \mathcal{C}, 1 \leq j \leq \rho(C), a \in A \quad (2)$$

where, for every $v \in V$ and $S \subseteq A$, $p_v(S)$ is a shorthand for $\sum_{a \in S} p_v(a)$ and for every C and every $T \subseteq A^{\rho(C)}$, $p_C(T)$ is a shorthand for $\sum_{\mathbf{a} \in T} p_C(\mathbf{a})$.

If we relax the previous program by allowing the variables to take values in the range $[0, 1]$ instead of $\{0, 1\}$, we obtain the *basic linear programming relaxation* for I , which we denote by $\text{BLP}(I)$. As Γ is fixed, an optimal solution of $\text{BLP}(I)$ can be computed in time polynomial in the representation size of I . Restriction (1) of $\text{BLP}(I)$ expresses the fact that, for each $v \in V$, the quantities $p_v(a), a \in A$ form a discrete probability distribution on A . Also (1) and (2) together express the fact that, for each constraint $C = (\mathbf{v}, R)$, of arity k , the quantities $p_C(\mathbf{a}), \mathbf{a} \in A^k$ form a probability distribution on A^k and that the marginals of the p_C distribution are “consistent” with the p_v distributions.

2.1. Algebra

Most of the terminology introduced in this section is standard. See [Burris and Sankapanaavar 1981] for more detail on basic notions of universal algebra and [Bulatov et al. 2005; Bulatov and Valeriote 2008; Cohen and Jeavons 2006] for more detail about the algebraic approach to the CSP.

An n -ary *operation* on A f is a map from A^n to A . Let us now define several types of operations that will be used in this paper.

- An operation f is *idempotent* if it satisfies the identity $f(x, \dots, x) = x$.
- An n -ary operation f on A is *totally symmetric* if $f(x_1, \dots, x_n) = f(y_1, \dots, y_n)$ whenever $\{x_1, \dots, x_n\} = \{y_1, \dots, y_n\}$. It follows from this condition that we can properly write $f(S)$ for every $S \subseteq A$.
- An n -ary ($n \geq 3$) operation is a *NU (near-unanimity)* operation if it satisfies the identities

$$f(y, x, \dots, x, x) = f(x, y, \dots, x, x) = \dots = f(x, x, \dots, x, y) = x$$

- A ternary NU operation is called a *majority* operation.
- A binary idempotent commutative associative operation is called a *semilattice* operation.
- A pair of semilattice operations on A is a pair of *lattice* operations if, in addition, they satisfy the absorption identities: $f(x, g(x, y)) = g(x, f(x, y)) = x$. In this case (A, f, g) is called a *lattice*.

It is standard practice to use infix notation for lattice operations, i.e., to write $x \sqcup y$ and $x \sqcap y$ for $f(x, y)$ and $g(x, y)$ respectively. A lattice is said to be *distributive* if it satisfies the identity $x \sqcap (y \sqcup z) = (x \sqcap y) \sqcup (x \sqcap z)$. Equivalently, a lattice is distributive

if it can be represented by a family of subsets of a set with the operations interpreted as set-theoretic intersection and union (see [Grätzer 2002]).

An operation f *preserves* (or is a *polymorphism* of) a k -ary relation R if for every n and (not necessarily distinct) tuples $(a_1^i, \dots, a_k^i) \in R$, $1 \leq i \leq n$, the tuple

$$(f(a_1^1, \dots, a_k^1), \dots, f(a_1^n, \dots, a_k^n))$$

belongs to A as well. Given a set Γ of relations on A , we denote by $\text{Pol}(\Gamma)$ the set of all operations that preserve all relations in Γ . If $f \in \text{Pol}(\Gamma)$ then Γ is said to be *invariant* under f . If R is a relation we might freely write $\text{Pol}(R)$ to denote $\text{Pol}(\{R\})$. We denote by $\text{Aut}(\Gamma)$ the set of all unary operations in $\text{Pol}(\Gamma)$ that are one-to-one. Every member of $\text{Aut}(\Gamma)$ is said to be an *automorphism* of Γ . If every unary operation in $\text{Pol}(\Gamma)$ is one-to-one then Γ is said to be a *core*.

The cornerstone of the use of algebra in the exploration of constraint satisfaction is a theorem proven by Geiger and also by Bodnarchuk et al. [Bodnarchuk et al. 1969; Geiger 1968]. In order to state it, we need to introduce some definitions. Let Γ be a finite set of relations on A and let $R \subseteq A^k$. Let eq_A (eq, if A is clear from the context) the relation $\{(a, a) \mid a \in A\}$. We say that R is *pp-definable* from Γ if there exists a (primitive positive) formula

$$\phi(x_1, \dots, x_k) \equiv \exists y_1, \dots, y_l \psi(x_1, \dots, x_k, y_1, \dots, y_l)$$

where ψ is a conjunction of atomic formulas with relations in Γ and eq_A such that for every $(a_1, \dots, a_k) \in A^k$

$$(a_1, \dots, a_k) \in R \text{ if and only if } \phi(a_1, \dots, a_k) \text{ holds.}$$

If ψ does not contain eq_A then we say that R is *pp-definable from Γ without equality*. Note that in the definition of primitive positive formulas we are slightly abusing notation by identifying a relation with its relation symbol.

A k -ary relation R is *irredundant* if for every two different coordinates $1 \leq i < j \leq k$, R contains a tuple (a_1, \dots, a_k) with $a_i \neq a_j$.

THEOREM 2.5. [Bodnarchuk et al. 1969; Geiger 1968] *Let Γ be a finite set of relations on A and let R be a relation on A . Then the following holds.*

- (1) $\text{Pol}(\Gamma) \subseteq \text{Pol}(R)$ if and only if R is pp-definable from Γ .
- (2) if R is irredundant and $\text{Pol}(\Gamma) \subseteq \text{Pol}(R)$ then R pp-definable from Γ without equality.

An *algebra* is an ordered pair $\mathbb{A} = (A, F)$ where A is a non-empty set, called the *universe* of \mathbb{A} , and F is a set of finitary operations on A , called the *basic operations* of \mathbb{A} . If Γ is a set of relations on A , the *algebra associated to Γ* is the algebra $(A, \text{Pol}(\Gamma))$. Throughout the paper we use the same capital letters (with different font) to denote a structure and its universe.

The *term operations* of an algebra are the operations that can be built from its basic operations using composition and projections. The *full idempotent reduct* of an algebra \mathbb{A} is the algebra with the same universe of \mathbb{A} and whose basic operations are the idempotent term operations of \mathbb{A} . For the purposes of this paper it is only necessary to know that the full idempotent reduct of the algebra associated to Γ has as basic operations all the idempotent operations that preserve Γ .

There are some standard ways to assemble new algebras from those already at hand. The most standard ones are the formation of *subalgebras*, *direct products*, and *homomorphic images*, which are defined in a natural way. A class of algebras is a variety if it is closed under formation of homomorphic images (H), subalgebras (S) and direct products (P). The variety generated by \mathbb{A} is denoted by $\mathcal{V}(\mathbb{A})$; it is known that

$\mathcal{V}(\mathbb{A}) = \text{HSP}(\mathbb{A})$, i.e. that every member \mathbb{C} of the $\mathcal{V}(\mathbb{A})$ is obtained as a homomorphic image of a subalgebra of a power of \mathbb{A} ; furthermore this power can be taken to be finite if \mathbb{C} is finite.

A set Γ of finite relations on A is *compatible* with \mathbb{A} if every relation in Γ is preserved by every basic operation in \mathbb{A} .

Tame Congruence Theory (TCT), developed by Hobby and McKenzie [Hobby and McKenzie 1988], is a powerful tool to analyze finite algebras. We use TCT as a black box to link existing results and we do not require precise definitions from TCT (see [Bulatov and Valeriote 2008] for more detail regarding the use of TCT in CSP). Every algebra can be assigned a subset of five *types* that correspond to different possible “local behaviours” of the algebra. The possible types are: (1) the *unary* type, (2) the *affine* type, (3) the *Boolean* type, (4) the *lattice* type, and (5) the *semilattice* type. A variety is said to *admit* a type if this type occurs in some finite algebra in the variety; otherwise, the variety *omits* the type.

The following result follows from [Szendrei 1992] and [Valeriote 2009] (see [Larose and Tesson 2009])

THEOREM 2.6. *Let \mathbb{A} be a finite idempotent algebra.*

- (1) *If $\mathcal{V}(\mathbb{A})$ admits the unary or affine types then there exists an algebra \mathbb{B} in $\text{HS}(\mathbb{A})$ with more than one element and an Abelian group structure \mathcal{G} on the base set, B , of \mathbb{B} such that every relation in $3\text{EQ-LIN}(\mathcal{G})$ is compatible with \mathbb{B} .*
- (2) *If $\mathcal{V}(\mathbb{A})$ omits the unary and affine types, but admits the semilattice type then there exists an algebra \mathbb{B} in $\text{HS}(\mathbb{A})$ whose universe is $\{0, 1\}$ and such that every relation in 3-HORN is compatible with \mathbb{B} .*

It turns out that for every core constraint language Γ , $\text{CSP}(\Gamma)$ has bounded width if and only if its associated algebra fails the first condition of Theorem 2.6. The class of bounded width problems has also several characterizations in terms of the presence of certain operations in $\text{Pol}(\Gamma)$. The following theorem (obtained combining results from [Barto and Kozik 2009; Kozik et al. 2013; Maróti and McKenzie 2008]) provides one of them.

THEOREM 2.7. *Let Γ be a finite set of relations on A such that Γ is a core. Then the following are equivalent:*

- (1) *$\mathcal{V}(\mathbb{A})$ omits the unary or affine types;*
- (2) *$\text{Pol}(\Gamma)$ contains a 3-ary idempotent operation f and a 4-ary idempotent operation g such that for all $a, b \in A$,*

$$f(a, a, b) = f(a, b, a) = f(b, a, a) = g(a, a, a, b) = \dots = g(b, a, a, a);$$

- (3) *$\text{CSP}(\Gamma)$ has bounded width.*

3. ALGEBRAIC REDUCTIONS

Let Γ be any finite set of operations on A . We start by observing that if Γ is not a core then we can easily define another constraint language Γ' on a smaller domain such that $\text{CSP}(\Gamma)$ and $\text{CSP}(\Gamma')$ behave identically with respect to approximation. Indeed, let e be any non-surjective unary operation in $\text{Pol}(\Gamma)$ and define Γ' to be $\{e(R) \mid R \in \Gamma\}$ where $e(R) = \{e(\mathbf{a}) \mid \mathbf{a} \in R\}$ (recall that e is applied component-wise). Since e is not surjective, the domain of Γ' is a proper subset of A . For every instance I of $\text{CSP}(\Gamma)$, one can construct an ‘equivalent’ instance I' of $\text{CSP}(\Gamma')$. Define I' to be the instance with the same set of variables as I and that contains, for every constraint (\mathbf{v}, R) in I the constraint $(\mathbf{v}, e(R))$. Every assignment for I can be transformed into an assignment for I' satisfying (at least) the same number of constraints by composing it with e and, conversely, every assignment for I' is an assignment for I , since $e(R) \subseteq R$ for all $R \in \Gamma$.

Hence, one can use any polynomial-time algorithm that approximates $\text{CSP}(\Gamma)$ to obtain a polynomial-time algorithm that approximates $\text{CSP}(\Gamma')$ with the same error function and vice versa.

This implies that if we want to explore the robust approximation of constraint satisfaction problems we only need to consider those constraint languages that are cores.

The algebraic-based approach to robust approximation relies on the next theorem. It says that the algebraic structure of the set of operations that preserve a core Γ characterizes in a very tight way how its associated constraint satisfaction problem, $\text{CSP}(\Gamma)$, behaves with respect to robust approximation.

THEOREM 3.1. *Let Γ be a finite set of relations on a finite set A such that Γ is a core. Let \mathbb{A} denote the full idempotent reduct of the algebra associated to Γ . Let \mathbb{C} be an algebra in $\mathcal{V}(\mathbb{A})$, and let Γ_0 be a finite set of relations invariant under the operations in \mathbb{C} . Then $\text{CSP}(\Gamma_0) \leq_{\text{RA}} \text{CSP}(\Gamma)$ whenever*

- (1) $\text{eq} \in \Gamma$ or
- (2) $\mathbb{C} \in \text{HS}(\mathbb{A})$ and every relation in Γ_0 is irredundant.

It seems plausible that, for every constraint language Γ , $\text{CSP}(\Gamma \cup \{\text{eq}\}) \leq_{\text{RA}} \text{CSP}(\Gamma)$. If it is the case then Theorem 3.1 could be strengthened.

This section is devoted to the proof of Theorem 3.1. The proof is obtained via a chain of simple reductions. Both the proof structure and most of the arguments are fairly standard in the algebraic approach to CSP.

LEMMA 3.2. *Let Γ be a finite set of relations on A and let R be a relation pp-definable from Γ without equality. Then $\text{CSP}(\Gamma \cup \{R\}) \leq_{\text{RA}} \text{CSP}(\Gamma)$.*

Proof. Let $\phi(x_1, \dots, x_k)$ be a primitive positive formula defining R from Γ . Then, ϕ is of the form $\exists y_1, \dots, y_l \psi(x_1, \dots, x_k, y_1, \dots, y_l)$ where ψ is the quantifier-free part of ϕ . The heart of the proof is the observation that ψ can be alternatively seen as an instance of $\text{CSP}(\Gamma)$. More precisely, we define the instance associated to ψ , I_ψ , as the instance that has variables $x_1, \dots, x_k, y_1, \dots, y_l$ and contains for every atomic formula $S(v_1, \dots, v_r)$ in ψ , the constraint $((v_1, \dots, v_r), S)$. It follows that for any assignment $s : \{x_1, \dots, x_k, y_1, \dots, y_l\} \rightarrow A$, s is a solution of I_ψ if and only if $\psi(s(x_1), \dots, s(x_k), s(y_1), \dots, s(y_l))$ holds.

Let K be the number of atomic formulas in ψ . Assume that there is a polynomial-time algorithm ALG that $(1 - f(\epsilon), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma)$ for all $\epsilon \geq 0$. We shall give a polynomial-time algorithm that $(1 - Kf(\epsilon), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma \cup \{R\})$ for all $\epsilon \geq 0$.

Let I be an instance of $\text{CSP}(\Gamma \cup \{R\})$. Our algorithm starts by constructing in polynomial time an instance I' of $\text{CSP}(\Gamma)$ 'equivalent' to I .

Initially place in instance I' K copies of every constraint in I whose constraint relation belongs to Γ . Then, for every constraint C of the form $((v_1, \dots, v_k), R)$ (that is, whose constraint relation is R) in I , do the following: rename the variables of ψ such that for every $1 \leq i \leq k$, x_i becomes v_i and every y_j , ($1 \leq j \leq l$) becomes a different fresh (i.e., not used in I') variable. We refer to this new formula (which is obviously logically equivalent to ψ) as ψ_C . Add to I' all constraints in the instance associated to ψ_C .

Then, run algorithm ALG with input I' . In polynomial time ALG will stop and report an assignment t' . Output the assignment t obtained by projecting t' to the variables of I .

Let us determine the quality of t . Assume that there is an assignment s for I that $(1 - \epsilon)$ -satisfies I . We claim that s can be extended to an assignment for I' that $(1 - \epsilon)$ -satisfies I' . Notice that every variable occurring in I' but not in I has been introduced

when replacing a constraint C of the form $((v_1, \dots, v_k), R)$ by the constraints in I_{ψ_C} . If s satisfies C then we can extend it over the fresh variables of I_{ψ_C} in such a way that all constraints in I_{ψ_C} are satisfied. If, otherwise, s does not satisfy C then just extend it over the fresh variables of I_{ψ_C} arbitrarily. Proceeding in this way for every such constraint, we produce a complete assignment for I' that we call s' . Since every constraint unsatisfied by s gives rise to at most K constraints unsatisfied by s' and the total number of constraints in I' is K times the total number of constraints in I , it follows that s' $(1 - \epsilon)$ -satisfies I' as we claimed.

The assignment returned by ALG, t' , is guaranteed to $(1 - f(\epsilon))$ -satisfy I' . Every constraint unsatisfied by t' gives rise to at most one constraint unsatisfied by t . Since the total number of constraints in I' is at most K times the total number of constraints of I , it follows that assignment t $(1 - Kf(\epsilon))$ -satisfies I . ■

As a byproduct of Lemma 3.2 we can state the following strengthened version of the hardness results in [Håstad 2001; Guruswami and Zhou 2012; Khot et al. 2007], involving only irredundant relations, which will be useful in our proofs.

THEOREM 3.3. (*Hardness results of Theorems 2.1 and 2.4, restated*)

- (1) Let \mathcal{G} be an Abelian group with more than one element and let Γ be the set of all irredundant relations in $3\text{EQ-LIN}(\mathcal{G})$. There is no polynomial-time algorithm that robustly solves $\text{CSP}(\Gamma)$ unless $\text{P} = \text{NP}$.
- (2) Let Γ be the set containing relations $\{0\}$, $\{1\}$, and $\{(x, y, z) \mid x \wedge y \rightarrow z\}$. There is no polynomial-time algorithm that $(1 - \epsilon, 1 - o(1/\log(1/\epsilon)))$ -approximates $\text{CSP}(\Gamma)$ for all $\epsilon \geq 0$ unless the UG conjecture is false.
- (3) There is no polynomial-time algorithm that $(1 - \epsilon, 1 - o(\sqrt{\epsilon}))$ -approximates $\text{CSP}(\{\neq\})$ for all $\epsilon \geq 0$ unless the UG conjecture is false.

Proof. (1) Follows from the fact that eq is pp-definable without equality from irredundant relations in Γ (for example with $\exists u, v (x + u + v = 0) \wedge (y + u + v = 0)$) and Theorem 2.1. (2) Follows from Theorem 2.4(2) and the well-known fact that one can pp-define without equality any Horn clause using the relations in Γ . (3) This is merely Theorem 2.4(4) which we restate here for convenience. ■

If $\mu : B \rightarrow C$ is a surjective map and R is a k -ary relation on C , $\mu^{-1}(R)$ is defined to be the k -ary relation $\{\mathbf{b} \in B^k \mid \mu(\mathbf{b}) \in R\}$.

LEMMA 3.4. Let Γ_0 be a finite set of relations on C , let $\mu : B \rightarrow C$ be a surjective map, and let $\Gamma_1 = \{\mu^{-1}(R) \mid R \in \Gamma_0\}$. Then $\text{CSP}(\Gamma_0) \leq_{\text{RA}} \text{CSP}(\Gamma_1)$

Proof. This is straightforward. Let I_0 be any instance of $\text{CSP}(\Gamma_0)$ with variables V and let I_1 be an instance of $\text{CSP}(\Gamma_1)$ obtained by replacing every constraint relation $R \in \Gamma_0$ by $\mu^{-1}(R)$. Every assignment $s_1 : V \rightarrow B$ for I_1 can be transformed into an assignment s_0 for I_0 satisfying the same number of constraints by composing it with μ . Similarly, any assignment $s_0 : V \rightarrow C$ for I_0 can be transformed into an assignment s_1 for I_1 by setting $s_1(v)$ to be an arbitrary element in $\mu^{-1}(s_0(v))$ for every $v \in V$. It follows easily that one can use any polynomial-time algorithm that approximates $\text{CSP}(\Gamma_1)$ to obtain a polynomial-time algorithm that approximates $\text{CSP}(\Gamma_0)$ with the same error function. ■

If R is a k -ary relation on A^m (not on A) then the *coordinatization* of R , $\text{coord}(R)$, is the (km) -ary relation on A

$$\text{coord}(R) = \{((a_1^1, \dots, a_1^m, \dots, a_k^1, \dots, a_k^m) \mid ((a_1^1, \dots, a_1^m), \dots, (a_k^1, \dots, a_k^m)) \in R\}$$

LEMMA 3.5. Let Γ_1 be a finite set of relations in A^m and let $\Gamma_2 = \{\text{coord}(R) \mid R \in \Gamma_1\}$. Then $\text{CSP}(\Gamma_1) \leq_{\text{RA}} \text{CSP}(\Gamma_2)$.

Proof. This is straightforward. Let I_1 be an instance of Γ_1 and let I_2 be an instance of Γ_2 defined in the following way. For every variable v of I_1 , I_2 contains m variables v^1, \dots, v^m . Also, for every constraint $((v_1, \dots, v_k), R)$ in I_1 , I_2 contains the constraint $((v_1^1, \dots, v_1^m, \dots, v_k^1, \dots, v_k^m), \text{coord}(R))$. Every assignment s_2 of I_2 can be transformed into an assignment s_1 of I_1 satisfying the same number of constraints by just setting $s_1(v) = (s_2(v^1), \dots, s_2(v^m))$ for every variable v in I_1 . Similarly any assignment s_2 of I_2 can be transformed (by reversing the previous transformation) to an assignment s_1 of I_1 satisfying again the same number of constraints. It follows easily that one can use any polynomial-time algorithm that approximates $\text{CSP}(\Gamma_2)$ to obtain a polynomial-time algorithm that approximates $\text{CSP}(\Gamma_1)$ with the same error function. ■

The operators $\mu^{-1}(R)$ and $\text{coord}(R)$ interact very nicely with the algebraic constructions in a variety. In particular, the following lemma follows directly from the definitions.

LEMMA 3.6. *Let \mathbb{A}, \mathbb{B} be algebras and let Γ be a finite set of relations on B compatible with \mathbb{B} . Then:*

- (1) *If \mathbb{A} is homomorphic to \mathbb{B} via the surjective mapping $\mu : A \rightarrow B$ then $\mu^{-1}(\Gamma)$ is compatible with \mathbb{A} .*
- (2) *If \mathbb{B} is a subalgebra of \mathbb{A} then Γ is compatible with \mathbb{A} .*
- (3) *If $\mathbb{B} = \mathbb{A}^m$ then $\text{coord}(\Gamma)$ is compatible with \mathbb{A} .*

LEMMA 3.7. *Let Γ be a finite set of relations on $A = \{a_1, \dots, a_n\}$ such that Γ is a core. Then $\text{CSP}(\Gamma \cup \{\{a_i\} \mid 1 \leq i \leq n\}) \leq_{\text{RA}} \text{CSP}(\Gamma)$.*

Proof. Let ϕ be the (quantifier-free) pp-formula with free variables x_1, \dots, x_n defined as

$$\phi = \bigwedge_{S \in \Gamma, (a_{i_1}, \dots, a_{i_{\rho(S)}}) \in S} S(x_{i_1}, \dots, x_{i_{\rho(S)}})$$

The structure of the solutions of ϕ is easy to understand. In particular, for every $(b_1, \dots, b_n) \in A^n$, $\phi(b_1, \dots, b_n)$ holds if and only if the mapping $e : A \rightarrow A$ sending a_i to b_i for every $1 \leq i \leq n$ belongs to $\text{Pol}(\Gamma)$. Furthermore, since Γ is a core, the later condition is equivalent to the fact that e is an automorphism of Γ .

Hence, the n -ary relation $R = \{(e(a_1), \dots, e(a_n)) \mid e \in \text{Aut}(\Gamma)\}$ is pp-definable from Γ (without equality) via ϕ . Now, for every $1 \leq i \leq n$ consider the binary relation eq_i defined by the primitive positive formula

$$\exists x_1, \dots, x_{i-1}, x_{i+1}, \dots, x_n \quad R(x_1, \dots, x_{i-1}, y, x_{i+1}, \dots, x_n) \wedge \\ R(x_1, \dots, x_{i-1}, z, x_{i+1}, \dots, x_n)$$

It follows from the definition of eq_i that $\{(a_i, a_i)\} \subseteq \text{eq}_i \subseteq \text{eq}$.

Let $\Gamma' = \Gamma \cup \{R\} \cup \{\text{eq}_i \mid 1 \leq i \leq n\}$. It follows from Lemma 3.2 that $\text{CSP}(\Gamma') \leq_{\text{RA}} \text{CSP}(\Gamma)$. In what remains we shall show that $\text{CSP}(\Gamma \cup \{\{a_i\} \mid 1 \leq i \leq n\}) \leq_{\text{RA}} \text{CSP}(\Gamma')$ completing the proof.

Assume that there is a polynomial-time algorithm ALG that $(1 - f(\epsilon), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma')$ for all $\epsilon \geq 0$. We shall show how we can use ALG to obtain a polynomial-time algorithm that $(1 - 2f(\epsilon), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma \cup \{\{a_i\} \mid 1 \leq i \leq n\})$ for all ϵ in $[0, \beta]$ for a fixed β . This immediately gives, for some $K > 0$, a $(1 - Kf(\epsilon), 1 - \epsilon)$ -approximation for all $\epsilon \geq 0$.

Let I be an instance of $\text{CSP}(\Gamma \cup \{\{a_i\} \mid 1 \leq i \leq n\})$ and let m be the number of its constraints. Our algorithm starts by constructing in polynomial time an instance I' of $\text{CSP}(\Gamma')$ in the following way. The set of variables of I' contains all the variables of

I in addition to n new variables v_1, \dots, v_n . Instance I' has $2m$ constraints which are constructed in the following way:

- (a) Place in I' every constraint in I whose constraint relation is not in $\{\{a_i\} \mid 1 \leq i \leq n\}$.
- (b) For every constraint in I of the form $(v, \{a_i\})$ $1 \leq i \leq n$, place in I' the constraint $((v, v_i), \text{eq}_i)$.
- (c) Place m copies of the constraint $((v_1, \dots, v_n), R)$ in I' .

Assume that there is an assignment s that $(1-\epsilon)$ -satisfies I . Let s' be the assignment for I' that acts as s on the variables in I and that sets $s'(v_i) = a_i$ for every $1 \leq i \leq n$, and let C be any constraint in I' . If C is added in step (a) then we know that it is satisfied by s' whenever it is satisfied by s . If C is added in step (b) then C is of the form $((v, v_i), \text{eq}_i)$, $1 \leq i \leq n$. As $(a_i, a_i) \in \text{eq}_i$ we have that C is satisfied by s' whenever $(v, \{a_i\})$ is satisfied by s . Finally, constraint $((v_1, \dots, v_n), R)$ is always satisfied by s' as the identity map is always an automorphism.

We conclude that s' falsifies the same total number of constraints as s . It follows that s' is $(1-\epsilon)$ -satisfiable as the total number of constraints in I' is larger than that in I .

Now, run algorithm ALG with input I' . In polynomial time ALG will stop and report an assignment t' that satisfies a $(1-f(\epsilon))$ -fraction of the constraints in I' . By requiring ϵ to be small enough we can guarantee that $(1-f(\epsilon)) > 1/2$ which implies that t' must necessarily satisfy constraint $R(v_1, \dots, v_n)$. Consider the mapping $e : A \rightarrow A$ defined as $e(a_i) = t'(v_i)$. It follows that $(e(a_1), \dots, e(a_n)) \in R$ and hence e is an automorphism of Γ . It follows that e^{-1} is also an automorphism of Γ and, by Theorem 2.5, of Γ' as well. Consequently, the assignment t defined as $t(v) = e^{-1}(t'(v))$ satisfies exactly the same constraints in I' as t' . Additionally, $t(v_i) = a_i$ holds for every $1 \leq i \leq n$. Output the assignment obtained by projecting t to the variables of I . We shall prove that t (and hence its projection to the variables of I) $(1-2f(\epsilon))$ -satisfies I .

Let C be any constraint in I . If the constraint relation of C is not in $\{\{a_i\} \mid 1 \leq i \leq n\}$ then C must also appear in I' . Otherwise C is of the form $(v, \{a_i\})$, $1 \leq i \leq n$. In this case, as $\text{eq}_i \subseteq \text{eq}$ and $t(v_i) = a_i$ it follows that if t satisfies $((v, v_i), \text{eq}_i)$ then t must satisfy $(v, \{a_i\})$ as well. It follows that the total number of constraints falsified by t (in I) is not larger than the number of constraints falsified by t (in I'). Since the total number of constraints in I' is twice the total number of constraints in I we conclude that t satisfies at least a $(1-2f(\epsilon))$ -fraction of the constraints in I . ■

We are finally in a position to prove Theorem 3.1.

Proof. (of Theorem 3.1)

(1) Since $\mathbb{C} \in \mathcal{V}(\mathbb{A})$, there exist a power, \mathbb{A}^m , of \mathbb{A} , and a subalgebra, \mathbb{B} , of \mathbb{A}^m such that there is a surjective homomorphism μ from \mathbb{B} to \mathbb{C} . Let $\Gamma_1 = \{\mu^{-1}(R) \mid R \in \Gamma_0\}$ and let $\Gamma_2 = \{\text{coord}(R) \mid R \in \Gamma_1\}$. By Lemma 3.4, $\text{CSP}(\Gamma_0) \leq_{\text{RA}} \text{CSP}(\Gamma_1)$ and, by Lemma 3.5, $\text{CSP}(\Gamma_1) \leq_{\text{RA}} \text{CSP}(\Gamma_2)$. Furthermore, by Lemma 3.6, Γ_2 is compatible with \mathbb{A} .

Let $\Gamma_3 = \Gamma \cup \{\{a\} \mid a \in A\}$ and let g be any operation preserving Γ_3 (and hence preserving Γ as well). It follows from the fact that g preserves $\{a\}$ for every $a \in A$ that g should be idempotent. It follows that g belongs to the full idempotent reduct of Γ , that is, \mathbb{A} . Since Γ_2 is compatible with \mathbb{A} it follows that g preserves Γ_2 . We have just seen that $\text{Pol}(\Gamma_3) \subseteq \text{Pol}(\Gamma_2)$. It follows by Theorem 2.5(1) and Lemma 3.2 that $\text{CSP}(\Gamma_2) \leq_{\text{RA}} \text{CSP}(\Gamma_3)$. Finally, Lemma 3.7 guarantees that $\text{CSP}(\Gamma_3) \leq_{\text{RA}} \text{CSP}(\Gamma)$.

(2) After inspecting the previous argument one realizes that the condition $\text{eq} \in \Gamma$ is only required when applying Theorem 2.5(1) to prove $\text{CSP}(\Gamma_2) \leq_{\text{RA}} \text{CSP}(\Gamma_3)$. This can be overcome by noticing that since $\mathbb{C} \in \text{HS}(\mathbb{A})$ we can assume $m = 1$ and, hence, $\Gamma_2 = \Gamma_1$. Observe also that if R is an irredundant relation in Γ_0 then $\mu^{-1}(R)$ must necessarily be irredundant as well. Then, in this case $\text{CSP}(\Gamma_2) \leq_{\text{RA}} \text{CSP}(\Gamma_3)$ follows from Theorem 2.5(2) and Lemma 3.2. ■

Combining Theorem 3.1 with Theorems 2.1 and 2.4 we obtain the following hardness results.

THEOREM 3.8. *Let Γ be a finite set of relations on A such that Γ is a core and let \mathbb{A} be the algebra associated to Γ . Then:*

- (1) *If $\mathcal{V}(\mathbb{A})$ admits the unary or affine types then $\text{CSP}(\Gamma)$ is not robustly solvable unless $\text{P} = \text{NP}$.*
- (2) *If $\mathcal{V}(\mathbb{A})$ admits the semilattice type then $\text{CSP}(\Gamma)$ is not robustly solvable with polynomial loss unless the UG conjecture is false.*

Proof. It follows from ([Hobby and McKenzie 1988], Chapter 5) that if $\mathcal{V}(\mathbb{A})$ satisfies one of the conditions of items (1) or (2) then so does its full idempotent reduct.

In case (1), it follows from Theorems 2.6 and 3.1 that there exists an abelian group \mathcal{G} with more than one element such that $\text{CSP}(\Gamma_1) \leq_{\text{RA}} \text{CSP}(\Gamma)$ where Γ_1 is the set of irredundant relations in $3\text{EQ-LIN}(\mathcal{G})$. By Theorem 3.3(1), $\text{CSP}(\Gamma_1)$ is not robustly solvable (unless $\text{P} = \text{NP}$), hence neither is $\text{CSP}(\Gamma)$.

In case (2) let Γ_2 be the constraint language containing $\{0\}$, $\{1\}$, and $\{(x, y, z) \mid x \wedge y \rightarrow z\}$. Since all relations in Γ_2 are irredundant it follows from Theorems 2.6 and 3.1 that $\text{CSP}(\Gamma_2) \leq_{\text{RA}} \text{CSP}(\Gamma)$. By Theorem 3.3(2), $\text{CSP}(\Gamma_2)$ is not robustly solvable with polynomial loss unless the UG conjecture is false. Hence the same holds for $\text{CSP}(\Gamma)$. ■

Item (1) of Theorem 3.8 is the ‘easy’ direction of the Guruswami-Zhou conjecture. Combining it with Theorems 2.3 and 2.7 one obtains the full proof.

4. DUALITIES

In this section we present a combinatorial view on CSPs and local consistency algorithms, in the form of dualities, and link it with polymorphisms. The combinatorial description of dualities is not used in approximation algorithms in Section 5, but it helps to place our results into a uniform perspective. We refer the reader to survey [Bulatov et al. 2008] for more information about dualities.

A (*finite relational*) *structure* is a tuple $\mathbf{A} = (A, R_1, \dots, R_m)$ where A , the *universe* of \mathbf{A} , is a non-empty set, and for each $1 \leq i \leq m$, R_i is a relation on A . Let $\mathbf{I} = (V, S_1, \dots, S_m)$ and $\mathbf{A} = (A, R_1, \dots, R_m)$ be *similar* structures, meaning that they have the same number of relations and that $\rho(R_i) = \rho(S_i)$ for every $1 \leq i \leq m$. A map $f : V \rightarrow A$ is a *homomorphism* from \mathbf{I} to \mathbf{A} if $f(S_i) \subseteq R_i$ for every $1 \leq i \leq m$, where for every relation S we have

$$f(S) = \{f(\mathbf{a}) \mid \mathbf{a} \in S\}.$$

We write $\mathbf{I} \rightarrow \mathbf{A}$ if there is a homomorphism from \mathbf{I} to \mathbf{A} and $\mathbf{I} \not\rightarrow \mathbf{A}$ otherwise. Two structures \mathbf{A} and \mathbf{A}' are said to be *homomorphically equivalent* if $\mathbf{A} \rightarrow \mathbf{A}'$ and $\mathbf{A}' \rightarrow \mathbf{A}$.

The constraint satisfaction problem can be rephrased in terms of homomorphisms as follows: If $\Gamma = \{R_1, \dots, R_m\}$ is a finite set of relations on A and $I = (V, A, \mathcal{C})$ is an instance of $\text{CSP}(\Gamma)$, let \mathbf{A} be the structure (A, R_1, \dots, R_m) and let $\mathbf{I} = (V, S_1, \dots, S_m)$ be the structure with universe V and where for every $1 \leq i \leq m$, S_i contains the scopes of all constraints in \mathcal{C} whose constraint relation is R_i . It is easy to verify that any assignment $s : V \rightarrow A$ satisfies all constraints in \mathcal{C} if and only if s is a homomorphism from \mathbf{I} to \mathbf{A} .

A set \mathcal{O} of structures is called an *obstruction set* for \mathbf{A} if for any structure \mathbf{I} similar to \mathbf{A} , $\mathbf{I} \rightarrow \mathbf{A}$ if and only if $\mathbf{O} \not\rightarrow \mathbf{A}$ for every $\mathbf{O} \in \mathcal{O}$.

In graph theory, the treewidth of a graph is a natural number that measures how much the graph resembles a tree. This measure, as many others, is lifted in a natural way to structures.

For $0 \leq j \leq k$, a structure $\mathbf{I} = (V, S_1, \dots, S_m)$ is said to have *treewidth at most (j, k)* if there is a tree T , called a *tree-decomposition* of \mathbf{I} , such that

- (1) the nodes of T are subsets of V of size at most k ,
- (2) adjacent nodes can share at most j elements,
- (3) nodes containing any given element form a subtree, and
- (4) for any tuple in any relation in \mathbf{I} , there is a node in T containing all elements from that tuple.

If T is a path then it is called a *path-decomposition* of \mathbf{I} and \mathbf{I} is said to have *path-width* at most (j, k) .

Definition 4.1. A finite set Γ of relations on A is said to have *(j, k) -treewidth duality* if the structure (A, Γ) has an obstruction set consisting only of structures of treewidth at most (j, k) . We say that Γ has *j -treewidth duality* if it has (j, k) -treewidth duality for some $k \geq j$ and that Γ has *bounded treewidth duality* if it has j -treewidth duality for some $j \geq 0$.

The following result establishes a fundamental connection between width and dualities.

THEOREM 4.2. [Feder and Vardi 1998; Kolaitis and Vardi 2000] *Let $0 \leq j \leq k$ and let Γ be a finite set of relations on A . The following conditions are equivalent:*

- (1) $\text{CSP}(\Gamma)$ has width (j, k) ;
- (2) Γ has (j, k) -treewidth duality.

Besides bounded treewidth duality many other types of dualities have been explored in the study of CSP. We shall present some of them that are particularly relevant to the present work.

4.1. Tree duality

As in [Nešetřil and Tardif 2000], the *incidence multigraph* of a structure $\mathbf{I} = (V, S_1, \dots, S_m)$, denoted $\text{Inc}(\mathbf{I})$, is defined as the bipartite multigraph with parts V and $\text{Block}(\mathbf{I})$, where $\text{Block}(\mathbf{I})$ consists of all pairs (S_i, \mathbf{v}) such that $1 \leq i \leq m$ and $\mathbf{v} \in S_i$, and with edges $e_{v,i,Z}$ joining $v \in V$ to $Z = (S, (v_1, \dots, v_r)) \in \text{Block}(\mathbf{A})$ when $v_i = v$. Then \mathbf{I} is said to be a *tree* if its incidence multigraph is a tree (in particular, it has no multiple edges). For a tree \mathbf{I} , we say that an element of V is a *leaf* if it is incident to at most one block in $\text{Inc}(\mathbf{I})$. A block of \mathbf{I} (i.e., a member of $\text{Block}(\mathbf{I})$) is said to be *pendant* if it is incident to at most one non-leaf element, and it is said to be *non-pendant* otherwise. For example, any block with a unary relation is always pendant. If \mathbf{I} has just one binary relation, i.e. is a digraph, then \mathbf{I} is tree in the above sense if and only if it is an oriented tree in the usual sense of graph theory.

We shall say that a structure has *tree duality* if it has an obstruction set consisting of tree structures. See [Bulatov et al. 2008] for examples of structures with tree duality.

Let (A, Γ) be a structure. Let A_P be the set of all non-empty subsets of A . If R is a r -ary relation on A then we define relation, R_P , as the r -ary relation on A_P

$$R_P = \{(\text{pr}_1 S, \dots, \text{pr}_r S) \mid \emptyset \neq S \subseteq R\}$$

It follows from the definition of R_P that for every $(S_1, \dots, S_r), (T_1, \dots, T_r) \in (A_P)^r$

$$\{(S_1, \dots, S_r), (T_1, \dots, T_r)\} \subseteq R_P \Rightarrow (S_1 \cup T_1, \dots, S_r \cup T_r) \in R_P \quad (3)$$

Let Γ_P be the constraint language on A_P defined as $\Gamma_P = \{R_P \mid R \in \Gamma\}$.

THEOREM 4.3. [Feder and Vardi 1998] *Let Γ be a finite set of relations on A . The following conditions are equivalent:*

- (1) (A, Γ) has tree duality;
- (2) (A, Γ) has 1-treewidth duality;
- (3) (A, Γ) is homomorphically equivalent to (A_P, Γ_P) ;
- (4) Γ totally symmetric polymorphisms of all arities.
- (5) $\text{CSP}(\Gamma)$ has width 1.

Width 1 problems are closely related with arc-consistency, one of main types of local consistency [Dalmau and Pearson 1999].

4.2. Pathwidth Duality

By replacing “treewidth” with “pathwidth” throughout Definition 4.1 one obtains the corresponding notions of *pathwidth dualities*. Bounded path duality was introduced in [Dalmau 2005] as a tool to study CSPs solvable in non-deterministic logarithmic space. See [Bulatov et al. 2008; Carvalho et al. 2010; 2011; Dalmau 2005] for examples of structures with this duality. The following theorem, due to Larose and Tesson [Larose and Tesson 2009], gives a general necessary condition for bounded pathwidth duality.

THEOREM 4.4. *Let Γ be a finite set of relations on A such that Γ is a core and let \mathbb{A} be the algebra associated to Γ . If $\mathcal{V}(\mathbb{A})$ admits the unary, affine, or semilattice types then Γ does not have bounded pathwidth duality.*

The comparison of Theorems 3.8 and 4.4 hints at a link between pathwidth duality and robust approximation with polynomial loss as both properties share the same forbidden typesets (and the same basic forbidden structures, $3\text{EQ-LIN}(\mathcal{G})$ and 3-HORN). In view of this, it seems reasonable to investigate whether one can robustly solve with polynomial loss a $\text{CSP}(\Gamma)$ whenever its constraint language, Γ , has pathwidth duality. Some sufficient conditions for bounded pathwidth duality are known, we shall now present the two most general ones (to the best of our knowledge).

It was shown in [Dalmau and Krokhn 2008] that a finite set Γ of relations on A has bounded pathwidth duality whenever it is preserved by a majority operation, and this result has been recently generalized in [Barto et al. 2012] to an NU operation of any arity. In a different direction, [Carvalho et al. 2010] characterizes those finite sets Γ of relations that possess an obstruction set consisting of trees of bounded pathwidth. In Section 5 we show that, for every such Γ , $\text{CSP}(\Gamma)$ is robustly solvable with polynomial loss. In what follows we shall describe in detail some of the results in [Carvalho et al. 2010].

We call a operation f of arity $k \cdot m \cdot n$ on A *k -layered m -block symmetric* if it satisfies the following condition:

$$f(\overbrace{x_{11}^{(1)}, \dots, x_{1m}^{(1)}, \dots, x_{n1}^{(1)}, \dots, x_{nm}^{(1)}}^{S_1^{(1)}}, \dots, \overbrace{x_{11}^{(k)}, \dots, x_{1m}^{(k)}, \dots, x_{n1}^{(k)}, \dots, x_{nm}^{(k)}}^{S_n^{(k)}}) = f(\overbrace{y_{11}^{(1)}, \dots, y_{1m}^{(1)}, \dots, y_{n1}^{(1)}, \dots, y_{nm}^{(1)}}^{T_1^{(1)}}, \dots, \overbrace{y_{11}^{(k)}, \dots, y_{1m}^{(k)}, \dots, y_{n1}^{(k)}, \dots, y_{nm}^{(k)}}^{T_n^{(k)}})$$

whenever $\{S_1^{(l)}, \dots, S_n^{(l)}\} = \{T_1^{(l)}, \dots, T_n^{(l)}\}$ for each “level” l where, for all i , $S_i^{(l)} = \{x_{i1}^{(l)}, \dots, x_{im}^{(l)}\}$ and $T_i^{(l)} = \{y_{i1}^{(l)}, \dots, y_{im}^{(l)}\}$. This allows us to write such an operation as $f(S_1, \dots, S_k)$, where $S_i = \{S_1^{(i)}, \dots, S_n^{(i)}\}$ for all i .

Let us call a sequence S_1, \dots, S_k *nested* if either $k = 1$ or, for each $1 \leq j < k$, every set in S_{j+1} is a subset of every set in S_j . We say that a k -layered m -block symmetric operation f is a *k -layered m -ABS operation* if the following *absorption* property holds:

for any $1 \leq i \leq k$ and for any nested sequence $\mathcal{S}_1, \dots, \mathcal{S}_k$ we have

$$f(\mathcal{S}_1, \dots, \mathcal{S}_i, \dots, \mathcal{S}_k) = f(\mathcal{S}_1, \dots, \mathcal{S}'_i, \dots, \mathcal{S}_k)$$

where \mathcal{S}'_i is any subset of \mathcal{S}_i obtained by removing any element (i.e., a subset of A) in \mathcal{S}_i that entirely contains some other element in \mathcal{S}_i .

Example 4.5. Let $A = \{0, 1\}^k$. In this example we will think of elements of A as k -columns of Boolean values. Consider the operation f on A such that

$$f(x_{11}^{(1)}, \dots, x_{1m}^{(1)}, \dots, x_{n1}^{(1)}, \dots, x_{nm}^{(1)}, \dots, x_{11}^{(k)}, \dots, x_{1m}^{(k)}, \dots, x_{n1}^{(k)}, \dots, x_{nm}^{(k)}) =$$

$$\left(\begin{array}{c} (\bigvee_{i=1}^n \bigwedge_{j=1}^m x_{ij}^{(1)}[1]) \wedge (\bigwedge_{i=1}^n \bigwedge_{j=1}^m x_{ij}^{(2)}[1]) \wedge \dots \wedge (\bigwedge_{i=1}^n \bigwedge_{j=1}^m x_{ij}^{(k)}[1]) \\ (\bigvee_{i=1}^n \bigwedge_{j=1}^m x_{ij}^{(2)}[2]) \wedge \dots \wedge (\bigwedge_{i=1}^n \bigwedge_{j=1}^m x_{ij}^{(k)}[2]) \\ \vdots \\ (\bigvee_{i=1}^n \bigwedge_{j=1}^m x_{ij}^{(k)}[k]) \end{array} \right)$$

where $x_{ij}^{(w)}[l]$ denotes the l -th component of variable $x_{ij}^{(w)}$.

It can be directly verified that f is a k -layered m -ABS operation.

The following theorem follows from [Carvalho et al. 2010]:

THEOREM 4.6. *Let Γ be a finite set of relations on A . Then the following are equivalent:*

- (1) (A, Γ) has an obstruction set consisting of trees of bounded pathwidth;
- (2) there exists some $k \geq 1$ such that for every $m, n \geq 1$, Γ is invariant under a k -layered m -ABS operation.

4.3. Caterpillar and jellyfish dualities

The particular case of 1-layered ABS operations gives rise to a well-understood type of dualities called caterpillar duality. In graph theory, a caterpillar is a tree which becomes a path after all its leaves are removed. Following [Loten and Tardif 2008], we say that a tree is a *caterpillar* if each of its blocks is incident to at most two non-leaf elements, and each element is incident to at most two non-pendant blocks. Informally, a caterpillar has a body consisting of a chain of elements v_1, \dots, v_{n+1} with blocks B_1, \dots, B_n where B_i is incident to v_i and v_{i+1} ($i = 1, \dots, n$), and legs of two types: (i) pendant blocks incident to exactly one of the elements v_1, \dots, v_{n+1} , together with some leaf elements incident to such blocks, and (ii) leaf elements incident to exactly one of the blocks B_1, \dots, B_n . Examples of structures with caterpillar duality can be found in [Carvalho et al. 2011].

THEOREM 4.7. [Carvalho et al. 2011] *Let Γ be a finite set of relations on A . Then the following are equivalent:*

- (1) (A, Γ) has caterpillar duality;
- (2) (A, Γ) is homomorphically equivalent to a structure with lattice polymorphisms;
- (3) for every $m, n \geq 1$, Γ is invariant under a mn -ary 1-layered m -ABS operation.

Note that robust satisfiability for structures with lattice polymorphisms was studied in [Kun et al. 2012], where a robust algorithm with linear loss for the corresponding CSPs is presented. By Lemma 5.1 below, this result extends to all structures with caterpillar duality. We will further extend this result to a subclass of structures covered in Theorem 4.6.

We say that a non-leaf $a \in A$ of a tree structure \mathbf{A} is *extreme* if it is incident to at most one non-pendant block (i.e., it has at most one other non-leaf at distance two from it) in $\text{Inc}(\mathbf{A})$, and we say that a pendant block is *extreme* if either it is the only block of \mathbf{A} or else it is adjacent to a non-leaf, and this (unique) non-leaf is extreme. Finally, we say that an element is *terminal* if it is isolated (i.e., does not appear in any relation in \mathbf{A}) or it appears in an extreme pendant block. We say that a tree structure \mathbf{A} is a *jellyfish* if it is a one-element structure with empty relations or it is obtained from one tuple (in one relation) \mathbf{a} , called the body of the jellyfish, and a family of caterpillars by identifying one terminal element of each caterpillar with some element in the tuple \mathbf{a} . It is not hard to see that a jellyfish structure is a tree of bounded pathwidth. A structure has jellyfish duality if it has an obstruction set consisting of jellyfish structures. Examples of structures with jellyfish duality can be found in [Carvalho et al. 2011]. It can be checked using results of [Carvalho et al. 2010; 2011] that each structure with jellyfish duality has an $2mn$ -ary 2-layered m -ABS polymorphism for all m, n .

THEOREM 4.8. [Carvalho et al. 2011] *Let Γ be a finite set of relations on A . Then the following are equivalent:*

- (1) (A, Γ) has jellyfish duality;
- (2) (A, Γ) is homomorphically equivalent to a structure (A', Γ') with polymorphism $x \sqcup (y \sqcap z)$ for some distributive lattice (A', \sqcup, \sqcap) .

5. POSITIVE APPROXIMATION RESULTS

In this section we show that each width 1 CSP(Γ) admits a robust $(1 - O(1/\log(1/\epsilon)), 1 - \epsilon)$ -approximation algorithm and describe two subclasses of width 1 CSPs where the approximation guarantee can be improved to $O(\epsilon^{1/k})$ with $k > 1$ and $O(\epsilon)$, respectively.

LEMMA 5.1. *If structures $\mathbf{A} = (A, \Gamma)$ and $\mathbf{A}' = (A', \Gamma')$ are homomorphically equivalent then $\text{CSP}(\Gamma) \leq_{\text{RA}} \text{CSP}(\Gamma')$ and $\text{CSP}(\Gamma') \leq_{\text{RA}} \text{CSP}(\Gamma)$.*

Proof. Since the two structures are homomorphically equivalent, the relations in Γ and Γ' are in one-to-one correspondence. If I is an instance of CSP(Γ), one can construct an equivalent instance of CSP(Γ') by simply replacing each constraint relation in I by the corresponding relation from Γ' . If s is an assignment for I and f is a homomorphism from \mathbf{A} to \mathbf{A}' then it is easy to check that $f \circ s$ is an assignment for I' that satisfies all constraints satisfied by s . It follows that, for any ϵ , I is $(1 - \epsilon)$ satisfiable if and only if I' is $(1 - \epsilon)$ satisfiable, and one can easily switch between assignments for I and I' by using homomorphisms. ■

THEOREM 5.2. *Let Γ be a finite set of relations on A such that CSP(Γ) has width 1. There is a polynomial-time algorithm that $(1 - O(1/\log(1/\epsilon)), 1 - \epsilon)$ -approximates CSP(Γ) for every $\epsilon \geq 0$.*

Proof. By Theorem 4.3 and Lemma 5.1, it is enough to prove the theorem for Γ_P . Now, fix an arbitrary order $\{a_1, \dots, a_k\}$ on A and rename A_P by replacing every element S of A_P by its indicator k -ary tuple, namely, the tuple $(b_1, \dots, b_k) \in \{0, 1\}^k$ such that $b_i = 1$ if $a_i \in S$ and $b_i = 0$ otherwise. Let Γ_C be the finite set of relations on $\{0, 1\}$ defined as $\Gamma_C = \{\text{coord}(R_P) \mid R_P \in \Gamma_P\}$ where $\text{coord}(\cdot)$ is the coordinatization operator introduced in Section 3. It follows from (3) that Γ_C is preserved by the disjunction operation $\vee : \{0, 1\}^2 \rightarrow \{0, 1\}$. It is well known that every boolean relation invariant under \vee can be expressed as a conjunction of dual Horn clauses. It follows from Lemma 3.2 and Theorem 2.4 that there is a polynomial-time algorithm that $(1 - O(1/\log(1/\epsilon)), 1 - \epsilon)$ -approximates CSP(Γ_C) for every $\epsilon \geq 0$. The result then follows from Lemma 3.5. ■

Which structures admit an efficient robust algorithm with polynomial loss? As mentioned in Section 4 the properties of robust approximation with polynomial loss and of pathwidth duality have the same forbidden typesets. It seems natural then to try to prove that every constraint language Γ with bounded pathwidth duality gives rise to a constraint satisfaction problem, $\text{CSP}(\Gamma)$ that is robustly solvable with polynomial loss. The next theorem gives a partial result in this direction. It is quite feasible that this theorem covers all constraint languages Γ with tree duality such that $\text{CSP}(\Gamma)$ is robustly solvable with polynomial loss. Indeed, it was conjectured in [Larose and Tesseon 2009] that every core structure that falsifies the assumptions of Theorem 3.8 (i.e. the corresponding algebra generates a variety admitting unary, or affine, or semilattice type) has bounded pathwidth duality, and it is also possible (and left as an open question in [Carvalho et al. 2010]) that every structure that has both tree duality and bounded pathwidth duality has an obstruction set consisting of trees of bounded pathwidth.

THEOREM 5.3. *If Γ and $k \geq 1$ satisfy condition (2) from Theorem 4.6 then there is a polynomial-time algorithm that $(1 - O(\epsilon^{1/k}), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma)$ for every $\epsilon \geq 0$.*

Proof. Let $I = (V, A, C)$ be any instance of $\text{CSP}(\Gamma)$ and assume that I is $(1 - \epsilon')$ -satisfiable for some $\epsilon' \geq 0$. Start by solving the LP relaxation of I , $\text{BLP}(I)$, determining an optimal solution. Let $1 - \epsilon$ be the value of the goal function achieved by the optimal solution. Since $\text{BLP}(I)$ is a relaxation of the integer canonical program for I it follows that $\epsilon \leq \epsilon'$. For every constraint $C = (v, R) \in C$ we shall use ϵ_C to denote $1 - p_C(R)$.

Let $H > 1$ be a constant. To prove the present theorem we could fix straight away H to be, say, 2, but it will be handy later, when proving Theorem 5.8 to be able to reuse the analysis with a different value for H . Let L be the maximum arity of any relation in Γ , let $J = L2^{|A|} + 1$, let $b = \epsilon/J$, and let $z = J(Hb)^{1/k}$.

For every $\theta \in \{1, \dots, \lfloor z^{-1} \rfloor\}$ and every $0 \leq i \leq k$ define M_θ^i as

$$M_\theta^i = \begin{cases} 0 & \text{if } i = 0 \\ b(J\theta)^i & \text{otherwise} \end{cases}$$

We shall obtain a solution by applying the following randomized rounding algorithm to the optimal solution of the LP:

- (1) Choose $\theta \in \{1, \dots, \lfloor z^{-1} \rfloor\}$ uniformly at random.
- (2) For every v and every $0 \leq i \leq k$ define $S_v^i = \{S \subseteq A \mid p_v(S) \geq 1 - M_\theta^i\}$. Since $M_\theta^i \leq M_\theta^k = H^{-1} < 1$ it follows that $\emptyset \notin S_v^i$.
- (3) Let f be an mkn -ary k -layered m -ABS operation that preserves Γ with $m = |A|^L$ and $n = L(2^{|A|} - 1)$. Output the assignment $t : V \rightarrow A$ defined by $t(v) = f(\min S_v^1, \dots, \min S_v^k)$ where $\min S_v^i$ contains all those sets in S_v^i that are minimal with respect to inclusion. By the properties of f we see that t is well-defined.

We shall prove for each constraint $C \in C$ that the probability that C is falsified by assignment t is at most $D\epsilon^{1/k}(1 + \epsilon_C/\epsilon)$ where $D = 4kJHJ^{2-1/k}$. It follows from linearity of expectation that the expected fraction of constraints falsified by t is at most $D\epsilon^{1/k}(1 + \text{avg}\{\epsilon_C\}/\epsilon) = 2D\epsilon^{1/k}$. Note that as z^{-1} depends on ϵ it can be, in principle, very large. To overcome it we observe that we can safely replace any value of $\epsilon \leq (4|C|D)^{-k}$ with $(4|C|D)^{-k}$ as the fraction of falsified constraints, $2D\epsilon^{1/k}$, would be at most $1/(2|C|)$, meaning that, indeed, all constraints are satisfied. Hence, we can assume that z^{-1} is bounded by a polynomial in the input size. In consequence, we can even make the algorithm deterministic (besides polynomial-time) by trying all choices for θ and selecting the one producing the best assignment.

Let $C = ((v_1, \dots, v_r), R)$ be a constraint in \mathcal{C} . We shall see that the probability that C is falsified by t is at most $D\epsilon^{1/k}(1 + \epsilon_C/\epsilon)$ completing the proof. This will follow from Lemmas 5.5 and 5.7 below.

Definition 5.4. A choice of θ is good for C if

$$M_\theta^1 \geq \epsilon_C \quad (4)$$

and for every variable v in the scope of C , every $1 \leq i \leq k$, and every $S \subseteq A$ the two following conditions hold:

$$M_\theta^1 \notin [1 - p_v(S) - \epsilon_C, 1 - p_v(S)] \quad (5)$$

$$\theta + 1 \neq \lceil (1 - p_v(S))^{1/i} b^{-1/i} J^{-1} \rceil \quad (6)$$

LEMMA 5.5. *The probability that θ is not good for C is at most $D\epsilon^{1/k}(1 + \epsilon_C/\epsilon)$.*

Proof. We shall see how many out of the $\lfloor z^{-1} \rfloor$ choices for θ falsify each one of the conditions of definition 5.4. The number of values for θ that falsify (4) is $\lfloor \frac{\epsilon_C}{Jb} \rfloor$. For every v in the scope of C , every $1 \leq i \leq k$ and every $S \subseteq A$, there is only one choice that falsifies (6) and at most $1 + \lfloor \frac{\epsilon_C}{Jb} \rfloor$ choices that falsify (5). Hence the total number of choices that make θ not good is at most

$$2Lk2^{|A|} + (Lk2^{|A|} + 1) \frac{\epsilon_C}{Jb} \leq 2kJ(1 + \epsilon_C/\epsilon).$$

By adjusting the constant in $O(\cdot)$ in the statement of Theorem 5.3, we can assume the $\epsilon \leq H^{-1}2^{-k}J^{-2k+1}$. With this assumption, we have $z^{-1} \geq 2$, and so $\frac{1}{2}z^{-1} \leq \lfloor z^{-1} \rfloor$. Thus the probability that θ is not good for C is at most

$$\frac{2kJ(1 + \epsilon_C/\epsilon)}{\lfloor z^{-1} \rfloor} \leq \frac{4kJ(1 + \epsilon_C/\epsilon)}{z^{-1}} = D\epsilon^{1/k}(1 + \epsilon_C/\epsilon).$$

The following lemma will be useful. ■

LEMMA 5.6. *Assume that θ is good for C . Then for every variable v in the scope, every $1 \leq i \leq k$, and every $S \subseteq A$: if $p_v(S) \geq 1 - \epsilon_C - M_\theta^i - (J-1)M_\theta^{i-1}$ then $p_v(S) \geq 1 - M_\theta^i$.*

Proof. Case $i = 1$ follows from (5) and $M_\theta^0 = 0$. Assume now that $i > 1$. Condition (6) can be rewritten as $(1 - p_v(S))^{1/i} b^{-1/i} J^{-1} \notin (\theta, \theta + 1]$ which again can be rewritten as $p_v(S) \notin [1 - b(J(\theta+1))^i, 1 - b(J\theta)^i] = [1 - M_{\theta+1}^i, 1 - M_\theta^i]$. Now, assume that $p_v(S) \geq 1 - \epsilon_C - M_\theta^i - (J-1)M_\theta^{i-1}$. We have that $M_\theta^{i-1} \geq M_\theta^i \geq \epsilon_C$ where the second inequality is by (4). It follows that $p_v(S) \geq 1 - M_\theta^i - JM_\theta^{i-1} \geq 1 - M_{\theta+1}^i$ where the second inequality follows from $M_{\theta+1}^i = b(J(\theta+1))^i \geq bJ^i(\theta^i + \theta^{i-1}) = M_\theta^i + JM_\theta^{i-1}$. Since $p_v(S) \notin [1 - M_{\theta+1}^i, 1 - M_\theta^i]$ it follows that $p_v(S) \geq 1 - M_\theta^i$. ■

LEMMA 5.7. *If θ is good for C then C is satisfied by t .*

Proof. For every $0 \leq i \leq k-1$ and every $v \in V$ define $G_v^i = \cap_{S \in \mathcal{S}_v^i} S$. Let $1 \leq i \leq k$, let $1 \leq j, l \leq r$ and let $S \in \mathcal{S}_{v_j}^i$. We shall prove that:

$$\text{pr}_t(R \cap (G_{v_1}^{i-1} \times \dots \times G_{v_{j-1}}^{i-1} \times (S \cap G_{v_j}^{i-1}) \times G_{v_{j+1}}^{i-1} \times \dots \times G_{v_r}^{i-1})) \in \mathcal{S}_{v_l}^i \quad (7)$$

Relation $R' = R \cap (G_{v_1}^{i-1} \times \dots \times G_{v_{j-1}}^{i-1} \times (S \cap G_{v_j}^{i-1}) \times G_{v_{j+1}}^{i-1} \times \dots \times G_{v_r}^{i-1})$ can be written down as the intersection of R , $(A^{j-1} \times S \times A^{r-j})$, and all relations of the form $(A^{s-1} \times S' \times A^{r-s})$ where $1 \leq s \leq r$ and $S' \in \mathcal{S}_{v_s}^{i-1}$. By condition (2) of BLP(I) it follows that $p_C(A^{j-1} \times S \times A^{r-j}) = p_{v_j}(S) \geq 1 - M_\theta^i$. Similarly, we have $p_C(A^{s-1} \times S' \times A^{r-s}) \geq$

$1 - M_\theta^{i-1}$ for every $1 \leq s \leq r$ and $S' \in \mathcal{S}_{v_s}^{i-1}$. It follows from the union bound that $p_C(R') \geq 1 - \epsilon_C - M_\theta^i - r2^{|A|}M_\theta^{i-1}$. It follows by consistency of marginals (i.e. condition 2) that $p_{v_l}(\text{pr}_l R') \geq p_C(R')$. Then, by Lemma 5.6, $p_{v_l}(\text{pr}_l R') \geq 1 - M_\theta^i$ and so $\text{pr}_l R' \in \mathcal{S}_{v_l}^i$.

We are ready to show that that $(t(v_1), \dots, t(v_r)) \in R$. The rest of the proof is similar to that of Lemma 22 in [Carvalho et al. 2010]. We shall build a matrix N as follows. Recall that $m = |A|^L$. For every $1 \leq j \leq r$, every $1 \leq i \leq k$, and every set $S \in \mathcal{S}_{v_j}^i$ construct a $(m \times r)$ -matrix $N_{j,S}^i$ whose entries are elements of A such that:

- (1) each row of $N_{j,S}^i$ is a tuple of R , and
- (2) for any $1 \leq l \leq r$ the set of entries in the l -th column is exactly

$$\text{pr}_s(R \cap (G_{v_1}^{i-1} \times \dots \times G_{v_{j-1}}^{i-1} \times (G_{v_j}^{i-1} \cap S) \times G_{v_{j+1}}^{i-1} \times \dots \times G_{v_r}^{i-1}))$$

That is, the matrix can be seen as a sequence of m tuples $\mathbf{t}_1, \dots, \mathbf{t}_m$ (the rows) of R such that $\{\mathbf{t}_1, \dots, \mathbf{t}_m\} = R \cap (G_{v_1}^{i-1} \times \dots \times G_{v_{j-1}}^{i-1} \times (G_{v_j}^{i-1} \cap S) \times G_{v_{j+1}}^{i-1} \times \dots \times G_{v_r}^{i-1})$. This is easily achieved by placing in the matrix all tuples in $R \cap (G_{v_1}^{i-1} \times \dots \times G_{v_{j-1}}^{i-1} \times (G_{v_j}^{i-1} \cap S) \times G_{v_{j+1}}^{i-1} \times \dots \times G_{v_r}^{i-1})$ and repeating some of them if necessary. By condition (7) the set of all entries in the l -th column of $N_{j,S}^i$ belongs to $\mathcal{S}_{v_l}^i$ and, by construction, it must be a subset of $G_{v_l}^{i-1}$. It follows that if S is minimal in $\mathcal{S}_{v_j}^i$ then the set of entries in the j -th column is precisely S .

Recall that $n = L(2^{|A|} - 1)$. For every $1 \leq i \leq k$ construct a $(mn \times r)$ -matrix N^i as follows. It is divided into n layers of consecutive m rows, each layer is a matrix $N_{j,S}^i$ for some $1 \leq j \leq r$ and some $S \in \mathcal{S}_{v_j}^i$, and, for each choice of i, j, S , the matrix $N_{j,S}^i$ appears as a layer. By the choice of n , this is possible. For every $1 \leq i \leq k$ and every $1 \leq j \leq r$ we shall denote by $\mathcal{T}_{v_j}^i$ the set containing all those $T \subseteq A$ such that T is the set of all entries of the j th column for some matrix $N_{j,S}^i$ included in N^i . By the remarks made after the construction of $N_{j,S}^i$ we have that $\min \mathcal{T}_{v_j}^i = \min S_{v_j}^i$ for every $1 \leq j \leq r$ and $1 \leq i \leq k$.

Finally form the $(kmn \times r)$ -matrix N whose first mn rows are occupied by matrix N^1 , next mn rows are occupied by matrix N^2 and so on. Let (a_1, \dots, a_r) be the result of applying f column-wise to N , which must be tuple of R since f preserves R . To complete our proof we shall see that (a_1, \dots, a_r) is precisely $(t(v_1), \dots, t(v_r))$.

Let $j \in \{1, \dots, r\}$. By the construction of N it follows that $a_j = f(\mathcal{T}_{v_j}^1, \dots, \mathcal{T}_{v_j}^k)$. By the construction of the matrices, for every $1 \leq i \leq k$, every element in $\mathcal{T}_{v_j}^i$ is a subset of $G_{v_j}^{i-1}$ implying that $(\mathcal{T}_{v_j}^1, \dots, \mathcal{T}_{v_j}^k)$ is a nested sequence. It follows by the absorption property that $f(\mathcal{T}_{v_j}^1, \dots, \mathcal{T}_{v_j}^k) = f(\min \mathcal{T}_{v_j}^1, \dots, \min \mathcal{T}_{v_j}^k)$ and since $\min(\mathcal{T}_{v_j}^i) = \min(S_{v_j}^i)$ for every $1 \leq i \leq k$ it follows that $f(\min \mathcal{T}_{v_j}^1, \dots, \min \mathcal{T}_{v_j}^k) = f(\min S_{v_j}^1, \dots, \min S_{v_j}^k) = t(v_j)$. ■

This completes the proof of Theorem 5.3. ■

The case $k = 1$ of Theorem 5.3 (i.e. for structures with caterpillar duality) has been previously shown in [Kun et al. 2012]. With some local modifications in the proof of Theorem 5.3 we can extend this result to structures with jellyfish duality. Our result gives the currently most general sufficient condition for robust solvability with linear loss. It will also be useful in Section 6.

THEOREM 5.8. *If (A, Γ) has jellyfish duality then there is a polynomial-time algorithm that $(1 - O(\epsilon), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma)$ for every $\epsilon \geq 0$.*

Proof. By Lemma 5.1 and Theorem 4.8, we can assume that Γ is preserved by $x \sqcup (y \sqcap z)$ for some distributive lattice (A, \sqcup, \sqcap) . In the proof of Theorem 5.3, set $H > 2|A|^L$, $k = 1$, and modify step (3) of the rounding algorithm by setting $t(v)$ to be $\sqcap_{S \in \mathcal{S}_v^1} \sqcup S$ where $\sqcup S = \sqcup_{a \in S} a$. It is only required to adapt the proof of Lemma 5.7 to show that if θ is good for C then C is satisfied by t . Construct matrix $N = N^1$ as in the proof of Theorem 5.3.

In our proof we shall use the following two properties of lattices.

- (i) $x_0 \sqcup ((x_{11} \sqcup \dots \sqcup x_{1m}) \sqcap \dots \sqcap (x_{n1} \sqcup \dots \sqcup x_{nm})) = (x_{11} \sqcup \dots \sqcup x_{1m}) \sqcap \dots \sqcap (x_{n1} \sqcup \dots \sqcup x_{nm})$ whenever $x_0 \in \{x_{u1}, \dots, x_{um}\}$ for every $u \in \{1, \dots, n\}$
- (ii) $(x_{11} \sqcup \dots \sqcup x_{1m}) \sqcap \dots \sqcap (x_{n1} \sqcup \dots \sqcup x_{nm})$ is a 1-layered m -ABS operation.

Both properties follow directly from the definitions.

Now, let $\mathbf{b} = (b_1, \dots, b_r)$ the any tuple in A^r with $p_C(\mathbf{b}) \geq 1/|A|^r$ which must necessarily exist because $p_C(A^r) = 1$. First, we prove that \mathbf{b} appears in every of the matrices $N_{j,S}^1$ used to construct N^1 .

By construction, for every $1 \leq j \leq r$ and every $S \in \mathcal{S}_{v_j}^1$, $N_{j,S}^1$ contains all the tuples of

$$R \cap (G_{v_1}^0 \times \dots \times G_{v_{j-1}}^0 \times (G_{v_j}^0 \cap S) \times G_{v_{j+1}}^0 \times \dots \times G_{v_r}^0) = R \cap (A^{j-1} \times S \times A^{r-j})$$

By consistency of marginals $p_C(A^{j-1} \times S \times A^{r-j}) = p_{v_j}(S) \geq 1 - M_\theta^1$. Then, by the union bound $p_C(R \cap (A^{j-1} \times S \times A^{r-j})) \geq 1 - \epsilon_C - M_\theta^1$ which is not smaller than $1 - 2M_\theta^1 \geq 1 - 2H^{-1} > 1 - 1/|A|^L$ by (4). Since $L \geq r$ it follows that \mathbf{b} must necessarily belong to $R \cap (A^{j-1} \times S \times A^{r-j})$ and hence to $N_{j,S}^1$.

Now, if $N_{11}^1, \dots, N_{1m}^1, \dots, N_{n1}^1, \dots, N_{nm}^1$ are the rows in N^1 then let (a_1, \dots, a_r) be the tuple $\mathbf{b} \sqcup ((N_{11}^1 \sqcup \dots \sqcup N_{1m}^1) \sqcap \dots \sqcap (N_{n1}^1 \sqcup \dots \sqcup N_{nm}^1))$ where \sqcup and \sqcap are applied component-wise.

We want to show that $(a_1, \dots, a_r) \in R$. Observe that for every pair of tuples $\mathbf{t}, \mathbf{t}' \in R$ we have that $\mathbf{t} \sqcup \mathbf{t}'$ belongs to R as $\mathbf{t} \sqcup \mathbf{t}' = \mathbf{t} \sqcup (\mathbf{t}' \sqcap \mathbf{t}')$ and the latter must be in R . Alternatively we can say that the binary operation $x \sqcup y$ preserves R because it can be obtained from $x \sqcup (y \sqcap z)$ by composition.

Proceeding in this way we shall prove that the $(nm + 1)$ -ary operation $x_0 \sqcup ((x_{11} \sqcup \dots \sqcup x_{1m}) \sqcap \dots \sqcap (x_{n1} \sqcup \dots \sqcup x_{nm}))$ preserves R implying that $(a_1, \dots, a_r) \in R$. First, we observe that the m -ary operation $x_1 \sqcup \dots \sqcup x_m$ preserves R as it can be obtained from composition from $x \sqcup y$ by $x_1 \sqcup (x_2 \sqcup (x_3 \sqcup \dots \sqcup (x_{m-1} \sqcup x_n) \dots))$. In a bit more complicated fashion we can show that $x_0 \sqcup (x_1 \sqcap \dots \sqcap x_n)$ preserves R . If $n = 3$ it follows from the properties of distributive lattices that $x_0 \sqcup ((x_0 \sqcup (x_1 \sqcap x_2)) \sqcap x_3)$ is equal to $x_0 \sqcup (x_1 \sqcap x_2 \sqcap x_3)$. The pattern generalizes easily to arbitrary values for n . Finally, one obtains $x_0 \sqcup ((x_{11} \sqcup \dots \sqcup x_{1m}) \sqcap \dots \sqcap (x_{n1} \sqcup \dots \sqcup x_{nm}))$ by suitably composing $x_0 \sqcup (x_1 \sqcap \dots \sqcap x_n)$ and $x_1 \sqcup \dots \sqcup x_m$. This finishes the proof that $(a_1, \dots, a_r) \in R$.

Finally, we have:

$$\begin{aligned} b_j \sqcup ((N_{11,j}^1 \sqcup \dots \sqcup N_{1m,j}^1) \sqcap \dots \sqcap (N_{n1,j}^1 \sqcup \dots \sqcup N_{nm,j}^1)) &= \\ ((N_{11,j}^1 \sqcup \dots \sqcup N_{1m,j}^1) \sqcap \dots \sqcap (N_{n1,j}^1 \sqcup \dots \sqcup N_{nm,j}^1)) &= \\ \sqcap_{S \in \mathcal{T}_{v_j}^1} \sqcup S &= \\ \sqcap_{S \in \mathcal{S}_{v_j}^1} \sqcup S &= \\ t(v_j) & \end{aligned}$$

which implies that $(t(v_1), \dots, t(v_r)) = (a_1, \dots, a_r)$ and, hence, that t satisfies C .

The first equality follows from property (i) and the fact that \mathbf{b} appears in all the matrices used to construct N^1 . The third equality follows from property (2) and the fact that $\min(\mathcal{T}_{v_j}^1) = \min(\mathcal{S}_{v_j}^1)$. ■

6. THE BOOLEAN CLASSIFICATION

Theorem 5.8 is the only missing piece to complete the classification of the Boolean case.

THEOREM 6.1. *Let Γ be a finite set of Boolean relations which is a core. The following conditions hold:*

- (1) *If $\text{Pol}(\Gamma)$ contains the operation $x \vee (y \wedge z)$ or $x \wedge (y \vee z)$ then*
 - *there is a polynomial-time algorithm that $(1 - O(\epsilon), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma)$ for every $\epsilon \geq 0$.*
- (2) *otherwise, if $\text{Pol}(\Gamma)$ contains the majority operation $(x \vee y) \wedge (y \vee z) \wedge (x \vee z)$ then*
 - *there is a polynomial-time algorithm that $(1 - O(\sqrt{\epsilon}), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma)$ for every $\epsilon \geq 0$, but*
 - *there is no polynomial-time algorithm that $(1 - o(\sqrt{\epsilon}), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma)$ for all $\epsilon \geq 0$ unless the UG conjecture is false.*
- (3) *otherwise, if $\text{Pol}(\Gamma)$ contains $x \vee y$ or $x \wedge y$ then*
 - *there is a polynomial-time algorithm that $(1 - O(1/\log(1/\epsilon)), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma)$ for every $\epsilon \geq 0$ but*
 - *there is no polynomial-time algorithm that $(1 - o(1/\log(1/\epsilon)), 1 - \epsilon)$ -approximates $\text{CSP}(\Gamma)$ for all $\epsilon \geq 0$ unless the UG conjecture is false.*
- (4) *otherwise $\text{CSP}(\Gamma)$ is not robustly tractable unless $\text{P} = \text{NP}$.*

Proof. The family of all sets of the form $\text{Pol}(\Gamma)$ where Γ is a set of boolean relations was completely described by Post (see [Szendrei 1986], for example). The following result follows directly from Post's description.

LEMMA 6.2.

- (1) *If $\{x \vee (y \wedge z), x \wedge (y \vee z)\} \cap \text{Pol}(\Gamma) = \emptyset$ then $\text{Pol}(\Gamma)$ is included in at least one of $\text{Pol}(\{\neq_2\})$, $\text{Pol}(3\text{-HORN})$, or $\text{Pol}(3\text{-DualHORN})$.*
- (2) *If $\{x \vee (y \wedge z), x \wedge (y \vee z), (x \vee y) \wedge (y \vee z) \wedge (x \vee z)\} \cap \text{Pol}(\Gamma) = \emptyset$ then $\text{Pol}(\Gamma)$ is included in at least one of $\text{Pol}(3\text{-HORN})$, $\text{Pol}(3\text{-DualHORN})$, or $\text{Pol}(3\text{EQ-LIN}(\mathbb{Z}_2))$ where \mathbb{Z}_2 is the 2-element cyclic group.*
- (3) *If $\{x \vee y, x \wedge y, (x \vee y) \wedge (y \vee z) \wedge (x \vee z)\} \cap \text{Pol}(\Gamma) = \emptyset$ then $\text{Pol}(\Gamma)$ is included in $\text{Pol}(3\text{EQ-LIN}(\mathbb{Z}_2))$.*

Let us consider each of the items of the theorem separately.

(1) Follows from Theorems 5.8 and 4.8.

(2) The existence of the approximation algorithm follows from Theorem 2.4 (3), Lemma 3.2, and the well-known fact that every relation preserved by the operation $(x \vee y) \wedge (y \vee z) \wedge (x \vee z)$ can be written as a conjunction of clauses in 2-SAT. The hardness part follows from Theorem 3.3(2-3) by applying Lemma 6.2(1), Theorem 2.5, and Lemma 3.2.

(3) If $(x \wedge y) \in \text{Pol}(\Gamma)$ then the existence of the approximation algorithm follows from Theorem 2.4(1), Lemma 3.2, and the well-known fact that every relation preserved by $x \wedge y$ is pp-definable from 3-HORN. The case $x \vee y$ follows similarly, by replacing Horn by dual Horn. The hardness part follows from Theorem 3.3(1-2) by applying Lemma 6.2(2), Theorem 2.5, and Lemma 3.2.

(4) This follows from Theorem 3.3(1) by applying Lemma 6.2(3), Theorem 2.5, and Lemma 3.2. ■

7. CONCLUSION

We have adapted the universal-algebraic framework to study robustly satisfiable problems $\text{CSP}(\Gamma)$ with a given error function, and we used it to derive some hardness conditions. We described three classes of CSPs that can be robustly solved with exponential, polynomial, and linear loss. We would like to mention some open problems arising from our research.

PROBLEM 1. *Which problems $\text{CSP}(\Gamma)$ can be robustly solved with polynomial or linear loss?*

PROBLEM 2. *Consider the set of numbers $k \geq 1$ such that there is a problem $\text{CSP}(\Gamma)$ that can be $(1 - O(\epsilon^{1/k}), 1 - \epsilon)$ -approximated, but not $(1 - o(\epsilon^{1/k}), 1 - \epsilon)$ -approximated, modulo some complexity-theoretic assumptions. Is this set infinite? Does it contain all positive integers?*
