# Galerkin/Runge-Kutta Discretizations for Semilinear Parabolic Equations 

Stephen L. Keeling*


#### Abstract

A new class of fully discrete Galerkin/Runge-Kutta methods is constructed and analyzed for semilinear parabolic initial boundary value problems. Unlike any classical counterpart, this class offers arbitrarily high, optimal order convergence. In support of this claim, error estimates are proved, and computational results are presented. Furthermore, it is noted that special RungeKutta methods allow computations to be performed in parallel so that the final execution time can be reduced to that of a low order method.

## 1 Introduction

In this paper, three classes of semilinear initial boundary value problems are considered. Specifically, the goal is to construct and analyze fully discrete approximations to the unique solution $u(x, t)$ of:

u & =0 & & \text { on } \partial \Omega \times\left[0, t^{*}\right] \\
u(\mathbf{x}, 0) & =u^{0}(\mathbf{x}) & & \text { in } \Omega,
\end{align*}\right.
$$

where:

L u \equiv-\sum_{i, j=1}^{N} \partial_{x_{i}}\left(\ell_{i j}(\mathbf{x}) \partial_{x_{j}} u\right)+\ell_{0}(\mathbf{x}) u
$$

and $f$ takes one of the following forms:

f=f(\mathbf{x}, t, u),  \tag{1.1.i}\\
f=\mathbf{g}(\mathbf{x}, t, u) \cdot \nabla u,  \tag{1.1.ii}\\
f=f(\mathbf{x}, t, u, \nabla u) \tag{1.1.iii}
\end{gather*}
$$

Here, $\Omega$ is a bounded domain in $\mathbf{R}^{N}$ with $\partial \Omega$ sufficiently smooth. Also, $\ell_{i j}(\mathbf{x})$ and $\ell_{0}(\mathbf{x})$ are assumed to be smooth. Further, on $\bar{\Omega}$, the matrix $\left\{\ell_{i j}\right\}$ is symmetric and uniformly positive definite and $\ell_{0}$ is nonegative. The initial data $u^{0}$ is assumed to be both sufficiently smooth and compatible, and precise hypotheses on the required smoothness of the solution $u$ are made as needed. Then, in the respective sections, it is assumed that there exist constants $\rho, c_{\rho}>0$ such that for all ( $\mathrm{x}, \mathrm{t}) \in \bar{\Omega} \times\left[0, t^{*}\right]$, one of the following local Lipschitz properties holds. Specifically, it is assumed that in case (1.1.i):

in case (1.1.ii), for $1 \leq i \leq N$ :

and in case (1.1.iii), for $1 \leq j \leq N$ :

\left|f(\mathbf{x}, t, u(\mathbf{x}, t), \mathrm{U})-f\left(\mathbf{x}, t, U_{0}, \mathrm{U}\right)\right| \leq c_{\rho}\left|u(\mathbf{x}, t)-U_{0}\right| \\
\text { and } \\
\left|f\left(\mathbf{x}, t, U_{0}, \mathrm{~V}^{j}\right)-f\left(\mathbf{x}, t, U_{0}, \mathrm{U}\right)\right| \leq c_{\rho}\left|\partial_{x_{j}} u(\mathbf{x}, t)-U_{j}\right|,
\end{gather*}
$$

where $V_{i}^{j} \equiv U_{i}, i \neq j$ and $V_{j}^{j} \equiv \partial_{x_{j}} u(\mathbf{x}, t)$. In addition, to prove certain estimates for case (1.1.iii), it is assumed that:

\end{gather*} \Rightarrow \max _{1 \leq i, j \leq N}\left|\partial_{d_{i} d_{j}}^{2} f\left(\mathbf{x}, t, U_{0}, \mathrm{U}\right)\right| \leq c_{\rho}
$$

where $\partial_{d_{j}} f$ denotes partial differentiation of $f$ with respect to its argument connected with the $j$ th spatial derivative of $u$. See the remarks prior to Proposition 4.3 for an explanation of the division (1.1.i) - (1.1.iii).

Now, for $1 \leq p \leq \infty$ and integers $s \geq 0$, let $W^{s, p} \equiv W^{s, p}(\Omega)$ represent the well-known Sobolev spaces consisting of functions with (distributional) derivatives of order $\leq s$ in $L_{p} \equiv L_{p}(\Omega)$. Also, let $\|\cdot\|_{W^{o, p}}$ denote the usual norm. Then, in particular, take $H^{s} \equiv W^{s, 2}$ and denote its norm by $\|\cdot\|_{s}$. In addition, let $H_{0}^{1}$ be the subspace of $H^{1}$ consisting of functions vanishing on $\partial \Omega$ in the sense of trace. Its dual is denoted by $H^{-1}$ with norm $\|\cdot\|_{-1}$. Next, let the inner product on $L_{2}$ be denoted by $(\cdot, \cdot)$, and the associated norm by $\|\cdot\|$. Further, $\|\cdot\|_{L_{\infty}}$ represents the norm on $L_{\infty}$, and $\|\cdot\|_{s, \infty}$ the norm on $L_{\infty}\left(\left[0, t^{*}\right], H^{s}\right)$. See Adams [1] for more details.

Equipped with the above notation, let the following be combined with (1.3) and (1.4), respectively. Specifically, assume that in case (1.1.ii):

Now, let $L$ be extended to have domain $H^{2} \cap H_{0}^{1}$. Then, $L$ is $L_{2}$-selfadjoint and for every nonegative integer $s$, it is bounded from $H^{s+2} \cap H_{0}^{1}$ into $H^{s}$. Furthermore, introducing the solution operator $T$ for the elliptic problem:

as $T w \equiv v$, it is well-known (Friedman [12]) that for every nonnegative integer $s, T$ is bounded from $H^{s}$ into $H^{s+2} \cap H_{0}^{1}$. Also, the solution operator is positive definite and selfadjoint on $L_{2}$; hence, $T$ has a square root and it can be shown (Thomée [18]) that:

Note that here and throughout this work, $c$ (sometimes with a subscript) is used to denote a general positive constant, not necessarily the same in any two places. Moreover, if in a given (in)equality, there is a crucial element upon which $c$ is meant to depend, such dependence is indicated explicitly.

A rough description of the results now follows. For this, let $h$ and $k$ denote spatial and temporal discretization parameters respectively, and suppose that $U_{h}^{n}$ is a fully discrete approximation to $u(n k)$ obtained according to (1.34) described below. Now, in section 2, the error committed for the approximation of the solution to (1.1) in case (1.1.i), is shown to be of optimal order in $L_{2}$ :

under the condition that $h^{-N / 2}\left(h^{r}+k^{\nu}\right)$ is sufficiently small. Here, $r$ and $\nu$ represent respectively, optimal exponents, characteristic of the Galerkin method and the Runge-Kutta method upon which the fully discrete scheme is based. Next, section 3 deals with case (1.1.ii) and the same optimal $L_{2}$ estimate is established but under the additional condition that $h^{-N / 2} k^{-1 / 2}\left(h^{r}+k^{\nu}\right)$ is small enough. Finally, in section 4, case (1.1.iii) is studied, and it is proved that the error is of optimal order in $H^{1}$ :

provided $h^{-N / 2}\left(h^{r-1}+k^{\nu}\right)$ is small enough. Then, a duality argument is used to obtain (1.9). For each of the cases (1.1.i) - (1.1.iii), results for the starting scheme (1.37) are stated without proof, since what is presented for the principal scheme (1.34) captures the main ideas with fewer details. Nevertheless, complete proofs are provided in [14]. Also, in the latter, linear problems with time dependent coefficients and quasilinear problems are considered. Further, preconditioned iterative methods are combined with specially constructed Galerkin/Runge-Kutta schemes and the results obtained are similar to those reported here.

It should also be mentioned that the discovery of the methods described below was fortuitous. Note that there are extrapolation options other than (1.33) and (1.36), which are apparently more natural. For example, $\mathrm{T}^{l} e$ could be used instead of $l!A^{l} e$ in (1.32) and (1.35), since this is suggested by the case that $f=f(x, t)$. On the other hand, an iterative procedure could be used during initial time steps to approximate fully implicit stages, and this might be followed with a standard extrapolation using previously computed stages to approximate stages for the current time step. Both of these ideas are considered in a computational section. However, under rather general conditions, optimal order convergence is proved and demonstrated computationally only for (1.34) and (1.37). In fact, for the linear nonhomogenous problem, Crouzeix [8] has developed an explicit example showing that unless $\partial_{t}^{l} u$ is in the domain of $L^{m}$ for certain $l$ and $m$, a classical fully discrete scheme fashioned after (1.25) cannot be expected to offer optimal order convergence.

In [4], Baker, Dougalis, and Karakashian analyze Galerkin/Multistep fully discrete approximations for the solution of (1.1) in case (1.1.i). Assuming local Lipschitz properties, they prove an optimal $L_{2}$ error estimate such as (1.9). In connection with case (1.1.ii), they have obtained similar results for the Navier-Stokes equations [3]. Also, for quasilinear equations which embrace case (1.1.ii), Bramble and Sammon* have announced results including an optimal $L_{2}$ estimate for a Galerkin/Obrechkoff method which is fourth order in time. Finally, note that in [11], Dougalis and Karakashian analyze Galerkin/Runge-Kutta approximations for the Korteweg-De Vries equation, and they prove optimal $L_{2}$ estimates for some modified IRKM's which are up to fourth order in time. Hence, the spirit of their work is similar to that of the present study.

In the remainder of this section, there is a presentation of material relevant to the spatial and temporal discretizations considered here, which concludes with a precise definition of the schemes for which the above claims are made.

## Spatial Discretizations

In terms of the solution operator, (1.1) can be written as:

For the spatial approximation of the solution to this problem, let $\left\{S_{h}\right\}_{0<h<1}$ be a family of finitedimensional subspaces of $H^{1}$. Then, suppose that a corresponding family of operators $\left\{T_{h}\right\}_{0<h<1}$ is given satisfying:

[^1]i. $T_{h}: L_{2} \rightarrow S_{h}$ is selfadjoint, positive semidefinite on $L_{2}$, and positive definite on $S_{h}$.
ii. There is an integer $r \geq 2$ such that:

Now, problem (1.11) has the following semidiscrete formulation. Find $u_{h}:\left[0, t^{*}\right] \rightarrow S_{h}$ such that:

u_{h}(0) & =u_{h}^{0}
\end{align*}\right.

where $f_{h}$ represents $f$ depending on $u_{h}$ instead of $u$ as indicated in one of (1.1.i) - (1.1.iii), and $u_{h}^{0} \in S_{h}$ is a suitable approximation to $u^{0}$.

To make the machinery more definite, consider the following Ordinary Galerkin Method. From (1.1), let $D(\cdot, \cdot)$ be a symmetric bilinear form defined by:

Then, take $S_{h}$ to consist of continuous, piecewise polynomials of degree $\leq r-1$, vanishing on $\partial \Omega$. Now, let $T_{h}: L_{2} \rightarrow S_{h}$ be defined by:

D\left(T_{h} w, \chi\right) \equiv(w, \chi) \quad \forall w \in L_{2}, \quad \forall \chi \in S_{h}
$$

For more examples of Galerkin methods satisfying the assumptions above as well as others below, see Bramble, Schatz, Thomée, and Wahlbin [5], and the references cited therein.

Next, the following inverse properties are prescribed for $S_{h}$. Throughout this work, it is assumed that $S_{h} \subset L_{\infty}$ and:

Moreover, for cases (1.1.ii) and (1.1.iii), it is assumed that $S_{h} \subset W^{1, \infty}$ and hence:

In fact, for certain estimates related to case (1.1.iii), it is assumed that:

For details connected with (1.14) - (1.16), see Ciarlet [7].
According to the properties prescribed above, the restriction of $T_{h}$ to $S_{h}$ is invertible and its inverse is henceforth denoted by $L_{h}$. Since $L_{h}$ is also positive definite and selfadjoint on $S_{h}$, both $L_{h}$ and $T_{h}$ have square roots but it is also assumed that:

Defining the elliptic projection operator as $P_{E} \equiv T_{h} L$, it follows from (1.12) that:

Also, it can be shown that $L_{h} T_{h} \equiv P_{0}$ is the orthogonal projection of $L_{2}$ onto $S_{h}$. Then, since $I-P_{0}$ is majorized by $I-P_{E}$ in $L_{2}$, it follows from (1.19) that:

In addition to (1.19), with $\omega(t) \equiv P_{E} u(t)$, it is assumed for case (1.1.i) that:

Further, for cases (1.1.ii) and (1.1.iii), it is assumed that:

\sup _{0 \leq t \leq t^{*}}\|u(t)-\omega(t)\|_{W^{1, \infty}} \equiv \gamma_{1}(h) \rightarrow 0, \quad \text { as } h \rightarrow 0 \tag{1.22}

For details connected with (1.21) and (1.22), see Rannacher and Scott [16], and Schatz and Wahlbin [17].

Now, problem (1.13) takes the following form. Find $u_{h}:\left[0, t^{*}\right] \rightarrow S_{h}$ satisfying:

u_{h}(0) & =u_{h}^{0}
\end{align*}\right.
$$

In [4], Baker, Dougalis and Karakashian analyze approximations of the form (1.23) with $f$ as in (1.1.i). Assuming local Lipschitz properties, they prove an optimal $L_{2}$ estimate:

\left\|u-u_{h}\right\|_{0, \infty}=\mathcal{O}\left(h^{r}\right)
$$

In connection with case (1.1.ii), Baker* has obtained similar results for the Navier-Stokes equations. Then in [10], Dendy studies Galerkin semidiscrete approximations for quasilinear problems which embrace case (1.1.iii). Assuming global Lipschitz properties, he establishes the following:

\left\|u-u_{h}\right\|_{1, \infty}=O\left(h^{r-1}\right) \quad \text { and } \quad\left\|u-u_{h}\right\|_{0, \infty}=O\left(h^{\min (r, 2 r-2-N / 2)}\right)
$$

In the present paper, semidiscrete approximations are not analyzed. Instead, (1.23) serves only as a source of inspiration for fully discrete approximations, and $u_{\boldsymbol{h}}$ is not even mentioned in forthcoming proofs.

## Temporal Discretizations

For the temporal approximation of the solution to (1.23), Implicit Runge-Kutta Methods (IRKM's) are now introduced. Given an integer $q \geq 1$, a $q$-stage IRKM is characterized by a set of constants:

and it is convenient to make the following definitions:

$$

For the IRKM formulation used in this work, choose arbitrarily, $t_{0} \in \mathbf{R}, \mathbf{y}_{0} \in \mathbf{R}^{n}, \mathbf{F}: \mathbf{R}^{\boldsymbol{n + 1}} \rightarrow \mathbf{R}^{n}$ sufficiently smooth, and $k>0$ sufficiently small, so that for $t_{0} \leq t \leq t_{0}+k$, smooth functions $\mathbf{y}, \hat{\mathbf{y}}: \mathbf{R} \rightarrow \mathbf{R}^{n}$ are well-defined by:

\hat{\mathbf{y}}(t)=\mathbf{y}_{0}+\left(t-t_{0}\right) \sum_{i=1}^{q} b_{i} \mathbf{F}\left(t_{0}+\tau_{i}\left(t-t_{0}\right), \mathbf{y}^{i}(t)\right)
\end{array}\right.
$$

The method is described as explicit if $a_{i j}=0, i \leq j$ and implicit if for any $i, a_{i i} \neq 0$. Also, it is said to have order $\nu$ if for every $\mathbf{y}$ and $\hat{\mathbf{y}}$ defined as above, $D_{t}^{l} \mathbf{y}\left(t_{0}\right)=D_{t}^{l} \hat{\mathbf{y}}\left(t_{0}\right), 0 \leq l \leq \nu$. Butcher [6] has developed simple conditions for the above parameters, which guarantee a given order; however, only the following is explicitly required in this work:

To see the roots of condition (1.26), let (1.24) have $n=1, t_{0}=0, y_{0}=1$, and $F(y)=-y$, so that $y(t)=e^{-t}$. Then, from (1.25), $\hat{y}(t)=r(t)$ where $r(z)$ is a rational approximation to the exponential $e^{-z}$ given by:

Expanding this expression shows that $r(z)$ is a $\nu$ th order approximation to the exponential if and only if (1.26) holds. Next, with regard to stability, an IRKM is said to be $A_{0}$-stable if:

Here, $A \mathcal{L}_{h}$ for example, is understood in the sense of composition of operators defined on $S_{h}$. Note that (1.23) and (1.34) are only partially patterned after (1.24) and (1.25), i. e., the stages $\bar{U}_{h}^{n}$ are not fully implicit, and extrapolation circumvents the solution of a nonlinear system of algebraic equations for each $n$.

Since the extrapolation for the principal scheme uses previously computed approximations, a starting procedure is required to generate $\left\{U_{h}^{m}\right\}_{m=0}^{\nu-1}$. ## 2 Semilinearities Independent of Spatial Derivatives

In this section, the principal scheme (1.34) is analyzed for the approximation of the solution to (1.1) in case (1.1.i), and (1.9) is established. That the stages are well-defined depends on the Lemma below. Its proof involves a spectral argument after $\boldsymbol{A}$ is transformed to Jordan form, and the details are provided by Karakashian [13]. First, define the product space norm:

## 3 Semilinearities Depending Linearly on Spatial Derivatives

In this section, the principal scheme (1.34) is analyzed for the approximation of the solution to (1.1) in case (1.1.ii), and (1.9) is established. Again, sufficiently accurate starting approximations are assumed given. Also, an error equation appears below, which differs in certain ways from (2.2). For the sequel, define the new terms:

## 4 General Semilinearities

In this section, the principal scheme (1.34) is analyzed for the approximation of the solution to (1.1) in case (1.1.iii), and (1.10) and (1.9) are established. For this, the basic structure of previous sections is followed and in fact, several of the estimates of section 3 are readily adapted. First, the error equation (3.1) serves here but with:

analogue to the $H^{-1}$ estimate prior to (3.14), it is tempting to suppose the existence of constants $\rho, c_{\rho}>0$ such that for $0 \leq t \leq t^{*}$, the following are satisfied:

\max _{0 \leq m \leq n^{*}}\left\|U_{h}^{m}-u^{m}\right\|_{W^{1, \infty}} \leq \rho . \tag{4.19}
\end{equation*}
$$

Note that by (1.15), (1.18), (4.15), and (1.22), for $\theta(h, k)$ small enough:

$$
\left\|U_{h}^{m}-u^{m}\right\|_{W^{1, \infty}} \leq c h^{-N / 2}\left\|\xi^{m}\right\|_{1}+\left\|\eta^{m}\right\|_{W^{1, \infty}} \leq c \theta(h, k) \leq \rho \quad 0 \leq m \leq \nu-1 .
$$

Now suppose that for each $h$ and $k$, there exists an $n=n(h, k)$ such that $\nu-1 \leq n \leq n^{*}-1$ and:

$$
\begin{equation*}
\max _{0 \leq l \leq n}\left\|U_{h}^{l}-u^{l}\right\|_{W^{1, \infty}} \leq \rho \tag{4.20}
\end{equation*}
$$

while:

$$
\begin{equation*}
\left\|U_{h}^{n+1}-u^{n+1}\right\|_{W^{1}, \infty}>\rho . \tag{4.21}
\end{equation*}
$$

Given (4.20), inequalities (4.1), (4.2), and (4.4) can be combined to obtain:

$$
\left\|\xi^{l+1}\right\|_{2}^{2} \leq(1+\tilde{c} k)\| \| \xi^{l}\left\|_{2}^{2}+c_{1} k\left[\left(h^{r-1}+k^{\nu}\right) \mathcal{N}(u)\right]^{2}+c_{2} k \sum_{m=0}^{\nu-1}\right\|\left\|\xi^{l-m}\right\|_{2}^{2} \quad \nu-1 \leq l \leq n
$$

After summing this over $\nu-1 \leq l \leq n$ and applying the discrete Gronwall Lemma to the result, it follow that:

$$
\begin{equation*}
\left\|\left\|\xi^{n+1}\right\|_{2}^{2} \leq\left(1+c_{3} k\right)^{n-\nu+1}\left\{\left\|\left|\xi^{\nu-1}\left\|_{2}^{2}+c_{1} t^{*}\left[\left(h^{r-1}+k^{\nu}\right) \mathcal{N}(u)\right]^{2}+c_{3} k \sum_{m=0}^{\nu-1} \mid\right\| \xi^{m} \|_{2}^{2}\right\}\right.\right.\right. \tag{4.22}
\end{equation*}
$$

for $c_{3} \equiv \tilde{c}+c_{2} \nu \geq 0$. Also, the exponential dependence on $t^{*}$ can be eliminated if $c_{3} \leq 0[14]$. Now, by (1.15), (1.18), (4.22), (4.15), and (1.22), for $\theta(h, k)$ small enough:

$$
\left\|U_{h}^{n+1}-u^{n+1}\right\|_{W^{1, \infty}} \leq c h^{-N / 2}\left\|\xi^{n+1}\right\|_{1}+\left\|\eta^{n+1}\right\|_{W^{1, \infty}} \leq c \theta(h, k) \leq \rho .
$$

Hence, (4.21) is contradicted and (4.19) is established. In fact, (4.16) follows from (4.22) and (4.15) after using (1.19).

Now, if (4.17) holds, (4.18) is obtained as follows. Given (4.19), inequalities (3.2), (4.2), and (4.6) can be combined to obtain:

$$
\|\mid\| \xi^{l+1}\left\|_{1}^{2} \leq(1+\tilde{c} k)\right\| \xi^{l}\left\|_{1}^{2}+c_{4} k\left[\left(h^{r}+k^{\nu}\right) \mathcal{N}(u)\right]^{2}+c_{5} k \sum_{m=0}^{\nu-1}\right\| \xi^{l-m} \|_{1}^{2} \quad \nu-1 \leq l \leq n^{*}-1
$$

since for small enough $\epsilon$ and $\theta(h, k), \quad r-2-p_{N, \epsilon} \geq 0$ and:

$$
\begin{aligned}
\left\{c\left(h^{r}+k^{\nu}\right) \mathcal{N}(u)+c(\epsilon) h^{-p_{N, \epsilon}}\left[\left(h^{r-1}+k^{\nu}\right) \mathcal{N}(u)\right]^{2}\right\}^{2} & \leq c\left[h^{\left.r-2-p_{N, \epsilon}+\theta(h, k)\right]^{2}\left[\left(h^{r}+k^{\nu}\right) \mathcal{N}(u)\right]^{2}}\right. \\
& \leq c_{4}\left[\left(h^{r}+k^{\nu}\right) \mathcal{N}(u)\right]^{2} .
\end{aligned}
$$

After summing over $\nu-1 \leq l \leq n \leq n^{*}-1$ and applying the discrete Gronwall Lemma to the result, it follows that:

$$
\begin{equation*}
\left\|\mid \xi^{n+1}\right\|_{1}^{2} \leq\left(1+c_{6} k\right)^{n-\nu+1}\left\{\| \| \xi ^ { \nu - 1 } \left\|_{1}^{2}+c_{4} t^{*}\left[\left(h^{r}+k^{\nu}\right) \mathcal{N}(u)\right]^{2}+c_{6} k \sum_{m=0}^{\nu-1}\left|\left\|\xi^{m} \mid\right\|_{1}^{2}\right\}\right.\right. \tag{4.23}
\end{equation*}
$$

for $c_{6} \equiv \tilde{c}+c_{4} \nu \geq 0$. Again, the exponential dependence on $t^{*}$ can be eliminated if $c_{6}<0$ [14]. Finally, (4.18) follows from (4.23) and (4.17) after using (1.19).

See [14] for a proof of the next Theorem. It requires the inequality:

$$
\begin{equation*}
\left\|L_{h}^{\frac{1}{2}} \chi\right\| \leq c h^{-1}\|\chi\| \quad \forall \chi \in S_{h} \tag{4.24}
\end{equation*}
$$

which depends on inverse properties such as (1.14) - (1.16).
Theorem 4.2 Assume that (1.29), (1.30), (1.91) and (4.24) are satisfied. Then provided $h^{-N / 2}\left(h^{r-1}+k^{3 / 2}\right)+\gamma_{1}(h)$ is sufficiently small, $\left\{U_{h}^{n, i}\right\}_{0 \leq n \leq \min (i, \nu-1)}^{1 \leq i \leq 2-1}$ are well-defined by (1.37) and (1.99) and the following holds:

$$
\max _{0 \leq n \leq \min (i, \nu-1)}\| \| U_{h}^{n, i}-\omega^{n} \|_{2} \leq c\left(h^{r-1}+k^{i / 2+1}\right) \mathcal{N}(u) \quad 1 \leq i \leq 2 \nu-1 .
$$

Therefore, (4.15) follows with $U_{h}^{n} \equiv U_{h}^{n, 2(\nu-1)}, 0 \leq n \leq \nu-1$. Furthermore:

$$
\max _{0 \leq n \leq \min (i, \nu-1)} \mid\left\|U_{h}^{n, i}-\omega^{n}\right\|_{1} \leq c\left(h^{r}+k^{(i+1) / 2}\right) \mathcal{N}(u) \quad 1 \leq i \leq 2 \nu-1
$$

and (4.17) follows with $U_{h}^{n} \equiv U_{h}^{n, 2 \nu-1}, 0 \leq n \leq \nu-1$.

## 5 Computational Aspects.

Note from (1.34) and (1.37), the need of an efficient method for solving linear equations of the form:

$$
\left[I+k A \mathcal{L}_{h}\right] \Psi=\Phi \quad \Psi, \Phi \in \mathbf{S}_{h}
$$

In connection with parallel implementation, it can be seen below that the preferred methods are those for which the eigenvalues of $A$ are distinct. So, let these be called multiply implicit (MIRK) methods.

First, consider the use of IRKM's which have high order with respect to $q$, such as the GaussLegendre ( $\nu=2 q$ ) or the Radau ( $\nu=2 q-1$ ) methods (See e. g., Dekker and Verwer [9]). These are $A_{0}$-stable, and the latter are strongly $A_{0}$-stable while the former are not. Also, though each class of methods satisfies (1.30), for neither is $\sigma(A) \subset \mathbf{R}$. Nevertheless, these are (complex) MIRK's, for which $A$ can always be transformed to quasidiagonal form:

$$
A=S^{-1} \Lambda S
$$

where for some $m, 1 \leq m<q$ :

$$
\Lambda=\operatorname{diag}_{1 \leq i \leq m}\left\{\Lambda_{i}\right\}
$$

and:

$$
\text { either } \quad \Lambda_{i}=\lambda_{i}>0 \quad \text { or } \quad \Lambda_{i}=\left[\begin{array}{cc}
\alpha_{i} & -\beta_{i} \\
\beta_{i} & \alpha_{i}
\end{array}\right] \quad \alpha_{i}, \beta_{i}>0 \quad 1 \leq i \leq m
$$

Then, the linear system can be written as:

$$
\left[I+k \boldsymbol{\Lambda} \mathcal{L}_{k}\right](S \Psi)=(S \Phi)
$$

which decouples to equations of the form:

$$
\left[I+k \lambda L_{h}\right] \psi=\phi \quad \psi, \phi \in S_{h}
$$

and:

$$
\left[\begin{array}{cc}
I+k \alpha L_{h} & -k \beta L_{h} \\
k \beta L_{h} & I+k \alpha L_{h}
\end{array}\right]\left[\begin{array}{l}
\psi_{1} \\
\psi_{2}
\end{array}\right]=\left[\begin{array}{c}
\phi_{1} \\
\phi_{2}
\end{array}\right] \quad \psi_{i}, \phi_{i} \in S_{h}, i=1,2 .
$$

Note that the subordinate equations can in principle, be solved simultaneously. Further, the $2 \times 2$ system is equivalent to the following pair of equations:

$$
\left[I+k \alpha L_{h}\right] \psi_{1}=\phi_{1}+k \beta L_{h} \psi_{2}
$$

and:

$$
\left[I+2 \alpha k L_{h}+\left(\alpha^{2}+\beta^{2}\right) k^{2} L_{h}^{2}\right] \psi_{2}=\left[I+k \alpha L_{h}\right] \phi_{2}-k \beta L_{h} \phi_{1} \equiv \chi_{0}
$$

Following Baker, Bramble and Thomée [2], since for $x \in \mathbf{R}$ :

$$
\frac{1}{1+2 \alpha x+\left(\alpha^{2}+\beta^{2}\right) x^{2}}=1-\Re\left[\frac{z_{1} x}{1+z_{2} x}\right] \quad z_{1} \equiv 2 \alpha+\beta^{-1}\left(\alpha^{2}+\beta^{2}\right) i, \quad z_{2} \equiv \alpha+\beta i
$$

complex arithmetic can be used to obtain:

$$
\psi_{2}=\chi_{0}-k \Re\left\{z_{1}\left[T_{h}+z_{2} k I\right]^{-1} \chi_{0}\right\} .
$$

Next, in spite of the order barrier $\nu \leq q+1$, consider methods for which $A$ is similar to a matrix of the form:

$$
\Lambda=\left[\begin{array}{cccc}
\lambda_{1} & & & 0 \\
\theta_{2} & \lambda_{2} & & \\
& \ddots & \ddots & \\
0 & & \theta_{q} & \lambda_{q}
\end{array}\right] \quad \begin{array}{lll}
\lambda_{i}>0, & 1 \leq i \leq q \\
\theta_{i}=0 \text { or } 1, & 2 \leq i \leq q
\end{array}
$$

so that the block system reduces to equations which are linear in $L_{h}$ :

$$
\left\{\begin{array}{rl}
{\left[I+k \lambda_{1} L_{h}\right] \psi_{1}} & =\phi_{1} \\
{\left[I+k \lambda_{i} L_{h}\right] \psi_{i}} & =\phi_{i}-k \theta_{i} L_{h} \psi_{i-1}, \quad 2 \leq i \leq q
\end{array} \quad \psi_{j}, \phi_{j} \in S_{h}, \quad 1 \leq j \leq q\right.
$$

A class of (real) MIRK's is obtained in case $\lambda_{i} \neq \lambda_{j}, i \neq j$ and $\theta_{i}=0,2 \leq i \leq q$. The depth of decoupling these methods allow in the above equations makes them appear, in a parallel environment, more attractive than their complex counterparts above. However, the cost of this advantage is reduced order.

On the other hand, the class for which $\lambda_{i}=\lambda, 1 \leq i \leq q$ is said to contain singly implicit (SIRK) methods. Since these require the formation and factorization of only a single matrix with the dimension of $S_{h}$, SIRK's are preferred if computations are to be performed on a serial machine. A selection from the previous set was made for the example discussed below.

The following problem is of the class considered in Section 2:

$$
\left\{\begin{aligned}
\partial_{t} u & =\partial_{x}^{2} u+f(x, t, u) & & \text { in }(-1,1) \times[0, .1] \\
u & =0 & & \text { on }\{-1,1\} \times[0, .1] \\
u(x, 0) & =1-x^{2} & & \text { in }(-1,1)
\end{aligned}\right.
$$

where:

$$
f(x, t, u)=\frac{2-\left(1-x^{2}\right) \log \left(1+X^{2}\right)}{\left(1+X^{2}\right)^{t}}+\frac{2 t\left(1-5 x^{2}\right)}{\left(1+X^{2}\right)^{t+1}}-\frac{4 x^{2} t(t+1)\left(1-x^{2}\right)}{\left(1+X^{2}\right)^{t+2}}, \quad X^{2} \equiv 1-\left(1+x^{2}\right)^{t} u
$$

The solution is given by:

$$
u(x, t)=\frac{1-x^{2}}{\left(1+x^{2}\right)^{t}}
$$

For the spatial discretization, the Ordinary Galerkin Method was used and $S_{h}$ was constructed of smooth cubic splines defined on a uniform mesh. For the temporal discretization, the following three-stage diagonally implicit (DIRK) method was used:

$$
\begin{array}{ccc|cc}
\gamma & 0 & 0 & \gamma & \gamma \equiv \frac{1}{2}+\frac{1}{\sqrt{3}} \cos \left(\frac{\pi}{18}\right) \\
\frac{1}{2}-\gamma & \gamma & 0 & \frac{1}{2} & \beta \equiv\left[6(1-2 \gamma)^{2}\right]^{-1} .
\end{array}
$$

In the sequel, let (1.34), (1.37), and (1.38) be identified as the modified method. For comparison, a classical method is now introduced. Define $\mathcal{F}^{n}: \mathbf{L}_{\mathbf{2}} \rightarrow \mathbf{L}_{\mathbf{2}}$ to have components:

$$
\mathcal{f}_{i}^{n}(\Phi) \equiv f\left(\mathbf{x}, t^{n}+k \tau_{i}, \phi_{i}\right) \quad \Phi \in \mathbf{S}_{h}
$$

Next, let $\bar{U}_{h}^{0,0} \equiv e U_{h}^{0}=e P_{0} u^{0}$ and after the stages $\left\{\bar{U}_{h}^{n-m}\right\}_{m=1}^{\min (n, \nu)}$ are computed as indicated below, take:

$$
\bar{U}_{h}^{n, 0} \equiv \sum_{m=1}^{\min (n, \nu)}(-1)^{m+1}\binom{n}{m} \bar{U}_{h}^{n-m} \quad 1 \leq n \leq n^{*}-1 .
$$

Then define:

$$
\bar{U}_{h}^{n, l} \equiv\left[I+k A \mathcal{L}_{h}\right]^{-1}\left\{e U_{h}^{n}+k A P_{0} \mathcal{F}^{n}\left(\bar{U}_{h}^{n, l-1}\right)\right\} \quad l \geq 1, \quad 0 \leq n \leq n^{*}-1
$$

and:

$$
\bar{U}_{h}^{n} \equiv \bar{U}_{h}^{n, \max (\nu+1-n, 1)} \quad 0 \leq n \leq n^{*}-1 .
$$

Finally, take:

$$
U_{h}^{n+1}=U_{h}^{n}-k b^{T} \mathcal{L}_{h} \bar{U}_{h}^{n}+k b^{T} P_{0} \mathcal{F}^{n}\left(\bar{U}_{h}^{n}\right) .
$$

Now, in addition to the modified and classical methods, let a hybrid method be given by (1.34), (1.37), and (1.38), but with $l!A^{l} e$ replaced by $T^{l} e$ in (1.32) and (1.35).

These three methods were tested on the ICASE SUN 3/180. In Tables 1-3, the $L_{2}$ errors:

$$
E(k) \equiv E(k, k), \quad E(h, k) \equiv\left\|U_{h}^{n^{*}}-u^{n^{*}}\right\|
$$

are reported together with estimates of the convergence order obtained according to the formula:

$$
\text { Order } \equiv \frac{\log \left(E\left(k_{2}\right) / E\left(k_{1}\right)\right)}{\log \left(k_{2} / k_{1}\right)}
$$

As expected, the classical method requires much more time because of the additional function evaluations. Also, for the present example, the classical and hybrid methods offer roughly the same accuracy. However, at least according to theoretical efforts, this is not to be generally expected. Finally, note that the literature apparently does not contain an explanation of the better than

second order convergence seen in Tables 2 and 3. In particular, with $L v \equiv \partial_{x}^{2} v, v \in H^{2} \cap H_{0}^{1}$, the above solution is not even in the domain of $L^{2}$. Nevertheless, only second order convergence is demonstrated for example, in Experiment 7.5.2 of Dekker and Verwer [9], where a stiff nonlinear ordinary differential equation is considered. Further, the modified method has been applied to this problem to give not only fourth order convergence, but accuracy exceeding that reported for any method discussed in the Experiment.
