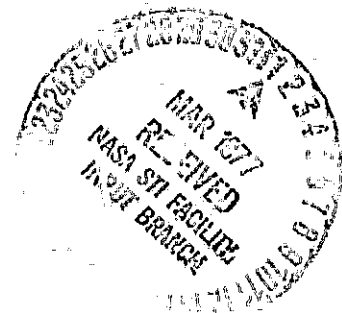

(iii) This third Report covers the period when letters and telegrams were exchanged giving specific details of problems of communication on Landsat matters. Departmental letters C.1/3-38 dated 20th August 1976, and C.1/3-44 dated 16th September 1976 give specific details.

The other problem concerns the administrative side of the placing of an order for Landsat data. An order was placed by the Department of Water Affairs on 15th June through this Department (C.1/3-29 refers). No acknowledgement of receipt of this order was received in Botswana. Two queries concerning this order were made on 20th August 1976, and again on 13th September 1976. The order was in fact received on 14th September 1976. This lack of communication during the three month period in which the order was processed should surely be avoided in future. A second order was placed by this Department on 9th November, 1976. It would be appreciated if the receipt of the order could be acknowledged and a provisional delivery date given so that plans can be put in hand for the imagery to be processed promptly on its arrival in Botswana.
