He has also held visiting professorships in Switzerland (St. Gallen), New Zealand (Christchurch), and in Berlin, and gave invited lectures in Australia, Austria, Canada, Germany, Hong Kong, Italy, Japan, Switzerland, the United Kingdom, and the United States. Over the last ten years, CHI has been adapting the techniques of literature bibliometrics to the analysis of patents and patent bibliometrics. In 1988, Mr. Narin was awarded the Derek de Solla Price Medal, given by the Editorial and Advisory Board of Scientometrics, for his outstanding contributions to quantitative studies of science.
