The Study Committee on Aging recently conducted a survey of state agencies to determine what services they are providing to older persons in South Carolina. We received excellent response to our requests for information and are impressed by the wide ranging services throughout state government for our older citizens.

A number of state agencies have programs established specifically for older persons. They are active participants in many other general state services; in some instances they represent the majority of the recipients. The survey also revealed several ancillary programs helpful to the aging.

A digest of these agency reports follows. We believe that this summary will be of interest to older South Carolinians, to the general public, to the members of the General Assembly, and to the State agencies themselves. Information on sources of services is provided. Figures on monetary expenditures, percentages, and numbers of persons served are actual where available. Where actual figures were not available, estimates are included. Where no figures were available, it is so indicated (N/A).

Program Title: Prevention of Blindness

Description: The Prevention of Blindness Division provides a wide range of services to those individuals not eligible for rehabilitation, who have an eye disease or an eye injury which, if not treated, may lead to legal or total blindness. These services include eye examinations, transportation for clients to eye specialists, surgery and hospitalization, emergency medical treatment for eye disorders, glaucoma control, counseling and public education in the need for good eye care to prevent serious eye problems from occurring. This division operates low vision clinics and pathology clinics in areas where clients have difficulty in securing ophthalmological care due to the scarcity of eye specialists. A mobile eye screening unit is operated in cooperation with the Lion's Sight Conservation of S. C., which provides testing of visual acuity and glaucoma screening to the public at no cost.

These services are rendered through a network of 13 offices and two facilities operated by the Commission throughout the state.

There is one or more Home Economist in each County Extension Office who conducts educational programs cooperatively planned with advisory committees. Volunteer leaders extend professional efforts.

Specialists at Clemson University provide training, publications, and teaching materials for County Extension staffs in such areas as nutrition, family economics, home management, housing and home furnishings, clothing and textiles, human relations, and child development.
