### Small divisor problem in the theory of three-dimensional water gravity waves

#### Abstract

We consider doubly-periodic travelling waves at the surface of an infinitely deep perfect fluid, only subjected to gravity g and resulting from the nonlinear interaction of two simply periodic travelling waves making an angle  $2\theta$  between them.

Denoting by  $\mu = gL/c^2$  the dimensionless bifurcation parameter (L is the wave length along the direction of the travelling wave and c is the velocity of the wave), bifurcation occurs for  $\mu = \cos \theta$ . For non-resonant cases, we first give a large family of formal three-dimensional gravity travelling waves, in the form of an expansion in powers of the amplitudes of two basic travelling waves. "Diamond waves" are a particular case of such waves, when they are symmetric with respect to the direction of propagation.

The main object of the paper is the proof of existence of such symmetric waves having the above mentioned asymptotic expansion. Due to the occurence of small divisors, the main difficulty is the inversion of the linearized operator at a non trivial point, for applying the Nash Moser theorem. This operator is the sum of a second order differentiation along a certain direction, and an integro-differential operator of first order, both depending periodically of coordinates. It is shown that for almost all angles  $\theta$ , the 3-dimensional travelling waves bifurcate for a set of "good" values of the bifurcation parameter having asymptotically a full measure near the bifurcation curve in the parameter plane  $(\theta, \mu)$ .

#### 1 Introduction

#### 1.1 Presentation and history of the problem

We consider small-amplitude three-dimensional doubly periodic travelling gravity waves on the free surface of a perfect fluid. These unforced waves appear in literature as steady 3-dimensional water waves, since they are steady in a suitable moving frame. The fluid layer is supposed to be infinitely deep, and the flow is irrotational only subjected to gravity. The bifurcation parameter is the horizontal phase velocity, the infinite depth case being not essentially different from the finite depth case, except for very degenerate situations that we do not consider here. The essential difficulty here, with respect to the existing literature is that we assume the absence of surface tension. Indeed the surface tension plays a major role in all existing proofs for three-dimensional travelling gravity-capillary waves, and when the surface tension is very small, which is the case in many usual situations, this implies a reduced domain of validity of these results.




Figure 1: 3-dim travelling wave, the elevation  $\eta_{\varepsilon}^{(2)}$  is computed with formula (1.10). Top:  $\theta = 11.3^{\circ}$ ,  $\tau = 1/5$ ,  $\varepsilon = 0.8\mu_c$ ; bottom:  $\theta = 26.5^{\circ}$ ,  $\tau = 1/2$ ,  $\varepsilon = 0.6\mu_c$ . The dashed line is the direction of propagation of the waves. Crests are dark and troughs are grey.

In 1847 Stokes [40] gave a nonlinear theory of two-dimensional travelling gravity waves, computing the flow up to the cubic order of the amplitude of the waves, and the first mathematical proofs for such periodic two-dimensional waves are due to Nekrasov [30], Levi-Civita [28] and Struik [41] about 80 years ago. Mathematical progresses on the study of three-dimensional doubly periodic water waves came much later. In particular, to our knowledge, first formal expansions in powers of the amplitude of three-dimensional travelling waves can be found in papers [16] and [39]. One can find many references and results of researches on this subject in the review paper of Dias and Kharif [14] (see section 6). The work of Reeder and Shinbrot (1981)[36] represents a big step forward. These authors consider symmetric diamond patterns, resulting from (horizontal) wave vectors belonging to a lattice  $\Gamma'$  (dual to the spatial lattice  $\Gamma$  of the doubly periodic pattern) spanned by two wave vectors  $K_1$  and  $K_2$ with the same length, the velocity of the wave being in the direction of the bissectrix of these two wave vectors, taken as the  $x_1$  horizontal axis. We give at Figure 1 two examples of patterns for these waves (see the detailed comment about these pictures at the end of subsection 2.4). These waves also appear in litterature as "short crested waves" (see Roberts and Schwartz [37], Bridges, Dias, Menasce [5] for an extensive discussion on various situations and numerical computations). If we denote by  $\theta$  the angle between  $K_1$  and the  $x_1$  – axis, Reeder and Shinbrot proved that bifurcation to diamond waves occurs provided the angle  $\theta$  is not too close to 0 or to  $\pi/2$ , and provided that the surface tension is not too small. In addition their result is only valid outside a "bad" set in the parameter space, corresponding to resonances, a quite small set indeed. This means that if one considers the dispersion relation  $\Delta(K, \mathbf{c}) = 0$ , where K and  $\mathbf{c} \in \mathbb{R}^2$  are respectively a wave vector and the velocity of the travelling wave, then there is no resonance if for the critical value of the velocity  $\mathbf{c}_0$  there are only the four solutions  $\pm K_1, \pm K_2$  of the dispersion equation, for  $K \in \Gamma'$  (i.e. for K being any integer linear combination of  $K_1$  and  $K_2$ ). The fact that the

surface tension is supposed not to be too small is essential for being able to use Lyapunov-Schmidt technique, and the authors mention a small divisor problem if there is no surface tension, as computed for example in [37]. Notice that the existence of spatially bi-periodic gravity water waves was proved by Plotnikov in [32], [31] in the case of finite depth and for fixed rational values of  $gL/c^2 \tan \theta$ , where g, L, c are respectively the acceleration of gravity, the wave length in the direction of propagation, and the velocity of the wave. Indeed, such a special choice of parameters avoids resonances and the small divisor problem, because the pseudo-inverse of the linearized operator is bounded.

Craig and Nicholls (2000) [9] used the hamiltonian formulation introduced by Zakharov [44], in coupling the Lyapunov-Schmidt technique with a variational method on the bifurcation equation. Still in the presence of surface tension, they could suppress the restriction of Reeder and Shinbrot on the "bad" resonance set in parameter space, but they pay this complementary result in losing the smoothness of the solutions. Among other results, the other paper by Craig and Nicholls (2002) [8] gives the principal parts of "simple" doubly periodic

waves (i.e. in the non resonant cases), expanded in Taylor series, taking into account the two-dimensions of the parameter  $\mathbf{c}$ . They emphasize the fact that this expansion is only formal in the absence of surface tension.

Mathematical results of another type are obtained in using "spatial dynamics", in which one of the horizontal coordinates (the distinguished direction) plays the role of a time variable, as was initiated by Kirchgässner [25] and extensively applied to two-dimensional water wave problems (see a review in [13]). The advantage of this method is that one does not choose the behavior of the solutions in the direction of the distinguished coordinate, and solutions periodic in this coordinate are a particular case, as well as quasi-periodic or localized solutions (solitary waves). In this framework one may a priori assume periodicity in a direction transverse to the distinguished direction, and a periodic solution in the distinguished direction is automatically doubly periodic. The first mathematical results obtained by this method, containing 3-dimensional doubly periodic travelling waves, start with Haragus, Kirchgässner, Groves and Mielke (2001) [19], [17], [21], generalized by Groves and Haragus (2003) [18]. They use a hamiltonian formulation and center manifold reduction. This is essentially based on the fact that the spectrum of the linearized operator is discrete and has only a finite number of eigenvalues on the imaginary axis. These eigenvalues are related with the dispersion relation mentioned above. Here, one component (or multiples of such a component) of the wave vector K is imposed in a direction transverse to the distinguished one, and there is no restriction for the component of K in the distinguished direction, which, in solving the dispersion relation, gives the eigenvalues of the linearized operator on the imaginary axis. The resonant situations, in the terminology of Craig and Nicholls correspond here to more than one pair of eigenvalues on the imaginary axis, (in addition to the origin). In all cases it is known that the largest eigenvalue on the imaginary axis leads to a family of periodic solutions, via the Lyapunov center theorem (hamiltonian case), so, here again, there is no restriction on the resonant set in the parameter space at a fixed finite depth. The only restriction with this formulation is that it is necessary to assume that the depth of the fluid layer is finite. This ensures that the spectrum of the linearized operator has a spectral gap near the imaginary axis, which allows to use the center manifold reduction method. In fact if we restrict the study to periodic solutions as here, the center manifold reduction is not necessary, and the infinite depth case might be considered in using an extension of the proof of Lyapunov-Devaney center theorem in the spirit of [23], in this case where 0 belongs to the continuous spectrum. However, it appears that the number of imaginary eigenvalues becomes infinite when the surface tension cancels, which prevents the use of center manifold reduction in the limiting case we are considering in the present paper, not only because of the infinite depth.

#### 1.2 Formulation of the problem

Since we are looking for waves travelling with velocity  $\mathbf{c}$ , let us consider the system in the moving frame where the waves look steady. Let us denote by  $\varphi$ 

the potential defined by

$$\varphi = \phi - \mathbf{c} \cdot X,$$

where  $\phi$  is the usual velocity potential,  $X = (x_1, x_2)$  is the 2-dim horizontal coordinate,  $x_3$  is the vertical coordinate, and the fluid region is

$$\Omega = \{ (X, x_3) : -\infty < x_3 < \eta(X) \},$$

which is bounded by the free surface  $\Sigma$  defined by

$$\Sigma = \{ (X, x_3) : x_3 = \eta(X) \}.$$

We also make a scaling in choosing  $|\mathbf{c}|$  for the velocity scale, and L for a length scale (to be chosen later), and we still denote by  $(X, x_3)$  the new coordinates, and by  $\varphi, \eta$  the unknown functions. Now defining the parameter  $\mu = \frac{gL}{c^2}$  (the Froude number is  $\frac{c}{\sqrt{gL}}$ ) where g denotes the acceleration of gravity, and  $\mathbf{u}$  the unit vector in the direction of  $\mathbf{c}$ , the system reads

$$\Delta \varphi = 0 \text{ in } \Omega, \tag{1.1}$$

$$\nabla_X \eta \cdot (\mathbf{u} + \nabla_X \varphi) - \frac{\partial \varphi}{\partial x_3} = 0 \text{ on } \Sigma, \tag{1.2}$$

$$\mathbf{u} \cdot \nabla_X \varphi + \frac{(\nabla \varphi)^2}{2} + \mu \eta = 0 \text{ on } \Sigma,$$

$$\nabla \varphi \to 0 \text{ as } x_3 \to -\infty.$$
(1.3)

Hilbert spaces of periodic functions. We specialize our study to spatially periodic 3-dimensional travelling waves, i.e. the solutions  $\eta$  and  $\varphi$  are bi-periodic in X. This means that there are two independent wave vectors  $K_1, K_2 \in \mathbb{R}^2$  generating a lattice

$$\Gamma' = \{ K = n_1 K_1 + n_2 K_2 : n_i \in \mathbb{Z} \},\$$

and a dual lattice  $\Gamma$  of periods in  $\mathbb{R}^2$  such that

$$\Gamma = \{\lambda = m_1 \lambda_1 + m_2 \lambda_2 : m_i \in \mathbb{Z}, \lambda_i \cdot K_l = 2\pi \delta_{il}\}.$$

The Fourier expansions of  $\eta$  and  $\varphi$  are in terms of  $e^{iK\cdot X}$ , where  $K\in\Gamma'$  and  $K\cdot\lambda=2n\pi,\,n\in\mathbb{Z}$ , for  $\lambda\in\Gamma$ . The situation we consider in the further analysis, is with a lattice  $\Gamma'$  generated by the symmetric wave vectors  $K_1=(1,\tau),\,K_2=(1,-\tau)$ . In such a case the functions on  $\mathbb{R}^2/\Gamma$  are  $2\pi$  periodic in  $x_1,\,2\pi/\tau$  periodic in  $x_2$ , and invariant under the shift  $(x_1,x_2)\mapsto (x_1+\pi,x_2+\pi/\tau)$  (and conversely). We define the Fourier coefficients of a bi- periodic function u on such lattice  $\Gamma_\tau$  by

$$\widehat{u}(k) = \frac{\sqrt{\tau}}{2\pi} \int_{[0,2\pi] \times [0,2\pi/\tau]} u(X) \exp(-ik \cdot X) dX.$$

For  $m \geq 0$  we denote by  $H^m(\mathbb{R}^2/\Gamma)$  the Sobolev space of bi-periodic functions of  $X \in \mathbb{R}^2/\Gamma$  which are square integrable on a period, with their partial derivatives up to order m, and we can choose the norm as

$$||u||_m = \left(\sum_{k \in \Gamma'} (1 + |k|)^{2m} |\widehat{u}(k)|^2\right)^{1/2}.$$

**Operator equations.** Now, we reduce the above system for  $(\varphi, \eta)$  to a system of two scalar equations in choosing the new unknown function

$$\psi(X) = \varphi(X, \eta(X)).$$

and we define the Dirichlet-Neumann operator  $\mathcal{G}_{\eta}$  by

$$\mathcal{G}_{\eta}\psi = \sqrt{1 + (\nabla_{X}\eta)^{2}} \frac{d\varphi}{dn} |_{x_{3}=\eta(X)}$$

$$= \frac{\partial \varphi}{\partial x_{3}} |_{x_{3}=\eta(X)} - \nabla_{X}\eta \cdot \nabla_{X}\varphi$$
(1.4)

where n is normal to  $\Sigma$ , exterior to  $\Omega$ , and  $\varphi$  is the solution of the  $\eta-$  dependent Dirichlet problem

$$\begin{array}{rcl} \Delta\varphi & = & 0, & x_3 < \eta(X) \\ \varphi & = & \psi, & x_3 = \eta(X), \\ \nabla\varphi & \to & 0 \text{ as } x_3 \to -\infty. \end{array}$$

Notice that this definition of  $\mathcal{G}_{\eta}$  follows [27] and insures the selfadjointness and positivity of this linear operator in  $L^2(\mathbb{R}^2/\Gamma)$  (see Appendix A.1). Our definition differs from another usual way of defining the Dirichlet - Neumann operator without the square root in factor in (1.4). Now we have the identity(1.4) and the system to solve reads

$$\mathcal{F}(U, \mu, \mathbf{u}) = 0, \quad \mathcal{F} = (\mathcal{F}_1, \mathcal{F}_2),$$
 (1.5)

where  $U = (\psi, \eta)$ , and

$$\mathcal{F}_1(U, \mu, \mathbf{u}) = : \mathcal{G}_n(\psi) - \mathbf{u} \cdot \nabla_X \eta,$$
 (1.6)

$$\mathcal{F}_{2}(U, \mu, \mathbf{u}) = : \mathbf{u} \cdot \nabla_{X} \psi + \mu \eta + \frac{(\nabla \psi)^{2}}{2} +$$

$$-\frac{1}{2(1 + (\nabla_{X} \eta)^{2})} \{ \nabla_{X} \eta \cdot (\nabla_{X} \psi + \mathbf{u}) \}^{2}.$$
(1.7)

Let us define the 2-components function space

$$\mathbb{H}^m(\mathbb{R}^2/\Gamma) = H_0^m(\mathbb{R}^2/\Gamma) \times H^m(\mathbb{R}^2/\Gamma)$$

We denote the norm of U in  $\mathbb{H}^m(\mathbb{R}^2/\Gamma)$  by

$$||U||_m = ||\psi||_{H^m} + ||\eta||_{H^m},$$

where  $H_0^m$  means functions with 0 average, and  $U = (\psi, \eta)$ . The 0 average condition comes from the fact that the value  $\psi$  of the potential is defined up to an additive constant (easily checked in equations (1.6), (1.7)). Moreover, the average of the right hand side of (1.6) is 0 as it can be easily checked (this is proved for instance in [8]). We have the following

**Lemma 1.1** For any fixed  $m \geq 3$ , the mapping

$$(U, \mu, \mathbf{u}) \mapsto \mathcal{F}(U, \mu, \mathbf{u})$$
 is  $C^{\infty} : \mathbb{H}^m(\mathbb{R}^2/\Gamma) \times \mathbb{R} \times \mathbb{S}_1 \to \mathbb{H}^{m-1}(\mathbb{R}^2/\Gamma)$ 

in the neighborhood of  $\{0\} \times \mathbb{R} \times \mathbb{S}_1$ . Moreover  $\mathcal{F}(\cdot, \mu, \mathbf{u})$  is equivariant under translations of the plane:

$$\mathcal{T}_{\mathbf{v}}\mathcal{F}(U,\mu,\mathbf{u}) = \mathcal{F}(\mathcal{T}_{\mathbf{v}}U,\mu,\mathbf{u})$$

where

$$\mathcal{T}_{\mathbf{v}}U(X) = U(X + \mathbf{v}).$$

In addition, there is  $M_3 > 0$ , such that for  $||U||_3 \le M_3$  and  $|\mu| \le M_3$ ,  $\mathcal{F}$  satisfies for any  $m \ge 3$  the "tame" estimate

$$||\mathcal{F}(U,\mu,\mathbf{u})||_{m-1} \le c_m(M_3)||U||_m,$$
 (1.8)

where  $c_m$  only depends on m and  $M_3$ .

**Proof.** The  $C^{\infty}$  smoothness of  $(\psi, \eta) \mapsto \mathcal{G}_{\eta}(\psi) : \mathbb{H}^m(\mathbb{R}^2/\Gamma) \to H^{m-1}(\mathbb{R}^2/\Gamma)$  comes from the study of the Dirichlet-Neumann operator, see (A.1,A.2), and the properties of elliptic operators. This result is proved in particular by Craig and Nicholls in [9], and by D.Lannes in [27]. Notice that  $H^s(\mathbb{R}^2/\Gamma)$  is an algebra for s > 1. Notice that it is proved by Craig et al [10] that the mapping  $(\psi, \eta) \mapsto \mathcal{G}_{\eta}(\psi) : H^m(\mathbb{R}^2/\Gamma) \times C^m(\mathbb{R}^2/\Gamma) \to H^{m-1}(\mathbb{R}^2/\Gamma)$  is analytic and the authors give the explicit Taylor expansion near 0, with the same type of "tame" estimates that we shall use in the following sections. We choose here to stay with  $(\psi, \eta) \in \mathbb{H}^m(\mathbb{R}^2/\Gamma)$  and we just use the  $C^{\infty}$  smoothness of the mapping, in addition to the tame estimates (see [27]).

The equivariance of  $\mathcal F$  under translations of the plane is obvious.

We refer to [27] for the proof of the following "tame" estimate, valid for any  $k \geq 1$  (here simpler than in [27] since we have periodic functions and since there is no bottom wall)

$$||\mathcal{G}_n(\psi)||_k < c_k(||\eta||_3)\{||\eta||_{k+1}||\psi||_3 + ||\psi||_{k+1}\},\tag{1.9}$$

necessary to get estimate (1.8).

#### 1.3 Results

We are now in a position to formulate the main result of this paper on the existence of non-linear diamond waves satisfying operator equation (1.5). We

find an explicit solution to (1.5) in the vicinity of an approximate solution  $U_{\varepsilon}^{(N)}$  which existence is stated in the following lemma restricted to "diamond waves", i.e to solutions belonging to the important subspace (still with  $\Gamma'$  generated by  $(1, \pm \tau)$ )

 $\mathbb{H}^k_{(S)} = \{ U = (\psi, \eta) \in \mathbb{H}^k(\mathbb{R}^2/\Gamma) : \psi \text{ odd in } x_1, \text{ even in } x_2, \ \eta \text{ even in } x_1 \text{ and in } x_2 \}.$ 

For these solutions the unit vector  $\mathbf{u}_0 = (1,0)$  is fixed (see a more general statement at Theorem 2.3, with non necessarily symmetric formal solutions).

**Lemma 1.2** Let  $N \geq 3$  be an arbitrary positive number and the critical value of parameter  $\mu_c(\tau) = (1+\tau^2)^{-1/2}$  is such that the dispersion equation  $n^2 + \tau^2 m^2 = \mu_c^{-2} n^4$  has only the solution (n,m) = (1,1) in the circle  $m^2 + n^2 \leq N^2$ . Then approximate 3-dimensional diamond waves are given by

$$U_{\varepsilon}^{(N)} = (\psi, \eta)_{\varepsilon}^{(N)} = \sum_{1 \le p \le N} \varepsilon^p U^{(p)} \in \mathbb{H}_{(S)}^k, \text{ for any } k, \tag{1.10}$$

$$U^{(1)} = (\sin x_1 \cos \tau x_2, \frac{-1}{\mu_c} \cos x_1 \cos \tau x_2), \quad \mu_{\varepsilon}^{(N)} = \mu_c + \tilde{\mu}, \quad \tilde{\mu} = \mu_1 \varepsilon^2 + O(\varepsilon^4),$$

where

$$\mu_1 = \left(\frac{1}{4\mu_c^3} - \frac{1}{2\mu_c^2} - \frac{3}{4\mu_c} + 2 + \frac{\mu_c}{2} - \frac{9}{4(2-\mu_c)}\right),\,$$

and where for any k,

$$\mathcal{F}(U_{\varepsilon}^{(N)}, \mu_{\varepsilon}^{(N)}, \mathbf{u}_0) = \varepsilon^{N+1} Q_{\varepsilon},$$

 $Q_{\varepsilon}$  uniformly bounded in  $\mathbb{H}^k_{(S)}$ , with respect to  $\varepsilon$ . There is one critical value  $\tau_c$  of  $\tau$  such that  $\mu_1(\tau_c) = 0$ , and  $\mu_1(\tau) < 0$  for  $\tau < \tau_c$ ,  $\mu_1(\tau) > 0$  for  $\tau > \tau_c$ .

**Proof.** The lemma is a particular case of the general Theorem 2.3 in the symmetric case.  $\blacksquare$ 

The following theorem on existence of 3D-diamond waves is the main result of the paper (notice that  $\tau = \tan \theta$ )

**Theorem 1.3** Let us choose arbitrary integers  $l \geq 23$ ,  $N \geq 3$  and a real number  $\delta < 1$ . Assume that

$$\tau \in (\delta, 1/\delta), \quad \mu_c = (1+\tau^2)^{-1/2}.$$

Then there is a set  $\mathfrak{N}$  of full measure in (0,1) with the following property. If  $\mu_c \in \mathfrak{N}$  and  $\tau \neq \tau_c$ , then there exists a positive  $\varepsilon_0 = \varepsilon_0(\mu_c, N, l, \delta)$  and a set  $\mathcal{E} = \mathcal{E}(\mu_c, N, l, \delta)$  so that

$$\lim_{\varepsilon \to 0} \frac{2}{\varepsilon^2} \int_{\mathcal{E} \cap (0,\varepsilon)} s \, ds = 1,$$

and for every  $\mu = \mu_{\varepsilon}^{(N)}$  with  $\varepsilon \in \mathcal{E}$ , equation (1.5) has a "diamond wave" type solution  $U = U_{\varepsilon}^{(N)} + \varepsilon^N W_{\varepsilon}$  with  $W_{\varepsilon} \in \mathbb{H}^l_{(S)}$ . Moreover,  $W : \mathcal{E} \to \mathbb{H}^l_{(S)}$  is a Lipschitz function cancelling at  $\varepsilon = 0$ , and for  $\tau < \tau_c$  (resp.  $\tau > \tau_c$ ), and when  $\varepsilon$  varies in  $\mathcal{E}$ , the parameter  $\mu = \mu_{\varepsilon}^{(N)}$  runs over a measurable set of the interval  $(\mu_{\varepsilon_0}^{(N)}, \mu_c)$  (resp.  $(\mu_c, \mu_{\varepsilon_0}^{(N)})$  of asymptotically full measure near  $\mu_c$ .




Figure 2: Small sectors where 3-dimensional waves bifurcate. Their vertices lie on the critical curve  $\mu = \mu_c(\tau)$ . The good set of points is asymptotically of full measure at the vertex on each half line (see the detail above). In the paper we only give the proof for each half line  $\tau = const$  (dashed line on the figure)

We can roughly express our result in considering the two-dimensional parameter plane  $(\tau,\mu)$  where  $\tau=\tan\theta$ ,  $2\theta$  being the angle between the two basic wave vectors of same length generating the two-dimensional lattice  $\Gamma'$  dual of the lattice  $\Gamma$  of periods for the waves. The critical value  $\mu_c(\tau)$  of  $\mu (= gL/c^2)$ , where  $\mu_c(\tau) = (1+\tau^2)^{-1/2} = \cos\theta$ , corresponds to the solutions of the dispersion relation we consider here (in particular 3-dimensional diamond waves propagating in the direction of the bisectrix of the wave vectors). We show that for  $\tau < \tau_c$  ( $\approx 2.48$ ) the bifurcating (diamond) waves of size  $O(|\mu - \mu_c(\tau)|^{1/2})$  occur for  $\mu < \mu_c(\tau)$ , while for  $\tau > \tau_c$  it occurs for  $\mu > \mu_c(\tau)$ . We prove that bifurcation of these 3-dimensional waves occurs on half lines  $\tau = const$  of the plane, with their origin on the critical curve, for "good" values of  $\tau$  (which appear to be nearly all values of  $\tau$ ). Moreover, we prove that on each half line, these waves exist for "good" values of  $\mu$ , this set of "good" values being asymptotically of full measure at the bifurcation point  $\mu = \mu_c(\tau)$  (see Figure 2).

Another way to describe our result is in terms of a bifurcation from a non isolated eigenvalue in the spectrum of the linearized operator at the origin. Indeed, for our critical values  $(\tau, \mu_c(\tau))$  of the parameter, the differential at the origin is a selfadjoint operator with in general a non isolated 0 eigenvalue (see Theorem 4.1). Our result means that from each point  $(\tau, \mu_c(\tau))$  where  $\tau$  is chosen in a full measure set of  $(0, \infty)$ , a branch of solutions bifurcates in the

following sense. Every half line  $\tau = const$  with origin at the point  $(\tau, \mu_c(\tau))$  and on the good side of this curve, contains a measurable set of points where the bi-periodic gravity waves exist, with an amplitude  $O(|\mu - \mu_c|^{1/2})$ , this set being asymptotically of full measure near  $\mu_c(\tau)$ .

In fact, we can improve our result in replacing the half lines mentioned above, by small sectors centered on these half lines. Each half line in each sector, with origin at the vertex of the sector, contains a measurable set where the bi-periodic gravity waves exist, with an amplitude  $O(|\mu - \mu_c|^{1/2})$ , this set being asymptotically of full measure near  $\mu_c(\tau)$ . The proof of such a result introduces many technicalities, which are not essential for the understanding of the paper. This complication is mainly due to the fact that we then need to work with a lattice  $\Gamma$  now depending on  $\varepsilon$ . We just mention in various places what is really needed for such an extension of the result proved here.

#### 1.4 Mathematical background

There are some aspects of our method which deserve brief mention. First we use the Nash-Moser method, which is now an integral part of nonlinear analysis [12], for proving Theorem 1.3. The crucial point for the Nash-Moser method is to obtain a priori bounds on an approximate right-inverse of the partial derivative  $\partial_U \mathcal{F}(U,\mu,\mathbf{u})$ . As it is shown in Section 2, this problem is equivalent to the problem of invertibility of a second-order selfadjoint pseudodifferential operator with multiple characteristics. Second, we use the Moser theory of foliation on a torus [29] and the invariant parametric representation of the Dirichlet-Neumann operator to reduce the linearized equation to a canonical form with constant coefficients in the principal part. We employ a modification of the Weil Theorem [43] on uniform distribution of numbers  $\{\omega n^2\}$  modulo 1 to deduce the effective estimates of small divisors, and hence to prove the invertibility of the principal part of the linearized operator. The most essential ingredient of our approach is the algebraic descent method [24], [35] which allows to reduce the canonical pseudodifferential equation on 2-dimensional torus to a Fredholm-type equation.

#### 1.5 Structure of the paper

Now we can explain the organization of the paper. In section 2, we prove Theorem 2.3 which establishes the existence of approximate solutions under the form of power series of the amplitudes of the two incident mono-periodic travelling waves, corresponding to symmetric basic wave vectors. The parameter is two-dimensional here, due to the freedom in the direction of propagation of the three-dimensional wave. To show this result, we use a formal Lyapunov-Schmidt technique, assuming that the angle  $2\theta$  between the two basic wave vectors satisfies that  $\tau = \tan \theta$  is such that the equation for positive integers (n, m)

$$n^2 + \tau^2 m^2 = n^4 (1 + \tau^2)$$

has the unique solution (n,m)=(1,1) (non resonance property). In playing with scales and parameters, this condition is not restrictive among non resonant situations, which indeed represent the general case. In such a case, the kernel of the linearized operator at rest state (taken as the origin) is four-dimensional, and in using extensively the symmetries of the system (1.5), we obtain, for a fixed value of the bifurcation parameter  $(\mu, \mathbf{u})$ , doubly-periodic formal travelling gravity waves propagating in the direction  $\mathbf{u}$ . Limiting cases are the monoperiodic travelling waves corresponding to one of the basic wave vectors. The Lemma 1.2 is a particular case of the above theorem.

From now on, we restrict the study to solutions called "diamond waves", which are symmetric with respect to the direction of propagation, here the  $x_1$ -axis. In section 3 we consider the linear operator  $\mathcal{L}(U,\mu)$  corresponding to the differential of (1.5) at a non zero point in  $\mathbb{H}^k_{(S)}$ , which we need to invert for using the Nash-Moser theorem. The principal part of this operator is the symmetric sum

$$-\mathcal{J}^*(\frac{1}{\mathfrak{a}}\mathcal{J}\cdot)+\mathcal{G}_{\eta}, \quad \mathcal{J}=V\cdot 
abla,$$

of a second order derivative in the direction of a periodic vector field V(X), and of the Dirichlet-Neumann operator which is integro-differential of first order, both parts depending periodically on coordinates. More precisely,  $V = \mathbb{G}^{-1}(X)(\mathbf{u}_0 + \nabla \psi(X))$ , where  $\mathbb{G}(X) dX \cdot dX$  is the first fundamental form of the free surface. Recall that  $\mathbb{G}$  is a covariant tensor field on  $\Sigma$ , and for the standard parametrization  $x_3 = \eta(X)$ , it is given by  $\mathbb{G}(X) = 1 + \nabla \eta \otimes \nabla \eta$ . It follows from the kinematic condition (1.2) that integral curves of the vector field V(X) coincide with trajectories of liquid particles moving along  $\Sigma$  and submitted to the vertical gravity  $\mu$ .

Section 3 is concerned with the first step of the long way towards the inversion of  $\mathcal{L}$ , which consists in finding a diffeomorphism of the torus for which the highest order terms of the operator  $\mathcal{L}$  become constants (depending on the linearization point). We begin (Lemma 3.6) with the construction of a diffeomorphism which takes integral curves of the vector field V onto straight lines parallel to the abscissa axis. Being endowed with the Jacobi metric  $ds^2 = (1/2 - \mu \eta(X)) \mathbb{G}(X) dX \cdot dX$  the free surface becomes a Riemannian manifold on which the integral curves of V coincide with geodesics (see Appendix I). Hence, by Lemma 3.6, they form a geodesic foliation on  $\Sigma$ . Moreover, since the distance between each of these curves and the abscissa axis is finite, the foliation has a zero rotation number. It is at this point where the restriction to symmetric solutions (diamond waves) is necessary, since we don't know yet how to manage such a diffeomorphism in the non symmetric case, see [29] for discussion. Recall that the Moser Theorem [29] guarantees the existence of at least one geodesic for any given rotation number.

The second result of Section 3 is Theorem 3.5 which gives the parametric representation of the Dirichlet-Neumann operator in arbitrary coordinates Y on  $\Sigma$  so that a mapping X = X(Y) is a diffeomorphism of a torus. It follows from this theorem that for any smooth periodic function u(Y) and  $\check{u}(X) = u(Y(X), Y(X))$ 

the Dirichlet-Neumann operator has the decomposition

$$\mathcal{G}_{\eta}\check{u} = \check{\mathcal{G}_{1}}u + \check{\mathcal{G}_{0}}u + \check{\mathcal{G}_{-1}}u,$$

in which  $\mathcal{G}_i$  are pseudodifferential operators of order i. We give an explicit expression for their symbols in terms of the first fundamental form and the principal curvatures of the free surface. In particular, we show that, up to a positive invariant multiplier, the symbol of the operator  $\mathcal{G}_1$  is equal to  $\sqrt{\mathbb{G}(Y)^{-1}k \cdot k}$ , and the real part of the symbol of  $\mathcal{G}_0$  coincides with the difference between the sum of the principal curvatures and the normal curvature of  $\Sigma$  in the direction of  $\mathbb{G}^{-1}k$ . This leads to the interesting conclusion: the manifold  $\Sigma$  is defined by its Dirichlet-Neumann operator up to translation and rotation of the embedding space.

Combining Lemma 3.6 and Theorem 3.5 gives the main result of Section 3 – Theorem 3.4. This theorem ensures the existence of a diffeomorphism X=X(Y) of the 2-dimensional torus, which brings the linearized operator to the canonical form

$$\mathfrak{L} + \mathfrak{H} = \mathfrak{L} + \mathfrak{A}\partial_{y_1} + \mathfrak{B} + \mathfrak{L}_{-1},$$

where the remainder  $\mathfrak{L}_{-1}$  is of order -1,  $\mathfrak{A}$  and  $\mathfrak{B}$  are zero-order pseudodifferential operators, and the principal part

$$\mathfrak{L} = \nu \partial_{y_1}^2 + (-\Delta)^{1/2}, \quad \Delta = \partial_{y_1}^2 + \tau^2 \partial_{y_2}^2$$

is a selfadjoint pseudodifferential operator. Here the parameter  $\nu$  depends on the point of linearization, with  $\nu(0) = \nu_0 = \mu_c(\tau)^{-1}$  (Lemma 3.7).

In Section 4 we study the operator  $\mathfrak L$  in many details, and give estimates on its resolvent in Sobolev spaces of bi-periodic functions which are odd in  $y_1$ , and even in  $y_2$ . We begin with the observation that for  $\nu_0 = \mu_c(\tau)^{-1}$  and almost every positive  $\tau$ , zero is a simple eigenvalue of the operator  $\mathfrak L_0 = \nu_0 \partial_{y_1}^2 + (-\Delta)^{1/2}$  and

$$\|\mathfrak{L}_0^{-1}u\|_s \le c(\tau,\alpha)\|u\|_{s+(1+\alpha)/2}$$

for all u orthogonal to the kernel of  $\mathfrak{L}_0$  and  $\alpha > 0$ . Next we study the perturbation of its resolvent assuming that  $\nu = \nu_0 - \varepsilon^2 \nu_1 + O(\varepsilon^3)$  and with a spectral parameter  $\varkappa = O(\varepsilon^2)$ , both being Lipschitz functions of a small parameter  $\varepsilon$ . Here we have a *small divisor* problem, and we meet the necessity to restrict the parameter values to "good ones", for being able to find suitable estimates. Calculations (Lemma 4.5) show that the resolvent of  $\mathfrak L$  satisfies the estimate

$$\|(\mathfrak{L} - \varkappa)^{-1}u\|_{s} \le c\|u\|_{s+1}, \quad u \in (\ker \mathfrak{L}_{0})^{\perp},$$
 (1.11)

if parameters  $\nu$  and  $\varkappa$  satisfy the quadratic Diophantine inequalities

$$|\omega n^2 - m - C| \ge cn^{-2}$$
 for all positive integers  $n, m,$  (1.12)

where  $\omega = \nu \tau^{-1}$  and  $C = (2\nu\tau)^{-1} - \varkappa \tau^{-1}$ . Note that there is a difference between linear and polynomial Diophantine approximations: in classic theory

of linear Diophantine forms, see [6] for general theory, the integers for which "small divisors" are really small, form a sparse set in the integral lattice. This property was used in pioneering works of Siegel [38] and in the Arnold proof of the Kolmogorov Theorem [2]. In contrast to the linear case, the couples (m, n), for which the left hand side of inequality (1.12) is small, can form clusters in  $\mathbb{Z}^2$ , and the problem of obtaining small divisors estimates becomes more complicated. It turns out that the validity of inequalities (1.12) with a constant c independent of the small parameter is a consequence of estimate

$$N^{-1} \operatorname{card} \{n : \omega_0 n^2 \text{ modulo } 1 \le \varepsilon \text{ and } 1 \le n \le N\} \le c\varepsilon \text{ for all } N \ge \varepsilon^{-\lambda}.$$
(1.13)

Recall that, by the Weil Theorem [43], [6], for each fixed  $\varepsilon$ , the left hand side tends to  $\varepsilon$  as  $N \to \infty$ . Hence the inequality holds true for some c depending on  $\varepsilon$ . In Appendix E we make this result more precise and prove the existence of absolute constant c such that inequality (1.13) is fulfilled for all  $\lambda \geq 78$  and all intervals of length  $\varepsilon$ . This leads to the main result of this section – Theorem 4.2, which shows that with a suitable choice of the parameters, the resolvent operator provides a loss of one in the degree of differentiability. Moreover, estimate (1.11) holds true for all  $\varepsilon^2$  in an asymptotically full measure set on every half line  $\theta = const$  of the parameter plane, the origin of which being chosen arbitrarily in a full measure set, on the bifurcation curve  $\mu = \cos \theta$ .

In Section 5 we take into account all remaining terms of the linear operator  $\mathfrak{L} + \mathfrak{H}$  and prove its invertibility with a loss of differentiability. The main difficulty is that the operator  $\mathfrak{L} + \mathfrak{H}$  involves the principal part  $\mathfrak{L}$ , which inverse is unbounded, and arbitrary operators  $\mathfrak{A}$ ,  $\mathfrak{B}$  with "variable coefficients".

Most, if not all, existing results related to such problems were obtained by use of the Fröhlich-Spencer method proposed in [15], cf [32, 34], and developed by Craig and Wayne [11, 7] and Bourgain [3, 4]. The basic idea of the method is a representation of operators in the form of infinite matrices with elements labelled by some lattice and block decompositions of this lattice. Let us use the operator  $\mathcal{L} + \mathfrak{H}$  to illustrate the main features of this method. First we have to replace a periodic function u by the sequence of its Fourier coefficients  $\{\hat{u}(k)\}\$ ,  $k \in \Gamma'$ , and the operator  $\mathfrak{L}$  by the diagonal matrix with the elements L(k). Then we have to split the lattice  $\Gamma'$  into a "regular" part which consists of all k with "large" L(k), and an "irregular" part which includes all k corresponding to "small" values of L(k). Using the contraction mapping principle we can eliminate the "regular" component and reduce the inversion of  $\mathcal{L} + \mathfrak{H}$  to the inversion of an infinite matrix on the "irregular" subspace. The existence of an inverse to this matrix is established by using a special iteration process which is the core of the method. Note that the Fröhlich-Spencer method is working in our case only if  $\mathfrak{A}=0$ .

Our approach is based on the descent method which was proposed in [35, 24] and dates back to the classic Floquet-Lyapunov theory. The descent method is a pure algebraic procedure which brings the canonical operator to an operator with constant coefficients and does not depend on the structure and spectral properties of the principal part  $\mathfrak{L}$ . The heart of the method is the following

identity (Theorem 5.2)

$$(\mathfrak{L} + \mathfrak{A}\mathfrak{D}_1 + \mathfrak{B})(1 + \mathfrak{C})u = (1 + \mathfrak{E})(\mathfrak{L} - \varkappa)u + \mathfrak{F}u,$$

which holds true for all functions  $u \in H^2(\mathbb{R}^2/\Gamma)$  odd in  $y_1$ . Here  $\mathfrak{C}$  and  $\mathfrak{E}$  are bounded operators in the Sobolev spaces of periodic functions  $H^s(\mathbb{R}^2/\Gamma)$ ; the remainder  $\mathfrak{F}$  is a bounded operator :  $H^{s-1}(\mathbb{R}^2/\Gamma) \mapsto H^s(\mathbb{R}^2/\Gamma)$ ; the Floquet exponent  $\varkappa$  has an explicit expression in terms of operators  $\mathfrak{A}$  and  $\mathfrak{B}$ . Moreover, if  $\|\mathfrak{A}\|, \|\mathfrak{B}\| \sim \varepsilon$ , then  $\|\mathfrak{C}\|, \|\mathfrak{E}\|, \|\mathfrak{F}\| \sim \varepsilon$  and  $\varkappa = O(\varepsilon^2)$ . The proof of these results constitutes Section 5.1 and Appendix F. The technique used is more general than the one used in [24], since we use here general properties of pseudodifferential operators, however taking into account of the symmetry properties of  $\mathcal{L}$ .

The descent method of algebraic character presented here, might be easily used for example on the one-dimensional KDV and Schrödinger equations, avoiding the heavy technicalities of the Fröhlich-Spencer method.

Thus we reduce the problem of the inversion of the canonical operator  $\mathfrak{L}+\mathfrak{H}$  to the problem of the inversion of operator  $\mathfrak{L}-\varkappa+\tilde{\mathfrak{L}}_{-1}$ , where  $\tilde{\mathfrak{L}}_{-1}$  is a smoothing remainder. It is then possible to use the result of section 4 for inverting the full operator and to prove Theorem 5.1 – the main result on the existence and estimates of  $(\mathfrak{L}+\mathfrak{H})^{-1}$ . In particular, this theorem implies that if  $\mathfrak{A}$  and  $\mathfrak{B}$  are Lipschitz operator-valued functions of a small parameter  $\varepsilon$ , which vanish for  $\varepsilon=0$  and satisfy symmetry and metric conditions (Section 5), and if  $\mathfrak{L}-\varkappa$  meets all requirements of Theorem 4.2, then for all  $\varepsilon^2$  taken in an asymptotically full measure set, the resolvent has the representation

$$(\mathfrak{L}+\mathfrak{H})^{-1}(\varepsilon)=\frac{1}{\mathfrak{c}}\mathfrak{H}_0(\varepsilon)+\mathfrak{H}_1(\varepsilon),$$

in which operators  $\mathfrak{H}_1(\varepsilon): H^s(\mathbb{R}^2/\Gamma) \mapsto H^{s-1}(\mathbb{R}^2/\Gamma)$  are uniformly bounded in  $\varepsilon$ , and  $\mathfrak{H}_0(\varepsilon)$  are bounded operators of rank 1, the coefficient  $\mathfrak{c} = \varepsilon^2 @ + O(\varepsilon^3)$  being given by (5.9). We show at the end of the section (see Theorem 5.9), that the results apply to the linear operator  $\mathcal{L}(U,\mu)$  corresponding to the differential of (1.5) at a non zero point in  $\mathbb{H}^k_{(S)}$ . In particular, we give the sufficient conditions which provide the existence of the bounded inverse  $\mathcal{L}(U,\mu)^{-1}: H^{s+3}(\mathbb{R}/\Gamma) \mapsto H^s(\mathbb{R}/\Gamma)$ .

Section 6 applies extensively the result proved in [24] concerning the Nash-Moser theorem with parameters in a Cantor set. The main result, which is the main result of the paper is Theorem 1.3 establishing the existence of smooth bi-periodic travelling gravity waves symmetric with respect to the direction of propagation, in the region of the parameter space mentioned above. Notice that, a part from the last section, which heavily rests upon the self contained Appendix N of [24], the rest of the paper is self contained, with some details of computations and basics on pseudodifferential operators put in Appendix, for providing an easy reading.

#### 2 Formal solutions

#### 2.1 Differential of $\mathcal{G}_n$

In this subsection we study the structure of the operator  $\mathcal{G}_{\eta}$ , and we give useful formulas and estimates.

The following regularity property holds

**Lemma 2.1** The differential  $h \mapsto \partial_{\eta} \mathcal{G}_{\eta}[h]$  of  $G_{\eta}$  satisfies for  $\eta$ ,  $\psi$ , h smooth enough bi-periodic functions

$$\partial_{\eta} \mathcal{G}_{\eta}[h]\psi = -\mathcal{G}_{\eta}(h\zeta) + \nabla_{X} \cdot \{(\zeta \nabla_{X} \eta - \nabla_{X} \psi)h\}, \tag{2.1}$$

$$\zeta = \frac{1}{1 + (\nabla_X \eta)^2} \{ \mathcal{G}_{\eta} \psi + \nabla_X \eta \cdot \nabla_X \psi \}. \tag{2.2}$$

Moreover, despite of the apparent loss of derivatives for  $(\psi, \eta)$  in (2.1,2.2) we have for  $||U||_3 \leq M_3$ , the following tame estimate

$$||\partial_{\eta}\mathcal{G}_{\eta}[h]\psi||_{k} \leq c_{k}(M_{3})\{||h||_{k+1} + ||U||_{k+1}||h||_{2}\}.$$

**Proof.** We refer to Appendix A.1 for the formula (2.1,2.2) already proved for instance in [27], and we also refer to [27] for the tame estimate.

From the formulas of the above Lemma 2.1, we are now able to compute successive derivatives of  $\mathcal{F}$ . Observe that in (2.1,2.2) there is a loss of two derivatives for  $(\psi, \eta)$ . In fact there is a compensation cancelling the dependence into the second order derivatives and we have the following Lemma which completes Lemma 1.1:

**Lemma 2.2** For  $||U||_3 \le M_3$ , and  $|\mu| \le M_3$  the following tame estimates hold (and analogous ones for higher order derivatives)

$$\begin{split} ||\partial_{U}\mathcal{F}(U,\mu,\mathbf{u})[\delta U]||_{k} & \leq c_{k}(M_{3})\{||\delta U||_{k+1} + ||U||_{k+1}||\delta U||_{3}\}, \\ ||\partial_{UU}^{2}\mathcal{F}(U,\mu,\mathbf{u})[\delta U_{1},\delta U_{2}]||_{k} & \leq c_{k}(M_{3})\{||\delta U_{1}||_{k+1}||\delta U_{2}||_{3} + \\ & + ||\delta U_{2}||_{k+1}||\delta U_{1}||_{3} + ||U||_{k+1}||\delta U_{1}||_{3}||\delta U_{2}||_{3}\}. \end{split}$$

### 2.2 Linearized equations at the origin and dispersion relation

The linearization at the origin of system (1.6), (1.7) leads to

$$\mathcal{G}^{(0)}(\psi) - \mathbf{u} \cdot \nabla_X \eta = 0, \tag{2.3}$$

$$\mathbf{u} \cdot \nabla_X \psi + \mu \eta = 0, \tag{2.4}$$

where the following operator

$$\mathcal{G}^{(0)} = (-\Delta)^{1/2}$$

is defined more precisely in Appendix A.2. Now expanding in Fourier series, we have

$$\psi(X) = \sum_{K \in \Gamma'} \psi_K e^{iK \cdot X}, \quad \eta(X) = \sum_{K \in \Gamma'} \eta_K e^{iK \cdot X},$$

and (2.3), (2.4) give for any  $K \in \Gamma'$ 

$$|K|\psi_K - i(K \cdot \mathbf{u})\eta_K = 0,$$
  
$$i(K \cdot \mathbf{u})\psi_K + \mu\eta_K = 0.$$

Hence, the dispersion relation reads

$$\Delta(K, \mu, \mathbf{u}) \stackrel{def}{=} \mu |K| - (K \cdot \mathbf{u})^2 = 0.$$
 (2.5)

The point now to discuss is the number of solutions  $K \in \Gamma'$  of (2.5), for a fixed vector  $\mathbf{u} \in \mathbb{S}_1$ , and a fixed parameter  $\mu$ . We restrict our analysis to a lattice  $\Gamma'$  generated by two vectors  $K_1$  and  $K_2$  symmetric with respect to the  $x_1$ - axis, taken in the direction of  $\mathbf{u}$ , which is the situation if one is looking for short crested waves:

$$K_1 = (1, \tau), \quad K_2 = (1, -\tau)$$

where  $\tau$  is positive. When  $\tau$  is small, the lattice  $\Gamma$  of periods is formed with diamonds elongated in the  $x_2$  direction (see Figure 1). Taking 1 for the first component of  $K_1$  implies that we choose the length scale L as the wave length in the  $x_1$ - direction divided by  $2\pi$ .

We consider in what follows, the cases when the direction  $\mathbf{u}_0$  of the travelling waves at criticality is the  $x_1$  – axis, and the critical parameter  $\mu_c = (1+\tau^2)^{-1/2}$  is such that the equation for  $(m_1, m_2) \in \mathbb{N}^2$ 

$$\mu_c \sqrt{m_1^2 + \tau^2 m_2^2} - m_1^2 = 0 (2.6)$$

has only the solution

$$(m_1, m_2) = (1, 1).$$

In case we have a solution  $(m_1, m_2) \neq (1, 1)$ , one can make the change  $(\mu_c, \tau) \mapsto (\frac{\mu_0}{m_1}, \tau \frac{m_2}{m_1})$  to recover the case we study here. Moreover, changing  $\mu$  into  $\mu/m_1$  corresponds to changing the length scale L into  $L/m_1$  which indeed corresponds to the new wave length in the  $x_1$  direction. So, it is clear that we do not restrict the generality in choosing the case of a solution  $(m_1, m_2) = (1, 1)$ .

Notice that for any integer l, when  $\tau = l$  or 1/l, there is an infinite number of solutions  $(m_1, m_2)$  of (2.6), hence we need to avoid such choices for  $\tau$ .

**Remark.** We notice here the fundamental difference between the present type of study and the works using spatial dynamics for finding travelling waves, as for instance Groves and Haragus in [18]. Their study only consider cases with surface tension, and cannot work without surface tension, since this would lead to an infinite set of imaginary eigenvalues  $\pm im_1$  (hence preventing the use of center manifold reduction), with no restriction for  $m_1$  to be an integer, while  $m_2 \in \mathbb{N}$  (this corresponds to fixing the length scale with the period in  $x_2$ , transverse to the direction of the travelling waves.

## 2.3 Formal computation of 3-dimensional waves in the simple case

In this subsection we make a formal bifurcation analysis for the simple case. We denote by  $\mu_c$  the critical value of  $\mu$ , and we denote by  $\mathbf{u}_0 = (1,0)$  the critical direction for the waves (this direction of propagation may be changed for bifurcating travelling waves). The lattice  $\Gamma'$  is generated by the two symmetric wave vectors  $K_1 = (1, \tau)$ ,  $K_2 = (1, -\tau)$ , where

$$\mu_c^{-2} = 1 + \tau^2$$
.

We notice that we have the following Fourier series for  $U=(\psi,\eta)$ :

$$U = \sum_{n=(n_1,n_2)\in\mathbb{Z}^2} U_n e^{i(n_1 K_1 \cdot X + n_2 K_2 \cdot X)}, \quad U_n = (\psi_n, \eta_n), \quad \psi_0 = 0,$$

and we notice that

$$n_1K_1 \cdot X + n_2K_2 \cdot X = m_1x_1 + \tau m_2x_2,$$
  
 $m_1 = n_1 + n_2, m_2 = n_1 - n_2,$ 

which gives functions which are  $2\pi$  – periodic in  $x_1$  and  $2\pi/\tau$  – periodic in  $x_2$ .

We already noticed the equivariance of system (1.6), (1.7) with respect to translations of the plane, represented by the linear operator  $\mathcal{T}_{\mathbf{v}}$ ,  $\mathbf{v}$  being any vector of the plane. Let us complete the symmetry properties of our system by the symmetries  $\mathcal{S}_0$  and  $\mathcal{S}_1$  defined by the representations of respectively the symmetry with respect to 0, and the symmetry with respect to  $x_1$  axis

$$S_0 U = \sum_{n=(n_1,n_2)\in\mathbb{Z}^2} (SU_n) e^{-i(n_1 K_1 \cdot X + n_2 K_2 \cdot X)}, \quad SU_n = (-\psi_n, \eta_n), (2.7)$$

$$S_1 U = \sum_{n=(n_1, n_2) \in \mathbb{Z}^2} U_n e^{i(n_1 K_2 \cdot X + n_2 K_1 \cdot X)}. \tag{2.8}$$

The system (1.6), (1.7) is equivariant, under the symmetry  $S_0$  in all cases, while it is equivariant under  $S_1$  only if

$$\mathbf{u} \cdot K_1 = \mathbf{u} \cdot K_2$$
.

In particular, in such a case we have

$$\mathcal{L}_0 \mathcal{S}_1 = \mathcal{S}_1 \mathcal{L}_0, \quad \mathcal{L}_0 \mathcal{S}_0 = \mathcal{S}_0 \mathcal{L}_0,$$

where we denote by  $\mathcal{L}_0$  the symmetric linearized operator for  $\mu = \mu_c$  and  $\mathbf{u} = \mathbf{u}_0$ 

$$\mathcal{L}_0 = \begin{pmatrix} \mathcal{G}^{(0)} & -\mathbf{u}_0 \cdot \nabla \\ \mathbf{u}_0 \cdot \nabla & \mu_c \end{pmatrix}. \tag{2.9}$$

Notice that the commutation property with the linear operator  $S_0$  is not trivial since the choice of writing our system in the moving frame selects the direction

**u** which breaks a reflection symmetry. Indeed the symmetry property results from the galilean invariance of the Euler equations.

In the following Lemma, we use the two parameters  $\tilde{\mu} = \mu - \mu_c$  and  $\omega = \mathbf{u} - \mathbf{u}_0$  and we notice that, since  $\mathbf{u}$  is unitary, we have

$$\omega = (\omega_1, \omega_2),$$

$$\omega_2 = \frac{1}{2\tau}\omega \cdot (K_1 - K_2),$$

$$\omega_1 = -\frac{\omega_2^2}{2} + O(\omega_2^4).$$

In the following subsections we prove the following

**Theorem 2.3** Assume we are in the simple case, i.e. for  $\tau$  and the critical value of the parameter  $\mu_c(\tau) = (1 + \tau^2)^{-1/2} < 1$  such that the equation  $n^2 + \tau^2 m^2 = \mu_c^{-2} n^4$  has only the solution (n, m) = (1, 1) in  $\mathbb{N}^2$ . Then, for any  $N \geq 1$ , and any  $\mathbf{v} \in \mathbb{R}^2$ , approximate 3-dimensional waves are given by  $\mathcal{T}_{\mathbf{v}} U_{\varepsilon}^{(N)} (T^2 - torus family of solutions)$  where  $K_1 = (1, \tau)$ ,  $K_2 = (1, -\tau)$  are the wave vectors, and

$$\begin{split} U_{\varepsilon}^{(N)} &= (\psi, \eta)_{\varepsilon}^{(N)} = \sum_{(p_1, p_2) \in \mathbb{N}^2, \ p_1 + p_2 \le N} \varepsilon_1^{p_1} \varepsilon_2^{p_2} U^{(p_1, p_2)} \in \mathbb{H}^k, \ \text{for any } k, \\ U^{(1,0)} &= \xi_1 = (\sin(K_1 \cdot X), \frac{-1}{\mu_c} \cos(K_1 \cdot X)), \\ U^{(0,1)} &= \xi_2 = (\sin(K_2 \cdot X), \frac{-1}{\mu_c} \cos(K_2 \cdot X)), \end{split}$$

$$U^{(2,0)} = \left(\frac{-1}{2\mu_c^2}\sin(2K_1 \cdot X), \frac{1}{2\mu_c^3}\cos(2K_1 \cdot X)\right),$$

$$U^{(0,2)} = \left(\frac{-1}{2\mu_c^2}\sin(2K_2 \cdot X), \frac{1}{2\mu_c^3}\cos(2K_2 \cdot X)\right),$$

$$U^{(1,1)} = \left(\frac{1 - 2\mu_c}{\mu_c(2 - \mu_c)}\sin((K_1 + K_2) \cdot X), \frac{\mu_c^2 + 2\mu_c - 2}{\mu_c^2(2 - \mu_c)}\cos((K_1 + K_2) \cdot X)\right) + \left(0, \frac{\tau^2}{\mu_c}\cos((K_1 - K_2) \cdot X)\right),$$

$$\tilde{\mu} = -\frac{\mu_c^2}{8}(\alpha_0 + \beta_0)(\varepsilon_1^2 + \varepsilon_2^2) + O\{(\varepsilon_1^2 + \varepsilon_2^2)^2\},$$

$$\omega \cdot (K_1 - K_2) = (\varepsilon_1^2 - \varepsilon_2^2) \left(\frac{\mu_c}{8}(\alpha_0 - \beta_0) + O\{(\varepsilon_1^2 + \varepsilon_2^2)\}\right),$$

with

$$\alpha_0 + \beta_0 = \frac{4}{\mu_c^2} \left( -\frac{1}{\mu_c^3} + \frac{2}{\mu_c^2} + \frac{3}{\mu_c} - 8 - 2\mu_c + \frac{9}{2 - \mu_c} \right)$$

$$\beta_0 - \alpha_0 = \frac{4}{\mu_c^2} \left( -\frac{3}{\mu_c^3} + \frac{2}{\mu_c^2} + \frac{3}{\mu_c} - 8 - 2\mu_c + \frac{9}{2 - \mu_c} \right),$$

and where for any N and k

$$\mathcal{F}(U_{\varepsilon}^{(N)}, \mu_c + \tilde{\mu}, \mathbf{u}_0 + \omega) = (\varepsilon_1^2 + \varepsilon_2^2)^{\frac{N+1}{2}} Q_{\varepsilon},$$

 $Q_{\varepsilon}$  uniformly bounded in  $\mathbb{H}^k$ , with respect to  $\varepsilon_1, \varepsilon_2$ . There are critical values  $\tau_c$  and  $\tau'_c$  of  $\tau$  such that  $(\alpha_0 + \beta_0)(\tau_c) = 0$ , and  $(\alpha_0 - \beta_0)(\tau'_c) = 0$ , and  $\alpha_0 + \beta_0$  is positive for  $\tau \in (0, \tau_c)$ , negative for  $\tau > \tau_c$ ,  $\tau_c \approx 2.48$ , while  $\alpha_0 - \beta_0$  is negative for  $\tau \in (0, \tau'_c)$ , positive for  $\tau > \tau'_c$ ,  $\tau'_c \approx 0.504$ . Moreover, for  $\varepsilon_1 = \varepsilon_2$  we have "diamond waves" where the direction of propagation  $\mathbf{u}$  is along the  $x_1$ -axis; and for  $\varepsilon_2 = 0$  (resp.  $\varepsilon_1 = 0$ ) we obtain 2-dimensional travelling waves of wave vector  $K_1$  (resp.  $K_2$ ). All solutions are invariant under the shift  $\mathcal{T}_{\mathbf{v}_0}$ :  $X \mapsto X + (\pi, \pi/\tau)$  and  $\psi^{(N)}_{\varepsilon}$  is odd in X, while  $\eta^{(N)}_{\varepsilon}$  is even in X.

Remark 1: In this lemma we assume that equation (2.6) for  $(m_1, m_2) \in \mathbb{Z}^2$  has only the four solutions  $(m_1, m_2) = (\pm 1, \pm 1)$ , corresponding to the four wave vectors  $K = \pm K_1$  and  $\pm K_2$ . The corresponding pattern of the waves for  $\varepsilon_1 = \varepsilon_2$  is in diamond form, and for  $\tau$  close to 0, the diamonds are flattened in the  $x_1$  direction, and elongated in  $x_2$  direction, looking like flattened hexagons or flattened rectangles, because of the elongated shape of crests and troughs. This last case is indeed observed experimentally for deep fluid layers. Nearly all (in the measure sense) values of  $\tau$  are indeed such that we are in the simple case.

**Remark 2**: The above Lemma is stated differently in Theorem 4.1 of [8]; indeed we prove here that the manifold of solutions has a simple formulation in terms of the two parameters.

Remark 3: Since  $\mu = gL/c^2$ , the result of Theorem 2.3 about the sign of  $\alpha_0 + \beta_0$  shows that for  $\tau < \tau_c$  the bifurcation of "diamond waves" (i.e.  $\omega = 0$ ) occurs for a velocity c of the waves larger than the critical velocity  $c_0$  corresponding to  $\mu_c$ , while for  $\tau > \tau_c$  the bifurcation occurs for  $c < c_0$ . This is in accordance with the numerical results of Bridges et al [5] (see p. 166-167 with  $A_1 = A_2$  real,  $T_{10} = 1, \tau = 0$  (no surface tension)). Notice that  $\tau_c^2 \approx 6.15$ , i.e. this corresponds to a critical angle  $\theta$  between the wave number  $K_1$  and the direction of the travelling wave, such that  $\theta \approx 68^0$ , which is very large, and not easy to reach experimentally.

**Remark 4:** Notice that for  $\tau$  near  $\tau'_c$  we still have "diamond waves' (even for  $\tau = \tau'_c$ ) and it may exist other bifurcating 3-dimensional waves, as noticed in [5]. However to confirm this, we need to compute at least coefficients of order 4 in (B.5).

**Proof**: the proof is made in Appendix B.

#### 2.4 Geometric pattern of diamond waves

Diamond waves are obtained for  $\varepsilon_1 = \varepsilon_2$ , they propagate along the  $x_1$  – axis, and possess the symmetry  $S_1$ . In making  $\varepsilon_1 = \varepsilon_2 = \varepsilon/2$  in Lemma 2.3 we obtain

$$U_{\varepsilon}^{(N)} = (\psi, \eta)_{\varepsilon}^{(N)} = \sum_{n \in \mathbb{N}, \ n \le N} \varepsilon^{n} U^{(n)} \in \mathbb{H}^{k}, \text{ for any } k,$$

$$U^{(1)} = \xi_{0} = (\sin x_{1} \cos \tau x_{2}, -\frac{1}{\mu_{c}} \cos x_{1} \cos \tau x_{2}),$$

$$U^{(2)} = \frac{1}{4} (U^{(2,0)} + U^{(0,2)} + U^{(1,1)}),$$
(2.10)

where  $\psi_{\varepsilon}^{(N)} \in H_{o,e}^k, \eta_{\varepsilon}^{(N)} \in H_{e,e}^k$  meaning that  $\psi_{\varepsilon}^{(N)}$  is odd in  $x_1$ , even in  $x_2$ , and  $\eta_{\varepsilon}^{(N)}$  is even in both coordinates. Moreover, we have

$$\mu - \mu_c = \tilde{\mu} = \varepsilon^2 \mu_1 + O(\varepsilon^4)$$

with

$$\mu_c = (1+\tau^2)^{-1/2},$$

$$\mu_1 = -\frac{\mu_c^2}{16}(\alpha_0 + \beta_0)$$

$$= \frac{1}{4\mu_c^3} - \frac{1}{2\mu_c^2} - \frac{3}{4\mu_c} + 2 + \frac{\mu_c}{2} - \frac{9}{4(2-\mu_c)}.$$
(2.11)

For  $\tau$  close to 0 (corresponds to some of the experiments shown in [20]), one has

$$\eta = \tilde{\varepsilon}\cos x_1\cos \tau x_2 + \frac{\tilde{\varepsilon}^2}{4}\cos 2x_1(1+\cos 2\tau x_2) + O(\tilde{\varepsilon}^2\tau^2 + |\tilde{\varepsilon}|^3)$$

with

$$\tilde{\varepsilon} = -\varepsilon/\mu_c \sim -\varepsilon$$
.

One can assume that  $\tilde{\varepsilon} > 0$  since  $\tilde{\varepsilon} < 0$  would correspond to a shift by  $\pi$  of  $x_1$ . Then the above formula shows that crests (maxima) and troughs (minima) are elongated in the  $x_2$  direction, with crests sharper than the troughs, and there are "nodal" lines ( $\eta \approx 0$ ) (as noticed in experiments [20]) at

$$x_2 = \pi/2\tau + n\pi/\tau, \quad n \in \mathbb{Z},$$

where  $\eta$  is of order  $O(\tilde{\varepsilon}^2 \tau^2 + |\tilde{\varepsilon}|^3)$ . So, the pattern roughly looks asymptotically like rectangles elongated in  $x_2$  direction, narrow around the crests, wide around the troughs, organized in staggered rows. Notice that when  $\tau \to 0$ , we have  $\mu_1 \sim -3/4$ , hence  $\varepsilon^2 \sim (4/3)(\mu_c - \mu)$ , i.e.

$$\frac{c-c_0}{c_0} \sim \frac{3}{8} F_0^2 \tilde{\epsilon}^2, \quad F_0 = \frac{c_0}{\sqrt{gL}},$$

where  $F_0$  is the Froude number built with the short wave length L.

For larger, still small, values of  $\tau$ , the nodal lines disappear and the pattern looks like hexagons where two sides of crests, parallel to the  $x_2$  axis, are connected to the nearest tip of two analogue crests, shifted by half of the wave length in  $x_1$  and  $x_2$  directions.

For values of  $\tau$  near 1, the pattern of the surface looks like juxta position of squares.

For large  $\tau$ , i.e. in particular  $\tau > \tau_c$ , we have for the free surface truncated at order  $\varepsilon^2$ 

$$\eta = \tilde{\varepsilon}\cos x_1\cos \tau x_2 + \frac{\tau\tilde{\varepsilon}^2}{4}\cos 2\tau x_2(1+\cos 2x_1) + O(\tilde{\varepsilon}^2)$$

where

$$\tilde{\varepsilon} = -\varepsilon/\mu_c \sim -\varepsilon\tau$$
.

The above formula shows that crests (maxima) and troughs (minima) are elongated in the  $x_1$  direction, with crests sharper than the troughs, and there are "nodal" lines ( $\eta \approx 0$ ) at

$$x_1 = \pi/2 + n\pi, \quad n \in \mathbb{Z}.$$

Moreover, in the above formula, we see that  $\tau$  is in factor of  $\tilde{\varepsilon}^2$ , which means that the second order term in the expansion influences much sooner the shape of the surface as  $\tilde{\varepsilon}$  increases. In particular for small values of  $\tilde{\varepsilon}$  there are local maxima between two minima in the troughs. This phenomenon is seen in experiments (see [20]) in the case when  $\tau$  is small, however the values of  $\tilde{\varepsilon}$  allowing such a phenomenon for  $\tau$  small are O(1) and cannot be justified mathematically. So, when  $\tau$  is large, the pattern roughly looks asymptotically like rectangles elongated in  $x_1$  direction, narrow around the crests, wide around the troughs, organized in staggered rows, and where local maxima in the middle of the troughs may occur for a large enough amplitude. Notice in addition that when  $\tau \to \infty$ , then  $\mu_1 \sim \frac{1}{4}\tau^{7/2}$ , hence  $\varepsilon^2\tau^2 \sim \frac{4}{\tau^{3/2}}(\mu - \mu_c)$ , i.e.

$$\frac{c_0 - c}{c_0} \sim \frac{1}{8} \tau^{3/2} F_0^2 \tilde{\epsilon}^2, \quad F_0 = \frac{c_0}{\sqrt{gL}},$$

where we observe that in this last formula L is the physical wave length along  $x_1$ , which is in this case the long wave length (=  $\tau L_1$ , if  $L_1$  denotes the short one). We plot at Figure 1 the elevation  $\eta_{\varepsilon}^{(2)}$  a) for  $\tau = 1/5$  ( $\theta \sim 11.3^{\circ}$ ),  $\varepsilon = 0.8\mu_c$ , b) for  $\tau = 1/2$  ( $\theta \sim 26.5^{\circ}$ ),  $\varepsilon = 0.6\mu_c$ . These cases correspond to  $\tau$  very small or moderately small, currently observed in experiments (see [20]). Observe however that in both cases we need to consider  $\tau$  not exactly 1/5 or 1/2 since both cases are not "simple cases" as required at Theorem 2.3. Indeed, if we consider solutions  $(n,m) \in \mathbb{N}^2$  different from (1,1) for the critical dispersion relation

$$n^2 + \tau^2 m^2 = (1 + \tau^2) n^4, (2.12)$$

then the smallest values are (n,m)=(61,18971) for  $\tau=1/5$ , and (13,377) for  $\tau=1/2$ . This means that the computation fails for coefficients of  $\varepsilon^{18971}$  in the

first case, and  $\varepsilon^{377}$  in the second case. Notice that the formal computations made by Roberts and Schwartz [37] (1983) correspond to diamond waves with  $\tau=1$  ( $\theta=45^o$ ) and  $\tau=\sqrt{3}$  ( $\theta=60^o$ ). They observed numerically the flattening of troughs and sharpening of crests. However, both cases are not "simple cases" in the sense of Theorem 2.3, and these formal computation should break at order  $\varepsilon^{35}$  for  $\tau=1$ , and at order  $\varepsilon^{195}$  for  $\tau=\sqrt{3}$  (due to solutions of (2.12) (n,m)=(5,35) for  $\tau=1$ , and (n,m)=(13,195) for  $\tau=\sqrt{3}$ ).

#### 3 Linearized operator

In this section we study the linearized problem at a non zero  $U = (\psi, \eta)$  for the system (1.6), (1.7). We restrict our study to diamond waves, i.e. the direction of the waves we are looking for is  $\mathbf{u} = \mathbf{u}_0 = (1,0)$  and the system possesses the symmetries  $\mathcal{S}_0$  and  $\mathcal{S}_1$  (see (2.7), (2.8)). The purpose is to invert the linearized operator, for being able to use the Newton method, as it is required in Nash-Moser theorem.

#### 3.1 Linearized system in $(\psi, \eta) \neq 0$

Let us write the nonlinear system (1.6), (1.7) under the form (1.5)

$$\mathcal{F}(U,\mu) = 0,$$

where

$$U = (\psi, \eta),$$

and we omit the argument  $\mathbf{u}_0$  since it is now fixed. Then, for any given (f,g) the linear system

$$\partial_U \mathcal{F}(U,\mu)[\delta U] = F, \quad F := (f,q)$$

can be written as follows

$$\partial_{\eta} \mathcal{G}_{\eta}[\delta \eta] \psi + \mathcal{G}_{\eta}(\delta \psi) - \mathbf{u}_{0} \cdot \nabla(\delta \eta) = f,$$

$$V \cdot \nabla(\delta \psi) + \mu \delta \eta + \left( \mathfrak{b}^{2} \nabla \eta - \mathfrak{b}(\nabla \psi + \mathbf{u}_{0}) \right) \cdot \nabla(\delta \eta) = g$$

where

$$V = \nabla \psi + \mathbf{u}_0 - \mathfrak{b} \nabla \eta, \quad \mathfrak{b} = \frac{1}{1 + |\nabla \eta|^2} \{ \nabla \eta \cdot (\mathbf{u}_0 + \nabla \psi) \}. \tag{3.1}$$

Now defining

$$\delta \phi = \delta \psi - \mathfrak{b} \delta \eta,$$

and after using (2.1,2.2), we obtain the new system

$$\mathcal{L}(U,\mu)[\delta\phi,\delta\eta] = F + \mathcal{R}(\mathcal{F},U)[\delta U], \tag{3.2}$$

where the linear symmetric operator  $\mathcal{L}(U,\mu)$  is defined by

$$\mathcal{L}(U,\mu) = \begin{pmatrix} \mathcal{G}_{\eta} & \mathcal{J}^* \\ \mathcal{J} & \mathfrak{a} \end{pmatrix}, \tag{3.3}$$

$$\mathcal{J} = V \cdot \nabla(\cdot), \quad \mathfrak{a} = V \cdot \nabla \mathfrak{b} + \mu.$$
 (3.4)

The rest  $\mathcal{R}$  has the form

$$\mathcal{R}(\mathcal{F}, U)[\delta U] = (R_1(\mathcal{F}, U)[\delta U], 0),$$

$$R_1(\mathcal{F}, U)[\delta U] = \mathcal{G}_{\eta} \left( \frac{\mathcal{F}_1 \delta \eta}{1 + (\nabla \eta)^2} \right) - \nabla \cdot \left( \frac{\mathcal{F}_1 \delta \eta}{1 + (\nabla \eta)^2} \nabla \eta \right),$$

and cancels when U is a solution of  $\mathcal{F}(U,\mu)=0$ . We also notice that for  $U=(\psi,\eta)\in\mathbb{H}^m_{(S)}$  where

 $\mathbb{H}^m_{(S)} = \{ U \in \mathbb{H}^m(\mathbb{R}^2/\Gamma) : \psi \text{ odd in } x_1, \text{ even in } x_2, \ \eta \text{ even in } x_1 \text{ and in } x_2 \},$ then

$$V = (V_1, V_2) \in H_{e,e}^{m-1}(\mathbb{R}^2/\Gamma) \times H_{o,o}^{m-1}(\mathbb{R}^2/\Gamma),$$
  
$$\mathfrak{b} \in H_{o,e}^{m-1}(\mathbb{R}^2/\Gamma), \quad \mathfrak{a} \in H_{e,e}^{m-2}(\mathbb{R}^2/\Gamma),$$

all these functions being invariant under the shift

$$\mathcal{T}_{\mathbf{v}_0}: (x_1, x_2) \mapsto (x_1 + \pi, x_2 + \pi/\tau).$$

Moreover we have the following "tame" estimates

**Lemma 3.1** Let  $U \in \mathbb{H}^m_{(S)}$ ,  $m \geq 3$ . Then, there exists  $M_3 > 0$  such that for  $||U||_3 \leq M_3$ , one has

$$||V - \mathbf{u}||_{m-1} + ||\mathfrak{a} - \mu||_{m-2} \le c_m(M_3)||U||_m$$

$$||R_1(\mathcal{F}, U)[\delta U]||_{m-2} \le c_s(M_3)\{||\mathcal{F}_1||_2(||\eta||_m||\delta\eta||_2 + ||\delta\eta||_{m-1}) + ||\mathcal{F}_1||_{m-1}||\delta\eta||_2\}.$$

**Proof.** The tame estimates on  $V - \mathbf{u}$  and  $\mathfrak{a} - \mu$  result directly from their definitions, from the following inequality, valid for any  $f, g \in H^m(\mathbb{R}^2/\Gamma), m \geq 2$ 

$$||fg||_m \le c_m \{||f||_2 ||g||_m + ||f||_m ||g||_2\}, \tag{3.5}$$

and from interpolation estimates like

$$||f||_{\lambda\alpha+(1-\lambda)\beta} \le c||f||_{\alpha}^{\lambda}||f||_{\beta}^{1-\lambda},\tag{3.6}$$

which leads to

$$||f||_{\alpha_2}||f||_{\beta_2} \le c||f||_{\alpha_1}||f||_{\beta_1}$$

when

$$0 \le \alpha_1 \le \alpha_2 \le \beta_2 \le \beta_1, \quad \alpha_1 + \beta_1 = \alpha_2 + \beta_2.$$

The tame estimate on  $R_1(\mathcal{F}, U)[\delta U]$  follows from the tame estimates (3.5), (1.9) and from the following interpolation estimate deduced from (3.6):

$$||f||_3||g||_{k+1} \le c_k\{||f||_2||g||_{k+2} + ||f||_{k+1}||g||_3\}.$$

The main problem in using the Nash Moser theorem, is to invert the approximate linearized system, i.e. invert the linear system

$$\mathcal{L}[\delta\phi, \delta\eta] = (f, g),$$

which leads to the scalar equation

$$\mathcal{G}_{\eta}(\delta\phi) - \mathcal{J}^*(\frac{1}{\mathfrak{a}}\mathcal{J}(\delta\phi)) = h \tag{3.7}$$

with

$$h=f-\mathcal{J}^*(\frac{1}{\mathfrak{a}}g)\in H^s_{o,e}(\mathbb{R}^2/\Gamma)$$

and where we look for  $\delta \phi$  in some  $H_{o,e}^{s-r}(\mathbb{R}^2/\Gamma)$ .

### 3.2 Pseudodifferential operators and diffeomorphism of the torus

In this section we use a diffeomorphism:  $\mathbb{R}^2 \to \mathbb{R}^2$ , such that the principal part of the symbol of the linear operator occurring in (3.7) has a simplified structure. Its new structure will allow us to use further a suitable descent method for obtaining, at the end of the process, a pseudodifferential operator equation with constant coefficients, plus a perturbation operator of "small" order.

Let us denote the change of coordinates by X = X(Y), where  $X(\cdot)$  is a not yet determined diffeomorphism of  $\mathbb{R}^2$  such that

$$X(Y) = \mathbb{T}Y + \widetilde{\mathcal{V}}(Y), \quad \mathbb{T}Y = (y_1, y_2/\tau), \tag{3.8}$$

We assume that  $\widetilde{\mathcal{V}}(Y)$  and  $\widetilde{\eta}(Y) = \eta(X(Y))$  satisfy the following

Condition 3.2 Functions  $\tilde{\eta}$  and  $\widetilde{\mathcal{V}}$  are doubly  $2\pi$ -periodic,  $\tilde{\eta}$  is even in  $y_1$  and  $y_2$ ,  $\widetilde{\mathcal{V}}_1$  is odd in  $y_1$  and even in  $y_2$ ,  $\widetilde{\mathcal{V}}_2$  is odd in  $y_2$  and even in  $y_1$ , and

$$\tilde{\eta}(y_1 + \pi, y_2 + \pi) = \tilde{\eta}(y_1, y_2), \quad \widetilde{\mathcal{V}}(y_1 + \pi, y_2 + \pi) = \widetilde{\mathcal{V}}(y_1, y_2).$$

In particular, X(Y) takes diffeomorphically  $\mathbb{R}^2/\Gamma_1$  onto  $\mathbb{R}^2/\Gamma_\tau$ . The lattices of periods  $\Gamma_1$  and  $\Gamma_\tau$  are respectively the dual of lattices  $\Gamma_1'$  and  $\Gamma_\tau'$  generated by the wave vectors  $(1, \pm 1)$  and  $(1, \pm \tau)$ . In new coordinates the free surface has the parametric representation

$$x = \mathbf{r}(Y) := (X_1(Y), X_2(Y), \widetilde{\eta}(Y))^t,$$

with 2x2 matrix  $\mathbb{G}(Y)$  of the first fundamental form of the free surface defined by  $g_{ij} = \partial_{y_i} \mathbf{r} \cdot \partial_{y_j} \mathbf{r}$ . We denote by J the determinant of the Jacobian matrix  $\mathbb{B}(Y) = \nabla_Y X(Y)$ .

Our aim is to simplify the structure of the operators involved in the basic equation (3.7) by choosing an appropriate change of coordinates. The most

suitable tool for organizing such a process is the theory of pseudodifferential operators, and we begin with recalling the definition of a pseudodifferential operator . We consider the class of integro-differential operators on a two-dimensional torus having the representation

$$\mathfrak{A}u(Y) = \frac{1}{2\pi} \sum_{k \in \mathbb{Z}^2} e^{ikY} A(Y,k) \widehat{u}(k), \quad \widehat{u}(k) = \frac{1}{2\pi} \int_{\mathbb{T}^2} e^{-ikY} u(Y) dY,$$

which properties are completely characterised by the function  $A: \mathbf{T}^2 \times \mathbb{R}^2 \mapsto \mathbb{C}$  named the symbol of  $\mathfrak{A}$ . We say that  $\mathfrak{A}$  is a pseudodifferential operator, if its symbol satisfy the condition

**Condition 3.3** There are integers l > 0,  $m \ge 0$  and a real r named the order of the operator  $\mathfrak{A}$  so that

$$|\mathfrak{A}|_{m,l}^r = \|A(\cdot,0)\|_{C^l} + \sup_{k \in \mathbb{Z}^2 \setminus \{0\}} \sup_{|\alpha| < m} |k|^{|\alpha|-r} \|\partial_k^{\alpha} A(\cdot,k)\|_{C^l} < \infty.$$

Pseudodifferential operators enjoy many remarkable properties including explicit formulae for compositions and commutators (see Appendix F for references and more details). Important examples of such operators are the first-order pseudodifferential operator  $\mathcal{G}^{(0)} = (-\Delta)^{1/2}$  with the symbol  $|\mathbb{T}^{-1}k|$  and the second-order pseudodifferential operator

$$\mathfrak{L} = \nu \mathfrak{D}_1^2 + (-\Delta)^{1/2}, \text{ where } \mathfrak{D}_1 = \partial_{y_1}, \tag{3.9}$$

with the symbol

$$L(k) = -\nu k_1^2 + |\mathbb{T}^{-1}k|. \tag{3.10}$$

On the other hand, integro-differential operators  $\mathfrak{D}_{1}^{j}$ , defined by

$$\mathfrak{D}_1^j u(Y) = \frac{1}{2\pi} \sum_{k_1 \neq 0} e^{ikY} \left( ik_1 \right)^j \widehat{u}_k, \quad j \in \mathbb{Z}.$$
 (3.11)

are not pseudodifferential for  $j \leq 0$ , which easy follows from the formulae

$$\mathfrak{D}_1^j u = \partial_{y_1}^j u \text{ for } j > 0, \text{ and } \mathfrak{D}_1^0 u = \Pi_1 u = u - \frac{1}{2\pi} \int_{-\pi}^{\pi} u(s, y_2) ds.$$

Further we will consider also the special class of zero-order pseudodifferential operators  $\mathfrak{A}$  with symbols having the form of composition  $A(Y, \xi(k))$ , where the vector field  $\xi(k) = (\xi_1(k), \xi_2(k))$  is defined by

$$\xi(k) = \mathbb{T}^{-1}k/|\mathbb{T}^{-1}k| \text{ for } k \neq 0, \quad \xi(0) = 0.$$

The metric properties of such operators are characterized by the norm

$$|\mathfrak{A}|_{m,l} = \sup_{|\alpha| \le m} \sup_{|\xi| \le 1} \|\partial_{\xi}^{\alpha} A(\cdot, \xi)\|_{C^{l}} < \infty, \tag{3.12}$$

which is equivalent to the norm  $|\mathfrak{A}|_{m,l}^0$ . By abuse of notation, further we will write simply  $\xi$  instead of  $\xi(k)$  and use both the notations  $A(Y, \xi_1, \xi_2)$  and  $A(Y, \xi)$  for  $A(Y, \xi)$ .

We are now in a position to formulate the main result of this section.

**Theorem 3.4** For any integers  $\rho, m \ge 14$ , real  $\tau \in (\delta, \delta^{-1})$ , and  $U = (\psi, \eta) \in \mathbb{H}^m_{(S)}(\mathbb{R}^2/\Gamma_{\tau})$ , there exists  $\varepsilon_0 > 0$  so that for

$$||U||_{\rho} \leq \varepsilon \quad with \quad \varepsilon \in [0, \varepsilon_0]$$

there are a diffeomorphism of the torus of the form (3.8), satisfying Condition 3.2, zero-order pseudodifferential operators  $\mathfrak{A}$ ,  $\mathfrak{B}$  and an integro-differential operator  $\mathfrak{L}_{-1}$  of order -1 such that:

(i) The identity

$$\left[\mathcal{G}_{\eta}\check{u} - \mathcal{J}^*\left(\frac{1}{\mathfrak{a}}\mathcal{J}\check{u}\right)\right] \circ (\mathbb{T} + \tilde{\mathcal{V}}) = \kappa \left[\mathfrak{L}u + \mathfrak{A}\mathfrak{D}_1u + \mathfrak{B}u + \mathfrak{L}_{-1}u\right]$$
(3.13)

holds true for any  $u \in H^2_{o,e}(\mathbb{R}^2/\Gamma_1)$  and  $\check{u}(X) = u(Y(X))$ .

(ii) The operators  $\mathfrak{A}$ ,  $\mathfrak{B}$  and  $\mathfrak{L}_{-1}$  have the bounds

$$|\mathfrak{A}|_{4,m-6} + |\mathfrak{B}|_{4,m-6} \le c_m(||U||_6)||U||_m,$$
  
$$||\mathfrak{L}_{-1}u||_r \le c\varepsilon ||u||_{r-1}, \quad for \quad 1 \le r \le \rho - 13,$$
  
$$||\mathcal{L}_{-1}u||_s \le c(\varepsilon ||u||_{s-1} + ||U||_{s+13}||u||_0).$$

(iii) Operators  $\mathfrak{A}$ ,  $\mathfrak{B}$  and  $\mathfrak{L}_{-1}$  are invariant with respect to the symmetries  $Y \to \pm Y^*$ ,  $Y^* = (-y_1, y_2)$  which is equivalent to the equivariant property

$$\mathfrak{A}\mathfrak{D}_{1}u(\pm Y^{*}) = \mathfrak{A}\mathfrak{D}_{1}u^{*}(\pm Y), \quad \mathfrak{B}u(\pm Y^{*}) = \mathfrak{B}u^{*}(\pm Y), 
\mathfrak{L}_{-1}u(\pm Y^{*}) = \mathfrak{L}_{-1}u^{*}(\pm Y), \quad u^{*}(Y) = u(Y^{*});$$
(3.14)

they are also invariant with respect to transform  $Y \to Y + (\pi, \pi)$ .

(iv) Diffeomorphism (3.8) of the torus can be inverted as  $Y = \mathbb{T}^{-1}(X - \mathcal{V}(X))$ ,

$$y_1 = x_1 + d(x_1, x_2), \quad y_2 = \tau x_2 + \tau e(x_1, x_2).$$

Functions  $d \in C^{m-4}_{o,e}(\mathbb{R}^2/\Gamma_{\tau}), \ e \in C^{m-4}_{e,o}(\mathbb{R}^2/\Gamma_{\tau}), \ \kappa, J \in C^{m-4}_{e,e}(\mathbb{R}^2/\Gamma_1)$  and parameter  $\nu$  satisfy the inequalities

$$||d||_{C^{m-4}} + ||e||_{C^{m-4}} \le c_m(||U||_4)||U||_m, \quad |\nu - 1/\mu| \le c(||U||_4)||U||_4,$$
(3.15)

$$\|\kappa - 1\|_{C^{m-5}} + \|J - 1/\tau\|_{C^{m-5}} < c_m(\|U\|_5)\|U\|_m. \tag{3.16}$$

The proof is based on two propositions, the first of which gives the representation of the Dirichlet-Neumann operator in the invariant parametric form, and the second shows that trajectories of liquid particles on the free surface forms a foliation of the two-dimensional torus.

In order to formulate them it is convenient to introduce the notations

$$\mathbf{G}_1(Y,k) = \sqrt{\mathbb{G}^{-1}k \cdot k}, \quad \mathbf{div} \, \mathbf{q}(Y) = \frac{1}{\sqrt{\det \mathbb{G}}} \, \mathrm{div}_Y \, \left( \sqrt{\det \mathbb{G}} \mathbf{q}(Y) \right).$$

Recall that  $\mathbb{G}k \cdot k$  is the first fundamental form of the surface  $\Sigma$ .

**Theorem 3.5** Suppose that functions  $\tilde{\eta}$  and  $\widetilde{\mathcal{V}}$  satisfy Condition 3.2 and there are integers  $\rho$ , l such that

$$\begin{aligned} ||\widetilde{\eta}||_{C^{\rho}} + ||\widetilde{\mathcal{V}}||_{C^{\rho}} &\leq \varepsilon, \quad 10 \leq \rho \leq l, \\ ||\widetilde{\eta}||_{C^{s}} + ||\widetilde{\mathcal{V}}||_{C^{s}} &\leq E_{l}, \quad s \leq l. \end{aligned}$$

Then there exists  $\varepsilon_0 > 0$  depending on  $\rho$  and l only such that for  $0 \le \varepsilon \le \varepsilon_0$  and  $2\pi$ -periodic sufficiently smooth function u, the operator  $\mathcal{G}_n$  has the representation

$$\mathcal{G}_{\eta}\check{u}\circ(\mathbb{T}+\widetilde{\mathcal{V}})=\mathcal{G}_{1}u+\mathcal{G}_{0}u+\mathcal{G}_{-1}u,\quad \check{u}(X)=u(Y(X)). \tag{3.17}$$

Here  $\mathcal{G}_1$  is a first order pseudodifferential operator with symbol

$$G_1(Y,k) = \frac{\sqrt{\det \mathbb{G}}}{I} \mathbf{G}_1(Y,k), \quad Y \in \mathbb{R}^2, \quad k \in \mathbb{Z}^2,$$
 (3.18)

 $\mathcal{G}_0$  is a zero order pseudodifferential operator with symbol

$$G_0 = \text{Re } G_0 + i \text{Im } G_0,$$

Re 
$$G_0(Y,k) = \frac{\det \mathbb{G}}{2J^2} \left[ \frac{1}{\mathbf{G}_1^2} Q(Y,k) + \mathbf{div}(\mathbb{G}^{-1}\nabla_Y \tilde{\eta}) \right],$$
 (3.19)

Im 
$$G_0(Y, k) = -\frac{\sqrt{\det \mathbb{G}}}{2J} \operatorname{\mathbf{div}}(\nabla_k \mathbf{G}_1).$$
 (3.20)

Here the quadratic form Q(Y, .) is given by

$$Q(Y,k) = \frac{1}{2} \nabla_Y (\mathbb{G}^{-1} k \cdot k) \cdot (\mathbb{G}^{-1} \nabla_Y \tilde{\eta}) - \mathbb{G}^{-1} k \cdot \nabla_Y (\mathbb{G}^{-1} \nabla_Y \tilde{\eta} \cdot k), \quad (3.21)$$

and the operator  $\mathcal{G}_0$  satisfies the estimates

$$|\mathcal{G}_0 u|_{4,\rho-2}^0 \le c\varepsilon, \quad |\mathcal{G}_0 u|_{4,l-2}^0 \le cE_l,$$
 (3.22)

while the linear operator  $\mathcal{G}_{-1}$  satisfies

$$||\mathcal{G}_{-1}u||_r \le c\varepsilon ||u||_{r-1}, \text{ for } 1 \le r \le \rho - 9,$$
  
 $||\mathcal{G}_{-1}u||_s \le c(\varepsilon ||u||_{s-1} + E_l||u||_0), \text{ for } s \le l - 9.$  (3.23)

Moreover, operators  $\mathcal{G}_1$ ,  $\mathcal{G}_0$  and  $\mathcal{G}_{-1}$  satisfy the symmetry properties

$$\mathcal{G}_j u(\pm Y^*) = \mathcal{G}_j u^*(\pm Y), \quad j = 1, 0, -1, \quad u^*(Y) = u(Y^*).$$

**Proof.** The proof is given in Appendix G.

The formula for the principal term  $G_1$  is a classic result of the theory of pseudodifferential operators [22]. The expression for the second term in local Riemann coordinates was given in [1]. It seems that the general formulae (3.19), (3.20) are new. Note that the ratio det  $\mathbb{G}/J^2 = 1 + |\nabla_X \eta(X)|^2$  is a scalar invariant and the real part of  $G_0$  can be rewritten in the invariant form

$$\frac{J}{\sqrt{\det \mathbb{G}}} \operatorname{Re} G_0 = \frac{1}{2} \frac{LG - 2MF + NF}{EG - F^2} - \frac{1}{2} \frac{L\xi_1^2 + 2M\xi_1\xi_2 + N\xi_2^2}{E\xi_1^2 + 2F\xi_1\xi_2 + G\xi_2^2}.$$
 (3.24)

Here we use the standard notations for the second fundamental form  $L\xi_1^2 + 2M\xi_1\xi_2 + N\xi_2^2$  and the first fundamental form  $E\xi_1^2 + 2F\xi_1\xi_2 + G\xi_2^2$  of the surface  $x_3 = \eta(X)$ , the vector  $\xi$  is connected with the covector k by the relation  $k = \mathbb{G}\xi$ . The right hand side of (3.24) is the difference between the mean curvature of  $\Sigma$  and half of the normal curvature of  $\Sigma$  in the direction  $\xi$ . Note also that the conclusion of Theorem 3.5 holds true without assumption on the smallness of  $\varepsilon$ , but the proof becomes more complicated and goes far beyond the scope of the paper.

**Lemma 3.6** For  $m \geq 4$ , and  $U \in \mathbb{H}^m_{(S)}(\mathbb{R}^2/\Gamma_\tau)$  with  $||U||_4$  small enough, there exists a unique function  $\mathcal{Z} \in \mathcal{C}^{m-3}(\mathbb{R}^2)$  such that

$$\frac{\partial \mathcal{Z}}{\partial z_1} = \frac{V_2}{V_1}(z_1, \mathcal{Z}), \quad \Pi_1 \mathcal{Z} = z_2, \tag{3.25}$$

where  $\Pi_1$  denotes the average over a period in  $z_1$ , and  $V_i$  are the components of the vector field V defined by (3.1). Moreover,  $\mathcal{Z}$  is even in  $z_1$ , odd in  $z_2$ ,

$$\mathcal{Z}(Z) = \mathcal{Z}(Z + (2\pi, 0)) = \mathcal{Z}(Z + (0, 2\pi/\tau)) - 2\pi/\tau = \mathcal{Z}(Z + (\pi, \pi/\tau)) - \pi/\tau,$$

and the shifted function  $\mathcal{T}_{\delta}\mathcal{Z} = \mathcal{Z}(\cdot + \delta, \cdot)$  is solution of the system (3.25) where  $V = V(\cdot + \delta, \cdot)$ . Moreover, the mapping

$$x_1 = z_1, \quad x_2 = z_2 - \widetilde{d}_1(z_1, z_2) = \mathcal{Z}(z_1, z_2),$$
 (3.26)

with his inverse

$$z_1 = x_1, \quad z_2 = x_2 + d_1(x_1, x_2)$$

define automorphisms of the torus  $\mathbb{R}/\Gamma_{\tau}$ :  $X \mapsto Z = \mathcal{U}_1(X)$ ,  $X = \mathcal{U}_1^{-1}(Z)$ . The functions  $d_1$  and  $\widetilde{d}_1$  have symmetry (e, o), as above and we have the following tame estimates

$$||d_1||_{C^{m-3}} + ||\widetilde{d_1}||_{C^{m-3}} \le c_m(||U||_4)||U||_m.$$

The automorphism  $U_1$  takes integral curves of the vector field V, which coincide with the bicharacteristics of the operator  $\mathcal{G}_{\eta} - \mathcal{J}^*(\mathfrak{a}^{-1}\mathcal{J}\cdot)$ , onto straight lines  $\{z_2 = \text{const.}\}$ . In other words, bicharacteristics form a foliation of the torus with a rotation number equal to 0.

**Proof.** The proof is made in Appendix C. ■

Let us turn to the proof of Theorem 3.4. We look for the desired diffeomorphism  $Y \to X$  in the form of the composition  $(\mathcal{U}_2 \circ \mathcal{U}_1)^{-1}$ ,

$$X \xrightarrow{\mathcal{U}_1} Z \xrightarrow{\mathcal{U}_2} Y$$

where the diffeomorphism  $\mathcal{U}_1: \mathbb{R}^2/\Gamma_\tau \mapsto \mathbb{R}^2/\Gamma_\tau$  is completely defined by Lemma 3.6, and the diffeomorphism  $\mathcal{U}_2: \mathbb{R}^2/\Gamma_\tau \mapsto \mathbb{R}^2/\Gamma_1$  is unknown. We look for it in the form  $Y = \mathcal{U}_2(Z)$  with

$$y_1 = z_1 + d_2(Z), \quad y_2 = \tau(z_2 + e_2(z_2)),$$
 (3.27)

where functions  $d_2$  and  $e_2$  will be specified below. Our first task is to make the formal change of variables in the left hand side of (3.13). We begin with the consideration of the second-order differential operator  $\mathcal{J}^*(\mathfrak{a}^{-1}\mathcal{J}\cdot)$ . It follows from the equality  $\mathcal{J} = V \cdot \nabla_X$  that

$$-\mathcal{J}^*\big(\frac{1}{\mathfrak{a}}\mathcal{J}\check{u}\big))\circ\mathcal{U}_1^{-1}\circ\mathcal{U}_2^{-1}\equiv\frac{1}{J}\nabla_Y\cdot\Big\{\frac{J}{\mathfrak{a}}\big(\mathbb{B}^{-1}V\cdot\nabla_Yu\big)\mathbb{B}^{-1}V\Big\},$$

where

$$V = V(X(Y)), \quad \mathfrak{a} = \mathfrak{a}(X(Y)), \quad \mathbb{B}(Y) = \nabla_Y X(Y), J(Y) = \det \mathbb{B}(Y).$$

In particular, we have

$$\mathbb{B}^{-1}(Y(Z)) = \nabla_Z Y(Z) \left[ \nabla_Z X(Z) \right]^{-1}.$$

On the other hand, Lemma 3.6 and formulae (3.27) imply

$$\left[\nabla_Z X(Z)\right]^{-1} V(X(Z)) = V_1(X(Z))\mathbf{e}_1, \quad \nabla_Z Y(Z)\mathbf{e}_1 = (1 + \partial_{z_1} d_2(Z))\mathbf{e}_1,$$

where  $\mathbf{e}_1 = (1,0)$ . Thus we get

$$-\mathcal{J}^*\left(\frac{1}{\mathfrak{a}}\mathcal{J}\check{u}\right)) \equiv \frac{1}{J}\partial_{y_1}\left\{\frac{J}{\mathfrak{a}}(1+\partial_{z_1}d_2)^2V_1^2\partial_{y_1}u\right\}.$$

From this and parametric representation (3.17) of the Dirichlet-Neumann operators we conclude that the left hand side of the desired identity (3.13) is equal to

$$\mathfrak{p}(Z(Y))\partial_{y_1}^2 u(Y) + \mathfrak{s}(Y))\partial_{y_1} u(Y) + \mathcal{G}_1 u(Y) + \mathcal{G}_0 u(Y) + \mathcal{G}_{-1} u(Y),$$

where

$$\mathfrak{p}(Z) = \frac{1}{\mathfrak{a}(X(Z))} \left(1 + \partial_{z_1} d_2(Z)\right)^2 V_1(X(Z))^2,$$

$$\mathfrak{s}(Y) = \frac{1}{J(Y)} \partial_{y_1} \left\{ J(Y) \mathfrak{p}(Z(Y)) \right\}.$$
(3.28)

Note that (3.13) is a second order operator with respect to the variable  $y_1$  and a first- order operator with respect to variable  $y_2$ . Its principal part is the pseudodifferential operator  $\mathfrak{p}\partial y_1^2 + \mathcal{G}_1$  which symbol reads

$$-\mathfrak{p}k_1^2 + J^{-1} (\operatorname{adj} \mathbb{G} k \cdot k)^{1/2},$$

which we write in the form

$$-\mathfrak{p}k_1^2 + (\tau J)^{-1}\sqrt{g_{11}}\Big(\tau^2k_2^2 - 2\tau^2g_{11}^{-1}g_{12}k_1k_2 + \tau^2g_{11}^{-1}g_{22}k_1^2\Big)^{1/2}.$$

Hence operator (3.13) can be reduced to the operator with constant coefficients at principal derivatives if for some constant  $\nu$ ,

$$\nu^{-1}\mathfrak{p}(Z(Y)) = (\tau J(Y))^{-1} \sqrt{g_{11}(Y)}.$$
 (3.29)

This equality can be regarded as first order differential equation for functions  $d_2(Z)$ ,  $e_2(z_2)$  and a constant  $\nu$ . It becomes clear if we write the right hand side as a function of the variable Z. To this end note that since  $\partial_{y_1}z_2(Y) = \partial_{z_2}x_1(Z) = 0$ ,

$$g_{11} = \left| \nabla_Z X \, \partial_{y_1} Z \right|^2 + \left( \nabla_X \eta \cdot \nabla_Z X \cdot \partial_{y_1} Z \right)^2 = \left[ \partial_{y_1} z_1(Y) \right]^2 \left[ 1 + (\partial_{z_1} Z)^2 + (\partial_{x_1} \eta + \partial_{x_2} \eta \partial_{z_1} Z)^2 \right].$$

which along with (3.25) gives

$$g_{11} = \frac{V^2 + (V \cdot \nabla_X \eta)^2}{V_1^2 (1 + \partial_{z_1} d_2)^2}.$$
 (3.30)

On the other hand, we have

$$J(Y(Z))^{-1} = \det \nabla_Z Y(Z) (\det \nabla_Z X(Z))^{-1} = \tau (1 + \partial_{z_1} d_2) (1 + \partial_{z_2} e_2) (\partial_{z_2} Z)^{-1}.$$

Substituting these equalities into (3.29) we obtain the differential equation for  $d_2$  and  $e_2$ ,

$$\partial_{z_1} d_2(Z) = \left[ \nu \mathfrak{q}(Z) \left( 1 + e_2'(z_2) \right) \right]^{1/2} - 1, \tag{3.31}$$

where  $\mathfrak{q}$  is equal to

$$V_1(X(Z))^{-3} \Big( |V(X(Z))|^2 + \big(V(X(Z)) \cdot \nabla_X \eta(X(Z))\big)^2 \Big)^{1/2} \mathfrak{a}(X(Z)) \partial_{z_2} \big( \mathcal{Z}(Z) \big)^{-1},$$
(3.32)

has symmetry (e, e), and is close to  $\mu$ . Note that it is completely defined by equalities (3.1), (3.4), and Lemma 3.6. This equation can be solved as follows. We first note that it gives a unique  $d_2$  with symmetry (o, e) provided that

$$\nu^{-1/2} (1 + e_2'(z_2))^{-1/2} = \frac{1}{2\pi} \int_{-\pi}^{\pi} \mathfrak{q}^{1/2}(Z) dz_1.$$
 (3.33)

This now determines a unique periodic odd function  $e_2$  provided that

$$\nu = 2\pi\tau \int_{-\pi/\tau}^{\pi/\tau} \left( \int_{-\pi}^{\pi} \mathfrak{q}^{1/2}(Z) dz_1 \right)^{-2} dz_2, \tag{3.34}$$

which is just  $1/\mu$  when  $(\psi, \eta) = 0$ . We observe that the invariance of  $\mathfrak{q}(Z)$  under the shift  $T_{\mathbf{v}_0}$ , leads to the invariance of the right hand side of (3.33) by the change  $z_2 \mapsto z_2 + \pi/\tau$ . This means that  $e_2$  is indeed  $\pi/\tau$  periodic. It follows from Appendix G (see Lemma G.3) of [24] and Lemma 3.6 that

$$\begin{aligned} ||\mathfrak{q} - \mu||_{C^{m-4}} & \leq & c_m(||U||_4)||U||_m, \\ |\nu - 1/\mu| & \leq & c||U||_4, \\ ||d_2||_{C^{m-4}} + ||e_2||_{C^{m-4}} & \leq & c_m(||U||_4)||U||_m. \end{aligned}$$

From this, the identities

$$d(X) = d_2(x_1, x_2 + d_1(X)), \quad e(X) = d_1(X) + e_2(x_2 + d_1(X))),$$

and from Appendix G (see Lemma G.1) of [24] we deduce estimates (3.15) for the functions d, e, and also estimate (3.16) for the Jacobian J. Hence the diffeomorphism  $Y \to X$  is well defined and meets all requirements of assertion (iv) of Theorem 3.4. Next set

$$\kappa(Y) = (\tau J(Y))^{-1} \sqrt{g_{11}(Y)}, \quad b(Y) = -\tau g_{11}(Y)^{-1} g_{12}(Y), \quad 1 + 2a = \tau^2 g_{11}(Y)^{-1} g_{12}(Y).$$

It follows from (3.15) that

$$||g_{11} - 1||_{C^{m-5}} + ||g_{22} - 1/\tau^2||_{C^{m-5}} + ||g_{12}||_{C^{m-5}} \le c_m(||U||_5)||U||_m,$$
 (3.35)

which leads to estimate (3.16) for  $\kappa$  and the following estimates for the functions a and b

$$||a||_{C^{m-5}} + ||b||_{C^{m-5}} \le c_m(||U||_5)||U||_m.$$
(3.36)

We are now in a position to define the operators  $\mathfrak{A}$ ,  $\mathfrak{B}$  and  $\mathfrak{L}_{-1}$  defined by the left hand side of identity (3.13). It follows from (3.28) and (3.29), that its coefficients satisfies the inequalities.

$$\mathfrak{p} = \nu \kappa, \quad \mathfrak{p}^{-1}\mathfrak{s} = \partial_{y_1}(\ln \kappa J)$$

From this we conclude that

$$\left[\mathcal{G}_{\eta}\check{u} - \mathcal{J}^*\left(\frac{1}{\mathfrak{a}}\mathcal{J}\check{u}\right)\right] \circ (\mathcal{U}_2 \circ \mathcal{U}_1)^{-1} = \kappa \left[\mathfrak{L} + \widetilde{\mathcal{G}}_1 u + \nu \partial_{y_1}(\ln \kappa J)\mathfrak{D}_1 u + \mathfrak{B}u + \mathfrak{L}_{-1}u\right]$$

where

$$\mathfrak{B} = \frac{1}{\kappa} \mathcal{G}_0, \quad \mathfrak{L}_{-1} = \frac{1}{\kappa} \mathcal{G}_{-1}, \quad \widetilde{\mathcal{G}}_1 = \frac{1}{\kappa} \mathcal{G}_1 - (-\Delta)^{1/2}.$$
 (3.37)

By construction, the operator  $\widetilde{\mathcal{G}}_1$  has the following symbol

$$\left\{ (1+2a(Y))k_1^2 + 2b(Y)\tau k_1k_2 + \tau^2 k_2^2 \right\}^{1/2} - \left\{ k_1^2 + \tau^2 k_2^2 \right\}^{1/2}$$

which implies that  $\widetilde{\mathcal{G}}_1 = \mathfrak{A}_0 \mathfrak{D}_1$  where the zero order pseudodifferential operator  $\mathfrak{A}_0$  has the symbol

$$\frac{-2i(a(Y)k_1+\tau b(Y)k_2)}{\left\{(1+2a(Y))k_1^2+2b(Y)\tau k_1k_2+\tau^2k_2^2\right\}^{1/2}+\left\{k_1^2+\tau^2k_2^2\right\}^{1/2}}.$$

which can be written in the standard form

$$A_0(Y,\xi) = \frac{-2i(a(Y)\xi_1 + b(Y)\xi_2)}{1 + (1 + 2a(Y))\xi_1^2 + 2b(Y)\xi_1\xi_2 + \xi_2^2)^{1/2}}.$$
 (3.38)

Hence the basic identity (3.13) holds with the operators  $\mathfrak{B}$ ,  $\mathfrak{L}_{-1}$  and the operator  $\mathfrak{A} = \mathfrak{A}_0 + \nu \partial_{y_1} (\ln g_{11})$  which yields (i). Estimates (ii) follow from formula (3.38), estimates (3.36), (3.35) (3.16) and Theorem 3.5.

Note that the functions  $\kappa$ , J, a are even and the function b is odd both in  $y_1$  and  $y_2$ . Moreover, they are invariant under the shift  $Y \to Y + (\pi, \pi/\tau)$ . Hence the operator  $\mathfrak A$  satisfies the symmetry conditions (iii). Formulae (3.37) along with Theorem 3.5 imply that the operators  $\mathfrak B$  and  $\mathfrak L_{-1}$  also satisfy the conditions (3.14), which completes the proof of Theorem 3.4.

#### 3.3 Main orders of the diffeomorphism and coefficient $\nu$

In using later the Nash-Moser theorem, we need to set

$$U = U_{\varepsilon}^{(N)} + \varepsilon^N W$$

where  $U_{\varepsilon}^{(N)}$  is an approximate solution, up to order  $\varepsilon^{N}$  of the system (1.6), (1.7), and W is the unknown perturbation. At Theorem 2.3, for  $\varepsilon_{1} = \varepsilon_{2} = \varepsilon/2$  (Diamond waves), we showed how to compute explicitly any order of approximation  $U_{\varepsilon}^{(N)}$ , with  $\mu - \mu_{c}(\tau) = \varepsilon^{2}\mu_{1}(\tau) + O(\varepsilon^{4})$ ,  $\mu_{1}(\tau) \neq 0$  for  $\tau \neq \tau_{c}$ . Then we need to know in particular the principal part of the coefficient  $\nu$  in (3.34) and (3.9), which implies the knowledge of the diffeomorphisms  $\mathcal{U}_{1}$  and  $\mathcal{U}_{2}$ . We show the following two Lemmas:

**Lemma 3.7** For  $N \geq 3$ , we have

$$\nu(\varepsilon, \tau, W) = \mu_c^{-1} - \varepsilon^2 \nu_1(\tau) + O(\varepsilon^3), \tag{3.39}$$

where  $\mu_c = (1 + \tau^2)^{-1/2}$ , and

$$\nu_1(\tau) = \frac{\mu_1(\tau)}{\mu_c^2} - \frac{3}{16\mu_c} + \frac{5}{4\mu_c^3} 
= \frac{1}{4\mu_c^5} - \frac{1}{2\mu_c^4} + \frac{1}{2\mu_c^3} + \frac{7}{8\mu_c^2} - \frac{1}{4\mu_c} - \frac{9}{16(2-\mu_c)}, \quad (3.40)$$

which is positive for any  $\tau > 0$ ,  $(\nu_1(\tau) > 5/16\mu_c)$ .

**Lemma 3.8** For  $N \geq 3$ , the diffeomorphism (3.8) of the torus, which allows to obtain the form (3.13) for the linear operator  $\mathcal{G}_{\eta} - \mathcal{J}^*(\frac{1}{\mathfrak{a}}\mathcal{J}(\cdot))$ , and the principal part of  $\tilde{\eta}(Y)$ , are given by

$$X = (x_1, x_2), \quad Y = (y_1, y_2), \quad X(Y) = (X_1(Y), X_2(Y)),$$

$$X_{1}(Y) = y_{1} + \frac{\varepsilon}{2}\sin y_{1}\cos y_{2} + \varepsilon^{2}(\xi_{11}\sin 2y_{1} + \xi_{12}\sin 2y_{1}\cos 2y_{2}) + O(\varepsilon^{3}),$$

$$X_{2}(Y) = \frac{1}{\tau}y_{2} + \varepsilon\tau\cos y_{1}\sin y_{2} + \varepsilon^{2}(\xi_{21}\sin 2y_{2} + \xi_{22}\cos 2y_{1}\sin 2y_{2}) + O(\varepsilon^{3}),$$

$$\tilde{\eta}(Y) = -\frac{\varepsilon}{\mu_{c}}\cos y_{1}\cos y_{2} + \varepsilon^{2}\{\eta_{00} + \eta_{01}\cos 2y_{1} + \eta_{02}\cos 2y_{2}(1 + \cos 2y_{1})\} + O(\varepsilon^{3}),$$

where  $\varepsilon > 0$  is defined by the main order  $\varepsilon \xi_0$  of  $U_{\varepsilon}^{(N)}$  and

$$\mu = \mu_c + \varepsilon^2 \mu_1(\tau) + O(\varepsilon^4), \quad \mu_c = (1 + \tau^2)^{-1/2},$$

and where

$$\xi_{11} = -\frac{1}{4} \left\{ \frac{3}{4(2-\mu_c)} - \frac{3}{16} - \frac{5}{4\mu_c} + \frac{3}{4\mu_c^2} + \frac{1}{\mu_c^3} - \frac{1}{\mu_c^4} \right\},$$

$$\xi_{12} = -\frac{1}{64}, \quad \xi_{21} = -\frac{\tau}{8} + \frac{17}{32\tau}, \quad \xi_{22} = -\frac{\tau}{8},$$

$$\eta_{00} = \frac{1}{4\mu_c^3} - \frac{1}{8\mu_c}, \quad \eta_{02} = \frac{1}{8\mu_c},$$

$$\eta_{01} = -\frac{1}{4\mu_c} - \frac{1}{4\mu_c^2} + \frac{1}{4\mu_c^3} + \frac{3}{8(2-\mu_c)}.$$

**Proof:** see Appendix D.

#### 4 Small divisors. Estimate of $\mathcal{L}$ - resolvent

It follows from Theorem 3.4 that the pseudodifferential operator  $\mathfrak{L} = \mathcal{G}^{(0)} + \nu \partial_{y_1}^2$  with the symbol

$$L(k) = -\nu k_1^2 + (k_1^2 + \tau^2 k_2^2)^{1/2}, \quad k \in \mathbb{Z}^2.$$
(4.1)

forms the principal part of the linear problem. In this section we describe the structure of the spectrum of  $\mathfrak L$  and investigate in details the dependence of its resolvent on parameters  $\nu$  and  $\tau$ . The first result in this direction is the following theorem which constitutes generic properties of  $\mathfrak L$ .

**Theorem 4.1** For every positive  $\nu$  and  $\tau$ , the operator  $\mathfrak{L}$  is selfadjoint in  $H^0(\mathbb{R}^2/\Gamma)$  and has the natural domain of definition

$$D(\mathfrak{L}) = \{ u \in H^0(\mathbb{R}^2/\Gamma) : \sum_{k \in \mathbb{Z}^2} L(k)^2 |\widehat{u}(k)|^2 < \infty \}.$$

The spectrum of  $\mathfrak{L}$  coincides with the closure of the discrete spectrum which consists of all numbers  $\lambda_k = L(k)$ ,  $k \in \mathbb{N}^2$ ; the corresponding eigenfunctions are defined by

$$(2\pi)^{-1} \exp(\pm ik \cdot Y), \quad (2\pi)^{-1} \exp(\pm k^* \cdot Y) \quad where \quad k^* = (-k_1, k_2).$$

For each real  $\varkappa \neq \lambda_k$ ,  $k \in \mathbb{Z}^2$ , the resolvent  $(\mathfrak{L}-\varkappa)^{-1}$  is a selfadjoint unbounded operator defined in terms of the Fourier transform by the formula

$$(\widehat{\mathfrak{L}-\varkappa})^{-1}u(k) = (L(k)-\varkappa)^{-1}\widehat{u}(k), \quad k \in \mathbb{Z}^2.$$
(4.2)

**Proof.** The operator  $\mathfrak{L}$  is unitary equivalent to a multiplication operator in the Hilbert space  $l_2$ , which can be represented by the infinite diagonal matrix with diagonal elements L(k),  $k \in \mathbb{Z}^2$ . It remains to note that for such a matrix the spectrum coincides with the closure of diagonal, and the discrete spectrum coincides with the diagonal.  $\blacksquare$ 

Note that zero is nontrivial eigenvalue of  $\mathfrak L$  if and only if the dispersion equation L(k)=0 has a nontrivial solution  $k=k_0$ . The number of such solutions depends on the arithmetic nature of parameters  $\nu$ ,  $\tau$ . We restrict our attention to the simplest case when  $k_0=(1,1)$ . It is easy to see that in this case the point  $(\nu,\tau)=(\nu_0,\tau)$  belongs to the positive branch of the hyperbola  $\nu_0^2-\tau^2=1$ .

Our aim is to investigate in details the dependence of  $\mathfrak{L}$ -resolvent on parameter  $\nu$ . With further applications to the Nash-Moser theory in mind we take the perturbed values of parameter  $\nu$ , and a spectral parameter  $\varkappa$  in the form

$$\nu_j(\varepsilon) = \nu_0 - \varepsilon^2 \nu_1 + \varepsilon^3 \tilde{\nu}_j(\varepsilon), \quad \varkappa_j(\varepsilon) = \varepsilon^2 \tilde{\varkappa}_j(\varepsilon),$$
 (4.3)

where  $\nu_0 = \nu_0(\tau)$  and  $\nu_1 = \nu_1(\tau)$ . Here functions  $\tilde{\nu}_j$  and  $\tilde{\varkappa}_j$ ,  $j \geq 1$ , are defined on the segment  $[0, r_0]$  and satisfy the inequalities

$$|\tilde{\nu}_{j}(\varepsilon)| + |\tilde{\varkappa}_{j}(\varepsilon)| \leq R,$$

$$|\tilde{\nu}_{j}(\varepsilon') - \tilde{\nu}_{j}(\varepsilon'')| + |\tilde{\varkappa}_{j}(\varepsilon') - \tilde{\varkappa}_{j}(\varepsilon'')| \leq R|\varepsilon' - \varepsilon''|,$$

$$|\tilde{\nu}_{j+1} - \tilde{\nu}_{j}| + |\tilde{\varkappa}_{j+1} - \tilde{\varkappa}| \leq R(2^{-j}).$$

$$(4.4)$$

Denoting by  $\mathfrak{L}_0$  the operator  $\mathfrak{L}$  for  $\nu = \nu_0(\tau)$ , the next theorem establishes the basic estimates for a resolvent  $(\mathfrak{L} - \varkappa)^{-1}$  on the orthogonal complement to ker  $\mathfrak{L}_0$ , which are stable with respect to perturbations of parameters from a suitable Cantor set.

**Theorem 4.2** (a) For each  $\alpha \in (0,1]$ , there is a set of full measure  $\mathfrak{N}_{\alpha} \subset (1,\infty)$  so that whenever  $\nu_0 \in \mathfrak{N}_{\alpha}$  and  $\nu = \nu_0(\tau) = (1+\tau^2)^{1/2}$ , zero is a non-trivial eigenvalue of  $\mathfrak{L}_0$  and

$$\ker \mathfrak{L}_{0} = span \left\{ 1, \exp(\pm ik_{0} \cdot Y), \exp(\pm k_{0}^{*} \cdot Y) \right\},$$
  
 $\|\mathfrak{L}_{0}^{-1}u\|_{s-(1+\alpha)/2} \le c\|u\|_{s}, \text{ when } u \in (\ker \mathfrak{L}_{0})^{\perp} \cap H^{s}(\mathbb{R}^{2}/\Gamma).$  (4.5)

(b) Suppose that  $\nu_0 \in \mathfrak{N}_{\alpha}$  with  $\alpha \in (0, 1/78)$ , then there is a set  $\mathcal{E} \subset [0, r_0)$  so that

$$\frac{2}{r^2} \int_{[0,r] \cap \mathcal{E}} \varepsilon \, d\varepsilon \to 1 \quad as \quad r \to 0, \tag{4.6}$$

and for all  $\varepsilon \in \mathcal{E}$ ,  $j, s \ge 1$  and  $\nu = \nu_j(\varepsilon)$ ,  $\varkappa = \varkappa_j(\varepsilon)$ ,

$$\left\| \left( \mathfrak{L} - \varkappa \right)^{-1} u \right\|_{s-1} \le c \|u\|_s \quad \text{when} \quad u \in (\ker \mathfrak{L}_0)^{\perp} \cap H^s(\mathbb{R}^2/\Gamma), \tag{4.7}$$

where the positive constant c depends on  $\alpha$ ,  $\nu_0$  and R only.

**Remark 4.3** The fact proved at Lemma 3.7 that  $\nu_1(\tau) > 0$ , allows the freedom to take  $\tau$  as a function of  $\varepsilon$  as  $\tau = \tau_0 + \varepsilon^2 \tau_1$ . Then, for  $|\tau_1|$  small enough, we have

$$\omega_1 := \omega_0(\nu_0^{-1}\nu_1 - \tau_0^{-1}\tau_1) \neq 0$$

and Theorem 4.2 still holds true.

It follows from formula (4.2) and the Parseval identity that Theorem 4.2 will be proved once we prove the following

**Theorem 4.4** (a) For any  $\alpha \in (0,1]$  there is a set of full measure  $\mathfrak{N}_{\alpha} \subset (1,\infty)$  so that for all  $\nu_0 \in \mathfrak{N}_{\alpha}$  and  $\nu = \nu_0(\tau)$ ,

$$|L(k)| \ge c|k|^{-(1+\alpha)/2} \quad when \quad k \ne 0, \pm k_0, \pm k_0^*.$$
 (4.8)

(b) Suppose that  $\nu_0 \in \mathfrak{N}_{\alpha}$  with  $\alpha \in (0, 1/78)$ , then, there is a set  $\mathcal{E} \subset [0, r_0)$  satisfying (4.6) so that for all  $\varepsilon \in \mathcal{E}$ ,  $j \geq 1$  and  $\nu = \nu_j(\varepsilon)$ ,  $\varkappa = \varkappa_j(\varepsilon)$ ,

$$|(L(k) - \varkappa)^{-1}| \ge c|k|^{-1} \text{ for all } k \ne 0, \pm k_0, \pm k_0^*,$$
 (4.9)

where the positive constant c depends on  $\nu_0$ ,  $\alpha$  and R only.

The proof naturally falls into four steps.

**First step.** We begin with proving two auxiliary lemmas which establish a connection between the symbol L and the Diophantine function defined by the formula

$$(m,n) \to \omega - \frac{m}{n^2} - \frac{C}{n^2}, \quad (m,n) \in \mathbf{N}^2,$$
 (4.10)

where constants  $\omega$ , C are connected with parameters  $\nu$ ,  $\tau$  and  $\varkappa$  by the relations

$$\omega = \nu/\tau$$
,  $C = 1/(2\nu\tau) - \varkappa/\tau$ .

**Lemma 4.5** Let for some  $\varrho \geq 2$  and  $\alpha \in [0,1]$ , parameters  $\nu$ ,  $\tau$  and a vector  $k \in \mathbb{Z}^2$  satisfy the inequalities

$$0 < \rho^{-1} \le \nu, \tau < \rho, \quad |\varkappa| < \rho, \quad |k_1| \ge 2\rho^2,$$
 (4.11)

$$|\omega k_1^2 - |k_2| - C| \ge 5(\rho^2 + \rho^{10})|k_1|^{-1-\alpha},$$
 (4.12)

Then  $|L(k) - \varkappa| \ge |k|^{-(1+\alpha)/2}$ .

**Proof.** Since L(k) is even in k, it suffices to prove the lemma for

$$k = (n, m)$$
 with integers  $n > 2\varrho^2$ ,  $m > 0$ .

We begin with the observation that for  $n^2 \ge 2\varrho^2 m$ ,

$$\begin{split} -L(k) + \varkappa &\geq \varrho^{-1} n^2 - \sqrt{\varrho^2 m^2 + n^2} - \varrho \geq \\ 4\varrho^4 \Big(\frac{1}{\varrho} - \frac{1}{2} \big(\frac{1}{\varrho^2} + \frac{1}{\varrho^4}\big)^{1/2}\Big) - \varrho \geq \frac{4}{3}\varrho^3 - \varrho > 1. \end{split}$$

Hence it suffices to prove the lemma for

$$n^2 \le 2\varrho^2 m. \tag{4.13}$$

Since for all non-negative  $\sigma$ ,  $0 \le 1 + \sigma/2 - (1 + \sigma)^{1/2} \le \sigma^2/4$ , we have

$$-\tau^{-1}L(k) = \omega n^2 - m - (2\tau^2 m)^{-1}n^2 + (4\tau^4 m^3)^{-1}n^4 o_1, \quad o_1 \in [0, 1],$$

which along with the identity

$$(2\tau^2 m)^{-1} n^2 = (2\nu\tau)^{-1} + (2\nu\tau m)^{-1} (\omega n^2 - m)$$

yields

$$-\tau^{-1}e(k)(L(k) - \varkappa) = \omega n^2 - m - C + o_2. \tag{4.14}$$

Here

$$o_2 = C(1 - e(k)) + e(k)(4\tau^4 m^3)^{-1}n^4 o_1, \quad e(k) = (1 - (2\tau\nu m)^{-1})^{-1}.$$

Since

$$(2\nu\tau m)^{-1} \le 2^{-1}\varrho^2 m^{-1} \le \varrho^4 n^{-2} \le 2^{-1},$$

we have

$$1 < e(k) < 2$$
,  $e(k) - 1 < 2\rho^4 n^{-2}$ ,

which along with the inequality  $|C| \leq 3\varrho^2/2$  leads to the estimate

$$|o_2| \le \left(3\varrho^6 + \frac{\varrho^4}{2} \frac{n^6}{m^3}\right) \frac{1}{n^2} \le 5\varrho^{10} n^{-2}.$$

From this, (4.12) and (4.14) we conclude that

$$2\varrho|L(k) - \varkappa| \ge |\omega n^2 - m - C| - 2\varrho^{10}n^{-2} \ge 5(\varrho^2 + \varrho^{10})n^{-1-\alpha} - 5\varrho^{10}n^{-2} \ge 5\varrho^2n^{-1-\alpha}.$$

It remains to note that due (4.13) the right hand side is larger than  $|k|^{-(1+\alpha)/2}$  and the lemma follows.  $\blacksquare$ 

**Lemma 4.6** Suppose that parameters  $\nu_0, \tau_0$  and  $\nu, \tau, \varkappa$  satisfy the following conditions.

(i) There is  $\varrho \geq 2$  so that

$$0 < \varrho^{-1} \le \nu, \tau, \nu_0 < \varrho, \quad |\varkappa| < \varrho.$$

(ii) The dispersion equation

$$\nu_0 k_1^2 - \sqrt{k_1^2 + \tau^2 k_2^2} = 0 (4.15)$$

has the unique positive solution  $k = k_0$ .

(iii) There are positive N and q so that

$$\begin{split} N \geq 2\varrho^2, \quad q \geq 5(\varrho^2 + \varrho^{10}), \\ |\omega n^2 - m - C| \geq q n^{-1-\alpha} \quad \textit{for all integers} \ \ n \geq N, \ m \geq 0 \end{split}$$

Then there are positive  $\delta$  and  $\gamma_0$ , depending on N, q and  $\nu_0$  only, so that

$$|L(k) - \varkappa| \ge \gamma_0 |k|^{-(1+\alpha)/2} \quad for \ all \quad k \ne 0, \pm k_0, \pm k_0^*$$
 (4.16)

when

$$|\nu - \nu_0| + |\varkappa| \le \delta. \tag{4.17}$$

**Proof.** It follows from (iii) that  $\nu$ ,  $\tau$  and  $\varkappa$  meet all requirements of Lemma 4.5 which implies that  $|L(k) - \varkappa| \ge |k|^{-(1+\alpha)/2}$  for all  $|k_1| \ge N$ . On the other hand, since

$$\lim_{|k_2| \to \infty} |L(k) - \varkappa| \ge \lim_{|k_2| \to \infty} \sqrt{\varrho^{-2} k_2^2 + k_1^2} - \varrho k_1^2 - \varrho = \infty,$$

there is  $N^*$  depending on  $\varrho$  and N only so that  $|L(k) - \varkappa| \ge |k|^{-(1+\alpha)/2}$  for all  $|k| \ge N^*$ . Since the number of wave vectors k in the circle  $|k| \le N$  is finite, the existence  $\delta$  and  $\gamma_0$  follows from continuity of L(k) as a function of parameters  $\nu, \tau$ .

**Second step.** Next we prove that condition (iii) from the previous lemma is the generic property of function (4.10) which leads to assertion (a) of Theorem 4.4. In order to formulate the results let us introduce the important function  $d: \mathbb{N}^2 \to \mathbb{R}$  defined by the formula

$$d(m,n) = \omega_0 - \frac{m}{n^2} - \frac{C_0}{n^2}$$
, where  $\omega_0 = \nu_0/\tau$ ,  $C_0 = (2\nu_0\tau)^{-1}$ . (4.18)

**Lemma 4.7** For each  $\alpha \in (0,1]$  and q > 0 there is a set of a full measure  $\mathfrak{M}_{\alpha}$  in  $(1,\infty)$  so that for all  $\nu_0 \in \mathfrak{M}_{\alpha}$ , there exists N > 0, depending on  $\nu_0$ ,  $\alpha$  and q only, such that

$$|d(m,n)| \ge qn^{-3-\alpha} \quad when \quad n \ge N, m \ge 0. \tag{4.19}$$

**Proof.** Noting that  $C_0 = (\omega_0 - \omega_0^{-1})/2$ , we rewrite inequality (4.19) in the equivalent form

$$|d_0(\omega_0, m, n)| \ge qn^{-3-\alpha}$$
 where  $d_0(\omega_0, m, n) = \omega_0 - \frac{1}{n^2} (m - 2^{-1}\omega_0 + 2^{-1}\omega_0^{-1}).$ 

Without loss of generality we can assume also that  $\omega_0 \in [1,a]$ , where a is an arbitrary positive number. The set of points  $\omega_0$  for which  $|d_0(\omega_0,m,n)| \leq qn^{-3-\alpha}$  can be covered by the system of the intervals  $\iota(m,n)$  labelled by integers m and n. It is easy to see that their extremities  $\omega_0^{\pm}(m,n)$  satisfy  $\left(n^2 + \frac{1}{2}\right)\omega_0^{\pm}(m,n) \geq m - \frac{q}{n^{1+\alpha}}$ . On the other hand, since

$$\partial_{\omega} d_0(\omega_0, m, n) = 1 + (2n^2)^{-1} + (2\omega_0^2 n^2)^{-1} \in [1, 2],$$

the length of each intervals is less than  $2qn^{-3-\alpha}$ . Hence for fixed n, the number of intervals  $\iota(m,n)$  having nonempty intersections with a segment [1,a] is less than  $a(n^2+1/2)+q/n^{1+\alpha}$ . From this we conclude that

$$\sum_{n \geq N} \sum_{m: \iota(m,n) \cap [1,a] \neq \emptyset} \text{ meas } \iota(m,n) \leq 2q(\frac{3}{2}a+q) \sum_{n \geq N} n^{-1-\alpha} \leq cq(a+q)N^{-\alpha}.$$

Hence

$$\max \left\{ \omega_0 \in [1, a] : |d_0(\omega, m, n)| \ge q n^{-3-\alpha} \quad \text{for all} \ m \ge 0, n \ge N \right\} \ge a - cq(a+q)N^{-\alpha} \to a \text{ as } N \to \infty.$$

It remains to note that the mapping  $\nu_0 \to \omega_0$  takes diffeomorphically the interval  $[1,\infty)$  onto itself and the lemma follows.

Next lemma shows that almost each point of  $\mathfrak{M}_{\alpha}$  satisfies the following

**Condition M.** There are positive constant  $c_0$ ,  $c_1$  such that for all integers n > 0,  $m \ge 0$ ,

$$|d(m,n)| \ge c_0 n^{-3-\alpha},\tag{4.20}$$

$$\left| e^{2\pi i\omega_0 n} - 1 \right|^{-1} \le c_1 n^2 \tag{4.21}$$

**Lemma 4.8** For each  $\alpha \in (0,1)$  there is a set  $\mathfrak{N}_{\alpha} \subset \mathfrak{M}_{\alpha}$  such that meas  $(\mathfrak{M}_{\alpha} \setminus \mathfrak{N}_{\alpha}) = 0$  and Condition M holds for each  $\nu_0 \in \mathfrak{N}_{\alpha}$ .

**Proof.** We begin with the observation that inequality (4.21) holds for almost every  $\omega_0$  with a constant  $c_1$  depending on  $\omega_0$  only. Hence it suffices to show that inequality (4.20) holds true for each  $\nu_0 \in \mathfrak{M}_{\alpha}$ . Fix  $q=1, \nu \in \mathfrak{M}_{\alpha}$  and note that by lemma (4.7),  $|d(m,n)| \geq n^{-3-\alpha}$  for all  $n \geq N$ . Since  $\lim_{m \to \infty} d(m,n) = -\infty$ , we can choose N such that this inequality is fulfilled for all (m,n) outside of the simplex  $n > 0, m \geq 0, n + m \leq N$ . It remains to note that this simplex contains only finite number of integer points and  $d(m,n) \neq 0$  for irrational  $\omega_0$  different from the sum of a rational and the square root of a rational.

**Third step** We intend now to study the robustness of estimate (4.20) when one adds a small perturbation to d(m, n). In order to formulate the corresponding result we introduce some notations. For each  $\varepsilon \in [0, r_0]$  and  $j \ge 1$  set

$$\tilde{\omega}_j(\varepsilon) = \nu_j(\varepsilon)/\tau, \quad \tilde{C}_j(\varepsilon) = (2\nu_j(\varepsilon)\tau)^{-1} - \varkappa_j(\varepsilon)\tau^{-1}$$

It follows from (4.3) that they have the representation

$$\tilde{\omega}_i(\varepsilon) = \omega_0 - \varepsilon^2 \omega_1 + \varepsilon^3 \tilde{\Omega}_i(\varepsilon), \tilde{C}_i(\varepsilon) = C_0 - \varepsilon^2 \tilde{\varphi}_i(\varepsilon) \quad \varepsilon \in [0, r_0],$$

in which  $\omega_1 = \tau^{-1}\nu_1$ . Our task is to obtain the estimates for the function  $\tilde{D}_j: [0, r_0] \times \mathbb{N}^2 \to \mathbb{R}$  defined by

$$\tilde{D}(\varepsilon, m, n, ) = \tilde{\omega_j}(\varepsilon) - \frac{m}{n^2} - \frac{C_0}{n^2} + \varepsilon^2 \frac{\tilde{\varphi_j}(\varepsilon)}{n^2}.$$
(4.22)

For technical reason it is convenient to formulate the problem in terms of a new small parameter  $\lambda$ . Set

$$\lambda = \varepsilon^{2}, \quad \varphi_{j}(\lambda) = \tilde{\varphi}_{j}(\sqrt{\lambda}), \quad \Omega_{j}(\lambda) = \tilde{\Omega}_{j}(\sqrt{\lambda}),$$
  

$$\omega_{j}(\lambda) = \omega_{0} - \lambda \omega_{1} + \lambda^{3/2} \Omega_{j}(\lambda), \quad \lambda \in [0, \rho_{0}],$$
(4.23)

where  $\rho_0 = r_0^2$ . It follows from (4.4) that for suitable choice R and  $r_0$ ,

$$|\Omega_j| + |\varphi_j| \le R, \quad |\Omega_{j+1} - \Omega_j| + |\varphi_{j+1} - \varphi_j| \le R(2^{-j}), \quad |\Omega_j'(\lambda)| + |\varphi_j'(\lambda)| \le \frac{R}{2\sqrt{\lambda}}.$$

$$(4.24)$$

Set

$$D_j(\lambda, m, n, ) := \tilde{D}_j(\sqrt{\lambda}, m, n) = \omega_j(\lambda) - \frac{m}{n^2} - \frac{C_0}{n^2} + \lambda \frac{\varphi_j(\lambda)}{n^2}. \tag{4.25}$$

**Definition 4.9** For positive N, q, r denote by  $\mathcal{H}_j(N,q,r)$  the set defined by

$$\mathcal{H}_{j}(N,q,r) = \Big\{ \lambda \in (0,r) : |D_{j}(\lambda,m,n)| \ge qn^{-4} \text{ for all integers } n \ge N, \quad m \ge 0 \Big\}.$$

$$(4.26)$$

**Theorem 4.10** Assume that  $\nu_0 \in \mathfrak{N}_{\alpha}$  with  $\alpha \in (0, 1/78)$ . Then, for each q > 0, there is N > 0 such that

$$\frac{1}{r} \ meas \bigcap_{j\geq 1} \{\mathcal{H}_j(N,q,r)\} \to 1 \quad as \quad r \to 0, \tag{4.27}$$

and there exists  $c^*$  such that

$$\frac{1}{r} \ meas \ \bigcap_{j \ge 1} \{ \mathcal{H}_j(N, q, r) \} \ge 1 - c^* r^{\varpi} \ for \ 0 < r < r^*, \tag{4.28}$$

where  $0 < \varpi < \min\{\alpha/(3-\alpha), (78^{-1}-\alpha)/(3+\alpha)\}.$ 

**Proof.** Subsection 4.1 is devoted to the proof.

**Fourth step.** We are now in a position to complete the proof of Theorem 4.4. First note that by Lemmas 4.7 and 4.8 for each  $\nu_0 \in \mathfrak{N}_{\alpha}$ , parameters  $\nu = \nu_0(\tau)$  and  $\varkappa = 0$  meet all requirements of Lemma 4.6 with  $\delta = 0$ . Applying this lemma we obtain (4.8). It remains to note that for almost all  $\nu_0$  the dispersion equation has the only positive solution  $k_0$  and assertion (a) follows. In order to prove (b) choose an arbitrary  $\nu_0 \in \mathfrak{N}_{\alpha}$ , q > 0 and set

$$\mathcal{E} = \left\{ \varepsilon > 0 : \varepsilon^2 \in \bigcap_{j \ge 1} \mathcal{H}_j(N, q, r) \right\},$$

where N is given by Theorem 4.10. It follows from this theorem that the set  $\mathcal{E}$  satisfies density condition (4.6). On the other hand, (4.26) implies that for  $\varepsilon \in \mathcal{E}$ , parameters  $\nu = \nu_j(\varepsilon)$ ,  $\varkappa = \varkappa_j(\varepsilon)$  meet all requirements of Lemma 4.6. Since

$$|\nu_i(\varepsilon) - \nu_0| + |\varkappa_i(\varepsilon)| \to 0 \text{ as } \varepsilon \to 0$$

uniformly with respect to j, there exists  $\varepsilon_2 > 0$  depending on  $\nu_0$  and R only such that for all  $\varepsilon \in \mathcal{E} \cap (0, \varepsilon_2)$ , parameters  $\nu = \nu_j(\varepsilon)$  and  $\varkappa = \varkappa_j(\varepsilon)$  satisfy inequality (4.17) which yields (4.16) (where  $\alpha = 1$ ), and the theorem follows.

# 4.1 Proof of Theorem 4.10

Our approach is based on standard methods of metric theory of Diophantine approximations and Weil Theorem on the uniform distribution of a sequence  $\{\omega_0 n^2\}$ . Without loss of generality we can assume that  $\omega_1 > 0$ , and  $\rho_0 = r_0^2$  satisfies the inequality

$$\rho_0 < \frac{\omega_0}{4}(\omega_1 + R)^{-1} \Rightarrow \omega(\lambda) \ge \frac{3\omega_0}{4} \text{ for } \lambda \le \rho_0.$$
(4.29)

It follows from (4.24) that the sequences  $\Omega_j$  and  $\varphi_j$  converge uniformly on  $[0, \rho_0]$  to functions  $\Omega_{\infty}$  and  $\varphi_{\infty}$  such that

$$|\Omega_{\infty}| + |\varphi_{\infty}| \le R, |\Omega_{\infty} - \Omega_j| + |\varphi_{\infty} - \varphi_j| \le 2^{1-j}R, |\Omega_{\infty}'(\lambda)| + |\varphi_{\infty}'(\lambda)| \le 2^{-1}\lambda^{-1/2}R.$$
(4.30)

Our task is to estimate the measure of intersection of the sets  $\mathcal{H}_j$ . We begin with the investigation of their structure.

Structure of a set  $\mathcal{H}_j(N,q,r)$ . The main result of this paragraph is the following covering lemma. Fix an arbitrary positive q and set

$$r_2 = \min\left\{\frac{\rho_0}{2}, \frac{\omega_1^2}{128R^2}\right\}, \quad N_3(q) = \max\left\{\left(\frac{16R}{\omega_1}\right)^{1/2}, \left(\frac{2q}{c_0}\right)^{1/(1-\alpha)}, \left(\frac{4q}{\omega_1 r_2}\right)^{1/4}\right\}, \tag{4.31}$$

where  $c_0$  is the constant from Condition M.

**Lemma 4.11** For  $N > N_3(q)$ ,  $r < r_2$  and  $1 \le j \le \infty$ , the set  $[0, r] \setminus \mathcal{H}_j(N, q, r)$  is covered by the system of the intervals

$$I_j(m,n) = (\lambda_j^-(m,n), \lambda_j^+(m,n)), \quad n \ge N \quad I_j(m,n) \cap [0,r] \ne \emptyset,$$

such that

(i)  $\lambda_i^{\pm}(m,n)$  are solutions of the equations

$$\lambda_j^{\pm} \left( \omega_1 - \frac{\varphi_j(\lambda_j^{\pm})}{n^2} \right) - (\lambda_j^{\pm})^{3/2} \Omega(\lambda_j^{\pm}) = d(m, n) \pm \frac{q}{n^4}$$
 (4.32)

with d(m, n) > 0. They satisfy the inequalities

$$0 < \lambda_{i}^{-}(m, n) < \lambda_{i}^{+}(m, n) < 2r_{2}, \tag{4.33}$$

$$\frac{2}{5\omega_1}d(m,n) \le \lambda_j^{\pm} \le \frac{2}{\omega_1}d(m,n) \tag{4.34}$$

$$\frac{4q}{3\omega_1} \frac{1}{n^4} \le \lambda_j^+(m,n) - \lambda_j^-(m,n) \le \frac{4q}{\omega_1} \frac{1}{n^4}.$$
 (4.35)

(ii) For a fixed n > N, the left extremities  $\lambda_{-}^{j}(m,n)$  strongly decreases in m,

$$\lambda_{j}^{-}(M_{j,n}(r), n) \le \lambda_{j}^{-}(M_{j,n}(r) - 1, n) \le \dots \le \lambda^{-}(m_{j,n}(r), n),$$
 (4.36)

$$\lambda_j^-(k-1,n) - \lambda_j^-(k,n) \ge \frac{2}{3\omega_1 n^2},$$
 (4.37)

where

$$m_{j,n}(r) = \min\{m > 0 : I_j(m,n) \cap [0,r] \neq \emptyset\},\$$
  
 $M_{j,n}(r) = \max\{m > 0 : I_j(m,n) \cap [0,r] \neq \emptyset\}.$ 

(iii) For each such interval with  $I_j(m,n) \cap [0,r] \neq \emptyset$ ,

$$d(m,n) \le \frac{5}{2}\omega_1 r, \quad n \ge \left(\frac{2c_0}{5\omega_1}\right)^{1/(3+\alpha)} r^{-1/(3+\alpha)}, \lambda_j^+(m,n) \le 2r. \quad (4.38)$$

(iv) If intervals  $I_j(m,n)$  and  $I_{\infty}$  have nonempty intersections with (0,r], then

$$|\lambda_j^{\pm}(m,n) - \lambda_{\infty}^{\pm}(m,n)| \le 2^{-j-4}\omega_1.$$
 (4.39)

**Proof.** By abuse of notations, we suppress the index j. Proof of (i).

$$-\partial_{\lambda}D(\lambda, m, n) = \omega_1 - \frac{\varphi + \lambda \varphi'}{n^2} - \frac{3}{2}\lambda^{1/2}\Omega(\lambda) - \lambda^{3/2}\Omega'(\lambda),$$

it follows from (4.31)and (4.24) that for  $\lambda \leq 2r_2$ 

$$\omega_1 - \frac{2R}{n^2} - 2R\lambda^{1/2} \le -\partial_\lambda D(\lambda, m, n) \le \omega_1 + \frac{2R}{n^2} + 2R\lambda^{1/2},$$

which along with (4.31) implies the inequalities

$$\frac{\omega_1}{2} \le -\partial_{\lambda} D(\lambda, m, n) \le \frac{3\omega_1}{2} \quad \text{for} \quad \lambda \in [0, 2r_2], \quad n > N_3. \tag{4.40}$$

Hence the function  $-D(\lambda, m, n)$  is strongly monotone on the interval  $(0, 2r_2)$ . Therefore for  $r < r_2, N \ge N_3$  the set  $(0, r) \setminus \mathcal{H}(N, q, r)$  can be covered by the system of the intervals

$$J(m,n) = (\beta(m,n), \gamma(m,n)), \quad 0 \le \beta(m,n) < \gamma(m,n) \le r,$$

such that

$$-D(\beta(m,n), m, n) = -\frac{q}{n^4} \text{ if } \beta(m,n) > 0, \tag{4.41}$$

$$-D(\gamma(m, n), m, n) = +\frac{q}{n^4} \text{ if } \gamma(m, n) < r, \tag{4.42}$$

$$-\frac{q}{n^4} \le -D(\beta(m,n), m, n) < \frac{q}{n^4} \text{ if } \beta(m,n) = 0$$
 (4.43)

$$-\frac{q}{n^4} < -D(\gamma(m, n), m, n) \le \frac{q}{n^4} \text{ if } \gamma(m, n) = r, \tag{4.44}$$

Note that, by condition M,

$$\frac{q}{n^4} = \frac{q}{c_0 n^{1-\alpha}} \frac{c_0}{n^{3+\alpha}} \le \frac{q}{c_0 n^{1-\alpha}} |d(m,n)|,$$

which along with (4.31) yields the inequalities

$$\frac{1}{2}|d(m,n)| \le |d(m,n) \pm \frac{q}{n^4}| \le \frac{3}{2}|d(m,n)|, \quad |d(m,n)| \ge 2\frac{q}{n^4} \quad \text{for} \quad n \ge N_3.$$
(4.45)

From this and the equality D(0, m, n) = d(m, n) we conclude that case (4.43) is impossible and  $\beta(m, n) > 0$  for all intervals J(m, n). Let us consider case (4.44). Since the function  $-D(\lambda, m, n)$  increases in  $\lambda$  on the segment  $[0, 2r_2]$ , there is a maximal  $\gamma *$  in  $(0, 2r_2]$  such that

$$(\beta(m,n),r) \subset (\beta(m,n),\gamma^*) \subset (\beta(m,n),2r_2),$$
  
 $|D(\lambda,m,n)| \leq qn^{-4} \text{ in } (\beta(m,n),\gamma^*).$ 

Let us show that  $\gamma^* < 2r_2$ . If the assertion is false, then  $r_2, 2r_2 \in (\beta(m, n), \gamma^*]$  which yields

$$-qn^{-4} \le -D(r_2, m, n) \le -D(2r_2, m, n) \le qn^{-4}.$$

Thus we get

$$r_2 \min_{[r_2, 2r_2]} \{-\partial_{\lambda} D(\lambda, m, n)\} \le D(r_2, m, n) - D(2r_2, m, n) \le 2qn^{-4} \le 2qN_3^{-4}.$$

From this and (4.40) we obtain the inequality

$$\omega_1 \frac{r_2}{2} \le 2q N_3^{-4},$$

which contradicts (4.31), and the assertion follows. In particular, we have  $-D(\gamma^*, m, n) = qn^{-4}$ . Since the equations  $-D(\lambda_{\pm}, m, n) = \pm qn^{-4}$  are equivalent to (4.32), in the cases (4.41), (4.42) we have in the cases (4.41), (4.42) that

$$\beta(m,n) = \lambda^{-}(m,n), \quad \gamma(m,n) = \lambda^{+}(m,n), \quad J(m,n) = I(m,n),$$

in the case (4.44) we have

$$\beta(m,n) = \lambda^{-}(m,n), \quad \gamma^* = \lambda^{+}(m,n), \quad J(m,n) \subset I(m,n).$$

Hence the set  $[0, r] \setminus \mathcal{H}(N, q, r)$  is covered by the intervals I(m, n) with the ends satisfying (4.32), (4.33). It follows from (4.31) and (4.24) that for  $n > N_3(q)$ ,  $\lambda < r_2$ ,

$$\frac{3\omega_1}{4}\lambda \le \lambda \left(\omega_1 - \frac{\varphi}{n^2}\right) - \lambda^{3/2}\Omega(\lambda) \le \frac{5}{4}\omega_1\lambda. \tag{4.46}$$

In particular, the left side of equation (4.32) is positive, which along with (4.45) yields positivity of d(m, n) in the right side of equations (4.32). Combining (4.32), (4.46), (4.45) gives (4.34). Next equation (4.32) implies

$$D(\lambda^{-}(m, n), m, n) - D(\lambda^{+}(m, n), m, n) = 2qn^{-4}$$
.

From this and (4.40) we conclude that

$$\omega_1(\lambda^+(m,n) - \lambda^-(m,n)) \le 4qn^{-4},$$
  
 $\omega_1(\lambda^+(m,n) - \lambda^-(m,n)) \ge \frac{4}{3}qn^{-4},$ 

which yields

$$\frac{4q}{3\omega_1} \frac{1}{n^4} \le \lambda^+(m,n) - \lambda_-(m,n) \le \frac{4q}{\omega_1} \frac{1}{n^4}$$

and the assertion follows:

Let us turn to the proof of (ii). By Lemma 4.11(i),  $I(m,n) \cap [0,r] \neq \emptyset$  if and only if  $\lambda^-(m,n) \leq r$ . In particular,  $0 < \lambda^-(m_n(r),n), \lambda^-(M_n(r),n) \leq r$ . On the other hand,  $\lambda^-(m,n)$  is a solution to the equation

$$-D(\lambda^{-}(m,n),m,n) = -qn^{-4}. (4.47)$$

By (4.40) we have

$$-\partial_m D(\lambda, m, n) = \frac{1}{n^2}, \quad \frac{\omega_1}{2} \le -\partial_\lambda D(\lambda, m, n) \le \frac{3\omega_1}{2} \text{ for } \lambda \in [0, r].$$

Hence for fixed  $n \geq N_3$ , the implicit function  $\lambda^-(m,n)$  satisfying the equation (4.47) is defined and strongly decreases on the interval  $[m_n(r), M_n(r)]$  which yields (4.36). The relation  $I(k,n) \cap [0,r] \neq \emptyset$  for each integer  $k \in [m_n(r), M_n(r)]$  follows from (4.36). Next if  $m_n(r) \leq k - 1 \leq k \leq M_n(r)$ , then we have

$$\begin{split} 0 &= -D(\lambda^-(k-1,n), k-1,n) + D(\lambda^-(k,n), k,n) = \\ &= -D(\lambda^-(k-1,n), k-1,n) + D(\lambda^-(k,n), k-1,n) + \\ &- D(\lambda^-(k,n), k-1,n) + D(\lambda^-(k,n), k,n) \\ &= -D(\lambda^-(k-1,n), k-1,n) + D(\lambda^-(k,n), k-1,n) - \frac{1}{n^2} \\ &\leq \max_{\lambda \in [0,r]} \{ -\partial_\lambda D(\lambda, k-1,n) \} (\lambda^-(k-1,n) - \lambda^-(k,n)) - \frac{1}{n^2} \\ &\leq \frac{3\omega_1}{2} (\lambda^-(k-1,n) - \lambda^-(k,n)) - \frac{1}{n^2}, \end{split}$$

and hence

$$\frac{3\omega_1}{2}(\lambda^-(k-1,n)-\lambda^-(k,n)) \ge \frac{1}{n^2}$$

which completes the proof of (ii).

Next note that (4.38) is a consequence of the inequalities

$$\frac{2c_0}{5\omega_1}\frac{1}{n^{3+\alpha}} \le \frac{2}{5\omega_1}d(m,n) \le \lambda^-(m,n) \le r,$$

and (iii) follows.

It remains to prove (iv). We have

$$D_{\infty}(\lambda_{\infty}^{\pm}, m, n) - D_{\infty}(\lambda_{i}^{\pm}, m, n) = D_{j}(\lambda_{i}^{\pm}, m, n) - D_{\infty}(\lambda_{i}^{\pm}, m, n).$$

On the other hand,

$$|D_{j}(\lambda_{j}^{\pm}, m, n) - D_{\infty}(\lambda_{j}^{\pm}, m, n)| \leq \frac{\lambda_{j}^{\pm}}{N^{2}} |\varphi_{\infty} - \varphi_{j}| + (\lambda_{j}^{\pm})^{3/2} |\Omega_{\infty} - \Omega_{j}| \leq 2r_{2}R2^{-j}(N^{-2} + 1) < 4r_{2}R2^{-j},$$

which along with (4.40) and (4.31) implies

$$|\lambda_{\infty}^{\pm}(m,n) - \lambda_{j}^{\pm}(m,n)| \le \frac{8R}{\omega_{1}} r_{2} 2^{-j} \le \frac{\omega_{1}}{16} 2^{-j},$$

and the lemma follows.  $\blacksquare$ 

Cardinality of the set  $\{I_i(m,n)\}$ . Set

$$\theta_n = \{\omega_0 n^2 - C\} = \text{ decimal part of } \omega_0 n^2 - C,$$

and introduce the sequence of numbers  $\delta_n(r)$  defined by

$$\delta_n(r) = 1$$
 when  $\theta_n \leq \frac{5}{2}\omega_1 r n^2$ , and  $\delta_n(r) = 0$  otherwise.

**Lemma 4.12** For each  $n \ge N_3$  and  $0 < r < r_2, 1 \le j \le \infty$ ,

$$card \{m: I_j(m,n) \cap [0,r] \neq \emptyset\} \leq \delta_n + crn^2. \tag{4.48}$$

**Proof.** For simplicity we omit the index j. Denote by  $\mathcal{I}$  the totality of all intervals I(m,n) given by Lemma 4.11 such that  $I(m,n) \cap [0,r_2] \neq \emptyset$ . By assertion (ii) of Lemma 4.11 there is one-to-one correspondence between the intervals  $I(m,n) \in \mathcal{I}$ , having nonempty intersection with [0,r], and the sequence of  $\lambda^-(k,n)$  given by (4.36). In particular, we have

card 
$$\{m: I(m,n) \cap [0,r] \neq \emptyset\} = M_n(r) - m_n(r) + 1.$$
 (4.49)

On the other hand, inequality (4.37) yields

$$\lambda^{-}(m_n(r), n) - \lambda^{-}(M_n(r), n) \ge (M_n(r) - m_n(r)) \frac{2}{3\omega_1 n^2}$$

Since  $m_n(r), M_n(r) \in [0, r]$ , we conclude from this that

$$M_n(r) - m_n(r) \le cn^2 r$$
.

Combining this inequality with (4.49) we obtain

card 
$$\{m: I(m,n) \cap [0,r] \neq \emptyset\} \le 1 + crn^2$$
 (4.50)

On the other hand, for given  $n > N_3$ ,

$$\Big(\bigcup_{m:I(m,n)\in\mathcal{I}}I(m,n)\Big)\cap[0,r]=\emptyset \ \ \text{if} \ \ \min_{m:I(m,n)\in\mathcal{I}}\lambda_-(m,n)>r.$$

Since, by Lemma 4.11,  $0 < \frac{2}{5\omega_1}d(m,n) \le \lambda_-(m,n)$ , we conclude from this that

$$\left(\bigcup_{m:I(m,n)\in\mathcal{I}}I(m,n)\right)\cap[0,r]=\emptyset \ \text{if} \ \min_{m:d(m,n)>0}d(m,n)>\frac{5}{2}\omega_1r$$

Obviously

$$\min_{m:d(m,n)>0} d(m,n) = \frac{1}{n^2} \min_{m:\omega_0 n^2 - C - m > 0} (\omega_0 n^2 - C - m) = \frac{\theta_n}{n^2},$$

which yields

card 
$$\{m: I(m,n) \cap [0,r] \neq \emptyset\} = 0$$
 for  $\frac{\theta_n}{n^2} > \frac{5}{2}\omega_1 r$  (4.51)

Combining (4.50) and (4.51) we obtain

$$\sum_{m:I(m,n)\cap[0,r]\neq\emptyset} 1 = \operatorname{card} \{m:I(m,n)\cap[0,r]\neq\emptyset\} \le \delta_n(r) + crn^2,$$

and the lemma follows.

**Proof of Theorem 4.10.** First note that

$$\operatorname{meas} \, \Big([0,r] \backslash \bigcap_{j=1}^{\infty} \mathcal{H}_j(N,q,r) \Big) \leq \sum_{\stackrel{(m,n) \, : \, n \, \geq \, N_3}{I_j(m,n) \, \cap \, [0,r] \, \neq \, \emptyset}} \, \operatorname{meas} \, \Big( \bigcup_{j=1}^{\infty} I_j(m,n) \Big) := \wp(r).$$

The following lemma gives an estimate for  $\wp$  in terms of the sequence  $\delta_n(r)$ .

**Lemma 4.13** For each  $N \ge N_3$ ,  $0 < r < r_2$ , and  $\sigma \in (0, 1/(3 + \alpha))$ ,

$$\wp(r) \le \sum_{n > c_3 r^{-1/(3+\alpha)}} c \frac{\delta_n(r)}{n^4} (\ln n + 1) + c r^{1+\sigma}, \tag{4.52}$$

where c depends on  $\omega_1$ ,  $\alpha$ ,  $\sigma$  and R only,  $c_3 = \left(\frac{2c_0}{5\omega_1}\right)^{1/(3+\alpha)}$ ,  $c_0$  is the constant from Condition M.

**Proof.** Introduce the sequence

$$\varsigma(n) = \frac{4}{\ln 2} \ln n - \frac{1}{\ln 2} \ln \left[ \frac{64}{3\omega_1^2} q \right], \quad n \ge 1.$$

It is easy to see that  $\omega_1 2^{-j-4} < 4q/(3\omega_1 n^4)$  for all  $j > \varsigma(n)$ . It follows from this and (4.39) that for all such j, the intervals  $I_j(m,n)$  have nonempty intersections with  $I_{\infty}(m,n)$  and  $\bigcup_{j>\varsigma(n)}I_j(m,n)\subset \tilde{I}_{\infty}(m,n)$ , which yields

meas 
$$\left(\bigcup_{j>\varsigma(n)} I_j(m,n)\right) \le \text{ meas } \tilde{I}_{\infty}(m,n) \le \frac{20q}{3\omega_1} \frac{1}{n^4}$$

where  $\widetilde{I}_{\infty}(m,n)$  is the  $4q/(3\omega_1 n^4)$ - neighborhood of  $I_{\infty}(m,n)$ . Thus we get

$$\wp(r) \leq \sum_{\substack{n \geq N_3 \\ I_j(m,n) \cap [0,r] \neq \emptyset}} \sum_{j=1}^{\varsigma(n)} \sum_{(m:I_j(m,n) \cap [0,r] \neq \emptyset} \operatorname{meas} I_j(m,n) + \sum_{\substack{n \geq N_3 \\ I_j(m,n) \cap [0,r] \neq \emptyset}} \sum_{(m:I_{\infty}(m,n) \cap [0,r] \neq \emptyset} \operatorname{meas} \left(\bigcup_{j>\varsigma(n)} I_j(m,n)\right),$$

which leads to

$$\wp(r) \le \sum_{\substack{n \ge N_3 \\ I_j(m,n) \cap [0,r] \neq \emptyset}} \frac{c}{n^4} \sum_{j=1}^{\varsigma(n)} \sum_{(m:I_j(m,n) \cap [0,r] \neq \emptyset} 1 + \sum_{n \ge N_3} \frac{c}{n^4} \sum_{(m:I_\infty(m,n) \cap [0,r] \neq \emptyset} 1,$$

Since, by Lemma 4.11, the intersection  $I_j(m,n) \cap [0,r]$  is empty for  $n < c_3 r^{-1/(3+\alpha)}$ , we have

$$\wp(r) \le \sum_{n \ge c_3 r^{-1/(3+\alpha)}} \frac{c}{n^4} \sum_{j=1}^{\varsigma(n)} \operatorname{card} \{ m : I_j(m,n) \cap [0,r] \ne \emptyset \} + \sum_{n \ge c_3 r^{-1/(3+\alpha)}} \frac{c}{n^4} \operatorname{card} \{ m : I_\infty \cap [0,r] \ne \emptyset \},$$

which along with (4.48) yields

$$\wp(r) \leq \sum_{n \geq c_3 r^{-1/(3+\alpha)}} \frac{c}{n^4} \varsigma(n) (\delta_n(r) + crn^2) + \sum_{n \geq c_3 r^{-1/(3+\alpha)}} \frac{c}{n^4} (\delta_n + crn^2),$$

$$\leq c \sum_{n \geq c_3 r^{-1/(3+\alpha)}} \frac{\delta_n(r)}{n^4} (1 + \ln n) + cr \sum_{n \geq c_3 r^{-1/(3+\alpha)}} \frac{1 + \ln n}{n^2}$$

$$\leq \sum_{n \geq c_3 r^{-1/(3+\alpha)}} c \frac{\delta_n(r)}{n^4} (1 + \ln n) + cr^{1+\sigma},$$

which completes the proof. Introduce the sequence

$$\nu_n(r) = 1$$
 when  $\theta_n \leq \frac{5}{2}\omega_1 r^{\frac{1-\alpha}{3-\alpha}}$ , and  $\nu_n(r) = 0$  otherwise.

**Lemma 4.14** Let  $0 < r \le r_2$  and  $0 < \beta < \alpha/(3 - \alpha)$ .

If  $c_3 r^{\frac{-1}{3+\alpha}} \ge r^{\frac{-1}{3-\alpha}}$ , then

$$\wp(r) \le cr^{1+\beta}.\tag{4.53}$$

If  $c_3 r^{\frac{-1}{3+\alpha}} < r^{\frac{-1}{3-\alpha}}$ , then

$$\wp(r) \le c \sum_{\substack{c_3 r^{-1/(3+\alpha)} \le n \le r^{-1/(3-\alpha)}}} \frac{\nu_n(r)}{n^4} (1 + \ln n) + cr^{1+\beta}, \tag{4.54}$$

where c does not depend on r.

**Proof.** Since  $\beta < 1/(3+\alpha)$ , we have from inequality (4.52)

$$\wp(r) \le c\Pi(r) + \sum_{n \ge r^{-1/(3-\alpha)}} c \frac{\delta_n(r)}{n^4} (1 + \ln n) + cr^{1+\beta}, \tag{4.55}$$

where

$$\Pi(r) = \sum_{c_3 r^{-1/(3+\alpha)} \le n \le r^{-1/(3-\alpha)}} \frac{\delta_n(r)}{n^4} (1 + \ln n) \text{ for } c_3 r^{\frac{-1}{3+\alpha}} < r^{\frac{-1}{3-\alpha}},$$

and  $\Pi(r) = 0$  otherwise. It is easy to see that

$$\sum_{n \ge r^{-1/(3-\alpha)}} \frac{\delta_n(r)}{n^4} (1 + \ln n) \le \sum_{n \ge r^{-1/(3-\alpha)}} \frac{1}{n^4} (1 + \ln n) \le cr^{1+\beta}$$
 (4.56)

If  $n \le r^{-1/(3-\alpha)}$  then  $\theta_n > \frac{5}{2}\omega_1 r^{(1-\alpha)/(3-\alpha)}$  yields  $\theta_n > \frac{5}{2}\omega_1 n^2 r$ . In other words, equality  $\nu_n(r) = 0$  yields  $\delta_n(r) = 0$ . Hence

$$\Pi(r) \le \sum_{c_3 r^{-1/(3+\alpha)} \le n \le r^{-1/(3-\alpha)}} \frac{\nu_n(r)}{n^4} (1 + \ln n) \text{ for } c_3 r^{\frac{-1}{3+\alpha}} < r^{\frac{-1}{3-\alpha}}, \quad (4.57)$$

and  $\Pi(r) = 0$  otherwise. Substituting (4.56) and (4.57) into (4.55) and noting that we obtain needed inequalities (4.53), (4.54).

Now set

$$r_3 = \min\{\left(\left(\frac{5}{2}\omega_1\right)^{-1}c_3^{-\frac{1}{78}}\right)^{1/\iota}, c_3^{3+\alpha}\left(\frac{1}{4}\right)^{78(3+\alpha)}\}, \quad \iota = \frac{1-\alpha}{3-\alpha} - \frac{1}{78(3+\alpha)}$$

**Remark** This complicated formulae simply express the fact that the number  $\rho = \left(c_3^{-1} r^{1/(3+\alpha)}\right)^{1/78}$  satisfies the inequalities

$$\frac{5}{2}\omega_1 r^{(1-\alpha)/(3-\alpha)} \le \rho \le 1/4 \text{ for } r \le r_3.$$

**Lemma 4.15** Let,  $0 < r \le r_3$ ,  $c_3 r^{-1/(3+\alpha)} < r^{-1/(3-\alpha)}$ , and  $0 < \gamma < (1/78 - \alpha)/(3+\alpha)$ . Then

$$\sum_{c_3 r^{-1/(3+\alpha)} \le n \le r^{-1/(3-\alpha)}} \frac{\nu_n(r)}{n^4} (1 + \ln n) \le c r^{1+\gamma}. \tag{4.58}$$

**Proof.** Let p and q be the minimal and maximal integers from the interval  $(c_3r^{-1/(3+\alpha)}, r^{-1/(3-\alpha)})$ . Introduce the average

$$S_n(r) = \frac{1}{n} \sum_{k=1}^{n} \nu_k(r),$$

Noting that  $\nu_n(r) = nS_n - (n-1)S_{n-1}$ , we obtain

$$\sum_{\substack{c_3 r^{-1/(3+\alpha)} \le n \le r^{-1/(3-\alpha)}}} \frac{\nu_n(r)}{n^4} = \sum_{\substack{p \le n \le q}} \frac{\nu_n(r)}{n^4}$$
$$\le \sum_{\substack{p \le n \le q-1}} \left(\frac{1+\ln n}{n^4} - \frac{1+\ln(n+1)}{(n+1)^4}\right) nS_n + \frac{1}{q^3} S_q.$$

Since  $q \ge c_3 r^{-1/(3+\alpha)}$  and

$$\left(\frac{1+\ln n}{n^4} - \frac{1+\ln(n+1)}{(n+1)^4}\right)n \le \frac{c}{n^4}(1+\ln n),$$

we conclude from this that

$$\sum_{\substack{c_3r^{-1/(3+\alpha)} \le n \le r^{-1/(3-\alpha)}}} \frac{\nu_n(r)}{n^4} (1 + \ln n)$$

$$\le c \Big\{ \sum_{\substack{c_3r^{-1/(3+\alpha)} \le n \le r^{-1/(3-\alpha)}}} \frac{1}{n^4} (1 + \ln n) + r^{3/(3+\alpha)} \Big\} \sup_{\substack{n \ge c_3r^{-1/(3+\alpha)}}} S_n \le cr^{(3-\vartheta)/(3+\alpha)} \sup_{\substack{n \ge c_3r^{-1/(3+\alpha)}}} S_n, \tag{4.59}$$

where  $\vartheta$  is an arbitrary positive number. Now set

$$\rho = \left(c_3^{-1} r^{1/(3+\alpha)}\right)^{1/78}.$$

It follows from the choice of  $r_3$  and the inequality  $r < r_3$  that

$$\frac{5}{2}\omega_1 r^{(1-\alpha)/(3-\alpha)} \le \rho < 1/4, \quad n \ge c_3 r^{-1/(3+\alpha)} \Rightarrow n \ge \rho^{-78}.$$
 (4.60)

It follows from this that

$$S_n \equiv \frac{1}{n} \sum_{\substack{1 \le k \le n \\ \theta_n \le \frac{5}{2}\omega_1 r^{(1-\alpha)/(3-\alpha)}}} 1 \le \frac{1}{n} \sum_{\substack{1 \le k \le n, \\ \theta_n \in [0, \rho]}} 1.$$

Applying Proposition E.1 we obtain that for any  $n \ge c_3 r^{-1/(3+\alpha)} = \rho^{-78}$ 

$$S_n \le c\rho = cr^{1/78(3+\alpha)},$$

Combining this inequality with (4.59) we finally obtain

$$\sum_{c_3 r^{-1/(3+\alpha)} \le n \le r^{-1/(3-\alpha)}} \frac{\nu_n(r)}{n^4} (1 + \ln n) \le c r^{1/78(3+\alpha)} r^{(3-\vartheta)/(3+\alpha)} = c r^{1+\gamma},$$

and the lemma follows.  $\blacksquare$ 

Finally, combining inequalities (4.53), (4.54) and (4.58) we conclude that for  $0 < r < r_3$ ,

$$\wp(r) \le cr(r^{\beta} + r^{\gamma}) \le cr^{1+\varpi},$$

which completes the proof of Theorem 4.10.

# 5 Descent method-Inversion of the linearized operator

In this section we give a general method of reduction, the descent method, allowing to transform the original linear operator of order 2 into the sum of a main operator with constant coefficients and a smoothing perturbation operator.

Let us consider the basic operator equation

$$\mathfrak{L}u + \mathfrak{A}\mathfrak{D}_1 u + \mathfrak{B}u + \mathfrak{L}_{-1} u = f, \tag{5.1}$$

with zero-order pseudodifferential operators  $\mathfrak{A}$ ,  $\mathfrak{B}$  and an integro-differential operator  $\mathfrak{L}_{-1}$  of order -1. Assume that they satisfy the following conditions.

# Symmetry condition:

(i) For all  $Y \in \mathbb{T}^2$  and  $|\xi| \leq 1$ ,

$$A(Y, -\xi) = \overline{A(Y, \xi)},\tag{5.2}$$

which means in particular that  $\mathfrak{A}u$  is real for real-valued functions u.

(ii) Equation (5.1) is invariant with respect to the symmetry  $Y \to Y^* = (-y_1, y_2)$ . This is equivalent to the equivariant property

$$\mathfrak{A}\mathfrak{D}_1 u(Y^*) = \mathfrak{A}\mathfrak{D}_1 u^*(Y), \quad \mathfrak{B}u(Y^*) = \mathfrak{B}u^*(Y),$$
  
$$\mathfrak{L}_{-1} u(Y^*) = \mathfrak{L}_{-1} u^*(Y), \quad u^*(Y) = u(Y^*),$$

$$(5.3)$$

which can be also written in the form

$$A(Y^*, \xi^*) = -A(Y, \xi), \quad B(Y^*, \xi^*) = B(Y, \xi).$$
 (5.4)

(iii) For each  $s \in [1, l-3]$ ,  $H_{o,e}^s(\mathbb{R}^2/\Gamma)$  is invariant subspace of operators  $\mathfrak{AD}_1$ ,  $\mathfrak{B}$  and  $\mathfrak{L}_{-1}$ .

Metric condition:

(iv) There are exponents r, s, and l, satisfying inequalities

$$1 < r < s < l - 10$$
,

and  $\varepsilon \in (0,1]$  so that

$$|\mathfrak{A}|_{4,r} + |\mathfrak{B}|_{4,r} \le \varepsilon, \quad |\mathfrak{A}|_{4,l} + |\mathfrak{B}|_{4,l} < \infty. \tag{5.5}$$

For each  $s \in [r, l-10]$  there is a constant  $C_s$  so that

$$\|\mathcal{L}_{-1}u\|_{r} \le c\varepsilon \|u\|_{r-1},$$

$$\|\mathcal{L}_{-1}u\|_{s} \le c(\varepsilon \|u\|_{s-1} + C_{s}\|u\|_{0}).$$
(5.6)

# Restrictions on the spectrum and resolvent of $\mathfrak{L}$ :

(v) The selfadjoint operator  $\mathfrak{L}: H^s_{o,e}(\mathbb{R}^2/\Gamma) \mapsto H^s_{o,e}(\mathbb{R}^2/\Gamma)$  has a simple eigenvalue  $\nu_1 \varepsilon^2 + O(\varepsilon^3)$  with corresponding eigenfunction  $\psi^{(0)}$ ; the space  $H^s_{o,e}(\mathbb{R}^2/\Gamma)$  is the sum of orthogonal subspaces

$$H_{o,e}^s(\mathbb{R}^2/\Gamma) = \operatorname{span} \{\psi^{(0)}\} \oplus H_{o,e}^{s,\perp};$$

 $H_{o,e}^{s,\perp}$  are invariant subspaces of the operator  $\mathfrak{L}$ . Denote by  $\mathcal{Q}$  the orthogonal projector of  $H_{o,e}^{s}(\mathbb{R}^{2}/\Gamma)$  onto  $H_{o,e}^{s,\perp}$ .

(vi) For

$$\varkappa = \frac{1}{16\nu\pi^2} \int_{\mathbb{T}^2} \left( A(Y,0,1)^2 - 4\nu B(Y,0,1) \right) dY, \tag{5.7}$$

and all  $s \geq 1$ , the inverse  $(\mathfrak{L} - \varkappa)^{-1} : H_{o,e}^{s,\perp} \mapsto H_{o,e}^{s-1,\perp}$  is continuous and

$$\|(\mathfrak{L} - \varkappa)^{-1}u\|_{s-1} \le c(s)\|u\|_{s}. \tag{5.8}$$

#### Nondegeneracy condition:

(vii)

$$\varkappa = O(\varepsilon^2), \quad \int_{\mathbb{T}^2} \left( (\mathfrak{L} + \mathfrak{H}) \psi^{(0)} - \mathfrak{H} \mathcal{Q} (\mathfrak{L} - \varkappa)^{-1} \mathcal{Q} \mathfrak{H} \psi^{(0)} \right) \psi^{(0)} dY = @\varepsilon^2 + O(\varepsilon^3),$$
(5.9)

where @ is a non-zero absolute constant, and the operator  $\mathfrak{H} = \mathfrak{A}\mathfrak{D}_1 + \mathfrak{B} + \mathfrak{L}_{-1}$ .

Here and below we denote by c generic constants depending on r and l only, and use the standard notation  $O(\varepsilon^n)$  for quantities which absolute value does not exceed  $c\varepsilon^n$ . The following theorem is the main result of this section.

**Theorem 5.1** Under the above assumptions, there is a positive constant  $\varepsilon_0$  depending on l, r only so that for any  $f \in H^s_{o,e}(\mathbb{R}^2/\Gamma)$  and  $\varepsilon < \varepsilon_0$ , equation (5.1) has a unique solution  $u \in H^{s-1}_{o,e}(\mathbb{R}^2/\Gamma)$  satisfying the inequalities

$$||u||_{r-1} \le \varepsilon^{-2} c ||f||_r,$$
 (5.10)

$$||u||_{s-1} \le \varepsilon^{-2} c ||f||_r (1 + C_s + |\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) + c ||f||_s.$$
 (5.11)

**Proof.** The proof constitutes the next two subsections.

## 5.1 Descent method

In this subsection we develop an algebraic method which allows us to reduce (5.1) to a Fredholm -type equation. The main result in this direction is the following

**Theorem 5.2** Let zero-order pseudodifferential operators  $\mathfrak A$  and  $\mathfrak B$  satisfy symmetry conditions (i), (ii), metric condition (iv), and  $\varkappa$  is given by (5.7). Then there exist integro-differential operators  $\mathfrak C$ ,  $\mathfrak E$ ,  $\mathfrak F$  satisfying symmetry condition (5.3) with  $\mathfrak B$  replaced by  $\mathfrak C$ ,  $\mathfrak E$ ,  $\mathfrak F$  so that

$$(\mathfrak{L} + \mathfrak{A}\mathfrak{D}_1 + \mathfrak{B})(1 + \mathfrak{C})\Pi_1 = (1 + \mathfrak{E})\Pi_1(\mathfrak{L} - \varkappa) + \mathfrak{F}, \tag{5.12}$$

and for  $1 \le s \le l - 10$ ,

$$\|\mathfrak{C}u\|_{s} + \|\mathfrak{E}u\|_{s} \le c\varepsilon \|u\|_{s} + c(|\mathfrak{A}|_{4,s+9} + |\mathfrak{B}|_{4,s+9}) \|u\|_{0}, \|\mathfrak{F}u\|_{s} \le c\varepsilon \|u\|_{s-1} + c(|\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) \|u\|_{0}.$$
(5.13)

The proof falls into three steps and is based on the following proposition, which gives the special decomposition of zero-order operators and plays the key role in our analysis. In order to formulate it we introduce the important notion of an elementary operator.

**Definition 5.3** Let  $\tilde{W}: \mathbb{T}^2 \to \mathbb{C}$  be a function of class  $C^l(\mathbb{R}^2/\Gamma)$ . We say that  $\mathfrak{W}$  is the elementary operator associated with  $\tilde{W}$ , if  $\mathfrak{W}$  is a zero-order pseudodifferential operator with the symbol  $W(Y, \xi_2) = Re \ \tilde{W}(Y) + i\xi_2 Im \ \tilde{W}(Y)$ .

**Proposition 5.4** Let a zero-order pseudodifferential operators  $\mathfrak{A}$  with symbol  $A(Y,\xi)$ , and an elementary operator  $\mathfrak{W}$ , satisfy conditions (3.12), (5.2), and  $\mathfrak{S}$  be a pseudodifferential operator with the symbol  $S(Y,\xi) = W(Y,\xi_2)A(Y,\xi)$ . Then there exist pseudodifferential operators  $\mathfrak{M}_A$ ,  $\mathfrak{P}_A$ ,  $\mathfrak{U}_S$  and  $\mathfrak{N}_A$ ,  $\mathfrak{Q}_A$ ,  $\mathfrak{V}_S$  so that

$$\mathfrak{A}\Pi_1 = \sum_{j=0}^{1} \mathfrak{A}_j \mathfrak{D}_1^{-j} + \mathfrak{M}_A \mathfrak{L} + \mathfrak{N}_A, \tag{5.14}$$

$$\mathfrak{A}\mathfrak{D}_1 = \sum_{j=0}^2 \mathfrak{A}_j \mathfrak{D}_1^{1-j} + \mathfrak{P}_A \mathfrak{L} + \mathfrak{Q}_A, \tag{5.15}$$

$$\mathfrak{SD}_1 = \sum_{j=0}^2 \mathfrak{S}_j \mathfrak{D}_1^{1-j} + \mathfrak{U}_S \mathfrak{L} + \mathfrak{V}_S. \tag{5.16}$$

Here  $\mathfrak{A}_j$ ,  $\mathfrak{S}_j$  are elementary pseudodifferential operators associated with the complex-valued functions

$$\tilde{A}_0(Y) = A(Y, 0, 1), \quad \tilde{A}_1(Y) = \frac{1}{\nu} [\partial_{\xi_1} A](Y, 0, 1),$$
 (5.17)

$$\tilde{A}_2(Y) = \frac{1}{2\nu^2} [(\partial_{\xi_1}^2 - \partial_{\xi_2})A + iIm \ A](Y, 0, 1), \tag{5.18}$$

$$\tilde{S}_j = \tilde{A}_j \tilde{W} \quad for \quad j = 0, 1, \quad \tilde{S}_2 = \tilde{A}_2 \tilde{W} - \left(\frac{1}{\nu}\right)^2 Im \ \tilde{A}_0 Im \ \tilde{W}.$$
 (5.19)

For any  $u \in H^s(\mathbb{R}^2/\Gamma)$  with  $1 \le s < l - 4$ ,

$$\|\mathfrak{M}_{A}u\|_{s} + \|\mathfrak{N}_{A}u\|_{s} + \|\mathfrak{P}_{A}u\|_{s} + \|\mathfrak{Q}_{A}u\|_{s} \leq$$

$$c(s)\Big(|\mathfrak{A}|_{3,s}\|u\|_{0} + |\mathfrak{A}|_{3,3}\|u\|_{s-1}\Big),$$

$$\|\mathfrak{U}_{S}u\|_{s-1} + \|\mathfrak{V}_{S}u\|_{s} \leq$$

$$c(s)\Big(\Big(|\mathfrak{A}|_{3,3}|\mathfrak{W}|_{3,s+3} + |\mathfrak{A}|_{3,s+3}||\mathfrak{W}|_{3,3}\Big)\|u\|_{0} + |\mathfrak{A}|_{3,3}|\mathfrak{W}|_{3,3}\|u\|_{s-1}\Big)$$

$$(5.21)$$

**Proof:** The proof is given in Appendix F. Let us turn to the proof of Theorem 5.2.

# First step

We begin with the calculation of a commutator of an elementary operator and the left side of (5.12).

**Lemma 5.5** Let  $\mathfrak{W}$  be the elementary operator associated with a function  $\tilde{W} \in C^l(\mathbb{R}^2/\Gamma)$ . Then

$$(\mathfrak{L} + \mathfrak{A}\mathfrak{D}_1 + \mathfrak{B})\mathfrak{W} = \mathfrak{WL} + (\mathfrak{W}_1 + \mathfrak{S})\mathfrak{D}_1 + \mathfrak{T} + \mathfrak{R}, \tag{5.22}$$

where symbols of an elementary operator  $\mathfrak{W}_1$  and zero-order pseudodifferential operators  $\mathfrak{S}$ ,  $\mathfrak{T}$  are given by

$$W_1 = 2\nu \partial_{y_1} W, \quad S = AW,$$

$$T = \nu \partial_{y_1}^2 W - i\xi_1 \partial_{y_1} W - i\tau \xi_2 \partial_{y_2} W + A \partial_{y_1} W + BW +$$

$$\xi_1 (\xi^{\perp} \cdot \partial_{\xi} A) (\xi_2 \partial_{y_1} - \tau \xi_1 \partial_{y_2}) W,$$

$$(5.23)$$

where  $\xi^{\perp} = (\xi_2, -\xi_1)$ . The remainder has the estimate

$$\begin{split} \|\Re u\|_{s} &\leq c(s) \Big( |1 - \mathfrak{W}|_{0,6} \|u\|_{s-1} + |1 - \mathfrak{W}|_{0,s+6} \|u\|_{0} \Big) + \\ &c(s) \Big( |\mathfrak{W}|_{0,6} |\mathfrak{A}|_{2,3} \|u\|_{s-1} + (|\mathfrak{W}|_{0,s+6} |\mathfrak{A}|_{2,3} + |\mathfrak{W}|_{0,6} |\mathfrak{A}|_{2,s}) \|u\|_{0} \Big) + (5.24) \\ &c(s) \Big( |\mathfrak{W}|_{0,4} |\mathfrak{B}|_{2,3} \|u\|_{s-1} + (|\mathfrak{W}|_{0,s+4} |\mathfrak{B}|_{2,3} + |\mathfrak{W}|_{0,5} |\mathfrak{B}|_{2,s}) \|u\|_{0} \Big). \end{split}$$

**Proof.** It is easy to see that

$$\nu \mathfrak{D}_1^2 \mathfrak{W} = \nu \mathfrak{W} \mathfrak{D}_1^2 + \mathfrak{W}_1 \mathfrak{D}_1 + \mathfrak{W}_2, \tag{5.25}$$

where  $\mathfrak{W}_2$  is the elementary operator associated with the functions  $\nu \partial_{y^1}^2 \tilde{W}$ . Next since  $(-\Delta)^{-1/2}$  and  $\mathfrak{W}$  are first and zero order pseudodifferential operators, formulae for commutators (F.6), (F.8) from Proposition F.3 imply

$$(-\Delta)^{1/2}\mathfrak{W} = \mathfrak{W}(-\Delta)^{1/2} + [(-\Delta)^{1/2}, \mathfrak{W}]_1 + \mathfrak{D}^{[N,W]}, \tag{5.26}$$

where the symbol of the operator  $[(-\Delta)^{1/2}, \mathfrak{W}]_1$  is equal to

$$-i(\xi_1 \partial_{y_1} + \tau \xi_2 \partial_{y_2})W. \tag{5.27}$$

Moreover, since  $|1-\mathfrak{W}|_{m,l} \leq ||1-\tilde{W}||_{C^l}$  and the symbol of the operator  $(-\Delta)^{1/2}$  does not depend on Y, inequality (F.10) yields the estimate

$$\|\mathfrak{D}^{[N,W]}u\|_{s} \le c(s)(\|1-\tilde{W}\|_{C^{6+s}}\|u\|_{0} + \|1-\tilde{W}\|_{C^{6}}\|u\|_{s-1}). \tag{5.28}$$

Next applying formulae (F.5),(F.7) to the composition of the pseudodifferential operators  $\mathfrak{AD}_1$  and  $\mathfrak{W}$  we arrive at the equality

$$\mathfrak{AD}_1\mathfrak{W} = \mathfrak{SD}_1 + (\mathfrak{AD}_1\mathfrak{W})_1 + \mathfrak{D}^{(AD_1W)}, \tag{5.29}$$

where  $(\mathfrak{AD}_1\mathfrak{W})_1$  is a zero order pseudodifferential operator which symbol is given by formula (F.7) with A replaced by  $ik_1A$  and B replaced by W. Noting that for  $k \neq 0$ ,

$$k_1 \partial_{k_1} \xi = \xi_1 \xi_2 \xi^{\perp}, \quad k_1 \partial_{k_2} \xi = -\tau \xi_1^2 \xi^{\perp} \text{ with } \xi^{\perp} = (\xi_2, -\xi_1)$$

we can rewrite expression (F.7) for the symbol  $(\mathfrak{AD}_1\mathfrak{W})_1$  in the form

$$A\partial_{y^1}W + \xi_1 \left[ \xi^{\perp} \cdot \partial_{\xi} A \right] \left[ \xi_2 \partial_{y_1} W - \tau \xi_1 \partial_{y_2} W \right]. \tag{5.30}$$

Recall that it vanishes for k = 0. Since  $\mathfrak{AD}_1$  is a first order operator with  $|\mathfrak{AD}_1|_{1,l}^1 \leq c|\mathfrak{A}|_{1,l}$  inequality (F.9) from Proposition F.3 implies the estimate

$$\|\mathfrak{D}^{AD_1W}u\|_s \le c\Big(|\mathfrak{A}|_{2,s}|\mathfrak{W}|_{0,6} + |\mathfrak{A}|_{2,3}|\mathfrak{W}|_{0,6+s}\Big)\|u\|_0 + c|\mathfrak{A}|_{2,3}|W|_{0,6}\|u\|_{s-1}.$$
(5.31)

Setting

$$\mathfrak{T}=\mathfrak{W}_2+[(-\Delta)^{1/2},\mathfrak{W}]_1+(\mathfrak{AD}_1\mathfrak{W})_1+(\mathfrak{BW})_0$$

we obtain the needed representation. with the remainder

$$\mathfrak{D}^{[N,W]} + \mathfrak{D}^{(AD_1W)} + \mathfrak{D}^{(BW)}$$

and the lemma follows.  $\blacksquare$ 

#### Second step

Now we give a formal construction of the operators  $\mathfrak{C}$ ,  $\mathfrak{E}$  and  $\mathfrak{F}$ . We take the operator  $\mathfrak{C}$  in the form

$$\mathfrak{C} = \sum_{p=0}^{2} \mathfrak{W}^{(p)} \mathfrak{D}_{1}^{-p} - \Pi_{1}, \tag{5.32}$$

where elementary operators  $\mathfrak{W}^{(p)}$  will be specified below. Applying Lemma 5.5 and noting that  $\mathfrak{L}$  commutes with  $\mathfrak{D}_1^j$  we obtain

$$(\mathfrak{L} + \mathfrak{A}\mathfrak{D}_1 + \mathfrak{B})\mathfrak{W}^{(p)}\mathfrak{D}_1^{-p} = \mathfrak{W}^{(p)}\mathfrak{D}_1^{-p}\mathfrak{L} + \mathfrak{W}_1^{(p)}\mathfrak{D}_1^{1-p} + \mathfrak{K}^{(p)}\mathfrak{D}_1^{1-p} + \mathfrak{K}^{(p)}\mathfrak{D}_1^{-p} + \mathfrak{K}^{(p)}\mathfrak{D}_1^{-p}.$$

Here  $\mathfrak{S}^{(p)}$ ,  $\mathfrak{T}^{(p)}$ ,  $\mathfrak{R}^{(p)}$  are given by Lemma 5.5 with  $\mathfrak{W}$  replaced by  $\mathfrak{W}^{(p)}$ . Combining these identities we arrive at

$$\begin{split} \big(\mathfrak{L}+\mathfrak{A}\mathfrak{D}_1+\mathfrak{B}\big)(\Pi_1+\mathfrak{C}) &= (\Pi_1+\mathfrak{C})\mathfrak{L}+\\ &+\sum_{p=0}^2 \Big(\mathfrak{W}_1^{(p)}\mathfrak{D}_1^{1-p}+\mathfrak{S}^{(p)}\mathfrak{D}_1^{1-p}+\mathfrak{T}^{(p)}\mathfrak{D}_1^{-p}+\mathfrak{R}^{(p)}\mathfrak{D}_1^{-p}\Big). \end{split} \tag{5.33}$$

Recall that  $\mathfrak{S}^{(p)}$  and  $\mathfrak{T}^{(p)}$  are zero-order pseudodifferential operators, hence by Proposition 5.4, they have the decomposition

$$\begin{split} \mathfrak{S}^{(p)}\mathfrak{D}_1 &= \sum_{j=0}^2 \mathfrak{S}_j^{(p)}\mathfrak{D}_1^{1-j} + \mathfrak{U}_{S^{(p)}}\mathfrak{L} + \mathfrak{V}_{S^{(p)}}, \\ \mathfrak{T}^{(p)}\Pi_1 &= \sum_{j=0}^1 \mathfrak{T}_j^{(p)}\mathfrak{D}_1^{1-j} + \mathfrak{M}_{T^{(p)}}\mathfrak{L} + \mathfrak{N}_{T^{(p)}}, \end{split}$$

in which the symbols of elementary operators  $\mathfrak{S}_{j}^{(p)}$  are given by the formulae (5.19) with W replaced by  $W^{(p)}$ , and the symbols of elementary operators  $\mathfrak{T}_{j}^{(p)}$  are given by formulae (5.17), (5.18) with A replaced by T. Substituting these relations into (5.33) we obtain the identity

$$(\mathfrak{L} + \mathfrak{A}\mathfrak{D}_1 + \mathfrak{B})(\Pi_1 + \mathfrak{C}) = (\Pi_1 + \mathfrak{C})(\mathfrak{L} - \varkappa) + \sum_{p=0}^{3} \mathfrak{I}_p \mathfrak{D}_1^{1-p} + \mathfrak{R}' \mathfrak{L} + \mathfrak{R}'',$$

$$(5.34)$$

where the elementary operators  $\mathfrak{I}_j$  and the reminders  $\mathfrak{R}',\,\mathfrak{R}''$  are given by

$$\mathfrak{I}_{0} = \mathfrak{W}_{1}^{(0)} + \mathfrak{S}_{0}^{(0)}, 
\mathfrak{I}_{1} = \mathfrak{W}_{1}^{(1)} + \mathfrak{S}_{0}^{(1)} + \mathfrak{S}_{1}^{(0)} + \mathfrak{T}_{0}^{(0)} + \varkappa \mathfrak{W}^{(0)}, 
\mathfrak{I}_{2} = \mathfrak{W}_{1}^{(2)} + \mathfrak{S}_{0}^{(2)} + \mathfrak{S}_{2}^{(0)} + \mathfrak{S}_{1}^{(1)} + \mathfrak{T}_{1}^{(0)} + \mathfrak{T}_{0}^{(1)} + \varkappa \mathfrak{W}^{(1)}, 
\mathfrak{I}_{3} = \mathfrak{S}_{2}^{(1)} + \mathfrak{S}_{1}^{(2)} + \mathfrak{S}_{2}^{(2)} \mathfrak{D}_{1}^{-1} + \mathfrak{T}_{1}^{(1)} + \mathfrak{T}_{0}^{(2)} + \mathfrak{T}_{1}^{(2)} \mathfrak{D}_{1}^{-1} + \varkappa \mathfrak{W}^{(2)},$$
(5.35)

$$\mathfrak{R}' = \sum_{p=0}^{2} \mathfrak{U}_{S^{(p)}} \mathfrak{D}_{1}^{-p} + \sum_{p=0}^{1} \mathfrak{M}_{T^{(p)}} \mathfrak{D}_{1}^{-p},$$

$$\mathfrak{R}'' = \sum_{p=0}^{2} \mathfrak{V}_{S^{(p)}} \mathfrak{D}_{1}^{-p} + \sum_{p=0}^{1} \mathfrak{N}_{T^{(p)}} \mathfrak{D}_{1}^{-p} + \sum_{p=0}^{2} \mathfrak{R}^{(p)} \mathfrak{D}_{1}^{-p}.$$
(5.36)

Noting that

$$\mathfrak{D}_{1}^{-2} = (-\Delta)^{-1/2} \mathfrak{D}_{1}^{-2} \mathfrak{L} - \nu (-\Delta)^{-1/2}.$$

we can rewrite (5.34) in the form

$$(\mathfrak{L} + \mathfrak{A}\mathfrak{D}_1 + \mathfrak{B})(\Pi_1 + \mathfrak{C}) = (\Pi_1 + \mathfrak{C})(\mathfrak{L} - \varkappa) + \sum_{p=0}^{2} \mathfrak{I}_p \mathfrak{D}_1^{1-p} + \mathfrak{F}$$
 (5.37)

with

$$\mathfrak{E} = \mathfrak{C} + \mathfrak{R}' + \mathbf{I}_3(-\Delta)^{-1/2}\mathfrak{D}_1^{-2},$$
  

$$\mathfrak{F} = \mathfrak{R}'' - \nu\mathfrak{I}_3(-\Delta)^{-1/2} + \varkappa(\mathfrak{R}' + \mathfrak{I}_3(-\Delta)^{-1/2}\mathfrak{D}_1^{-2}.$$
(5.38)

Now our task is to show that  $\mathfrak{I}_j$ ,  $j \leq 2$ , vanish for an appropriate choice of elementary operators  $\mathfrak{W}^{(p)}$ . Note that the operator equations  $\mathfrak{I}_j = 0$  are equivalent to the scalar equations  $\widetilde{I}_j(Y) = 0$ , in which the complex-valued functions  $\widetilde{I}_j$  are associated with the operators  $\mathfrak{I}_j$ . This observation along with formulae (5.35) leads to the equations

$$\begin{split} \tilde{W}_{1}^{(0)} + \tilde{S}_{0}^{(0)} &= 0, \\ \tilde{W}_{1}^{(1)} + \tilde{S}_{0}^{(1)} + \tilde{S}_{1}^{(0)} + \tilde{T}_{0}^{(0)} + \kappa \tilde{W}^{(0)} &= 0, \\ \tilde{W}_{1}^{(2)} + \tilde{S}_{0}^{(2)} + \tilde{S}_{2}^{(0)} + \tilde{S}_{1}^{(1)} + \tilde{T}_{1}^{(0)} + \tilde{T}_{0}^{(1)} + \varkappa \tilde{W}^{(1)} &= 0 \end{split}$$
 (5.39)

By Proposition 5.4, we have  $\tilde{T}_0^{(p)} = T^{(p)}(Y,0,1)$  and  $\tilde{T}_1^{(p)} = \nu^{-1}[\partial_{\xi_1}T^{(p)}](Y,0,1)$ , which along with equality (5.23) yields

$$\tilde{T}_{0}^{(p)} = \nu \partial_{y_{1}}^{2} \tilde{W}^{(p)} - i\tau \partial_{y_{2}} \tilde{W}^{(p)} + \tilde{A}_{0} \partial_{y_{1}} \tilde{W}^{(p)} + \tilde{B}_{0} \tilde{W}^{(p)},$$

$$\tilde{T}_{1}^{(p)} = -i \frac{1}{\nu} \partial_{y_{1}} \tilde{W}^{(p)} + 2\tilde{A}_{1} \partial_{y_{1}} \tilde{W}^{(p)} + \tilde{B}_{1} \partial_{y_{1}} \tilde{W}^{(p)}.$$

Substituting these identities into (5.39) and using  $\tilde{S}_{j}^{(p)} = \tilde{A}_{j}\tilde{W}^{(p)}$  we obtain the recurrent system of ordinary differential equations for functions  $\tilde{W}^{(p)}$ , p = 0, 1, 2, 2, 3

$$(2\nu\partial_{y_1} + \tilde{A}_0)\tilde{W}^{(0)} = 0, (5.40)$$

$$(2\nu\partial_{y_1} + \tilde{A}_0)\tilde{W}^{(j)} + g_j = 0, \quad j = 1, 2,$$
 (5.41)

where

$$g_{1} = \left(\nu \partial_{y_{1}}^{2} \tilde{W}^{(0)} + \tilde{A}_{0} \partial_{y_{1}} \tilde{W}^{(0)} + \tilde{B}_{0} \tilde{W}^{(0)} - i\tau \partial_{y_{2}} \tilde{W}^{(0)}\right) + \varkappa \tilde{W}^{(0)}, \qquad (5.42)$$

$$g_{2} = \left(\tilde{A}_{2} \tilde{W}^{(0)} + \tilde{A}_{1} \tilde{W}^{(1)}\right) + \left(2\tilde{A}_{1} \partial_{y_{1}} \tilde{W}^{(0)} + \tilde{B}_{1} \partial_{y_{1}} \tilde{W}^{(0)} - i\frac{1}{\nu} \partial_{y_{1}} \tilde{W}^{(0)}\right) + \left(\nu \partial_{y_{1}}^{2} \tilde{W}^{(1)} + \tilde{A}_{0} \partial_{y_{1}} \tilde{W}^{(1)} + \tilde{B}_{0} \tilde{W}^{(1)} - i\tau \partial_{y_{2}} \tilde{W}^{(1)}\right) + \varkappa \tilde{W}^{(1)}. \qquad (5.43)$$

By the equivariant property, the function  $\tilde{A}_0$  is odd in  $y_1$  and  $\Pi_1 \tilde{A}_0 = \tilde{A}_0$ . Therefore, the general solutions of homogeneous equation (5.40) has the form

$$\tilde{W}^{(0)}(Y) = C(y_2)a^-(Y), \text{ where } a^{\pm}(Y) = \exp(\pm \frac{1}{2\nu}\mathfrak{D}_1^{-1}\tilde{A}_0)$$
 (5.44)

and  $C(y_2)$  is an arbitrary function. On the other hand, inhomogeneous equation (5.41) has a periodic solution if and only if

$$\int_{-\pi}^{\pi} g_j(y_1, y_2) a^+(y_1, y_2) dy_1 = 0 \text{ for all } y_2.$$
 (5.45)

Now we aim to show that solvability condition (5.45) is fulfilled for an appropriate choice of C. Substituting (5.44) into the expression for  $g_1$  and next to (5.45) we obtain the ordinary differential equation for C,

$$-i2\pi C' + 2\pi C\varkappa - iC\tau \int_{-\pi}^{\pi} a^{+} \partial_{y_{2}} a^{-} dy_{1} + C\nu \int_{-\pi}^{\pi} a^{+} \partial_{y_{1}}^{2} a^{-} dy_{1} + C\nu \int_{-\pi}^{\pi} \tilde{A}_{0} a^{+} \partial_{y_{1}} a^{-} dy_{1} + C\int_{-\pi}^{\pi} \tilde{B}_{0} dy_{1} = 0.$$

Noting that

$$\int_{-\pi}^{\pi} a^{+} \partial_{y_{2}} a^{-} dy_{1} = -\frac{1}{2\nu} \int_{-\pi}^{\pi} \partial_{y_{2}} \mathfrak{D}_{1}^{-1} \tilde{A}_{0} dy_{1} = 0,$$

$$\nu \int_{-\pi}^{\pi} a^{+} \partial_{y_{1}}^{2} a^{-} dy_{1} + \int_{-\pi}^{\pi} \tilde{A}_{0} a^{+} \partial_{y_{1}} a^{-} dy_{1} = -\frac{1}{4\nu} \int_{-\pi}^{\pi} \tilde{A}_{0}^{2} dy_{1},$$

we can rewrite it in the form

$$C'(y_2) + b(y_2)C(y_2) = 0, (5.46)$$

with the coefficient

$$b(y_2) = \frac{i}{2\pi} \int_{-\pi}^{\pi} \left( \tilde{B}_0 - \frac{1}{4\nu} \tilde{A}_0^2 \right) dy_1 + i\varkappa.$$
 (5.47)

It follows from formula (5.7) for  $\varkappa$ , that the mean value of b over a period is zero. Therefore, equation (5.46) has a periodic solution

$$C = \exp(-\mathfrak{D}_2^{-1}b). \tag{5.48}$$

In this case the particular periodic solution to (5.45) is

$$\tilde{W}^{(1)} = -\frac{1}{2\nu} a^{-} \mathfrak{D}_{1}^{-1} (g_{1} a^{+}). \tag{5.49}$$

Next note that, by the equivariant property, the functions  $\tilde{A}_0$ ,  $\tilde{A}_2$ , and  $\tilde{B}_1$  are odd and the functions  $\tilde{A}_1$ ,  $\tilde{B}_0$  are even in  $y_1$ . Hence  $a^{\pm}$ ,  $\tilde{W}^{(0)}$  are even, and

 $\tilde{W}^{(1)}$  is odd in  $y_1$ . In particular,  $g_2$  is odd in  $y_1$  and automatically satisfies solvability condition (5.45). From this we conclude that the operators  $\mathfrak{I}_j$ ,  $j \leq 2$  vanish when

$$\tilde{W}^{(0)} = \exp\left(-\mathfrak{D}_2^{-1}b\right)a^-, \quad \tilde{W}^{(j)} = -\frac{1}{2\nu}a^-\mathfrak{D}_1^{-1}(g_ja^+), \quad j = 1, 2, \quad (5.50)$$

which along with (5.37) leads to identity (5.12).

#### Third step

It remains to show that operators introduced above are well-defined and satisfy inequalities (5.13). We begin with the estimating of the functions  $\tilde{W}^{(p)}$ . Recall that for all smooth functions  $a, b \in C^s(\mathbb{R}^2/\Gamma)$ ,

$$||1 - \exp a||_{C^s} \le c(||a||_{C^0})||a||_{C^s}, \quad ||ab||_{C^s} \le c(s)||a||_{C^0}||b||_{C^s} + ||a||_{C^s}||b||_{C^0}.$$

It follows from this and (5.7), (5.44), (5.38), and (5.48) that

$$||1 - \tilde{W}^{(0)}||_{C^s} \le c(||\tilde{A}_0||_{C^0}, ||\tilde{B}_0||_{C^0}) \Big(||\tilde{A}_0||_{C^s} + ||\tilde{B}_0||_{C^s}\Big). \tag{5.51}$$

On the other hand, (5.42) implies the estimate

$$||g_1||_{C^s} \le c \Big( ||1 - \tilde{W}^{(0)}||_{C^{s+2}} + ||\tilde{A}_0||_{C^0} ||\tilde{W}^{(0)}||_{C^{s+1}} + ||\tilde{A}_0||_{C^s} ||\tilde{W}^{(0)}||_{C^1} + ||\tilde{A}_0||_{C^s} \Big) + \Big( ||\tilde{B}_0||_{C^s} ||\tilde{W}^{(0)}||_{C^0} + ||\tilde{B}_0||_{C^0} ||\tilde{W}^{(0)}||_{C^s} \Big).$$

Combining it with (5.51) and noting that

$$\|\tilde{W}^{(0)}\|_{C^1} \le c \|\tilde{W}^{(0)}\|_{C^0} + c \|\tilde{W}^{(0)}\|_{C^s}$$

we arrive at

$$\|\tilde{W}^{1}\|_{C^{s}} \le c(\|\tilde{A}_{0}\|_{C^{0}}, \|\tilde{B}_{0}\|_{C^{0}}) \Big(\|\tilde{A}_{0}\|_{C^{s+2}} + \|\tilde{B}_{0}\|_{C^{s+2}}\Big). \tag{5.52}$$

Arguing as before and using (5.43) we obtain

$$\begin{aligned} \|g_2\|_{C^s} &\leq c(\|\tilde{A}_0\|_{C^0}, \|\tilde{B}_0\|_{C^0}, \|\tilde{A}_1\|_{C^0}, \|\tilde{A}_2\|_{C^0}, \|\tilde{B}_1\|_{C^0}) \Big( \|\tilde{A}_0\|_{C^{s+4}} + \|\tilde{B}_0\|_{C^{s+4}} + \|\tilde{A}_1\|_{C^{s+3}} + \|\tilde{B}_1\|_{C^{s+2}} + \|\tilde{A}_2\|_{C^s} \Big), \end{aligned}$$

which along with (5.50) leads to the estimate

$$\|\tilde{W}^{(2)}\|_{C^s} \le c(\|\tilde{A}_j\|_{C^0}, \|\tilde{B}_j\|_{C^0}) \Big( \sum_{i=0}^2 \|\tilde{A}_j\|_{C^{s+4}} + \sum_{i=0}^1 \|\tilde{B}_j\|_{C^{s+4}} \Big).$$
 (5.53)

Noting that  $\|\tilde{A}_j\|_{C^s} \leq |\mathfrak{A}|_{3,s}$ , we conclude from (5.51), (5.52), (5.53) that

$$||1 - \tilde{W}^{(0)}||_{C^s} + ||\tilde{W}^{(1)}||_{C^s} + ||\tilde{W}^{(2)}||_{C^s} \le c(|\mathfrak{A}|_{3,0}, |\mathfrak{B}|_{3,0}) \Big(|\mathfrak{A}|_{3,s+4} + |\mathfrak{B}|_{3,s+4}\Big),$$

which leads to

$$|1 - \mathfrak{W}^{(0)}|_{m,s} + |\mathfrak{W}^{(1)}|_{m,s} + |\mathfrak{W}^{(2)}|_{m,s} \le c(|\mathfrak{A}|_{3,0}, |\mathfrak{B}|_{3,0}) \left(|\mathfrak{A}|_{3,s+4} + |\mathfrak{B}|_{3,s+4}\right)$$
(5.54)

for all  $m \geq 0$ . Now we can estimate the norm of the operator  $\mathfrak{C}$ . Since  $\mathfrak{C}\Pi_1 = \mathfrak{C}$ , Proposition F.1 along with (5.54) implies

$$\|\mathfrak{C}u\|_{s} \leq \|(1-\mathfrak{W}^{(0)})u\|_{s} + \|\mathfrak{W}^{(1)}u\|_{s} + \|\mathfrak{W}^{(2)}u\|_{s} \leq c(|\mathfrak{A}|_{3,0}, |\mathfrak{B}|_{3,0}) \Big( (|\mathfrak{A}|_{3,s+4} + |\mathfrak{B}|_{3,s+4}) \|u\|_{0} + (|\mathfrak{A}|_{3,4} + |\mathfrak{B}|_{3,4}) \|u\|_{s} \Big).$$

$$(5.55)$$

Let us estimate the operators  $\mathfrak{E}$ ,  $\mathfrak{F}$ . First note that inequalities (5.20) (5.21) from Proposition 5.4 imply the estimate

$$\begin{split} \|\mathfrak{U}_{S^{(p)}}u\|_{s-1} + \|\mathfrak{V}_{S^{(p)}}u\|_{s} &\leq c(|\mathfrak{A}|_{3,0}, |\mathfrak{B}|_{3,0}) \Big( (|\mathfrak{A}|_{3,3}|\mathfrak{W}^{(p)}|_{3,s+3} + \\ &+ |\mathfrak{A}|_{3,s+3}|\mathfrak{W}^{(p)}|_{3,3} \Big) \|u\|_{0} + |\mathfrak{A}|_{3,3}|\mathfrak{W}^{(p)}|_{3,3}\|u\|_{s-1} \Big). \end{split}$$

From this and (5.54) we conclude that

$$\|\mathfrak{U}_{S^{(p)}}u\|_{s-1} + \|\mathfrak{V}_{S^{(p)}}u\|_{s} \le$$

$$c(|\mathfrak{A}|_{3,7}, |\mathfrak{B}|_{3,7}) \Big( (|\mathfrak{A}|_{3,s+7} + |\mathfrak{B}|_{3,s+7}) \|u\|_{0} + (|\mathfrak{A}|_{3,7} + |\mathfrak{B}|_{3,7}) \|u\|_{s-1}.$$
(5.56)

Next (5.54) along with inequality (5.24) from Lemma 5.5 implies the inequality

$$\|\mathfrak{R}^{(p)}u\|_{s} \leq c(|\mathfrak{A}|_{3,10}, |\mathfrak{B}|_{3,10}) ((|\mathfrak{A}|_{3,s+10} + |\mathfrak{B}|_{3,s+10}) \|u\|_{0} + (|\mathfrak{A}|_{3,10} + |\mathfrak{B}|_{3,10}) \|u\|_{s-1}).$$

$$(5.57)$$

Recalling that for arbitrary zero-order operators  $\mathfrak{A},\mathfrak{W}$  and the operator  $\mathfrak{S}$  with a symbol S=AW,

$$|\mathfrak{S}|_{m,s} \leq c(s,m)(|\mathfrak{A}|_{m,0}|\mathfrak{W}|_{m,s} + |\mathfrak{A}|_{m,s}||\mathfrak{W}|_{m,0}),$$

and using formula (5.23) for symbol  $\mathfrak{T}$  we obtain

$$|\mathfrak{T}^{(p)}|_{3,s} \leq |1-\mathfrak{W}^{(p)}|_{3,s+2} + (|\mathfrak{A}|_{4,0} + |\mathfrak{B}|_{3,0})|\mathfrak{W}^{(p)}|_{0,s+1} + (|\mathfrak{A}|_{4,s} + |\mathfrak{B}|_{3,s})|\mathfrak{W}^{(p)}|_{0,1},$$

which being combined with (5.54) gives

$$|\mathfrak{T}^{(p)}|_{3,s} \le c(|\mathfrak{A}|_{4,0}, |\mathfrak{B}|_{3,0}) (|\mathfrak{A}|_{4,s+6} + |\mathfrak{B}|_{4,s+6}).$$
 (5.58)

In particular, inequality (5.58) along with (5.20) yields the estimate

$$\|\mathfrak{M}_{T^{(p)}}u\|_{s} + \|\mathfrak{N}_{T^{(p)}}u\|_{s} \leq$$

$$c(|\mathfrak{A}|_{4,0}, |\mathfrak{B}|_{4,0}) \Big( \big( |\mathfrak{A}|_{4,s+6} + |\mathfrak{B}|_{4,s+6} \big) \|u\|_{0} + \big( |\mathfrak{A}|_{4,9} + |\mathfrak{B}|_{4,9} \big) \|u\|_{s-1} \Big).$$

$$(5.59)$$

Similar arguments applying to the formula (5.23) for the symbol of the operator  $\mathfrak{S}$  give the estimate

$$|\mathfrak{S}^{(p)}|_{3,s} \le c(|\mathfrak{A}|_{3,0}|\mathfrak{B}|_{3,0})(|\mathfrak{A}|_{3,s+4} + |\mathfrak{B}|_{3,s+4}).$$
 (5.60)

Finally estimate  $\Im_3(-\Delta)^{-1/2}$ . Applying (5.54), (5.58), (5.60) to (5.35) we arrive at

$$|\mathfrak{I}_3|_{3,s} \le c(|\mathfrak{A}|_{4,0}, |\mathfrak{B}|_{3,0})(|\mathfrak{A}|_{4,s+6} + |\mathfrak{B}|_{4,s+6}),$$

which along with inequality (F.1) from Proposition F.1 implies

$$\|\mathfrak{I}_{3}(-\Delta)^{-1/2}u\|_{s} \le c(|\mathfrak{A}|_{4,0},|\mathfrak{B}|_{3,0})\Big((|\mathfrak{A}|_{4,s+9}+|\mathfrak{B}|_{4,s+9})\|u\|_{0}+(|\mathfrak{A}|_{4,9}+|\mathfrak{B}|_{4,9})\|u\|_{s-1}\Big).$$
(5.61)

Next note that

$$\|\mathfrak{E}u\|_{s} \leq \|\mathfrak{C}u\|_{s} + \|\mathfrak{I}_{3}(-\Delta)^{-1/2}u\|_{s} + \|\mathfrak{R}'u\|_{s},$$
$$\|\mathfrak{F}u\|_{s} \leq \|\mathfrak{I}_{3}(-\Delta)^{-1/2}u\|_{s} + \|\mathfrak{R}''u\|_{s}.$$

It follows from (5.56), (5.57), and (5.59) that

$$\begin{split} \|\mathfrak{R}'u\|_{s} &\leq \sum_{p=0}^{2} \|\mathfrak{U}_{S^{(p)}}u\|_{s} + \sum_{p=0}^{1} \|\mathfrak{M}_{T^{(p)}}u\|_{s} \leq \\ &c(|\mathfrak{A}|_{4,9}, |\mathfrak{B}|_{4,9}) \Big( \big(|\mathfrak{A}|_{4,9+s} + |\mathfrak{B}|_{4,9+s}\big) \|u\|_{0} + \big(|\mathfrak{A}|_{4,9} + |\mathfrak{B}|_{4,9}\big) \|u\|_{s} \Big), \\ \|\mathfrak{R}''u\|_{s} &\leq \sum_{p=0}^{2} \|\mathfrak{V}_{S^{(p)}}u\|_{s} + \sum_{p=0}^{1} \|\mathfrak{N}_{T^{(p)}}u\|_{s} + \|\mathfrak{R}^{(p)}u\|_{s} \leq \\ &c(|\mathfrak{A}|_{4,10}, |\mathfrak{B}|_{4,10}) \Big( \big(|\mathfrak{A}|_{4,10+s} + |\mathfrak{B}|_{4,10+s}\big) \|u\|_{0} + \big(|\mathfrak{A}|_{4,10} + |\mathfrak{B}|_{4,10}\big) \|u\|_{s} \Big). \end{split}$$

Combining these results with (5.61) and (5.13) we finally obtain

$$\begin{split} \|\mathfrak{C}u\|_s + \|\mathfrak{C}u\|_s &\leq c(|\mathfrak{A}|_{4,9}, |\mathfrak{B}|_{4,9}) \Big( \big(|\mathfrak{A}|_{4,9} + |\mathfrak{B}|_{4,9} \big) \|u\|_s + \\ & \big( |\mathfrak{A}|_{4,s+9} + |\mathfrak{B}|_{4,s+9} \big) \|u\|_0 \Big), \\ \|\mathfrak{F}u\|_s &\leq c(|\mathfrak{A}|_{4,10}, |\mathfrak{B}|_{4,10}) \Big( \big(|\mathfrak{A}|_{4,10} + |\mathfrak{B}|_{4,10} \big) \|u\|_{s-1} + \\ & \big( |\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10} \big) \|u\|_0 \Big), \end{split}$$

which gives (5.13) and the theorem 5.2 follows.

# 5.2 Proof of Theorem 5.1

The proof is based on the following lemma on the invertibility of the operator  $1 + \mathfrak{E}$  from Theorem 5.2.

**Lemma 5.6** Under the assumptions of Theorem 5.1, there is a positive  $\varepsilon_1$  depending on r and l only, so that for all  $\varepsilon \in (0, \varepsilon_1)$ , the operator  $1 + \mathfrak{E}$  has the bounded inverse  $(1 + \mathfrak{E})^{-1} : H^s_{o,e}(\mathbb{R}^2/\Gamma) \mapsto H^s_{o,e}(\mathbb{R}^2/\Gamma)$  and, for all  $u \in H^s_{o,e}(\mathbb{R}^2/\Gamma)$ ,

$$\|(1+\mathfrak{E})^{-1}u\|_r \le c\|u\|_r,\tag{5.62}$$

$$\|(1+\mathfrak{E})^{-1}u\|_{s} \le c\|u\|_{r}(C_{s} + |\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) + c\|u\|_{s}. \tag{5.63}$$

**Proof.** Formally we have

$$(1+\mathfrak{E})^{-1} = \sum_{n=0}^{\infty} (-1)^n \mathfrak{E}^n.$$

By Theorem 5.2, the operator  $\mathfrak{E}: H^r_{o,e}(\mathbb{R}^2/\Gamma) \mapsto H^r_{o,e}(\mathbb{R}^2/\Gamma)$  is bounded and its norm does not exceed  $c\varepsilon$ . It follows from this and inequality (5.13) that for  $c\varepsilon \leq 1$ ,

$$\begin{split} \|\mathfrak{E}^n u\|_s & \leq c\varepsilon \|\mathfrak{E}^{n-1} u\|_s + c(|\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) \|\mathfrak{E}^{n-1} u\|_r \leq \\ & c\varepsilon \|\mathfrak{E}^{n-1} u\|_s + (c\varepsilon)^{n-1} (|\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) \|u\|_r \leq \\ & (c\varepsilon)^2 \|\mathfrak{E}^{n-2} u\|_s + 2(c\varepsilon)^{n-1} (|\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) \|u\|_r \leq \\ & \dots (c\varepsilon)^{n-1} \Big( \|u\|_s + n(|\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) \|u\|_r \Big), \end{split}$$

which leads to the estimate

$$\left\| \sum_{n=0}^{\infty} (-1)^n \mathfrak{E}^n u \right\|_{s} \le c \left( \|u\|_s + (|\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) \|u\|_r \right) \left( 1 + \sum_{n=1}^{\infty} n(c\varepsilon)^{n-1} \right).$$

It remains to note that for  $\varepsilon < 1/c$ , the series in the right hand side converges absolutely and the lemma follows.  $\blacksquare$ 

Let us turn to the proof of Theorem 5.1. Since  $\mathfrak A$  and  $\mathfrak B$  satisfy all hypotheses of Theorem 5.2, the corresponding operators  $\mathfrak C$ ,  $\mathfrak E$ ,  $\mathfrak F$  are well defined and meet all requirements of this theorem. Moreover, condition (iv) along with inequalities (5.13) yields the estimates

$$\|\mathfrak{C}u\|_{s} + \|\mathfrak{C}u\|_{s} \le c\varepsilon \|u\|_{s} + c(|\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10})\|u\|_{0}, \|\mathfrak{F}u\|_{s} \le c\varepsilon \|u\|_{s-1} + c(|\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10})\|u\|_{0},$$

$$(5.64)$$

$$\|\mathfrak{C}u\|_t + \|\mathfrak{E}u\|_t \le c\varepsilon \|u\|_t, \quad \text{for} \quad t \in [2, r].$$
 (5.65)

We look for a solution to basic equation (5.1) in the form

$$u = \lambda \psi^{(0)} + (1 + \mathfrak{C})v \text{ with } v \in H_{o.e}^{s-1, \perp}.$$
 (5.66)

Substituting this representation into (5.1) we obtain the equation

$$\lambda(\mathfrak{L} + \mathfrak{H})\psi^{(0)} + (\mathfrak{L} + \mathfrak{H})(1 + \mathfrak{C})v = f. \tag{5.67}$$

Since  $\Pi_1$  coincides with the identity mapping on  $H^r_{o,e}(\mathbb{R}^2/\Gamma)$ , it follows from Theorem 5.2 that

$$(\mathfrak{L} + \mathfrak{H})(1 + \mathfrak{C}) = (1 + \mathfrak{E})(\mathfrak{L} - \varkappa) + \mathfrak{Z} \quad \text{on} \quad H_{\alpha, \varepsilon}^{r}(\mathbb{R}^{2}/\Gamma), \tag{5.68}$$

where

$$\mathfrak{Z} = \mathfrak{F} + \mathfrak{L}_{-1}(1 + \mathfrak{C}).$$

Hence we can rewrite (5.67) in the equivalent form

$$\lambda(\mathfrak{L} + \mathfrak{H})\psi^{(0)} + (1 + \mathfrak{E})(\mathfrak{L} - \varkappa)v + \mathfrak{Z}v = f.$$

Applying to both sides the operators  $\mathcal{Q}$  and  $1-\mathcal{Q}$  and noting that  $\mathcal{QL}\psi^{(0)}=0$  we obtain the system of operator equations for a scalar  $\lambda$  and unknown function  $v\in H^{s-1,\perp}_{o,e}$ ,

$$Q(1 + \mathfrak{E})(\mathfrak{L} - \varkappa)v + Q\mathfrak{Z}v = Q(f - \lambda\mathfrak{H}\psi^{(0)}), \tag{5.69}$$

$$\lambda(1-Q)(L+\mathfrak{H})\psi^{(0)} + (1-Q)(\mathfrak{L}+\mathfrak{H})(1+\mathfrak{C})v = (1-Q)f.$$
 (5.70)

Our aim is to resolve the first equation with respect to v. Hence the task now is to prove the solvability of the equation

$$Q(1 + \mathfrak{E})(\mathfrak{L} - \varkappa)v + Q\mathfrak{Z}v = Qg. \tag{5.71}$$

The corresponding result is given by

**Lemma 5.7** Under the above assumptions, there is a positive  $\varepsilon_2$  depending on r, l only, so that for  $g \in H^s_{o,e}(\mathbb{R}^2/\Gamma)$  and  $0 < \varepsilon < \varepsilon_2$ , equation (5.71) has the unique solution satisfying the inequalities

$$||v||_{r-1} \le c||g||_r, \tag{5.72}$$

$$||v||_{s-1} \le c||g||_r (C_s + |\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) + c||g||_s.$$
 (5.73)

**Proof.** We look for a solution to equation (5.71) in the form

$$v = \mathcal{Q}(\mathfrak{L} - \varkappa)^{-1} (1 + \mathfrak{E})^{-1} \mathcal{Q}\varphi \tag{5.74}$$

with the new unknown function  $\varphi \in H_{o,e}^{s}^{\perp}$ . Since the operator  $\mathfrak{L}$  commutes with the projector  $\mathcal{Q}$ , we have

$$Q(1+\mathfrak{E})(\mathfrak{L}-\varkappa)Q(\mathfrak{L}-\varkappa)^{-1}(1+\mathfrak{E})^{-1}Q = Q\mathfrak{X}_0Q + Q \tag{5.75}$$

with

$$\mathfrak{X}_0 = -(\mathfrak{E}\mathcal{Q})^2 + (1+\mathfrak{E})\mathcal{Q}\Big((1+\mathfrak{E})^{-1} - 1 + \mathfrak{E}\Big).$$

Hence (5.71) is equivalent to the equation

$$\varphi + \mathcal{Q} \mathfrak{X} \mathcal{Q} \varphi = \mathcal{Q} g, \tag{5.76}$$

in which the operator  $\mathfrak{X}$  is defined by

$$\mathfrak{X} = \mathfrak{X}_0 + \mathfrak{Z}(\mathfrak{L} - \varkappa)^{-1} (1 + \mathfrak{E})^{-1}.$$

We use the regularization method to prove the existence and uniqueness of solutions to (5.76), and consider a family of regularising equations depending on small positive parameter  $\delta$ ,

$$\varphi + \mathcal{Q} \mathcal{X} \mathcal{Q}(-\Delta)^{-\delta} \varphi = \mathcal{Q} g, \quad \delta > 0.$$
 (5.77)

Let us estimate the norm of the operator  $\mathfrak{X}$ . It is easy to see that Lemma 5.6 implies the estimates

$$\|\mathfrak{X}_0\varphi\|_r \le c\varepsilon^2 \|\varphi\|_r,$$

$$\|\mathfrak{X}_0\varphi\|_s \le c\|\varphi\|_r (|\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) + c\varepsilon^2 \|\varphi\|_s.$$

$$(5.78)$$

On the other hand, inequality (5.8) along with Lemma 5.6 leads to the estimate

$$\|\mathcal{Q}(\mathfrak{L} - \varkappa)^{-1} (1 + \mathfrak{E})^{-1} \mathcal{Q} \varphi\|_{r-1} \le c \|\varphi\|_r,$$

$$\|\mathcal{Q}(\mathfrak{L} - \varkappa)^{-1} (1 + \mathfrak{E})^{-1} \mathcal{Q} \varphi\|_{s-1} \le c \|\varphi\|_r (|\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) + c \|\varphi\|_s.$$
(5.79)

Next estimates (5.64) for  $\mathfrak{C}$  and  $\mathfrak{F}$  along with inequalities (5.6) for  $\mathfrak{L}_{-1}$  imply

$$\|\Im\varphi\|_{r} \le c\varepsilon \|\varphi\|_{r-1},$$

$$\|\Im\varphi\|_{s} \le c\|\varphi\|_{r-1} \left(C_{s} + |\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}\right) + c\varepsilon \|\varphi\|_{s-1}.$$
(5.80)

Combining (5.78)-(5.80) we finally arrive at

$$\|\mathfrak{X}\varphi\|_r \le c\varepsilon \|\varphi\|_r,$$
$$\|\mathfrak{X}\varphi\|_s \le c\|\varphi\|_r (C_s + |\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}) + c\varepsilon \|\varphi\|_s.$$

Since the operators  $(-\Delta)^{-\delta}$  are uniformly bounded in  $H_{o,e}^r(\mathbb{R}^2/\Gamma)$ , it follows that each solution to equation (5.77) satisfies the inequalities

$$\|\varphi\|_{r}(1-c\varepsilon) \leq c\|g\|_{r},$$

$$\|\varphi\|_{s}(1-c\varepsilon) \leq c\|\varphi\|_{r}(C_{s}+|\mathfrak{A}|_{4,s+10}+|\mathfrak{B}|_{4,s+10})+$$

$$c\|g\|_{s}+c\|g\|_{r}(|\mathfrak{A}|_{4,s+10}+|\mathfrak{B}|_{4,s+10}).$$

Hence for  $\varepsilon < 1/2c$ ,

$$\|\varphi\|_{r} \le c\|g\|_{r},$$

$$\|\varphi\|_{s} \le c\|g\|_{s} + c\|g\|_{r} \left(C_{s} + |\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}\right),$$
(5.81)

In particular, the solution is unique. Since the operator

$$\mathcal{QXQ}(-\Delta)^{-\delta}: H^r_{o,e}(\mathbb{R}^2/\Gamma) \mapsto H^r_{o,e}(\mathbb{R}^2/\Gamma)$$

is compact, uniqueness along with the Fredholm Theorem implies the solvability of equations (5.77) for all  $\delta>0$ . Hence they have a family of solutions  $\varphi_\delta$  satisfying (5.81). After passing to a subsequence we can assume that

$$\varphi_{\delta} \to \varphi$$
,  $(-\Delta)^{-\delta} \varphi_{\delta} \to \varphi$  weakly in  $H^s(\mathbb{R}^2/\Gamma)$  as  $\delta \searrow 0$ .

Obviously  $\varphi$  serves as a solution to equation (5.76). Recalling (5.74) we obtain the solvability and uniqueness result for (5.71). It remains to note that estimates (5.72), (5.73) follow from formula (5.74) and inequalities (5.79),(5.81).

We are now in a position to complete the proof of Theorem 5.1. Applying Lemma 5.7 to equation (5.69) we obtain the representation

$$v = \lambda v_0 + v_f, \tag{5.82}$$

in which  $v_0$  and  $v_f$  are solutions to equations (5.71) with  $g = -\mathcal{Q}\mathfrak{H}\psi^{(0)}$  and  $g = \mathcal{Q}f$ . It follows from (5.72), (5.73) that

$$||v_f||_{r-1} \le c||f||_r,$$

$$||v_f||_{s-1} \le c||f||_r \left(C_s + |\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}\right) + c||f||_s, \qquad (5.83)$$

$$||v_0||_{r-1} \le c\varepsilon,$$

$$||v_0||_{s-1} \le c\left(C_s + |\mathfrak{A}|_{4,s+10} + |\mathfrak{B}|_{4,s+10}\right).$$

The functions  $v_0$  and  $v_f$  are completely defined by the eigenfunction  $\psi_0$  and the right hand side f of equation (5.1), but the scalar  $\lambda$  still remains unknown. In order to find it we substitute representation (5.82) into (5.70) to obtain

$$\lambda(1-\mathcal{Q})(\mathfrak{L}+\mathfrak{H})\Big(\psi^{(0)}+(1+\mathfrak{C})v_0\Big)=(1-\mathcal{Q})\Big(f-\big(\mathfrak{L}+\mathfrak{H})(1+\mathfrak{C})v_f\Big). (5.84)$$

It follows from identity (5.68) that equation (5.71) for  $v_0$  is equivalent to

$$\mathcal{Q}(\mathfrak{L} - \varkappa)\mathcal{Q}v_0 + \mathcal{Q}((\mathfrak{L} + \mathfrak{H})\mathfrak{C} + \mathfrak{H} + \kappa)\mathcal{Q}v_0 = -\mathcal{Q}\mathfrak{H}\psi^{(0)}.$$

Since the operator  $\mathcal{Q}(\mathfrak{L}-\varkappa)$  has the bounded inverse  $\mathcal{Q}(\mathfrak{L}-\varkappa)^{-1}: H^{s,\perp}_{o,e} \mapsto H^{s-1,\perp}_{o,e}$ , we have

$$v_0 + \mathcal{Q}(\mathfrak{L} - \varkappa)^{-1} \mathcal{Q}((\mathfrak{L} + \mathfrak{H})\mathfrak{C} + \mathfrak{H} + \kappa) \mathcal{Q}v_0 = -\mathcal{Q}(\mathfrak{L} - \varkappa)^{-1} \mathcal{Q}\mathfrak{H}\psi^{(0)}.$$
 (5.85)

Next, using inequalities (5.83) along with (5.65) and (5.72) and noting that for  $2 \le t \le r$ ,

$$\|\mathfrak{H}u\|_{t-1} \le c\varepsilon \|u\|_t$$

we arrive at

$$\|\mathcal{Q}(\mathfrak{L}-\varkappa)^{-1}\mathcal{Q}\mathfrak{H}\psi^{(0)}\|_{r-2}\leq c\varepsilon,\quad \|\mathcal{Q}(\mathfrak{L}-\varkappa)^{-1}\big((\mathfrak{L}+\mathfrak{H})\mathfrak{C}+\mathfrak{H}+\varkappa)v_0\|_{r-3}\leq c\varepsilon^2,$$

which leads to

$$v_0 = -\mathcal{Q}(\mathfrak{L} - \varkappa)^{-1} \mathcal{Q}\mathfrak{H}\psi^{(0)} + v' \text{ with } ||v'||_{r-3} \le c\varepsilon^2.$$

Substituting this expression into (5.84) gives

$$\lambda(1-\mathcal{Q})(\mathfrak{L}+\mathfrak{H})\Big(\psi^{(0)}-\mathcal{Q}(\mathfrak{L}-\varkappa)^{-1}\mathcal{Q}\mathfrak{H}\psi^{(0)}\Big)+\lambda v''=(1-\mathcal{Q})\Big(f-\big(\mathfrak{L}+\mathfrak{H})(1+\mathfrak{C})v_f\Big)$$
 (5.86)

where

$$v'' = (1 - \mathcal{Q})(\mathfrak{L} + \mathfrak{H}) \Big( v' + \mathfrak{C}v_0 \Big).$$

Next noting that

$$\|(1-\mathcal{Q})\mathfrak{L}u\|_s \leq c\varepsilon \|u\|_0$$

and using estimate (5.65) we obtain

$$||v''||_{r-4} \le c\varepsilon ||v'||_{r-3} + c\varepsilon^2 ||v_0||_{r-2} \le c\varepsilon^3.$$

Multiplying both sides of (5.84) by  $\psi^{(0)}$  and integrating the result over  $\mathbb{T}^2$  leads to equality

$$\lambda K = \int_{\mathbb{T}^2} \left( f - (\mathfrak{L} + \mathfrak{H})(1 + \mathfrak{C})v_f \right) \psi^{(0)} dY, \tag{5.87}$$

in which

$$K = \int\limits_{\mathbb{T}^2} (\mathfrak{L} + \mathfrak{H}) \Big( \psi^{(0)} - \mathcal{Q} (\mathfrak{L} - \varkappa)^{-1} \mathcal{Q} \mathfrak{H} \psi^{(0)} \Big) \psi^{(0)} \, dY + \int\limits_{\mathbb{T}^2} v'' \psi^{(0)} \, dY = @\varepsilon^2 + O(\varepsilon^3).$$

Hence there is a positive  $\varepsilon_1 < \varepsilon_2$  depending on r, l and  $\psi_0$  only so that  $2|K| > |@|\varepsilon^2$  for all  $0 < \varepsilon < \varepsilon_1$ . From this, relation (5.87) and inequalities (5.83) we conclude that for such  $\varepsilon$  the unknown  $\lambda$  is well defined and

$$\varepsilon^2 |\lambda| < \frac{c}{|@|} ||f||_r. \tag{5.88}$$

Hence for  $0 < \varepsilon < \varepsilon_1$ , equation (5.1) has the unique solution  $u \in H^r_{o,e}$ . It remains to note that inequalities (5.83) and (5.88) along with the identity

$$u = \lambda \psi^{(0)} + \lambda (1 + \mathfrak{C}) v_0 + (1 + \mathfrak{C}) v_f$$

imply estimates (5.10), (5.11) and this ends the proof of Theorem 5.1.

# 5.3 Verification of assumptions of Theorem 5.1

In this subsection we check all abstract conditions required for solving the linear equation (5.1), in the case when the operators involved in this equation are defined by Theorem 3.4. Note that the symmetry conditions (5.3) and (iii) follows from assertion (iii) of this theorem. The same conclusion can be drawn for the Metric conditions (5.5), (5.6) which are realized, as soon as  $||U||_{\rho} \leq \varepsilon$  and  $\rho = l + 3$ .

Let us consider the restrictions on the spectrum and resolvent of  $\mathfrak{L}$ . Part (v) results immediately from Theorem 4.19, restricted to the space of functions odd

in  $y_1$  and even in  $y_2$ , and once we notice that the eigenvalue corresponding to the eigenvector  $\psi^{(0)} = \sin y_1 \cos y_2$  satisfies

$$-\nu + \sqrt{1 + \tau^2} = \varepsilon^2 \nu_1(\tau) + O(\varepsilon^3). \tag{5.89}$$

This results immediately from the fact that the linear operator  $\mathcal{L}$  (see (3.3) corresponds to the differentiation of the basic system at the point

$$U = U_{\varepsilon}^{(N)} + \varepsilon^N W, \quad N \ge 3 \tag{5.90}$$

where  $U_{\varepsilon}^{(N)}$  is the approximate solution at order  $\varepsilon^N$ , and from Lemma 3.7. Moreover the coefficient  $\nu_1$  is positive (larger than a positive number) for any value of  $\tau$ .

Now, from Lemma 3.8 we see that the Fourier expansion of the diffeomorphism of the torus has, at order  $\varepsilon$ , only harmonic 1 terms in Y, and at order  $\varepsilon^2$  only harmonics 2 and 0 in  $Y = (y_1, y_2)$ , all terms being invariant under the shift  $\mathcal{T}_{\mathbf{v}_0}: Y \mapsto Y + (\pi, \pi)$ . Let us now consider the expression of the linear operator  $\mathfrak{L} + \mathfrak{H}$  which is obtained after applying the above diffeomorphism on a linear operator which may be formally expanded in powers of  $\varepsilon$ , having coefficients with the same property as the diffeomorphism in terms of harmonics in Y. The result is that the formal expansion in powers of  $\varepsilon$  of  $\mathfrak{L} + \mathfrak{H}$  has the same property as above i.e. the order 0 is independent of Y, while orders  $\varepsilon$  and  $\varepsilon^2$  only contain respectively harmonic 1 and harmonics 2 and 0 in Y.

Let us consider the formula (5.7) giving the coefficient  $\varkappa$ . In the integral over  $\mathbb{T}^2$  the functions A and B are  $O(\varepsilon)$  and can be expanded in powers of  $\varepsilon$ , their principal part containing only harmonic 1-terms in Y. It results immediately that

$$\varkappa = O(\varepsilon^2). \tag{5.91}$$

It is not useful in our proof to give more precision on this coefficient, however the interested reader might check (after few days of computations) that

$$\varkappa = \varepsilon^{2} \frac{\mu_{c}(\tau)}{16} \{ 8\tau^{2} - 5\tau^{2} - \frac{7}{4} \} + O(\varepsilon^{3}). \tag{5.92}$$

Now, from the estimate on operators  $\mathfrak A$  and  $\mathfrak B$  in theorem 3.4 and from (5.7) we have

$$|\varkappa| \le c||U||_{14}$$

hence from (5.91) and (5.90) we deduce that

$$\varkappa = \varepsilon^2 \widetilde{\varkappa}, \quad |\widetilde{\varkappa}| \le c(1 + \varepsilon ||W||_{14}).$$
(5.93)

It should be noticed that in formulae (5.89) and (5.92) the terms of order  $O(\varepsilon^3)$  depend on the unknown W of (5.90) which is assumed to be bounded in  $\mathbb{H}^{14}_{(S)}$  (because of the smoothness required for computing operators  $\mathfrak{B}$  and  $\mathfrak{L}_{-1}$  above). Hence, if we want to apply the result of Theorem 4.2 for obtaining the required

estimate (5.8) for  $(\mathfrak{L} - \varkappa)^{-1}$  we need to show that properties (4.4) hold for the functions of  $\varepsilon$ 

$$\nu_j(\varepsilon) = \nu_0 - \varepsilon^2 \nu_1 + \varepsilon^3 \widetilde{\nu}_j(\varepsilon), \quad \varkappa = \varepsilon^2 \widetilde{\varkappa}_j(\varepsilon)$$

where  $\nu_0 = (1 + \tau^2)^{1/2}$ ,  $\nu_1 = \nu_1(\tau)$ ,  $\widetilde{\nu}_j(\varepsilon)$  and  $\widetilde{\varkappa}_j(\varepsilon)$  are obtained with some  $W_j$  in  $\mathbb{H}^{14}_{(S)}$  through the iteration of the Newton method of Nash Moser theorem. Because of the smooth dependence of these coefficients in function of  $(\varepsilon, U)$  (see in particular Theorem 3.4 for  $\nu$ , and (5.93) for  $\varkappa$ ), the properties (4.4) for  $\widetilde{\nu}_j(\varepsilon)$  and  $\widetilde{\varkappa}_j(\varepsilon)$  are verified as soon as there exists R > 0 such that

$$||W_{j}(\varepsilon') - W_{j}(\varepsilon'')||_{14} \leq R|\varepsilon' - \varepsilon''|,$$

$$||W_{j+1}(\varepsilon) - W_{j}(\varepsilon)||_{14} \leq 2^{-j}R$$

$$(5.94)$$

holds. This property will be checked in section 6. Assuming that this is true, we have all conditions of Theorem 4.2 realized. This completes the verification of restrictions on the spectrum and resolvent of  $\mathfrak{L}$ .

The nondegeneracy condition (5.9) is fundamental for obtaining the estimates (5.10), (5.11) for the solution of the linearized system. So, let us now consider the coefficient @ defined in (5.9). We notice that the eigenfunction  $\psi^{(0)} = \sin y_1 \cos y_2$  only contains harmonic 1-terms in Y, and assuming that W in formula (5.90) is bounded in  $\mathbb{H}^{14}_{(S)}$ , and denoting the coefficient of order  $\varepsilon$  in the operator  $\mathfrak{H}^{(1)}$  by  $\mathfrak{H}^{(1)}$  we have

$$Q\mathfrak{H}\psi^{(0)} = \varepsilon\mathfrak{H}^{(1)}\psi^{(0)} + O(\varepsilon^2),$$

and, since  $\mathfrak{L}_0$  is invertible on finite Fourier series orthogonal to  $\psi^{(0)}$ , one obtains

$$\mathfrak{H}Q(\mathfrak{L}-\varkappa)^{-1}Q\mathfrak{H}\psi^{(0)}=\varepsilon^2\mathfrak{H}^{(1)}\mathfrak{L}_0^{-1}\mathfrak{H}^{(1)}\psi^{(0)}+O(\varepsilon^3).$$

Now defining the coefficient of order  $\varepsilon^2$  in the operator  $\mathfrak{L} + \mathfrak{H}$  by  $\mathfrak{H}^{(2)}$  we have

$$@ = \int_{\mathbb{T}^2} \left( \mathfrak{H}^{(2)} \psi^{(0)} - \mathfrak{H}^{(1)} \mathfrak{L}_0^{-1} \mathfrak{H}^{(1)} \psi^{(0)} \right) \psi^{(0)} dY.$$
 (5.95)

Then, we prove the following

**Lemma 5.8** The coefficient @ of nondegeneracy condition (5.9) is given by

$$@ = -2\pi^2 \frac{\mu_1}{\mu_0^2} = \frac{\pi^2}{8} (\alpha_0 + \beta_0),$$

where  $\mu_1(\tau)$  is given by (2.11) and  $(\alpha_0 + \beta_0)(\tau)$  is given at Theorem 2.3. This coefficient is non zero for  $\tau \neq \tau_c$ .

**Proof:** the proof is made at Appendix H.

This completes the verification of Nondegeneracy condition.

## 5.4 Inversion of $\mathcal L$

Let us now consider the inversion of the operator  $\mathcal{L}$  defined in (3.3)

$$\mathcal{L}(U,\mu)V = F,\tag{5.96}$$

where

$$\mathcal{L}(U,\mu) = \begin{pmatrix} \mathcal{G}_{\eta} & \mathcal{J}^* \\ \mathcal{J} & \mathfrak{a} \end{pmatrix},$$
$$F = (f,g) \in \mathbb{H}^s_{(S)}, \quad V = (\delta\phi, \delta\eta)$$

and where we look for

$$\delta U = (\delta \psi, \delta \eta), \quad \delta \psi = \delta \phi + \mathfrak{b} \delta \eta,$$

where  $\mathfrak{b}$  is defined in (3.1). In this subsection we prove the following Theorem which collects the results of previous sections on the operator  $\mathcal{L}$ 

**Theorem 5.9** Consider M > 0,  $i \ge 14$ , and  $\pi/4 > \delta > 0$ , and set

$$U = U_{\varepsilon}^{(N)} + \varepsilon^{N} W, \quad N \ge 3,$$
  

$$\mu = \mu_{\varepsilon}^{(N)} = \mu_{\varepsilon} + \varepsilon^{2} \mu_{1}(\tau) + O(\varepsilon^{3}),$$
(5.97)

where  $||W||_i \leq M$ , and  $(U_{\varepsilon}^{(N)}, \mu_{\varepsilon}^{(N)})$  is the approximate solution at order  $\varepsilon^N$  obtained at Theorem 2.3 in the case of diamond waves  $(\varepsilon_1 = \varepsilon_2 = \varepsilon/2)$ , and  $\tau = \tan \theta_0$ ,  $\mu_c = \cos \theta_0$ ,  $\delta < \theta_0 < \pi/2 - \delta$ . Assume moreover in (5.97) that  $W = W_j(\varepsilon)$ ,  $j \in \mathbb{N}$  satisfies the property (5.94), then for  $\mu_c^{-1} \in \mathfrak{N}_{\alpha}$ ,  $\alpha \in (0, 1/78)$ , there exists  $\varepsilon_0 > 0$  and a subset  $\mathcal{E}$  of  $[0, \varepsilon_0]$  such that for any  $F \in \mathbb{H}^s_{(S)}$ ,  $s \geq 5$ , and for  $\varepsilon \in \mathcal{E}$ , the linear equation (5.96) has a unique solution V corresponding to  $\delta U \in \mathbb{H}^{s-3}_{(S)}$ , such that the following estimates hold

$$||\delta U||_{r-3} \leq \frac{c}{\varepsilon^2} ||F||_r, \quad 5 \leq r \leq i - 8,$$

$$||\delta U||_{s-3} \leq \frac{c(s)}{\varepsilon^2} ||F||_r (1 + \varepsilon^N ||W_j||_{s+18}) + c(s) ||F||_s.$$
(5.98)

Moreover the following property holds for the "good" set  $\mathcal E$ :

$$\frac{1}{|\mu_r^{(N)} - \mu_c|} meas\{\mu = \mu_\varepsilon^{(N)}; \varepsilon \in \mathcal{E} \cap (0, r)\} \to 1, \quad as \ r \to 0.$$
 (5.99)

**Proof.** By construction, we have

$$\mathcal{G}_{\eta}(\delta\phi) - \mathcal{J}^*(\frac{1}{\mathfrak{a}}\mathcal{J}(\delta\phi)) = h,$$

where

$$h = f - \mathcal{J}^*(g/\mathfrak{a}),$$

and which, after the change of coordinates of Theorem 3.4, becomes

$$(\mathfrak{L} + \mathfrak{A}\mathfrak{D}_1 + \mathfrak{B} + \mathfrak{L}_{-1})\widetilde{\delta\phi} = \frac{\widetilde{h}}{\kappa},$$

which we learnt to invert at Theorem 5.1.

First, for  $U \in \mathbb{H}^m_{(S)}$ , and  $||U||_r \leq M_r$ , we have the following estimates, due to Lemma 3.1

$$||h||_s \le c(M_4)\{||F||_{s+1} + ||F||_2||U||_{s+2}\},$$

and with Theorem 3.4 we obtain

$$||\widetilde{h}||_s \le c(M_4)(||h||_s + ||U||_{s+4}||h||_0).$$

Taking into account of the estimate on  $\kappa(Y)$  in Theorem 3.4, we then arrive to

$$\left\|\frac{\widetilde{h}}{\kappa}\right\|_{s} \le c(M_{5})\{\left\|F\right\|_{s+1} + \left\|F\right\|_{2}\left\|U\right\|_{s+5}\}. \tag{5.100}$$

In the same way, thanks to the Theorem 3.4, we also have

$$||\delta\phi||_s \le c(M_4)\{||\widetilde{\delta\phi}||_s + ||U||_{s+4}||\widetilde{\delta\phi}||_0\},$$

and since

$$\delta \eta = -\frac{1}{a} \mathcal{J}(\delta \phi) + \frac{1}{a} g,$$

we obtain

$$||\delta\eta||_s \le c(M_4)\{||\widetilde{\delta\phi}||_{s+1} + ||U||_{s+5}||\widetilde{\delta\phi}||_0\} + c(M_4)\{||F||_s + ||U||_{s+2}||F||_2\}.$$

Hence

$$||V||_{s} \leq c(M_{4})\{||\widetilde{\delta\phi}||_{s+1} + ||U||_{s+5}||\widetilde{\delta\phi}||_{0}\} + c(M_{4})\{||F||_{s} + ||U||_{s+2}||F||_{2}\},$$

and thanks to Lemma 3.1

$$||\delta U||_{s} \leq c(M_{3})\{||V||_{s} + ||U||_{s+1}||V||_{2}\},$$

$$\leq c(M_{7})\{||\widetilde{\delta \phi}||_{s+1} + ||U||_{s+5}||\widetilde{\delta \phi}||_{0} + ||U||_{s+1}||\widetilde{\delta \phi}||_{3}\} +$$

$$+c(M_{4})\{||F||_{s} + ||U||_{s+2}||F||_{2}\}.$$
(5.101)

It remains to use Theorem 5.1 which connects  $\widetilde{\delta\phi}$  and  $\frac{\widetilde{h}}{\kappa}$ , taking into account of estimates ii) of Theorem 3.4. Assuming that properties (4.4) hold for  $\widetilde{\nu}_j(\varepsilon)$  and  $\widetilde{\varkappa}_j(\varepsilon)$  we have (see Theorem 4.2) for  $\varepsilon \leq \varepsilon_0$  and  $\varepsilon \in \mathfrak{N}_{\alpha}$ ,  $\alpha \in (0, 1/78)$  the following estimates for  $||U||_{\rho} \leq \varepsilon$ ,  $i \geq 14$ ,  $1 \leq r \leq s$ 

$$\begin{aligned} ||\widetilde{\delta\phi}||_{r-1} &\leq & \frac{c(M_{14})}{\varepsilon^2} ||\widetilde{\frac{h}{\kappa}}||_r, \quad 1 \leq r \leq i - 9 \\ ||\widetilde{\delta\phi}||_{s-1} &\leq & \frac{c(M_{14})}{\varepsilon^2} ||\widetilde{\frac{h}{\kappa}}||_r (1 + ||U||_{s+19}) + c(M_{14}) ||\widetilde{\frac{h}{\kappa}}||_s. \end{aligned}$$

From this and (5.100) we deduce that

$$||\widetilde{\delta\phi}||_{r-2} \leq \frac{c(M_{14})}{\varepsilon^2}||F||_r, \quad 2 \leq r \leq i - 8,$$

$$||\widetilde{\delta\phi}||_{s-2} \leq \frac{c(M_{14})}{\varepsilon^2}||F||_r(1 + ||U||_{s+18}) + c(M_{14})||F||_s,$$

and from (5.101) we obtain the estimates for  $\delta U$  (5.98). The rest of Theorem 5.9 follows directly from the results of previous subsection and from Theorem 4.2.

# 6 Nonlinear problem. Proof of Theorem 1.3

In this section we complete the proof of the main Theorem 1.3 on existence of diamond nonlinear waves of finite amplitude. To this end we exploit the general version of the Nash-Moser Implicit Function Theorem proved in Appendix N of [24]. This result concerns the solvability of the operator equation

$$\Phi(W,\varepsilon) = 0 \tag{6.1}$$

in scales of Banach spaces  $E_s$  and  $F_s$  parametrized by  $s \in \mathbb{N}_0 = \mathbb{N} \cup \{0\}$ , and supplemented with the norms  $||\cdot||_s$  and  $|\cdot|_s$ . It is supposed that they satisfy the following conditions.

- (A1) For t < s there exists c(t,s) such that  $\|\cdot\|_t \le c(t,s)\|\cdot\|_s$ ,  $|\cdot|_t \le c(t,s)|\cdot|_s$ .
- (A2) For  $\lambda \in [0,1]$  with  $\lambda t + (1-\lambda)s \in \mathbb{N}$ ,

$$||\cdot||_{\lambda t+(1-\lambda)s} \leq c(t,s)||\cdot||_t^\lambda \, ||\cdot||_s^{1-\lambda}, \quad |\cdot|_{\lambda t+(1-\lambda)s} \leq c(t,s)|\cdot|t^\lambda \, |\cdot|_s^{1-\lambda}.$$

(A3) There exists a family of smoothing operators  $S_{\wp}$  defined over the first scale such that for  $\wp > 0$  and t < s,

$$||S_{\wp}W||_{t} \le c(t,s)||W||_{s}, \qquad ||S_{\wp}W||_{s} \le c(t,s)\wp^{t-s}||W||_{t},$$
$$||S_{\wp}W - W||_{t} \le c(t,s)\wp^{s-t}||W||_{s},$$

and, if  $\varepsilon \mapsto \wp(\varepsilon)$  is a smooth, increasing, convex function on  $[0,\infty)$  with  $\wp(0) = 0$ , then, for  $0 < \varepsilon_1 < \varepsilon_2$ ,

$$\| (S_{\wp(\varepsilon_1)} - S_{\wp(\varepsilon_2)})W \|_s \le c(t,s)|\varepsilon_1 - \varepsilon_2|\wp'(\varepsilon_2)\wp(\varepsilon_1)^{t-s-1} \|W\|_t.$$

(B1) Operators  $\Phi(\cdot, \varepsilon)$ , depend on a small parameter  $\varepsilon \in [0, \varepsilon_0]$ , and map a neighborhood of 0 in  $E_r$  into  $F_{\rho}$ . Suppose that there exist

$$\sigma \le \rho \le r - 1, \ \sigma, \rho, r \in \mathbb{N}_0,$$

and, for all  $l \in \mathbb{N}_0$ , numbers c(l) > 0 and  $\varepsilon(l) \in (0, \varepsilon_0]$  with the following properties for all W, U,  $W_i$ ,  $U_i \in B$  and  $\varepsilon$ ,  $\varepsilon_i \in [0, \varepsilon_0]$ , i = 1, 2, where  $B = \{W \in E_r : |W|_r \leq R_0\}$  for some  $R_0 > 0$ :

(B2) The operator  $\Phi: B \times [0, \varepsilon_0] \to F_\rho$  is twice continuously differentiable,

$$|\Phi(W,\varepsilon)|_{\rho+l} \le c(l)(1+||W||_{r+l})$$
 (6.2)

and, for  $W, U \in E_{r+l}, \varepsilon \in [0, \varepsilon(l)],$ 

$$|D(W, U, \varepsilon)|_{\rho+l} \leq c(l)(1 + ||W||_{r+l} + ||U||_{r+l})||W - U||_r^2 + c(l)||W - U||_r||W - U||_{r+l},$$

$$(6.3)$$

where

$$D(W, U, \varepsilon) = \Phi(W, \varepsilon) - \Phi(U, \varepsilon) - \Phi'_W(U, \varepsilon)(W - U).$$

Moreover,

$$|D(W_1, U_1, \varepsilon_1) - D(W_2, U_2, \varepsilon_2)|_{\rho} \leq c \left( |\varepsilon_1 - \varepsilon_2| + ||W_1 - W_2||_r + ||W_1 - W_2||_r \right) \cdot \left( ||W_1 - U_1||_r + ||W_2 - U_2||_r \right). \tag{6.4}$$

(B3) There exists a family of bounded linear operators  $\Lambda(W,\varepsilon): E_r \to F_\rho$ , depending on  $(W,\varepsilon) \in B \times [0,\varepsilon_0]$ , with

$$|\Lambda(W,\varepsilon)U|_{\rho} \le c(0)||U||_{r}, \quad U \in E_{r},$$
 (6.5)

that approximates the Fréchet derivative  $\Phi'_W$  as follows. For  $W \in E_{r+l} \cap B$ ,  $\varepsilon \in [0, \varepsilon(l)]$  and  $U \in E_{r+l}$ ,

$$|\Lambda(W,\varepsilon)U - \Phi'_{W}(W,\varepsilon)U|_{\rho+l} \leq c(l)(1 + ||W||_{r+l})|\Phi(W,\varepsilon)|_{r}||U||_{r} + c(l)|\Phi(W,\varepsilon)|_{r+l}||U||_{r} + c(l)|\Phi(W,\varepsilon)|_{r}||U||_{r+l}.$$
(6.6)

(B4) When  $W_i \in B \cap E_{r+l}$ ,  $\varepsilon_i \in [0, \varepsilon(l)]$ , i = 1, 2,

$$|\Phi(W_1, \varepsilon_1) - \Phi(W_2, \varepsilon_2)|_{\rho+l} \leq c(l) (1 + ||W_1||_{r+l} + ||W_2||_{r+l})$$

$$\cdot (|\varepsilon_1 - \varepsilon_2| + ||W_1 - W_2||_r) + c(l) ||W_1 - W_2||_{r+l},$$
(6.7)

$$|(\Phi'_{W}(W_{1},\varepsilon_{1}) - \Phi'_{W}(W_{2},\varepsilon_{2}))U|_{\rho+l} + |(\Lambda(W_{1},\varepsilon_{1}) - \Lambda(W_{2},\varepsilon_{2}))U|_{\rho+l} \leq$$

$$\leq c(l)\Big(\|W_{1} - W_{2}\|_{r+l} + (|\varepsilon_{1} - \varepsilon_{2}| + \|W_{1} - W_{2}\|_{r})(\|W_{1}\|_{r+l} + \|W_{2}\|_{r+l})\Big)\|U\|_{r} + (|\varepsilon_{1} - \varepsilon_{2}| + \|W_{1} - W_{2}\|_{r})\|U\|_{r+l}, \quad (6.8)$$

- A set  $\mathcal{E} \subset [0, \infty)$  is dense at 0 if  $\lim_{r \searrow 0} \frac{2}{r^2} \int_{\mathcal{E} \cap [0, r]} \varepsilon \, d\varepsilon = 1$ .
- (B5) If a set  $\mathcal{E} \subset [0, \varepsilon(l)]$  is dense at 0 and a mapping  $\vartheta : \mathcal{E} \to B \cap E_{r+l}$  is Lipschitz in the sense that for  $\varepsilon_1, \, \varepsilon_2 \in \mathcal{E}$ ,

$$\|\vartheta(\varepsilon_1) - \vartheta(\varepsilon_2)\|_r \le C|\varepsilon_1 - \varepsilon_2|$$
 where  $C = C(\vartheta)$ , constant,

then there is a set  $\mathcal{E}(\vartheta) \subset \mathcal{E}$ , which is also dense at 0, such that, for any  $\varepsilon \in \mathcal{E}(\vartheta)$  and  $f \in F_{\rho+l}$ , the equation  $\Lambda(\vartheta(\varepsilon), \varepsilon)\delta W = f$  has a unique solution satisfying

$$\|\delta W\|_{\rho-\sigma+l} \le \varepsilon^{-\varrho} c(l) (|f|_{\rho+l} + \|\vartheta(\varepsilon)\|_{r+l} |f|_{\rho}). \tag{6.9}$$

(B6) Suppose that  $\vartheta_0 : \mathcal{E}_0 \to B \cap E_{r+l}$  and mappings  $\vartheta_k : \bigcap_{i=0}^{k-1} \mathcal{E}(\vartheta_i) \to B \cap E_{r+l}$  satisfy, for a constant C independent of  $k \in \mathbb{N}$  sufficiently large,

$$\|\vartheta_k(\varepsilon_1) - \vartheta_k(\varepsilon_2)\|_r \le C|\varepsilon_1 - \varepsilon_2|, \quad \varepsilon_1, \ \varepsilon_2 \in \cap_{j=0}^{k-1} \mathcal{E}(\vartheta_j),$$
$$\|\vartheta_{k+1}(\varepsilon) - \vartheta_k(\varepsilon)\|_r \le \frac{1}{2^k}, \quad \varepsilon \in \cap_{j=0}^k \mathcal{E}(\vartheta_j).$$

Then  $\bigcap_{i=0}^{\infty} \mathcal{E}(\vartheta_i)$  is dense at 0, where the sets  $\mathcal{E}(\vartheta_i)$  are defined in (B5).

**Theorem 6.1** Suppose (A1)-(B6) hold and, for  $N \in \mathbb{N}$  with  $N \geq 2$ , equation (6.1) has approximate solution  $W = W_{\varepsilon}^{(N)} \in \cap_{s \in \mathbb{N}_0} E_s$ , with, for a constant k(N, s),

$$||W_{\varepsilon}^{(N)}||_{s} \le k(N, s)\varepsilon, \quad |\Phi(\varepsilon, W_{\varepsilon}^{(N)})|_{s} \le k(N, s)|\varepsilon|^{N+1}$$

$$(6.10)$$

and

$$||W_{\varepsilon_1}^{(N)} - W_{\varepsilon_2}^{(N)}||_s \le k(N, s)|\varepsilon_1 - \varepsilon_2|. \tag{6.11}$$

Then there is a set  $\mathcal{E}$ , which is dense at 0, and a family

$$\{W = \vartheta(\varepsilon) : \varepsilon \in \mathcal{E}\} \subset E_r$$

of solutions to (6.1) with  $\|\vartheta(\varepsilon_1) - \vartheta(\varepsilon_2)\|_r \le c|\varepsilon_1 - \varepsilon_2|$  for some constant c.

In order to apply Theorem 6.1 to the 3D wave problem, let us introduce some notations. Fix an arbitrary  $\alpha \in (0, 1/78)$  and  $0 < \delta < 1$ . Denote by  $\mathcal{N}$  the set of all  $\mu_c$  so that  $\nu_0 = \mu_c^{-1}$  belongs to the set  $\mathfrak{N}_{\alpha}$  given by Theorem 4.2. Since  $\mathfrak{N}_{\alpha} \subset [1, \infty)$  is a set of full measure,  $\mathfrak{N}$  is the set of full measure in (0,1). Choose an arbitrary  $\mu_c = (1+\tau^2)^{-1/2} \in \mathfrak{N}$  so that  $\tau \in (\delta, 1/\delta)$  and set  $\tau = \tan \theta$ . It is clear that  $\mu_c$  and  $\tau$  meet all requirements of Theorem 1.3.

Next we fix the lattice  $\Gamma$  such that the dual lattice is spanned by the wave vectors  $(1, \pm \tau)$ , and set

$$E_s = F_s = H^s_{o,e}(\mathbb{R}^2/\Gamma) \times H^s_{e,e}(\mathbb{R}^2/\Gamma).$$

Since the scaling mapping  $u \to u \circ \mathbb{T}^{-1}$  establishes an isomorphism between  $H^s(\mathbb{R}^2/\Gamma)$  and a closed subspace of the Sobolev space  $H^s$  of doubly  $2\pi$  – periodic functions, the properties (A1) and (A2) are clear. A smoothing operator with the required properties can be defined by

$$S_{\wp}u = \frac{\sqrt{\tau}}{2\pi} \sum_{K \in \Gamma'} \varsigma(\wp|K|) \hat{u}_K e^{iK \cdot X},$$

where  $\varsigma : \mathbb{R}^+ \to \mathbb{R}^+$  is a smooth function which equals 1 on [0,1] and 0 on  $[2,\infty)$ .

Fix an arbitrary N>3 and define the operator  $\Phi=(\Phi_1,\Phi_2)$  by the equalities

$$\Phi(W,\varepsilon) = \varepsilon^{-N} \mathcal{F} \left( U_{\varepsilon}^{(2N)} + \varepsilon^{N} W, \mu_{\varepsilon}^{(2N)} \right), \tag{6.12}$$

where  $(U_{\varepsilon}^{(2N)}, \mu_{\varepsilon}^{(2N)})$  is the approximate solution at order  $\varepsilon^{2N}$  obtained at Theorem 2.3 in the case of diamond waves  $(\varepsilon_1 = \varepsilon_2 = \varepsilon/2)$ , and  $\tau = \tan \theta$ ,  $\mu_c = \cos \theta$ ,  $\delta < \tau < 1/\delta$ . By construction  $W_{\varepsilon}^{(N)} = 0$ , hence (6.10) and (6.11) are satisfied.

It follows from Lemma 1.1 that the continuous mapping  $(W, \varepsilon) \mapsto \Phi(W, \varepsilon)$  from  $E_{s+1} \times \mathbb{R}$  into  $F_s$  for  $s \geq 2$ , is of class of  $C^{\infty}$ . Applying the same arguments as in section 9 of [24] we conclude from this that for  $5 \leq \rho \leq r-18$ , the operator  $\Phi$  satisfies Conditions (B1) and (B2), and inequality (6.7) from Condition (B4). Let us denote by  $\Lambda$  the approximate differential, defined as

$$\Lambda(W,\varepsilon) = \mathcal{L}(U_{\varepsilon}^{(2N)} + \varepsilon^{N}W, \mu_{\varepsilon}^{(2N)}) \begin{pmatrix} 1 & -\mathfrak{b} \\ 0 & 1 \end{pmatrix}$$

where the operator  $\mathfrak{L}$  and coefficient  $\mathfrak{b}$  are defined by formulae (3.1) and (3.3). It follows from this and (3.2) that the linear operator

$$\mathcal{R} = \Lambda(W, \varepsilon) - \partial_W \Phi(W, \varepsilon),$$

is defined by  $\mathcal{R}\delta W = (R_1\delta W, 0)$  with

$$R_1 \delta W = \mathcal{G}_{\eta} \left( \frac{\Phi_1 \delta \eta}{1 + (\nabla \eta)^2} \right) - \nabla \cdot \left( \frac{\Phi_1 \delta \eta}{1 + (\nabla \eta)^2} \nabla \eta \right),$$

where  $\delta W = (\delta \psi, \delta \eta)$  and  $\Phi_1 = \Phi_1(W, \varepsilon)$ . Then, thanks to Lemma 3.1, we have for  $s \geq 2$ , and  $||U||_3 \leq M_3$ 

$$||\Lambda(W,\varepsilon)u||_s \le c(M_3)(1+||W||_{s+2})||u||_{s+1},$$

$$||\mathcal{R}u||_s \le c_s(M_3)\{||\Phi||_2(1+||W||_{s+2})||u||_2+||u||_{s+1})+||\Phi||_{s+1}||u||_2.$$

Therefore, the operators  $\Phi$  and  $\Lambda$  satisfy Conditions (B3) and (B4). Now taking into account the result of Theorem 5.9, it appears that Condition (B5) is satisfied for

$$5 \leq \rho \leq r - 18$$
  
$$\sigma = 3, \quad \rho = 2,$$

Finally, since  $N \ge 3$ , condition (B6) is also satisfied thanks to Theorem 4.2, so we can apply Theorem 6.1, and Theorem 1.3 is proved.

## A Analytical study of $\mathcal{G}_{\eta}$

## A.1 Computation of the differential of $\mathcal{G}_{\eta}$

Let us make the following change of coordinate for  $x_3$ 

$$s = x_3 - \eta(X)$$

and denote by  $\theta$  the function defined by

$$\theta(X, s) = \varphi(X, s + \eta(X)).$$

Then the Dirichlet-Neumann operator is defined by

$$\Delta \theta - 2\nabla_X \eta \cdot \nabla_X (\frac{\partial \theta}{\partial s}) - \frac{\partial \theta}{\partial s} \Delta_X \eta + \frac{\partial^2 \theta}{\partial s^2} (\nabla_X \eta)^2 = 0, \quad s < 0$$
 (A.1)

$$\begin{array}{rcl} \theta|_{s=0} & = & \psi \\ \nabla\theta & \rightarrow & 0 \ \ {\rm as} \ \ s \rightarrow -\infty, \end{array}$$

and

$$\mathcal{G}_{\eta}\psi = (1 + (\nabla_X \eta)^2) \frac{\partial \theta}{\partial s}|_{s=0} - \nabla_X \eta \cdot \nabla_X \psi. \tag{A.2}$$

Notice that the above equations (A.1), (A.2) may be written into the form

$$\nabla \cdot (P_{\eta} \nabla \theta) = 0, \quad s < 0,$$
  
$$\mathcal{G}_{\eta} \psi = (P_{\eta} \nabla \theta) \cdot \mathbf{e}_{3}$$

where  $e_3$  is the unit vertical vector, and  $P_{\eta}$  is the following symmetric matrix

$$P_{\eta} = \left( \begin{array}{cc} \mathbb{I} & -\nabla_X \eta \\ -(\nabla_X \eta)^t & 1 + (\nabla_X \eta)^2 \end{array} \right).$$

We can see easily that the operator  $\mathcal{G}_{\eta}$  is symmetric and non negative in  $L^2(\mathbb{R}^2/\Gamma)$ : for  $\eta$ ,  $\psi_1$ ,  $\psi_2$  smooth enough bi-periodic functions

$$\begin{aligned}
\langle \mathcal{G}_{\eta} \psi_{1}, \psi_{2} \rangle &= \langle (P_{\eta} \nabla \theta_{1}) \cdot \mathbf{e}_{3}, \psi_{2} \rangle \\
&= \int_{-\infty}^{0} \int_{\mathbb{R}^{2}/\Gamma} (\nabla \theta_{2} \cdot P_{\eta} \nabla \theta_{1}) dX ds
\end{aligned}$$

which is symmetric. Moreover, we have

$$\nabla \theta \cdot P_{\eta} \nabla \theta = (\nabla_X \theta - \nabla_X \eta \frac{\partial \theta}{\partial s})^2 + (\frac{\partial \theta}{\partial s})^2 \ge 0,$$

hence, for  $\eta$  and  $\psi$  smooth enough bi-periodic functions

$$\langle \mathcal{G}_{\eta} \psi, \psi \rangle \geq 0.$$

Let us now compute formally the differential of  $\mathcal{G}_{\eta}$ . From (A.2), we obtain

$$\partial_{\eta} \mathcal{G}_{\eta}[h] \psi = (P_{\eta} \nabla \theta_1) \cdot \mathbf{e}_3 + (Q_{\eta}[h] \nabla \theta) \cdot \mathbf{e}_3 \tag{A.3}$$

with  $\theta$  as above, and where  $\theta_1$  satisfies the system

$$\begin{split} \nabla \cdot \left( P_{\eta} \nabla \theta_{1} \right) &= -\nabla \cdot \left( Q_{\eta}[h] \nabla \theta \right), \quad s < 0 \\ \theta_{1}|_{s=0} &= 0, \\ \nabla \theta_{1} &\to 0, \quad s \to -\infty, \\ Q_{\eta}[h] &= \left( \begin{array}{cc} 0 & -\nabla_{X} h \\ -(\nabla_{X} h)^{t} & 2\nabla_{X} \eta \cdot \nabla_{X} h \end{array} \right). \end{split}$$

Let us notice from (A.1), (A.2), that we have

$$\nabla \cdot \left( P_{\eta} \nabla (h \frac{\partial \theta}{\partial s}) \right) + \nabla \cdot (Q_{\eta}[h] \nabla \theta) = 0, \quad s < 0.$$

Indeed, we have

$$\begin{split} P_{\eta} \nabla (h \frac{\partial \theta}{\partial s}) & = & h P_{\eta} (\nabla \frac{\partial \theta}{\partial s}) + \frac{\partial \theta}{\partial s} \left( \begin{array}{c} \nabla_X h \\ -\nabla_X \eta \cdot \nabla_X h \end{array} \right), \\ Q_{\eta} [h] \nabla \theta & = & \left( \begin{array}{c} -\nabla_X h \frac{\partial \theta}{\partial s} \\ -\nabla_X \theta \cdot \nabla_X h + 2(\nabla_X \eta \cdot \nabla_X h) \frac{\partial \theta}{\partial s} \end{array} \right), \end{split}$$

hence

$$\begin{split} &\nabla \cdot \left( P_{\eta} \nabla (h \frac{\partial \theta}{\partial s}) \right) + \nabla \cdot (Q_{\eta}[h] \nabla \theta) = \\ &= h \nabla \cdot (P_{\eta} \nabla \frac{\partial \theta}{\partial s}) + \nabla_{X} h \cdot \left\{ (P_{\eta} \nabla \frac{\partial \theta}{\partial s}) - \nabla_{X} \frac{\partial \theta}{\partial s} + \nabla_{X} \eta \frac{\partial^{2} \theta}{\partial s^{2}} \right\}, \end{split}$$

and this cancels, thanks to  $\nabla \cdot (P_{\eta} \nabla \theta) = 0$ , and to the definition of  $P_{\eta}$ . It results that

$$\begin{array}{rcl} \theta_1 & = & h\frac{\partial\theta}{\partial s} + \theta_2, \\ \nabla \cdot \left(P_{\eta}\nabla\theta_2\right) & = & 0, \quad s < 0, \\ \theta_2|_{s=0} & = & -h\frac{\partial\theta}{\partial s}|_{s=0}, \\ \nabla\theta_2 & \to & 0, \quad s \to -\infty, \end{array}$$

hence looking at relationship (A.3), we obtain

$$\partial_{\eta} \mathcal{G}_{\eta}[h] \psi = (P_{\eta} \nabla \theta_{2}) \cdot \mathbf{e}_{3} + (P_{\eta} \nabla (h \frac{\partial \theta}{\partial s})) \cdot \mathbf{e}_{3} + (Q_{\eta}[h] \nabla \theta) \cdot \mathbf{e}_{3}$$

$$= -\mathcal{G}_{\eta} (h \frac{\partial \theta}{\partial s}|_{0}) + h \{ (1 + (\nabla_{X} \eta)^{2}) \frac{\partial^{2} \theta}{\partial s^{2}}|_{0} - \nabla_{X} \eta \cdot \nabla_{X} \frac{\partial \theta}{\partial s}|_{0} \} + \nabla_{X} h \cdot \{ \nabla_{X} \eta \frac{\partial \theta}{\partial s}|_{0} - \nabla_{X} \psi \},$$

and using  $\nabla \cdot (P_{\eta} \nabla \theta) = 0$ , we get

$$\partial_{\eta} \mathcal{G}_{\eta}[h] \psi = -\mathcal{G}_{\eta}(h \frac{\partial \theta}{\partial s}|_{0}) + h\{-\Delta_{X} \psi + \nabla_{X} \eta \cdot \nabla_{X} \frac{\partial \theta}{\partial s}|_{0} + \Delta_{X} \eta \frac{\partial \theta}{\partial s}|_{0}\} + \\
+ \nabla_{X} h \cdot \{\nabla_{X} \eta \frac{\partial \theta}{\partial s}|_{0} - \nabla_{X} \psi\} \\
= -\mathcal{G}_{\eta}(h \frac{\partial \theta}{\partial s}|_{0}) + \nabla_{X} \cdot \{h(\nabla_{X} \eta \frac{\partial \theta}{\partial s}|_{0} - \nabla_{X} \psi)\}$$

as required in Lemma 2.1, thanks to (A.2).

## A.2 Second order Taylor expansion of $\mathcal{G}_{\eta}$ in $\eta = 0$

Let us consider the Taylor expansion of  $\mathcal{G}_{\eta}$  in "powers" of  $\eta$ :

$$G_{\eta}\psi = G^{(0)}\psi + G^{(1)}\{\eta\}\psi + G^{(2)}\{\eta^{(2)}\}\psi + \dots$$

where  $\mathcal{G}^{(k)}$  is k- linear symmetric with respect to  $\eta$ , and linear in  $\psi$ . Moreover, for any  $k \geq 1$  and  $m \geq 2$ ,  $\mathcal{G}^{(k)}$  is bounded from

$$\{H^{m+1}(\mathbb{R}^2/\Gamma)\}^k$$
 into  $\mathcal{L}(H_0^{m+1}(\mathbb{R}^2/\Gamma), H_0^m(\mathbb{R}^2/\Gamma)).$ 

From the lemma above and (2.1), (2.2), we obtain

$$\mathcal{G}^{(1)}\{\eta\}\psi = -\mathcal{G}^{(0)}(\eta\mathcal{G}^{(0)}\psi) - \nabla \cdot (\eta\nabla\psi). \tag{A.4}$$

Differentiating once more (2.2) with respect to  $\eta$ , we now obtain in 0

$$\partial_n \zeta[h] = -\mathcal{G}^{(0)}(h\mathcal{G}^{(0)}\psi) - h\Delta\psi,$$

and differentiating (2.1) with respect to  $\eta$ , we then obtain the (symmetric) second order derivative in 0, and

$$\mathcal{G}^{(2)}\{\eta^{(2)}\}\psi = \mathcal{G}^{(0)}(\eta\mathcal{G}^{(0)}(\eta\mathcal{G}^{(0)}\psi)) + \frac{1}{2}\mathcal{G}^{(0)}(\eta^2\Delta\psi) + \frac{1}{2}\Delta(\eta^2\mathcal{G}^{(0)}\psi). \tag{A.5}$$

Now, if we Fourier expand any bi-periodic function as

$$\psi = \sum_{K \in \Gamma'} \psi_K e^{iK \cdot X}$$

then we have

$$\{\mathcal{G}^{(0)}\psi\}_K = |K|\psi_K,$$
 (A.6)

$$\{\mathcal{G}^{(1)}\{\eta\}\psi\}_K = \sum_{K_1 + K_2 = K, \ K_j \in \Gamma'} \{(K \cdot K_1) - |K||K_1|\}\psi_{K_1}\eta_{K_2}, \tag{A.7}$$

$$\{\mathcal{G}^{(2)}\{\eta^{(2)}\}\psi\}_{K} = \sum_{K_{1}+K_{2}+K_{3}=K, K_{j}\in\Gamma'} \frac{|K||K_{1}|}{2}\{|K_{1}+K_{2}|+|K_{1}+K_{3}|-|K|-|K_{1}|\}\psi_{K_{1}}\eta_{K_{2}}\eta_{K_{3}},$$

and we check that, for  $m \geq 2$ , the operators are bounded from  $\{H^{m+1}(\mathbb{R}^2/\Gamma)\}^k$  into  $\mathcal{L}(H_0^{m+1}(\mathbb{R}^2/\Gamma), H_0^m(\mathbb{R}^2/\Gamma))$  since we have

$$|(K_1 + K_2) \cdot K_1| - |K_1 + K_2||K_1|| \le 4|K_1||K_2|,$$

and there exists a constant c such that

$$|K_1 + K_2 + K_3| ||K_1 + K_2| + |K_1 + K_3| - |K_1 + K_2 + K_3| - |K_1|| \le c|K_2||K_3|.$$

## B Formal computation of 3-dimensional waves

In taking  $\mathbf{u}_0 = (1,0)$ , the symmetric linearized operator for  $\mu = \mu_c$  and  $\mathbf{u} = \mathbf{u}_0$  reads

$$\mathcal{L}_0 = \begin{pmatrix} \mathcal{G}^{(0)} & -\frac{\partial}{\partial x_1} \\ \frac{\partial}{\partial x_1} & \mu_c \end{pmatrix},$$

and  $\mathcal{L}_0$  has a four-dimensional kernel, spanned by the vectors

$$\begin{array}{lcl} \zeta_0 & = & (1,-i/\mu_c)e^{iK_1\cdot X}, \ \overline{\zeta}_0 = (1,i/\mu_c)e^{-iK_1\cdot X}, \\ \zeta_1 & = & (1,-i/\mu_c)e^{iK_2\cdot X}, \ \overline{\zeta}_1 = (1,i/\mu_c)e^{-iK_2\cdot X}. \end{array}$$

We observe that the action of different symmetries of the system on eigenvectors is as follows:

$$\mathcal{T}_{\mathbf{v}}\zeta_0 = \zeta_0 e^{iK_1 \cdot \mathbf{v}}, \ T_{\mathbf{v}}\zeta_1 = \zeta_1 e^{iK_2 \cdot \mathbf{v}}, 
\mathcal{S}_0\zeta_0 = -\overline{\zeta}_0, \ \mathcal{S}_0\zeta_1 = -\overline{\zeta}_1, 
\mathcal{S}_1\zeta_0 = \zeta_1, \ \mathcal{S}_1\zeta_1 = \zeta_0.$$

Let us write formally the nonlinear system (1.6), (1.7) under the form

$$\mathcal{L}_{0}U + \tilde{\mu}\mathcal{L}_{1}U + \mathcal{L}_{2}(\omega, U) + \mathcal{N}_{2}(U, U) + \mathcal{N}_{3}(U, U, U) + O(||U||^{4} + |\omega|||U||^{2}) = 0,$$
with  $U = (\psi, \eta)$ ,  $\tilde{\mu} = \mu - \mu_{c}$ ,  $\omega = \mathbf{u} - \mathbf{u}_{0}$ 

$$\mathcal{L}_{1}U = (0, \eta),$$

$$\mathcal{L}_{2}(\omega, U) = (-\omega \cdot \nabla \eta, \omega \cdot \nabla \psi),$$

$$\mathcal{N}_{2}(U, U) = \begin{cases} \mathcal{G}^{(1)}\{\eta\}\psi \\ \frac{1}{2}\nabla\psi^{2} - \frac{1}{2}(\frac{\partial \eta}{\partial x_{1}})^{2} \end{cases},$$

$$\mathcal{N}_{3}(U, U, U) = \begin{cases} \mathcal{G}^{(2)}\{\eta, \eta\}\psi \\ -\frac{\partial \eta}{\partial x_{1}}(\nabla \eta \cdot \nabla \psi) \end{cases}.$$

### B.1 Formal Fredholm alternative

Let us consider the formal resolution of the linear system

$$\mathcal{L}_0 U = F = (f, g),$$

with

$$U = \sum_{n=(n_1,n_2)\in\mathbb{Z}^2} U_n e^{i(n_1 K_1 \cdot X + n_2 K_2 \cdot X)}, \quad U_n = (\psi_n, \eta_n), \quad \psi_0 = 0,$$

$$F = \sum_{n=(n_1,n_2)\in\mathbb{Z}^2} F_n e^{i(n_1 K_1 \cdot X + n_2 K_2 \cdot X)}, \quad F_n = (f_n, g_n), \quad f_0 = 0.$$

Then, we have

$$|n_1K_1 + n_2K_2|\psi_n - i\{(n_1K_1 + n_2K_2) \cdot \mathbf{u}_0\}\eta_n = f_n$$
  
$$i\{(n_1K_1 + n_2K_2) \cdot \mathbf{u}_0\}\psi_n + \mu_c\eta_n = g_n,$$

hence for

$$\{(n_1K_1 + n_2K_2) \cdot \mathbf{u}_0\}^2 - \mu_c |n_1K_1 + n_2K_2| \neq 0$$

i.e. by assumption for  $(n_1, n_2) \neq (\pm 1, 0), (0, \pm 1)$ , this leads to

$$\psi_n = -\frac{\mu_c f_n + i\{(n_1 K_1 + n_2 K_2) \cdot \mathbf{u}_0\} g_n}{\{(n_1 K_1 + n_2 K_2) \cdot \mathbf{u}_0\}^2 - \mu_c |n_1 K_1 + n_2 K_2|},$$
 (B.2)

$$\eta_n = \frac{i\{(n_1K_1 + n_2K_2) \cdot \mathbf{u}_0\}f_n - |n_1K_1 + n_2K_2|g_n\}}{\{(n_1K_1 + n_2K_2) \cdot \mathbf{u}_0\}^2 - \mu_c|n_1K_1 + n_2K_2|},$$
 (B.3)

and for  $(n_1, n_2) = (0, 0)$ 

$$\psi_{0,0} = 0, \quad \eta_{0,0} = \frac{1}{\mu_c} g_{0,0},$$

while for  $(n_1, n_2) = (\pm 1, 0), (0, \pm 1)$ , we need to satisfy the compatibility conditions

$$(F, \zeta_0) = (F, \overline{\zeta}_0) = (F, \zeta_1) = (F, \overline{\zeta}_1) = 0$$

which gives

$$\begin{array}{rcl} \mu_c f_{1,0} + i g_{1,0} & = & 0, \\ \mu_c f_{-1,0} - i g_{-1,0} & = & 0, \\ \mu_c f_{0,1} + i g_{0,1} & = & 0, \\ \mu_c f_{0,-1} - i g_{0,-1} & = & 0. \end{array}$$

For uniqueness of the definition of the pseudo-inverse  $\widetilde{\mathcal{L}}_0^{-1}$ , we fix U such that

$$(U,\zeta_0)=(U,\overline{\zeta}_0)=(U,\zeta_1)=(U,\overline{\zeta}_1)=0,$$

hence this leads to

$$\psi_{1,0} = -i\frac{1+\tau^2}{2+\tau^2}g_{1,0} = \frac{1}{\mu_c(2+\tau^2)}f_{1,0},$$

$$\eta_{1,0} = \frac{1}{\mu_c(2+\tau^2)}g_{1,0} = \frac{i}{2+\tau^2}f_{1,0},$$

$$\psi_{0,1} = -i\frac{1+\tau^2}{2+\tau^2}g_{0,1} = \frac{1}{\mu_c(2+\tau^2)}f_{0,1},$$

$$\eta_{0,1} = \frac{1}{\mu_c(2+\tau^2)}g_{0,1} = \frac{i}{2+\tau^2}f_{0,1}.$$

### **B.2** Bifurcation equation

Now coming back to (B.1), we use a formal Lyapunov - Schmidt method and decompose U as follows

$$U = W + V$$

$$W = A\zeta_0 + \overline{A\zeta_0} + B\zeta_1 + \overline{B\zeta_1} = \mathcal{P}_0 U$$

We can solve formally with respect to V the part of equ. (B.1) orthogonal to the 4-dimensional kernel of  $\mathcal{L}_0$ , as a uniquely determined formal power series in  $\omega, \tilde{\mu}, A, \overline{A}, B, \overline{B}$ , which we write as

$$V = \mathcal{V}(\tilde{\mu}, \omega, A, \overline{A}, B, \overline{B}).$$

The uniqueness of the series and the symmetries of our system lead to the following identities

$$\begin{split} & \mathcal{T}_{\mathbf{v}} \mathcal{V}(\tilde{\mu}, \omega, A, \overline{A}, B, \overline{B}) &= \mathcal{V}(\tilde{\mu}, \omega, A e^{iK_1 \cdot \mathbf{v}}, \overline{A} e^{-iK_1 \cdot \mathbf{v}}, B e^{iK_2 \cdot \mathbf{v}}, \overline{B} e^{-iK_2 \cdot \mathbf{v}}), \\ & \mathcal{S}_0 \mathcal{V}(\tilde{\mu}, \omega, A, \overline{A}, B, \overline{B}) &= \mathcal{V}(\tilde{\mu}, \omega, -\overline{A}, -A, -\overline{B}, -B) \\ & \mathcal{S} \mathcal{V}(\tilde{\mu}, \mathbf{0}, A, \overline{A}, B, \overline{B}) &= \mathcal{V}(\tilde{\mu}, \mathbf{0}, B, \overline{B}, A, \overline{A}). \end{split}$$

The principal part of V is given by

$$V = -\widetilde{\mathcal{L}}_0^{-1}(\mathbb{I} - P_0)\mathcal{N}_2(W, W) + O\{(|\widetilde{\mu}| + |\omega|)||W|| + ||W||^3\},$$
  
$$-\widetilde{\mathcal{L}}_0^{-1}\mathcal{N}_2(W, W) = A^2U_{2000} + |A|^2U_{1100} + \overline{A}^2U_{0200} + ABU_{1010} + \overline{A}BU_{0110} +$$
  
$$+A\overline{B}U_{1001} + \overline{AB}U_{0101} + B^2U_{0020} + |B|^2U_{0011} + \overline{B}^2U_{0002}$$

where we observe easily that

$$\mathcal{P}_0 \mathcal{N}_2(W, W) = 0.$$

Using (A.7), and

$$2\mathcal{N}_2(U_1, U_2) = \begin{cases} \mathcal{G}^{(1)}\{\eta_1\}\psi_2 + \mathcal{G}^{(1)}\{\eta_2\}\psi_1 \\ \nabla \psi_1 \cdot \nabla \psi_2 - \frac{\partial \eta_1}{\partial x_1} \frac{\partial \eta_2}{\partial x_1} \end{cases}, \tag{B.4}$$

we find

$$\mathcal{N}_{2}(W,W) = A^{2}V_{2000} + |A|^{2}V_{1100} + \overline{A}^{2}V_{0200} + ABV_{1010} + \overline{A}BV_{0110} + A\overline{B}V_{1001} + \overline{A}BV_{0101} + B^{2}V_{0020} + |B|^{2}V_{0011} + \overline{B}^{2}V_{0002}$$

with

$$\begin{split} V_{2000} &= (0, -\frac{1}{\mu_c^2})e^{2iK_1 \cdot X}, \quad V_{0020} = (0, -\frac{1}{\mu_c^2})e^{2iK_2 \cdot X} \\ V_{1100} &= 0, \quad V_{0011} = 0, \quad V_{0200} = \overline{V}_{2000}, \quad V_{0002} = \overline{V}_{0020} \\ V_{1010} &= (\frac{4i}{\mu_c^2}(1 - \mu_c), -2)e^{i(K_1 \cdot X + K_2 \cdot X)}, \quad V_{0101} = \overline{V}_{1010} \\ V_{0110} &= (0, -2\tau^2)e^{i(-K_1 \cdot X + K_2 \cdot X)}, \quad V_{1001} = \overline{V}_{0110}. \end{split}$$

Now, thanks to (B.2), (B.3) we obtain  $-\widetilde{\mathcal{L}}_0^{-1}\mathcal{N}_2(W,W)$  as follows

$$\begin{array}{lll} U_{2000} & = & \left(\frac{-i}{\mu_c^2}, -\frac{1}{\mu_c^3}\right) e^{2iK_1 \cdot X}, & U_{0020} = \left(\frac{-i}{\mu_c^2}, -\frac{1}{\mu_c^3}\right) e^{2iK_2 \cdot X}, \\ \\ U_{1100} & = & 0, & U_{0011} = 0, & U_{0200} = \overline{U}_{2000}, & U_{0002} = \overline{U}_{0020}, \\ \\ U_{1010} & = & \left(\frac{-2i(2\mu_c - 1)}{\mu_c(2 - \mu_c)}, \frac{-2(\mu_c^2 + 2\mu_c - 2)}{\mu_c^2(2 - \mu_c)}\right) e^{i(K_1 \cdot X + K_2 \cdot X)}, & U_{0101} = \overline{U}_{1010}, \\ \\ U_{0110} & = & \left(0, \frac{2\tau^2}{\mu_c}\right) e^{i(-K_1 \cdot X + K_2 \cdot X)}, & U_{1001} = \overline{U}_{0110}. \end{array}$$

Replacing V by  $\mathcal{V}(\tilde{\mu}, \omega, A, \overline{A}, B, \overline{B})$  in the compatibility conditions, i.e. the components of (B.1) on ker  $\mathcal{L}_0$ ,

$$\langle \tilde{\mu} \mathcal{L}_1(W+\mathcal{V}) + \mathcal{L}_2(\omega, W+\mathcal{V}) + \mathcal{N}_2(W+\mathcal{V}, W+\mathcal{V}) + ..., \zeta_0 \rangle = 0,$$
  
$$\langle \tilde{\mu} \mathcal{L}_1(W+\mathcal{V}) + \mathcal{L}_2(\omega, W+\mathcal{V}) + \mathcal{N}_2(W+\mathcal{V}, W+\mathcal{V}) + ..., \zeta_1 \rangle = 0,$$

noticing that the complex conjugate equations are then automatically satisfied, lead to two complex equations of the form

$$f(\tilde{\mu}, \omega, A, \overline{A}, B, \overline{B}) = 0,$$
  
$$g(\tilde{\mu}, \omega, A, \overline{A}, B, \overline{B}) = 0,$$

for which the equivariance of the system (B.1) with respect to various symmetries leads to the following properties

$$\begin{array}{lcl} f(\tilde{\mu},\omega,Ae^{iK_1.\mathbf{v}},\overline{A}e^{-iK_1.\mathbf{v}},Be^{iK_2.\mathbf{v}},\overline{B}e^{-iK_2.\mathbf{v}}) & = & e^{iK_1.\mathbf{v}}f(\tilde{\mu},\omega,A,\overline{A},B,\overline{B}) \\ g(\tilde{\mu},\omega,Ae^{iK_1.\mathbf{v}},\overline{A}e^{-iK_1.\mathbf{v}},Be^{iK_2.\mathbf{v}},\overline{B}e^{-iK_2.\mathbf{v}}) & = & e^{iK_2.\mathbf{v}}g(\tilde{\mu},\omega,A,\overline{A},B,\overline{B}) \\ f(\tilde{\mu},\omega,-\overline{A},-A,-\overline{B},-B) & = & -\overline{f}(\tilde{\mu},\omega,A,\overline{A},B,\overline{B}) \\ g(\tilde{\mu},\omega,-\overline{A},-A,-\overline{B},-B) & = & -\overline{g}(\tilde{\mu},\omega,A,\overline{A},B,\overline{B}) \\ f(\tilde{\mu},\mathbf{0},B,\overline{B},A,\overline{A}) & = & g(\tilde{\mu},\mathbf{0},A,\overline{A},B,\overline{B}). \end{array}$$

Since  $K_1$  and  $K_2$  are linearly independent, it results that f and g take formally the form

$$f(\tilde{\mu}, \omega, A, \overline{A}, B, \overline{B}) = A\phi_0(\tilde{\mu}, \omega, |A|^2, |B|^2)$$
  
$$g(\tilde{\mu}, \omega, A, \overline{A}, B, \overline{B}) = B\phi_1(\tilde{\mu}, \omega, |A|^2, |B|^2),$$

where functions  $\phi_0$  and  $\phi_1$  are real valued. Moreover, for  $\omega = 0$  we have

$$\phi_1(\tilde{\mu}, \mathbf{0}, |A|^2, |B|^2) = \phi_0(\tilde{\mu}, \mathbf{0}, |B|^2, |A|^2).$$

It results immediately that we have the following (formal) solutions of our system (in addition to the trivial solution 0):

**Proof.** i) B = 0, |A| satisfying  $\phi_0(\tilde{\mu}, \omega, |A|^2, 0) = 0$ , which is not else that the 2-dimensional travelling wave with basic wave vector  $K_1$ , and where, with no loss of generality, we can choose the velocity  $\mathbf{c}$  in the direction of  $K_1$ .

- ii) A = 0, |B| satisfying  $\phi_1(\tilde{\mu}, \omega, 0, |B|^2) = 0$ , which is not else that the 2-dimensional travelling wave with basic wave vector  $K_2$ , and where, with no loss of generality, we can choose the velocity  $\mathbf{c}$  in the direction of  $K_2$ .
  - iii) |A| and |B| such that

$$\phi_0(\tilde{\mu}, \omega, |A|^2, |B|^2) = 0, 
\phi_1(\tilde{\mu}, \omega, |A|^2, |B|^2) = 0,$$
(B.5)

which gives a family of 3-dimensional travelling waves. Moreover we notice that if  $\omega = 0$  there is a family of solutions where |A| = |B| and

$$\phi_0(\tilde{\mu}, \mathbf{0}, |A|^2, |A|^2) = 0,$$

representing the "diamond waves" of [36]. The leading terms of  $\phi_0$  and  $\phi_1$  are computed by Bridges, Dias, Menasce in [5], even in cases with a finite depth and with surface tension. Since our case has less parameters, our computations may look simpler. The leading terms independent of |A| and |B| in  $\phi_0$  come from

$$\langle \tilde{\mu} \mathcal{L}_1 \zeta_0 + \mathcal{L}_2(\omega, \zeta_0), \zeta_0 \rangle = \frac{4\pi^2}{\tau} \frac{1}{\mu_c} \left( \frac{\tilde{\mu}}{\mu_c} - 2\omega \cdot K_1 \right),$$

and we notice that (in using  $\frac{\delta\mu}{\mu} = -2\frac{\delta c}{c}$ )

$$\frac{\tilde{\mu}}{\mu_c} - 2\omega \cdot K_1 \sim -2\frac{(\mathbf{c} - \mathbf{c}_0) \cdot K_1}{c_0}.$$

We then have

$$\begin{split} \phi_0(\tilde{\mu},\omega,|A|^2,|B|^2) &= \frac{1}{\mu_c} \left( \frac{\tilde{\mu}}{\mu_c} - 2\omega \cdot K_1 \right) + \alpha_0 |A|^2 + \beta_0 |B|^2 + O\{ (|\tilde{\mu}| + |\omega| + |A|^2 + |B|^2)^2 \} \\ \phi_1(\tilde{\mu},\omega,|A|^2,|B|^2) &= \frac{1}{\mu_c} \left( \frac{\tilde{\mu}}{\mu_c} - 2\omega \cdot K_2 \right) + \beta_0 |A|^2 + \alpha_0 |B|^2 + O\{ (|\tilde{\mu}| + |\omega| + |A|^2 + |B|^2)^2 \}, \end{split}$$

with

$$\alpha_{0} = \frac{\tau}{4\pi^{2}} \langle 2\mathcal{N}_{2}(\overline{\zeta}_{0}, U_{2000}) + 3\mathcal{N}_{3}(\zeta_{0}, \zeta_{0}, \overline{\zeta}_{0}), \zeta_{0} \rangle,$$

$$\beta_{0} = \frac{\tau}{4\pi^{2}} \langle 2\mathcal{N}_{2}(\zeta_{1}, U_{1001}) + 2\mathcal{N}_{2}(\overline{\zeta}_{1}, U_{1010}) + 6\mathcal{N}_{3}(\zeta_{0}, \zeta_{1}, \overline{\zeta}_{1}), \zeta_{0} \rangle.$$

We can formally solve the system of equations

$$\phi_0(\tilde{\mu}, \omega, |A|^2, |B|^2) = 0,$$
  
 $\phi_1(\tilde{\mu}, \omega, |A|^2, |B|^2) = 0,$ 

with respect to  $\tilde{\mu}$ ,  $\omega_2 = \frac{1}{2\tau}\omega \cdot (K_1 - K_2)$ . Indeed, we obtain respectively in adding and subtracting the two equations, a system easy to solve, in taking into account of  $\omega_1 = O(\omega_2^2)$ ,

$$\tilde{\mu} = -\frac{\mu_c^2}{2}(\alpha_0 + \beta_0)(|A|^2 + |B|^2) + O\{(|A|^2 + |B|^2)^2\},$$

$$\omega_2 = (|A|^2 - |B|^2)\left(\frac{\mu_c}{4\tau}(\alpha_0 - \beta_0) + O\{|A|^2 + |B|^2\}\right).$$

For the computation of coefficients  $\alpha_0$  and  $\beta_0$  we use again (A.7) and (B.4) and obtain

$$2\mathcal{N}_{2}(\overline{\zeta}_{0}, U_{2000}) = \left(\frac{2}{\mu_{c}^{5}}, 0\right) e^{iK_{1} \cdot X},$$

$$2\mathcal{N}_{2}(\zeta_{1}, U_{1001}) = \left(-\frac{4\tau^{4}}{\mu_{c}}, 0\right) e^{iK_{1} \cdot X},$$

$$2\mathcal{N}_{2}(\overline{\zeta}_{1}, U_{1010}) = \left(\frac{4(\mu_{c}^{3} + 4\mu_{c}^{2} - 5\mu_{c} + 1)}{\mu_{c}^{3}(2 - \mu_{c})}, \frac{8i(\mu_{c} - 1)(1 - \mu_{c}^{2})}{\mu_{c}^{3}(2 - \mu_{c})}\right) e^{iK_{1} \cdot X}.$$

Now, with (A.8) and the form of  $\mathcal{N}_3$  we have

$$3\mathcal{N}_{3}(\zeta_{0},\zeta_{0},\overline{\zeta}_{0}) = \left(\frac{1}{\mu_{c}^{5}},\frac{-i}{\mu_{c}^{4}}\right)e^{iK_{1}\cdot X},$$

$$6\mathcal{N}_{3}(\zeta_{0},\zeta_{1},\overline{\zeta}_{1}) = \left(\frac{2}{\mu_{c}^{4}}(2-\frac{1}{\mu_{c}}),\frac{-2i}{\mu_{c}^{2}}(2-\frac{1}{\mu_{c}^{2}})\right)e^{iK_{1}\cdot X}.$$

Finally we obtain

$$\alpha_0 = \frac{4}{\mu_c^5}$$

$$\beta_0 = -\frac{8}{\mu_c^5} + \frac{8}{\mu_c^4} + \frac{12}{\mu_c^3} - \frac{32}{\mu_c^2} - \frac{8}{\mu_c} + \frac{36}{\mu_c^2 (2 - \mu_c)}.$$

If  $\alpha_0 + \beta_0$  and  $\alpha_0 - \beta_0$  are both different from 0, we can solve the system (B.5) with respect to  $|A|^2$  and  $|B|^2$  and obtain a formal expansion in powers of  $(\tilde{\mu}, \omega)$  of the form

$$|A|^{2} = \frac{\tilde{\mu}}{-\mu_{c}^{2}(\alpha_{0} + \beta_{0})} + \frac{\omega \cdot (K_{1} - K_{2})}{\mu_{c}(\alpha_{0} - \beta_{0})} + O(|(\tilde{\mu}, \omega)|^{2}),$$
  

$$|B|^{2} = \frac{\tilde{\mu}}{-\mu_{c}^{2}(\alpha_{0} + \beta_{0})} - \frac{\omega \cdot (K_{1} - K_{2})}{\mu_{c}(\alpha_{0} - \beta_{0})} + O(|(\tilde{\mu}, \omega)|^{2}).$$

The indeterminacy on the phases of A and B means that we obtain in fact, for each fixed  $(\tilde{\mu}, \omega)$  leading to positive expressions for  $|A|^2$  and  $|B|^2$ , a torus of solutions, which is generated by acting the operator  $T_{\mathbf{v}}$  on a particular solution, for instance with A and B pure imaginary. This two-parameter family of tori of 3-dimensional waves connects with the 2-dimensional travelling waves respectively of wave vectors  $K_1$  and  $K_2$  (choosing  $\omega$  orthogonal to  $K_2$  or to  $K_1$ . If we choose  $\omega=0$  which means that we choose the direction of the waves as  $x_1$  axis, then we obtain the "diamond waves" as in [36], and [5], here without surface tension.

Let us study the sign of  $(\alpha_0 + \beta_0)$  and  $(\alpha_0 - \beta_0)$ . We have

$$\alpha_0 + \beta_0 = \frac{4}{\mu_c^2} \left( -\frac{1}{\mu_c^3} + \frac{2}{\mu_c^2} + \frac{3}{\mu_c} - 8 - 2\mu_c + \frac{9}{2 - \mu_c} \right)$$

$$\beta_0 - \alpha_0 = \frac{4}{\mu_c^2} \left( -\frac{3}{\mu_c^3} + \frac{2}{\mu_c^2} + \frac{3}{\mu_c} - 8 - 2\mu_c + \frac{9}{2 - \mu_c} \right),$$

where we notice that

$$\alpha_0 + \beta_0 = \frac{4}{\mu_c} \left\{ \left( \frac{1}{\mu_c^2} - \frac{2}{\mu_c} - 1 \right) \left( 2 - \frac{1}{\mu_c^2} \right) + \frac{1}{2\mu_c} + \frac{9}{2(2 - \mu_c)} \right\}$$

and it is easy to show (study of the factor as a function of  $1/\mu_c$ ) that  $\alpha_0 + \beta_0 > 0$  for  $\tau \in (0, \tau_c)$ , and  $\alpha_0 + \beta_0 < 0$  for  $\tau > \tau_c$  where  $\tau_c \in (\sqrt{6}, \sqrt{7})$ , i.e. more precisely  $\mu_{c,c} \sim 0.374$ . We also notice that the function of  $\mu_c$  in the factor for  $\beta_0 - \alpha_0$  is strictly increasing for  $\mu_c \in (0,1)$ , and cancels for  $\mu_c \sim 0.893$ . Now, defining new parameters  $\varepsilon_1$  and  $\varepsilon_2$  by

$$A = -\frac{i\varepsilon_1}{2}, B = -\frac{i\varepsilon_2}{2},$$

for a particular choice of a solution belonging to the torus, we get the results of Theorem 2.3.

### C Proof of Lemma 3.6

Let first consider the unique solution of the Cauchy problem (notice that  $\frac{V_2}{V_1} \in H^{m-1}_{o,o}(\mathbb{R}^2/\Gamma) \subset C^{m-3}_{o,o}(\mathbb{R}^2/\Gamma)$ , hence the vector field is Lipschitz for  $m \geq 4$ )

$$\frac{dX}{dx_1} = \frac{V_2}{V_1}(x_1, X), \quad X|_{x_1=0} = y,$$

which we denote by  $X(x_1, y) \in C^{m-3}$ . We can successively show that  $X(x_1, y)$  is even in  $x_1$ , odd in y, and such that

$$X(x_1, y) = X(x_1 + 2\pi, y) = X(x_1, y + \frac{2\pi}{\tau}) - \frac{2\pi}{\tau},$$

in using the uniqueness of the solution of the Cauchy problem, in looking for the system satisfied by  $X(-x_1,y), -X(x_1,-y), X(x_1,y+\frac{2\pi}{\tau})-\frac{2\pi}{\tau}$ , which is

the same as  $X(x_1, y)$ , and in comparing the systems satisfied by  $X(x_1 + \pi, y)$  and  $X(x_1 - \pi, y)$ , using the evenness in  $x_1$ . Notice that

$$\frac{\partial X}{\partial y}(x_1, y) = \exp\left(\int_0^{x_1} \partial_{x_2}(\frac{V_2}{V_1})(t, y)dt\right)$$

equals 1 for  $\frac{V_2}{V_1} = 0$ , i.e.if U = 0. Hence, for  $||U||_4$  small enough, we can solve (implicit function theorem) with respect to  $y = y(z_2)$  the equation

$$\Pi_1 X(\cdot, y) = z_2$$

where  $\Pi_1$  represents the average over a period in  $x_1$ . Then, we set

$$\mathcal{Z}(Z) = X(z_1, y(z_2))$$

and, thanks to  $\frac{V_2}{V_1}(x_1+\pi,x_2+\frac{\pi}{\tau})=\frac{V_2}{V_1}(x_1,x_2)$  we observe that the function

$$\mathcal{Z}(z_1+\pi,z_2+\frac{\pi}{\tau})-\frac{\pi}{\tau}$$

satisfies the same differential equation as  $\mathcal{Z}(z_1, z_2)$  with the same average in  $z_1$ , hence by uniqueness it is identical to  $\mathcal{Z}(z_1, z_2)$ . It is then clear that  $(z_1, z_2) \mapsto z_2 - \mathcal{Z}(Z) = \tilde{d}_1(Z)$  satisfies the properties indicated at Lemma 3.6 hence lies in  $C_{e,o}^{m-3}(\mathbb{R}^2/\Gamma)$ . The proof of the tame estimates for  $d_1$  and  $\tilde{d}_1$  is identical to the one made in Appendix G of [24]. Notice in addition, that replacing the initial condition at  $x_1 = 0$  by an average condition, allows to keep the equivariance under shifts  $\mathcal{T}_{\delta}$  parallel to  $x_1$  direction.

## D Proofs of Lemmas 3.7 and 3.8

Let us start with the expressions for U, given in (2.10)

$$U = \varepsilon \xi_0 + \varepsilon^2 U^{(2)} + O(\varepsilon^3),$$
  

$$\mu = \mu_c + \mu_1(\tau) \varepsilon^2 + O(\varepsilon^4),$$

with  $\xi_0 = (\psi_1, \eta_1)$  and  $\mu_1(\tau)$  given in (2.10) and (2.11), and where

$$U^{(2)} = \begin{cases} \frac{1-2\mu_c}{4\mu_c(2-\mu_c)} \sin 2x_1 - \frac{1}{4\mu_c^2} \sin 2x_1 \cos 2\tau x_2 \\ \frac{\mu_c^2 + 2\mu_c - 2}{4\mu_c^2(2-\mu_c)} \cos 2x_1 + \frac{\tau^2}{4\mu_c} \cos 2\tau x_2 + \frac{1}{4\mu_c^3} \cos 2x_1 \cos 2\tau x_2 \\ = (\psi_2, \eta_2). \end{cases}$$

We successively find from (3.1) and (3.4)

$$\begin{split} \mathfrak{b} &= \frac{\varepsilon}{\mu_c} \sin x_1 \cos \tau x_2 + \varepsilon^2 \mathfrak{b}^{(2)} + O(\varepsilon^3), \\ \mathfrak{b}^{(2)} &= \partial_{x_1} \eta_2 + \nabla \eta_1 \cdot \nabla \psi_1 \\ &= \left( \frac{1}{4\mu_c} + \frac{1}{2\mu_c^2} - \frac{1}{4\mu_c^3} - \frac{3}{4(2-\mu_c)} \right) \sin 2x_1 + \\ &- \frac{1}{4\mu_c^3} \sin 2x_1 \cos 2\tau x_2, \end{split}$$

$$\begin{split} V_1 &= 1 + \varepsilon \cos x_1 \cos \tau x_2 + \varepsilon^2 V_1^{(2)} + O(\varepsilon^3), \\ V_2 &= -\varepsilon \tau \sin x_1 \sin \tau x_2 + \varepsilon^2 V_2^{(2)} + O(\varepsilon^3), \end{split}$$

$$V_1^{(2)} = \partial_{x_1} \psi_2 - \mathfrak{b}^{(1)} \partial_{x_1} \eta_1,$$

$$V_1^{(2)} = -\frac{1}{4\mu_c^2} (1 + \cos 2\tau x_2 + \cos 2x_1 \cos 2\tau x_2) + \left(\frac{1}{4\mu_c} + \frac{1}{4\mu_c^2} - \frac{3}{4(2-\mu_c)}\right) \cos 2x_1,$$

$$V_2^{(2)} = \partial_{x_2} \psi_2 - \mathfrak{b}^{(1)} \partial_{x_2} \eta_1 = \frac{\tau}{4\mu_c^2} \sin 2x_1 \sin 2\tau x_2,$$

$$\mathfrak{a} = \mu_c + \frac{\varepsilon}{\mu_c} \cos x_1 \cos \tau x_2 + \varepsilon^2 \mathfrak{a}^{(2)} + O(\varepsilon^3),$$
  

$$\mathfrak{a}^{(2)} = \mu_1 + V^{(1)} \cdot \nabla \mathfrak{b}^{(1)} + \partial_{x_1} \mathfrak{b}^{(2)},$$

$$\mathfrak{a}^{(2)} = \mu_1 + \left(\frac{1}{\mu_c} + \frac{1}{\mu_c^2} - \frac{3}{4\mu_c^3} - \frac{3}{2(2-\mu_c)}\right)\cos 2x_1 + \frac{1}{4\mu_c^3}(1 - \cos 2x_1\cos 2\tau x_2) + \frac{2\mu_c^2 - 1}{4\mu_c^3}\cos 2\tau x_2,$$

$$\frac{\{V^2 + (V \cdot \nabla \eta)^2\}^{1/2}}{V_1^3} = 1 - 2\varepsilon \cos x_1 \cos \tau x_2 + \varepsilon^2 Y^{(2)} + O(\varepsilon^3)$$

$$Y^{(2)} = \frac{3}{4\mu_c^2} + \frac{5}{8} + \left(\frac{7}{8} - \frac{1}{2\mu_c} - \frac{3}{4\mu_c^2} + \frac{3}{2(2-\mu_c)}\right)\cos 2x_1 + \left(\frac{7}{8} + \frac{1}{2\mu_c^2}\right)\cos 2\tau x_2 + \left(\frac{5}{8} + \frac{1}{2\mu_c^2}\right)\cos 2x_1\cos 2\tau x_2.$$

For the determination of the function  $\mathcal{Z}(Z)=z_2-\widetilde{d_1}(Z)$  of Lemma 3.6, we have

$$\partial_{x_1'}\widetilde{d_1} = -\frac{V_2}{V_1}(x_1', x_2' - \widetilde{d_1}), \qquad \Pi_1\widetilde{d_1} = 0,$$

i.e.

$$\widetilde{d}_1 = \varepsilon \widetilde{d}_1^{(1)} + \varepsilon^2 \widetilde{d}_1^{(2)} + O(\varepsilon^3)$$

with

$$\partial_{z_1} \widetilde{d_1}^{(1)} = -V_2^{(1)}, \qquad \Pi_1 \widetilde{d_1}^{(1)} = 0,$$

$$\partial_{z_1}\widetilde{d_1}^{(2)} = V_1^{(1)}V_2^{(1)} - V_2^{(2)} + \partial_{x_2}V_2^{(1)}\widetilde{d_1}^{(1)}, \qquad \Pi_1\widetilde{d_1}^{(2)} = 0.$$

This leads to

$$\begin{array}{lcl} \widetilde{d_1}^{(1)} & = & -\tau \cos z_1 \sin \tau z_2, \\ \widetilde{d_1}^{(2)} & = & \frac{\tau}{4} \cos 2z_1 \sin 2\tau z_2, \end{array}$$

hence the diffeomorphism  $\mathcal{U}_1^{-1}$  takes the form

$$x_1 = z_1, \quad x_2 = z_2 + \varepsilon \tau \cos z_1 \sin \tau z_2 - \frac{\varepsilon^2 \tau}{4} \cos 2z_1 \sin 2\tau z_2 + O(\varepsilon^3).$$

Now we have

$$d_1 = \varepsilon d_1^{(1)} + \varepsilon^2 d_1^{(2)} + O(\varepsilon^3)$$

with

$$d_1^{(1)} = -\tau \cos x_1 \sin \tau x_2,$$
  

$$d_1^{(2)} = \frac{\tau}{4} \left\{ \tau^2 + (1 + \tau^2) \cos 2x_1 \right\} \sin 2\tau x_2,$$

and finally (3.32) gives

$$\mathfrak{q} = \mu_c (1 - \varepsilon \cos x_1 \cos \tau x_2 + \varepsilon^2 \mathfrak{q}^{(2)}) + O(\varepsilon^3),$$

with

$$\begin{split} \mathfrak{q}^{(2)} & = \frac{\mathfrak{a}^{(2)}}{\mu_c} + Y^{(2)} + \partial_{x_2} d_1^{(2)} - (2 + \tau^2 + \tau^4) \cos^2 x_1 \cos^2 \tau x_2 \\ & = \frac{\mu_1}{\mu_c} + \frac{1}{8} + \frac{1}{\mu_c^2} + \mathfrak{q}_{20}^{(2)} \cos 2x_1 + \mathfrak{q}_{02}^{(2)} \cos 2\tau x_2 + \\ & + \mathfrak{q}_{22}^{(2)} \cos 2x_1 \cos 2\tau x_2, \\ \mathfrak{q}_{20}^{(2)} & = \frac{3}{4(2 - \mu_c)} + \frac{3}{8} - \frac{5}{4\mu_c} + \frac{1}{2\mu_c^2} + \frac{1}{\mu_c^3} - \frac{1}{\mu_c^4}, \\ \mathfrak{q}_{02}^{(2)} & = \frac{7}{8} + \frac{1}{4\mu^2}, \quad \mathfrak{q}_{22}^{(2)} = \frac{1}{8} + \frac{1}{4\mu^2}. \end{split}$$

Now, we obtain

$$(\mathfrak{q} \circ \mathcal{U}_1^{-1})(Z) = \mu_0(1 - \varepsilon \cos z_1 \cos \tau z_2 + \varepsilon^2 \widetilde{\mathfrak{q}}^{(2)}) + O(\varepsilon^3)$$

with

$$\widetilde{\mathfrak{q}}^{(2)} = \frac{\mu_1}{\mu_c} - \frac{1}{8} + \frac{5}{4\mu_c^2} + (\mathfrak{q}_{20}^{(2)} + \frac{\tau^2}{4})\cos 2z_1 + \frac{9}{8}\cos 2\tau z_2 + \frac{3}{8}\cos 2z_1\cos 2\tau z_2,$$

and

$$\{(\mathfrak{q} \circ \mathcal{U}_{1}^{-1})(Z)\}^{1/2} = \mu_{c}^{1/2} \{1 - \frac{\varepsilon}{2} \cos z_{1} \cos \tau z_{2} + \varepsilon^{2} (\frac{\mu_{1}}{2\mu_{c}} - \frac{3}{32} + \frac{5}{8\mu_{c}^{2}}) + \varepsilon^{2} (\frac{\mathfrak{q}_{20}^{(2)}}{2} + \frac{\tau^{2}}{8} - \frac{1}{32}) \cos 2z_{1} + \varepsilon^{2} \frac{17}{32} \cos 2\tau z_{2} + \varepsilon^{2} \frac{5}{32} \cos 2z_{1} \cos 2\tau z_{2}\} + O(\varepsilon^{3}),$$

hence

$$\frac{1}{2\pi} \int_{-\pi}^{\pi} \{ (\mathfrak{q} \circ \mathcal{U}_{1}^{-1})(Z) \}^{1/2} dz_{1} = \mu_{c}^{1/2} \{ 1 + \varepsilon^{2} (\frac{\mu_{1}}{2\mu_{c}} - \frac{3}{32} + \frac{5}{8\mu_{c}^{2}}) + \varepsilon^{2} \frac{17}{32} \cos 2\tau z_{2} \} + O(\varepsilon^{3}).$$

Then with (3.34), we obtain

$$\nu = \mu_c^{-1} \{ 1 - \varepsilon^2 (\frac{\mu_1}{\mu_c} - \frac{3}{16} + \frac{5}{4\mu_c^2}) + O(\varepsilon^3) \},$$

as indicated in Lemma 3.7. Furthermore, in using (3.33), (3.31), we notice that

$$e_{2} = -\frac{17\varepsilon^{2}}{32\tau}\sin 2\tau z_{2} + O(\varepsilon^{3}),$$

$$d_{2} = -\frac{\varepsilon}{2}\sin z_{1}\cos \tau z_{2} + \varepsilon^{2}(d_{21}\sin 2z_{1} + d_{22}\sin 2z_{1}\cos 2\tau z_{2}) + O(\varepsilon^{3}),$$

$$d_{21} = \frac{1}{4}\left\{\frac{3}{4(2-\mu_{c})} + \frac{1}{16} - \frac{5}{4\mu_{c}} + \frac{3}{4\mu_{c}^{2}} + \frac{1}{\mu_{c}^{3}} - \frac{1}{\mu_{c}^{4}}\right\}, \quad d_{22} = \frac{5}{64}.$$

This, with (3.27), leads to the principal part of the bi-periodic functions occurring in the diffeomorphism of the torus of Theorem 3.4:

$$d(x,y) = -\frac{\varepsilon}{2}\sin x_1 \cos \tau x_2 + \varepsilon^2 \sin 2x_1 \{d_{21} - \frac{\tau^2}{8} + (d_{22} + \frac{\tau^2}{8})\cos 2\tau x_2\} + O(\varepsilon^3)$$

$$e(x,y) = -\varepsilon\tau \cos x_1 \sin \tau x_2 + \frac{\varepsilon^2}{4\tau} \sin 2\tau x_2 \left\{ \frac{1}{\mu_c^4} - \frac{2}{\mu_c^2} - \frac{9}{8} + \frac{\tau^2}{\mu_c^2} \cos 2x_1 \right\} + O(\varepsilon^3).$$

Inverting  $U_2 \circ U_1$ , and changing the coordinates in

$$\eta(X) = -\frac{\varepsilon}{\mu_c} \cos x_1 \cos \tau x_2 + \varepsilon^2 \left\{ \frac{\mu_c^2 + 2\mu_c - 2}{4\mu_c^2 (2 - \mu_c)} \cos 2x_1 + \frac{\tau^2}{4\mu_c} \cos 2\tau x_2 + \frac{1}{4\mu_c^3} \cos 2x_1 \cos 2\tau x_2 \right\} + O(\varepsilon^3)$$

leads to the results of Lemma 3.8.

# E Distribution of numbers $\{\omega_0 n^2\}$

Recall that for each  $x \in \mathbb{R}$ ,

$$[x] = \max\{N : N \in \mathbb{N}, N \le x\}, \{x\} = x - [x] \in [0, 1).$$

In this section we consider the distribution of the numbers

$$\theta_n = \{\omega_0 n^2 - C\}, \quad \sigma_n = \{\omega_0 n\}, \quad n \ge 1$$
 (E.1)

Due the famous Weil Theorem [43], for each polynomial  $f(x) = \alpha_k x^k + ... + \alpha_0$  with irrational  $\alpha_k$ , the numbers  $\{f(n)\}$  are uniformly distributed in [0, 1]. This means that for each  $[\alpha, \beta] \subset [0, 1]$ ,

card 
$$\{n : 0 \le n \le N, \{f(n)\} \in [\alpha, \beta]\} = N(\beta - \alpha) + o(N).$$

This result is the asymptotic relation in which the remainder strongly depends on the choice of the interval. We consider the simplest case

$$f(x) = \omega_0 x^2 - C$$
 with  $\{f(n)\} = \theta_n$ ,  $[\alpha, \beta] = [0, \rho]$ 

and deduce the rough, uniform in  $\rho$  estimate which is sufficient for our needs. The main result is the following .

### Proposition E.1 Suppose that

$$\frac{1}{|e^{2\pi i\omega_0 l}-1|} \leq c_1 l^2 \ \ \textit{for all positive integers} \quad l.$$

Then there is a constant c depending only on  $c_1$  such that

$$\frac{1}{N} \sum_{1 \le n \le N, \theta_n \in [0, \rho]} 1 \le c\rho \text{ for all } \rho \in (0, 1/4) \text{ and } N > \rho^{-78}.$$
 (E.2)

The proof is based on the following lemma.

**Lemma E.2** Under the assumptions of Proposition E.1, there exists positive c depending on  $c_1$  only such that

$$\frac{1}{N} \sum_{1 \le n \le N, \sigma_n \in [0, \varepsilon] \cup [1 - \varepsilon, 1]} 1 \le c\varepsilon \quad \text{for all} \quad \varepsilon \in (0, 1/4) \quad \text{and} \quad N > \varepsilon^{-9}. \tag{E.3}$$

**Proof.** Fix an arbitrary positive  $\varepsilon \in (0, 1/4)$  and introduce the function depending on parameter  $\varepsilon$  and given by the equalities

$$\varphi_{\varepsilon}(x) = 1 \quad \text{for} \quad x \in [0, \varepsilon] \cup [1 - \varepsilon, 1],$$

$$\varphi_{\varepsilon}(x) = 0 \quad \text{for} \quad x \in [2\varepsilon, 1 - 2\varepsilon],$$

$$\varphi_{\varepsilon}(x) = \frac{2\varepsilon - x}{\varepsilon} \quad \text{for} \quad x \in [\varepsilon, 2\varepsilon],$$

$$\varphi_{\varepsilon}(x) = \frac{x - 1 + 2\varepsilon}{\varepsilon} \quad \text{for} \quad x \in [1 - 2\varepsilon, 1 - \varepsilon].$$

We will assume that  $\varphi_{\varepsilon}$  is extended 1-periodically onto  $\mathbb{R}$ . Obviously the extended function is absolutely continuous and

$$\int_{0}^{1} \varphi_{\varepsilon}(x)dx = 3\varepsilon, \quad \int_{0}^{1} |\varphi'_{\varepsilon}(x)|^{2} dx = 2\varepsilon^{-1}.$$
 (E.4)

It has the representation

$$\varphi_{\varepsilon}(x) = \sum_{l=-\infty}^{\infty} \varphi_{\varepsilon,l} e^{2\pi i l x}, \quad \varphi_{\varepsilon,l} = \int_{0}^{1} e^{-2\pi i l x} \varphi_{\varepsilon}(x) dx.$$

It is clear that

$$|\varphi_{\varepsilon,l}| \le \int_{0}^{1} \varphi_{\varepsilon}(x)dx = 3\varepsilon.$$
 (E.5)

Obviously

$$\frac{1}{N} \sum_{1 \le n \le N, \sigma_n \in [0, \varepsilon] \cup [1 - \varepsilon, 1]} 1 \le \frac{1}{N} \sum_{1 \le n \le N} \varphi_{\varepsilon}(\sigma_n).$$
 (E.6)

Represent  $\varphi$  in the form

$$\varphi_{\varepsilon}(x) = \varphi_{\varepsilon,0} + \sum_{1 \le |l| \le k} \varphi_{\varepsilon,l} e^{2\pi i l x} + Q_k(x), \quad Q_k(x) = \sum_{k+1 \le |l|} \varphi_{\varepsilon,l} e^{2\pi i l x} \quad (E.7)$$

We have, by equality (E.4),

$$|Q_k(x)| \le 2 \sum_{k+1 \le l} |\varphi_{\varepsilon,l}| \le 2 \sqrt{\sum_{k+1 \le l} l^{-2}} \sqrt{\sum_{l} l^2 |\varphi_{\varepsilon,l}|^2} = \frac{1}{\pi} \sqrt{\sum_{k+1 \le l} l^{-2}} \sqrt{\int_{0}^{1} |\varphi_{\varepsilon}'(x)|^2 dx} \le c \frac{1}{\sqrt{k\varepsilon}}.$$
 (E.8)

Here c is some absolute constant. Combining (E.6)-(E.8) we obtain

$$\frac{1}{N} \sum_{1 \le n \le N, \sigma_n \in [0, \varepsilon] \cup [1 - \varepsilon, 1]} 1 \le 3\varepsilon + 6\varepsilon \sum_{1 \le l \le k} \frac{1}{N} \left| \sum_{1 \le n \le N} e^{2\pi i l \sigma_n} \right| + \frac{c}{\sqrt{k\varepsilon}}. \quad (E.9)$$

Since the numbers

$$e^{2\pi i l \sigma_n} = e^{2\pi i \omega_0 l n}$$

form a geometric progression, we have

$$\left| \sum_{1 \le n \le N} e^{2\pi i l \sigma_n} \right| \le \frac{2}{|e^{2\pi i \omega_0 l} - 1|} \le 2c_1 l^2.$$

Substituting this inequality into (E.9) we obtain

$$\frac{1}{N} \sum_{1 \le n \le N, \sigma_n \in [0, \varepsilon] \cup [1 - \varepsilon, 1]} 1 \le 3\varepsilon + c \frac{\varepsilon}{N} \sum_{1 \le l \le k} l^2 + \frac{c}{\sqrt{k\varepsilon}} \le 3\varepsilon + \frac{c\varepsilon k^3}{N} + \frac{c}{\sqrt{k\varepsilon}}.$$
 (E.10)

Now set

$$k = \left[\varepsilon^{-3/7} N^{2/7}\right]$$

and note that for  $N \geq \varepsilon^{-9}$ ,

$$\frac{1}{\sqrt{\varepsilon k}} \le \frac{\varepsilon}{(1 - \varepsilon^3)^{1/2}} \le c\varepsilon, \quad \frac{\varepsilon k^3}{N} \le \varepsilon,$$

which along with (E.10) yields

$$\frac{1}{N} \sum_{1 \leq n \leq N, \sigma_n \in [0,\varepsilon] \cup [1-\varepsilon,1]} 1 \leq c\varepsilon \ \text{ for } \ N \geq \varepsilon^{-9},$$

and the lemma E.2 follows.  $\blacksquare$ 

### **Proof of Proposition E.1**

The proof in main part imitates the proof of the Weil Theorem. Fix  $\rho \in (0, 1/4)$  and consider the function  $\varphi_{\rho}$  as defined above. Obviously

$$\frac{1}{N} \sum_{1 \le n \le N, \theta_n \in [0, \rho]} 1 \le \frac{1}{N} \sum_{1 \le n \le N} \varphi_{\rho}(\theta_n). \tag{E.11}$$

Combining (E.7)-(E.8) we obtain

$$\frac{1}{N} \sum_{1 \le n \le N, \theta_n \in [0, \rho]} 1 \le 3\rho + 6\rho \sum_{1 \le l \le k} \frac{1}{N} \left| \sum_{1 \le n \le N} e^{2\pi i l \theta_n} \right| + \frac{c}{\sqrt{k\rho}}.$$
 (E.12)

Next set

$$W_{l,N} = \left| \sum_{1 \le n \le N} e^{2\pi i l \theta_n} \right|. \tag{E.13}$$

We have from (E.12)

$$\frac{1}{N} \sum_{1 \le n \le N, \theta_n \in [0, \rho]} 1 \le 3\rho + 6\rho \sum_{1 \le l \le k} \frac{1}{N} W_{l, N} + \frac{c}{\sqrt{k\rho}}.$$
 (E.14)

Noting that

$$e^{2\pi i l\theta_n} = e^{2\pi i l(\omega_0 n^2 - C)}$$

we obtain

$$W_{l,N} = \left| \sum_{1 \le n \le N} e^{2\pi i \omega_0 l n^2} \right|. \tag{E.15}$$

Next we have

$$W_{l,N}^2 = \sum_{1 \leq m,n \leq N} e^{2\pi i g w_0 l(n^2 - m^2)}.$$

Setting r = m + n, q = n - m we arrive at

$$W_{l,N}^2 = \sum_{2 \le r \le N} \sum_{|q| \le r} e^{2\pi i \omega_0 lrq} + \sum_{N < r \le 2N} \sum_{|q| \le 2N - r} e^{2\pi i \omega_0 lrq}$$

Introduce the quantities

$$\chi_{rl} = \left| \sum_{|q| \le r} e^{2\pi i \omega_0 l r q} \right| \quad \text{for } 2 \le r \le N,$$

$$\chi_{rl} = \left| \sum_{|q| < 2N - r} e^{2\pi i \omega_0 l r q} \right| \quad \text{for } N < r \le 2N$$

Thus we get

$$W_{l,N}^2 = \sum_{2 \le r \le 2N} \chi_{rl} \tag{E.16}$$

Obviously

$$\chi_{rl} \le 2N. \tag{E.17}$$

On the other hand, since  $\chi_{rl}$  is a geometric progression in q,

$$\chi_{rl} \le \frac{1}{\sin(\pi\omega_0 rl)}.\tag{E.18}$$

Choose an arbitrary  $\varepsilon \in (0, 1/4)$  and denote by  $J_l$  the set of all r such that

$$2 \le r \le 2N$$
,  $\sigma_{rl} \equiv \{\omega_0 rl\} \in [0, \varepsilon] \cup [1 - \varepsilon, 1]$ .

It is easy to see that for  $r \in [2, N] \setminus J_l$ ,

$$\chi_{rl} \le \frac{1}{\sin(\pi\varepsilon)} \le \frac{c}{\varepsilon}.$$
(E.19)

From this and (E.16), (E.17) we conclude that

$$W_{l,N}^2 \le 2N \sum_{r \in J_l} 1 + c \frac{2N}{\varepsilon} \tag{E.20}$$

On the other hand for fixed  $l, r \in J_l$ , and p = rl we have  $\sigma_p = \{\omega_0 p\} \in [0, \varepsilon] \cup [1 - \varepsilon, 1]$ . Hence, since  $l \leq k$ ,

card 
$$J_l \leq \text{card } \{p : 1 \leq p \leq 2kN, \sigma_p \in [0, \varepsilon] \cup [1 - \varepsilon, 1] \}.$$

By lemma E.2, we have

$$\frac{1}{2kN} \operatorname{card} \left\{ p : 1 \le p \le 2kN, \sigma_p \in [0, \varepsilon] \cup [1 - \varepsilon, 1] \right\} \le c\varepsilon \text{ for } kN \ge \varepsilon^{-9},$$

which gives

$$\sum_{r \in J_l} 1 \le c2kN\varepsilon \text{ for } kN \ge \varepsilon^{-9}.$$

Substituting this inequality in (E.20) we obtain

$$W_{l,N}^2 \le ckN^2\varepsilon + c\frac{N}{\varepsilon}$$
 for  $kN > \varepsilon^{-9}$ ,

or

$$\frac{1}{N}W_{l,N} \le c\sqrt{k\varepsilon} + \frac{c}{\sqrt{N\varepsilon}} \text{ for } kN \ge \varepsilon^{-9}.$$

Substituting this result in (E.14) we finally obtain

$$\frac{1}{N} \sum_{1 < n < N, \theta_n \in [0, \rho]} 1 \le 3\rho + c\rho \sqrt{k^3 \varepsilon} + \frac{c\rho k}{\sqrt{N \varepsilon}} + \frac{c}{\sqrt{k \rho}} \text{ for } kN > \varepsilon^{-9}$$

It follows from this

$$\frac{1}{N} \sum_{1 \le n \le N, \theta_n \in [0, \rho]} 1 \le 3\rho + c\rho\sqrt{k^3\varepsilon} + c\rho k^{3/2}\varepsilon^4 + \frac{c}{\sqrt{k\rho}} \quad \text{for } kN > \varepsilon^{-9}. \quad (E.21)$$

Now choose

$$k = \left[\frac{1}{\rho^3}\right], \quad \varepsilon = k^{-3}, \quad N \ge k^{26}.$$

Obviously

$$k > \frac{1}{2\rho^3} \ge 32$$
,  $\varepsilon < 1/4$ ,  $Nk \ge \varepsilon^{-9}$ ,  $k^{3/2}\varepsilon^4 \le 1$ ,  $k^3\varepsilon = 1$ .

From this and (E.21) we conclude that

$$\frac{1}{N} \sum_{1 \le n \le N, \theta_n \in [0, \rho]} 1 \le c\rho \text{ for } N > \rho^{-78},$$

which completes the proof of the Proposition.

# F Pseudodifferential operators

In this section we collect basic facts from the theory of pseudodifferential operators. We refer to the pioneering paper [26] and monographs [42], [33] for general theory. Note only that different maps from functions A(Y, k) to operators  $\mathfrak{A} = A(Y, -i\partial_Y)$  give rise to different theories of pseudodifferential calculus. In these notes we assume that Y is a coordinate on the 2D-torus  $\mathbb{T}^2$  and that the dual variable k belongs to the lattice  $\mathbb{Z}^2$ . The first result constitutes the continuity properties of general pseudodifferential operators.

**Proposition F.1** Let  $|\mathfrak{A}|_{0,l}^r < \infty$  and  $0 \le s \le l-3$ ,  $r+s \ge 0$ . Then there is a constant c depending on s only so that for all  $u \in H^{s+r}(\mathbb{R}^2/\Gamma)$ ,

$$\|\mathfrak{A}u\|_{s} \le c\Big(|\mathfrak{A}|_{0,t}^{r}\|u\|_{r} + |\mathfrak{A}|_{0,3}^{r}\|u\|_{r+s}\Big).$$
 (F.1)

The proof is based on the following estimate of the convolution of non-negative sequences. Let us consider a non-negative sequences  $\mathbf{a}^j = (a^j(n))_{n \in \mathbb{Z}^2}$ ,  $1 \leq j \leq m$ , and  $\mathbf{v} = (v(n))_{n \in \mathbb{Z}^2}$ . Set

$$|\mathbf{a}^j|_s = \sup_{n \in \mathbb{Z}^2} (1 + |n|)^s a^j(n), \quad |||\mathbf{v}|||_s^2 = \sum_{n \in \mathbb{Z}^2} (1 + |n|)^{2s} v(n)^2.$$

**Lemma F.2** Under the above assumptions, the convolution  $\mathbf{w} = \mathbf{a}^1 * ... * \mathbf{a}^m * \mathbf{v}$  has the bound

$$|||\mathbf{w}|||_{s} \le c(s) \sum_{j} \left( \prod_{p \ne j} |\mathbf{a}^{p}|_{3} \right) |\mathbf{a}^{j}|_{s+3} ||\mathbf{v}||_{0} + \left( \prod_{j} |\mathbf{a}^{j}|_{3} \right) |||\mathbf{v}|||_{s}.$$
 (F.2)

**Proof.** We begin with proving (F.2) for m = 1. Recalling the formula

$$w(n) = \sum_{k_1 + \dots + k_{m+1} = n} a^1(k_1) \dots a^m(k_m) v(k_{m+1})$$

and noting that for  $k_1 + k_2 = n$ ,

$$(1+|n|)^s \le c(s)((1+|k_1|)^s + (1+|k_2|)^s)$$

we obtain for m = 1,

$$(1+|n|)^{s}w(n) \leq c(s)|\mathbf{a}^{1}|_{s+3} \sum_{k_{1}+k_{2}=n} (1+|k_{1}|)^{-3}v(k_{2}) + c(s)|\mathbf{a}^{1}|_{3} \sum_{k_{1}+k_{2}=n} (1+|k_{2}|)^{s}v(k_{2})(1+|k_{1}|)^{-3}.$$

From this and the classic inequality

$$\sum_{n} \left( \sum_{k_1 + k_2 = n} |a(k_1)v(k_2)| \right)^2 \le \left( \sum_{k} |a(k)| \right)^2 \sum_{k} |v(k)|^2.$$

we obtain (F.2) in the case m=1. The general case obviously follows from the mathematical induction principle and the distributive property of the convolution.  $\blacksquare$ 

Let us turn to the proof of Proposition F.1. We have

$$\widehat{\mathfrak{A}u}(n) = \frac{1}{2\pi} \sum_{k} \widehat{A}(n-k,k)\widehat{u}(k) \text{ where } \widehat{A}(p,k) = \frac{1}{2\pi} \int_{\mathbb{T}^2} A(Y,k)e^{-iYp} dY,$$

which yields

$$|\widehat{\mathfrak{A}u}(n)| \le c \sum_{k} |\widehat{A}(n-k,k)| |\widehat{u}(k)| \le [\mathbf{a} * \mathbf{v}](n), \tag{F.3}$$

with

$$a(n) = \sup_{k \in \mathbb{Z}^2} (1 + |k|)^{-r} |\widehat{A}(n, k)| \quad v(k) = (1 + |k|)^r |\widehat{u}(k)|.$$

It is easy to see that

$$|\mathbf{a}|_{s} \le c|\mathfrak{A}|_{0,s}^{r}, \quad |||\mathbf{v}|||_{s} \le c||u||_{s+r}.$$
 (F.4)

Applying Lemma F.2 to (F.3), using inequalities (F.4) and noting that

$$\left(\|\mathfrak{A}u\|_{s}\right)^{2} \le c \sum_{n} (1+|n|)^{2s} |\widehat{\mathfrak{A}u}|^{2}$$

we obtain (F.1), and the proposition follows.

The next proposition gives the representation for the composition and commutators of pseudodifferential operators

**Proposition F.3** Let  $\mathfrak{A}$  and  $\mathfrak{B}$  be pseudodifferential operators so that for some  $r, \rho \in \mathbb{R}^1$  and non-negative integers m, l,

$$|\mathfrak{A}|_{m,l}^r + |\mathfrak{B}|_{m,l}^{\rho} < \infty.$$

Let also

$$l > |r| + 5 + s$$
,  $l > s + 3$ ,  $m \ge 2$ .

Then the composition  $\mathfrak{AB}$  and the commutator  $\mathfrak{AB}-\mathfrak{BA}$  have the representations

$$\mathfrak{AB} = \sum_{p=0}^{d} (\mathfrak{AB})_p + \mathfrak{D}_{d+1}^{(AB)}, \quad d = 0, 1,$$
 (F.5)

$$\mathfrak{AB} - \mathfrak{BA} = \sum_{p=1}^{d} [\mathfrak{A}, \mathfrak{B}]_p + \mathfrak{D}_{d+1}^{[A,B]}, \quad d = 0, 1,$$
 (F.6)

in which  $(\mathfrak{AB})_p$  and  $[\mathfrak{A},\mathfrak{B}]_p$  are the pseudodifferential operators with symbols

$$(AB)_{0}(Y,k) = A(Y,k)B(Y,k), \quad (AB)_{1}(Y,k) = \frac{1}{i}\partial_{k}A(Y,k)\partial_{Y}B(Y,k), \quad (F.7)$$

$$[A,B]_{0}(Y,k) = 0, \quad [A,B]_{1}(Y,k) = \frac{1}{i}\left(\partial_{k}A(Y,k)\partial_{Y}B(Y,k) - \partial_{Y}A(Y,k)\partial_{k}B(Y,k)\right)$$

$$(F.8)$$

for 
$$k \neq 0$$
, and  $(AB)_p(Y,0) = [A, B]_p(Y,0) = 0$ .

The reminders have the estimates

$$\begin{split} \|\mathfrak{D}_{d+1}^{(AB)}u\|_{s} &\leq c \Big( |\mathfrak{A}|_{d+1,s}^{r}|\mathfrak{B}|_{d+1,|r|+d+4}^{\rho} + |\mathfrak{A}|_{d+1,3}^{r}|\mathfrak{B}|_{d+1,|r|+d+4+s}^{\rho} \Big) \|u\|_{r+\rho-d-1} + \\ & |\mathfrak{A}|_{d+1,3}^{r}|\mathfrak{B}|_{d+1,|r|+d+4}^{\rho} \|u\|_{s+r+\rho-d-1}, \end{split} \tag{F.9} \\ & \|\mathfrak{D}_{d+1}^{[A,B]}u\|_{s} \leq c \Big( |\mathfrak{A}|_{d+1,s+|\rho|+d+4}^{r}|\mathfrak{B}|_{d+1,|r|+d+4}^{\rho} + \\ & |\mathfrak{A}|_{d+1,|\rho|+d+4}^{r}|1 - \mathfrak{B}|_{d+1,|r|+d+4+s}^{\rho} \Big) \|u\|_{r+\rho-d-1} + \\ & |\mathfrak{A}|_{d+1,|\rho|+d+4}^{r}|1 - \mathfrak{B}|_{d+1,|r|+d+4}^{\rho} \|u\|_{s+r+\rho-d-1}, \end{aligned} \tag{F.10}$$

in which the constant c depends on  $s, r, \rho$  only.

The proof is based on the following lemma

### Lemma F.4 Let

$$\mathcal{R}_{d+1}(\eta,\zeta,k) = \widehat{A}(\eta,\zeta+k) - \sum_{p=0}^{d} \sum_{|\alpha|=p} \frac{1}{\alpha!(i)^{|\alpha|}} \partial_k^{\alpha} \widehat{A}(\eta,k) (i\zeta)^{\alpha} \quad for \quad k \neq 0,$$
(F.11)

and  $\mathcal{R}_{d+1}(\eta,\zeta,0) = \widehat{A}(\eta,\zeta)$ , where

$$\widehat{A}(\eta, k) = \frac{1}{2\pi} \int_{\mathbb{T}^2} e^{-i\eta Y} A(Y, k) dY.$$

Then for all  $\eta, \zeta, k \in \mathbb{Z}^2$  and  $0 \le s \le l$ ,

$$|\mathcal{R}_{d+1}(\eta,\zeta,k)| \le c(d,r)|A|_{d+1,l}^r(1+|\eta|)^{-l}(1+|\zeta|)^{|r|+d+1}(1+|k|)^{r-d-1}.$$
 (F.12)

**Proof.** It suffices to prove (4.32) for  $k \neq 0$  only. If  $|\zeta| \leq |k|/2$ , then the Taylor formula

$$\mathcal{R}_{d+1}(\eta,\zeta,k) = \sum_{|\alpha|=d+1} \frac{d+1}{\alpha!} \left\{ \int_{0}^{1} [\partial_{k}^{\alpha} \widehat{A}](\eta,k+t\zeta)(1-t)^{d} dt \right\} \zeta^{\alpha}$$

implies the estimate

$$|\mathcal{R}_{d+1}(\eta,\zeta,k)| \le c|\mathfrak{A}|_{d+1,s}^{r}(1+|\eta|)^{-s}(1+|\zeta|)^{d+1} \int_{0}^{1} (1+|k+t\zeta|)^{r-d-1} dt \le c|\mathfrak{A}|_{d+1,s}^{r}(1+|\eta|)^{-s}(1+|\zeta|)^{d+1}(1+|k|)^{r-d-1},$$
 (F.13)

which obviously yields (4.32). If  $|\zeta| \geq |k|/2$ , we have

$$|\mathcal{R}_{d+1}(\zeta,k)| \le c|\mathfrak{A}|_{d+1,s}^{r}(1+|\eta|)^{-s} \Big[ |k+\zeta|^{r} + \sum_{0}^{d} (1+|\zeta|)^{p} |k|^{r-p} \Big]$$

$$\le c|\mathfrak{A}|_{d+1,s}^{r}(1+|\eta|)^{-s} \Big[ |\zeta|^{r} + \sum_{0}^{d} (1+|\zeta|)^{p} |k|^{r-p} \Big].$$

Noting that for  $0 \le p \le d+1$  and  $|\zeta| \ge |k|/2$ ,

$$(1+|\zeta|)^p |k|^{r-p} \le c(1+|\zeta|)^{d+1} (1+|k|)^{r-d-1}$$

we obtain

$$|\mathcal{R}_{d+1}(\zeta,k)| \le c(s)|\mathfrak{A}|_{d+1}^r (1+|\eta|)^{-s} (1+|\zeta|)^{|r|+d+1} (1+|k|)^{r-d-1}$$

and the lemma follows.  $\blacksquare$ 

Let us turn to the proof of the proposition. Since  $[\mathfrak{A},\mathfrak{B}] = -[\mathfrak{A},(1-\mathfrak{B})]$ , it suffices to prove (4.33) only. To this end note that, by the definition of pseudodifferential operator,

$$\widehat{\mathfrak{AB}u}(n) = \sum_{p,k} \widehat{A}(n-p,p) \widehat{B}(p-k,k) \widehat{u}(k) = \sum_{\zeta,k} \widehat{A}(n-k-\zeta,k+\zeta) \widehat{B}(\zeta,k) \widehat{u}(k).$$

Applying Lemma F.4 to the Fourier transform  $\widehat{A}(\eta, k)$  of the symbol A we arrive at the identity

$$\sum_{\substack{k,\zeta\in\mathbb{Z}^2\\k\neq 0}}\sum_{p=0}^{d}\sum_{|\alpha|=p}\frac{1}{\alpha!(i)^{|\alpha|}}[\partial_k^{\alpha}\widehat{A}](n-k-\zeta,k)\Big[(i\zeta)^{\alpha}\widehat{B}(\zeta,k)\Big]\widehat{u}(k)+$$

$$+\sum_{\substack{k,\zeta\in\mathbb{Z}^2\\k,\zeta\in\mathbb{Z}^2}}\mathcal{R}_{d+1}(n-k-\zeta,\zeta,k)\widehat{B}(\zeta,k)\widehat{u}(k)=\widehat{\mathfrak{AB}}u(n).$$

Noting that  $(i\zeta)^{\alpha}\widehat{B}(\zeta,k) = \widehat{\partial_{Y}^{\alpha}B}(\zeta,k)$ , we obtain

$$\sum_{\substack{k,\zeta\in\mathbb{Z}^2\\k\neq0}}\sum_{|\alpha|=p}\frac{1}{\alpha!(i)^{|\alpha|}}[\partial_k^{\alpha}\widehat{A}](n-k-\zeta)\Big[(i\zeta)^{\alpha}\widehat{B}(\zeta,k)\Big]\widehat{u}(k)=\widehat{(\mathfrak{AB})_p}u(n),$$

which leads to representation (4.33) with the remainder

$$\widehat{\mathfrak{D}_{m+1}^{(AB)}}u(n) = \sum_{k,\zeta \in \mathbb{Z}^2} \mathcal{R}_{d+1}(n-k-\zeta,\zeta,k)\widehat{B}(\zeta,k)\widehat{u}(k).$$

In particular, we have the inequality

$$|\widehat{\mathfrak{D}_{m+1}^{(\widehat{AB})}}u| \le \mathbf{a} * \mathbf{b} * \mathbf{v},\tag{F.14}$$

in which the elements of the sequences a, b, v are given by

$$a(n) = \sup_{\zeta,k} (1+|\zeta|)^{-|r|-d-1} (1+|k|)^{-r+d+1} |\mathcal{R}_{d+1}(n,\zeta,k)|,$$
  
$$b(\zeta) = (1+|\zeta|)^{|r|+d+1} \sup_{k} (1+|k|)^{-\rho} |\widehat{B}(\zeta,k)|, v(k) = (1+|k|)^{r+\rho-d-1} |\widehat{u}(k)|.$$

Applying Lemma F.2 to the right side of (F.14) and noting that by Lemma F.4

$$|\mathbf{a}|_{s} \le |\mathfrak{A}|_{d+1,s}^{r}, \quad |\mathbf{b}|_{s} \le |\mathfrak{B}|_{0,s+|r|+d+1}^{\rho}, \quad |||\mathbf{v}|||_{s} \le c||u||_{\rho+r-d-1+s}$$

we obtain (4.41) and the proposition follows.

It is useful to reformulate the above results in terms of infinite matrices. To this end we introduce the Hilbert space  $\mathbf{F}_{s,t}$  which consists of all operators  $\mathcal{Y}: H^s(\mathbb{R}^2/\Gamma) \mapsto H^t(\mathbb{R}^2/\Gamma)$  having the representation

$$\widehat{\mathcal{Y}u}(k) = \sum_{p \in \mathbb{Z}^2} \mathcal{Y}_{kp} \widehat{u}(p)$$

such that

$$\|\mathcal{Y}\|_{\mathbf{F}_{s,t}}^{2} := \sup \left\{ \sum_{k} (1+|k|)^{2t} \left( \sum_{p} |\mathcal{Y}_{kp}| |\widehat{u}(p)| \right)^{2} : \sum_{k} (1+|k|)^{2s} |\widehat{u}(k)|^{2} \right\} < \infty.$$
(F.15)

**Corollary F.5** (i) Under the assumptions of Proposition F.1, operator  $\mathfrak{A}$  has a matrix representation with  $\mathfrak{A}_{kp} = \widehat{A}(k-p,p)$  and

$$\sum_{k} (1+|k|)^{2s} \Big( \sum_{p} |\mathfrak{A}_{kp}| |\widehat{u}(p)| \Big)^{2} \le c(|\mathfrak{A}|_{0,l}^{r})^{2} \sum_{k} (1+|k|)^{2r} |\widehat{u}(k)|^{2} + c(|\mathfrak{A}|_{0,3}^{r})^{2} \sum_{k} (1+|k|)^{2r+2s} |\widehat{u}(k)|^{2}.$$

In particular,  $\|\mathfrak{A}\|_{\mathbf{F}_{r+s,s}} \leq c |\mathfrak{A}|_{0,l}^r$ .

(ii) Under the assumptions of Proposition F.3, the operator  $\mathfrak{D}_{d+1}^{(AB)}$  has a matrix representation so that

$$\sum_{k} (1+|k|)^{2(s)} \left( \sum_{p} |\mathfrak{D}_{d+1,kp}^{(AB)}||\widehat{u}(p)| \right)^{2} \leq c \left( |\mathfrak{A}|_{d+1,s}^{r}|\mathfrak{B}|_{d+1,|r|+d+4}^{\rho} + |\mathfrak{A}|_{d+1,3}^{r}|\mathfrak{B}|_{d+1,|r|+d+4+s}^{\rho} \right)^{2} \sum_{k} (1+|k|)^{2r+2\rho-2d-2} |\widehat{u}(k)|^{2} + c(|\mathfrak{A}|_{d+1,3}^{r}|\mathfrak{B}|_{d+1,|r|+d+4}^{\rho})^{2} \sum_{k} (1+|k|)^{2s+2r+2\rho-2d-2} |\widehat{u}(k)|^{2} \tag{F.16}$$

In particular,

$$\|\mathfrak{D}_{d+1}^{(AB)}\|_{\mathbf{F}_{r+s+\rho-d-1,s}} \le c \Big( |\mathfrak{A}|_{d+1,s}^r |\mathfrak{B}|_{d+1,|r|+d+4}^\rho + |\mathfrak{A}|_{d+1,3}^r |\mathfrak{B}|_{d+1,|r|+d+4+s}^\rho \Big)$$

**Proof.** Assertion (i) is integral part of the proof of Proposition F.1. In order to prove (ii) note that

$$\mathfrak{D}_{d+1,kp}^{(AB)} = \sum_{\zeta \in \mathbb{Z}^2} \mathcal{R}_{d+1}(p-k-\zeta,\zeta,k) \widehat{B}(\zeta,k),$$

where  $\mathcal{R}_{d+1}$  is defined by formula (F.11). The needed result follows from (F.14) and Lemma F.2.  $\blacksquare$ 

### **Proof of Proposition** 5.4

We give the proof of representations (5.15) and (5.16) only, and begin with proving (5.15). Note that

$$A(Y,\xi) \equiv A_r(Y,\xi_1,\xi_2^2) + i\xi_2 A_i(Y,\xi_1,\xi_2^2),$$

where

$$A_r(\cdot,\cdot,\rho) = \frac{1}{2} \Big( A(\cdot,\cdot,\sqrt{\rho}) + A(\cdot,\cdot,-\sqrt{\rho}) \Big), A_i(\cdot,\cdot,\rho) = \frac{1}{2i\sqrt{\rho}} \Big( A(\cdot,\cdot,\sqrt{\rho}) - A(\cdot,\cdot,-\sqrt{\rho}) \Big).$$

Assuming  $k_1 \neq 0$  and noting that in this case  $\xi_2^2 = 1 - \xi_1^2$ , we arrive at the identity

$$A(Y,\xi) \equiv \mathcal{A}_r(Y,\xi_1) + i\xi_2\mathcal{A}_i(Y,\xi_1) \equiv \mathcal{A}(Y,\xi) \quad \text{where} \quad \mathcal{A}_\beta(Y,\xi_1) = A_\beta(Y,\xi_1,1-\xi_1^2).$$

From the Taylor formula we conclude that for  $k_1 \neq 0$ ,

$$\mathcal{A}(Y,\xi) = \sum_{j=0}^{j=2} \frac{1}{(i)^{j} j!} \left[ \partial_{\xi_{1}}^{j} \mathcal{A} \right] (Y,0,\xi_{2}) (i\xi_{1})^{j} + (\xi_{1})^{3} \mathcal{R}_{3}(Y,\xi)$$

$$\mathcal{R}_{3}(Y,\xi) = \frac{1}{6} \int_{0}^{1} [\partial_{\xi_{1}}^{3} \mathcal{A}] (Y,s\xi_{1},\xi_{2}) (1-s)^{3} ds.$$
(F.17)

Recalling symmetry property (5.2) we obtain

$$\begin{aligned} \left. \mathcal{A}_{r} + i\xi_{2}\mathcal{A}_{i} \right|_{\xi_{1}=0} &= \left[ \operatorname{Re} A + i\xi_{2}\operatorname{Im} A \right](Y,0,1) = A_{0}(Y,\xi_{2}), \\ \left. \partial_{\xi_{1}}(\mathcal{A}_{r} + i\xi_{2}\mathcal{A}_{i}) \right|_{\xi_{1}=0} &= i \left[ \partial_{\xi_{1}}(\operatorname{Im} A - i\xi_{2}\operatorname{Re} A) \right](Y,0,1) = -\nu A_{1}(Y,\xi_{2}) \\ \left. \partial_{\xi_{1}}^{2}(\mathcal{A}_{r} + i\xi_{2}\mathcal{A}_{i}) \right|_{\xi_{1}=0} &= \left[ (\partial_{\xi_{1}}^{2} - \partial_{\xi_{2}})(\operatorname{Re} A + i\xi_{2}\operatorname{Im} A) + i\xi_{2}\operatorname{Im} A \right](Y,0,1) = -2\nu^{2}A_{2}(Y,\xi_{2}), \end{aligned}$$

which being substituted into (F.17) leads to

$$A(Y,\xi) = A_0(Y,\xi_2) - \nu A_1(Y,\xi_2)i\xi_1 + \nu^2 A_2(Y,\xi_2)(i\xi_1)^2 + \mathcal{R}_3(Y,\xi)\xi_1^3. \quad (F.18)$$

Noting that

$$ik_{1}i\xi_{1} = -\frac{1}{\nu} + \frac{1}{\nu|\mathbb{T}^{-1}(k)|}L(k),$$

$$ik_{1}(i\xi_{1})^{2} = \left(\frac{1}{\nu}\right)^{2} \frac{1}{ik_{1}} - \left(\frac{1}{\nu}\right)^{2} \frac{1}{ik_{1}|\mathbb{T}^{-1}(k)|^{2}} \left(\nu k_{1}^{2} + |\mathbb{T}^{-1}(k)|\right)L(k), \qquad (F.19)$$

$$ik_{1}(\xi_{1})^{3} = \frac{i}{\nu^{2}|\mathbb{T}^{-1}(k)|} - \frac{i}{\nu^{2}|\mathbb{T}^{-1}(k)|^{3}} (\nu k_{1}^{2} + |\mathbb{T}^{-1}(k)|)L(k),$$

we get for  $k_1 \neq 0$ ,

$$ik_1 A(Y,\xi) = \sum_{j=0}^{2} A_j(Y,\xi_2)(ik_1)^{1-j} + P_A(Y,\xi)L(k) + Q_A(Y,\xi).$$
 (F.20)

Here the remainders are given by

$$P_{A}(Y,k) = \frac{1}{|\mathbb{T}^{-1}(k)|} A_{1}(Y,\xi_{2}) + \frac{i}{k_{1}|\mathbb{T}^{-1}(k)|^{2}} \Big( A_{2}(Y,\xi_{2}) - (F.21) \Big) \frac{k_{1}}{\nu^{2}|\mathbb{T}^{-1}(k)|} \mathcal{R}_{3}(Y,\xi) \Big) \Big( \nu k_{1}^{2} + |\mathbb{T}^{-1}(k)| \Big), \quad Q_{A}(Y,k) = \frac{i}{\nu^{2}|\mathbb{T}^{-1}(k)|} \mathcal{R}_{3}(Y,\xi).$$

Next set  $P_A(Y,k) = Q_A(Y,k) = 0$  for  $k_1 = 0$  and denote by  $\mathfrak{P}_A$ ,  $\mathfrak{Q}_A$  the pseudodifferential operators with the symbols  $P_A$ ,  $Q_A$ . With this notation, decomposition (5.15) easy follows from (F.20). It remains to note that formulae (F.17) and (F.21) imply the estimate

$$|\mathfrak{P}_A|_{0,l}^{-1} + |\mathfrak{Q}_A|_{0,l}^{-1} \le |\mathfrak{A}|_{3,l},$$

which along with Proposition F.1 yields inequalities (5.20) for  $\mathfrak{P}_A$  and  $\mathfrak{Q}_A$ .

Let us turn to the proof of (5.16). We begin with the observation that for  $k_1 \neq 0$ , the product of the symbols of the elementary operators  $\mathfrak{A}_j$  and  $\mathfrak{W}$  is equal to

$$A_i W \equiv S_i' + \xi_1^2 \text{Im } \tilde{A}_i \text{Im } \tilde{W}, \tag{F.22}$$

where  $S'_j$  are the symbols of the elementary operators associated with the functions  $\tilde{A}_j\tilde{W}$ . Multiplying both sides of (F.20) by  $W(Y,\xi_2)$  and using the identities

$$ik_1\xi_1^2 = -\left(\frac{1}{\nu}\right)^2 \frac{1}{ik_1} + \left(\frac{1}{\nu}\right)^2 \frac{1}{|\mathbb{T}^{-1}(k)|ik_1} \left(\nu k_1^2 + |\mathbb{T}^{-1}(k)|\right) L(k),$$
$$\xi_1^2 = \frac{1}{\nu} \frac{1}{|\mathbb{T}^{-1}(k)|} - \frac{1}{\nu} \frac{1}{|\mathbb{T}^{-1}(k)|^2} L(k)$$

we arrive at

$$ik_1S(Y,k) = \sum_{j=0}^{2} (ik_1)^{1-j} S'_j(Y,\xi_2) - \left(\frac{1}{\nu}\right)^2 \operatorname{Im} \tilde{A}_0 \operatorname{Im} \tilde{W} \frac{1}{ik_1} + L(k)U_S(Y,k) + V_S(Y,k),$$

where the symbols  $U_S(Y,k)$  and  $V_S(Y,k)$  are defined by

$$U_{S} = P_{A}W + \left(\frac{1}{\nu}\right)^{2} \frac{1}{|\mathbb{T}^{-1}(k)|ik_{1}} \left(\nu k_{1}^{2} + |\mathbb{T}^{-1}(k)|\right) \operatorname{Im} \tilde{A}_{0} \operatorname{Im} \tilde{W} - \frac{1}{\nu|\mathbb{T}^{-1}(k)|^{2}} \left(\operatorname{Im} \tilde{A}_{1} + (ik_{1})^{-1} \operatorname{Im} \tilde{A}_{2}\right) \operatorname{Im} \tilde{W},$$

$$V_{S} = Q_{A}W + \frac{1}{\nu|\mathbb{T}^{-1}(k)|} \left(\operatorname{Im} \tilde{A}_{1} + (ik_{1})^{-1} \operatorname{Im} \tilde{A}_{2}\right) \operatorname{Im} \tilde{W}.$$

Recall that  $\tilde{W}$  and  $\tilde{A}$  are smooth function on tori  $\mathbb{T}^2$  which do not depend on k. Setting  $U_S(Y,k)=V_S(Y,k)=0$  for  $k_1=0$ , denoting by  $\mathfrak{U}_S$  and  $\mathfrak{V}_S$  the pseudodifferential operators with the symbols  $U_S$ ,  $V_S$  and arguing as before we obtain desired identity (5.16). It remains to note that estimate (5.21) follows from Proposition (F.1) which completes the proof.

## G Dirichlet-Neuman operator

In this section we deduce the basic decomposition for the Dirichlet-Neumann operator and prove Theorem 3.5. Let us denote the change of coordinates by

$$x = x(y), \quad x = (X, x_3), \quad y = (Y, y_3),$$
  
 $X = X(Y), \quad x_3 = y_3 + \tilde{\eta}(Y),$  (G.1)

where

$$\tilde{\eta}(Y) = \eta(X(Y)),$$

and  $X(\cdot)$  is a diffeomorphism of the torus of the form (3.8) satisfying the Condition 3.2. Let us notice that with the new coordinate  $Y=(y_1,y_2)$  the lattice  $\Gamma'$  is generated by the two wave vectors  $(1,\pm 1)$ . We still denote the lattice of periods by  $\Gamma$ . For a function u(x) we define  $\widetilde{u}(y)$  by  $\widetilde{u}(y)=u(x(y))$ . The Jacobian matrix of the above diffeomorphism reads

$$\mathbb{B}_1(Y) = \begin{pmatrix} \partial_{y_1} X_1 & \partial_{y_2} X_1 & 0 \\ \partial_{y_1} X_2 & \partial_{y_2} X_2 & 0 \\ \partial_{y_1} \tilde{\eta} & \partial_{y_2} \tilde{\eta} & 1 \end{pmatrix}$$

and the determinant satisfies  $J = \det \mathbb{B}(Y) = \det \mathbb{B}_1(Y)$ . Now, we use the following identities for any scalar function u, and vector function V:

$$\nabla_x u(x(y)) = (\mathbb{B}_1^*)^{-1} \nabla_y \widetilde{u}(y),$$

$$\nabla_x \cdot V(x(y)) = \frac{1}{J} \nabla_y \cdot (J \mathbb{B}_1^{-1} \widetilde{V}(y)).$$

With these identities, the Dirichlet-Neumann operator (1.4) takes the new following form

$$\mathcal{A}\tilde{\varphi} = 0, \quad y_3 \in (-\infty, 0),$$

$$\tilde{\varphi}|_{y_3=0} = \tilde{\psi}(Y),$$

$$\nabla \tilde{\varphi} \to 0 \text{ as } y_3 \to -\infty,$$

$$\mathcal{G}_{\eta}\psi = \frac{1}{I}(\mathbb{A}(Y)\nabla_y \tilde{\varphi}).\mathbf{e}_3,$$
(G.2)

where

$$\begin{array}{rcl} \mathcal{A}\tilde{\varphi} & = & \nabla_y \cdot (\mathbb{A}(Y)\nabla_y \tilde{\varphi}), \\ \mathbb{A} & = & J(\mathbb{B}_1^* \mathbb{B}_1)^{-1} \ \ \text{(symmetric matrix)} \\ \det \mathbb{A} & = & J. \end{array}$$

Notice that for computing the new expression of  $\mathcal{G}_{\eta}\psi$ , we used the fact that  $\Phi(x) = x_3 - \eta(X)$  is such that  $\widetilde{\Phi}(y) = y_3$ , hence  $\nabla_x \Phi = (\mathbb{B}_1^*)^{-1} \mathbf{e}_3$ .

We already defined the 2x2 matrix  $\mathbb{G}(Y)$  of the first fundamental form of the free surface, and we have

$$\mathbb{B}_1^* \mathbb{B}_1(Y) = \left( \begin{array}{ccc} g_{11} & g_{12} & \partial_{y_1} \widetilde{\eta} \\ g_{12} & g_{22} & \partial_{y_2} \widetilde{\eta} \\ \partial_{y_1} \widetilde{\eta} & \partial_{y_2} \widetilde{\eta} & 1 \end{array} \right).$$

We assume that elements of the matrix  $\mathbb{A}(Y)$  are smooth  $2\pi$ -periodic functions, and for some  $\rho$  and l, satisfying the following inequalities for  $9 \leq \rho \leq l$ ,

$$\|\mathbb{A}_0 - \mathbb{A}\|_{C^{\rho}} \le c\varepsilon$$
,  $\|\mathbb{A}\|_{C^l} \le E_l$ , where  $\mathbb{A}_0 = \tau^{-1} \operatorname{diag} \{1, \tau^2, 1\}$ , (G.3)

where, by construction, the estimates of  $\mathbb{A}$  and  $\mathbb{A}_0 - \mathbb{A}$  would come from

$$||\widetilde{\eta}||_{C^{\rho+1}} + ||\widetilde{\mathcal{V}}(\cdot)||_{C^{\rho+1}} \leq c\varepsilon,$$

$$||\widetilde{\eta}||_{C^{s+1}} + ||\widetilde{\mathcal{V}}(\cdot)||_{C^{s+1}} \leq c(l), \quad s \leq l,$$
(G.4)

where  $\widetilde{\mathcal{V}}$  is defined in (3.8). By the factorization theorem, there are first order pseudodifferential operators  $\mathcal{G}^{\pm}$  so that

$$\mathcal{A} = a_{33}(\partial_{y_3} + \mathcal{G}^+)(\partial_{y_3} + \mathcal{G}^-),$$

$$e^{-ik \cdot Y} \mathcal{G}^{\pm} e^{ik \cdot Y} \to \pm \infty \text{ as } |k| \to \infty.$$
(G.5)

It follows from (G.2) that

$$\mathcal{G}_{\eta}\psi = \frac{1}{J} \left( \sum_{i=1}^{2} a_{3j} \partial_{y_{j}} - a_{33} \mathcal{G}^{-} \right) \widetilde{\psi}. \tag{G.6}$$

Hence the task now is to split  $\mathcal{G}^-$  into a sum of first and zero order pseudodifferential operators. The corresponding result is given by the following

**Theorem G.1** Under the above assumptions there is  $\varepsilon_0$  depending on  $\rho$  and l only such that for all  $\varepsilon \in (0, \varepsilon_0)$ , the operator  $\mathcal{G}^-$  has the representation

$$\mathcal{G}^{-} = \mathcal{G}_{1}^{-} + \mathcal{G}_{0}^{-} + \mathcal{G}_{-1}^{-}, \tag{G.7}$$

in which the pseudodifferential operators  $\mathcal{G}_0^-, \mathcal{G}_1^-$ , have the symbols  $G_0^-$  and  $G_1^-$  defined by

$$G_0^- = \frac{a_{33}}{2D} \left( i \nabla_k G_1^+ \nabla_Y G_1^- - 2bG_1^- + C_1 \right), \tag{G.8}$$

$$G_1^{\pm}(Y,k) = \frac{1}{a_{33}}(ia_{31}k_1 + ia_{32}k_2 \pm D),$$
 (G.9)

where

$$D(Y,k) = \left\{ \sum_{1 \le j,m \le 2} a_{33} a_{jm} k_j k_m - \left( a_{31} k_1 + a_{32} k_2 \right)^2 \right\}^{1/2},$$

$$C_1(Y,k) = \frac{i}{a_{33}} \sum_{j,m=1}^2 (\partial_{y_j} a_{jm}) k_m, \quad 2b = \frac{1}{a_{33}} \sum_{j=1}^2 \partial_{y_j} a_{3j}.$$
(G.10)

The zero-order pseudodifferential operator  $\mathcal{G}_0^-$  satisfies the inequality

$$|\mathcal{G}_0^-|_{m,n-1}^0 \le c \|\mathbb{A} - \mathbb{A}_0\|_{C^n}, \quad m \ge 0, \quad n \le l,$$
 (G.11)

and for any  $u \in H^{r-1}(\mathbb{R}^2/\Gamma)$ ,  $r < \rho - 8$  and  $1 \le s \le l - 8$ , the rest term has the bound

$$\|\mathcal{G}_{-1}^{-}u\|_{r} \le c\varepsilon \|u\|_{r-1}, \quad \|\mathcal{G}_{-1}^{-}u\|_{s} \le c(E_{l}\|u\|_{r-1} + \varepsilon \|u\|_{s-1}). \tag{G.12}$$

Moreover, operators  $\mathcal{G}_{1}^{-}$ ,  $\mathcal{G}_{0}^{-}$ ,  $\mathcal{G}_{-1}^{-}$  verify the following symmetry properties

$$\mathcal{G}_{i}^{-}u(\pm Y^{*}) = \mathcal{G}_{i}^{-}u^{*}(\pm Y), \quad j = 1, 0, -1, \quad u^{*}(Y) = u(Y^{*}).$$
 (G.13)

**Proof.** First we rewrite the operator  $\mathcal{A}$  in the form

$$\mathcal{A} = a_{33} \frac{\partial^2}{\partial y_3^2} + 2a_{33} \frac{\partial}{\partial y_3} \mathcal{B} + a_{33} \mathcal{C}, \quad \mathcal{C} = \mathcal{C}_2 + \mathcal{C}_1, \quad \mathcal{B} = \mathcal{B}_1 + b$$
 (G.14)

with differential operators

$$C_{2} = a_{33}^{-1} \sum_{i,j=1}^{2} a_{ij} \partial_{y_{i}} \partial_{y_{j}}, \quad C_{1} = a_{33}^{-1} \sum_{i,j=1}^{2} (\partial_{y_{i}} a_{ij}) \partial_{y_{j}},$$

$$\mathcal{B}_{1} = a_{33}^{-1} \sum_{j=1}^{2} a_{3j} \partial_{y_{j}}, \quad 2b = a_{33}^{-1} \sum_{j=1}^{2} \partial_{y_{j}} a_{3j}.$$
(G.15)

Combining (G.5) and (G.14) we obtain

$$\mathcal{G}^+ + \mathcal{G}^- = 2\mathcal{B}, \quad \mathcal{G}^+ \mathcal{G}^- = \mathcal{C}.$$
 (G.16)

We find the solution of (G.16) in the form

$$\mathcal{G}^{\pm} = \mathcal{G}_1^{\pm} + \mathcal{G}_0^{\pm} \pm \mathcal{X}, \tag{G.17}$$

with

$$\mathcal{G}_1^+ + \mathcal{G}_1^- = 2\mathcal{B}_1, \quad \mathcal{G}_0^+ + \mathcal{G}_0^- = 2b,$$
 (G.18)

where the symbol of pseudodifferential operator  $\mathcal{G}_1^-$  is given by formula (G.9),  $\mathcal{G}_0^-$  satisfying (G.11) and  $\mathcal{X}$  being unknown. It follows from these formulae that

$$G_1^{\pm} = \pm (-\Delta)^{1/2} + \tilde{G}_1^{\pm}$$

and for any integers  $m \geq 0$  and  $n \leq l$ 

$$|\tilde{\mathcal{G}}_1^-|_{m,n}^1 + |\mathcal{G}_0^-|_{m,n-1}^0 + |\mathcal{B}|_{m,n-1}^1 \le c \|\mathbb{A} - \mathbb{A}_0\|_{C^n}. \tag{G.19}$$

Representation (F.5) from Proposition F.3 yields the decompositions

$$\mathcal{G}_{1}^{+}\mathcal{G}_{1}^{-} = \mathcal{G}_{1}^{(2)} + \mathcal{G}_{1}^{(1)} + \mathcal{R}_{1}, 
\mathcal{G}_{0}^{+}\mathcal{G}_{1}^{-} = \mathcal{G}_{01}^{(1)} + \mathcal{R}_{01}, \quad \mathcal{G}_{1}^{+}\mathcal{G}_{0}^{-} = \mathcal{G}_{10}^{(1)} + \mathcal{R}_{10}.$$
(G.20)

Here the second order pseudodifferential operator  $\mathcal{G}_1^{(2)}$  have the symbol  $G_1^+G_1^-$ , and satisfies the identity

$$\mathcal{G}_1^{(2)} = \mathcal{C}_2,\tag{G.21}$$

the first order pseudodifferential operators  $\mathcal{G}_1^{(1)}$ ,  $\mathcal{G}_{10}^{(1)}$ , and  $\mathcal{G}_{01}^{(1)}$  have the symbols

$$G_1^{(1)} = -i\partial_k G_1^+ \partial_Y G_1^-,$$

$$G_{10}^{(1)} = G_1^+ G_0^-, \quad G_{01}^{(1)} = G_0^+ G_1^-,$$
(G.22)

and satisfy the identity

$$\mathcal{G}_{1}^{(1)} + \mathcal{G}_{10}^{(1)} + \mathcal{G}_{01}^{(1)} - \mathcal{C}_{1} = 0.$$
 (G.23)

Now from (G.16) and (G.21) we have

$$G_1^+ + G_1^- = 2B_1, \quad G_1^+ G_1^- = C_2$$

which leads to

$$G_1^{\pm} = B_1 \pm (B_1^2 - C_2)^{1/2}$$

and since  $a_{33} > 0$  for  $\varepsilon$  small enough, and noticing from (G.10) that

$$(B_1^2 - C_2)^{1/2} = \frac{1}{a_{33}}D,$$

the formula (G.9) follows. For obtaining  $G_0^-$ , we use (G.23), (G.22) which leads to (G.8)

It is then clear that  $G_0^-$  is a pseudodifferential operator of zero order which satisfies (G.11). Now, the symmetry properties (G.13) for  $\mathcal{G}_1^-$  and  $\mathcal{G}_0^-$  follow from (G.9), (G.8), the evenness of a,  $a_{33}$ ,  $a_{11}$ ,  $a_{22}$  in  $y_1$  and  $y_2$ , the oddness of b and  $a_{12}$  in  $y_1$  and  $y_2$ , and the evenness in  $y_1$ , oddness in  $y_2$  of  $a_{13}$ , and the oddness in  $y_1$ , evenness in  $y_2$  of  $a_{23}$ .

Inequality (F.9) from Proposition F.3 along with (G.19) implies the estimates

$$\|\mathcal{R}_{01}u\|_{s} + \|\mathcal{R}_{10}u\|_{s} + \|\mathcal{R}_{1}u\|_{s} \leq c\|\mathbb{A} - \mathbb{A}_{0}\|_{C^{6+s}}\|\mathbb{A} - \mathbb{A}_{0}\|_{C^{6}}\|u\|_{0} + c\|\mathbb{A} - \mathbb{A}_{0}\|_{C^{6}}^{2}\|u\|_{s}.$$
(G.24)

Substituting identities (G.20),(G.21) and (G.23) into (G.16) gives the equation for the operator  $\mathcal{X}$ 

$$\mathcal{X}^2 + (-\Delta)^{1/2}\mathcal{X} + \mathcal{X}(-\Delta)^{1/2} + \mathcal{U}\mathcal{X} + \mathcal{X}\mathcal{V} + \mathcal{W} = 0, \tag{G.25}$$

where

$$\mathcal{U} = (\widetilde{\mathcal{G}}_1^+ + \mathcal{G}_0^+), \mathcal{V} = -(\widetilde{\mathcal{G}}_1^- + \mathcal{G}_0^-),$$

$$\mathcal{W} = -(\mathcal{R}_1 + \mathcal{R}_{10} + \mathcal{R}_{01} + \mathcal{G}_0^+ \mathcal{G}_0^-).$$

Our task is to prove the existence of a "small" solution  $\mathcal{X}$  to (G.25). Introduce the Banach spaces of bounded operators

$$\mathbf{X}_s = \mathbf{F}_{s-1,s} \cap \mathbf{F}_{s,s+1}, \quad \mathbf{Y}_s = \mathbf{F}_{s,s-1}, \quad \mathbf{Z}_s = \mathbf{F}_{s,s}$$

supplemented with the norms

$$\|\mathcal{X}\|_{\mathbf{X}_{s}} = \|\mathcal{X}\|_{\mathbf{F}_{s-s+1}} + \|\mathcal{X}\|_{\mathbf{F}_{s-1-s}}, \quad \|\mathcal{Y}\|_{\mathbf{Y}_{s}} = \|\mathcal{Y}\|_{\mathbf{F}_{s-s-1}}, \quad \|\mathcal{Z}\|_{\mathbf{Z}_{s}} = \|\mathcal{Z}\|_{\mathbf{F}_{s-s}}.$$

It follows from (G.19), Corollary F.5, and (G.24)that for all  $r \leq \rho - 8$ ,

$$\|\mathcal{U}\|_{\mathbf{Y}_{r+1}} + \|\mathcal{V}\|_{\mathbf{Y}_r} + \|\mathcal{W}\|_{\mathbf{Z}_s} \le c\varepsilon, \tag{G.26}$$

where the constant c depends on l and  $\rho$  only. The rest of the proof is based on the following lemma which is proved at the end of this section.

**Lemma G.2** Under the above assumptions, there exist  $\varepsilon_0 > 0$  and c > 0 depending on  $\rho$  and l only such that for  $\varepsilon \in (0, \varepsilon_0)$  equation (G.25) has a solution satisfying the inequalities

$$\|\mathcal{X}\|_{\mathbf{X}_r} \le c\varepsilon \quad when \quad 0 \le r \le \rho - 8,$$
  
$$\|\mathcal{X}u\|_s \le c(\varepsilon \|u\|_{s-1} + E_l \|u\|_0) \quad when \quad 1 \le s \le l - 8.$$
 (G.27)

Moreover the operator  $\mathcal{X}$  satisfies the following symmetry property

$$\mathcal{X}u(\pm Y^*) = \mathcal{X}u^*(\pm Y).$$

**Proof.** We start with the consideration of the simple linear operator equation

$$(-\Delta)^{1/2}\mathcal{X} + \mathcal{X}(-\Delta)^{1/2} = \mathcal{Z} \text{ with } \mathcal{Z} \in \mathbf{Z}_s.$$
 (G.28)

It is easy to see that for any  $\mathcal{Z} \in \mathbf{Z}_s$  satisfying (G.28) and having the matrix form with elements  $\mathcal{Z}_{kp}$ , operator  $\mathcal{X}$  has the matrix representation with elements

$$\mathcal{X}_{kp} = \frac{1}{N(k) + N(p)} \mathcal{Z}_{kp}, \text{ where } N(k) = (k_1^2 + \tau^2 k_2^2)^{1/2}$$

which obviously yields the estimate

$$\|\mathcal{X}\|_{\mathbf{X}_s} \le c(\tau) \|\mathcal{Z}\|_{\mathbf{Z}_s}. \tag{G.29}$$

Hence the mapping  $\mathcal{Z} \mapsto \mathcal{X}$  defines a bounded linear operator  $\Xi \in \mathcal{L}(\mathbf{Z}_s, \mathbf{X}_s)$ . Let us consider the sequence of operators  $\mathcal{X}_n$  defined by the equalities

$$\mathcal{X}_0 = 0, \quad \mathcal{X}_{n+1} = -\Xi \Big( \mathcal{X}_n^2 + \mathcal{U} \mathcal{X}_n + \mathcal{X}_n \mathcal{V} + \mathcal{W} \Big).$$

Note that  $\mathcal{U}$  is a pseudodifferential operator which symbol U(Y,k) satisfying the inequalities

$$||U(\cdot,k)||_{C^r} \le c\varepsilon, \quad |\widehat{U}(p,q)| \le c\varepsilon(1+|p|)^{-\rho+1}|q|.$$

It is easy to see that for any  $\mathcal{X} \in \mathbf{X}_r$ , the operator  $\mathcal{U}\mathcal{X}$  has a matrix representation with the matrix elements

$$(\mathcal{U}\mathcal{X})_{kp} = \sum_{q \in \mathbb{Z}^2} \widehat{U}(k-q,q)\mathcal{X}_{qp}.$$

We have

$$(1+|k|)^r ||(\mathcal{U}\mathcal{X})_{kp}| \le c\varepsilon \sum_q (1+|k-q|)^{r-\rho+1} |\mathcal{X}_{qp}| (1+|q|)^{r+1},$$

which gives

$$\sum_{k} (1+|k|)^{2r} \left[ \sum_{p} |(\mathcal{U}\mathcal{X})_{kp}| |\widehat{u}(p)| \right]^{2} \leq c\varepsilon^{2} \sum_{k} \left[ \sum_{p} \sum_{q} (1+|q-k|)^{r-\rho+1} (1+|q|)^{r+1} |\mathcal{X}_{qp}| |\widehat{u}(p)| \right]^{2} \leq c\varepsilon^{2} \sum_{k} \left[ \sum_{q} (1+|q-k|)^{r-\rho+1} \left( (1+|q|)^{r+1} \sum_{p} |\mathcal{X}_{qp}| |\widehat{u}(p)| \right) \right]^{2} \leq c\varepsilon^{2} \sum_{q} \left[ (1+|q|)^{r+1} \sum_{p} |\mathcal{X}_{qp}| |\widehat{u}(p)| \right]^{2} \leq c\varepsilon^{2} \sum_{q} \left[ (1+|q|)^{r+1} \sum_{p} |\mathcal{X}_{qp}| |\widehat{u}(p)| \right]^{2} \leq c\varepsilon^{2} \|\mathcal{X}\|_{\mathbf{F}_{r,r+1}}^{2} \sum_{p} (1+|p|)^{2r} |\widehat{u}(p)|^{2}.$$

Thus we get

$$\|\mathcal{U}\mathcal{X}\|_{\mathbf{Z}_r} \leq c\|\mathcal{U}\|_{\mathbf{Y}_{r+1}}\|\mathcal{X}\|_{\mathbf{X}_r}.$$

Repeating these arguments we obtain

$$\|\mathcal{X}\mathcal{V}\|_{\mathbf{Z}_r} \leq c\|\mathcal{V}\|_{\mathbf{Y}_r}\|\mathcal{X}\|_{\mathbf{X}_r},$$

and

$$\|\mathcal{X}^2\|_{\mathbf{Z}_r} \le c\|\mathcal{X}\|_{\mathbf{Z}_r}^2 \le c\|\mathcal{X}\|_{\mathbf{X}_r}^2,$$

inequality (G.29) yields the estimates

$$\|\mathcal{X}_{n+1}\|_{\mathbf{X}_r} \le c\varepsilon(\|\mathcal{X}_n\|_{\mathbf{X}_r} + 1) + \|\mathcal{X}_n\|_{\mathbf{X}_r}^2, \tag{G.30}$$

which holds true for all  $r \in (1, \rho - 8)$ . On the other hand, since

$$\mathcal{X}_{n+1}^2 - \mathcal{X}_n^2 = (\mathcal{X}_{n+1} - \mathcal{X}_n)\mathcal{X}_{n+1} + \mathcal{X}_n(\mathcal{X}_{n+1} - \mathcal{X}_n)$$

we have

$$\|\mathcal{X}_{n+1} - \mathcal{X}_n\|_{\mathbf{X}_n} \le c\|\mathcal{X}_n - \mathcal{X}_{n-1}\|_{\mathbf{X}_n} (\varepsilon + \|\mathcal{X}_n\|_{\mathbf{X}_n} + \|\mathcal{X}_{n-1}\|_{\mathbf{X}_n}). \tag{G.31}$$

Here the constant c depends on  $\varrho$  and  $\tau$  only. It follows from (G.30) that for all  $\varepsilon \in (0, \varepsilon_0(\rho, \tau))$ , the values  $\|\mathcal{X}_n\|_{\mathbf{X}_r}$  are less than  $c\varepsilon$ . From this and (G.31) we conclude that for all small  $\varepsilon$  the sequence  $\mathcal{X}_n$  converges in  $\mathbf{X}_r$ . Repeating these arguments and using Corollary F.5 gives the tame estimate (G.27), and the lemma follows once we observe that the symmetry property of  $\mathcal{X}$  follows from the uniqueness of  $\mathcal{X}$  and from the equivariance with respect to the required symmetry of the equation (G.25).

In order to complete the proof of Theorem G.1, it remains to note that operator  $\mathcal{G}_{-1}^- := -\mathcal{X}$  with  $\mathcal{X}$  given by Lemma G.2 satisfies (G.12).

**Proof of Theorem 3.5** It follows from formulae (G.9), (G.6), and (G.7) that we can write

$$G_{\eta}\psi = \frac{1}{J} \{ \mathcal{D} - a_{33}(G_0^- + G_{-1}^-) \} \widetilde{\psi},$$

where the first order pseudodifferential operator  $\mathcal{D}$  has the symbol D(Y, k). Then we define

$$\mathcal{G}_0 = -\frac{a_{33}}{J}\mathcal{G}_0^-, \quad \mathcal{G}_{-1} = -\frac{a_{33}}{J}\mathcal{G}_{-1}^-,$$

and the symmetry properties follow from the evenness of J,  $a_{33}$  and from Theorem G.1 and Lemma G.2. The zero order pseudodifferential operator  $\mathcal{G}_0$  satisfies (3.22) and from Proposition F.1 we have

$$||\mathcal{G}_0 u||_r \le c\varepsilon ||u||_r, \quad 0 \le r \le \rho - 4$$
  
 $||\mathcal{G}_0 u||_s \le c(\varepsilon ||u||_s + E_l||u||_0), \quad 0 \le s \le l - 4,$  (G.32)

while the operator  $\mathcal{G}_{-1}$  satisfies

$$||\mathcal{G}_{-1}u||_r \le c\varepsilon ||u||_{r-1}, \ 1 \le r \le \rho - 8,$$
  
 $||\mathcal{G}_{-1}u||_s \le c(\varepsilon ||u||_{s-1} + E_l||u||_0), \ 1 \le s \le l - 8.$  (G.33)

We then deduce the estimates (3.23) in using (G.4).

Now our task is to calculate the symbols  $G_j$ . It is convenient to introduce the scalar  $\mathbf{I}(Y)$  and linear form  $\Pi(Y,k)$  defined by

$$\mathbf{I} = J/\sqrt{\det \mathbb{G}}, \quad \Pi = \mathbb{G}^{-1} \nabla_Y \tilde{\eta} \cdot k.$$

Recall the identity

$$a_{33} \sum_{1 \le j,m \le 2} a_{jm} k_j k_m - \left(\sum_{1 \le m \le 2} a_{3m} k_m\right)^2$$

$$= \det \mathbb{A}\left((\mathbb{A}^{-1})_{22} k_1^2 - 2(\mathbb{A}^{-1})_{12} k_1 \xi_2 + (\mathbb{A}^{-1})_{11} k_2^2\right).$$

Noting that det  $\mathbb{A} = J$ ,  $\mathbb{A}^{-1} = J^{-1} \mathbb{B}_1^* \mathbb{B}_1$ , we conclude from this that

$$a_{33} \sum_{1 \le i, m \le 2} a_{jm} k_j k_m - \left(\sum_{1 \le m \le 2} a_{3m} k_m\right)^2 = (\mathbb{B}_1^* \mathbb{B}_1)_{22} k_1^2 - 2(\mathbb{B}_1^* \mathbb{B}_1)_{12} k_1 k_2 + (\mathbb{B}_1^* \mathbb{B}_1)_{11} k_2^2.$$

Hence, by the definition of the metric tensor  $\mathbb{G}$ ,

$$a_{33} \sum_{1 \le j,m \le 2} a_{jm} k_j \xi_m - \left(\sum_{1 \le m \le 2} a_{3m} k_m\right)^2 = g_{22} k_1^2 - 2g_{12} k_1 k_2 + g_{11} k_2^2,$$

which yields

$$a_{33} \sum_{1 \le j,m \le 2} a_{jm} k_j k_m - \left(\sum_{1 \le m \le 2} a_{3m} k_m\right)^2 = (\det \mathbb{G}) \mathbb{G}^{-1} k \cdot k. \tag{G.34}$$

Substituting this relation into D (see (G.10)) finally gives

$$D(Y,k) = \sqrt{\det \mathbb{G}} \,\mathbf{G}_1(Y,k). \tag{G.35}$$

Noting that  $\mathcal{G}_1 = \frac{1}{J}\mathcal{D}$  we obtain the needed formula (3.18). The calculation of  $G_0$  is more delicate task. Since  $a_{33} = \det \mathbb{G}/J$ , formula (G.8) yields

$$(2\mathbf{IG}_1)G_0^- = i\nabla_k G_1^+ \nabla_Y G_1^- - \frac{G_1^-}{a_{33}} \sum_{i=1}^2 \partial_{y_i} a_{3j} + \frac{i}{a_{33}} \sum_{i,m=1}^2 \partial_{y_i} a_{jm} k_m.$$

It follows from the definition of the form  $\Pi$  that

$$\sum_{m=1}^{2} a_{3m} k_m = -a_{33} \Pi, \quad \sum_{j=1}^{2} \partial_{y_j} a_{3j} = -\operatorname{div}_Y(a_{33} \nabla_k \Pi). \tag{G.36}$$

From this, (G.9), and (G.35) we conclude that

$$G_1^- = -\mathbf{I}G_1 - i\Pi, \quad G_1^+ = \mathbf{I}G_1 - i\Pi,$$

and hence

$$(2\mathbf{I}\mathbf{G}_{1})G_{0}^{-} = i\nabla_{k}(\mathbf{I}\mathbf{G}_{1} - i\Pi)\nabla_{Y}(-\mathbf{I}\mathbf{G}_{1} - i\Pi) - \frac{1}{a_{33}}(\mathbf{I}\mathbf{G}_{1} + i\Pi)\operatorname{div}_{Y}(a_{33}\nabla_{k}\Pi) + \frac{i}{a_{33}}\sum_{j,m=1}^{2}\partial_{y_{j}}a_{jm}k_{m}. \quad (G.37)$$

Next differentiating both sides of (G.34) with respect to  $k_i$  we arrive to

$$2a_{33} \sum_{m=1}^{2} a_{jm} k_m - 2a_{3j} \sum_{m=1}^{2} a_{3m} k_m = (\det \mathbb{G}) \partial_{k_j} \mathbf{G}_1^2,$$

which along with (G.36) and the identity det  $\mathbb{G}/a_{33}=J$  leads to

$$\sum_{m=1}^{2} a_{jm} k_m = a_{33} \Pi \partial_{k_j} \Pi + J \mathbf{G}_1 \partial_{k_j} \mathbf{G}_1.$$

Substituting this expression into (G.37) we finally obtain

$$(2\mathbf{I}\mathbf{G}_{1})G_{0}^{-} = i\nabla_{k}(\mathbf{I}\mathbf{G}_{1} - i\Pi)\nabla_{Y}(-\mathbf{I}\mathbf{G}_{1} - i\Pi) - \frac{1}{a_{33}}(\mathbf{I}\mathbf{G}_{1} + i\Pi)\operatorname{div}_{Y}(a_{33}\nabla_{k}\Pi) + \frac{i}{a_{33}}\operatorname{div}_{Y}\left(a_{33}\Pi\nabla_{k}\Pi + J\mathbf{G}_{1}\nabla_{k}\mathbf{G}_{1}\right). \quad (G.38)$$

Let us calculate the real part of  $G_0$ . It is easy to see that

$$(2\mathbf{I}\mathbf{G}_1) \operatorname{Re} G_0^- = \mathbf{I}\nabla_k \mathbf{G}_1 \nabla_Y \Pi - \nabla_k \Pi \nabla_Y (\mathbf{I}\mathbf{G}_1) - \frac{\mathbf{I}\mathbf{G}_1}{a_{33}} \operatorname{div}_Y (a_{33} \nabla_k \Pi),$$

which along with the equality  $\mathbf{I}a_{33} = \sqrt{\det \mathbb{G}}$  implies

$$(2\mathbf{G}_1) \text{ Re } G_0^- = \nabla_k \mathbf{G}_1 \cdot \nabla_Y \Pi - \nabla_k \Pi \cdot \nabla_Y \mathbf{G}_1 - \mathbf{G}_1 \text{ div}_Y (\nabla_k \Pi) - \mathbf{G}_1 \nabla_k \Pi \cdot \nabla_Y \ln \sqrt{\det \mathbb{G}}.$$

Noting that

$$\operatorname{div}_Y(\nabla_k \Pi) + \nabla_k \Pi \cdot \nabla_Y \ln \sqrt{\det \mathbb{G}} = \operatorname{div}(\nabla_k \Pi),$$

and recalling

$$G_0 = -\frac{a_{33}}{I}G_0^- = -\frac{\det \mathbb{G}}{I^2}G_0^-,$$
 (G.39)

we obtain

Re 
$$G_0 = \frac{\det \mathbb{G}}{2J^2\mathbf{G}_1} (\nabla_k \Pi \cdot \nabla_Y \mathbf{G}_1 - \nabla_k \mathbf{G}_1 \cdot \nabla_Y \Pi) + \frac{\det \mathbb{G}}{2J^2} \mathbf{div}(\nabla_k \Pi).$$

From this and the identities

$$\nabla_k \Pi = \mathbb{G}^{-1} \nabla_Y \tilde{\eta}, \quad \nabla_k \mathbf{G}_1 = \frac{1}{\mathbf{G}_1} \mathbb{G}^{-1} k, \quad \nabla_Y \mathbf{G}_1 = \frac{1}{2\mathbf{G}_1} \nabla_Y (\mathbb{G}^{-1} k \cdot k)$$

we obtain the desired formula (3.19) for the real part of  $G_0$ . Next (G.38) yields

$$\begin{split} &(2\mathbf{I}\mathbf{G}_1) \text{ Im } G_0^- = -\mathbf{I}\nabla_k\mathbf{G}_1 \cdot \nabla_Y(\mathbf{I}\mathbf{G}_1) - \nabla_k\Pi \cdot \nabla_Y\Pi - \\ &\frac{1}{a_{33}}\Pi \text{div}_Y(a_{33}\nabla_k\Pi) + \frac{1}{a_{33}}\text{div}_Y\left[\Pi\nabla_k(a_{33}\Pi) + J\mathbf{G}_1\nabla_k\mathbf{G}_1\right] = \\ &\frac{J}{a_{33}}\mathbf{G}_1\text{div}_Y(\nabla_k\mathbf{G}_1) + \mathbf{G}_1\left(\frac{1}{a_{33}}\nabla_YJ - \mathbf{I}\nabla_Y\mathbf{I}\right) \cdot \nabla_k\mathbf{G}_1. \end{split}$$

Since  $J/a_{33} = \mathbf{I}^2$  and

$$\frac{1}{a_{33}}\nabla_Y J - \mathbf{I}\nabla_Y \mathbf{I} = \frac{J^2}{(\det \mathbb{G})^{3/2}}\nabla_Y \sqrt{\det \mathbb{G}} = \mathbf{I}^2 \frac{1}{\sqrt{\det \mathbb{G}}}\nabla_Y \sqrt{\det \mathbb{G}},$$

we have

$$2 \operatorname{Im} G_0^- = \mathbf{I} \operatorname{\mathbf{div}} (\nabla_k \mathbf{G}_1).$$

Recalling (G.39) we obtain (3.20) and the theorem follows.

Invariant form of Re  $G_0$ . In the rest of the section we prove the formula (3.24). We start with the calculation of the quadratic form

$$Q(Y, \mathbb{G}\xi) := \tilde{Q}(Y, \xi) = \tilde{Q}_{11}\xi_1^2 + 2\tilde{Q}_{12}\xi_1\xi_2 + \tilde{Q}_{22}\xi_2^2$$

It follows from (3.21) and the identity  $\mathbb{G}\partial_{y_j}\mathbb{G}^{-1}\mathbb{G}=-\partial_{y_j}\mathbb{G}$  that

$$\tilde{Q}(Y,\xi) = \sum_{j=1}^{2} (\xi_j \partial_{y_j} \mathbb{G}) \mathbf{q} \cdot \xi - \frac{1}{2} \partial_{y_j} (\mathbb{G}\xi \cdot \xi) q_j - \nabla_Y^2 \tilde{\eta} \xi \cdot \xi, \tag{G.40}$$

where the vector field  $\mathbf{q} = \mathbb{G}^{-1}\nabla_Y \tilde{\eta}$ . Thus we get

$$ilde{Q}_{lphaeta} = rac{1}{2} \sum_{j=1}^2 \Big( \partial_{y_lpha} g_{jeta} + \partial_{y_eta} g_{jlpha} - \partial_{y_j} g_{lphaeta} \Big) q_j - \partial_{lphaeta}^2 ilde{\eta},$$

which along with the equality  $g_{\alpha\beta} = \partial_{y_{\alpha}} \mathbf{r} \cdot \partial_{y_{\beta}} \mathbf{r}$  yields

$$\tilde{Q}_{\alpha\beta} = \left(\sum_{j=1}^{2} q_{j} \partial_{y_{j}} \mathbf{r} - \mathbf{e}_{3}\right) \cdot \partial_{y_{\alpha}y_{\beta}}^{2} \mathbf{r}.$$
(G.41)

On the other hand, since  $\tilde{\eta} = \mathbf{r} \cdot \mathbf{e}_3$ , the expression for  $\mathbf{q}$  reads

$$\mathbf{q} = \frac{1}{\det \mathbb{G}} \left\{ \begin{array}{c} (g_{22} \partial_{y_1} \mathbf{r} - g_{12} \partial_{y_2} \mathbf{r}) \cdot \mathbf{e}_3 \\ (-g_{12} \partial_{y_1} \mathbf{r} + g g_{11} \partial_{y_2} \mathbf{r}) \cdot \mathbf{e}_3 \end{array} \right\}.$$

Now set

$$\mathbf{a} = \partial_{y_1} \mathbf{r}, \quad \mathbf{b} = \partial_{y_2} \mathbf{r}, \quad \mathbf{c} = \mathbf{a} \times \mathbf{b}.$$
 (G.42)

Noting that

$$g_{11} = \mathbf{a} \cdot \mathbf{a}, \quad g_{12} = \mathbf{a} \cdot \mathbf{b}, \quad g_{22} = \mathbf{b} \cdot \mathbf{b},$$
  
$$\mathbf{b} \times \mathbf{c} = (\mathbf{b} \cdot \mathbf{b})\mathbf{a} - (\mathbf{a} \cdot \mathbf{b})\mathbf{b}, \quad \mathbf{a} \times \mathbf{c} = (\mathbf{a} \cdot \mathbf{b})\mathbf{a} - (\mathbf{a} \cdot \mathbf{a})\mathbf{b},$$

we obtain

$$(\det \mathbb{G})q_1 = (\mathbf{b} \times \mathbf{c}) \cdot \mathbf{e}_3, \quad (\det \mathbb{G})q_2 = -(\mathbf{a} \times \mathbf{c}) \cdot \mathbf{e}_3.$$

From this and the identity

$$[(\mathbf{b} \times \mathbf{c}) \cdot \mathbf{e}_3]\mathbf{a} - [(\mathbf{a} \times \mathbf{c}) \cdot \mathbf{e}_3]\mathbf{b} - |\mathbf{c}|^2\mathbf{e}_3 = -(\mathbf{c} \cdot \mathbf{e}_3)\mathbf{c},$$

which holds true for all  $\mathbf{a}, \mathbf{b} \in \mathbb{R}^3$  and  $\mathbf{c} = \mathbf{a} \times \mathbf{b}$ , we conclude that

$$(\det \mathbb{G})(q_1\partial_{y_1}\mathbf{r} + q_2\partial_{y_2}\mathbf{r}) - |\mathbf{c}|^2\mathbf{e}_3 = -(\mathbf{c}\cdot\mathbf{e}_3)\mathbf{c}.$$

Noting that  $|\mathbf{c}|^2 = \det \mathbb{G}$  and  $\mathbf{c} \cdot \mathbf{e}_3 = J$  we arrive at

$$\sum_{j=1}^{2} q_{j} \partial_{y_{j}} \mathbf{r} - \mathbf{e}_{3} = -\frac{J}{\sqrt{\det \mathbb{G}}} \mathbf{n},$$

where  $\mathbf{n} = \mathbf{c}/|\mathbf{c}|$  is the unit normal vector to  $\Sigma$ . Substituting this identity into (G.41) gives  $Q_{\alpha\beta} = -(\mathbf{n} \cdot \partial_{y_{\alpha}y_{\beta}}\mathbf{r})J/\sqrt{\det \mathbb{G}}$  which leads to

$$\tilde{Q}(Y,\xi) = -\frac{J}{\sqrt{\det \mathbb{G}}} (L\xi_1^2 + 2M\xi_1\xi_2 + N\xi_2^2).$$

Since

$$\mathbf{G}_1^2(Y, \mathbb{G}\xi) = \mathbb{G}\xi \cdot \xi := E\xi_1^2 + 2F\xi_1\xi_2 + G\xi_2^2$$

we finally obtain

$$\frac{\det \mathbb{G}}{2J^2} \left\{ \frac{1}{\mathbf{G}_1^2(Y, \mathbb{G}\xi)} Q(Y, \mathbb{G}\xi) \right\} = -\frac{\sqrt{\det \mathbb{G}}}{J} \frac{L\xi_1^2 + 2M\xi_1\xi_2 + N\xi_2^2}{2(E\xi_1^2 + 2F\xi_1\xi_2 + G\xi_2^2)}. \quad (G.43)$$

Our next task is to express  $\operatorname{\mathbf{div}} \mathbf{q}$  via the geometric characteristics of  $\Sigma$ . First we do this in the standard coordinates Y = X with  $\tilde{\eta} = \eta$ . In this case

$$\mathbb{G}^{-1} = \frac{1}{1 + |\nabla \eta|^2} \begin{pmatrix} 1 + \partial_{y_2} \eta^2, & -\partial_{y_1} \eta \ \partial_{y_2} \eta \\ -\partial_{y_1} \eta \ \partial_{y_2} \eta, & 1 + \partial_{y_1} \eta^2 \end{pmatrix}, \quad \det \mathbb{G} = 1 + |\nabla \eta|^2, \quad J = 1,$$

and  $\mathbf{q} = (1 + |\nabla \eta|^2)^{-1} \nabla \eta$ , which leads to the formula

$$\frac{\det \mathbb{G}}{2J^2} \operatorname{\mathbf{div}} \mathbf{q} = \frac{\sqrt{\det \mathbb{G}}}{J} \frac{1}{2} \operatorname{div} \left( \frac{\nabla \eta}{\sqrt{1 + |\nabla \eta|^2}} \right) = \frac{\sqrt{\det \mathbb{G}}}{J} \frac{\mathfrak{k}_1 + \mathfrak{k}_2}{2}, \quad (G.44)$$

where  $\mathfrak{k}_i$  are the principal curvatures of  $\Sigma$  at the point  $\mathbf{r}$ . Next note that  $\nabla \eta$  is a covariant vector field on  $\Sigma$ , hence  $\mathbb{G}^{-1}\nabla \eta$  is a vector field on  $\Sigma$ . Since **div** is an invariant operator on the space of vector fields on  $\Sigma$ , the left side of (G.44) does not depend on the choice of coordinates, hence

$$\frac{\det \mathbb{G}}{2J^2} \operatorname{\mathbf{div}} \mathbf{q} = \frac{\sqrt{\det \mathbb{G}}}{J} \frac{\mathfrak{k}_1 + \mathfrak{k}_2}{2} = \frac{\sqrt{\det \mathbb{G}}}{J} \frac{LG - 2MF + NE}{2(EG - F^2)}.$$
 (G.45)

Combining (G.43) and (G.45) gives the desired identity (3.24). If we define by  $\mathfrak{n}(\xi)$  the normal curvature of  $\Sigma$  in the direction  $\xi$  at a point  $\mathbf{r}$ , then (3.24) becomes

$$\frac{J}{\sqrt{\det \mathbb{G}}} \operatorname{Re} G_0(Y, \mathbb{G}\xi) = \frac{1}{2} (\mathfrak{k}_1 + \mathfrak{k}_2 - \mathfrak{n}(\xi)),$$

which leads to

Corollary G.3 Assume that the manifold  $\Sigma$  has a parametric representation  $\mathbf{r}(Y) = (\mathbb{T}Y + \tilde{\mathcal{V}}(Y), \tilde{\eta}(Y)), Y \in \mathbb{R}^2$  so that  $\tilde{\mathcal{V}}$  and  $\tilde{\eta}$ , which are not defined yet, satisfy all hypotheses of Theorem 3.5. Assume also that the parametric form

$$\mathfrak{G}u := \frac{J}{\sqrt{\det \mathbb{T}}} \mathcal{G}_{\eta} \check{u} \circ (\mathbb{T} + \mathcal{V}), \quad \check{u}(X) = u(Y(X)),$$

of the normal derivative operator is given for any bi- periodic smooth function u(Y). Then the manifold  $\Sigma$  is defined by the operator  $\mathfrak{G}$  up to a translation and a rotation of the embedding space.

**Proof.** Note that for all  $k \in \mathbb{Z}^2$ ,

$$\lim_{n \to \infty} \frac{1}{n} e^{-ink \cdot Y} \mathfrak{G} e^{ink \cdot Y} = \frac{J}{\sqrt{\det \mathbb{G}}} G_1(Y, k) = \sqrt{\mathbb{G}^{-1}k \cdot k},$$

$$\lim_{n \to \infty} \operatorname{Re} \left\{ e^{-ink \cdot Y} \mathfrak{G} e^{ink \cdot Y} - \frac{J}{\sqrt{\det \mathbb{G}}} G_1(Y, k) \right\} = \frac{J}{\sqrt{\det \mathbb{G}}} \operatorname{Re} G_0(Y, k).$$

Since  $G_0$  is a homogeneous function of k, it follows from this that the right hand sides of these equalities are defined by the operator  $\mathfrak{G}$  for all  $k \in \mathbb{R}^2$  and, in particular, for  $k = \mathbb{G}\xi$  with an arbitrary  $\xi \in \mathbb{R}^2$ . Hence the first fundamental form  $\mathbb{G}\xi \cdot \xi$  and the difference  $\mathfrak{k}_1 + \mathfrak{k}_2 - \mathfrak{n}(\xi)$  are completely defined by  $\mathfrak{G}$  for all directions  $\xi$  at each point of  $\Sigma$ . Hence the principle curvatures of  $\Sigma$  are also defined by the operator  $\mathfrak{G}$ . It remains to note that, by the Bonnet Theorem, the first fundamental form and the principal curvatures define  $\Sigma$  up to a translation and a rotation of the embedding space.

## H Proof of Lemma 5.8

To be able to compute all terms in (5.95), let us rewrite the system (1.6), (1.7) formally as a scalar equation for  $\psi$  and express the orders  $\varepsilon$  and  $\varepsilon^2$  of the differential computed at  $\psi_{\varepsilon}^{(N)}$ ,  $N \geq 3$ . Then the operator  $\mathfrak{L} + \mathfrak{H}$  is up to order  $\varepsilon^2$  closely linked with the new form of this operator after applying the diffeomorphism computed at Lemma 3.8.

Indeed we can formally solve (1.7) with respect to  $\eta$  in powers of  $\psi$  as

$$\eta = -\frac{1}{\mu} \partial_{x_1} \psi - \frac{1}{2\mu} (\nabla \psi)^2 + \frac{1}{2\mu^3} (\partial_{x_1}^2 \psi)^2 + O(||\psi||^3), \tag{H.1}$$

and replace  $\eta$  by this expression in (1.6). We then obtain a new scalar formal equation for  $\psi$ , under the form  $\mathcal{E}(\psi, \mu) = 0$ , where

$$\mathcal{E}(\psi, \mu) = \mathfrak{L}_0 \psi + (\mu - \mu_c) \mathfrak{L}_1 \psi + \mathcal{E}_2(\psi, \psi) + \mathcal{E}_3(\psi, \psi, \psi) + O(|\mu - \mu_c|^2 ||\psi|| + ||\psi||^4),$$

where

$$\mathfrak{L}_0 \psi = \frac{1}{\mu_c} \partial_{x_1}^2 \psi + \mathcal{G}^{(0)} \psi$$

$$\mathfrak{L}_1 \psi = -\frac{1}{\mu_c^2} \partial_{x_1}^2 \psi,$$

and  $\mathcal{E}_2$  and  $\mathcal{E}_3$  represent quadratic and cubic terms in  $\psi$ , respectively. Let us write the formal solution found at Theorem 2.3 for  $\varepsilon_1 = \varepsilon_2 = \varepsilon/2$ , under the form  $(N \geq 3)$ 

$$\psi_{\varepsilon}^{(N)} = \varepsilon \psi_1 + \varepsilon^2 \psi_2 + O(\varepsilon^3),$$
  

$$\mu = \mu_c + \varepsilon^2 \mu_1 + O(\varepsilon^3),$$

where

$$\psi_1 = \sin x_1 \cos \tau x_2,$$

then we have the identities

$$\mathfrak{L}_{0}\psi_{1} = 0, 
\mathfrak{L}_{0}\psi_{2} + \mathcal{E}_{2}(\psi_{1}, \psi_{1}) = 0, 
\mathfrak{L}_{0}\psi_{3} + \mu_{1}\mathfrak{L}_{1}\psi_{1} + 2\mathcal{E}_{2}(\psi_{1}, \psi_{2}) + \mathcal{E}_{3}(\psi_{1}, \psi_{1}, \psi_{1}) = 0.$$
(H.2)

Now, we may observe that the operator (3.7) we want to invert acts on  $\delta \phi = \delta \psi - \mathfrak{b} \delta \eta$ . Since  $\mathfrak{b}$  is  $O(\varepsilon)$  and  $\delta \eta$  may be expressed formally linearly in terms of  $\delta \psi$  in differentiating formally (H.1), we have formally

$$\partial_{\psi} \mathcal{E}(\psi, \mu) (1 + \mathcal{H}(\psi, \mu)) = \kappa \mathfrak{L}(\psi, \mu) - \mathcal{R}(\mathcal{E}, \mu) \tag{H.3}$$

where  $\mathfrak{L}(\psi,\mu)$  is the linear operator we want to invert,  $\kappa$  is the function we introduced at Theorem 3.4, and the operator  $\mathcal{H}(\psi,\mu)$  is such that formally

$$\delta \psi = (1 + \mathcal{H}(\psi, \eta))\delta \phi,$$

and  $\mathcal{R}(0,\mu) = 0$ . Since we set

$$\psi = \psi_{\varepsilon}^{(N)} + O(\varepsilon^N), \ N \ge 3$$
  
$$\mu = \mu_0 + \varepsilon^2 \mu_1(\tau_0) + O(\varepsilon^3), \ \mu_0 = \mu_c(\tau_0),$$

we have

$$\mathcal{E}(\psi_{\varepsilon}^{(2)}, \mu_0 + \varepsilon^2 \mu_1) = O(\varepsilon^3), \quad \mathcal{R} = O(\varepsilon^3),$$

hence

$$\partial_{\psi} \mathcal{E}(\psi, \mu) = \mathfrak{L}_0 + \varepsilon^2 \mu_1 \mathfrak{L}_1 + 2\mathcal{E}_2(\psi_{\varepsilon}^{(2)}, \cdot) + 3\mathcal{E}_3(\psi_{\varepsilon}^{(2)}, \psi_{\varepsilon}^{(2)}, \cdot) + O(\varepsilon^3).$$

Making now the change of coordinates computed at Lemma 3.8, the new expressions of operators  $\mathfrak{L}_0$ ,  $\mathfrak{L}_1$ ,  $\mathcal{E}_2(\psi_{\varepsilon}^{(2)},\cdot)$ ,  $\mathcal{E}_3(\psi_1,\psi_1,\cdot)$  take the following form

$$\begin{array}{rcl} \operatorname{new} \mathfrak{L}_0 & = & \mathfrak{L}_0 + \varepsilon \mathfrak{L}_0^{(1)} + \varepsilon^2 \mathfrak{L}_0^{(2)} + O(\varepsilon^3), \\ \operatorname{new} \mathfrak{L}_1 & = & \mathfrak{L}_1^{(0)} + \varepsilon \mathfrak{L}_1^{(1)} + O(\varepsilon^2), \\ \operatorname{new} \mathcal{E}_2(\psi_1, \cdot) & = & \mathcal{E}_2^{(0)}(\psi^{(0)}, \cdot) + \varepsilon \mathcal{E}_2^{(1)}(\psi^{(0)}, \cdot) + O(\varepsilon^2), \\ \operatorname{new} \mathcal{E}_3(\psi_1, \psi_1, \cdot) & = & \mathcal{E}_3^{(0)}(\psi^{(0)}, \psi^{(0)}, \cdot) + O(\varepsilon), \end{array}$$

and the functions  $\psi_1, \psi_2$  are transformed into

new 
$$\psi_1 = \psi^{(0)} + \varepsilon \psi_1^{(1)} + \varepsilon^2 \psi_1^{(2)} + O(\varepsilon^3)$$
  
new  $\psi_2 = \psi_2^{(0)} + \varepsilon \psi_2^{(1)} + O(\varepsilon^2)$ .

Moreover, we have thanks to Lemma 3.8

$$\kappa(Y) = 1 + \varepsilon \kappa_1(Y) + \varepsilon^2 \kappa_2(Y) + O(\varepsilon^3),$$
  

$$\text{new} \mathcal{H}(\psi, \mu) = \varepsilon \mathcal{H}_1 + \varepsilon^2 \mathcal{H}_2 + O(\varepsilon^3).$$

Hence, identities (H.2) lead to

$$\mathcal{L}_{0}\psi^{(0)} = 0, 
\mathcal{L}_{0}^{(1)}\psi^{(0)} + \mathcal{L}_{0}\psi_{1}^{(1)} = 0, 
\mathcal{L}_{0}^{(2)}\psi^{(0)} + \mathcal{L}_{0}^{(1)}\psi_{1}^{(1)} + \mathcal{L}_{0}\psi_{1}^{(2)} = 0,$$
(H.4)

$$\mathfrak{L}_{0}\psi_{2}^{(0)} + \mathcal{E}_{2}^{(0)}(\psi^{(0)}, \psi^{(0)}) = 0, \quad (H.5)$$

$$\mathfrak{L}_{0}^{(1)}\psi_{2}^{(0)} + \mathfrak{L}_{0}\psi_{2}^{(1)} + 2\mathcal{E}_{2}^{(0)}(\psi^{(0)}, \psi_{1}^{(1)}) + \mathcal{E}_{2}^{(1)}(\psi^{(0)}, \psi^{(0)}) = 0,$$

$$\mathfrak{L}_{0}\psi_{3}^{(0)} + \mu_{1}\mathfrak{L}_{1}^{(0)}\psi^{(0)} + 2\mathcal{E}_{2}^{(0)}(\psi^{(0)}, \psi_{2}^{(0)}) + \mathcal{E}_{3}^{(0)}(\psi^{(0)}, \psi^{(0)}, \psi^{(0)}) = 0.$$
 (H.6)

We deduce from these formulae and from (H.3), that the linear operator obtained after the change of coordinates satisfies

$$\mathfrak{L} + \mathfrak{H} = \mathfrak{L}_0 + \varepsilon \mathfrak{H}^{(1)} + \varepsilon^2 \mathfrak{H}^{(2)} + O(\varepsilon^3)$$

with

$$\kappa_1 \mathfrak{L}_0 + \mathfrak{H}^{(1)} = \mathfrak{L}_0^{(1)} + 2 \mathfrak{E}_2^{(0)}(\psi^{(0)}, \cdot) + \mathfrak{L}_0 \mathcal{H}_1$$
(H.7)

$$\kappa_{2}\mathfrak{L}_{0} + \kappa_{1}\mathfrak{H}^{(1)} + \mathfrak{H}^{(2)} = \mathfrak{L}_{0}^{(2)} + \mu_{1}\mathfrak{L}_{1}^{(0)} + 2\mathcal{E}_{2}^{(1)}(\psi^{(0)}, \cdot) + 2\mathcal{E}_{2}^{(0)}(\psi_{2}^{(0)}, \cdot) + 2\mathcal{E}_{2}^{(0)}(\psi_{1}^{(1)}, \cdot) + \\ + 3\mathcal{E}_{3}^{(0)}(\psi^{(0)}, \psi^{(0)}, \cdot) + \left\{\mathfrak{L}_{0}^{(1)} + 2\mathcal{E}_{2}^{(0)}(\psi^{(0)}, \cdot)\right\}\mathcal{H}_{1} + \mathfrak{L}_{0}\mathcal{H}_{2}.$$

We now compute the terms under the integral in (5.95). First we observe (thanks to (H.4), (H.5))

$$\mathfrak{L}_{0}^{-1}\mathfrak{H}^{(1)}\psi^{(0)} = \mathfrak{L}_{0}^{-1}\{\mathfrak{L}_{0}^{(1)}\psi^{(0)} + 2\mathfrak{E}_{2}^{(0)}(\psi^{(0)},\psi^{(0)})\} + \mathcal{H}_{1}\psi^{(0)} 
= \mathfrak{L}_{0}^{-1}\{-\mathfrak{L}_{0}\psi_{1}^{(1)} - 2\mathfrak{L}_{0}\psi_{2}^{(0)}\} + \mathcal{H}_{1}\psi^{(0)} 
= -(\psi_{1}^{(1)} + 2\psi_{2}^{(0)}) + \mathcal{H}_{1}\psi^{(0)},$$

hence

$$\begin{split} -\mathfrak{H}^{(1)}\mathfrak{L}_{0}^{-1}\mathfrak{H}^{(1)}\psi^{(0)} &= \mathfrak{L}_{0}^{(1)}(\psi_{1}^{(1)}+2\psi_{2}^{(0)})+2\mathcal{E}_{2}^{(0)}(\psi^{(0)},\psi_{1}^{(1)})+\\ &+4\mathcal{E}_{2}^{(0)}(\psi^{(0)},\psi_{2}^{(0)})+\mathfrak{L}_{0}\mathcal{H}_{1}(\psi_{1}^{(1)}+2\psi_{2}^{(0)})+\\ &-\kappa_{1}\mathfrak{L}_{0}(\psi_{1}^{(1)}+2\psi_{2}^{(0)})-\mathfrak{H}^{(1)}\mathcal{H}_{1}\psi^{(0)}. \end{split}$$

Moreover

$$\begin{split} \mathfrak{H}^{(2)}\psi^{(0)} &= \mathfrak{L}_{0}^{(2)}\psi^{(0)} + \mu_{1}\mathfrak{L}_{1}^{(0)}\psi^{(0)} + 2\mathcal{E}_{2}^{(1)}(\psi^{(0)},\psi^{(0)}) + 2\mathcal{E}_{2}^{(0)}(\psi_{2}^{(0)},\psi^{(0)}) + \\ &+ 2\mathcal{E}_{2}^{(0)}(\psi_{1}^{(1)},\psi^{(0)}) + 3\mathcal{E}_{3}^{(0)}(\psi^{(0)},\psi^{(0)},\psi^{(0)}) - \kappa_{1}\mathfrak{H}^{(1)}\psi^{(0)} + \\ &+ \left\{ \mathfrak{L}_{0}^{(1)} + 2\mathcal{E}_{2}^{(0)}(\psi^{(0)},\cdot) \right\} \mathcal{H}_{1}\psi^{(0)} + \mathfrak{L}_{0}\mathcal{H}_{2}\psi^{(0)} \end{split}$$

and in using again (H.4), (H.5), (H.6), and (H.7) we obtain

$$\mathfrak{H}^{(2)}\psi^{(0)} - \mathfrak{H}^{(1)}\mathfrak{L}_{0}^{-1}\mathfrak{H}^{(1)}\psi^{(0)} = -2\mu_{1}\mathfrak{L}_{1}^{(0)}\psi^{(0)} - \mathfrak{L}_{0}(3\psi_{3}^{(0)} + 2\psi_{2}^{(1)} + \psi_{1}^{(2)}) + + \mathfrak{L}_{0}\{\mathcal{H}_{1}(\psi_{1}^{(1)} + 2\psi_{2}^{(0)}) + \mathcal{H}_{2}\psi^{(0)} - \mathcal{H}_{1}^{2}\psi^{(0)}\}.$$

Hence (5.95) leads to

$$@=-2\mu_1 \int_{\mathbb{T}^2} (\mathfrak{L}_1^{(0)} \psi^{(0)}) \psi^{(0)} dY.$$

Since

$$\mathfrak{L}_{1}^{(0)} = -\frac{1}{\mu_{0}^{2}} \partial_{y_{1}}^{2}$$

we finally obtain the result of Lemma 5.8.

## I Fluid particles dynamics

The kinematic and dynamic boundary conditions (1.2, 1.3) give two equations for two unknowns  $\eta$  and  $\psi$ . Assume for the moment that we know  $\eta$  i.e. the free surface  $\Sigma$ . The question is can we restore  $\psi$  without solving PDE equations? The answer is yes: it suffices to solve a problem of moving a heavy single mass point along the free surface, or equivalently to find the corresponding geodesic flow on the surface with an appropriate metric.

Let us begin with the consideration of the motion of a single mass point along the surface  $\Sigma = \{x_3 = \eta(X)\}$ . Assuming that gravity  $\mu$  acts in the  $-e_3 = (0, 0, -1)$  direction we can write the governing equations in the form

$$\ddot{x} + \mu e_3 = \lambda \mathbf{n}, \quad x_3 = \eta(X),$$

where  $\lambda$  is the Lagrange multiplier and  $\mathbf{n}$  is a normal vector to  $\Sigma$ . Choosing components of X as generalized coordinates we rewrite equivalently these equation in the Lagrange form with the Lagrangian

$$\mathbf{L}(X, \dot{X}) = \mathbf{T}(X, \dot{X}) - \mathbf{U}(X) = \frac{1}{2} \mathbb{G}(X) \dot{X} \cdot \dot{X} - \mu \eta(X),$$

where  $\mathbb{G}dX \cdot dX$  is the first fundamental form of the free surface  $\Sigma$  with

$$\mathbb{G}(X) = I + \nabla_X \eta(X) \otimes \nabla_X \eta(X).$$

More precisely, we have

$$\frac{d}{dt}\partial_{\dot{X}}\mathbf{L}(X,\dot{X}) - \partial_{X}\mathbf{L}(X,\dot{X}) = 0.$$

If we define the moments and Hamiltonian by

$$y = \mathbb{G}\dot{X}, \quad \mathbf{H}(X, y) = \frac{1}{2}\mathbb{G}^{-1}y \cdot y + \mu\eta(X),$$

then the governing equations can be rewritten in the Hamilton form

$$\dot{X} = \partial_u \mathbf{H}(X, y), \quad \dot{y} = -\partial_X \mathbf{H}(X, y).$$
 (I.1)

Next, suppose that a  $\mathbb{C}^1$ -generating function S(X) satisfies the Hamilton-Jacobi equation

$$\mathbf{H}(X, \nabla_X S(X)) = h = \text{const} , \qquad (I.2)$$

and the periodicity conditions

$$S(X + 2\pi e_1) - 2\pi = S(X + \frac{2\pi}{\tau}e_2) - \frac{2\pi}{\tau} = S(X).$$
 (I.3)

Suppose also that X(t) is a solution of the equations

$$\dot{X} = \mathbb{G}^{-1}(X)\nabla_X S(X),\tag{I.4}$$

then, it is known that (X(t), y(t)), with  $y(t) = \nabla_X S(X(t))$ , is a solution of the Hamiltonian system (I.1), and the surface  $y = \nabla_X S(X)$  is an invariant manifold of (I.1), the flow being defined by (I.4).

Finally note that due the periodicity conditions, the mapping  $X \to (X, \nabla_X S(X))$  defines an embedding of the torus  $\mathbb{R}^2/\Gamma$  into  $\mathbb{R}^2/\Gamma \times \mathbb{R}^2$ . Therefore,  $\{y = \nabla_X S(X)\}$  is an invariant torus of (I.1) lying on the energy surface H = h. In coordinates X the Hamiltonian flow on the torus is given by (I.4)

Let us turn to the diamond wave problem. Set

$$\varphi^*(x) = \mathbf{u}_0 \cdot X + \varphi(x), \text{ and } \psi^*(X) = \varphi^*(x_1, x_2, \eta(X)),$$

and recall  $|\mathbf{u}_0| = 1$ . In these notations kinematic condition (1.2) and dynamic condition (1.3) can be rewritten in the equivalent form

$$\nabla_X \varphi^*(x_1, x_2, x_3) = \mathbb{G}(X)^{-1} \nabla_X \psi^*(X) \text{ for } x_3 = \eta(X),$$
 (I.5)

$$\frac{1}{2}\mathbb{G}^{-1}\nabla_X\psi^*\cdot\nabla_X\psi^* + \mu\eta = \frac{1}{2}.$$
 (I.6)

By construction the equation  $\dot{x} = \nabla \varphi^*(x)$  determines the trajectories of liquid particles. From (I.5), such a particle moving along the free surface satisfies

$$\dot{X} = G^{-1}(X)\nabla_X \psi^*(X). \tag{I.7}$$

On the other hand, equation (I.6) reads

$$\mathbf{H}(X, \nabla_X \psi^*) = 1/2.$$

Hence  $S(X) = \psi^*(X)$  is a generating function for the Hamiltonian system (I.1). From this we conclude that trajectories of liquid particles X(t), which are defined by  $\dot{X} = \mathbb{G}^{-1}\nabla_X\psi^*(X)$ , along with  $y(t) = \nabla_X S(X(t))$  serve as solutions of (I.1) and belongs to the invariant torus  $\{y = \nabla_X S(X)\}$ . In other words, they coincide with projections  $(X, y) \to X$  of solutions to (I.1) belonging to the invariant torus  $\{y = \nabla \psi^*(X)\} \subset \{\mathbf{H} = 1/2\}$ . Moreover, since by (3.1) we have

 $V = \mathbb{G}^{-1}\nabla_X\psi^*$ , they also coincide with the integral curves of the vector field V

Finally note that, by the Maupertuis principle, the projections  $(X, y) \to X$  of solutions of (I.1) belonging to the energy surface  $\mathbf{H} = 1/2$ , coincide with the geodesics on the manifold  $\Sigma$  endowed with the Jacobi metric

$$ds^{2} = (1/2 - \mu \eta(X)) \mathbb{G}(X) dX \cdot dX \equiv 2(1/2 - \mathbf{U}) \mathbf{T}(X, dX). \tag{I.8}$$

Hence the integral curves of the vector field V form the geodesic flow associated with the metric (I.8).

Corollary I.1 Suppose that  $\eta$  is an arbitrary bi-periodic smooth function so that the hamiltonian system (I.1) has an invariant torus  $\{y = \nabla_X S(X)\}$  with a smooth generating function S(X) satisfying the periodicity conditions (I.3). Then the solution  $\varphi^*$  of the Cauchy problem

$$\varphi^*(x) = S(X), \quad \partial_n \varphi^*(x) = 0 \quad \text{for} \quad x_3 = \eta(X),$$

for the Laplace equation, satisfies kinematic and dynamic conditions (1.2),(1.3). (The local existence of such a solution follows from the Cauchy-Kowalewski theorem, and the existence and boundedness in the lower half plane is true only for the "good" choice of generating function.)
