# A mixed singular/switching control problem for a dividend policy with reversible technology investment

#### Abstract

We consider a mixed stochastic control problem that arises in Mathematical Finance literature with the study of interactions between dividend policy and investment. This problem combines features of both optimal switching and singular control. We prove that our mixed problem can be decoupled in two pure optimal stopping and singular control problems. Furthermore, we describe the form of the optimal strategy by means of viscosity solution techniques and smooth-fit properties on the corresponding system of variational inequalities. Our results are of a quasi-explicit nature. From a financial viewpoint, we characterize situations where a firm manager decides optimally to postpone dividend distribution in order to invest in a reversible growth opportunity corresponding to a modern technology. In this paper, a reversible opportunity means that the firm may disinvest from the modern technology and return back to its old technology by receiving some gain compensation. The results of our analysis take qualitatively different forms depending on the parameters values.

## 1 Introduction

Stochastic optimization problems that involve both bounded variation control and/or optimal switching are becoming timely problems in the applied probability literature and more particulary in Mathematical Finance. On one hand, the study of singular stochastic control problems in corporate Finance originates with the research on optimal dividend policy for a firm whose cash reserve follows a diffusion model, see Jeanblanc and Shiryaev [11] and Choulli, Taksar and Zhou [3]. On the other hand, the combined singular / stopping control problems have emerged in target tracking models, see Davis and Zervos [6] and Karatzas, Ocone, Wang and Zervos [12] as well as in Mathematical Finance from firm investment theory. For instance, Guo and Pham [10] have studied the optimal time to activate production and to control it by buying or selling capital while Zervos [18] has applied this type of mixed problems in the field of real options theory. Finally, the theory of investment under uncertainty for a firm that can operate a production activity in different modes has led to optimal switching problems which have received a lot of attention in recent years from the applied mathematics community, see Brekke and Oksendal [2], Duckworth and Zervos [8], Ly Vath and Pham [13].

In this paper, we consider a combined stochastic control problem that has emerged in a recent paper by Décamps and Villeneuve [5] with the study of the interactions between dividend policy and investment under uncertainty. These authors have studied the interaction between dividend policy and irreversible investment decision in a growth opportunity. Our aim is to extend this work by relaxing the irreversible feature of the growth opportunity. In other words, we shall consider a firm with a technology in place that has the opportunity to invest in a new technology that increases its profitability. The firm self-finances the opportunity cost on its cash reserve. Once installed, the manager can decide to return back to the old technology by receiving some cash compensation. The mathematical formulation of this problem leads to a combined singular control/switching control for a one dimensional diffusion process. The diffusion process may take two regimes old or new that are switched at stopping times decisions. Within a regime, the manager has to choose a dividend policy that maximizes the expected value of all payouts until bankruptcy or regime transition. The transition from one regime to another incurs a cost or a benefit. The problem is to find the optimal mixed strategy that maximizes the expected returns.

Our analysis is rich enough to address several important questions that have arisen recently in the real option literature ${ }^{1}$. What is the effect of financing constraints on investment decision? When is it optimal to postpone dividends distribution in order to invest? Basically, two assumptions in the real option theory are that the investment decision is made independently of the financial structure of the investment firm and also that the cash process generated by the investment is independent of any managerial decision. In contrast, our model studies the investment under uncertainty with the following set of assumptions. The firm is cash constrained and must finance its investments on its cash benefits, and the cash process generated by the investment depends only on the managerial decision to pay or not dividends, to quit or not the project. Our major finding is to characterize the natural

[^1]intuition that the manager will delay dividend payments if the investment is sufficiently valuable.

As usual in stochastic control theory, the problem developed in this paper leads via the dynamic programming principle to a Hamilton Jacobi Bellman equation which forms in this paper a system of coupled variational inequalities. Therefore, a classical approach based on a verification theorem fails since it is very difficult to guess the shape of both the value function and optimal strategy. To circumvent this difficulty, we use a viscosity solution approach and uniqueness result combined with smooth-fit properties for determining the solution to the HJB system. As by product, we also determine the shape of switching regions. Our findings take qualitatively different forms depending on both the profit rates of each technology and transition costs.

The paper is organized as follows. We formulate the combined stochastic control problem in Section 2. In Section 3, we characterize by means of viscosity solutions, the system of variational inequalities satisfied by the value function, and we also state some regularity properties. Section 4 is devoted to qualitative results concerning the switching regions and in Section 5 we give the quasi-explicit computation and description of the value function and the optimal strategies.

## 2 Model formulation : a mixed switching/singular control problem

We consider a firm whose activities generate cash process. The manager of the firm acts in the best interest of its shareholders and maximizes the expected present value of dividends up to bankruptcy when the cash reserve becomes negative. The firm has at any time the possibility to invest in a modern technology that increases the drift of the cash from $\mu_{0}$ to $\mu_{1}$ without affecting the volatility $\sigma$. This growth opportunity requires a fixed cost $g>0$ self-financed by the cash reserve. Moreover, we consider a reversible investment opportunity for the firm : the manager can decide to return back to the old technology by receiving some fixed gain compensation $(1-\lambda) g$, with $0<\lambda<1$.

The mathematical formulation of this mixed singular/switching control problem is as follows. Let $W$ be a Brownian motion on a filtered probability space $\left(\Omega, \mathcal{F}, \mathbb{F}=\left(\mathcal{F}_{t}\right)_{t \geq 0}, \mathbb{P}\right)$ satisfying the usual conditions.

- A strategy decision for the firm is a singular/switching control $\alpha=\left(Z,\left(\tau_{n}\right)_{n \geq 1}\right) \in \mathcal{A}$ where $Z \in \mathcal{Z}$, the set of $\mathbb{F}$-adapted cadlag nondecreasing processes, $Z_{0^{-}}=0,\left(\tau_{n}\right)_{n}$ is an increasing sequence of stopping times, $\tau_{n} \rightarrow \infty . Z$ represents the total amount of dividends paid until time $t,\left(\tau_{n}\right)$ the switching technology (regimes) time decisions. By convention regime $i=0$ represents the old technology and $i=1$ the modern technology.
- Starting from an initial state $(x, i) \in \mathbb{R} \times\{0,1\}$ for the cash-regime value, and given a control $\alpha \in \mathcal{A}$, the dynamics of the cash reserve process of a firm is governed by :

(Here we used the convention $\tau_{0}=0$ ). We denote by $\left(X^{x, i}, I^{i}\right)$ the solution to (2.1)-(2.2) (as usual, we omit the dependance in the control $\alpha$ when there is no ambiguity). The time of strict bankruptcy is defined as

and we set by convention $X_{t}^{x, i}=X_{T}^{x, i}$ for $t \geq T$. Thus, for $t \in\left[T \wedge \tau_{2 n}, T \wedge \tau_{2 n+1}\right)$, the cash reserve $X^{x, i}$ is in technology $i$ (its drift term is $\mu_{i}$ ), while for $t \in\left[T \wedge \tau_{2 n+1}, T \wedge \tau_{2 n+2}\right.$ ), $X^{x, i}$ is in technology $1-i$ (its drift term is $\mu_{1-i}$ ). Moreover,

The optimal firm value is

Here, we used the notation : $\int_{0}^{T^{-}} e^{-\rho t} d Z_{t}=\int_{[0, T)} e^{-\rho t} d Z_{t}$. Notice that $v_{i}$ is nonnegative, and $v_{i}(x)=0$ for $x<0$. Since $T=T^{x, i, \alpha}$ is obviously nondecreasing in $x$, the value functions $v_{i}$ are clearly nondecreasing.

## 3 Dynamic programming and general properties on the value functions

We first introduce some notations. We denote by $R^{x, i}$ the cash reserve in absence of dividends distribution and in regime $i$, i.e. the solution to

The associated second order differential operator is denoted $\mathcal{L}_{i}$ :

In view of the dynamic programming principle, recalled below (see (3.20)), we formally expect that the value functions $v_{i}, i=0,1$, satisfy the system of variational inequalities :

This statement will be proved rigorously later by means of viscosity solutions. For the moment, we first state a standard comparison principle for this system of PDE.

Proposition 3.1 Suppose that $\varphi_{i}, i=0,1$, are two smooth functions on $(0, \infty)$ s.t. $\varphi_{i}\left(0^{+}\right)$ $:=\lim _{x \downarrow 0} \varphi_{i}(x) \geq 0$, and

where we set by convention $\varphi_{i}(x)=0$ for $x<0$. Then, we have $v_{i} \leq \varphi_{i}, i=0,1$.
Proof. Given an initial state-regime value $(x, i) \in(0, \infty) \times\{0,1\}$, take an arbitrary control $\alpha=\left(Z,\left(\tau_{n}\right), n \geq 1\right) \in \mathcal{A}$, and set for $m>0, \theta_{m, n}=\inf \left\{t \geq T \wedge \tau_{2 n}: X_{t}^{x, i} \geq m\right.$ or $X_{t}^{x, i} \leq$ $1 / m\} \nearrow \infty$ a.s. when $m$ goes to infinity. Apply then Itô's formula to $e^{-\rho t} \varphi_{i}\left(X_{t}^{x, i}\right)$ between the stopping times $T \wedge \tau_{2 n}$ and $\tau_{m, 2 n+1}:=T \wedge \tau_{2 n+1} \wedge \theta_{m, n}$. Notice that for $T \wedge \tau_{2 n} \leq t<$ $\tau_{m, 2 n+1}, X_{t}^{x, i}$ stays in regime $i$. Then, we have

where $Z^{c}$ is the continuous part of $Z$. We make the convention that when $T \leq \tau_{n},(T \wedge \theta)^{-}$ $=T$ for all stopping time $\theta>\tau_{n}$ a.s., so that (3.4) holds true a.s. for all $n, m$ (recall that $\varphi_{i}\left(X_{T}^{x, i}\right)=0$ ). Since $\varphi_{i}^{\prime} \geq 1$, we have by the mean-value theorem $\varphi_{i}\left(X_{t}^{x, i}\right)-\varphi_{i}\left(X_{t^{-}}^{x, i}\right)$ $\leq X_{t}^{x, i}-X_{t^{-}}^{x, i}=-\left(Z_{t}-Z_{t^{-}}\right)$for $T \wedge \tau_{2 n} \leq t<\tau_{m, 2 n+1}$. By using also the supersolution inequality of $\varphi_{i}$, taking expectation in the above Itô's formula, and noting that the integrand in the stochastic integral term is bounded by a constant (depending on $m$ ), we have

By sending $m$ to infinity, with Fatou's lemma, we obtain :

Now, as $\varphi_{i}(x) \geq \varphi_{1-i}\left(x-g_{i, 1-i}\right)$ and recalling $X_{T \wedge \tau_{2 n+1}}^{x, i}=X_{\left(T \wedge \tau_{2 n+1}\right)^{-}}^{x, i}-g_{i, 1-i}$ on $\left\{\tau_{2 n+1}<\right.$ $T\}$, we have

Moreover, notice that $\varphi_{i}$ is nonnegative as $\varphi_{i}\left(0^{+}\right) \geq 0$ and $\varphi_{i}^{\prime} \geq 1$. Hence, since $\varphi_{1-i}\left(X_{\left(T \wedge \tau_{2 n+1}\right)}^{x, i}\right)$ $=\varphi_{i-1}\left(X_{T}^{x, i}\right)=0$ on $\left\{T \leq \tau_{2 n+1}\right\}$, we see that inequality (3.6) also holds on $\left\{T \leq \tau_{2 n+1}\right\}$ and so a.s. Therefore, plugging into (3.5), we have

By iterating these two previous inequalities for all $n$, we then obtain

since $\varphi_{i}$ is nonnegative. By sending $n$ to infinity, we obtain the required result from the arbitrariness of the control $\alpha$.

As a corollary, we show a linear growth condition on the value functions.
Corollary 3.1 We have,

Proof. We set $\varphi_{0}(x)=x+\frac{\mu_{1}}{\rho}, \varphi_{1}(x)=x+\frac{\mu_{1}}{\rho}+(1-\lambda) g$, on $(0, \infty)$, and $\varphi_{i}(x)=0$ for $x$ $<0$. A straightforward computation shows that we have the supersolution properties for $\varphi_{i}, i=0,1$ :

We then conclude from Proposition 3.1.
The next result states the initial-boundary data for the value functions.
Proposition 3.2 1) The value function $v_{0}$ is continuous on $(0, \infty)$ and satisfies

Proof. 1) a) We first state (3.8). For $x>0$, let us consider the drifted Brownian $R^{x, 1}$, defined in (3.1), and denote $\theta_{0}=\inf \left\{t \geq 0: R_{t}^{x, 1}=0\right\}$. It is well-known that:

Fix some $r>0$, and denote $\theta_{r}=\inf \left\{t \geq 0: R_{t}^{x, 1}=r\right\}$. It is also well-known that

Let $\alpha=\left(Z,\left(\tau_{n}\right)_{n \geq 1}\right)$ be an arbitrary policy in $\mathcal{A}$, and denote $\eta=T \wedge \theta_{r}=T^{x, 0, \alpha} \wedge \theta_{r}$. Since $\mu_{0}<\mu_{1}$ and $g_{01}>0, g_{01}+g_{10}>0$, we notice that $X_{t}^{x, 0} \leq R_{t}^{x, 1}-Z_{t} \leq R_{t}^{x, 1}$ for all $t$ $\geq 0$. Hence $T \leq \theta_{0}, Z_{t} \leq R_{t}^{x, 1}$ for $t<T$, and in particular $Z_{\eta^{-}} \leq R_{\eta}^{x, 1}$. We then write :

\mathbb{E}\left[\int_{0}^{T^{-}} e^{-\rho t} d Z_{t}\right] & =\mathbb{E}\left[\int_{0}^{\eta^{-}} e^{-\rho t} d Z_{t}\right]+\mathbb{E}\left[1_{T>\eta} \int_{\eta}^{T^{-}} e^{-\rho t} d Z_{t}\right] \\
& \leq \mathbb{E}\left[Z_{\eta^{-}}\right]+\mathbb{E}\left[\mathbb{E}\left[1_{T>\eta} \int_{\eta}^{T^{-}} e^{-\rho t} d Z_{t} \mid \mathcal{F}_{\theta_{r}^{-}}\right]\right] \\
& \leq \mathbb{E}\left[R_{\eta}^{x, 1}\right]+\mathbb{E}\left[1_{T>\theta_{r}} \mathbb{E}\left[\int_{\theta_{r}}^{T^{-}} e^{-\rho t} d Z_{t} \mid \mathcal{F}_{\theta_{r}^{-}}\right]\right] \\
& \leq \mathbb{E}\left[R_{\eta}^{x, 1}\right]+\mathbb{E}\left[1_{T>\theta_{r}} e^{-\rho \theta_{r}} v_{0}\left(X_{\theta_{r}^{-}}^{x, 0}\right)\right] \tag{3.13}
\end{align*}
$$

where we also used in the second inequality the fact that on $\{T>\eta\}, \eta=\theta_{r}$, and $\theta_{r}$ is a predictable stopping time, and in the last inequality the definition of the value function $v_{0}$. Now, since $v_{0}$ is nondecreasing, we have $v_{0}\left(X_{\theta_{r}^{-}}^{x, 0}\right) \leq v_{0}(r)$. Moreover, recalling that $T$ $\leq \theta_{0}$, inequality (3.13) yields

0 \leq v_{0}(x) \leq \mathbb{E}\left[\sup _{0 \leq t \leq \theta_{0}} R_{t}^{x, 1}\right]+v_{0}(r) \mathbb{P}\left[\theta_{0}>\theta_{r}\right] \longrightarrow 0, \quad \text { as } x \downarrow 0, \tag{3.14}
\end{equation*}
$$

from (3.10)-(3.12). This proves $v_{0}\left(0^{+}\right)=0$.
b) We next prove the continuity of $v_{0}$ at any $y>0$. Let $\alpha=\left(Z,\left(\tau_{n}\right)_{n \geq 1}\right) \in \mathcal{A}, X^{y, 0}$ be the corresponding process and $T=T^{y, 0, \alpha}$ its bankruptcy time. According to (3.10) and (3.12), given a fixed $r>0$, for any arbitrary small $\varepsilon>0$, one can find $0<\delta<y$ s.t. for $0<x<\delta$,

Then, following the same lines of proof as for (3.13)-(3.14), we show

\end{equation*}
$$

for any $0<x<\delta$ and stopping time $\theta$ s.t. $X_{\theta}^{y, 0} \leq x$. Given $0<x<\delta$, consider the state process $X^{y-x, 0}$ starting from $y-x$ in regime 0 , and controlled by $\alpha$. Denote $\theta$ its bankruptcy time, i.e. $\theta=T^{y-x, 0, \alpha}=\inf \left\{t \geq 0: X_{t}^{y-x, 0}<0\right\}$. Notice that $X_{t}^{y-x, 0}=$ $X_{t}^{y, 0}-x$ for $t \leq \theta \leq T$, and so

$$

From (3.15), we then have

\mathbb{E}\left[\int_{0}^{T^{-}} e^{-\rho t} d Z_{t}\right] & =\mathbb{E}\left[\int_{0}^{\theta^{-}} e^{-\rho t} d Z_{t}\right]+\mathbb{E}\left[\int_{\theta}^{T^{-}} e^{-\rho t} d Z_{t}\right] \\
& \leq v_{0}(y-x)+\varepsilon
\end{aligned}
$$

From the arbitrariness of $\alpha$, and recalling that $v_{0}$ is nondecreasing, this implies

0 \leq v_{0}(y)-v_{0}(y-x) \leq \varepsilon
$$

which shows the continuity of $v_{0}$.
2) Given an arbitrary control $\alpha=\left(Z,\left(\tau_{n}\right)_{n \geq 1}\right) \in \mathcal{A}$, let us consider the control $\tilde{\alpha}=$ $\left(\tilde{Z},\left(\tilde{\tau}_{n}\right)_{n \geq 1}\right) \in \mathcal{A}$ defined by $\tilde{Z}=Z, \tilde{\tau}_{1}=0, \tilde{\tau}_{n}=\tau_{n-1}, n \geq 2$. Then, for all $x>0$, and by stressing the dependence of the state process on the control, we have $X_{t}^{x, 1, \tilde{\alpha}}=$ $X_{t}^{x+(1-\lambda) g, 0, \alpha}$ for $0 \leq t<T^{x, 1, \tilde{\alpha}}=T^{x+(1-\lambda) g, 0, \alpha}$. We deduce

v_{1}(x) \geq \mathbb{E}\left[\int_{0}^{\left(T^{x, 1, \tilde{\alpha}}\right)^{-}} e^{-\rho t} d \tilde{Z}_{t}\right]=\mathbb{E}\left[\int_{0}^{\left(T^{x+(1-\lambda) g, 0, \alpha}\right)^{-}} e^{-\rho t} d Z_{t}\right]
$$

which implies from the arbitrariness of $\alpha$ :

\begin{equation*}
v_{1}(x) \geq v_{0}(x+(1-\lambda) g), \quad x>0 . \tag{3.16}
\end{equation*}
$$

On the other hand, starting in the regime $i=1$, for $x \geq 0$, let $\alpha=\left(Z,\left(\tau_{n}\right)_{n \geq 1}\right)$ be an arbitrary control in $\mathcal{A}$. We denote $T_{1}=T \wedge \tau_{1}=T^{x, 1, \alpha} \wedge \tau_{1}$, and we write :

The first term in the r.h.s. of (3.17) is dealt similarly as in (3.13)-(3.14) : we set $\eta_{1}=$ $T_{1} \wedge \theta_{r}$ with $\theta_{r}=\inf \left\{t \geq 0: R_{t}^{x, 1}=r\right\}$ for some fixed $r>0$, and we notice that $X_{t}^{x, 1}=$ $R_{t}^{x, 1}-Z_{t} \leq R_{t}^{x, 1}$ for $t<\tau_{1}$. Hence $T_{1} \leq \theta_{0}=\inf \left\{t \geq 0: R_{t}^{x, 1}=0\right\}$, and $Z_{\eta_{1}^{-}} \leq R_{\eta_{1}}^{x, 1} \leq$ $\sup _{0 \leq t \leq \theta_{0}} R_{t}^{x, 1}$. Then, as in (3.13)-(3.14), we have :

For the second term in the r.h.s. of (3.17), since there is a change of regime at $\tau_{1}$ from $i=$ 1 to $i=0$, and by definition of the value function $v_{0}$, we have :

$$

$$
\begin{align*}
& \leq \mathbb{E}\left[1_{T>\tau_{1}} e^{-\rho \tau_{1}} v_{0}\left(X_{\tau_{1}}^{x, 1}\right)\right] \\
& \leq \mathbb{E}\left[1_{T>\tau_{1}} v_{0}\left(X_{\tau_{1}^{\prime}}^{x, 1}+(1-\lambda) g\right)\right] \\
& \leq \mathbb{E}\left[v_{0}\left(\sup _{0 \leq t \leq \theta_{0}} R_{t}^{x, 1}+(1-\lambda) g\right)\right] . \tag{3.19}
\end{align*}
$$

Here, we used in the second inequality the fact that $X_{\tau_{1}}^{x, 1}=X_{\tau_{1}^{-}}^{x, 1}+(1-\lambda) g$ on $\left\{\tau_{1}<T\right\}$, and in the last one the observation that $X_{t}^{x, 1} \leq R_{t}^{x, 1}$ for $t<\tau_{1}$, and $\tau_{1}=T_{1} \leq \theta_{0}$ on $\left\{\tau_{1}<T\right\}$. Hence, by combining (3.16)-(3.17)-(3.18)-(3.19), we obtain :

$$
\begin{aligned}
& v_{0}(x+(1-\lambda) g) \\
\leq & v_{1}(x) \leq \mathbb{E}\left[\sup _{0 \leq t \leq \theta_{0}} R_{t}^{x, 1}\right]+v_{1}(r) \mathbb{P}\left[\theta_{0}>\theta_{r}\right]+\mathbb{E}\left[v_{0}\left(\sup _{0 \leq t \leq \theta_{0}} R_{t}^{x, 1}+(1-\lambda) g\right)\right] .
\end{aligned}
$$

Finally, by using the continuity of $v_{0}$, the limits (3.10)-(3.11)-(3.12), as well as the linear growth condition (3.7) of $v_{0}$, which allows to apply dominated convergence theorem, we conclude that $v_{1}\left(0^{+}\right)=v_{0}((1-\lambda) g)$.

Remark 3.1 There is some asymmetry between the two value functions $v_{0}$ and $v_{1}$. Actually, $v_{0}$ is continuous at $0: v_{0}\left(0^{+}\right)=v_{0}\left(0^{-}\right)=0$, while it is not the case for $v_{1}$, since $v_{1}\left(0^{+}\right)=v_{0}((1-\lambda) g)>0=v_{1}\left(0^{-}\right):$When the reserve process in regime 0 approaches zero, we are ineluctably absorbed by this threshold. On the contrary, in regime 1 , when the reserve process approaches zero, we have the possibility to change of regime, which pushes us above the bankruptcy threshold by receiving $(1-\lambda) g$. In particular, at this stage, we do not know yet the continuity of $v_{1}$ on $(0, \infty)$. This will be proved in Theorem 3.1 as a consequence of the dynamic programming principle. In the sequel, we set by convention $v_{i}(0)=v_{i}\left(0^{+}\right)$for $i=0,1$.

We shall assume that the following dynamic programming principle holds : for any $(x, i)$ $\in \mathbb{R}_{+} \times\{0,1\}$, we have

\begin{align*}
(\mathbf{D P}) v_{i}(x)=\sup _{\alpha \in \mathcal{A}} \mathbb{E} & {\left[\int_{0}^{\left(T \wedge \theta \wedge \tau_{1}\right)^{-}} e^{-\rho t} d Z_{t}\right.} \\
& \left.+e^{-\rho\left(T \wedge \theta \wedge \tau_{1}\right)}\left(v_{i}\left(X_{T \wedge \theta}^{x, i}\right) 1_{T \wedge \theta<\tau_{1}}+v_{1-i}\left(X_{\tau_{1}}^{x, i}\right) 1_{\tau_{1} \leq T \wedge \theta}\right)\right] \tag{3.20}
\end{align*}
$$

where $\theta$ is any stopping time, possibly depending on $\alpha \in \mathcal{A}$ in (3.20).
We then have the PDE characterization of the value functions $v_{i}$.
Theorem 3.1 The value functions $v_{i}, i=0,1$, are continuous on $(0, \infty)$, and are the unique viscosity solutions with linear growth condition on $(0, \infty)$ and boundary data $v_{0}(0)$ $=0, v_{1}(0)=v_{0}((1-\lambda) g)$ to the system of variational inequalities :

\min \left[\rho v_{i}(x)-\mathcal{L}_{i} v_{i}(x), v_{i}^{\prime}(x)-1, v_{i}(x)-v_{1-i}\left(x-g_{i, 1-i}\right)\right]=0, x>0, i=0,1(3.21)
$$

Actually, we prove some more regularity results on the value functions.

Proposition 3.3 The value functions $v_{i}, i=0,1$, are $C^{1}$ on $(0, \infty)$. Moreover, if we set for $i=0,1$ :

\begin{aligned}
\mathcal{S}_{i} & =\left\{x \geq 0: v_{i}(x)=v_{1-i}\left(x-g_{i, 1-i}\right)\right\} \\
\mathcal{D}_{i} & =\left\{x>0: v_{i}^{\prime}(x)=1\right\}, \\
\mathcal{C}_{i} & =(0, \infty) \backslash\left(\mathcal{S}_{i} \cup \mathcal{D}_{i}\right),
\end{aligned}
$$

then $v_{i}$ is $C^{2}$ on the open set $\mathcal{C}_{i} \cup \operatorname{int}\left(\mathcal{D}_{i}\right)$ of $(0, \infty)$, and we have in the classical sense

$$
\rho v_{i}(x)-\mathcal{L}_{i} v_{i}(x)=0, \quad x \in \mathcal{C}_{i} .
$$

Remark 3.2 From the variational inequality (3.21), and since the value functions $v_{i}, i$ $=0,1$, are $C^{1}$ on $(0, \infty)$, we have $v_{i}^{\prime} \geq 1$, which implies in particular that $v_{i}$ is strictly increasing on $(0, \infty)$.

The proofs of Theorem 3.1 and Proposition 3.3 follow and combine essentially arguments from [10] for singular control, and [14] for switching control, and are postponed to Appendix A and B .
$\mathcal{S}_{i}$ is the switching region from technology $i$ to $1-i, \mathcal{D}_{i}$ is the dividend region in technology $i$, and $\mathcal{C}_{i}$ is the continuation region in technology $i$. Notice from the boundary conditions on $v_{i}$ that $\mathcal{S}_{i}$ may contain 0 . We denote $\mathcal{S}_{i}^{*}=\mathcal{S}_{i} \backslash\{0\}$.

## 4 Qualitative results on the switching regions

### 4.1 Benchmarks

We consider the firm value without investment/disinvestment in technology $i=0$ :

$$
\begin{equation*}
\hat{V}_{0}(x)=\sup _{Z \in \mathcal{Z}} \mathbb{E}\left[\int_{0}^{T_{0}^{-}} e^{-\rho t} d Z_{t}\right], \tag{4.1}
\end{equation*}
$$

where $T_{0}=\inf \left\{t \geq 0: X_{t} \leq 0\right\}$ is the time bankruptcy of the cash reserve in regime $0:$

d X_{t}=\mu_{0} d t+\sigma d W_{t}-d Z_{t}, \quad X_{0^{-}}=x .
$$

By convention, we set $\hat{V}_{0}(x)=0$ for $x<0$. It is known that $\hat{V}_{0}$, as the value function of a pure singular control problem, is characterized as the unique continuous viscosity solution on $(0, \infty)$, with linear growth condition to the variational inequality :

\begin{equation*}
\min \left[\rho \hat{V}_{0}-\mathcal{L}_{0} \hat{V}_{0}, \hat{V}_{0}^{\prime}-1\right]=0, \quad x>0 \tag{4.2}
\end{equation*}
$$

and boundary data

$$
\hat{V}_{0}(0)=0 .
$$

Actually, $\hat{V}_{0}$ is $C^{2}$ on $(0, \infty)$ and explicit computations of this standard singular control problem are developed in Shreve, Lehoczky and Gaver [16], Jeanblanc and Shiryaev [11], or Radner and Shepp [15] :

\hat{V}_{0}(x)=\left\{\begin{array}{cc}
\frac{f_{0}(x)}{f_{0}^{\prime}\left(\hat{x}_{0}\right)} & , 0 \leq x \leq \hat{x}_{0} \\
x-\hat{x}_{0}+\frac{\mu_{0}}{\rho}, & x \geq \hat{x}_{0}
\end{array}\right.
$$

where

$$
f_{0}(x)=e^{m_{0}^{+} x}-e^{m_{0}^{-} x}, \quad \hat{x}_{0}=\frac{1}{m_{0}^{+}-m_{0}^{-}} \ln \left(\frac{\left(m_{0}^{+}\right)^{2}}{\left(m_{0}^{-}\right)^{2}}\right),
$$

and $m_{0}^{-}<0<m_{0}^{+}$are roots of the characteristic equation :

\rho-\mu_{0} m-\frac{1}{2} \sigma^{2} m^{2}=0 .
$$

In other words, this means that the optimal cash reserve process is given by the reflected diffusion process at the threshold $\hat{x}_{0}$ with an optimal dividend process given by the local time at this boundary. When the firm starts with a cash reserve $x \geq \hat{x}_{0}$, the optimal dividend policy is to distribute immediately the amount $x-\hat{x}_{0}$ and then follows the dividend policy characterized by the local time.

As a second benchmark, we consider the firm value problem in technology $i=1$ with nonnegative constant liquidation value $L$ to be fixed later :

$$

$T_{1}=\inf \left\{t \geq 0: X_{t} \leq 0\right\}$ is the time bankruptcy of the cash reserve in regime 1:

d X_{t}=\mu_{1} d t+\sigma d W_{t}-d Z_{t}, \quad X_{0^{-}}=x
$$

By convention, we set $w_{1}^{L}(x)=0$ for $x<0$. Again, as value function of a pure singular control problem, $w_{1}^{L}$ is characterized as the unique continuous viscosity solution on $(0, \infty)$, with linear growth condition to the variational inequality :

$$
\begin{equation*}
\min \left[\rho w_{1}^{L}-\mathcal{L}_{1} w_{1}^{L},\left(w_{1}^{L}\right)^{\prime}-1\right]=0, \quad x>0 \tag{4.3}
\end{equation*}
$$

and boundary data

$$
\begin{equation*}
w_{1}^{L}(0)=L \tag{4.4}
\end{equation*}
$$

Actually, $w_{1}^{L}$ is $C^{2}$ on $(0, \infty)$ and explicit computations of this singular control problem are developed in Boguslavskaya [1] :

- If $L \geq \frac{\mu_{1}}{\rho}$, then :

w_{1}^{L}(x)=x+L, \quad x \geq 0
$$

The optimal strategy is to distribute the initial cash reserve immediately, and so to liquidate the firm at $X_{t}=0$ by changing of technology to regime $i=0$ and receiving $L$.

- If $L<\frac{\mu_{1}}{\rho}$, then

x-x_{1}^{L}+\frac{\mu_{1}}{\rho}, & x \geq x_{1}^{L},
\end{array}\right.
$$

with

$$
f_{1}(x)=e^{m_{1}^{+} x}-e^{m_{1}^{-} x}, \quad h_{1}(x)=e^{m_{1}^{-} x}
$$

$m_{1}^{-}<0<m_{1}^{+}$, the roots of the characteristic equation :

$$
\rho-\mu_{1} m-\frac{1}{2} \sigma^{2} m^{2}=0,
$$

and $x_{1}^{L}$ the solution to

$$
\begin{equation*}
L \frac{h_{1}(x) f_{1}^{\prime}(x)-h_{1}^{\prime}(x) f_{1}(x)}{f_{1}^{\prime}(x)}+\frac{f_{1}(x)}{f_{1}^{\prime}(x)}=\frac{\mu_{1}}{\rho} . \tag{4.6}
\end{equation*}
$$

The optimal cash reserve process is given by the reflected diffusion process at the threshold $x_{1}^{L}$ with an optimal dividend process given by the local time at this boundary. When the firm starts with a cash reserve $x \geq x_{1}^{L}$, the optimal dividend policy is to distribute immediately the amount $x-x_{1}^{L}$ and then follows the dividend policy characterized by the local time. In the sequel, we shall denote

$$
\hat{V}_{1}=w_{1}^{L} \quad \text { and } \quad \hat{x}_{1}=x_{1}^{L} \quad \text { when } \quad L=\hat{V}_{0}((1-\lambda) g) .
$$

$L=\hat{V}_{0}((1-\lambda) g)$ is the minimal received liquidation value when one switches to regime 0 at $x=0$ and do not switch anymore.

Remark 4.1 It is known (see e.g.[1]) that $\hat{V}_{0}$ and $w_{1}^{L}$ are concave on $(0, \infty)$. As a consequence, $\hat{V}_{0}$ and $w_{1}^{L}$ are globally Lipschitz since their first derivatives are bounded near zero.

Remark 4.2 We have $v_{0} \geq \hat{V}_{0}$ and $v_{1} \geq \hat{V}_{1}$ on $(0, \infty)$. This is rather clear since the class of controls over which maximization is taken in $\hat{V}_{0}$ and $\hat{V}_{1}$ is included in the class of controls of $v_{0}$ and $v_{1}$. This may be justified more rigorously by a maximum principle argument and by noting that $v_{0}$ and $v_{1}$ are (viscosity) supersolution to the variational inequality satisfied respectively by $\hat{v}_{0}$ and $\hat{V}_{1}$, with the same boundary data.

We first show the intuitive result that the value function for the dividend policy problem is nondecreasing in the rate of return of the cash reserve.

## Lemma 4.1

$$
\hat{V}_{1}(x) \geq \hat{V}_{0}(x+(1-\lambda) g), \quad \forall x \geq 0
$$

Proof. We set $w_{1}(x)=\hat{V}_{1}(x-(1-\lambda) g)$ for $x \geq(1-\lambda) g$. From (4.3), we see that $\hat{w}_{1}$ satisfies on $[(1-\lambda) g, \infty)$ :

\left(\rho w_{1}-\mathcal{L}_{0} w_{1}\right)(x) & =\left(\rho-\mathcal{L}_{1} \hat{V}_{1}+\left(\mu_{1}-\mu_{0}\right) \hat{V}_{1}^{\prime}\right)(x-(1-\lambda) g)>0
\end{aligned}
$$

since $\mu_{1}>\mu_{0}$ and $\hat{V}_{1}$ is increasing. Moreover, $w_{1}((1-\lambda) g)=\hat{V}_{1}(0)=\hat{V}_{0}((1-\lambda) g)$. By standard maximum principle on the variational inequality (4.2), we deduce that $w_{1} \geq \hat{V}_{0}$ on $[(1-\lambda) g, \infty)$, which implies the required result.

The next result precises conditions under which the value function in the old technology is larger than the value function in the modern technology after paying the switching cost from the old to the modern regimes.

Lemma 4.2 Suppose that $\hat{V}_{0}((1-\lambda) g)<\frac{\mu_{1}}{\rho}$. Then,

\hat{V}_{0}(x) \geq \hat{V}_{1}(x-g), \quad \forall x \geq 0, \quad \text { if and only if } \quad \frac{\mu_{1}-\mu_{0}}{\rho} \leq \hat{x}_{1}+g-\hat{x}_{0} .

Proof. Similar arguments as in Lemma 2.1 in Decamps and Villeneuve [5].
Remark 4.3 Recalling that $\hat{V}_{0}$ and $\hat{V}_{1}$ are increasing and concave, the above Lemma shows also that if $\frac{\mu_{1}-\mu_{0}}{\rho}>\hat{x}_{1}+g-\hat{x}_{0}$, then there exists $\hat{x}_{01} \geq g$ s.t.

$$
\max \left(\hat{V}_{0}(x), \hat{V}_{1}(x-g)\right)=\left\{\begin{array}{cc}
\hat{V}_{0}(x), & x \leq \hat{x}_{01} \\
\hat{V}_{1}(x-g), & x>\hat{x}_{01}
\end{array}\right.
$$

### 4.2 Preliminary results on the switching regions

In this section, we shall state some preliminary qualitative results concerning the switching regions.

Lemma 4.3 If $x \in \mathcal{S}_{i}$ then $x-g_{i, 1-i} \notin \mathcal{S}_{1-i}$.
Proof. Since $v_{i}(x)>v_{i}(x-\lambda g)$ for every $x>0$ and $i \in\{0,1\}$, we have for $x \in \mathcal{S}_{i}$,

$$
v_{1-i}\left(x-g_{i, 1-i}\right)=v_{i}(x)>v_{i}(x-\lambda g)=v_{i}\left(x-g_{i, 1-i}-g_{1-i, i}\right) .
$$

Therefore, $x-g_{i, 1-i} \notin \mathcal{S}_{1-i}$ for $x \in \mathcal{S}_{i}$.
Let us recall the notation $\mathcal{S}_{i}^{*}=\mathcal{S}_{i} \backslash\{0\}$. We have the following inclusion :
Lemma 4.4 $\mathcal{S}_{1}^{*} \subset \mathcal{D}_{1}$.
Proof. We make a proof by contradiction by assuming that there exists some $x \in \mathcal{S}_{1}^{*} \backslash \mathcal{D}_{1}$. According to Proposition 3.3, we have $v_{0}^{\prime}(x+(1-\lambda) g)=v_{1}^{\prime}(x)>1$, and so $x+(1-\lambda) g$ $\notin \mathcal{D}_{0}$. Applying Lemma 4.3 with $i=1$ implies $x+(1-\lambda) g \in \mathcal{C}_{0}$. Therefore,

$$
\begin{aligned}
\rho v_{1}(x)-\mathcal{L}_{1} v_{1}(x) & =\rho v_{1}(x)-\mathcal{L}_{0} v_{1}(x)+\left(\mu_{0}-\mu_{1}\right) v_{1}^{\prime}(x) \\
& =\rho v_{0}(x+(1-\lambda) g)-\mathcal{L}_{0} v_{0}(x+(1-\lambda) g)+\left(\mu_{0}-\mu_{1}\right) v_{1}^{\prime}(x) \\
& =\left(\mu_{0}-\mu_{1}\right) v_{1}^{\prime}(x) \quad \text { since } x+(1-\lambda) g \in \mathcal{C}_{0} \\
& <0,
\end{aligned}
$$

which contradicts Theorem 3.1.
We now introduce the following definition.
Definition 4.1 y is a left boundary of the closed set $\mathcal{D}_{i}$ if there is some $\delta>0$ such that $y-\varepsilon$ does not belong to $\mathcal{D}_{i}$ for every $0<\varepsilon<\delta$.

Lemma 4.5 Let $y>0$ be a left boundary of $\mathcal{D}_{i}$.

- If there is some $\varepsilon>0$ such that $(y-\varepsilon, y) \subset \mathcal{C}_{i}$, then $v_{i}(y)=\frac{\mu_{i}}{\rho}$.
- If not, $v_{i}(y)=\frac{\mu_{1-i}}{\rho}$.

Proof. Since $y$ is a left boundary of $\mathcal{D}_{i}$, there is some $\varepsilon>0$ such that $(y-\varepsilon, y) \subset \mathcal{C}_{i} \cup \mathcal{S}_{i}$. Therefore, two cases have to be considered.
$\star$ Case 1: If $(y-\varepsilon, y) \subset \mathcal{C}_{i}$. Then, according to Proposition 3.3, $v_{i}$ is twice differentiable at $x$, for $y-\varepsilon<x<y$ and satisfies $v_{i}^{\prime}(x)=1$ and $v_{i}^{\prime \prime}(x)=0$. Therefore, we have

$$
0=\rho v_{i}(x)-\mathcal{L}_{i} v_{i}(x)=\rho v_{i}(x)-\mu_{i} v_{i}^{\prime}(x)-\frac{\sigma^{2}}{2} v_{i}^{\prime \prime}(x) .
$$

By sending $x$ to $y$, we obtain that $v_{i}(y)=\frac{\mu_{i}}{\rho}$.

* Case 2: If not, there is an increasing sequence $\left(y_{n}\right)_{n}$ valued in $\mathcal{S}_{i}$, and converging to $y$ which therefore belongs to $\mathcal{S}_{i}$. We then have $v_{i}\left(y_{n}\right)=v_{1-i}\left(y_{n}-g_{i, 1-i}\right)$ and also $v_{i}^{\prime}\left(y_{n}\right)>1$ for $n$ great enough since $y$ is a left boundary of $\mathcal{D}_{i}$. Thus, $y_{n}-g_{i, 1-i} \notin \mathcal{D}_{1-i}$. Moreover, according to Lemma 4.3, we also have $y_{n}-g_{i, 1-i} \notin \mathcal{S}_{1-i}$ and therefore, $y_{n}-g_{i, 1-i} \in \mathcal{C}_{1-i}$ or equivalently

$$
\rho v_{1-i}\left(y_{n}-g_{i, 1-i}\right)-\mathcal{L}_{1-i} v_{1-i}\left(y_{n}-g_{i, 1-i}\right)=0 .
$$

By letting $n$ tends to $\infty$, we obtain $v_{1-i}\left(y-g_{i, 1-i}\right)=\frac{\mu_{1-i}}{\rho}$. Since $y \in \mathcal{S}_{i}$, this implies $v_{i}(y)=v_{1-i}\left(y-g_{i, 1-i}\right)=\frac{\mu_{1-i}}{\rho}$.

The next result shows that the switching region from modern technology $i=1$ to the old technology $i=0$ is either reduced to the zero threshold or to the entire state reserve domain $\mathbb{R}_{+}$, depending on the gain $(1-\lambda) g$ for switching from regime 1 to regime 0 .

Proposition 4.1 The two following cases arise:
(i) If $v_{0}((1-\lambda) g)<\frac{\mu_{1}}{\rho}$ then $\mathcal{S}_{1}=\{0\}$.
(ii) If $v_{0}((1-\lambda) g) \geq \frac{\mu_{1}}{\rho}$ then $\mathcal{S}_{1}=\mathcal{D}_{1}=\mathbb{R}_{+}$.

Proof. (i) Assume $v_{0}((1-\lambda) g)<\frac{\mu_{1}}{\rho}$.
We shall make a proof by contradiction by considering the existence of some $x_{0} \in S_{1}^{*}$. By Lemma 4.4, one can introduce the finite nonnegative number

$$
\underline{\mathrm{x}}=\inf \left\{y>0:\left[y, x_{0}\right] \subset \mathcal{D}_{1}\right\} .
$$

Hence, $\underline{x}$ is a left boundary of $\mathcal{D}_{1}$. Moreover, Lemma 4.5 gives $v_{1}(\underline{x})=\frac{\mu_{1}}{\rho}$ or $\frac{\mu_{0}}{\rho}$.

1. We first check that $\underline{x}>0$. If not, we would have: $v_{1}(y)=y+v_{0}((1-\lambda) g)$ for any $0<y<x_{0}$. But, in this case, we have for $0<y<x_{0}$,

$$
\rho v_{1}(y)-\mathcal{L}_{1} v_{1}(y)=\rho\left(y+v_{0}((1-\lambda) g)\right)-\mu_{1} .
$$

Therefore, under the assumption (i), $\rho v_{1}(y)-\mathcal{L}_{1} v_{1}(y)<0$ for $y$ small enough which is a contradiction.
2. We now prove that $v_{1}(\underline{\mathrm{x}})=\frac{\mu_{1}}{\rho}$. To see this, we shall show that the closed set $\mathcal{D}_{1}$ is an interval of $\mathbb{R}_{+}$. Let $a, b \in \mathcal{D}_{1}$ with $a<b$, we want to show that $(a, b) \subset \mathcal{D}_{1}$. If not, from Lemma 4.4, we can find a subinterval $(c, d)$ with $c, d \in \mathcal{D}_{1}$ and $(c, d) \subset \mathcal{C}_{1}$. But, for $c<x<d$, we have

$$
0=\rho v_{1}(x)-\mathcal{L}_{1} v_{1}(x)=\rho v_{1}(x)-\mu_{1} v_{1}^{\prime}(x)-\frac{\sigma^{2}}{2} v_{1}^{\prime \prime}(x) .
$$

By sending $x$ to $c$ and $d$, we obtain that $v_{1}(c)=v_{1}(d)=\frac{\mu_{1}}{\rho}$ which contradicts the fact that $v_{1}$ is strictly increasing. Since $\mathcal{D}_{1}$ is an interval of $\mathbb{R}_{+}$, we have $\underline{x}=\inf \mathcal{D}_{1}$. Thus, recalling that $\underline{x}>0$, we can find from Lemma 4.4, some $\varepsilon>0$ such that $(\underline{\mathrm{x}}-\varepsilon, \underline{\mathrm{x}}) \subset \mathcal{C}_{1}$, and deduce from Lemma 4.5 that $v_{1}(\underline{\mathrm{x}})=\frac{\mu_{1}}{\rho}$.
3. We now introduce

$$
\bar{x}=\inf \left\{y \geq \underline{\mathrm{x}} \mid y \in \mathcal{S}_{1}\right\} .
$$

Observe that $\bar{x}+(1-\lambda) g \in \mathcal{D}_{0}$. Moreover, according to Lemma 4.3, $\bar{x}+(1-\lambda) g \notin \mathcal{S}_{0}$ and thus a left neighbourhood of $\bar{x}+(1-\lambda) g$ belongs to $\mathcal{C}_{0}$. We first prove that $\bar{x}+(1-\lambda) g$ cannot be a left boundary of $\mathcal{D}_{0}$. On the contrary, we would have from Lemma 4.5,

$$
v_{1}(\bar{x})=v_{0}(\bar{x}+(1-\lambda) g)=\frac{\mu_{0}}{\rho}<\frac{\mu_{1}}{\rho}=v_{1}(\underline{\mathrm{x}})
$$

which contradicts the fact that $v_{1}$ is increasing. Therefore, $\bar{x}+(1-\lambda) g \in \stackrel{o}{\mathcal{D}}_{0}$, and we can find $y<\bar{x}$ such that $y+(1-\lambda) g$ is a left boundary of $\mathcal{D}_{0}$. Hence,

$$
v_{1}(\bar{x})=v_{0}(\bar{x}+(1-\lambda) g)=\bar{x}-y+v_{0}(y+(1-\lambda) g) \leq \bar{x}-y+v_{1}(y)
$$

Since the reverse inequality is always true, we obtain that $y \in \mathcal{S}_{1}$ which contradicts the definition of $\bar{x}$. We conclude that $\bar{x}$ cannot be strictly positive, which is a contradiction with the first step. This proves finally that $x_{0} \in \mathcal{S}_{1}^{*}$.
(ii) Assume that $v_{0}((1-\lambda) g) \geq \frac{\mu_{1}}{\rho}$. Let $y$ be a left boundary of $\mathcal{D}_{1}$. We shall prove that $y$ necessarily equals zero. If not, according to Lemma $4.5, v_{1}(y) \leq \frac{\mu_{1}}{\rho} \leq v_{1}(0)$ where the second inequality comes from the hypothesis and (3.9). Since the function $v_{1}$ is strictly increasing, we get the desired contradiction. Therefore, $\mathcal{D}_{1}=[0, a]$. It remains to prove that $a$ is infinite. From Lemma 4.4, the open set $(a, \infty)$ belongs to $\mathcal{C}_{1}$ if $a<\infty$. Using the regularity of $v_{1}$ on $\mathcal{C}_{1}$, we get by the same reasoning as in the proof of Lemma 4.5 that $v_{1}(a)=\frac{\mu_{1}}{\rho}$, which gives the same contradiction as before. Hence, $\mathcal{D}_{1}=[0, \infty)$. We then have for any $x>0$,

$$
v_{1}(x)=x+v_{0}((1-\lambda) g) \leq v_{0}(x+(1-\lambda) g)
$$

Since the reverse inequality is always true by definition, we conclude that $\mathcal{S}_{1}=[0, \infty)$.
The next proposition describes the structure of the switching region from technology $i$ $=0$ to $i=1$, in the case where the growth rate $\mu_{1}$ in the modern technology $i=1$, is large enough.

Proposition 4.2 Suppose that

$$
\frac{\mu_{1}-\mu_{0}}{\rho}>\hat{x}_{1}+g-\hat{x}_{0}, \quad \text { and } \quad \hat{V}_{0}((1-\lambda) g)<\frac{\mu_{1}}{\rho} .
$$

Then, there exists $x_{01}^{*} \in[g, \infty)$ s.t.

$$
\mathcal{S}_{0}^{*}=\left[x_{01}^{*}, \infty\right)
$$

Proof. We first notice that $\mathcal{S}_{0}^{*} \neq \emptyset$. On the contrary, we would have $v_{0}=\hat{V}_{0}$, and so $\hat{V}_{0}(x)$ $\geq v_{1}(x-g) \geq \hat{V}_{1}(x-g)$ for all $x$, which is in contradiction with Lemma 4.2. Moreover, since $v_{1}(x-g)=v_{0}(x)>0$ for all $x \in \mathcal{S}_{0}^{*}$, we deduce that $\mathcal{S}_{0}^{*} \subset[g, \infty)$ and so

$$
x_{01}^{*}:=\inf \mathcal{S}_{0}^{*} \in[g, \infty) .
$$

Let us now consider the function

$$
w_{0}(x)=\left\{\begin{array}{cc}
v_{0}(x), & x<x_{01}^{*} \\
v_{1}(x-g), & x \geq x_{01}^{*} .
\end{array}\right.
$$

We claim that $w_{0}$ is a viscosity solution, with linear growth condition and boundary data $w_{0}\left(0^{+}\right)=0$, to

$$
\min \left[\rho w_{0}(x)-\mathcal{L}_{0} w_{0}(x), w_{0}^{\prime}(x)-1, w_{0}(x)-v_{1}(x-g)\right]=0, x>0
$$

For $x<x_{01}^{*}$, this is clear since $w_{0}=v_{0}$ on $\left(0, x_{01}^{*}\right)$. For $x>x_{01}^{*}$, we see that $w_{0}^{\prime} \geq 1$ and

$$
\begin{aligned}
\rho w_{0}-\mathcal{L}_{0} w_{0} & =\left(\rho v_{1}-\mathcal{L}_{1} v_{1}+\left(\mu_{1}-\mu_{0}\right) v_{1}^{\prime}\right)(x-g) \\
& \geq\left(\mu_{1}-\mu_{0}\right) v_{1}^{\prime}(x-g) \geq 0
\end{aligned}
$$

Hence, the viscosity property is also satisfied for $x>x_{01}^{*}$. It remains to check the viscosity property for $x=x_{01}^{*}$. The viscosity subsolution property at $x_{01}^{*}$ is trivial since $w_{0}\left(x_{01}^{*}\right)=$
$v_{1}\left(x_{01}^{*}-g\right)$. For the viscosity supersolution property, take some $C^{2}$ test function $\varphi$ s.t. $x_{01}^{*}$ is a local minimum of $w_{0}-\varphi$. From the smooth-fit condition of the value function $v_{0}$ at the switching boundary, it follows that $w_{0}$ is $C^{1}$ at $x_{01}^{*}$. Hence $w_{0}^{\prime}\left(x_{01}^{*}\right)=\varphi^{\prime}\left(x_{01}^{*}\right)$. Moreover, since $w_{0}=v_{0}$ is $C^{2}$ for $x<x_{01}^{*}$, we also have $\varphi^{\prime \prime}\left(x_{01}^{*}\right) \leq w_{0}^{\prime \prime}\left(x_{01}^{*-}\right):=\lim _{x} \nearrow x_{01}^{*} w^{\prime \prime}(x)$. Since $\rho w_{0}(x)-\mathcal{L}_{0} w_{0}(x) \geq 0$ for $x<x_{01}^{*}$, we deduce by sending $x$ to $x_{01}^{*}$ :

$$
\rho w_{0}\left(x_{01}^{*}\right)-\mathcal{L}_{0} \varphi\left(x_{01}^{*}\right) \geq 0
$$

This implies the required viscosity supersolution inequality at $x=x_{01}^{*}$. By uniqueness, we conclude that $w_{0}=v_{0}$, which proves that $\mathcal{S}_{0}^{*}=\left[x_{01}^{*}, \infty\right)$.

## 5 Main result and description of the solution

We give an explicit description of the structure of the solution to our control problem, which depends crucially on parameter values.

### 5.1 The case : $\hat{V}_{0}((1-\lambda) g) \geq \frac{\mu_{1}}{\rho}$

Theorem 5.1 Suppose that $\hat{V}_{0}((1-\lambda) g) \geq \frac{\mu_{1}}{\rho}$. Then, we have $v_{0}(x)=\hat{V}_{0}(x)$ and $v_{1}(x)=$ $\hat{V}_{0}(x+(1-\lambda) g)=x+(1-\lambda) g-x_{0}+\frac{\mu_{0}}{\rho}$. It is optimal to never switch from regime 0 to regime 1. In regime 1, it is optimal to distribute all the surplus as dividends and to switch to regime 0 .

Proof. Under the condition of the theorem, and since $v_{0} \geq \hat{V}_{0}$, we have $v_{0}((1-\lambda) g) \geq \frac{\mu_{1}}{\rho}$. By Proposition 4.1, this implies $\mathcal{S}_{1}=\mathcal{D}_{1}=\mathbb{R}_{+}$. Recalling also the boundary data $v_{1}(0)=$ $v_{0}((1-\lambda) g)$, we get $v_{1}(x)=x+v_{0}((1-\lambda) g)$ for $x \geq 0$. We next prove that the region $\mathcal{S}_{0}^{*}$ is empty. To see this, we have to prove that for $x \geq g, v_{0}(x) \geq v_{1}(x-g)$. Let us consider for $x \geq g$ the function $\theta(x)=v_{0}(x)-\left(x-g+v_{0}((1-\lambda) g)\right)$. Since $\lambda>0$, we have $\theta(g)>0$. Moreover, $\theta^{\prime}(x)=v_{0}^{\prime}(x)-1 \geq 0$. Thus, $\theta(x)>0$ for $x \geq g$ which is equivalent to $\mathcal{S}_{0}^{*}=\emptyset$. As a consequence, $v_{0}$ is a smooth solution of the variational inequality

$$
\min \left[\rho v(x)-\mathcal{L}_{0} v(x), v^{\prime}(x)-1\right]=0
$$

with initial condition $v(0)=0$. By uniqueness, we deduce that $v_{0}=\hat{V}_{0}$. To close the proof, it suffices to note that $\hat{V}_{0}((1-\lambda) g) \geq \frac{\mu_{1}}{\rho}$ implies that $(1-\lambda) g \geq \hat{x}_{0}$. Therefore, $v_{0}((1-\lambda) g)$ $=(1-\lambda) g-x_{0}+\frac{\mu_{0}}{\rho}$.

### 5.2 The case : $\hat{V}_{0}((1-\lambda) g)<\frac{\mu_{1}}{\rho}$

First observe that in this case, we have

$$
v_{0}((1-\lambda) g)<\frac{\mu_{1}}{\rho}
$$

Indeed, on the contrary, from Theorem 5.1, we would get $v_{0}=\hat{V}_{0}$, and so an obvious contradiction $\hat{V}_{0}((1-\lambda) g) \geq \frac{\mu_{1}}{\rho}$ with the considered case. From Proposition 4.1, we then have $\mathcal{S}_{1}=\{0\}$ so that $v_{1}$ is the unique viscosity solution to

$$
\min \left[\rho v_{1}-\mathcal{L}_{1} v_{1}, v_{1}^{\prime}-1\right]=0, \quad x>0
$$

with the boundary data $v_{1}(0)=v_{0}((1-\lambda) g)$. Therefore, $v_{1}$ is the firm value problem in technology $i=1$ with liquidation value $v_{0}((1-\lambda) g)$ :

$$
\begin{equation*}
v_{1}(x)=\sup _{Z \in \mathcal{Z}} \mathbb{E}\left[\int_{0}^{T_{1}^{-}} e^{-\rho t} d Z_{t}+e^{-\rho T_{1}} v_{0}((1-\lambda) g)\right], \tag{5.1}
\end{equation*}
$$

The form of $v_{1}$ is described in (4.5) with liquidation value $L=v_{0}((1-\lambda) g)$ : we denote $x_{1}$ $=x_{1}^{L}$ the corresponding threshold.

Remark 5.1 Since $v_{1}$ and $\hat{V}_{1}$ are increasing with $v_{1}\left(x_{1}\right)=\hat{V}_{1}\left(\hat{x}_{1}\right)=\frac{\mu_{1}}{\rho}$, we have $x_{1} \leq \hat{x}_{1}$.
Notice that the expression of $v_{1}$ is not completely explicit since we do not know at this stage the liquidation value $v_{0}((1-\lambda) g)$. The next result give an explicit solution when

$$
\frac{\mu_{1}-\mu_{0}}{\rho} \leq \hat{x}_{1}+g-\hat{x}_{0} .
$$

Theorem 5.2 Suppose that

$$
\begin{equation*}
\hat{V}_{0}((1-\lambda) g)<\frac{\mu_{1}}{\rho} \leq \frac{\mu_{0}}{\rho}+\hat{x}_{1}+g-\hat{x}_{0} . \tag{5.2}
\end{equation*}
$$

Then $v_{0}=\hat{V}_{0}$ and $v_{1}=\hat{V}_{1}$. It is never optimal, once in regime $i=0$, to switch to regime $i=1$. In regime 1 , it is optimal to switch to regime 0 at the threshold $x=0$.

Proof. From Lemma 4.1 and Lemma 4.2, and recalling the variational inequalities (4.2) and (4.3), we see that $\hat{V}_{0}$ and $\hat{V}_{1}$ are viscosity solutions to

$$
\begin{aligned}
\min \left[\rho \hat{V}_{0}(x)-\mathcal{L}_{0} \hat{V}_{0}(x), \hat{V}_{0}^{\prime}(x)-1, \hat{V}_{0}(x)-\hat{V}_{1}(x-g)\right] & =0, \quad x>0, \\
\min \left[\rho \hat{V}_{1}(x)-\mathcal{L}_{1} \hat{V}_{1}(x), \hat{V}_{1}^{\prime}(x)-1, \hat{V}_{1}(x)-\hat{V}_{0}(x+(1-\lambda) g)\right] & =0, \quad x>0,
\end{aligned}
$$

together with the boundary data $V_{0}\left(0^{+}\right)=0$ and $\hat{V}_{1}\left(0^{+}\right)=\hat{V}_{0}((1-\lambda) g)$. By uniqueness to this system of variational inequalities, we conclude that $\left(v_{0}, v_{1}\right)=\left(\hat{V}_{0}, \hat{V}_{1}\right)$.

In the sequel, we suppose that

$$
\begin{equation*}
\frac{\mu_{1}-\mu_{0}}{\rho}>\hat{x}_{1}+g-\hat{x}_{0} . \tag{5.3}
\end{equation*}
$$

From Proposition 4.2, the switching region from regime 0 to regime 1 has the form :

$$
\mathcal{S}_{0}^{*}=\left\{x>0: v_{0}(x)=v_{1}(x-g)\right\}=\left[x_{01}^{*}, \infty\right),
$$

for some $x_{01}^{*} \in[g, \infty)$. Moreover, since $x_{1} \leq \hat{x}_{1}$ (see Remark 5.1), the above condition (5.3) implies $\frac{\mu_{1}-\mu_{0}}{\rho}>x_{1}+g-\hat{x}_{0}$. By same arguments as in Remark 4.3, there exists some $\bar{x}_{01}$ $\geq g$ s.t.

$$
\max \left(\hat{V}_{0}(x), v_{1}(x-g)\right)=\left\{\begin{array}{cc}
\hat{V}_{0}(x), & x \leq \bar{x}_{01} \\
v_{1}(x-g), & x>\bar{x}_{01}
\end{array}\right.
$$

Following [5], we introduce the pure stopping time problem

$$
\begin{equation*}
\bar{v}_{0}(x)=\sup _{\tau \in \mathcal{T}} \mathbb{E}\left[e^{-\rho\left(\tau \wedge T_{0}\right)} \max \left(\hat{V}_{0}\left(R_{\tau \wedge T_{0}}^{x, 0}\right), v_{1}\left(R_{\tau \wedge T_{0}}^{x, 0}-g\right)\right)\right] \tag{5.4}
\end{equation*}
$$

where $\mathcal{T}$ denotes the set of stopping times valued in $[0, \infty]$. We also denote $\mathcal{E}_{0}$ the exercice region for $\bar{v}_{0}$ :

\mathcal{E}_{0}=\left\{x \geq 0: \bar{v}_{0}(x)=\max \left(\hat{V}_{0}(x), v_{1}(x-g)\right)\right\}
$$

The next result shows that the original mixed singular/switching control problems may be reformulated as a coupled pure optimal stopping time and pure singular problem.

Theorem 5.3 Suppose that

$$

Proof. The proof follows along the lines of those of Theorem 3.1 in [5]. We will give only the road map of it in our context and omit the details.
Let us first note that the process $\left(e^{-\rho\left(t \wedge T_{0}\right)} v_{0}\left(R_{t \wedge T_{0}}^{x, 0}\right)\right)_{t \geq 0}$ is a supermartingale that dominates the function $\max \left(\hat{V}_{0}, v_{1}(.-g)\right)$. Therefore, according to Snell envelope theory, we have $v_{0} \geq \bar{v}_{0}$.
To prove the reverse inequality, it is enough to show that $\bar{v}_{0}^{\prime} \geq 1$ (see Proposition 3.4 in [5]) and to use the uniqueness result of Theorem 3.1. To this end, we will precise the shape of the exercise region $\mathcal{E}_{0}$. According to Lemma 4.3 by Villeneuve [17], $\bar{x}_{01}$ does not belong to $\mathcal{E}_{0}$. Thus, the exercise region can be decomposed into two subregions

Two cases have to be considered :
Case (i). If the subregion $\mathcal{E}_{00}$ is empty, the optimal stopping problem defined by $\bar{v}_{0}$ can be solved explicitely, and we have, see [5] Lemma 3.3,

The smooth-fit principle allows us to conclude that $\bar{v}_{0}^{\prime} \geq 1$ since $v_{1}^{\prime} \geq 1$.

Case (ii). If the subregion $\mathcal{E}_{00}$ is non empty, we can prove using the arguments of Proposition 3.5 and Lemma 3.4 in [5] that

with $a \geq \hat{x}_{0}$ and the value function $\bar{v}_{0}$ satisfies

The smooth fit principle gives $\bar{v}_{0}^{\prime}(a)=\hat{V}_{0}^{\prime}(a) \geq 1$ and $\bar{v}_{0}^{\prime}\left(x_{01}^{*}\right)=v_{1}^{\prime}\left(x_{01}^{*}-g\right) \geq 1$. Clearly, $\bar{v}_{0}$ is convex in a right neighbourhood of $a$ since $\hat{V}_{0}$ is linear at $a$. Therefore, if $\bar{v}_{0}$ remains convex on $\left(a, x_{01}^{*}\right)$, the proof is over. If not, the second derivative of $\bar{v}_{0}$ given by $A\left(m_{0}^{+}\right)^{2} e^{m_{0}^{+} x}+$ $B\left(m_{0}^{-}\right)^{2} e^{m_{0}^{-} x}$ vanishes at most one time on $\left(a, x_{01}^{*}\right)$, say in $d$. Hence,

which completes the proof.
Notice that the representation (5.1)-(5.4) of pure optimal singular and stopping problems for $v_{1}$ and $v_{0}$ is coupled, and so not easily computable. We decouple this representation by considering the sequence of pure optimal stopping and singular control problems, starting from $\hat{V}_{1}^{(0)}=\hat{V}_{1}$ and $\hat{V}_{0}^{(0)}=\hat{V}_{0}$ :

\end{aligned}
$$

The next result shows the convergence of this procedure.
Proposition 5.1 Under the conditions (5.5) of Theorem 5.3, we have for all $x>0$ :

Proof. We will first prove that the increasing sequence $\left(\hat{V}_{0}^{(k)}, \hat{V}_{1}^{(k)}\right)$ converges uniformly on every compact subsets of $\mathbb{R}_{+}$. To see this, we will apply Arzela-Ascoli Theorem by first proving the equi-continuity of the functions $\hat{V}_{i}^{(k)}$. Let us first remark that the functions $\hat{V}_{1}^{(k)}$ are Lipschitz continuous uniformly in $k$ since they are concave with bounded first derivative (see Remark 4.2) independently of $k$. Let us also check that the functions $\hat{V}_{0}^{(k)}$ are Lipschitz continuous uniformly in $k$. Using the inequality $\max (a, b)-\max (c, d) \leq \max (a-c, b-d)$, and by setting

\Delta(x, y)=\max \left(\hat{V}_{0}\left(R_{\tau \wedge T_{0}}^{x, 0}\right)-\hat{V}_{0}\left(R_{\tau \wedge T_{0}}^{y, 0}\right), \hat{V}_{1}^{(k-1)}\left(R_{\tau \wedge T_{0}}^{x, 0}-g\right)-\hat{V}_{1}^{(k-1)}\left(R_{\tau \wedge T_{0}}^{y, 0}-g\right)\right),
$$

we get by recalling also that $\hat{V}_{0}$ is Lipschitz (see Remark 4.2) :

\left|\hat{V}_{0}^{(k)}(x)-\hat{V}_{1}^{(k)}(y)\right| & \leq \sup _{\tau \in \mathcal{T}} \mathbb{E}\left[e^{-\rho\left(\tau \wedge T_{0}\right)}|\Delta(x, y)|\right] \\
& \leq K_{0} \sup _{\tau \in \mathcal{T}} \mathbb{E}\left[e^{-\rho\left(\tau \wedge T_{0}\right)}\left|R_{\tau \wedge T_{0}}^{x, 0}-R_{\tau \wedge T_{0}}^{y, 0}\right|\right] \\
& \leq K_{0}|x-y| \sup _{\tau \in \mathcal{T}} \mathbb{E}\left[e^{-\rho\left(\tau \wedge T_{0}\right)}\left|\mu_{0} \tau \wedge T_{0}+\sigma W_{\tau \wedge T_{0}}\right|\right] \\
& \leq K_{1}|x-y| .
\end{aligned}
$$

According to Corollary 3.7 , the set $\left\{\left(\hat{V}_{0}^{(k)}(x), \hat{V}_{1}^{(k)}(x)\right), k \in \mathbb{N}\right\}$ is bounded for every $x>0$. Therefore, Arzela-Ascoli Theorem gives that the increasing sequence $\left(\hat{V}_{0}^{(k)}, \hat{V}_{1}^{(k)}\right)$ converges uniformly on every compact subset of $\mathbb{R}_{+}$to some $\left(\hat{V}_{0}^{(\infty)}, \hat{V}_{1}^{(\infty)}\right)$.
On the other hand, for a fixed $k,\left(\hat{V}_{0}^{(k)}, \hat{V}_{1}^{(k)}\right)$ is the unique viscosity solution with linear growth to the system of variational inequalities

F_{0}^{(k)}\left(u_{0}, u_{0}^{\prime}, u_{0}^{\prime \prime}\right)=\min \left(\rho u_{0}-\mathcal{L}_{0} u_{0}, u_{0}-\max \left(\hat{V}_{0}, \hat{V}_{1}^{(k-1)}(.-g)\right)\right)=0, \\
F_{1}\left(u_{1}, u_{1}^{\prime}, u_{1}^{\prime \prime}\right)=\min \left(\rho u_{1}-\mathcal{L}_{1} u_{1}, u_{1}^{\prime}-1\right)=0
\end{gathered}
$$

with initial condition $u_{0}(0)=0, u_{1}(0)=\hat{V}_{0}^{(k)}((1-\lambda) g)$.
Since $\hat{V}_{1}^{(k-1)}$ converges uniformly on every compact subset of $\mathbb{R}_{+}$, the Hamiltonian $F_{0}^{(k)}$ converges to $F_{0}$ on every compact subset of $\mathbb{R} \times \mathbb{R} \times \mathbb{R}$, with

F_{0}\left(u, u^{\prime}, u^{\prime \prime}\right)=\min \left(\rho u-\mathcal{L}_{0} u, u-\max \left(\hat{V}_{0}, \hat{V}_{1}^{\infty}(.-g)\right)\right)=0 .

According to standard stability results for viscosity solution, see for instance Lemma 6.2 page 73 in Fleming and Soner [9], the couple $\left(\hat{V}_{0}^{(\infty)}, \hat{V}_{1}^{(\infty)}\right)$ is a viscosity solution of the system of variational inequalities

$$
\begin{align*}
\min \left(\rho \hat{V}_{0}^{\infty}-\mathcal{L}_{0} \hat{V}_{0}^{\infty}, \hat{V}_{0}^{\infty}-\max \left(\hat{V}_{0}, \hat{V}_{1}^{\infty}(.-g)\right)\right) & =0  \tag{5.6}\\
\min \left(\rho \hat{V}_{1}^{\infty}-\mathcal{L}_{1} \hat{V}_{1}^{\infty},\left(\hat{V}_{1}^{\infty}\right)^{\prime}-1\right) & =0 \tag{5.7}
\end{align*}
$$

with initial conditions $\hat{V}_{1}^{\infty}(0)=\hat{V}_{0}^{\infty}((1-\lambda) g)$ and $\hat{V}_{0}^{\infty}(0)=0$. By uniqueness to the system (5.6)-(5.7), we conclude that $\hat{V}_{0}^{\infty}=\bar{v}_{0}=v_{0}$ and $\hat{V}_{1}^{\infty}=v_{1}$.

We will close this section by describing the optimal strategy. According to Proposition 5.1, the value functions can be constructed recursively starting from $\left(\hat{V}_{0}, \hat{V}_{1}\right)$. Two cases have to be considered :
Case A : $\hat{V}_{0}^{(1)}((1-\lambda) g)=\hat{V}_{0}((1-\lambda) g)$. Then we have

$$
\begin{aligned}
\hat{V}_{1}^{(1)}(x) & =\sup _{Z \in \mathcal{Z}} \mathbb{E}\left[\int_{0}^{T_{1}^{-}} e^{-\rho t} d Z_{t}+e^{-\rho T_{1}} \hat{V}_{0}^{(1)}((1-\lambda) g)\right] \\
& =\sup _{Z \in \mathcal{Z}} \mathbb{E}\left[\int_{0}^{T_{1}^{-}} e^{-\rho t} d Z_{t}+e^{-\rho T_{1}} \hat{V}_{0}((1-\lambda) g)\right] \\
& =\hat{V}_{1}(x) .
\end{aligned}
$$

Therefore, we deduce by a straightforward induction that the sequence $\left(\hat{V}_{0}^{(k)}\right)_{k}$ is constant for $k \geq 1$ and the sequence $\left(\hat{V}_{1}^{(k)}\right)_{k}$ is constant for $k \geq 0$. Therefore, we deduce from Proposition 5.1 that $v_{0}=\hat{V}_{0}^{(1)}$ and $v_{1}=\hat{V}_{1}$.

In regime 0 , the optimal strategy consists in computing the optimal thresholds $a$ and $x_{01}^{*}$ associated to the optimal stopping problem $\hat{V}_{0}^{(1)}$. It is optimal to switch from regime 0 to regime 1 if the state process $R^{0}$ crosses the threshold $x_{01}^{*}$ while it is optimal to pay dividends and therefore abandon the growth opportunity forever if $R^{0}$ falls below the threshold $a$. At the level $a$, it is too costly to wait reaching the threshold $x_{01}^{*}$ even if the growth option is valuable. The shareholders prefer to receive today dividends than waiting a more profitable payment in the future.

In regime 1 , the optimal strategy consists in paying dividends above $\hat{x}_{1}$ and switching to regime 0 only when the manager is being forced by its cash constraints.
Case B: $\hat{V}_{0}^{(1)}((1-\lambda) g)>\hat{V}_{0}((1-\lambda) g)$. Let us introduce the sequence

& \hat{\theta}_{0}^{(k)}(x)=\sup _{\tau \in \mathcal{T}} \mathbb{E}\left[e^{-\rho\left(\tau \wedge T_{0}\right)} \hat{\theta}_{1}^{(k-1)}\left(R_{\tau \wedge T_{0}}^{x, 0}-g\right)\right], \quad k \geq 1, \\
& \hat{\theta}_{1}^{(k)}(x)=\sup _{Z \in \mathcal{Z}} \mathbb{E}\left[\int_{0}^{T_{1}^{-}} e^{-\rho t} d Z_{t}+e^{-\rho T_{1}} \hat{\theta}_{0}^{(k)}((1-\lambda) g)\right], \quad k \geq 1 .
\end{aligned}
$$

starting from $\hat{\theta}_{1}^{(0)}=\hat{V}_{1}$ and $\hat{\theta}_{0}^{(0)}=\hat{V}_{0}$. Proceeding analogously as in the proof of Proposition 5.1, we can prove that the sequence $\left(\theta_{0}^{(k)}, \theta_{1}^{(k)}\right)$ converges to $\left(\theta_{0}^{(\infty)}, \theta_{1}^{(\infty)}\right)$ solution of the system of variational inequalities :

& \min \left(\rho \hat{\theta}_{0}^{\infty}-\mathcal{L}_{0} \hat{\theta}_{0}^{\infty}, \hat{\theta}_{0}^{\infty}-\hat{\theta}_{1}^{\infty}(.-g)\right)=0, \\
& \left.\quad \min \left(\rho \hat{\theta}_{1}^{\infty}-\mathcal{L}_{1} \hat{\theta}_{1}^{\infty}, \hat{( } \theta_{1}^{\infty}\right)^{\prime}-1\right)=0,
\end{aligned}
$$

with initial conditions $\hat{\theta}_{1}^{\infty}(0)=\hat{\theta}_{0}^{\infty}((1-\lambda) g)$ and $\hat{\theta}_{0}^{\infty}(0)=0$.
Note that the function $\hat{\theta}_{0}^{\infty}$ corresponds to the managerial decision to accumulate cash reserve at the expense of shareholder's dividend payment in order to invest in the modern technology.

The key feature of our model in case B, which has to be viewed as the analogue of Proposition 3.5 in [5], can be summarized as follows :
$\star$ If the net expected value evaluated at the threshold $\hat{x}_{0}$ dominates the firm value running under the old technology that is $\hat{\theta}_{0}^{\infty}\left(\hat{x}_{0}\right)>\hat{V}_{0}\left(\hat{x}_{0}\right)$ then the manager postpones dividend distribution in order to invest in the modern technology and thus $v_{0}=\hat{\theta}_{0}^{\infty}$. Moreover, in regime 1, the manager always prefers to run under the modern technology until the cash process $X_{t}^{1}$ reaches zero forcing the manager to return back in regime 0 with the value $\hat{\theta}_{0}^{\infty}((1-\lambda) g)$, that is $v_{1}=\hat{\theta}_{1}^{\infty}$.
$\star$ If, on the contrary $\hat{\theta}_{0}^{\infty}\left(\hat{x}_{0}\right) \leq \hat{V}_{0}\left(\hat{x}_{0}\right)$ then the manager optimally ignores the strategy $\hat{\theta}_{0}^{\infty}$. Several situations can occur. For small values of the cash process $\left(X_{t}^{0} \leq a\right)$, the manager optimally runs the firm under the old technology and pays out any surplus above $\hat{x}_{0}$ as dividends. For high values of the cash process $\left(X_{t}^{0} \geq x_{01}^{*}\right)$, the manager switches
optimally to regime one. For intermediary values of the cash process $\left(a \leq X_{t}^{0} \leq x_{01}^{*}\right)$, there is an inaction region where the manager has not enough information to decide whether or not the investment is valuable.

We summarize all the results in Synthetic Table 1 and Figure 1.

### 5.3 Computational Aspects

In the following lines, we briefly describe a way of computing the free boundary points that characterize the optimal stopping strategy.

Case A In that case, the function $\hat{V}_{1}$ is given by formula (4.5) with $L=\hat{V}_{0}((1-\lambda) g)$ and the optimal threshold $\hat{x}_{1}$ is implicitely given by Equation (4.6) that can be solved using a standard Newton method. To figure out the optimal thresholds $a$ and $x_{01}^{*}$ of Regime 0 , we have to solve the following system where $\left(a, x_{01}^{*}, B, C\right)$ are unknown:

\begin{cases}B e^{m_{0}^{+} a}+C e^{m_{0}^{-} a} & =V_{0}(a) \\ B e^{m_{0}^{+} x_{01}^{*}}+C e^{m_{0}^{-} x_{01}^{*}} & =\hat{V}_{1}\left(x_{01}^{*}-g\right) \\ m_{0}^{+} B e^{m_{0}^{+} a}+m_{0}^{-} C e^{m_{0}^{-} a} & =V_{0}^{\prime}(a) \\ m_{0}^{+} B e^{m_{0}^{+} x_{01}^{*}}+m_{0}^{-} C e^{m_{0}^{-} x_{01}^{*}} & =\hat{V}_{1}^{\prime}\left(x_{01}^{*}-g\right)\end{cases}
$$

Case B The computation of the optimal thresholds in that case is more involved and relies on the computation of the approximating thresholds associated to the sequence $\left(\hat{\theta}_{0}^{(k)}, \hat{\theta}_{1}^{(k)}\right)$. At the time step $k$, the function $\hat{\theta}_{1}^{(k)}$ is given by formula (4.5) with $L=\hat{\theta}_{0}^{(k)}((1-\lambda) g)$. The optimal threshold $\hat{x}_{1}^{(k)}$ associated to the value function $\hat{\theta}_{1}^{(k)}$ is then given by Equation (4.6). In Regime 0 , the optimal threshold $x_{01}^{(k)}$ associated to the value function $\hat{\theta}_{0}^{(k)}$ can be figured out using the smooth fit principle, that is,

## Appendix A : Proof of Theorem 3.1

We divide the proof in several steps.
Proof of the continuity of $v_{1}$ on $(0, \infty)$.
We prove that $v_{1}$ is continuous at any $y>0$. We fix an arbitrary small $\varepsilon>0$. Applying the dynamic programming principle (DP) to $v_{1}$, there exists a control $\alpha=\left(Z,\left(\tau_{n}\right)_{n \geq 1}\right) \in \mathcal{A}$ s.t.

& =\mathbb{E}\left[\int_{0}^{\left(\tau_{1} \wedge T\right)^{-}} e^{-\rho t} d Z_{t}+e^{-\rho\left(\tau_{1} \wedge T\right)} v_{0}\left(X_{\tau_{1}}^{y, 1}\right) 1_{\tau_{1} \leq T}\right] \tag{A.1}
\end{align*}
$$

with $T=T^{y, 1, \alpha}$ the bankruptcy time of the process $X^{y, 1, \alpha}$, and since $v_{1}\left(X_{T}^{y, 1}\right)=0$ for $X_{T}^{y, 1}$ $<0$.

For any $0<x<y$, let $\theta=T^{y-x, 1, \alpha}$ be the bankruptcy time of the process $X^{y-x, 1, \alpha}$. We notice that $\theta \leq T$ and $X^{y-x, 1, \alpha}=X^{y, 1, \alpha}-x$ for all $0<t<\theta \leq T$. Applying the dynamic
programming principle (DP), we then have

\geq & \mathbb{E}\left[\int_{0}^{\left(\theta \wedge \tau_{1}\right)^{-}} e^{-\rho t} d Z_{t}+e^{-\rho\left(\theta \wedge \tau_{1}\right)} v_{0}\left(X_{\tau_{1}}^{y-x, 1}\right) 1_{\tau_{1} \leq \theta}\right] \\
\geq & \mathbb{E}\left[\int_{0}^{\left(\tau_{1} \wedge T\right)^{-}} e^{-\rho t} d Z_{t}+e^{-\rho\left(\tau_{1} \wedge T\right)} v_{0}\left(X_{\tau_{1}}^{y, 1}\right) 1_{\tau_{1} \leq T}\right]-\mathbb{E}\left[\int_{\theta \wedge \tau_{1}}^{\left(T \wedge \tau_{1}\right)^{-}} e^{-\rho t} d Z_{t}\right] \\
& +\mathbb{E}\left[e^{-\rho\left(\theta \wedge \tau_{1}\right)} v_{0}\left(X_{\tau_{1}}^{y-x, 1}\right) 1_{\tau_{1} \leq \theta}-e^{-\rho\left(T \wedge \tau_{1}\right)} v_{0}\left(X_{\tau_{1}}^{y, 1}\right) 1_{\tau_{1} \leq T}\right] \tag{A.2}
\end{align*}
$$

Notice that $\theta \rightarrow T$ as $x$ goes to zero. Hence, by the continuity of $v_{0}$ and the dominated convergence theorem, one can find $0<\delta_{1}<y$ s.t. for $0<x<\delta_{1}$ :

switching control, i.e. $\bar{\tau}_{1}=0$, while deciding not to distribute any dividend $\bar{Z}=0$, we obtain

On the other hand, let us consider the admissible control $\hat{\alpha}=\left(\hat{Z}, \hat{\tau}_{n}, n \geq 1\right)$ where we decide to never switch regime, while the dividend policy is defined by $\hat{Z}_{t}=\eta$ for $t \geq 0$, with $0 \leq \eta \leq \varepsilon$. Define the exit time $\tau_{\varepsilon}=\inf \left\{t \geq 0, X_{t}^{\bar{x}, i} \notin \bar{B}_{\varepsilon}(\bar{x})\right\}$. We notice that $\tau_{\varepsilon}<T$. From the dynamic programming principle (DP), we have

$\star$ Take first $\eta=0$. We then observe that $X$ is continuous on $\left[0, \tau_{\varepsilon} \wedge h\right]$ and only the first term of the relation (A.8) is non zero. By dividing the above inequality by $h$ with $h \rightarrow 0$, we conclude that

We notice that $\tau_{\varepsilon}<T$. Applying Itô's formula to the process $e^{-\rho t} \varphi\left(X_{t}^{\bar{x}, i}\right)$ between 0 and $\left(\tau_{\varepsilon} \wedge \tau_{1}\right)^{-}$, and by noting that before $\left(\tau_{\varepsilon} \wedge \tau_{1}\right)^{-}, X^{x, i}$ stays in regime $i$ and in the ball $\bar{B}_{\varepsilon}(\bar{x})$, we obtain

& -\mathbb{E}\left[\int_{0}^{\left(\tau_{\varepsilon} \wedge \tau_{1}\right)^{-}} e^{-\rho t} \varphi^{\prime}\left(X_{t}^{\bar{x}, i}\right) d Z_{t}^{c}\right] \\
& +\mathbb{E}\left[\sum_{0 \leq t<\tau_{\varepsilon} \wedge \tau_{1}} e^{-\rho t}\left[\varphi\left(X_{t}^{\bar{x}, i}\right)-\varphi\left(X_{t^{-}}^{\bar{x}, i}\right)\right]\right] . \tag{A.16}
\end{align*}

From Taylor's formula and (A.14), and noting that $\Delta X_{t}^{\bar{x}, i}=-\Delta Z_{t}$ for all $0 \leq t<\tau_{\varepsilon} \wedge \tau_{1}$, we have

& +\eta\left(\mathbb{E}\left[\int_{0}^{\left(\tau_{\varepsilon} \wedge \tau_{1}\right)^{-}} e^{-\rho t} d t\right]+\mathbb{E}\left[\int_{0}^{\left(\tau_{\varepsilon} \wedge \tau_{1}\right)^{-}} e^{-\rho t} d Z_{t}\right]\right) . \\
\geq & \mathbb{E}\left[\int_{0}^{\left(\tau_{\varepsilon} \wedge \tau_{1}\right)^{-}} e^{-\rho t} d Z_{t}+e^{-\rho \tau_{\varepsilon}^{-}} \varphi\left(X_{\tau_{\varepsilon}^{-}}^{\bar{x}, i}\right) 1_{\tau_{\varepsilon}<\tau_{1}}+e^{-\rho \tau_{1}^{-}} \varphi\left(X_{\tau_{1}^{-}}^{\bar{x}, i}\right) 1_{\tau_{1} \leq \tau_{\varepsilon}}\right] \\
& +\eta\left(\mathbb{E}\left[\int_{0}^{\left(\tau_{\varepsilon} \wedge \tau_{1}\right)^{-}} e^{-\rho t} d t\right]+\mathbb{E}\left[\int_{0}^{\left(\tau_{\varepsilon} \wedge \tau_{1}\right)^{-}} e^{-\rho t} d Z_{t}\right]\right) . \tag{A.18}
\end{align*}

Notice that while $X_{\tau_{\varepsilon}^{-}}^{\bar{x}, i} \in \bar{B}_{\varepsilon}(\bar{x}), X_{\tau_{\varepsilon}}^{\bar{x}, i}$ is either on the boundary $\partial \bar{B}_{\varepsilon}(\bar{x})$ or out of $\bar{B}_{\varepsilon}(\bar{x})$. However, there is some random variable $\gamma$ valued in $[0,1]$ s.t.

& +\mathbb{E}\left[e^{-\rho \tau_{\varepsilon}} \Delta Z_{\tau_{\varepsilon}} 1_{\tau_{\varepsilon}<\tau_{1}}\right] . \tag{A.21}

The $C^{2}$ function $\psi(x)=c_{0}\left[1-\frac{(x-\bar{x})^{2}}{\varepsilon^{2}}\right]$, with

\psi & =0, \quad \text { on } \partial \bar{B}_{\varepsilon}(\bar{x}),
\end{align*}\right.

Applying Itô's formula, we then obtain

A_{0} & =\frac{\mu_{1} B_{1}+C \sigma^{2}+1}{\rho}+\frac{C}{4}\left(\frac{B_{1}}{C}-2 \frac{\mu_{1}}{\rho}\right)^{2}+\frac{C}{4}\left(\frac{B_{0}}{C}-2 \frac{\mu_{0}}{\rho}\right)^{2}+w_{0}\left(0^{+}\right)+w_{1}\left(0^{+}\right) \\
A_{1} & =A_{0}+\frac{3}{2} g+\frac{g}{\lambda} \\
B_{0} & =3, B_{1}=2+\frac{2}{\lambda} \\
C & =\frac{1}{\lambda g} .
\end{aligned}
$$

We then define for all $\gamma \in(0,1)$, the continuous functions on $(0, \infty)$ by :

$$
w_{i}^{\gamma}=(1-\gamma) w_{i}+\gamma h_{i}, \quad i=0,1 .
$$

We then see that for all $\gamma \in(0,1), i=0,1$ :

$$
\begin{align*}
w_{i}^{\gamma}(x)-w_{1-i}^{\gamma}\left(x-g_{i, 1-i}\right) & =(1-\gamma)\left[w_{i}(x)-w_{1-i}\left(x-g_{i, 1-i}\right)\right]+\gamma\left[h_{i}(x)-h_{1-i}\left(x-g_{i, 1-i}\right)\right] \\
& \geq \gamma\left[\left(2 C g_{i, 1-i}+B_{i}-B_{1-i}\right) x+A_{i}-A_{1-i}-C g_{i, 1-i}^{2}+B_{1-i} g_{i, 1-i}\right] \\
& \geq \gamma \frac{g}{2}, \quad i=0,1 \tag{A.28}
\end{align*}
$$

Furthermore, we also easily obtain

$$
\begin{equation*}
h_{i}^{\prime}(x)-1=B_{i}+2 C x-1 \geq 1 \tag{A.29}
\end{equation*}
$$

A straight calculation will also provide us with the last required inequality, i.e.

$$
\begin{equation*}
\rho h_{i}(x)-\mathcal{L}_{i} h_{i}(x) \geq 1 . \tag{A.30}
\end{equation*}
$$

Combining (A.28), (A.29), and (A.30), this shows that $w_{i}^{\gamma}$ is a strict supersolution of the system : for $i=0,1$, we have on $(0, \infty)$

$$
\begin{equation*}
\min \left[\rho w_{i}^{\gamma}(x)-\mathcal{L}_{i} w_{i}^{\gamma}(x), w_{i}^{\gamma^{\prime}}(x)-1, w_{i}^{\gamma}(x)-w_{i-1}^{\gamma}\left(x-g_{i, 1-i}\right)\right] \geq \gamma \min \left\{1, \frac{g}{2}\right\}=\delta \cdot(\hat{A} \tag{A.31}
\end{equation*}
$$

Step 2. In order to prove the comparison principle, it suffices to show that for all $\gamma \in(0,1)$ :

$$
\max _{i \in\{0,1\}} \sup _{(0,+\infty)}\left(u_{i}-w_{i}^{\gamma}\right) \leq 0
$$

since the required result is obtained by letting $\gamma$ to 0 . We argue by contradiction and suppose that there exist some $\gamma \in(0,1)$ and $i \in\{0,1\}$, s.t.

$$
\begin{equation*}
\theta:=\max _{j \in\{0,1\}} \sup _{(0,+\infty)}\left(u_{j}-w_{j}^{\gamma}\right)=\sup _{(0,+\infty)}\left(u_{i}-w_{i}^{\gamma}\right)>0 \tag{A.32}
\end{equation*}
$$

Notice that $u_{i}(x)-w_{i}^{\gamma}(x)$ goes to $-\infty$ when $x$ goes to infinity. We also have $\lim _{x \rightarrow 0^{+}} u_{i}(x)-$ $\lim _{x \rightarrow 0^{+}} w_{i}^{\gamma}(x) \leq \gamma\left(\lim _{x \rightarrow 0^{+}} w_{i}(x)-A_{i}\right) \leq 0$. Hence, by continuity of the functions $u_{i}$ and $w_{i}^{\gamma}$, there exists $x_{0} \in(0, \infty)$ s.t.

$$
\theta=u_{i}\left(x_{0}\right)-w_{i}^{\gamma}\left(x_{0}\right) .
$$

For any $\varepsilon>0$, we consider the functions

$$
\begin{aligned}
\Phi_{\varepsilon}(x, y) & =u_{i}(x)-w_{i}^{\gamma}(y)-\phi_{\varepsilon}(x, y) \\
\phi_{\varepsilon}(x, y) & =\frac{1}{4}\left|x-x_{0}\right|^{4}+\frac{1}{2 \varepsilon}|x-y|^{2}
\end{aligned}
$$

for all $x, y \in(0, \infty)$. By standard arguments in comparison principle, the function $\Phi_{\varepsilon}$ attains a maximum in $\left(x_{\varepsilon}, y_{\varepsilon}\right) \in(0, \infty)^{2}$, which converges (up to a subsequence) to ( $x_{0}, x_{0}$ ) when $\varepsilon$ goes to zero. Moreover,

$$
\begin{equation*}
\lim _{\varepsilon \rightarrow 0} \frac{\left|x_{\varepsilon}-y_{\varepsilon}\right|^{2}}{\varepsilon}=0 \tag{A.33}
\end{equation*}
$$

Applying Theorem 3.2 in [4], we get the existence of $M_{\varepsilon}, N_{\varepsilon} \in \mathbb{R}$ such that:

$$
\begin{aligned}
\left(p_{\varepsilon}, M_{\varepsilon}\right) & \in J^{2,+} u_{i}\left(x_{\varepsilon}\right), \\
\left(q_{\varepsilon}, N_{\varepsilon}\right) & \in J^{2,-} w_{i}^{\gamma}\left(y_{\varepsilon}\right),
\end{aligned}
$$

and

$$
\left(\begin{array}{cc}
M_{\varepsilon} & 0  \tag{A.34}\\
0 & N_{\varepsilon}
\end{array}\right) \leq D^{2} \phi_{\varepsilon}\left(x_{\varepsilon}, y_{\varepsilon}\right)+\varepsilon\left(D^{2} \phi\left(x_{\varepsilon}, y_{\varepsilon}\right)\right)^{2}
$$

where

$$
\begin{aligned}
p_{\varepsilon} & =D_{x} \phi_{\varepsilon}\left(x_{\varepsilon}, y_{\varepsilon}\right)=\frac{1}{\varepsilon}\left(x_{\varepsilon}-y_{\varepsilon}\right)+\left(x_{\varepsilon}-x_{0}\right)^{3}, \\
q_{\varepsilon} & =-D_{y} \phi_{\varepsilon}\left(x_{\varepsilon}, y_{\varepsilon}\right)=\frac{1}{\varepsilon}\left(x_{\varepsilon}-y_{\varepsilon}\right), \\
D^{2} \phi_{\varepsilon}\left(x_{\varepsilon}, y_{\varepsilon}\right) & =\left(\begin{array}{cc}
3\left(x_{\varepsilon}-x_{0}\right)^{2}+\frac{1}{\varepsilon} & -\frac{1}{\varepsilon} \\
-\frac{1}{\varepsilon} & \frac{1}{\varepsilon}
\end{array}\right) .
\end{aligned}
$$

By writing the viscosity subsolution property of $u_{i}$ and the viscosity supersolution property (A.31) of $w_{i}^{\gamma}$, we have the following inequalities:

$$
\begin{align*}
& \min \left\{\rho u_{i}\left(x_{\varepsilon}\right)-\left(\frac{1}{\varepsilon}\left(x_{\varepsilon}-y_{\varepsilon}\right)+\left(x_{\varepsilon}-x_{0}\right)^{3}\right) \mu_{i}-\frac{1}{2} \sigma^{2} M_{\varepsilon}\right. \\
& \left(\frac{1}{\varepsilon}\left(x_{\varepsilon}-y_{\varepsilon}\right)+\left(x_{\varepsilon}-x_{0}\right)^{3}\right)-1, u_{i}\left(\left(x_{\varepsilon}\right)-u_{1-i}\left(x_{\varepsilon}-g_{i, 1-i}\right)\right\} \leq 0  \tag{A.35}\\
& \quad \min \left\{\rho w_{i}^{\gamma}\left(y_{\varepsilon}\right)-\frac{1}{\varepsilon}\left(x_{\varepsilon}-y_{\varepsilon}\right) \mu_{i}-\frac{1}{2} \sigma^{2} N_{\varepsilon}, \frac{1}{\varepsilon}\left(x_{\varepsilon}-y_{\varepsilon}\right)-1,\right. \\
& \left.w_{i}^{\gamma}\left(y_{\varepsilon}\right)-w_{i-1}^{\gamma}\left(x_{\varepsilon}-g_{i, 1-i}\right)\right\} \geq \delta \tag{A.36}
\end{align*}
$$

We then distinguish the following three cases:
$\star$ Case 1: $u_{i}\left(x_{\varepsilon}\right)-u_{1-i}\left(x_{\varepsilon}-g_{i, 1-i}\right) \leq 0$ in (A.35).
From the continuity of $u_{i}$ and by sending $\varepsilon \rightarrow 0$, this implies

$$
\begin{equation*}
u_{i}\left(x_{0}\right) \leq u_{1-i}\left(x_{0}-g_{i, 1-i}\right) . \tag{A.37}
\end{equation*}
$$

On the other hand, from (A.36), we also have

$$
w_{i}^{\gamma}\left(y_{\varepsilon}\right)-w_{i-1}^{\gamma}\left(x_{\varepsilon}-g_{i, 1-i}\right) \geq \delta
$$

which implies, by sending $\varepsilon \rightarrow 0$ and using the continuity of $w_{i}$ :

$$
\begin{equation*}
w_{i}^{\gamma}\left(x_{0}\right) \geq w_{i-1}^{\gamma}\left(x_{0}-g_{i, 1-i}\right)+\delta \tag{A.38}
\end{equation*}
$$

Combining (A.37) and (A.38), we obtain

$$
\begin{aligned}
\theta=u_{i}\left(x_{0}\right)-w_{i}^{\gamma}\left(x_{0}\right) & \leq u_{1-i}\left(x_{0}-g_{i, 1-i}\right)-w_{i-1}^{\gamma}\left(x_{0}-g_{i, 1-i}\right)-\delta, \\
& \leq \theta-\delta,
\end{aligned}
$$

which is a contradiction.
$\star$ Case 2: $\left(\frac{1}{\varepsilon}\left(x_{\varepsilon}-y_{\varepsilon}\right)+\left(x_{\varepsilon}-x_{0}\right)^{3}\right)-1 \leq 0$ in (A.35)
Notice that by (A.36), we have

$$
\frac{1}{\varepsilon}\left(x_{\varepsilon}-y_{\varepsilon}\right)-1 \geq \delta,
$$

which implies in this case

$$
\left(x_{\varepsilon}-x_{0}\right)^{3} \leq-\delta
$$

By sending $\varepsilon$ to zero, we obtain again a contradiction.
$\star$ Case 3: $\rho u_{i}\left(x_{\varepsilon}\right)-\left(\frac{1}{\varepsilon}\left(x_{\varepsilon}-y_{\varepsilon}\right)+\left(x_{\varepsilon}-x_{0}\right)^{3}\right) \mu_{i}-\frac{1}{2} \sigma^{2} M_{\varepsilon} \leq 0$ in (A.35)
From (A.36), we have

$$
\rho w_{i}^{\gamma}\left(y_{\varepsilon}\right)-\frac{1}{\varepsilon}\left(x_{\varepsilon}-y_{\varepsilon}\right) \mu_{i}-\frac{1}{2} \sigma^{2} N_{\varepsilon} \geq \delta,
$$

which implies in this case

$$
\begin{equation*}
\rho\left(u_{i}\left(x_{\varepsilon}\right)-w_{i}^{\gamma}\left(y_{\varepsilon}\right)\right)-\mu_{i}\left(x_{\varepsilon}-x_{0}\right)^{3}-\frac{1}{2} \sigma^{2}\left(M_{\varepsilon}-N_{\varepsilon}\right) \leq-\delta, \tag{A.39}
\end{equation*}
$$

From (A.34), we have

$$
\frac{1}{2} \sigma^{2}\left(M_{\varepsilon}-N_{\varepsilon}\right) \leq \frac{3}{2} \sigma^{2}\left(x_{\varepsilon}-x_{0}\right)^{2}\left[1+3 \varepsilon\left(x_{\varepsilon}-x_{0}\right)\right] .
$$

Plugging it into (A.39) yields

$$
\rho\left(u_{i}\left(x_{\varepsilon}\right)-w_{i}^{\gamma}\left(y_{\varepsilon}\right)\right) \leq \mu_{i}\left(x_{\varepsilon}-x_{0}\right)^{3}+\frac{3}{2} \sigma^{2}\left(x_{\varepsilon}-x_{0}\right)^{2}\left[1+3 \varepsilon\left(x_{\varepsilon}-x_{0}\right)\right]-\delta .
$$

By sending $\varepsilon$ to zero and using the continuity of $u_{i}$ and $w_{i}^{\gamma}$, we obtain the required contradiction : $\rho \theta \leq-\delta<0$. This ends the proof.

## Appendix B : Proof of Proposition 3.3

## $C^{1}$ property

We prove in three steps that for a given $i \in 0,1, v_{i}$ is a $C^{1}$ function on $(0, \infty)$. Notice first that since $v_{i}$ is a strictly nondecreasing continuous function on $(0, \infty)$, it admits a nonnegative left and right derivative $v_{i}^{\prime-}(x)$ and $v_{i}^{\prime+}(x)$ for all $x>0$.

Step 1. We start by proving that $v_{i}^{\prime-}(x) \geq v_{i}^{\prime+}(x)$ for all $x \in(0, \infty)$.
Suppose on the contrary that there exists some $x_{0}$ such that $v_{i}^{\prime-}\left(x_{0}\right)<v_{i}^{+}\left(x_{0}\right)$. Take then some $q \in\left(v_{i}^{\prime-}(x), v_{i}^{\prime+}(x)\right)$, and consider the function

$$
\varphi(x)=v_{i}\left(x_{0}\right)+q\left(x-x_{0}\right)+\frac{1}{2 \varepsilon}\left(x-x_{0}\right)^{2},
$$

with $\varepsilon>0$. Then $x_{0}$ is a local minimum of $v_{i}-\varphi_{i}$, with $\varphi^{\prime}\left(x_{0}\right)=q$ and $\varphi^{\prime \prime}\left(x_{0}\right)=\frac{1}{\varepsilon}$. Therefore, we get the required contradiction by writing the supersolution inequality :

$$
0 \leq \rho v_{i}\left(x_{0}\right)-\mu_{i} \varphi^{\prime}\left(x_{0}\right)-\frac{\sigma^{2}}{2} \varphi^{\prime \prime}\left(x_{0}\right)=\rho v_{i}\left(x_{0}\right)-\mu_{i} q-\frac{\sigma^{2}}{2 \varepsilon},
$$

and choosing $\varepsilon$ small enough.
Step 2. We now prove that for $i=0,1, v_{i}$ is $C^{1}$ on $(0, \infty) \backslash \mathcal{S}_{i}$.
Suppose there exists some $x_{0} \notin \mathcal{S}_{i}$ s.t. $v_{i}^{\prime-}\left(x_{0}\right)>v_{i}^{\prime+}\left(x_{0}\right)$. We then fix some $q \in$ $\left(v_{i}^{\prime+}\left(x_{0}\right), v_{i}^{\prime-}\left(x_{0}\right)\right)$ and consider the function

$$
\varphi(x)=v_{i}\left(x_{0}\right)+q\left(x-x_{0}\right)-\frac{1}{2 \varepsilon}\left(x-x_{0}\right)^{2},
$$

with $\varepsilon>0$. Then $x_{0}$ is a local maximum of $v_{i}-\varphi$, with $\varphi^{\prime}\left(x_{0}\right)=q>1, \varphi^{\prime \prime}\left(x_{0}\right)=-\frac{1}{\varepsilon}$. Since $x_{0} \notin \mathcal{S}_{i}$, the subsolution inequality property implies :

$$
\rho v_{i}\left(x_{0}\right)-\mu_{i} q+\frac{\sigma^{2}}{2 \varepsilon} \leq 0
$$

which leads to a contradiction, by choosing $\varepsilon$ sufficiently small. By combining the results from step 1 and step 2 , we obtain that $v_{i}$ is $C^{1}$ on the open set $(0, \infty) \backslash \mathcal{S}_{i}$.
Step 3. We now prove that $v_{i}$ is $C^{1}$ on $(0, \infty)$.
From Step 2, we have to prove the $C^{1}$ property of $v_{i}$ on $\mathcal{S}_{i}^{*}$. Fix then some $x_{0} \in \mathcal{S}_{i}^{*}$ so that $v_{i}\left(x_{0}\right)=v_{1-i}\left(x_{0}-g_{i, 1-i}\right)$. Hence, $x_{0}$ is a minimum of $v_{i}-v_{1-i}\left(.-g_{i, 1-i}\right)$, and so

$$
\begin{equation*}
v_{i}^{\prime-}\left(x_{0}\right)-v_{1-i}^{\prime-}\left(x_{0}-g_{i, 1-i}\right) \leq v_{i}^{\prime+}\left(x_{0}\right)-v_{1-i}^{\prime+}\left(x_{0}-g_{i, 1-i}\right) . \tag{B.1}
\end{equation*}
$$

Now, from Lemma 4.3, $x_{0}-g_{i, 1-i}$ belongs to the open set $(0, \infty) \backslash \mathcal{S}_{1-i}$. From step 2, $v_{1-i}$ is $C^{1}$ on $(0, \infty) \backslash \mathcal{S}_{1-i}$, and so $v_{1-i}^{\prime+}\left(x_{0}-g_{i, 1-i}\right)=v_{1-i}^{\prime-}\left(x_{0}-g_{i, 1-i}\right)$. From (B.1), we thus obtain

$$
v_{i}^{\prime-}\left(x_{0}\right) \leq v_{i}^{\prime+}\left(x_{0}\right),
$$

which is the required result, since the reverse inequality is already satisfied from Step 1.

## $C^{2}$ property

We now turn to the proof of the $C^{2}$ property of $v_{i}$ on the open set $\mathcal{C}_{i} \cup \operatorname{int}\left(\mathcal{D}_{i}\right)$ of $(0, \infty)$. Since it is clear that $v_{i}$ is $C^{2}$ on $\operatorname{int}\left(\mathcal{D}_{i}\right)\left(\right.$ where $\left.v_{i}^{\prime}=1\right)$, we only have to prove that $v_{i}$ is $C^{2}$ on $\mathcal{C}_{i}$. By standard arguments, we check that $v_{i}$ is a viscosity solution to

$$
\begin{equation*}
\rho v_{i}(x)-\mathcal{L}_{i} v_{i}(x)=0, \quad x \in \mathcal{C}_{i} . \tag{B.2}
\end{equation*}
$$

Indeed, let $\bar{x} \in \mathcal{C}_{i}$ and $\varphi$ a $C^{2}$ function on $\mathcal{C}_{i}$ s.t. $\bar{x}$ is a local maximum of $v_{i}-\varphi$, with $v_{i}(\bar{x})=$ $\varphi(\bar{x})$. Then, $\varphi^{\prime}(\bar{x})=v_{i}^{\prime}(\bar{x})>1$. By definition of $\mathcal{C}_{i}$, we also have $v_{i}(\bar{x})>v_{1-i}\left(x-g_{i, 1-i}\right)$ and so from the subsolution viscosity property (A.26) of $v_{i}$, we have

$$
\rho \varphi(\bar{x})-\mathcal{L}_{i} \varphi(\bar{x}) \leq 0 .
$$

The supersolution inequality for (B.2) is immediate from (A.12).
Now, for any arbitrary bounded interval $\left(x_{1}, x_{2}\right) \subset \mathcal{C}_{i}$, consider the Dirichlet boundary linear problem:

$$
\begin{array}{r}
\rho w(x)-\mathcal{L}_{i} w(x)=0, \quad \text { on } \quad\left(x_{1}, x_{2}\right) \\
w\left(x_{1}\right)=v_{i}\left(x_{1}\right), \quad w\left(x_{2}\right)=v_{i}\left(x_{2}\right) . \tag{B.4}
\end{array}
$$

Classical results provide the existence and uniqueness of a smooth $C^{2}$ function $w$ solution on $\left(x_{1}, x_{2}\right)$ to (B.3)-(B.4). In particular, this smooth function $w$ is a viscosity solution to (B.2) on ( $x_{1}, x_{2}$ ). From standard uniqueness results for (B.3)-(B.4), we get $v_{i}=w$ on $\left(x_{1}, x_{2}\right)$. From the arbitrariness of $\left(x_{1}, x_{2}\right) \subset \mathcal{C}_{i}$, this proves that $v_{i}$ is smooth $C^{2}$ on $\mathcal{C}_{i}$.
