We are constructing an asset price index (API) with the help of some numerical techniques of simultaneous functional equations that arise in dynamic stochastic games. Unlike the conventional linear-quadration approach, our methods may be used to address general model specifications including non-quadratic objective functions, non-linear equations of motion, and constraints on decision variables which has the keen relevance with higher investment in capital stock. On the basis of API, we can get to know the consumption and saving-investment habit in an economy. For instance, when API rises, as the investor feels his wealth is rising, and hence his consumption should rise.
