Attachments should be in pdf or postscript formats. Please do not use attachments in the format of a proprietary word processor [MS Word attachments (doc files), for example]. Even if you do not submit by email, be sure to include your email address. The abstract should be approximately 100 words. Every submission must include one or more JEL classification codes. Also, please include the names of one or two possible discussants. By submitting a paper, you indicate that you are also willing to serve as a discussant and/or program chair at other sessions if your paper is accepted for the CEA meetings. Please state your principal areas of specialization. In order to present a paper at the Annual Meeting, you must be a member of the Canadian Economics Association, and you must also register for the meeting. If you are not a member or have not registered for the conference, you may join or register after you find out whether your paper is accepted for presentation.
