The 2001 South-East Economic Theory and International Economics Conference will be held at Florida International University, Miami, Florida from November 16 to 18, 2001. The program will consist primarily of contributed papers and four invited plenary lectures. International Economics sessions will cover international trade as well as open economy macroeconomics. Economic Theory sessions will include topics in pure and applied theory (IO, Public Economics, Political Economy etc.). Prospective contributors are invited to submit extended abstracts of their papers before August 31, 2001. Only electronic submissions will be accepted. Each person may submit only one abstract, or be a co-author on multiple submissions provided that if all such papers were accepted, no person would present more than one paper.
