EEFS European Economics and Finance Society Call for papers The Second Annual EEFS Conference, will be held at the University of Bologna, Italy on 14-16 May 2003. The topic of the Conference will be on: "European Integration: Real and Financial Aspects" The Conference will focus on the fundamental changes we observe and experience today in Europe and other related issues in International Economics and Finance. Papers are solicited in such areas as: European integration analysis of financial markets, economic geography, international monetary economics, international trade and general equilibrium, macroeconomics, growth and development, industrial economics and organisation, labour economics, new political economy, public economics, topics on the dotcom/digital economy. It is envisaged that a number of papers from this Conference will be published in a special issue of an established journal in the forthcoming months. Paper Submission Abstracts, papers and/or session proposals should be submitted to Professor Gianluigi Pelloni, Professor Anna Soci, and Professor George Agiomirgianakis as attached files (doc or pdf format) to the following address [eefs@dse.unibo.it](mailto:eefs@dse.unibo.it) Abstracts and/or session proposals should be sent also by fax to the Conference Secretary's fax number: 00-39-0543-750918, referring clearly to the Bologna EEFS Conference. An entire paper may be submitted, when available, but it must include an abstract. Abstracts should not exceed 200 words, and should contain JEL classification codes. The authors should indicate their full name, affiliation, address, phone/fax, and e-mail for correspondence. Proposals for complete sessions are encouraged. Each session should be made up of three papers. In the submitted proposals, session organizers should indicate the name of the session chair, the names, affiliations, contact numbers and e-mail addresses of the authors and the chair, the titles of the papers each accompanied by the paper abstract. Participants are expected to serve as program chair at Conference sessions. The submission deadline is March 31st. Authors are expected to send an electronic copy of the paper by May 9th in order to facilitate its reproduction for the relevant session. After that date it is the responsibility of the authors to bring enough copies to the session.
