## Basis for projecting 2007/08 supply and demand:

- Beginning stocks are taken from 2006/07 ending stocks in the February 2007 *World Agricultural Supply and Demand Estimates* (WASDE) report.
- Sugar production and use are taken from USDA Agricultural Projections to 2016.
- Tariff rate quota (TRQ) imports are assumed to total the minimum under World Trade Organization commitments, other current trade agreements, and additional specialty sugar. Other program imports are projected based on trends. Other imports are projected from trends (molasses and syrups) and other updated analyses (imports from Mexico).

## Key results for 2007/08:

- Compared with a year earlier, beginning stocks are nearly unchanged from 2006/07.
- Production of beet sugar decreases with lower area and a return to trend yield, following recordhigh yields in 2006/07. Cane sugar production increases due to a rebound in yields more than offsetting lower area.
- Imports are projected to total 1.74 million short tons, raw value, including 75,000 tons of sugar imports from Mexico.
- Total use increases 55,000 tons, as higher domestic consumption more than offsets lower exports and other uses.
- Ending stocks total 1.2 million tons, or 11.4 percent of use.
