Other material like literature surveys, letters to the
editor etc. will be published if and when suitable
material becomes available.

Editorial policy

Our aim is to publish papers of interest to a wide
mathematical audience, such as expository articles
that make research results more widely accessible, and
papers on topics with fairly broad appeal. Main articles
must be written in such a way that a research student
interested in the topic of the paper can read them
profitably. Mathematical notes can be at a slightly
higher level. Clarity of exposition, accuracy of details
and the relevance and interest of the subject matter
will be the decisive factors in our acceptance of an
article for publication. All papers are refereed.

Submission of manuscripts

Authors should send by electronic mail a .pdf file
of their paper to the appropriate Associate Editor
(with a copy to the Managing Editor) or directly
to the Managing Editor. Use of regular mail is
also possible. Once the article is accepted, the
author must provide the article as a LaTeX file, if
available.

Articles written in a language other than English
should be accompanied by a short abstract in English.
For further details concerning the preparation of
manuscripts consult "Instructions to authors".
